The ornamental design for a ring, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a ring as seen from the top, front and left sides, wherein the broken line disclosure is for illustrative purposes only and does not constitute a part of the claimed design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof, the rear elevational view is identical;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a right side elevational view thereof, the left side elevational view is identical;

FIG. 6 is a perspective view similar to FIG. 1 wherein the broken line disclosure is for environmental purposes only and does not form a part of the claimed design;

FIG. 7 is a perspective view similar to FIG. 1 wherein the broken line disclosure is for environmental purposes only and does not form a part of the claimed design; and,

FIG. 8 is a perspective view of an alternative embodiment of FIG. 1 wherein the broken line disclosure is for environmental purposes only and does not form a part of the claimed design.

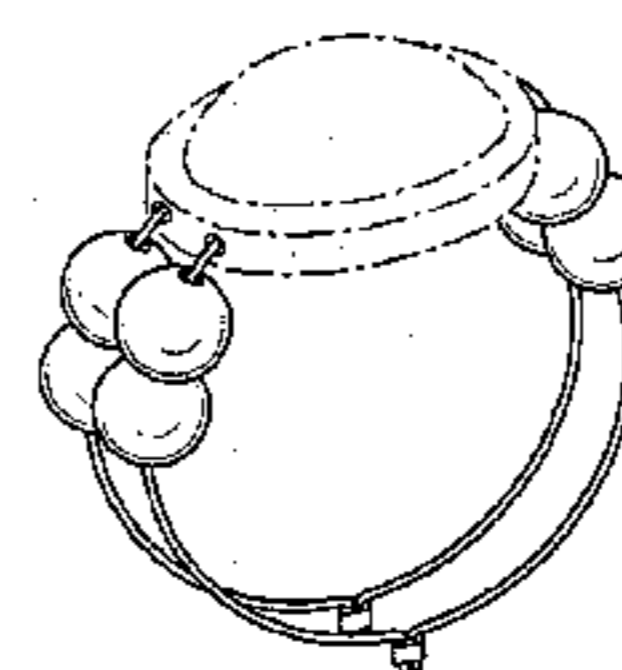
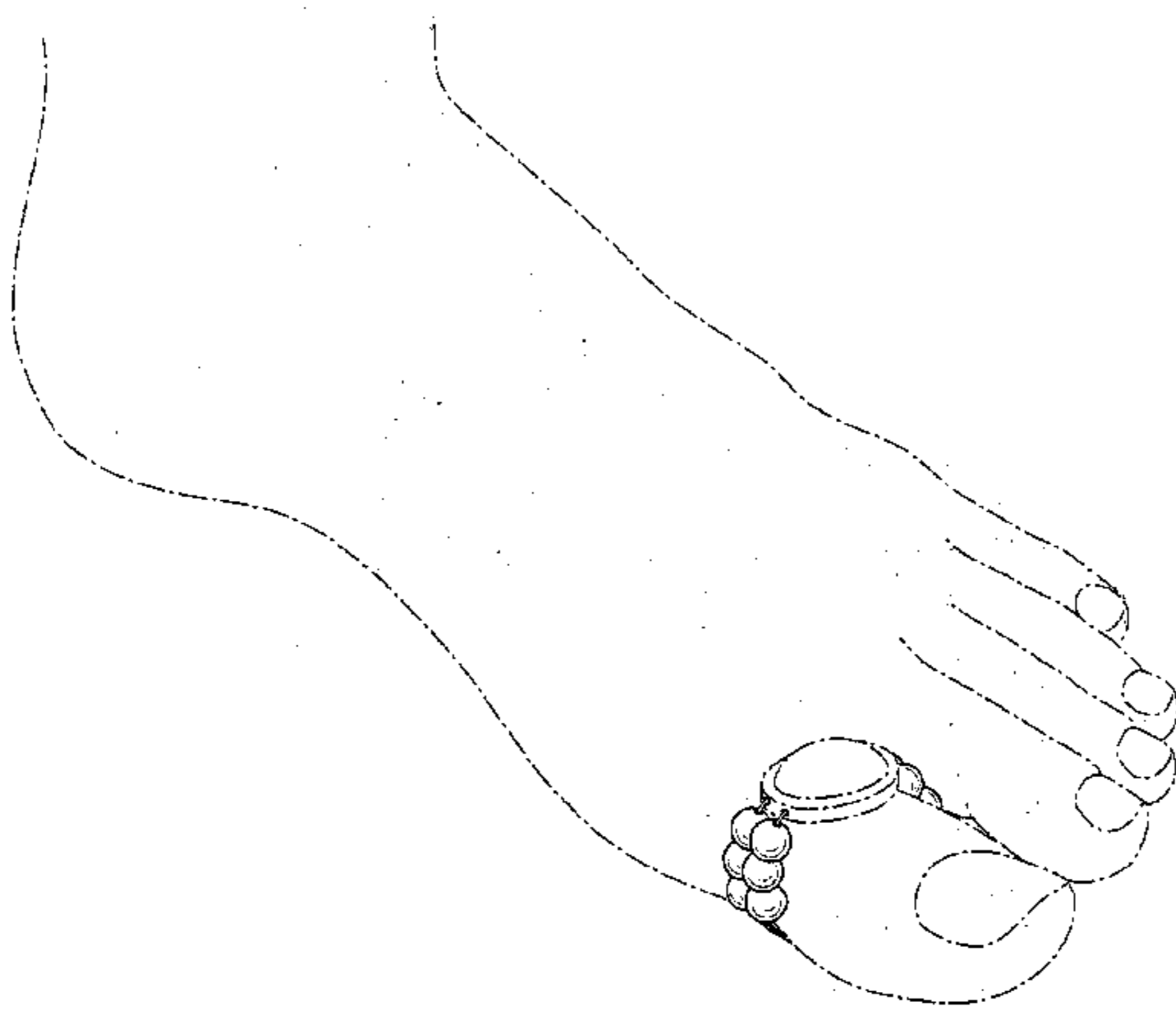
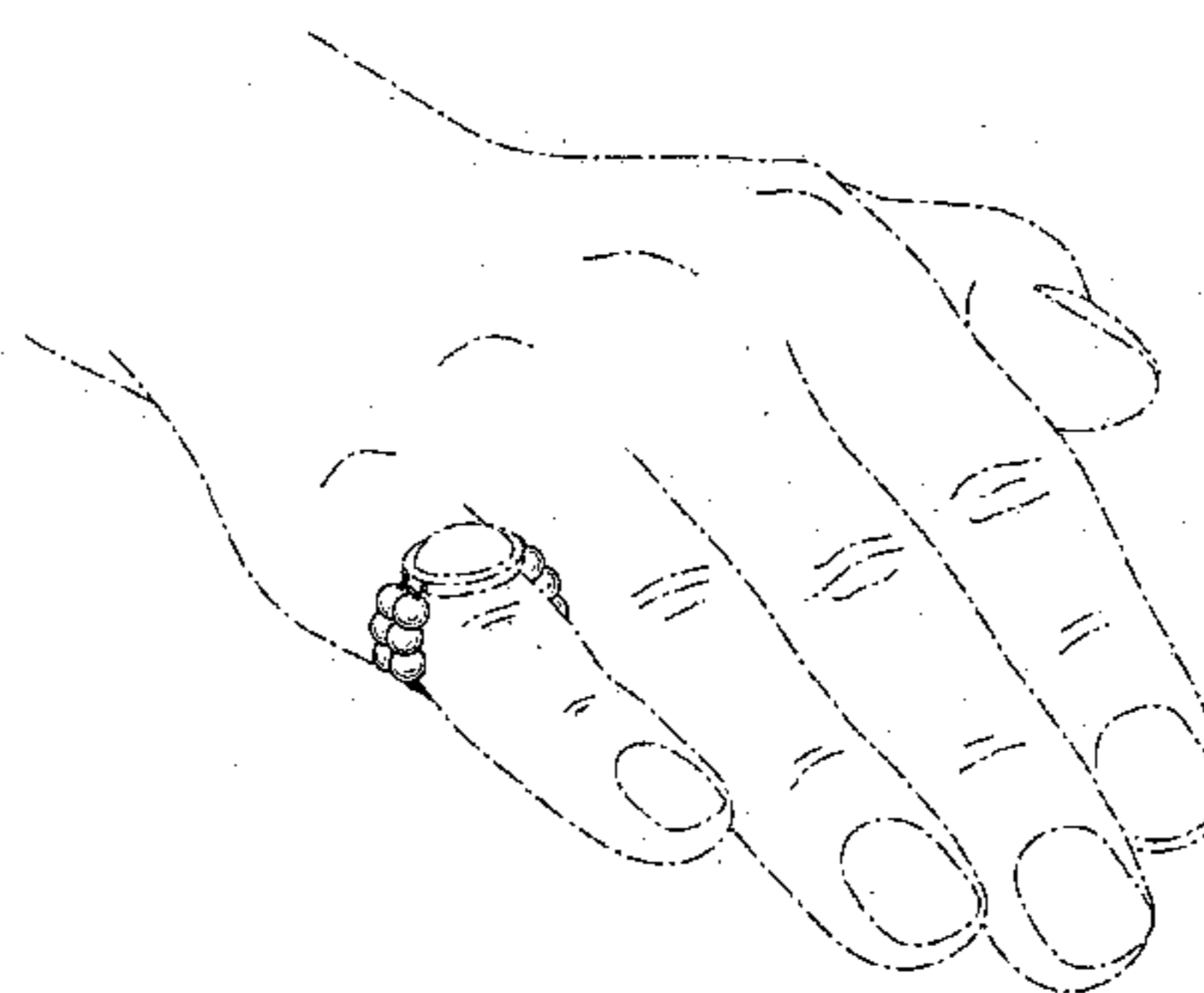
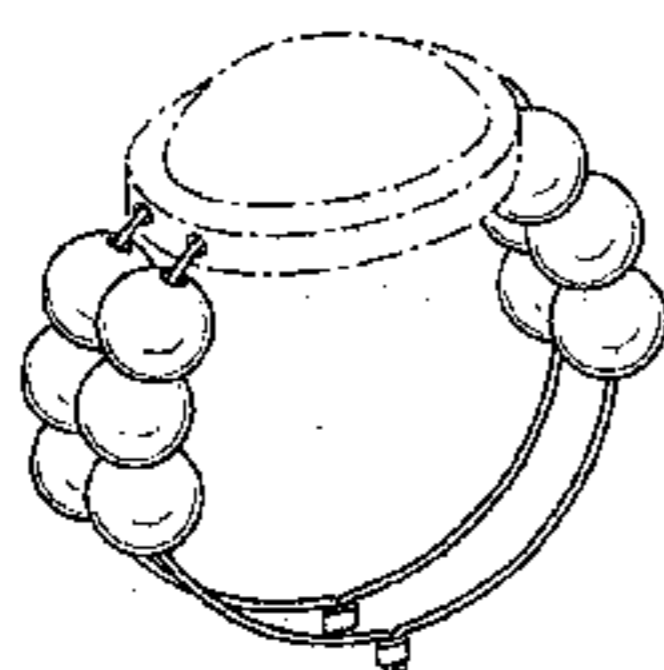

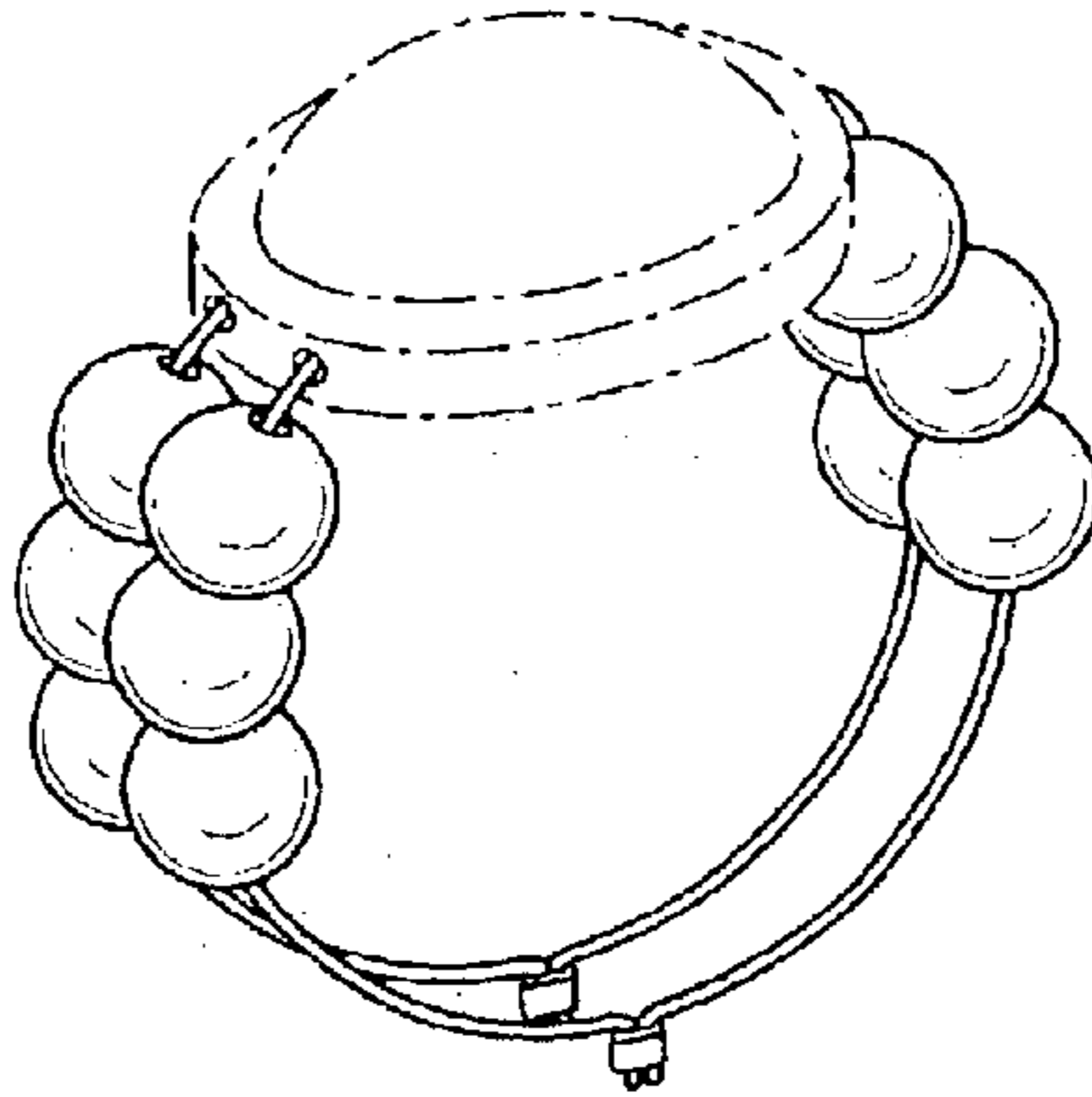

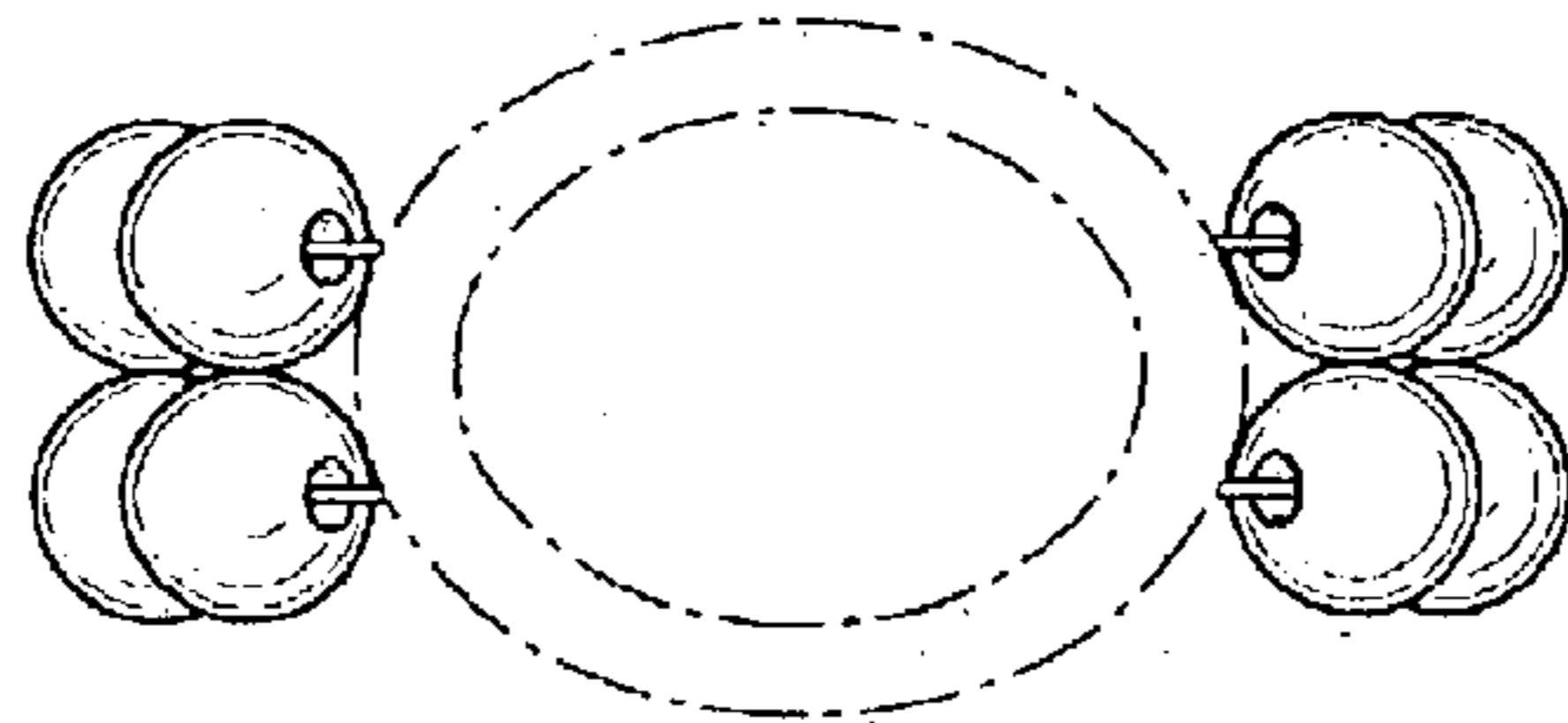

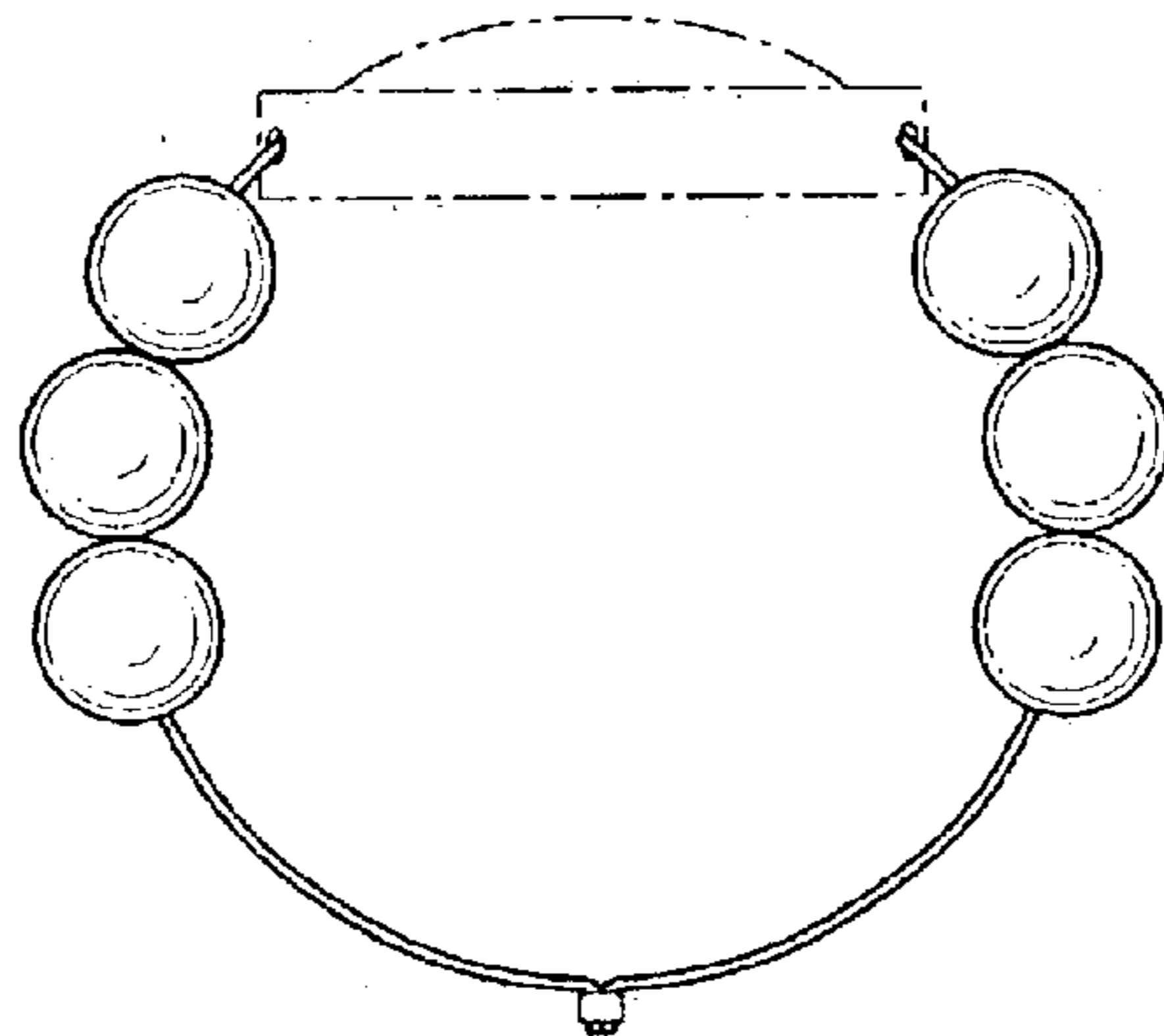

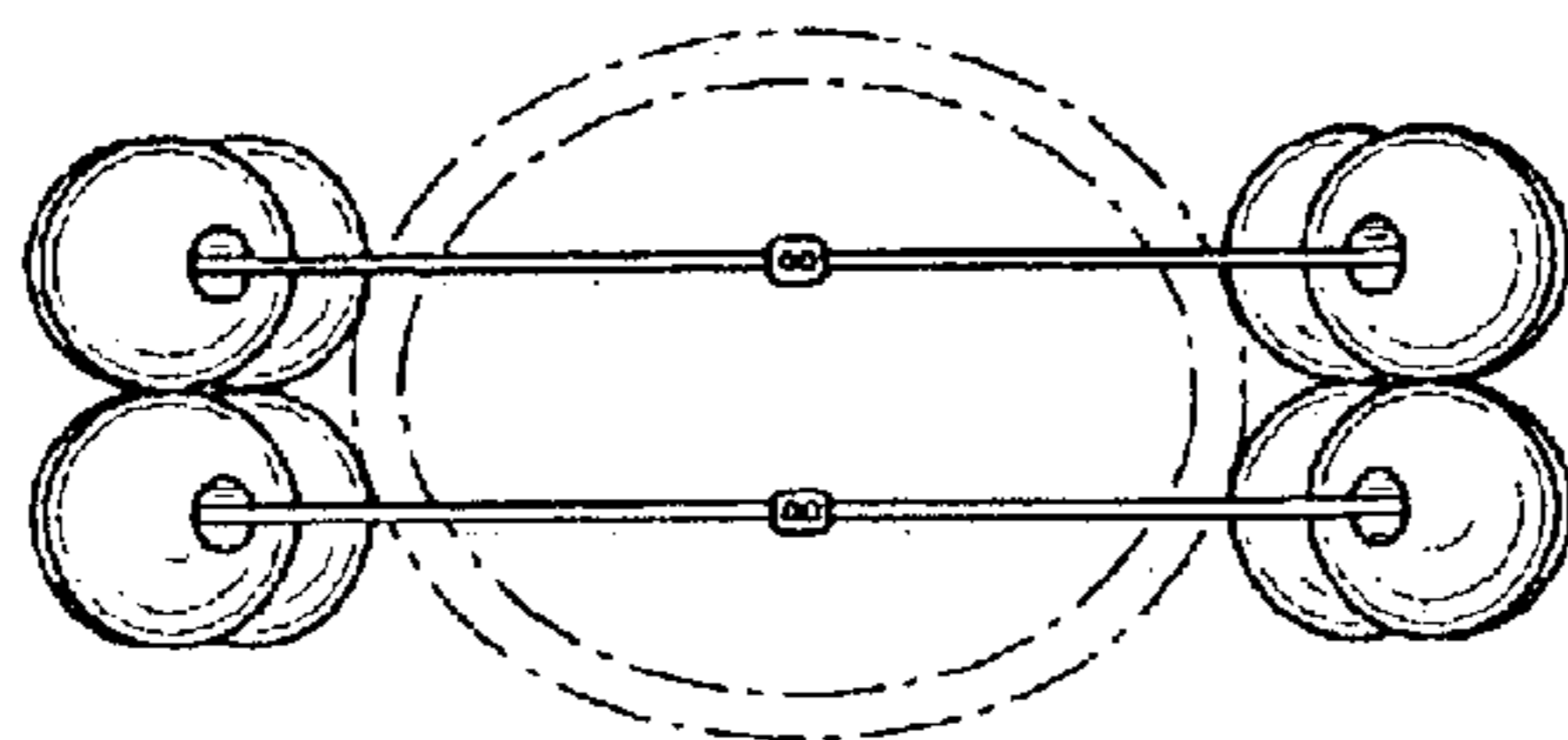

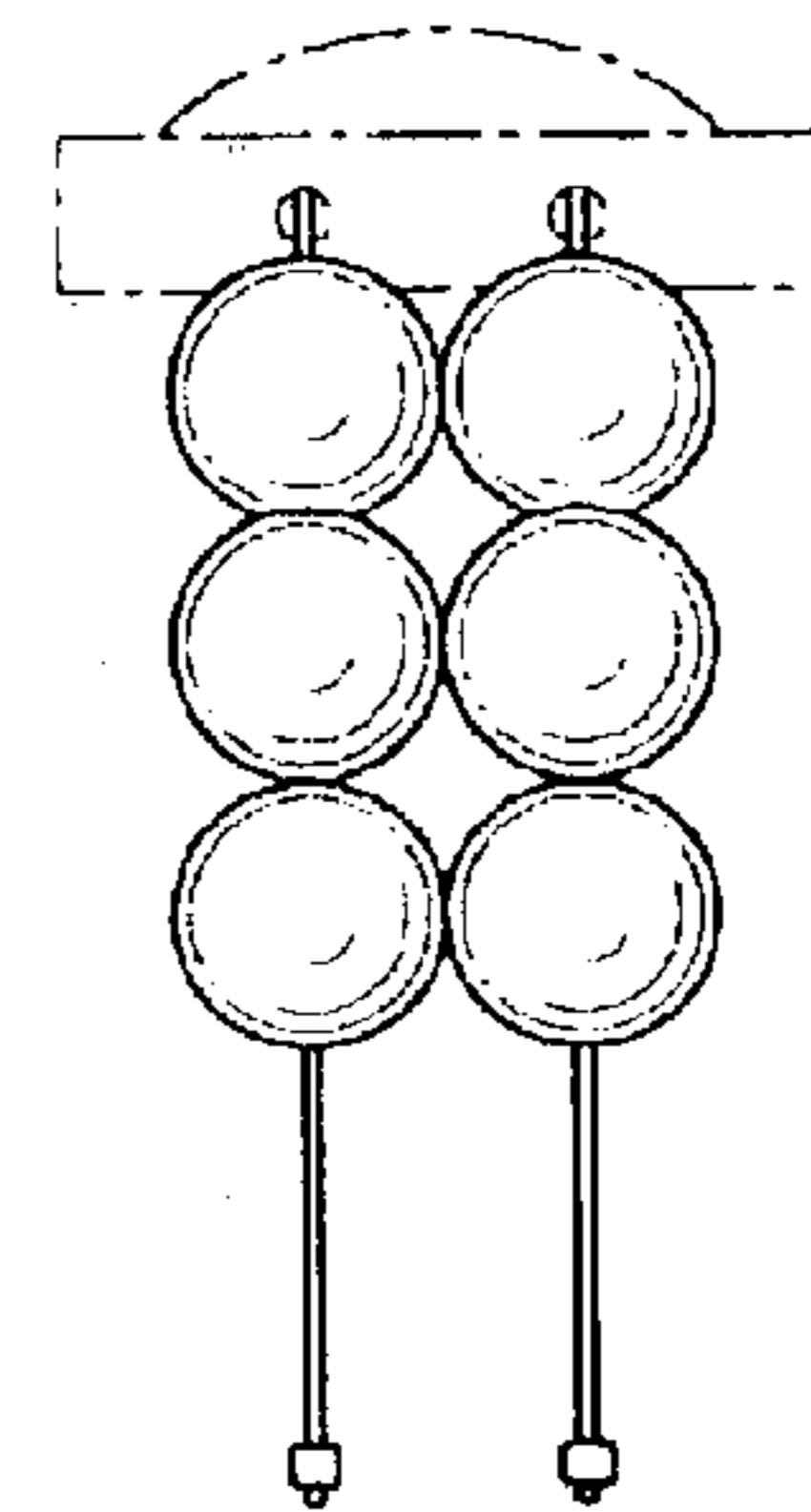

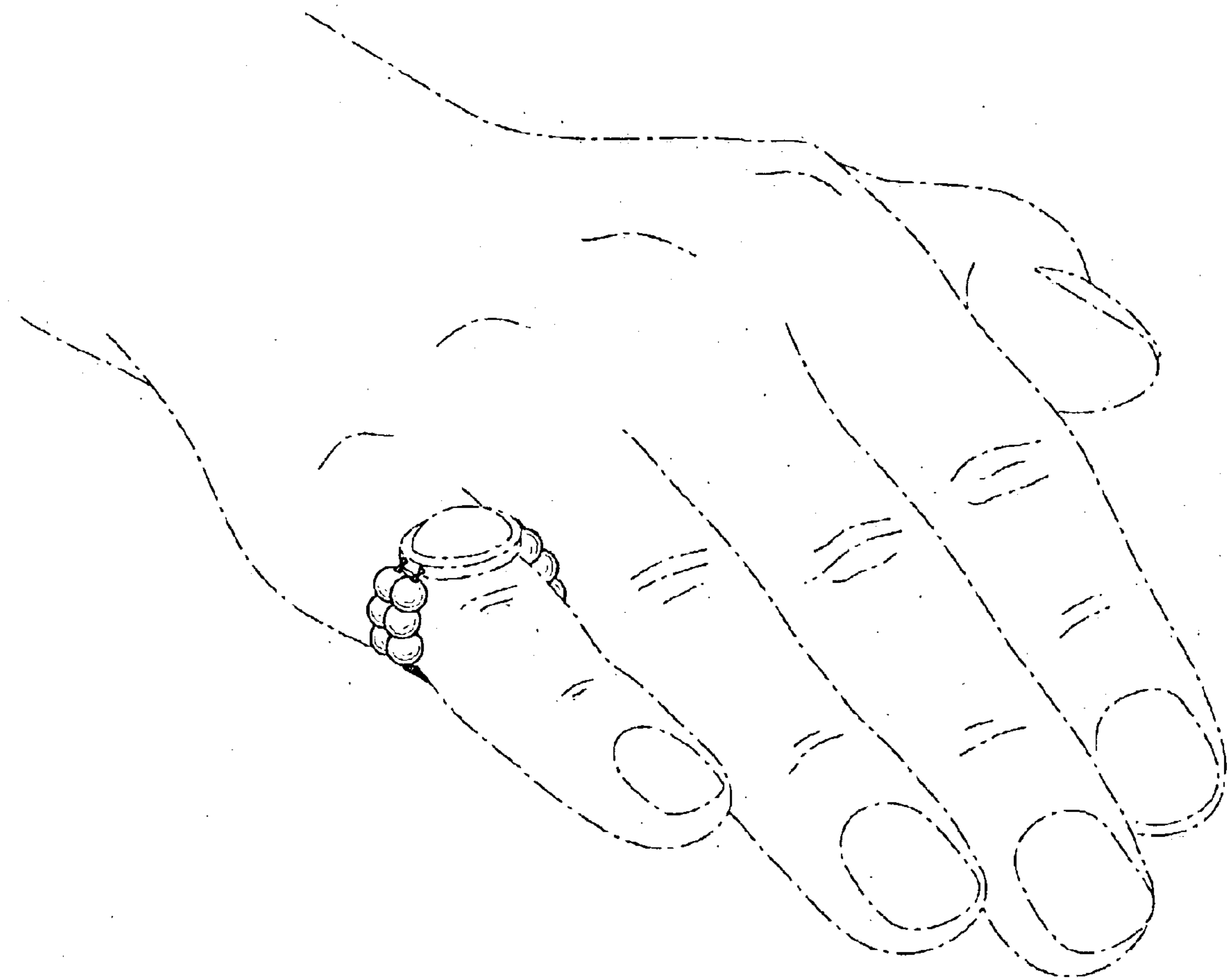

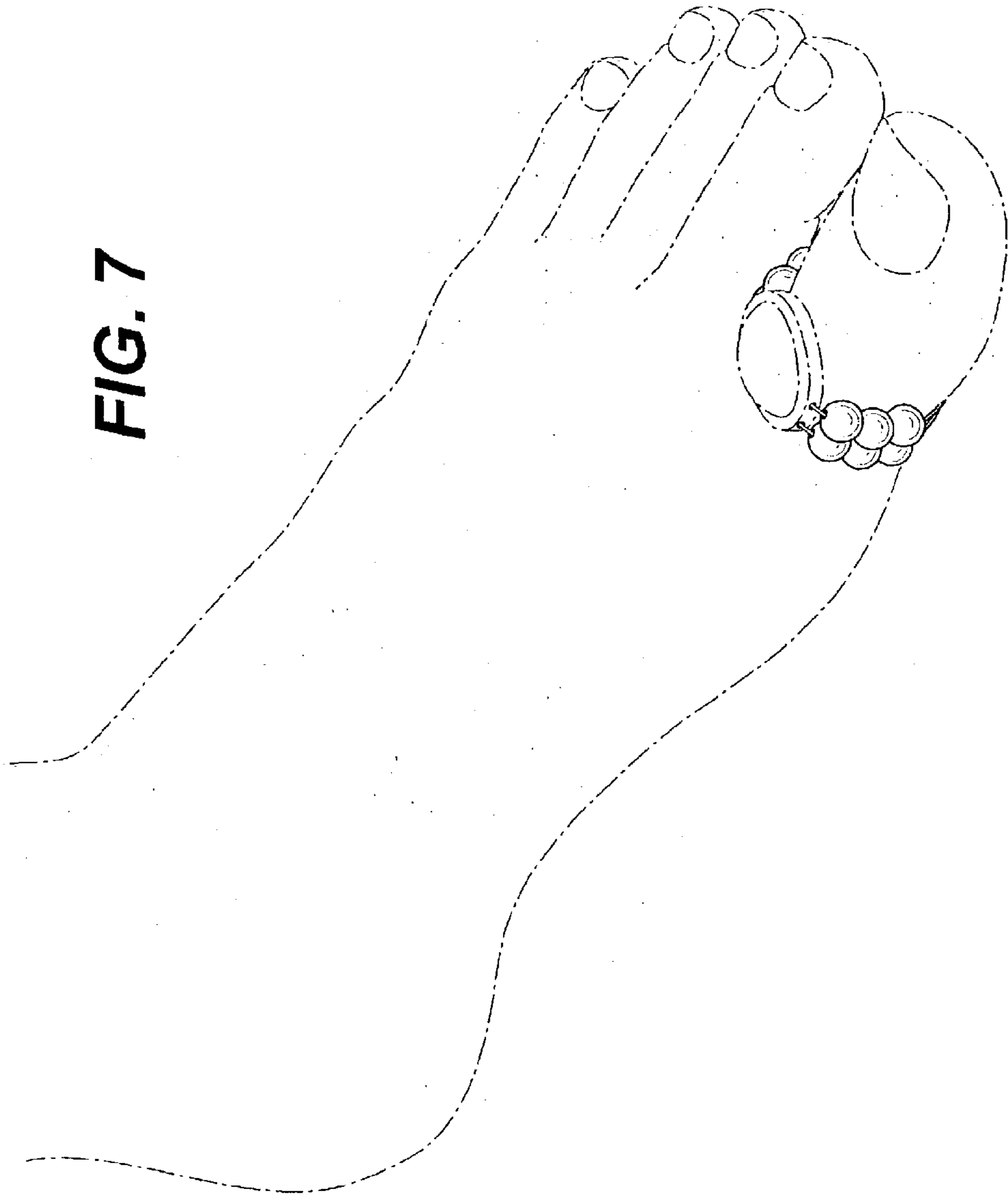
