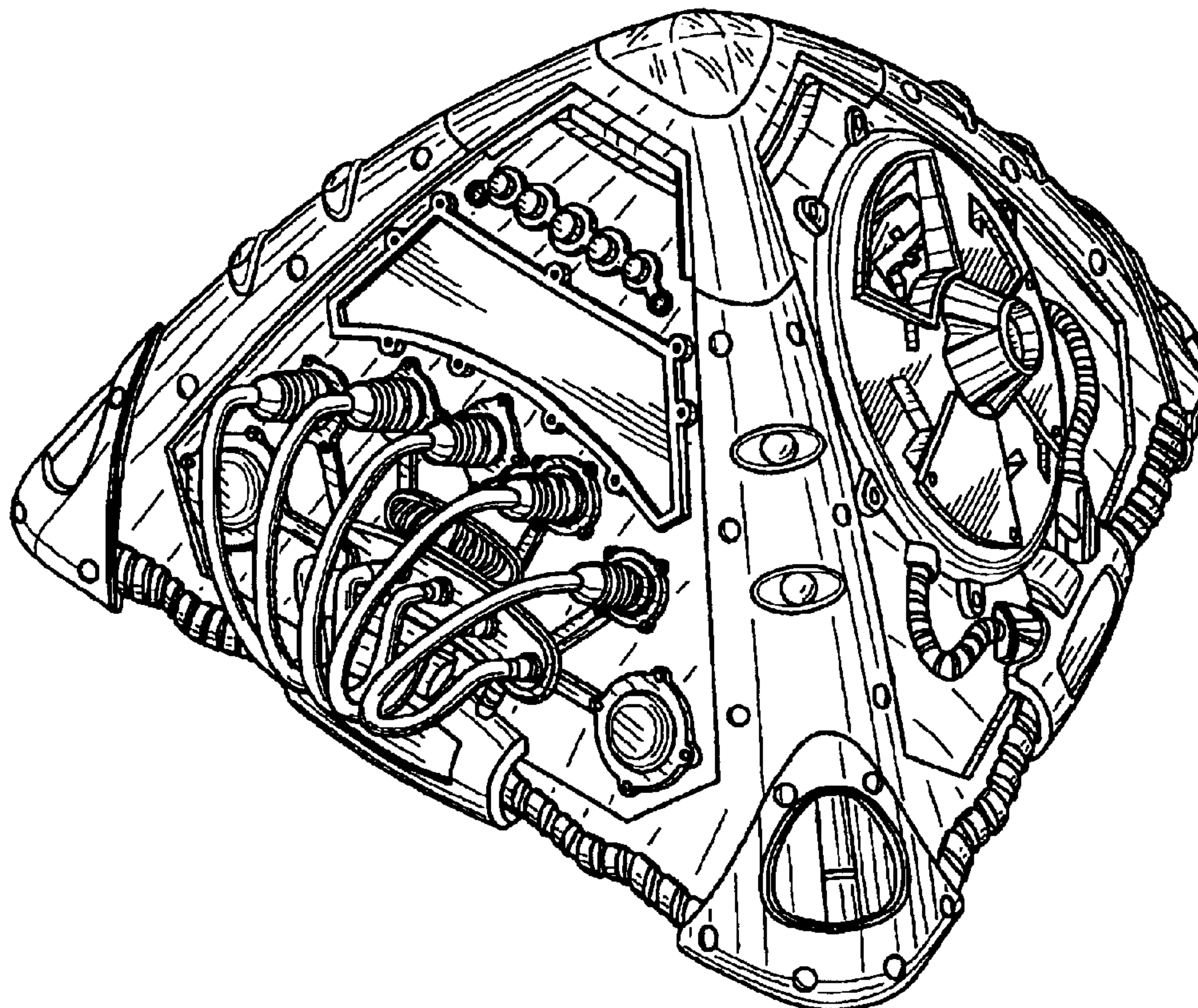
(57) **CLAIM**

The ornamental design for an electronic game, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the electronic game in accordance with an embodiment of the present design; FIG. 2 is a side elevational view of the electronic game illustrated in FIG. 1; FIG. 3 is a side elevational view of the electronic game illustrated in FIGS. 1-2; FIG. 4 is a side elevational view of the electronic game illustrated in FIGS. 1-3; FIG. 5 is a top plan view of the electronic game illustrated in FIGS. 1-4; and, FIG. 6 is a bottom plan view of the electronic game illustrated in FIGS. 1-5.

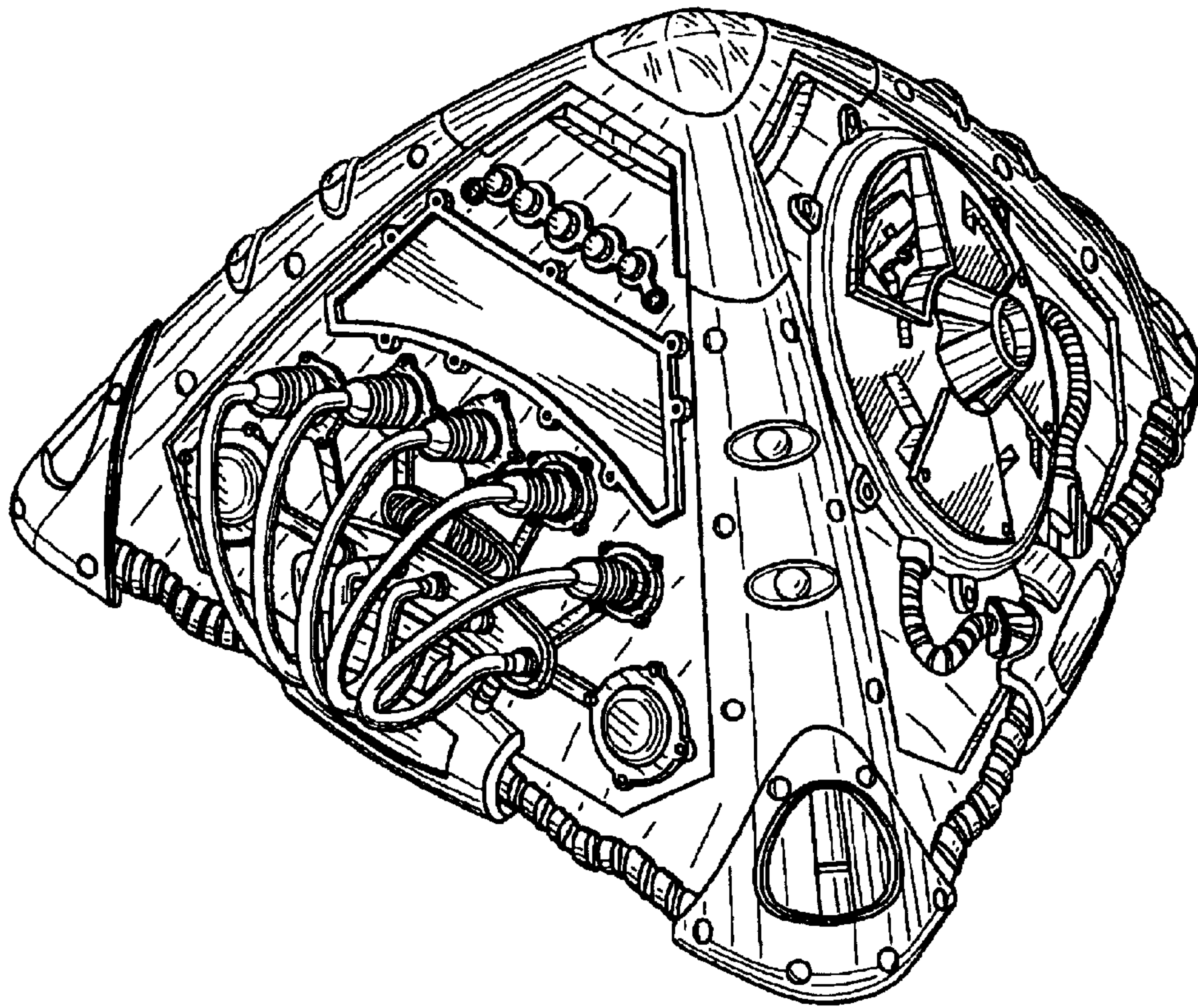

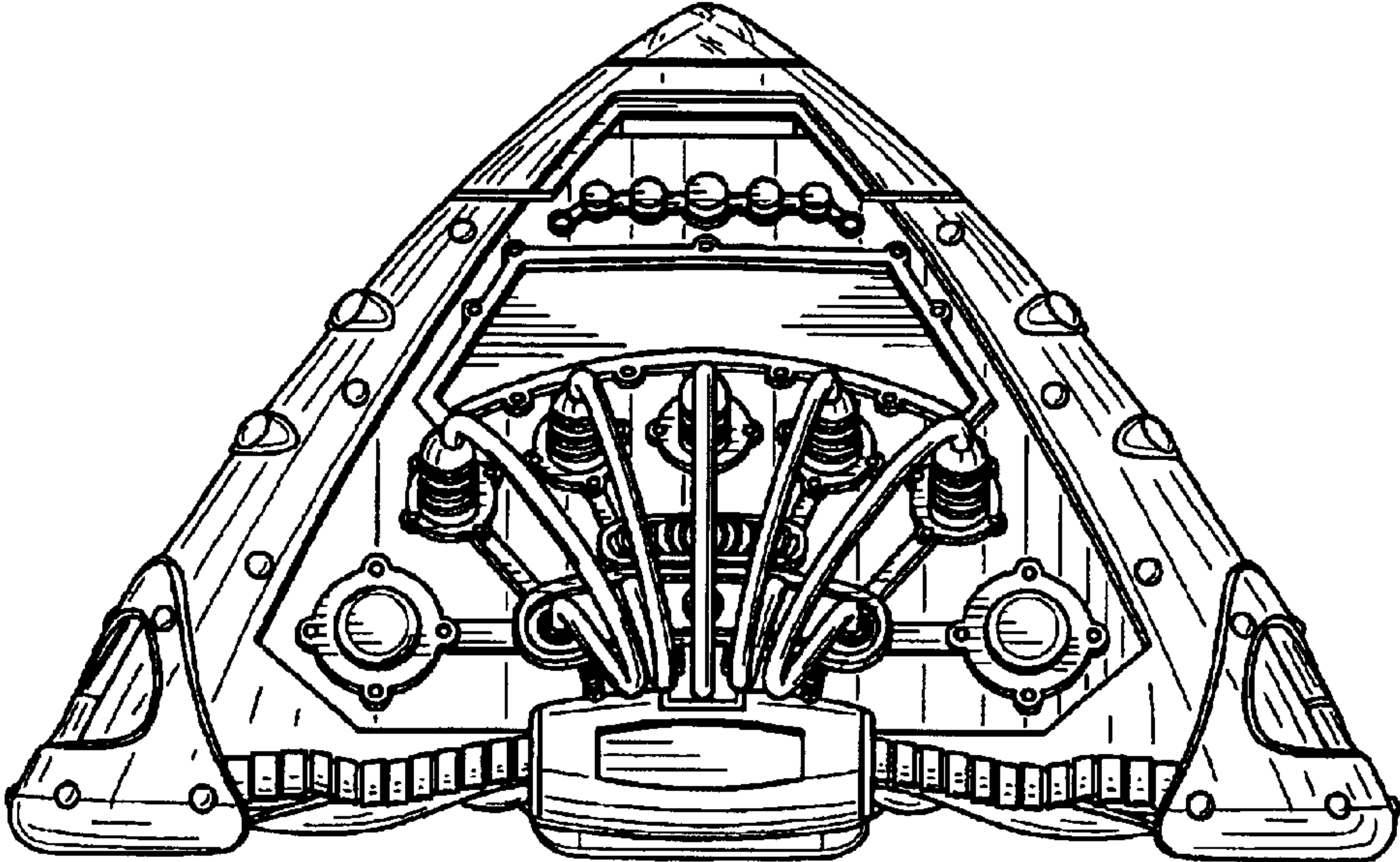

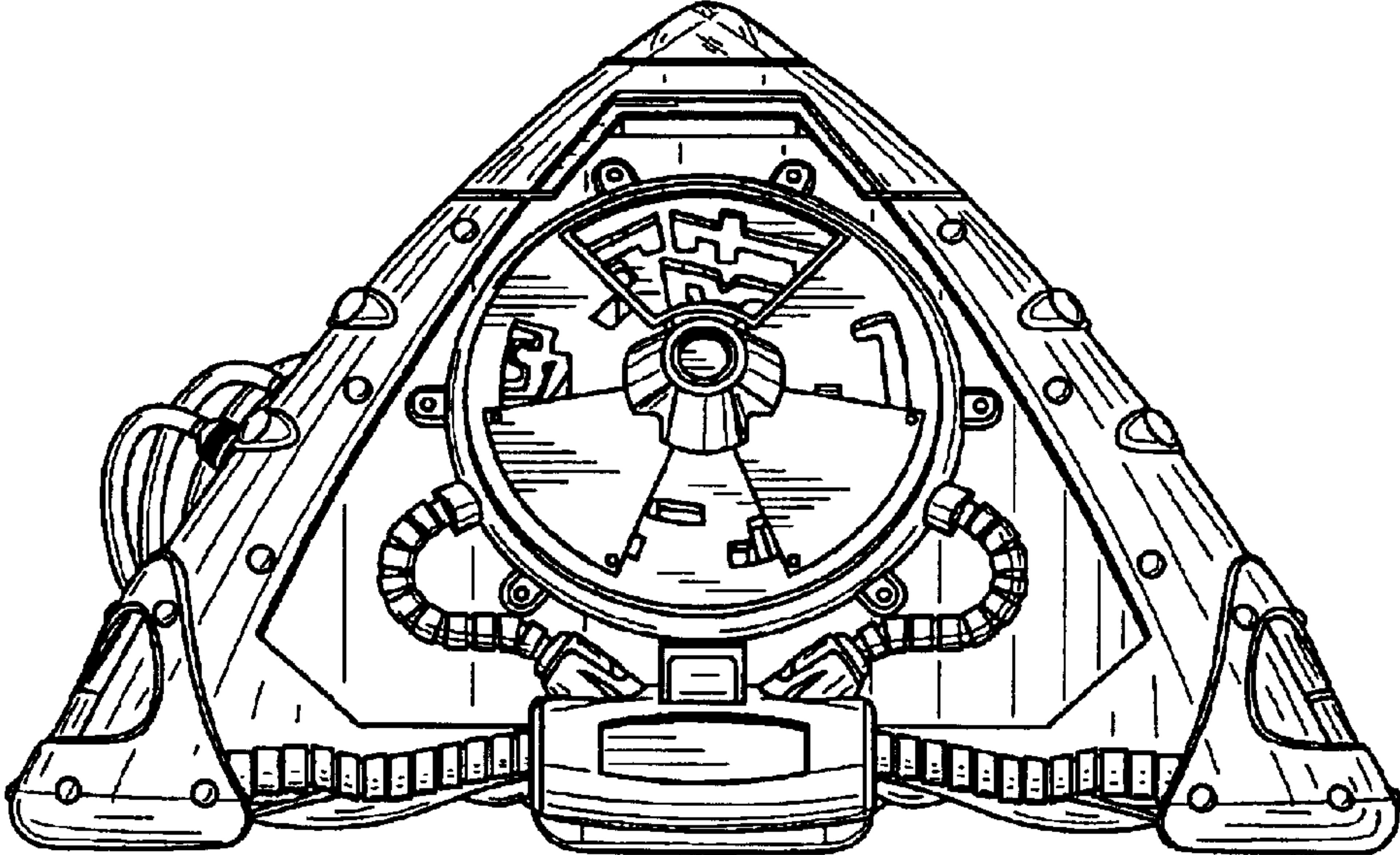

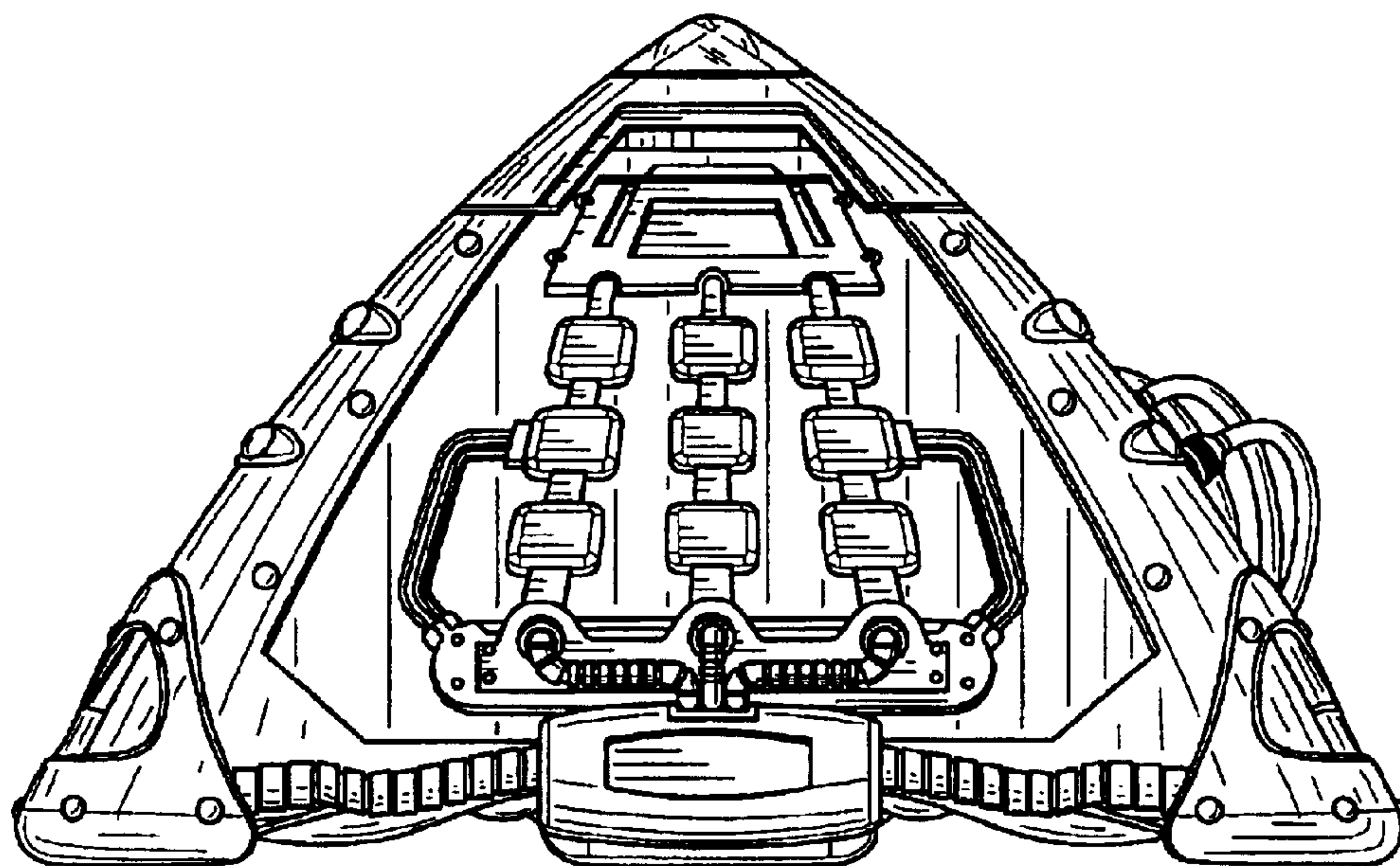

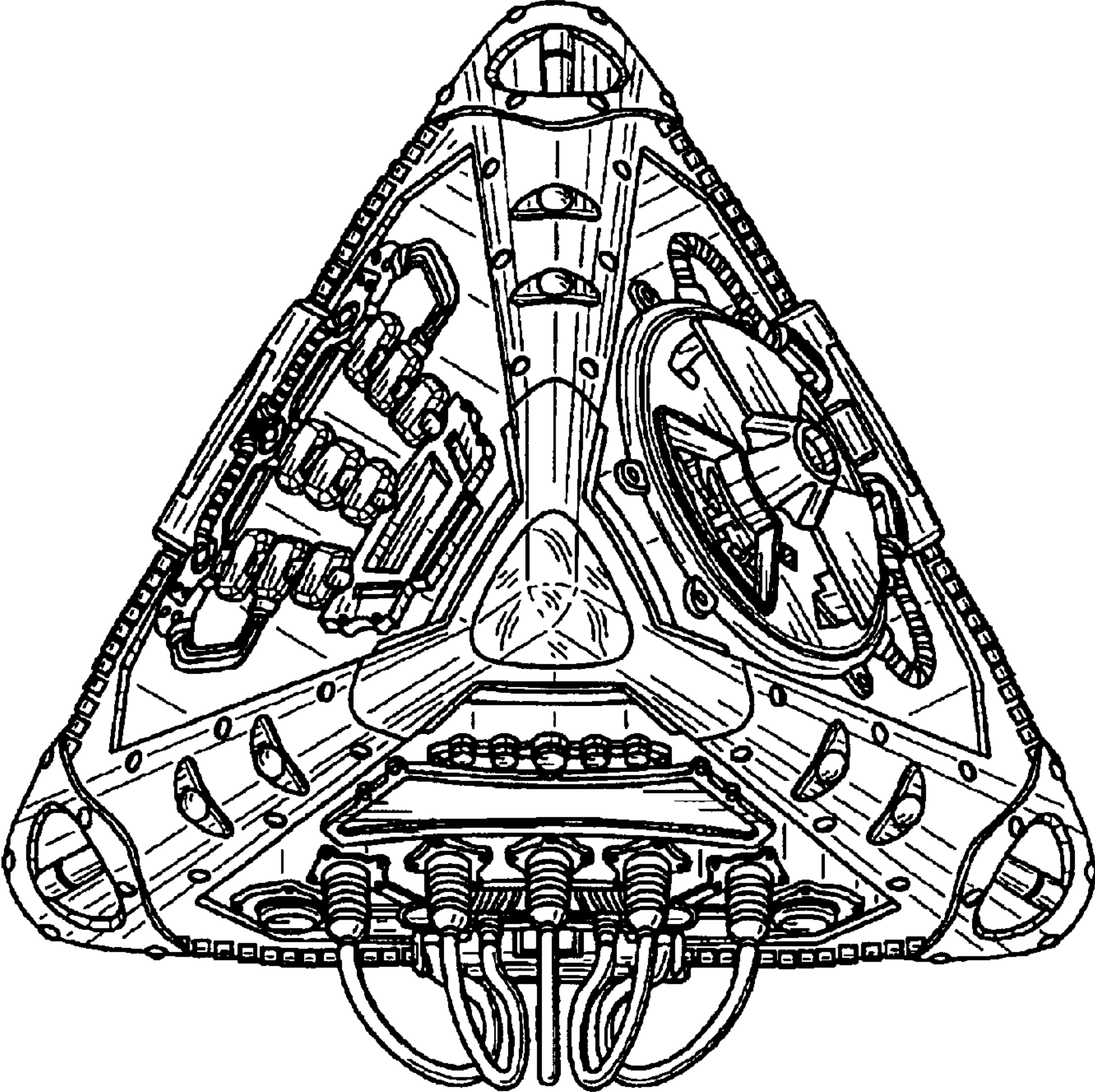

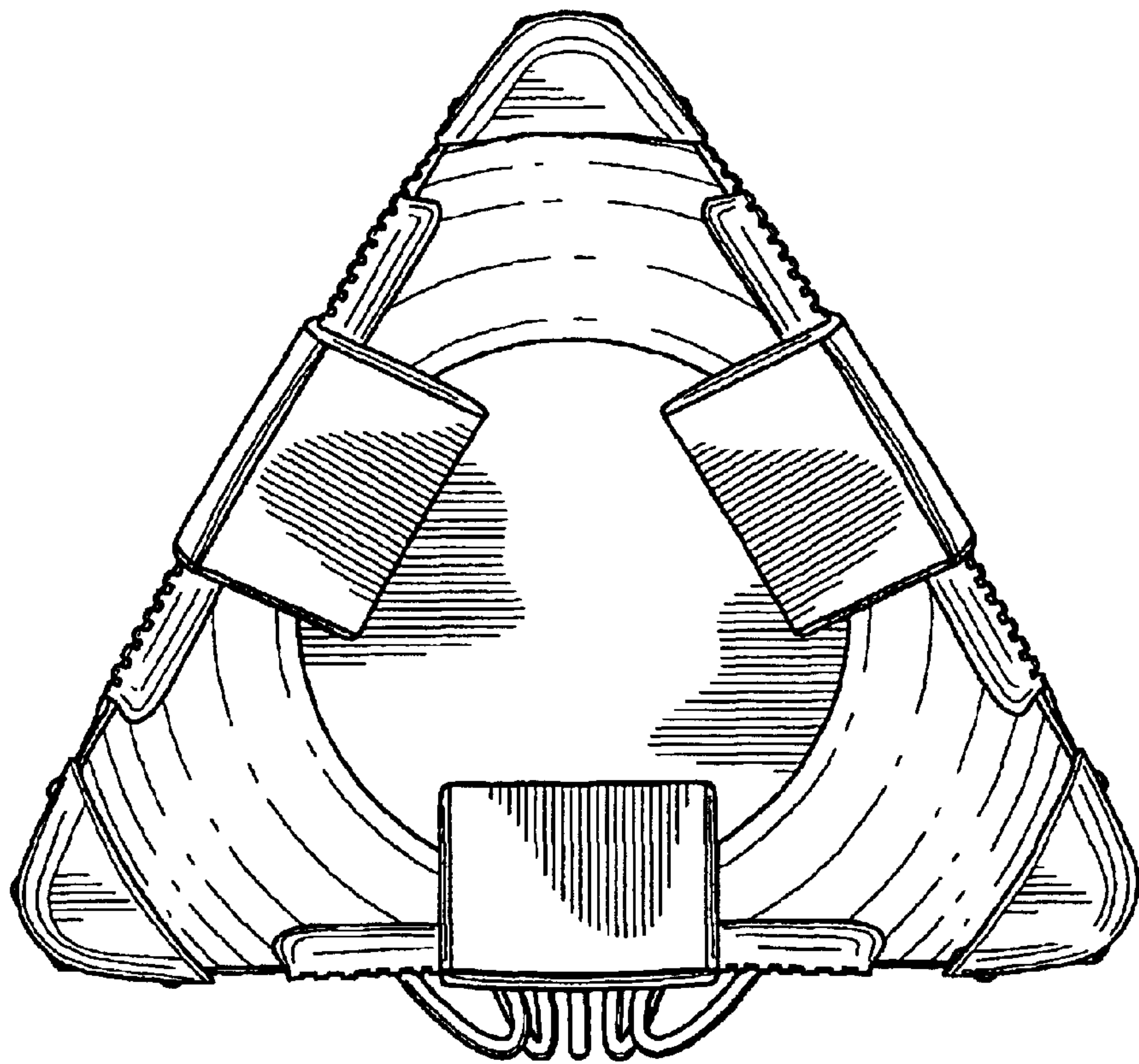
