(57) **CLAIM**

The ornamental design for a wall base with two curves and two flat sections, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a wall base with two curves and two flat sections, embodying this invention;

FIG. 2 is a top view of the wall base with two curves and two flat sections, shown in FIG. 1;

FIG. 3 is a front view of the wall base with two curves and two flat sections, shown in FIG. 1;

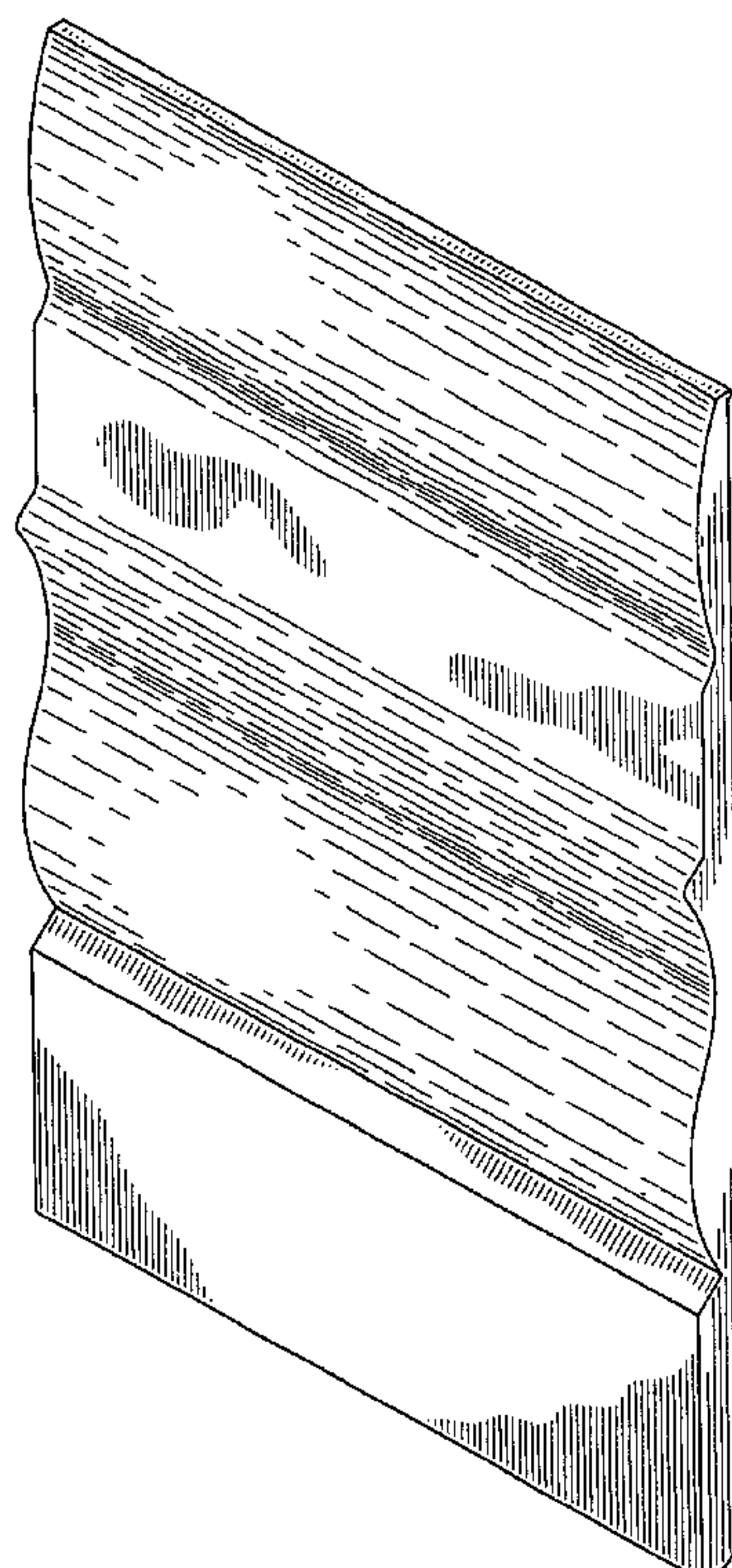
FIG. 4 is a right side view of the wall base with two curves and two flat sections, shown in FIG. 1;

FIG. 5 is a rear view of the wall base with two curves and two flat sections, shown in FIG. 1;

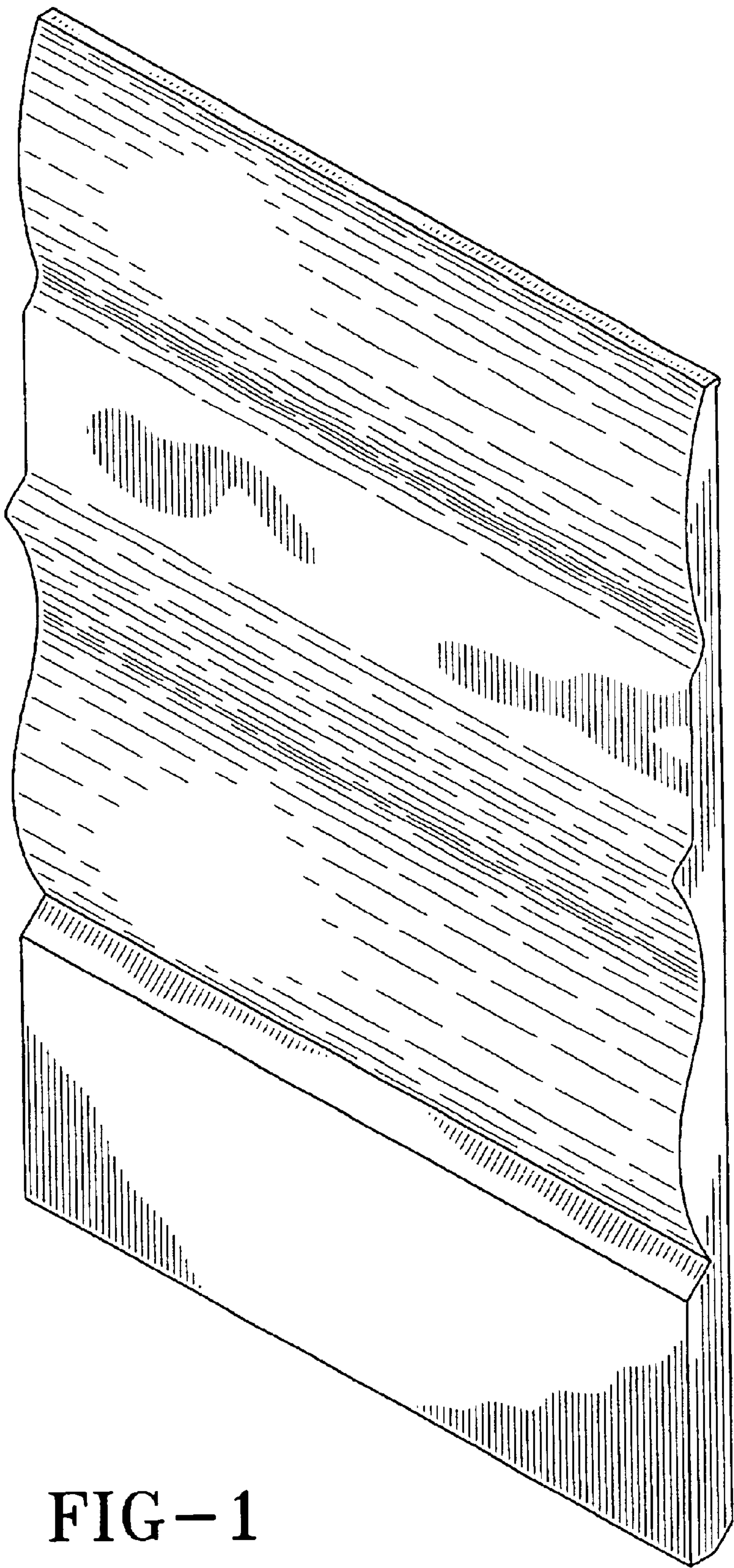

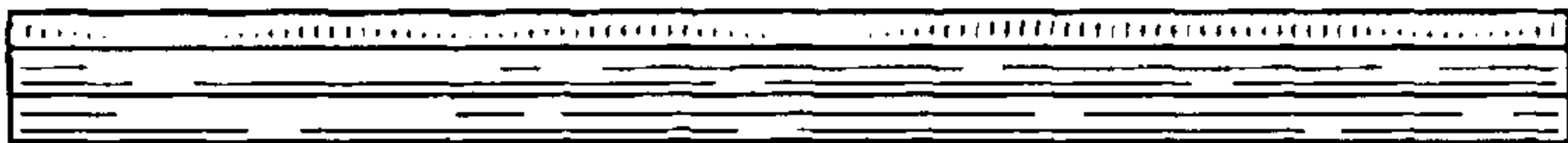

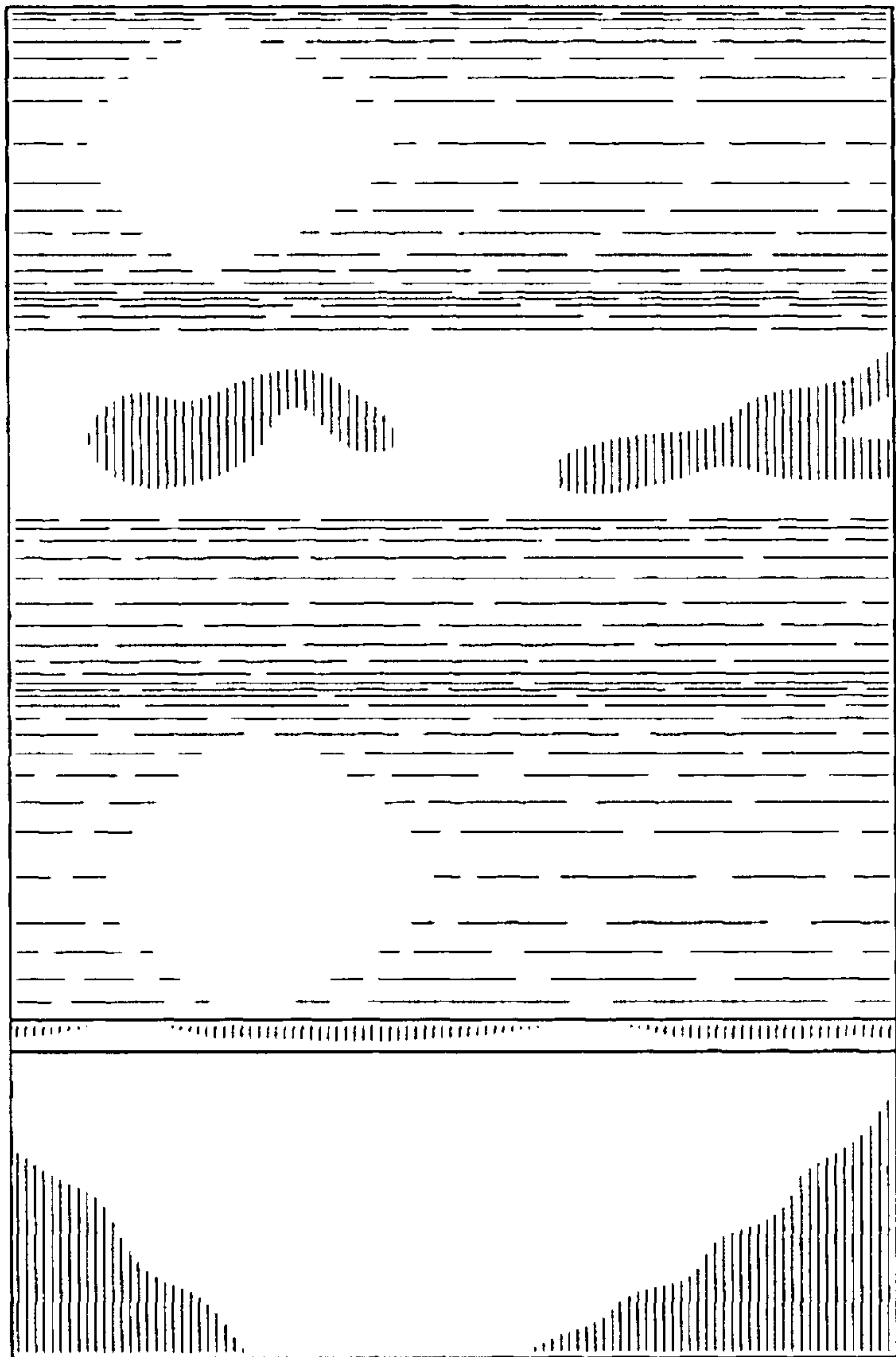

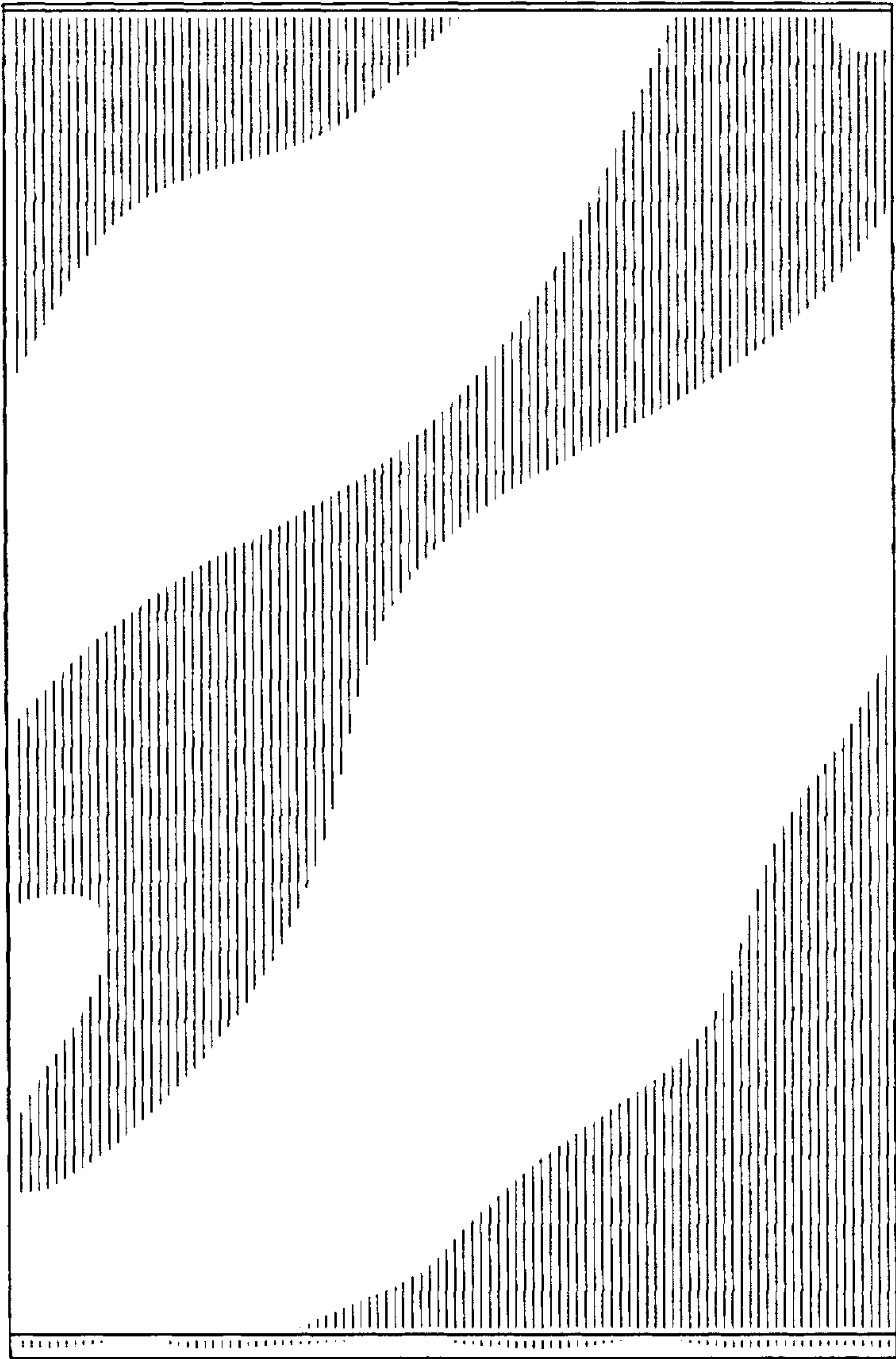

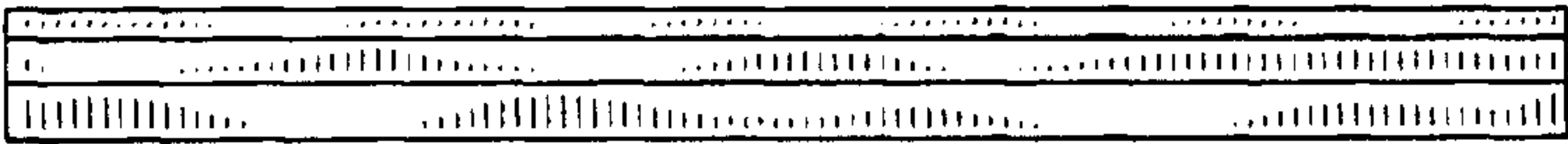
