The ornamental design for a light fixture, as shown and described.

**DESCRIPTION**

FIG. 4 is a back elevational view thereof;

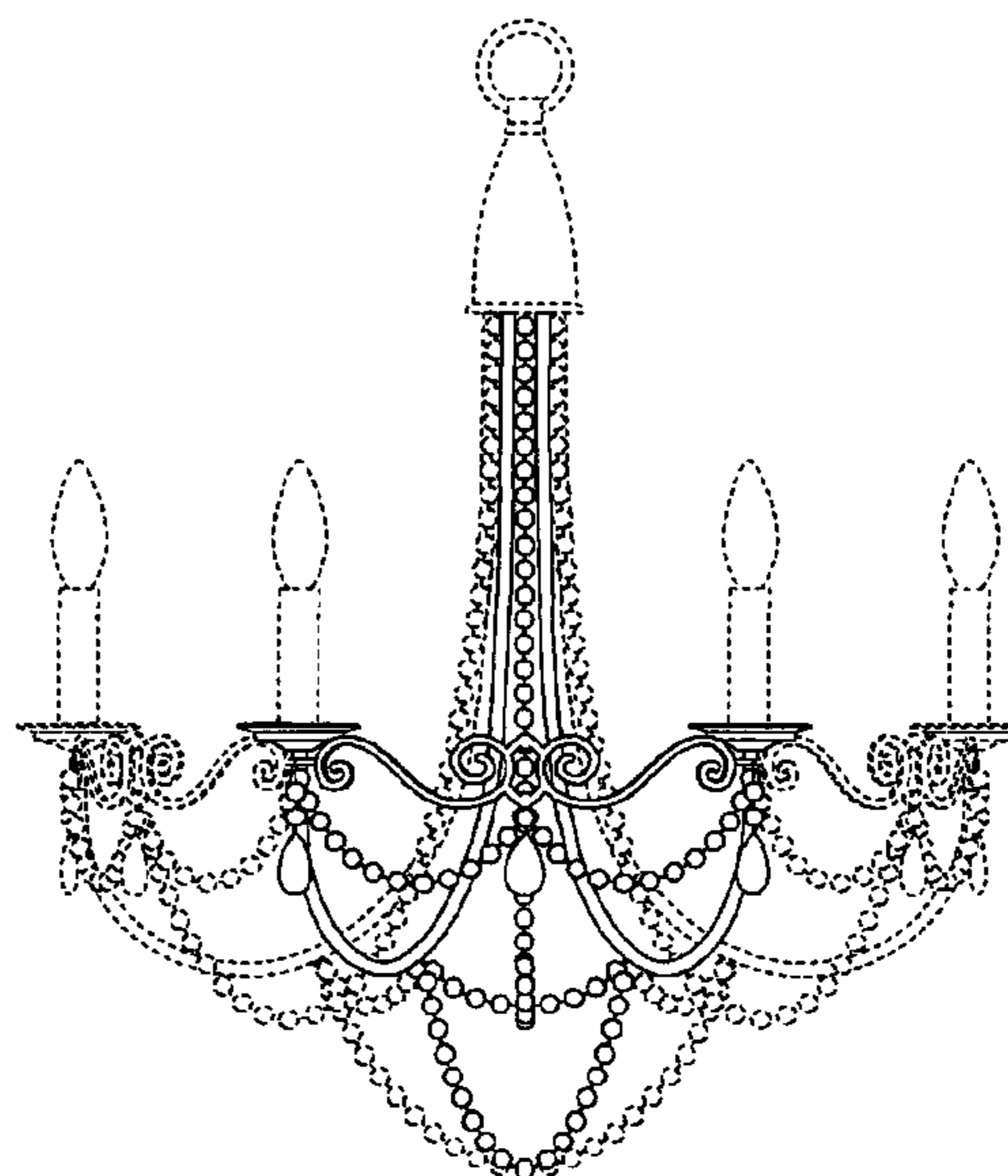
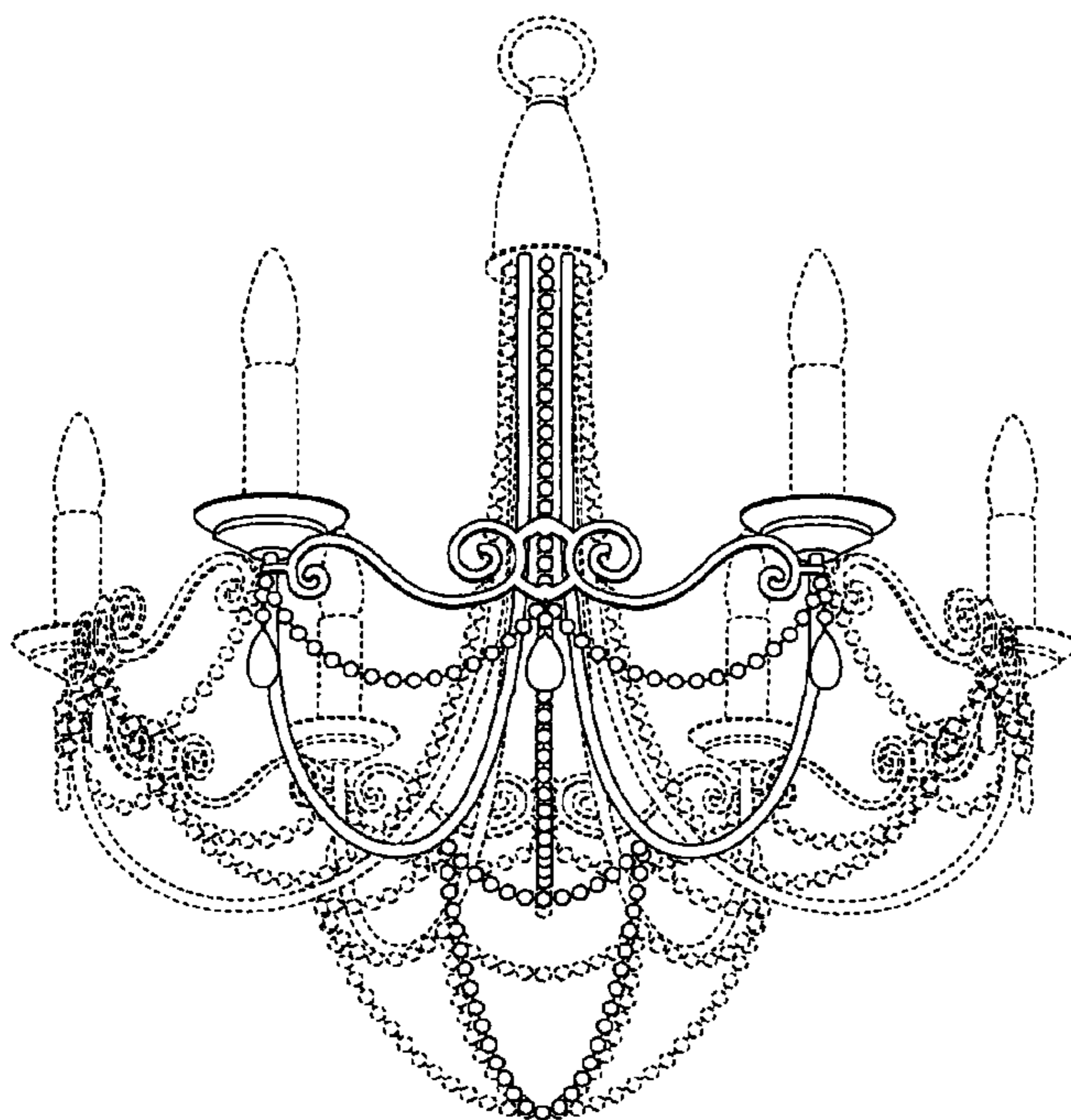
FIG. 5 is a top plan view thereof; and,

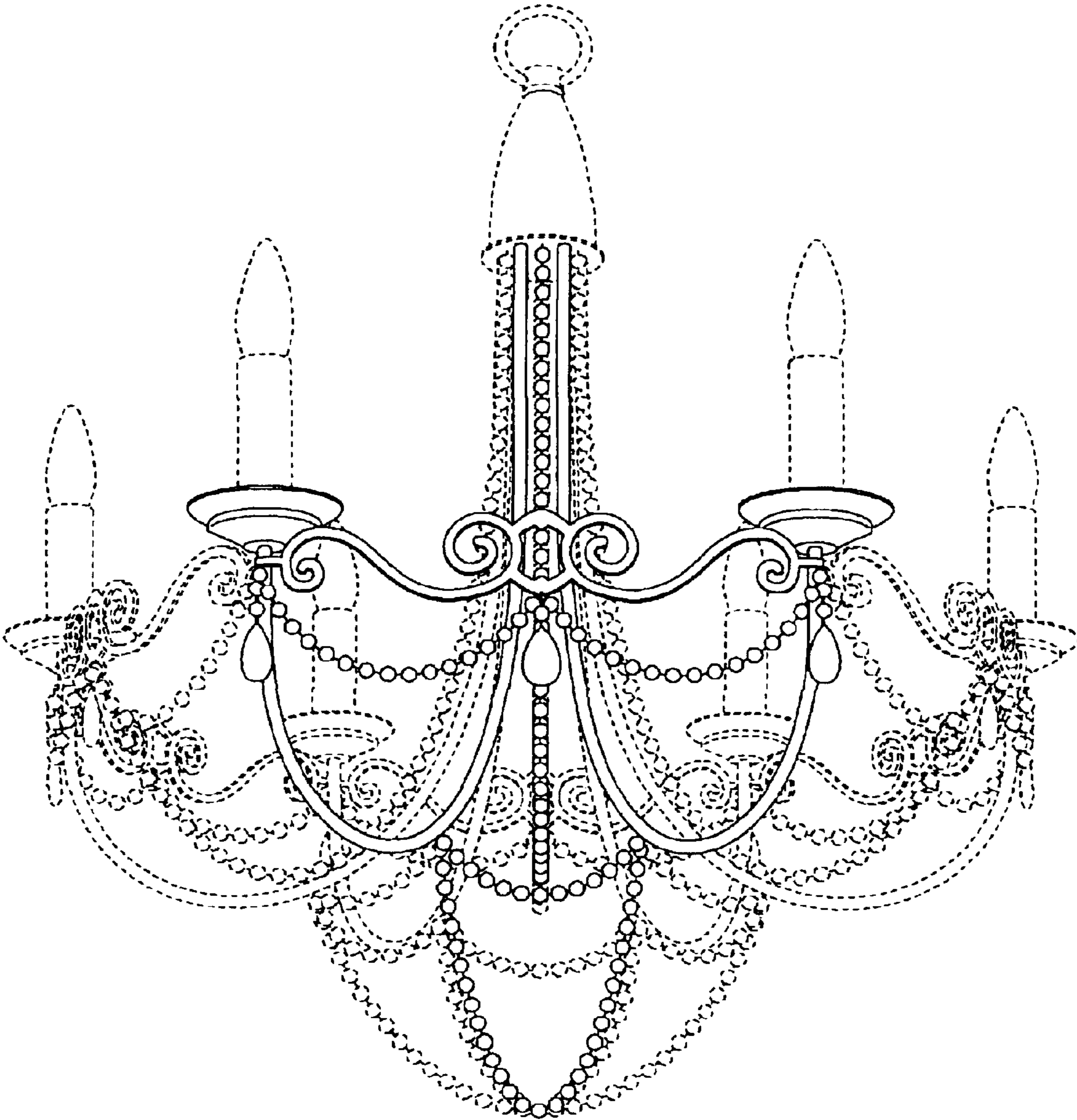
FIG. 6 is a bottom plan view thereof.

FIG. 1-FIG. 6 showing chains of translucent crystals defining arcs in space and crystal drop ornamentation.

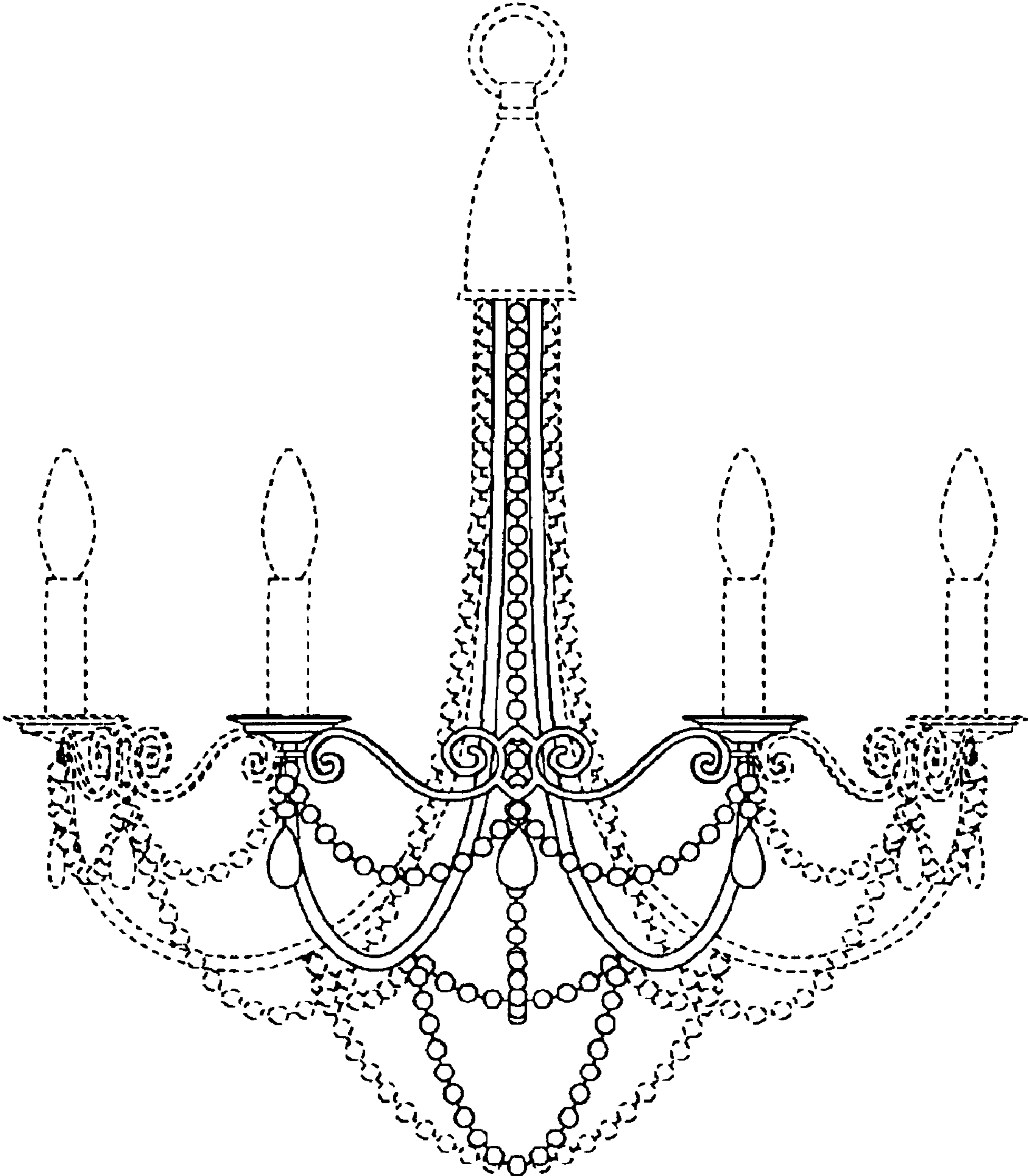

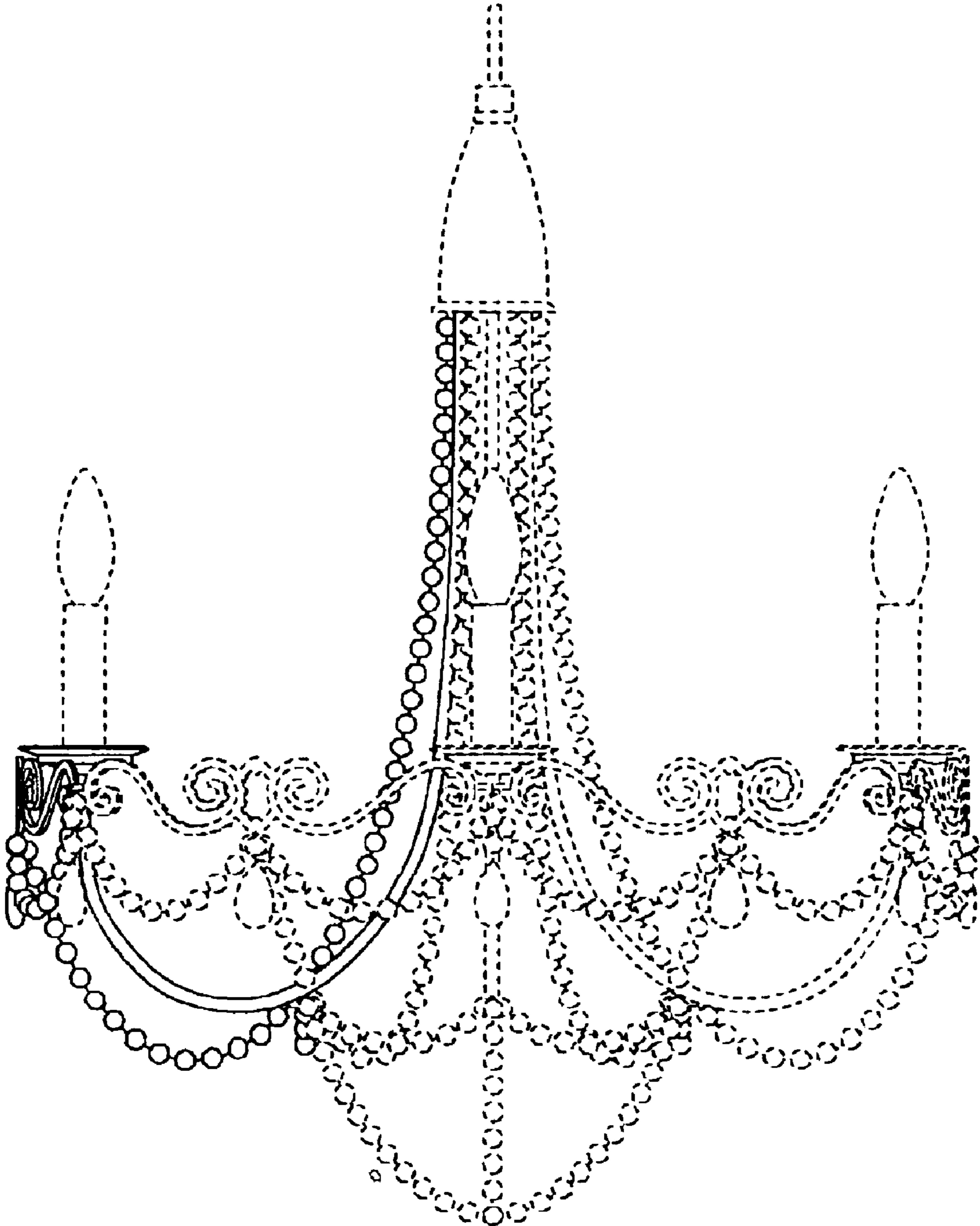




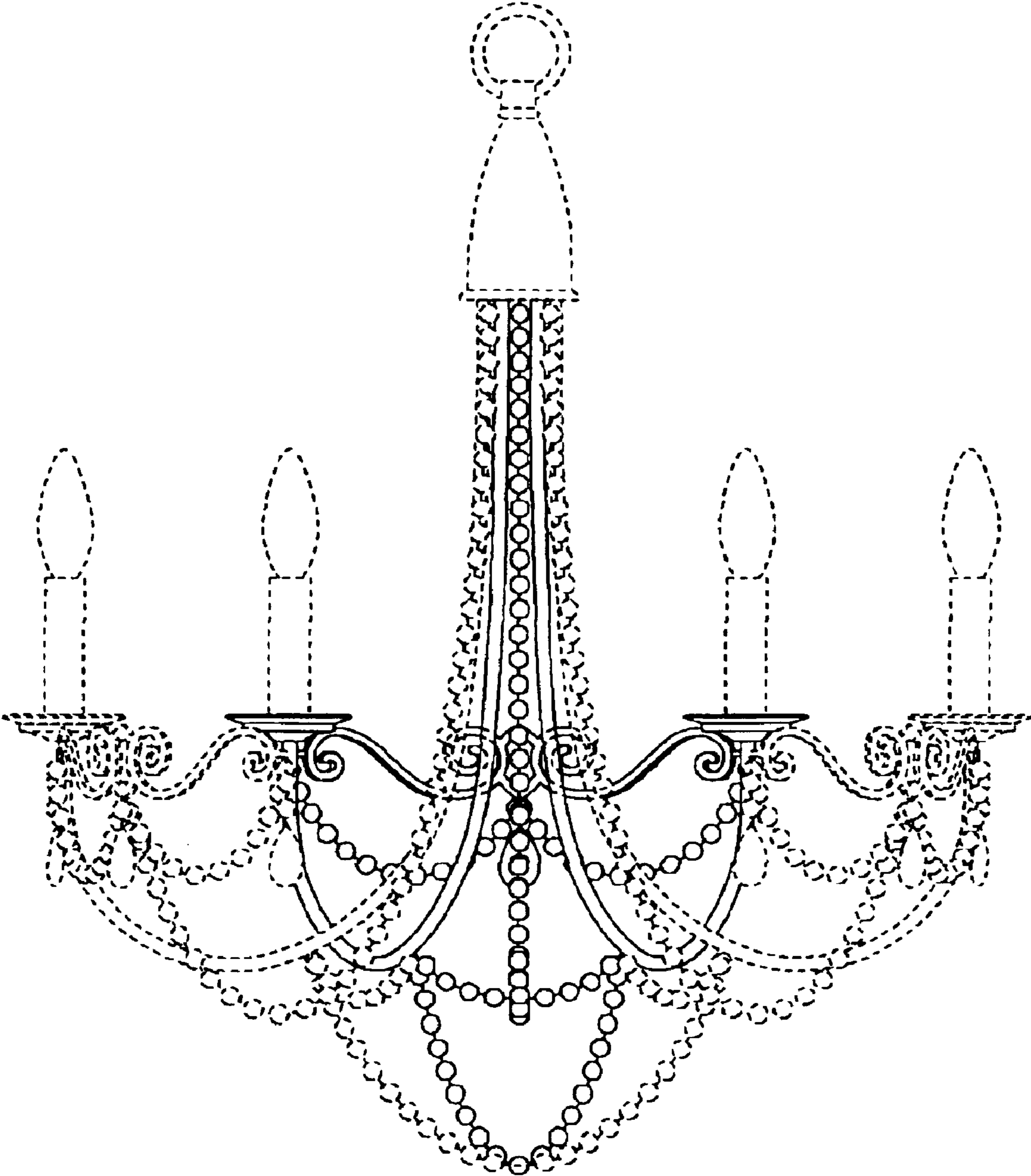

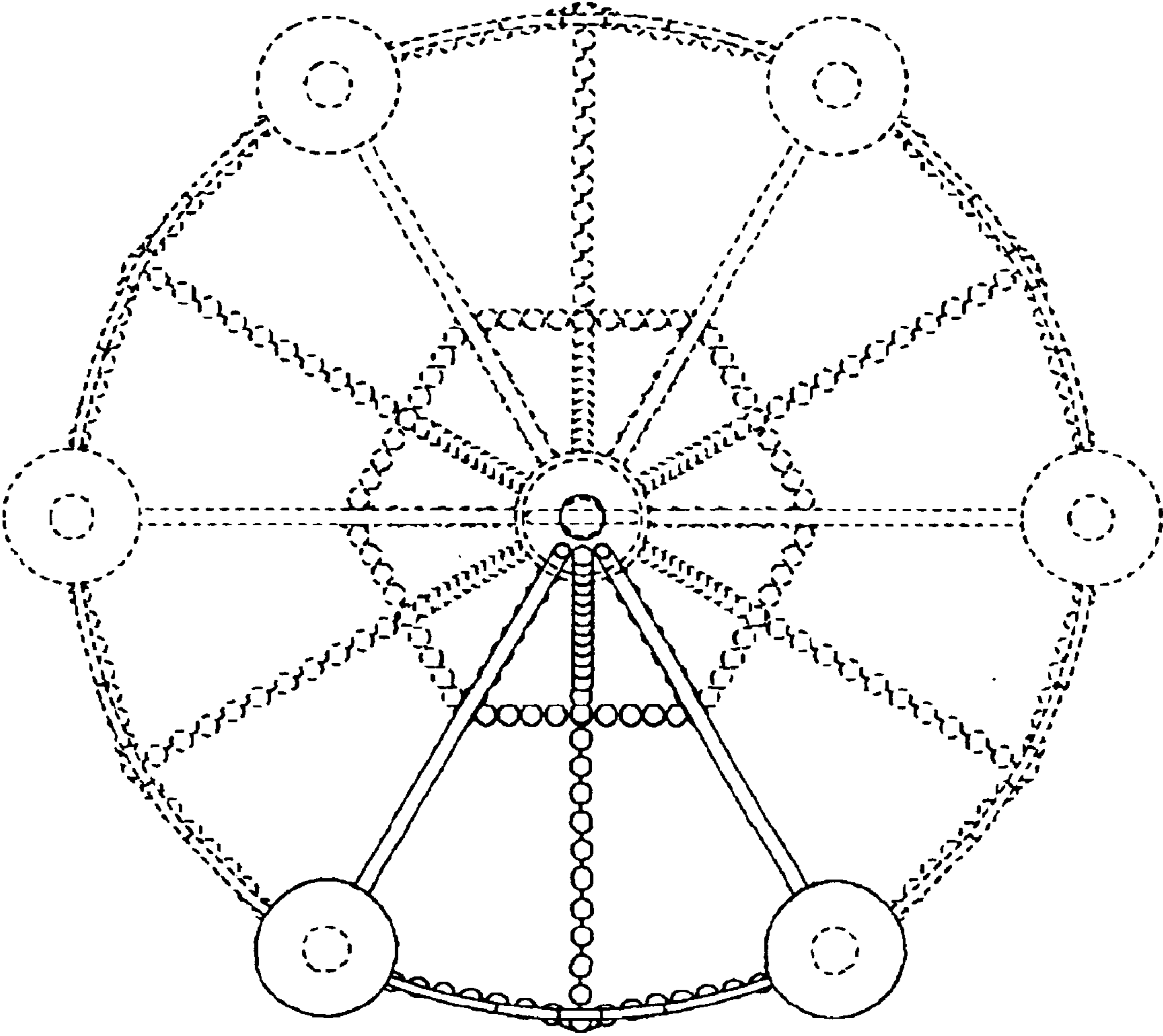

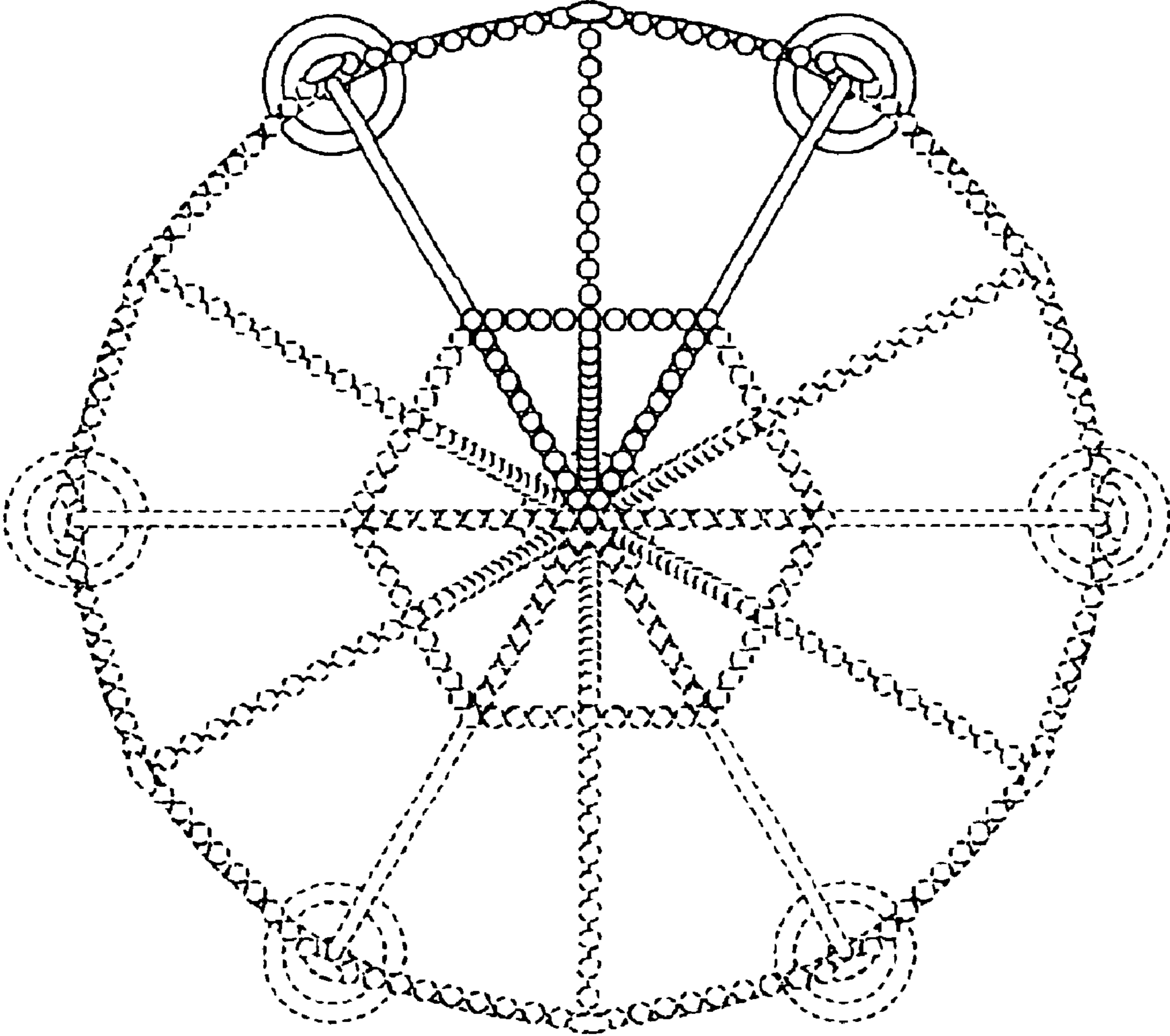
