(57) **CLAIM**

The ornamental design for a palm-held liquid and lotion applicator, as shown and described.

DESCRIPTION

FIG. 1 illustrates a top perspective view of a first embodiment of a palm-held liquid and lotion applicator showing my new design;

FIG. 2 illustrates a bottom perspective view thereof;

FIG. 3 illustrates a side view thereof, the opposite side is a mirror image thereto except for the continuous screw threading on the neck;

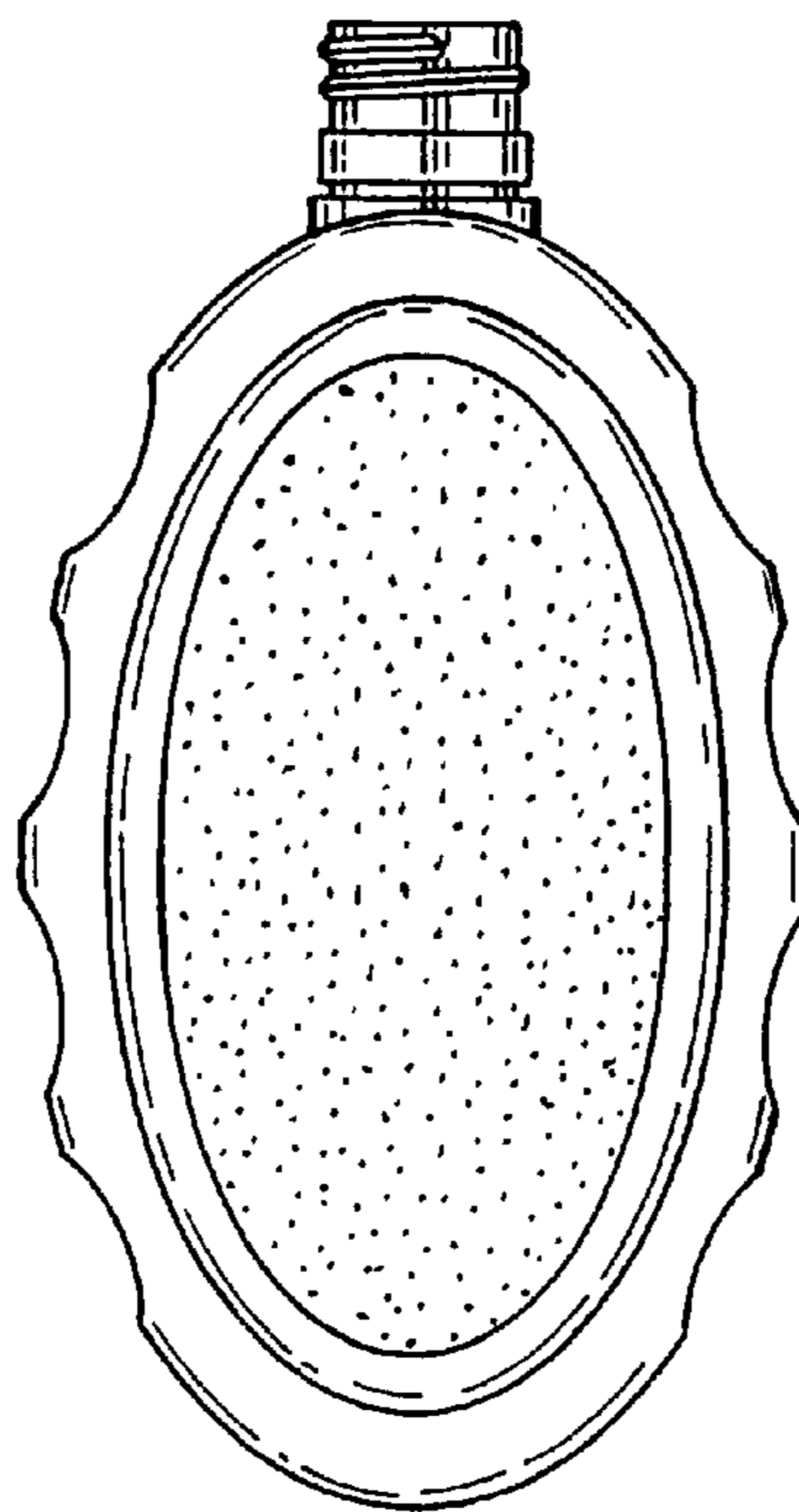
FIG. 4 illustrates a top plan view thereof;

FIG. 5 illustrates a perspective view of another embodiment thereof;

FIG. 6 illustrates a top plan view of the second embodiment, the rear view being the same except for the continuous screw threading on the neck; and,

FIG. 7 illustrates a side view of the second embodiment, the opposite side view is the same except for the continuous screw threading on the neck.

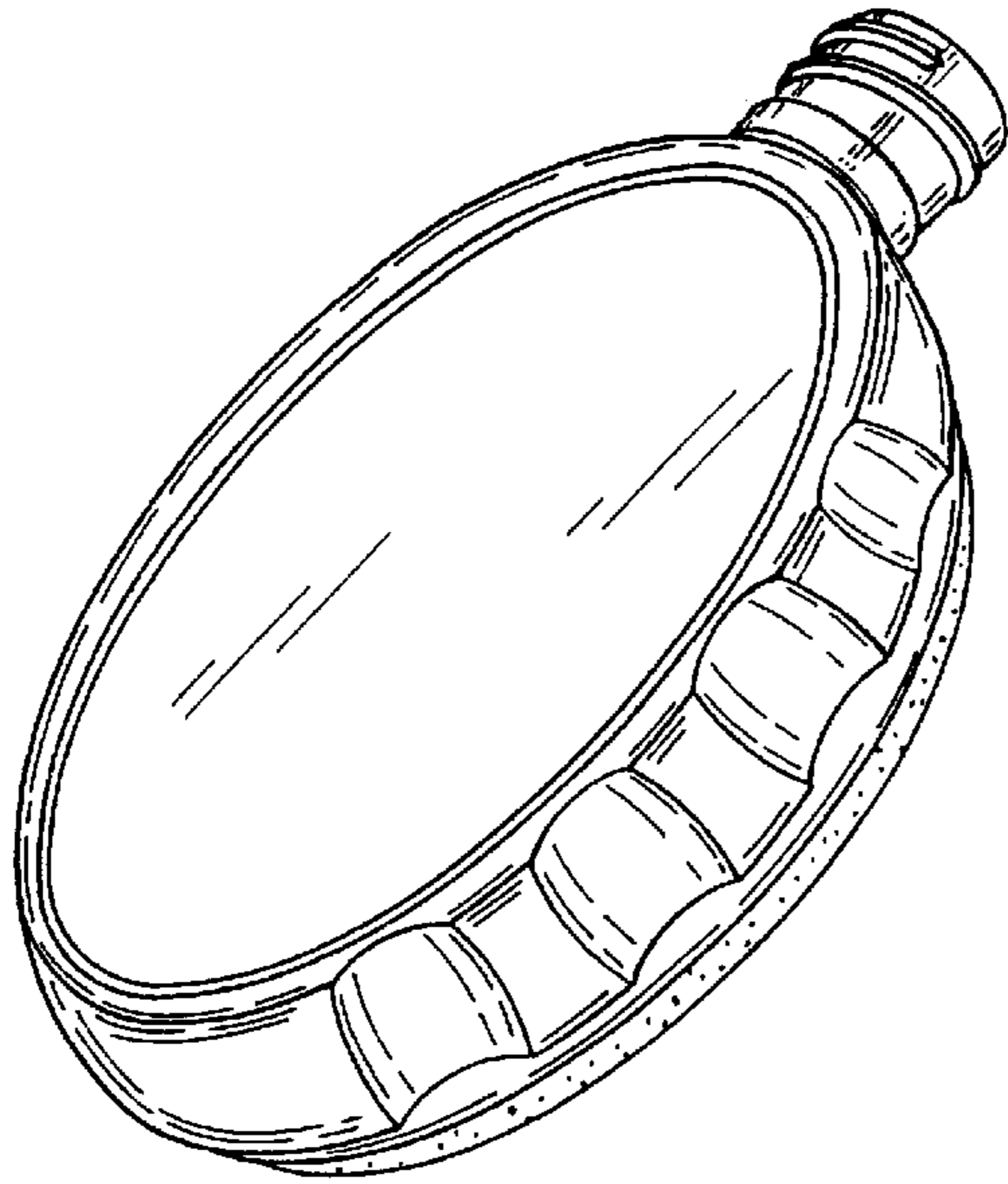

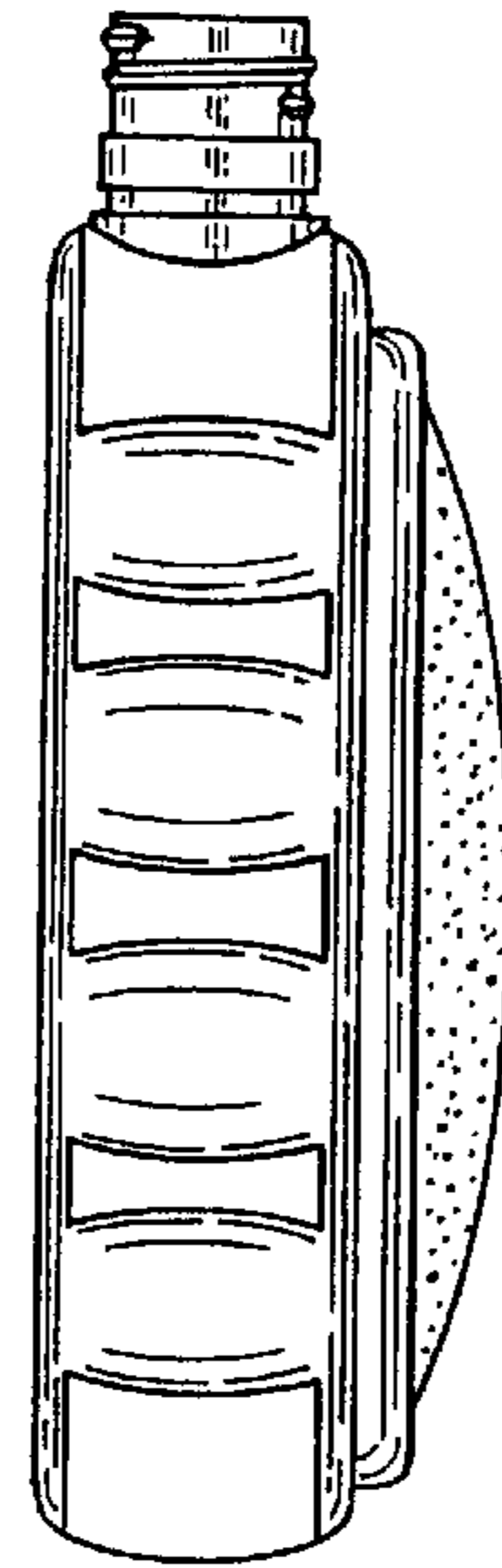

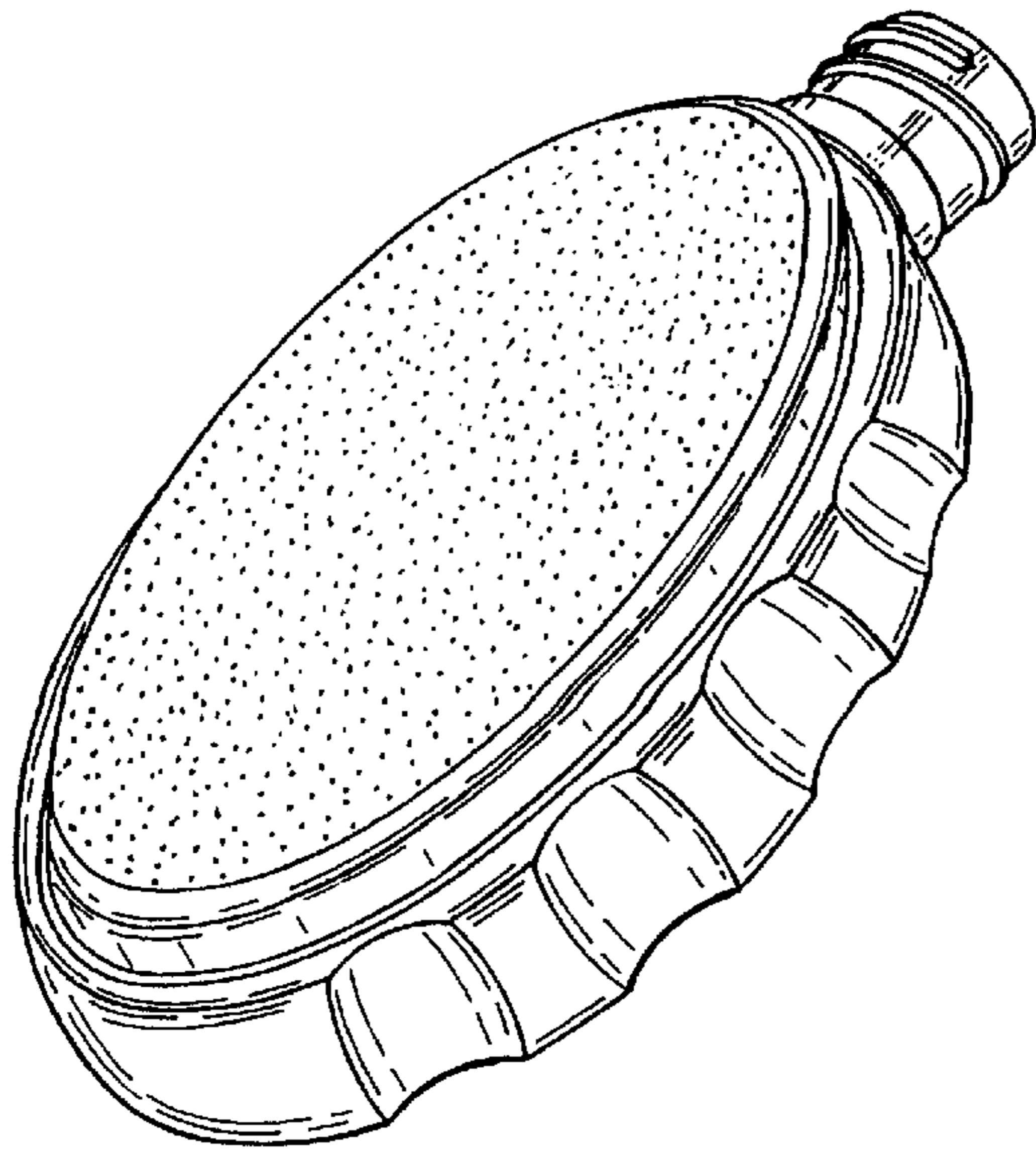

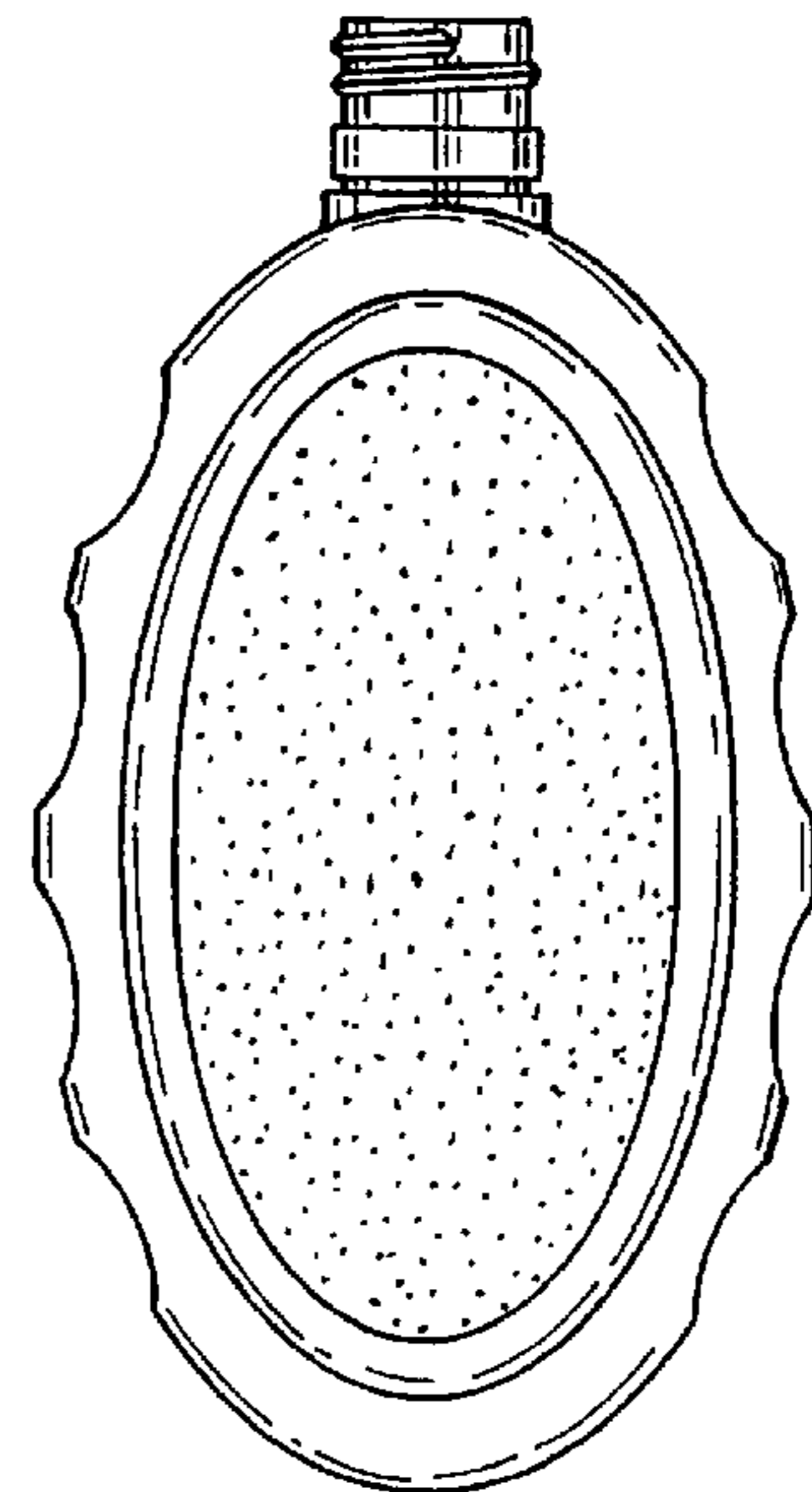

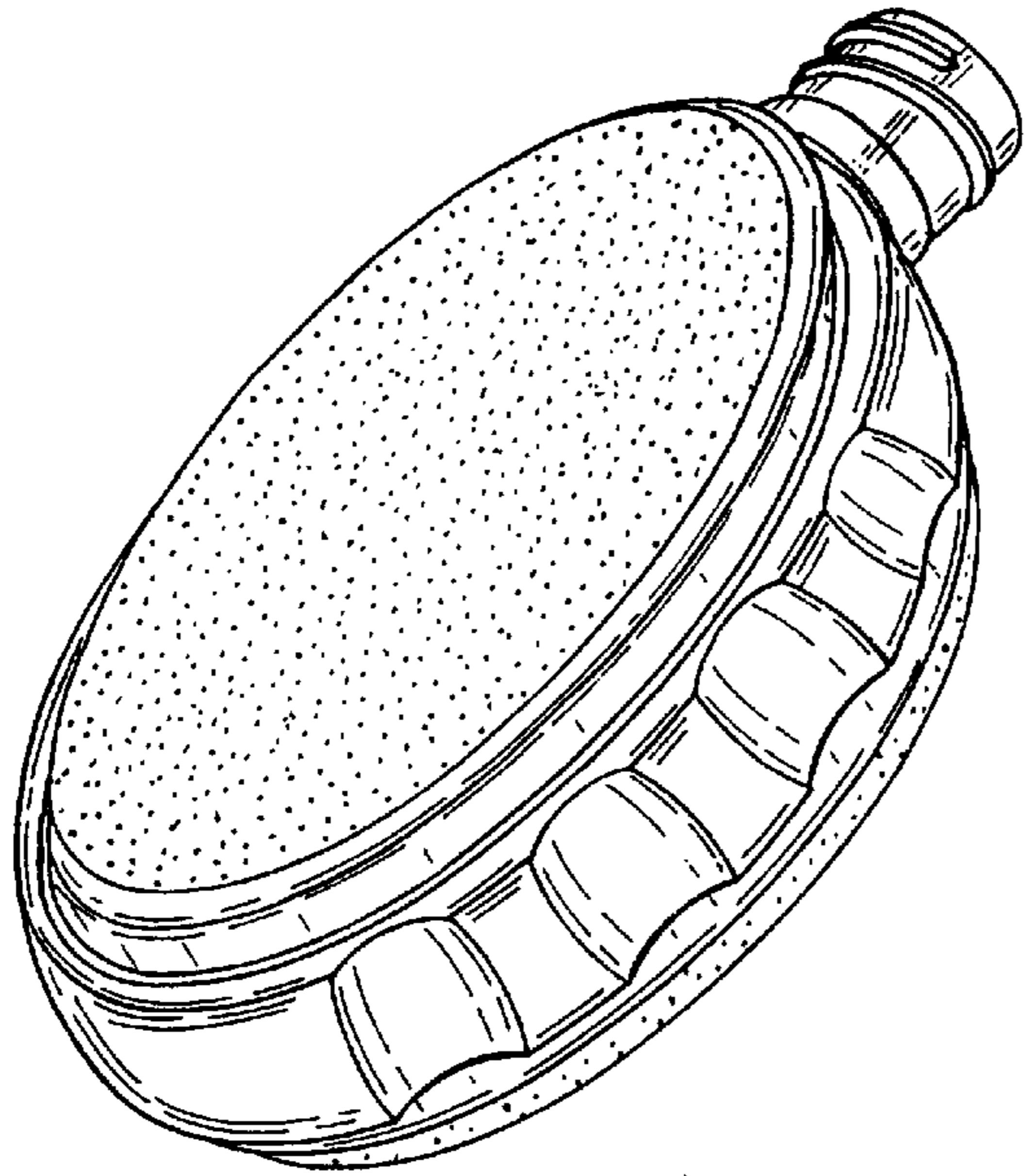

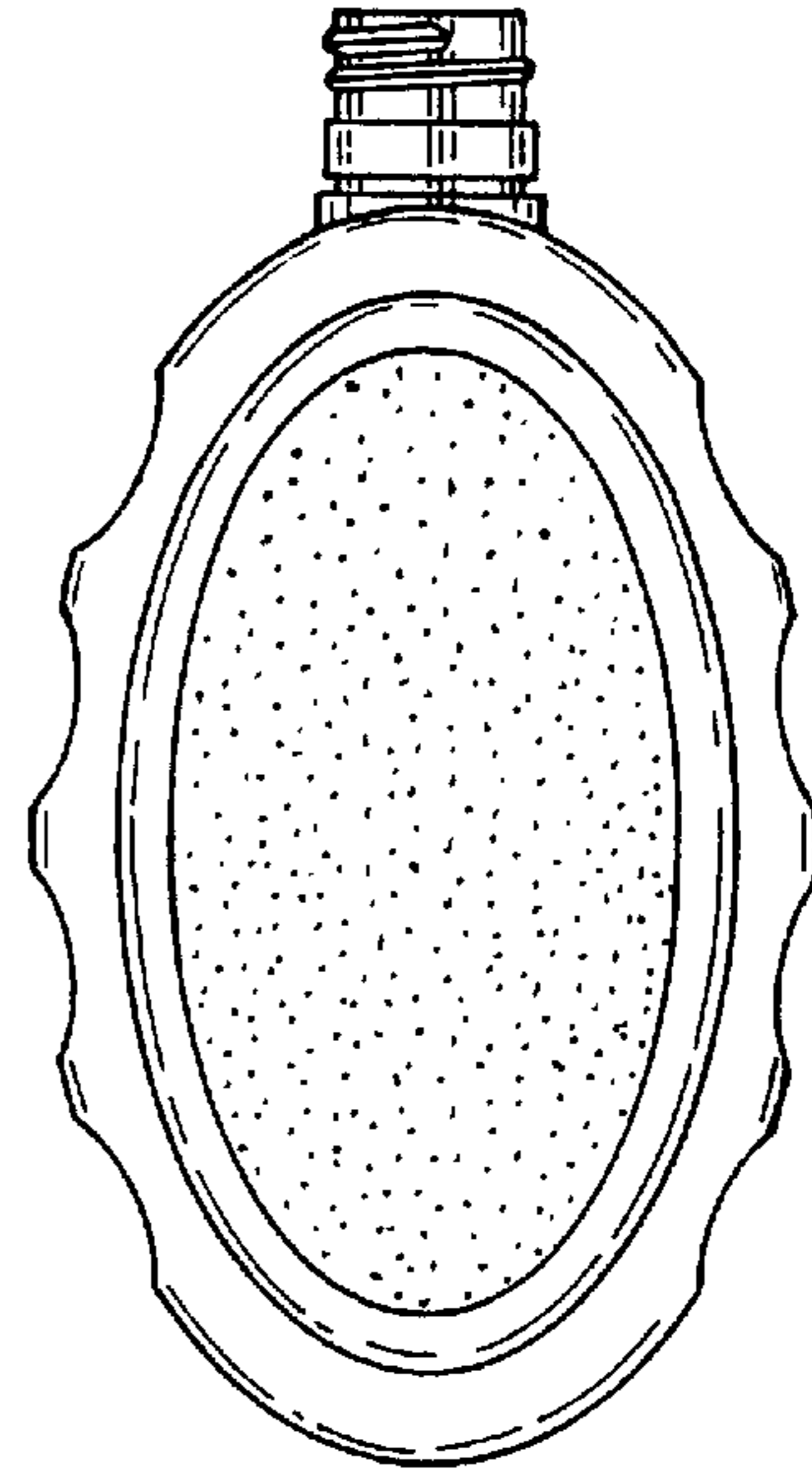

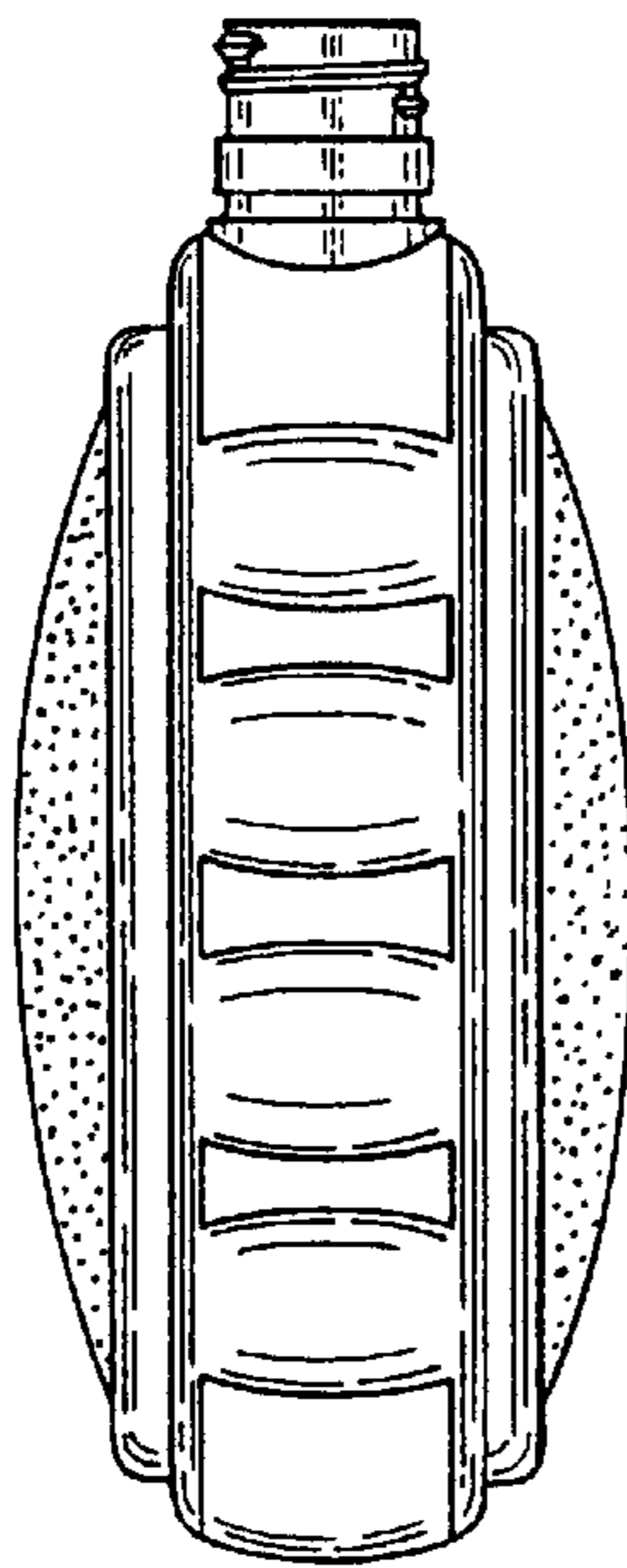
