(57) **CLAIM**

The ornamental design for a miniature hair trimmer housing,  
as shown and described.

FIG. 1 is a perspective view of one embodiment of a miniature hair trimmer housing of the present invention;

FIG. 2 is a front view of the miniature trimmer of FIG. 1;

FIG. 3 is a right side view of the miniature hair trimmer housing of FIG. 1;

FIG. 4 is a left side view of the miniature hair trimmer housing of FIG. 1;

FIG. 5 is a rear view of the miniature hair trimmer housing of FIG. 1;

FIG. 6 is a top view of the miniature hair trimmer housing of FIG. 1;

FIG. 7 is a bottom view of the miniature hair trimmer housing of FIG. 1;

FIG. 8 is a perspective view of an alternate embodiment of the miniature hair trimmer housing of the present invention;

FIG. 9 is a front view of the miniature hair trimmer housing of FIG. 8;

FIG. 10 is a right side view of the miniature hair trimmer housing of FIG. 8;

FIG. 11 is a left side view of the miniature hair trimmer housing of FIG. 8;

FIG. 12 is a rear view of the miniature hair trimmer housing of FIG. 8;

FIG. 13 is a top view of the miniature hair trimmer housing of FIG. 8; and,

FIG. 14 is a bottom view of the miniature hair trimmer housing of FIG. 8.

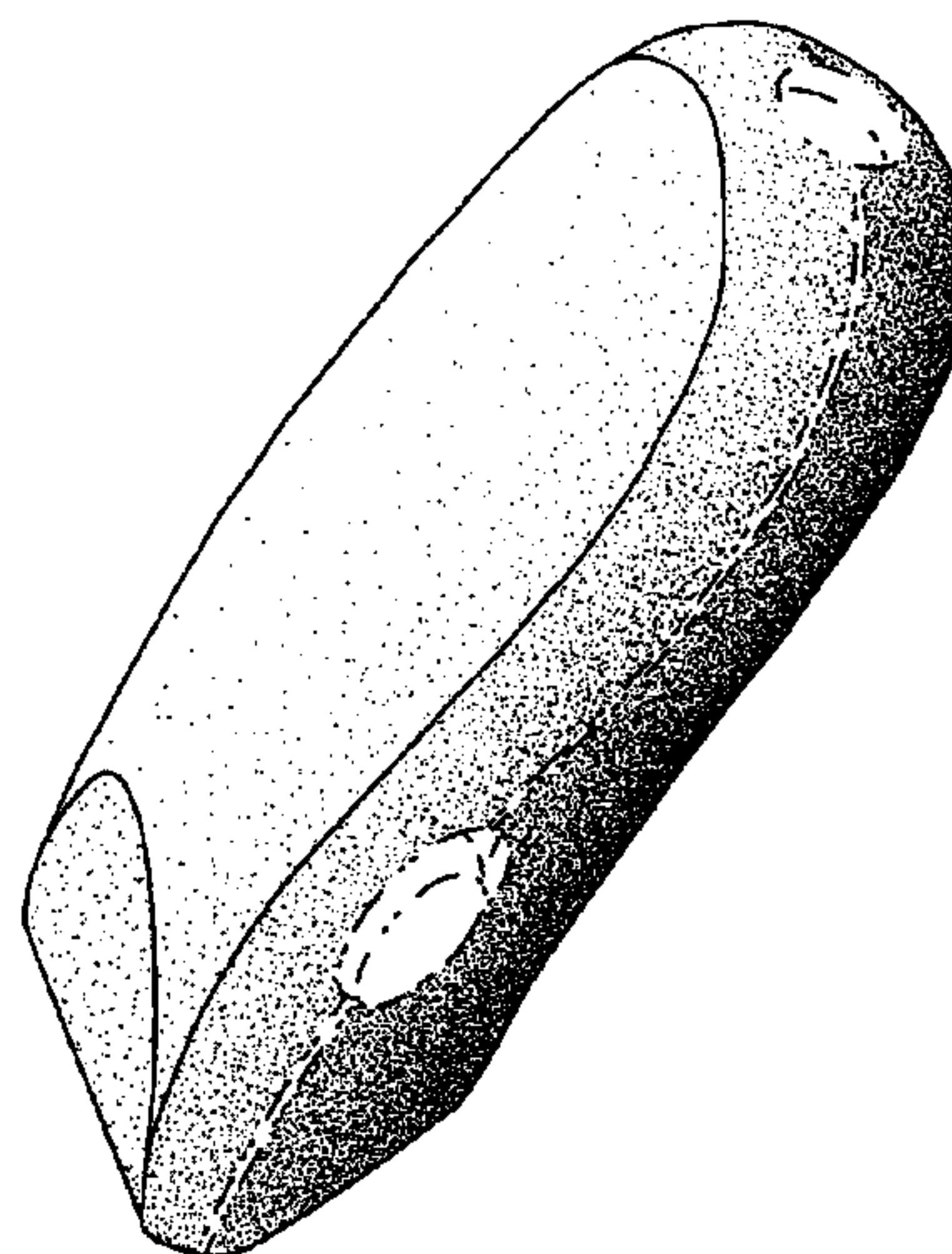
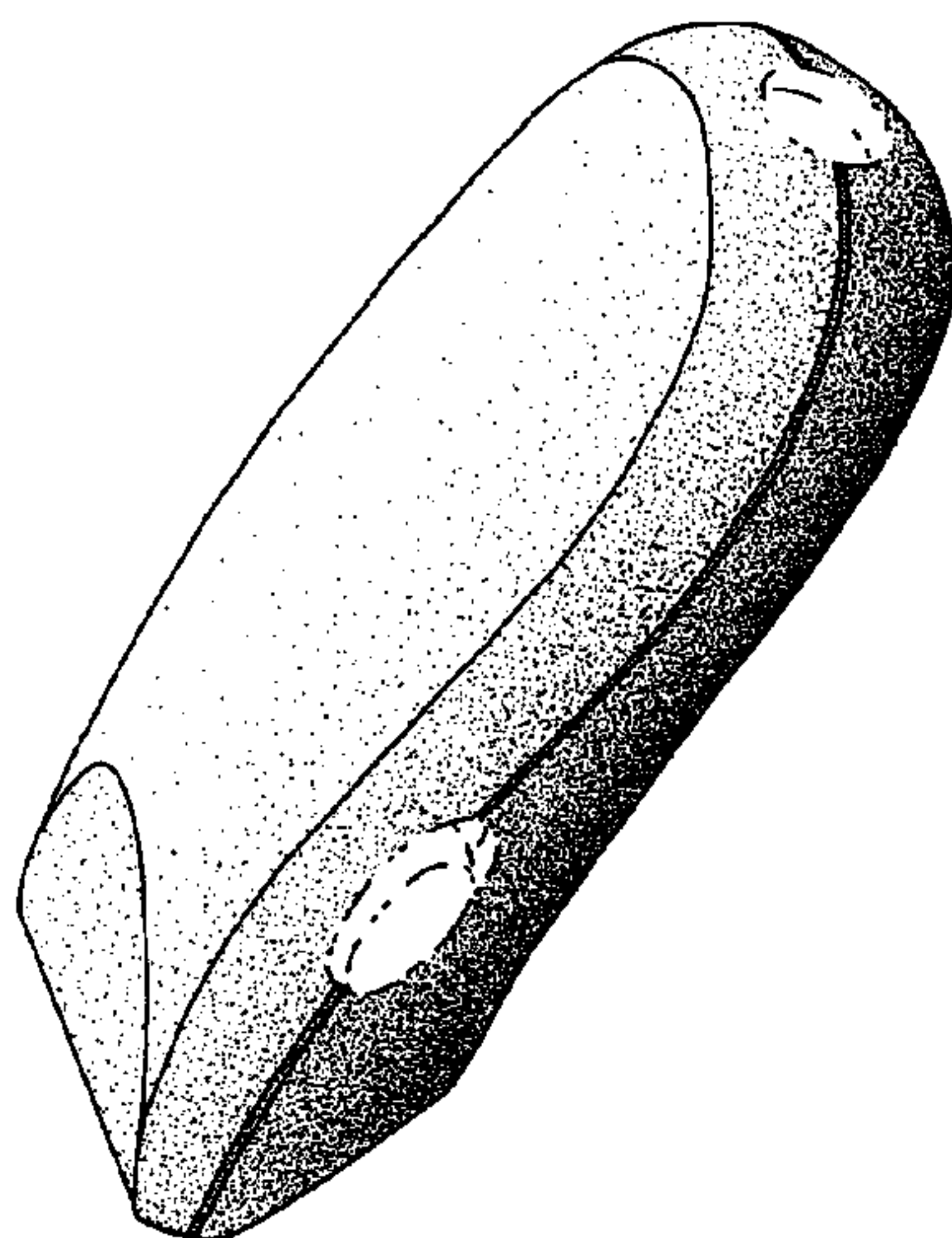

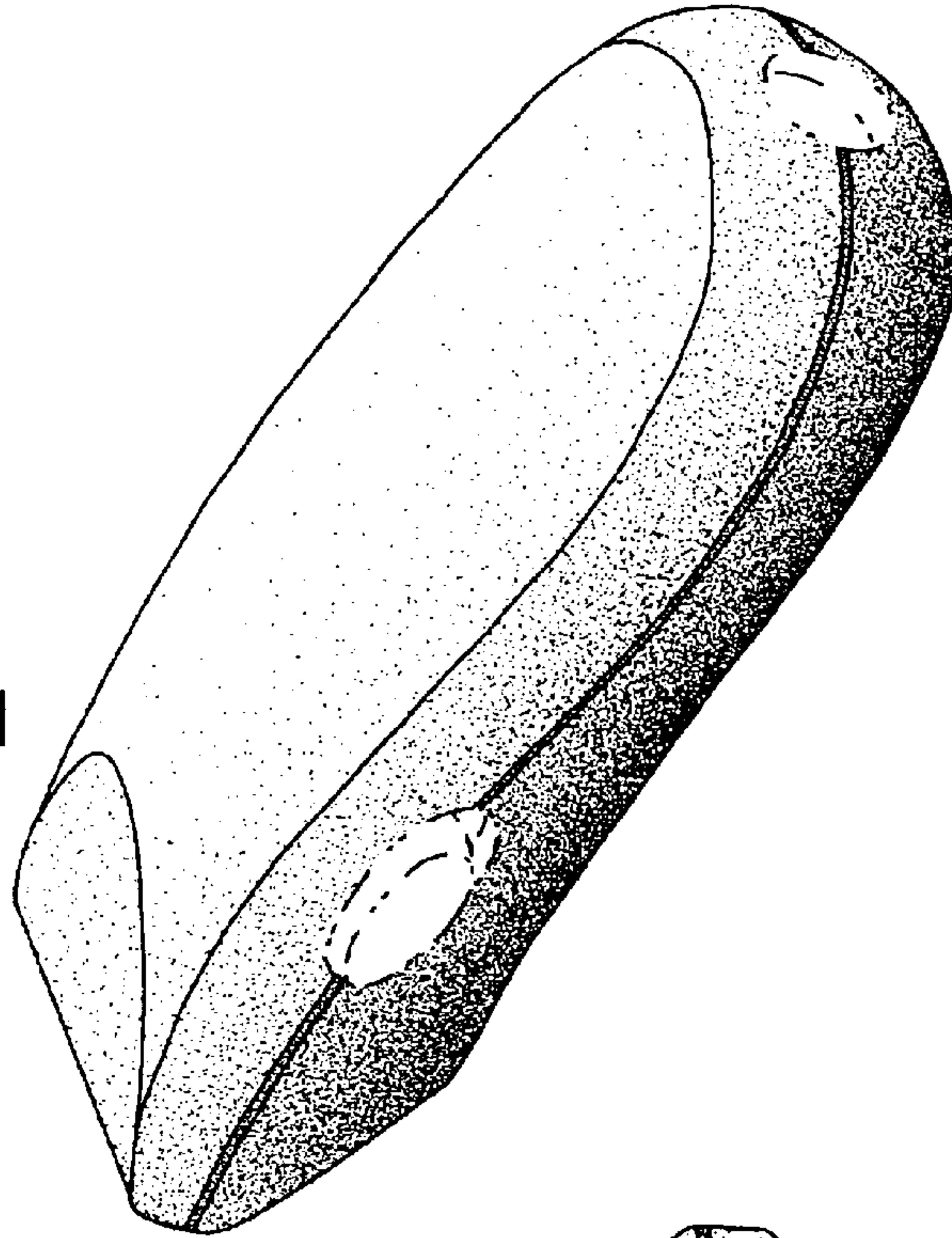

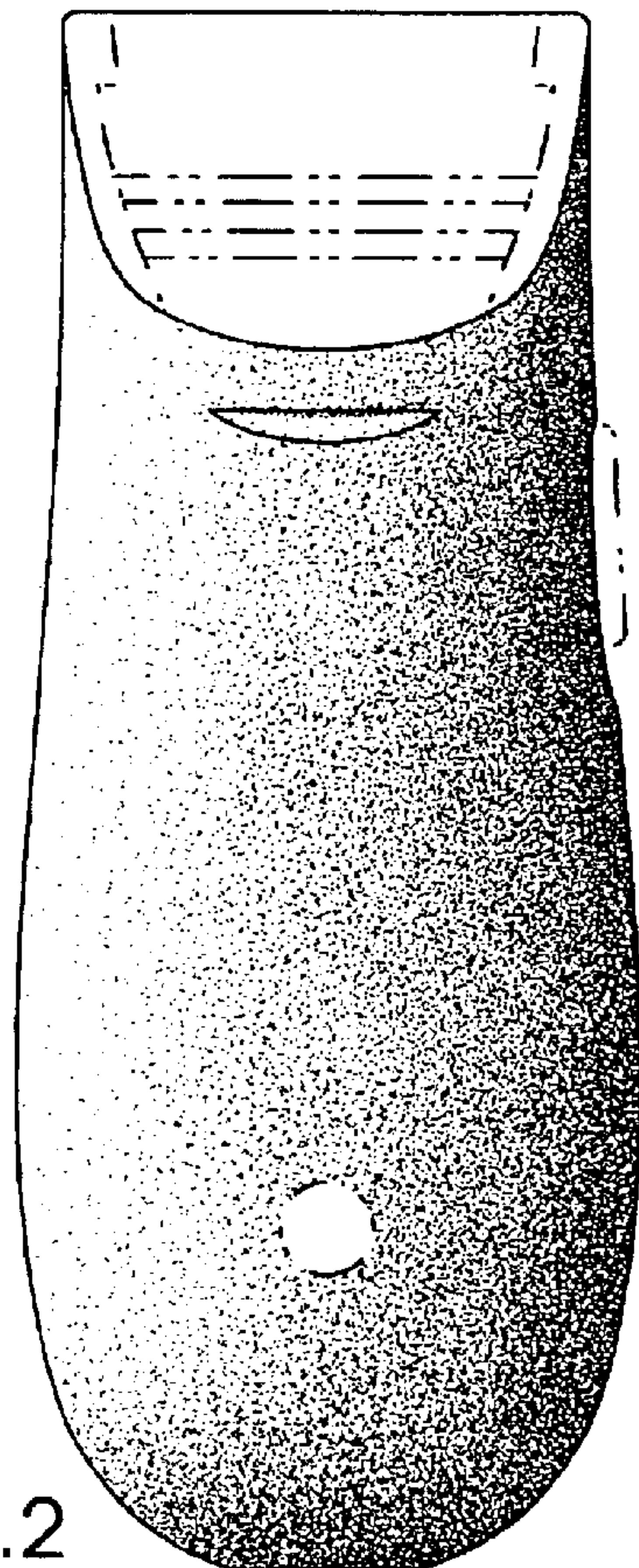
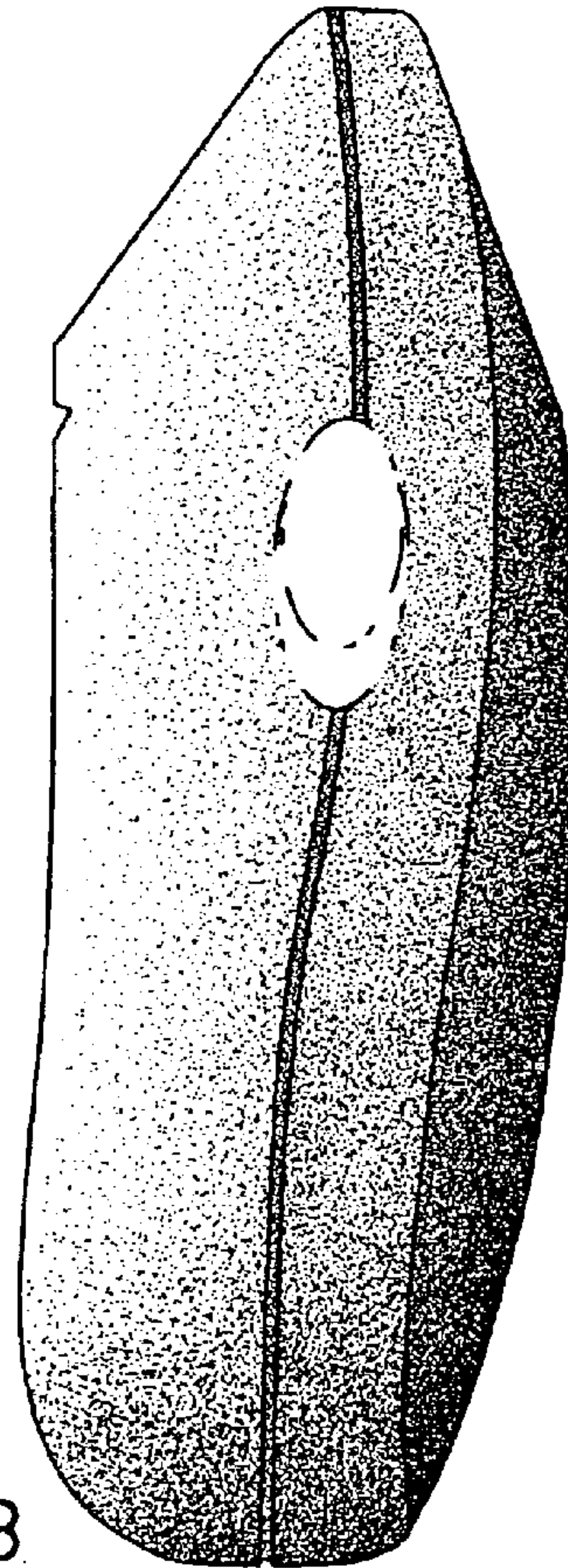

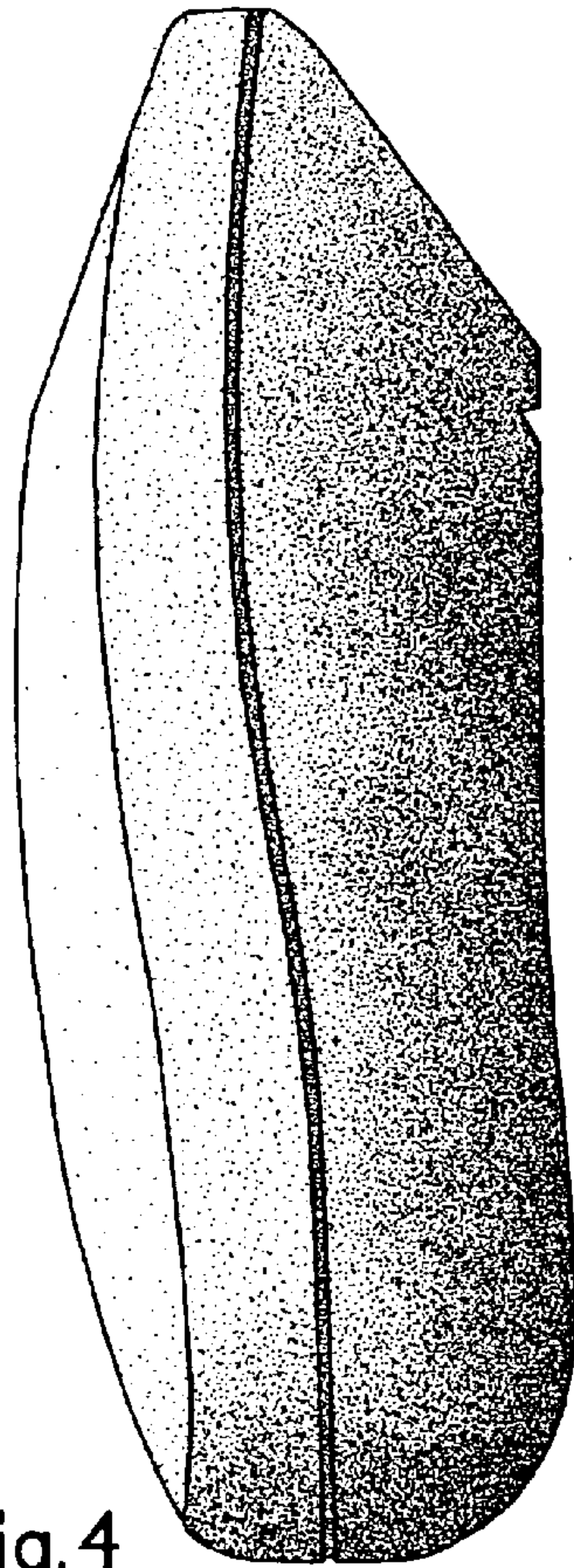

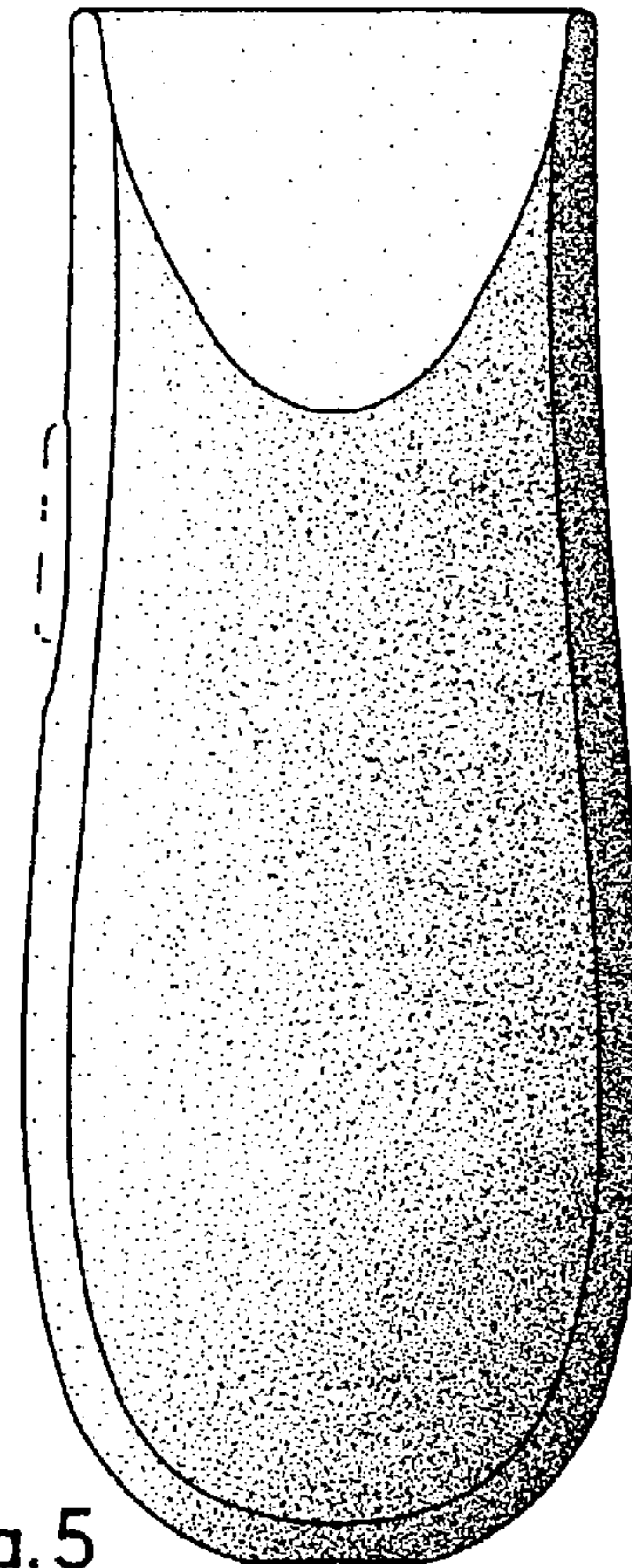

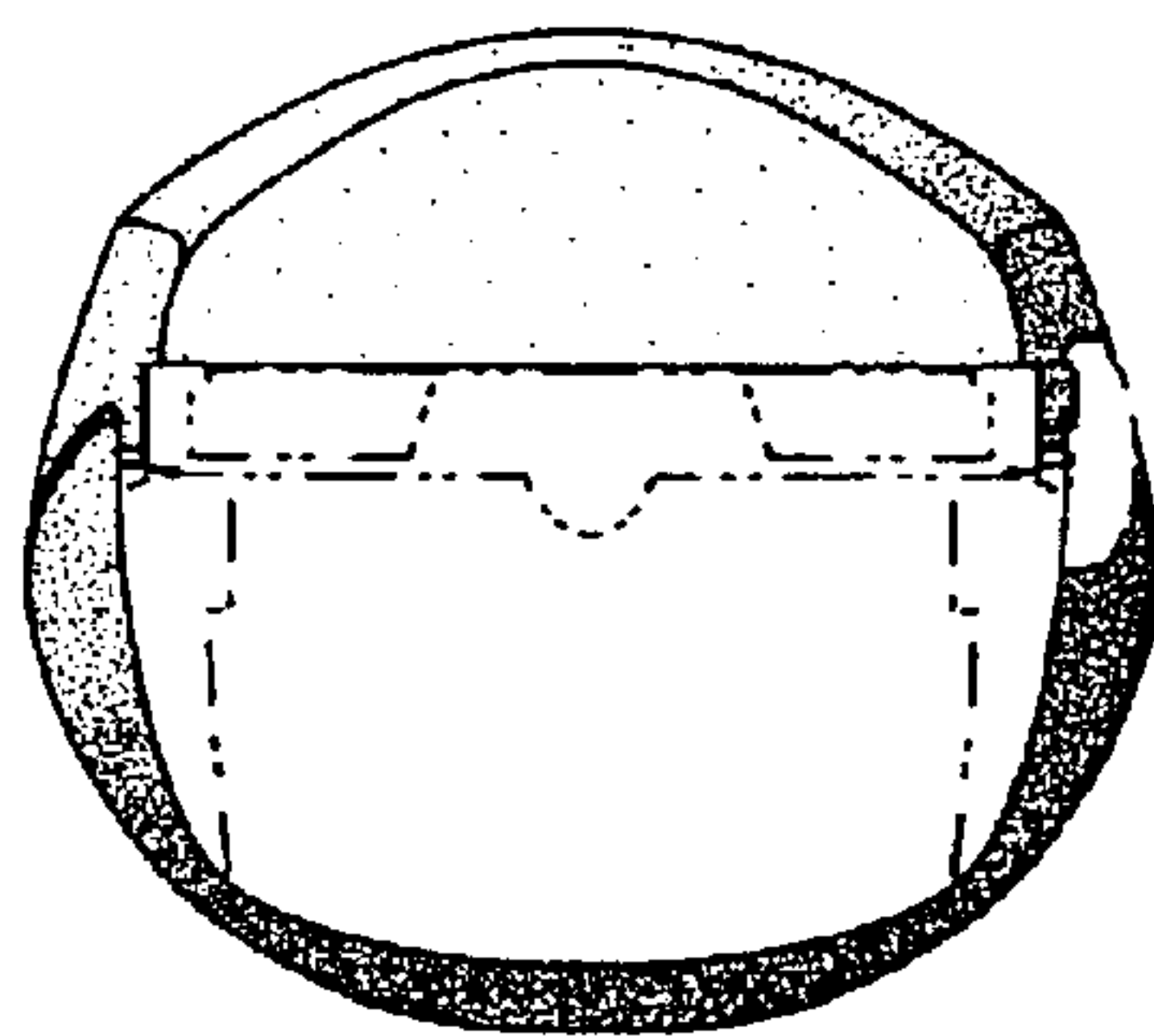

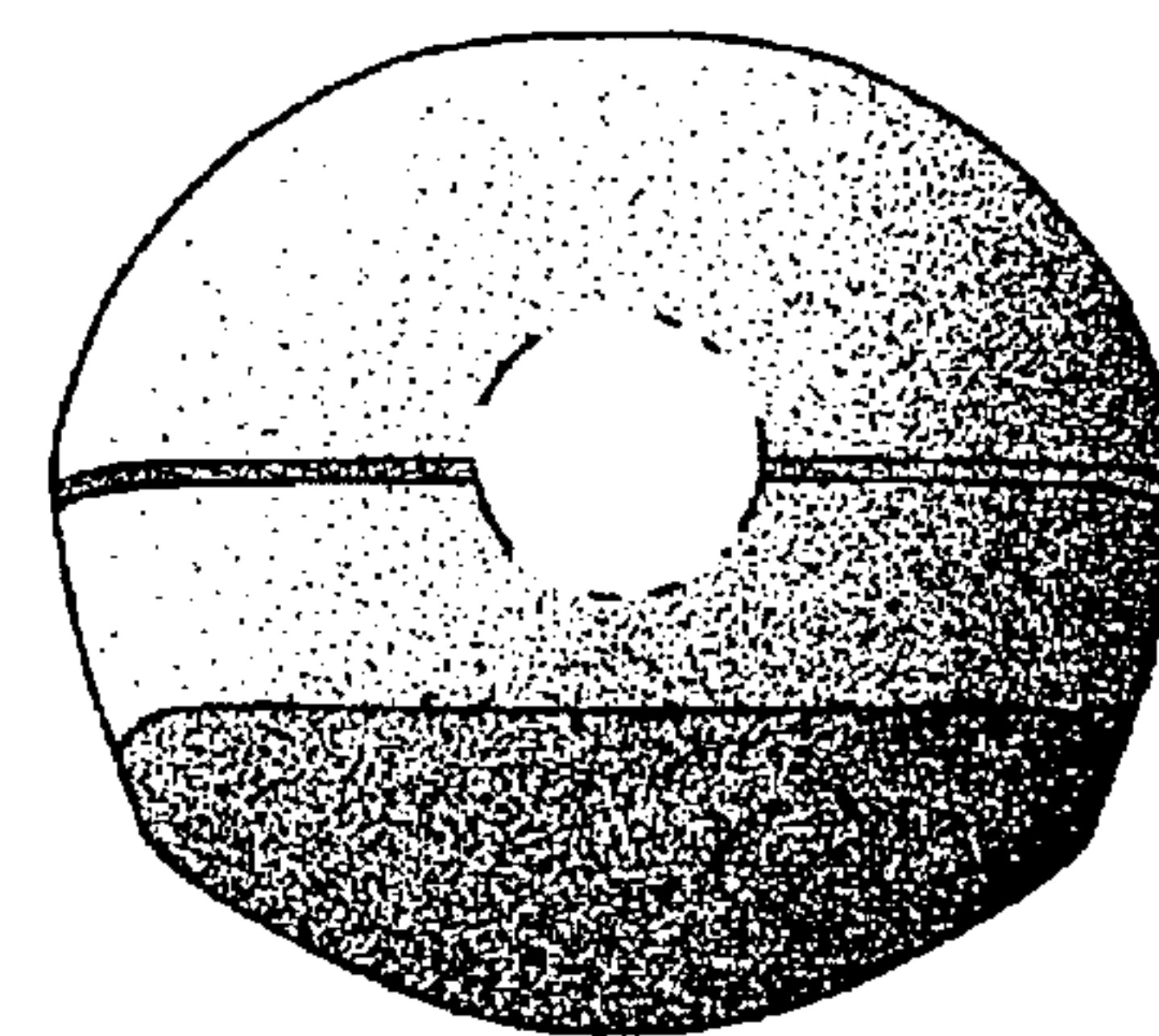

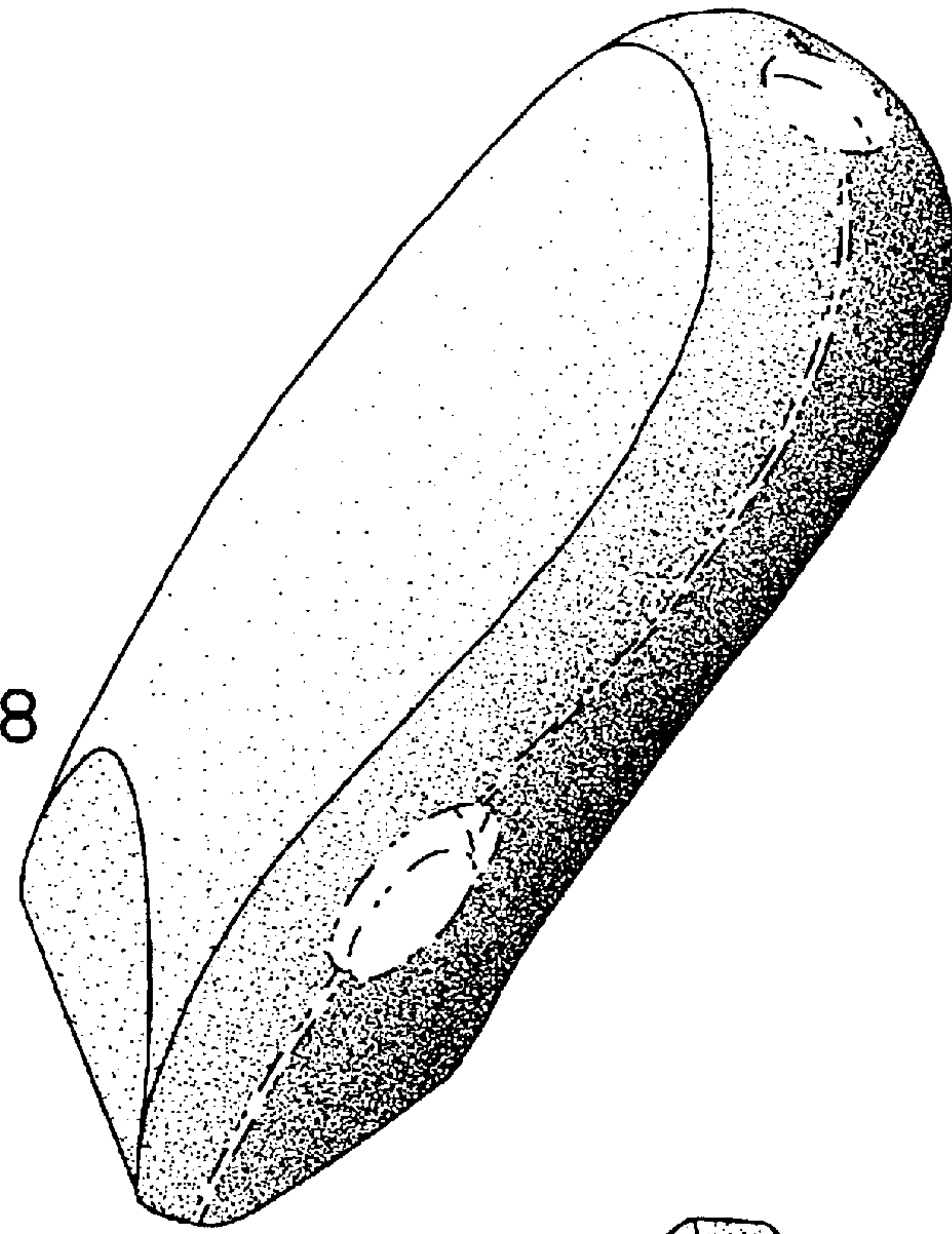

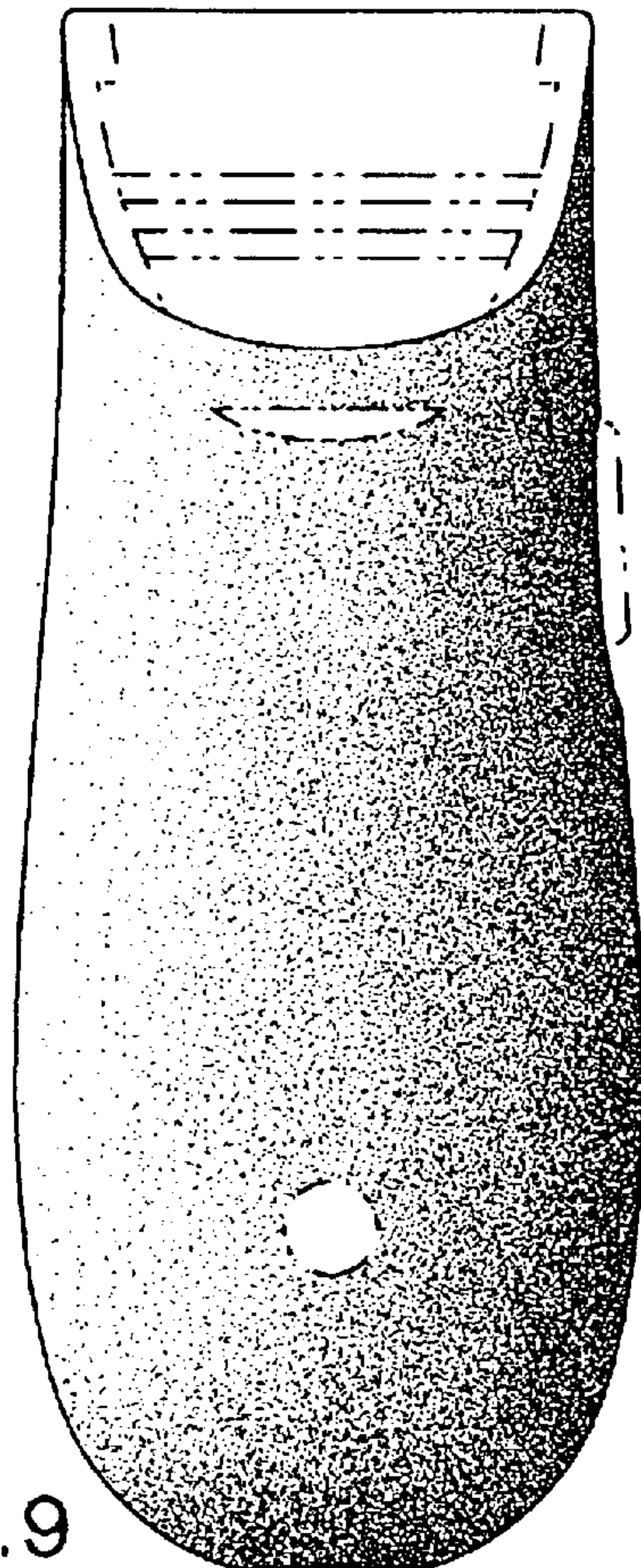
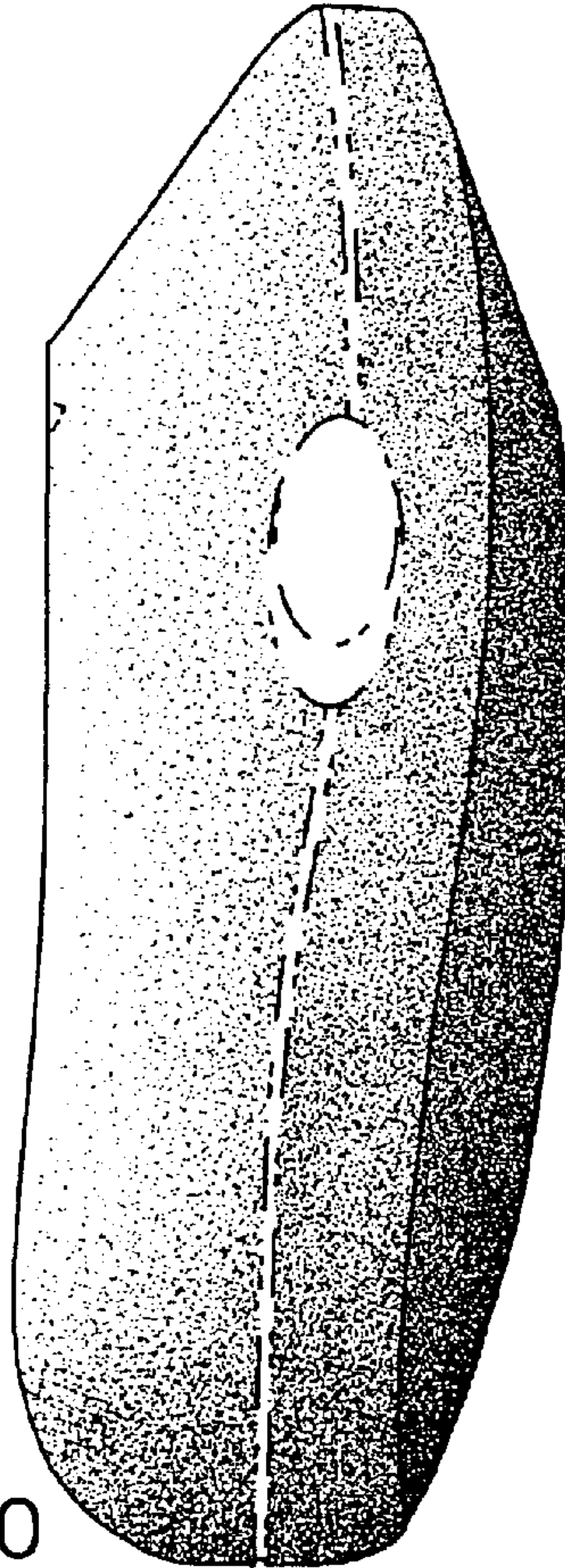

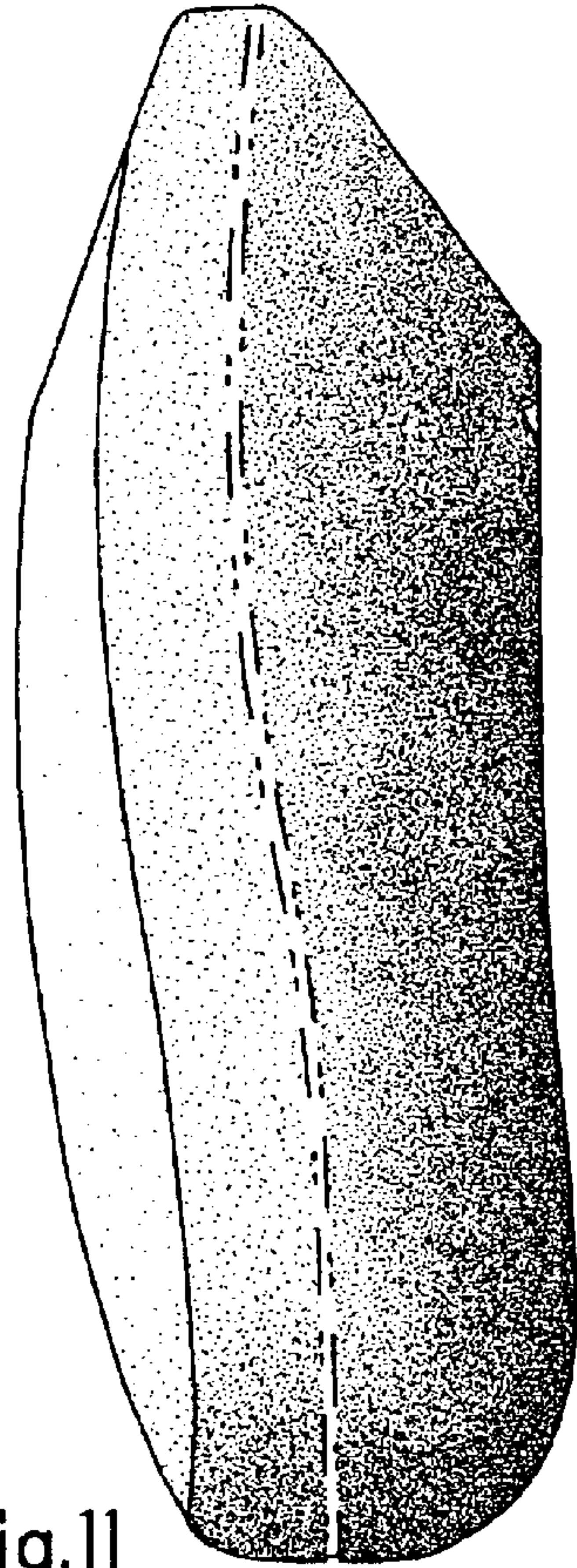

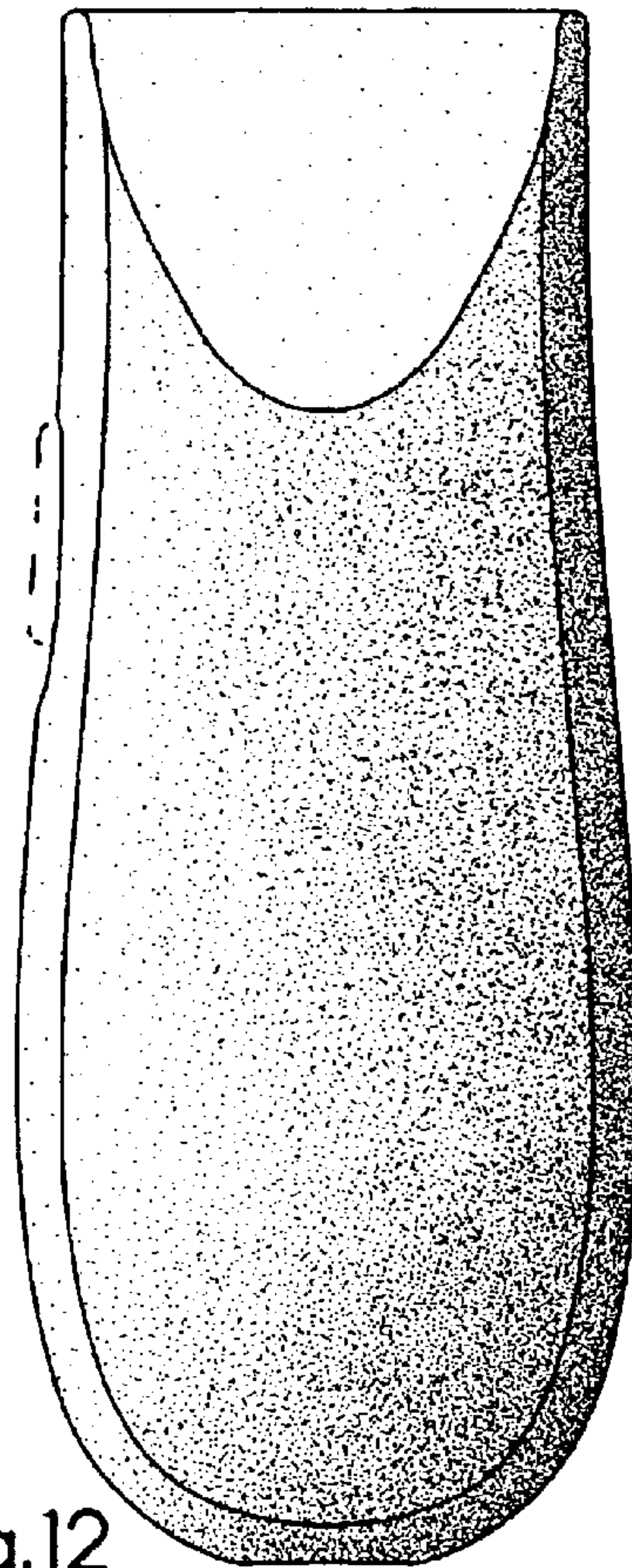

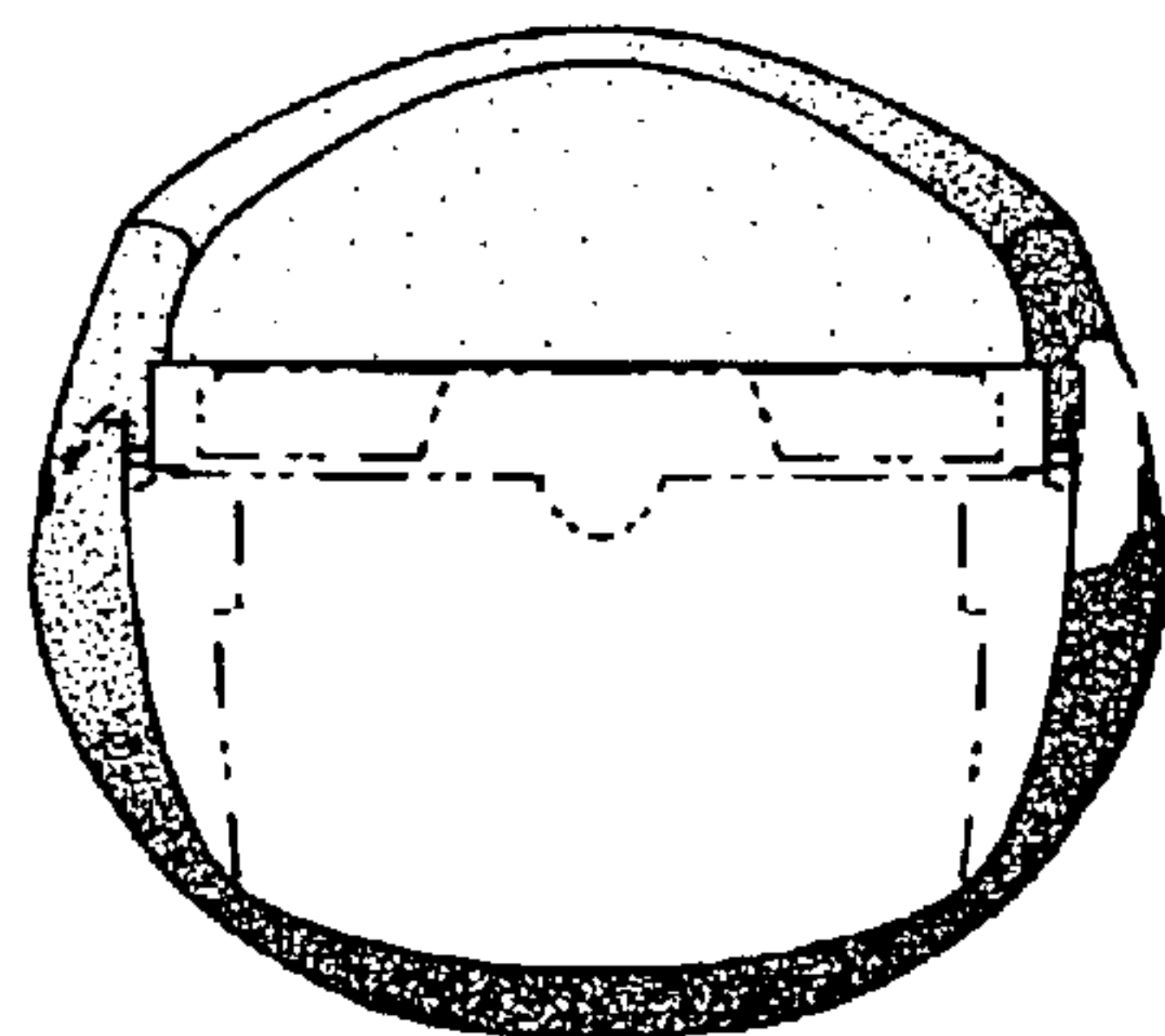

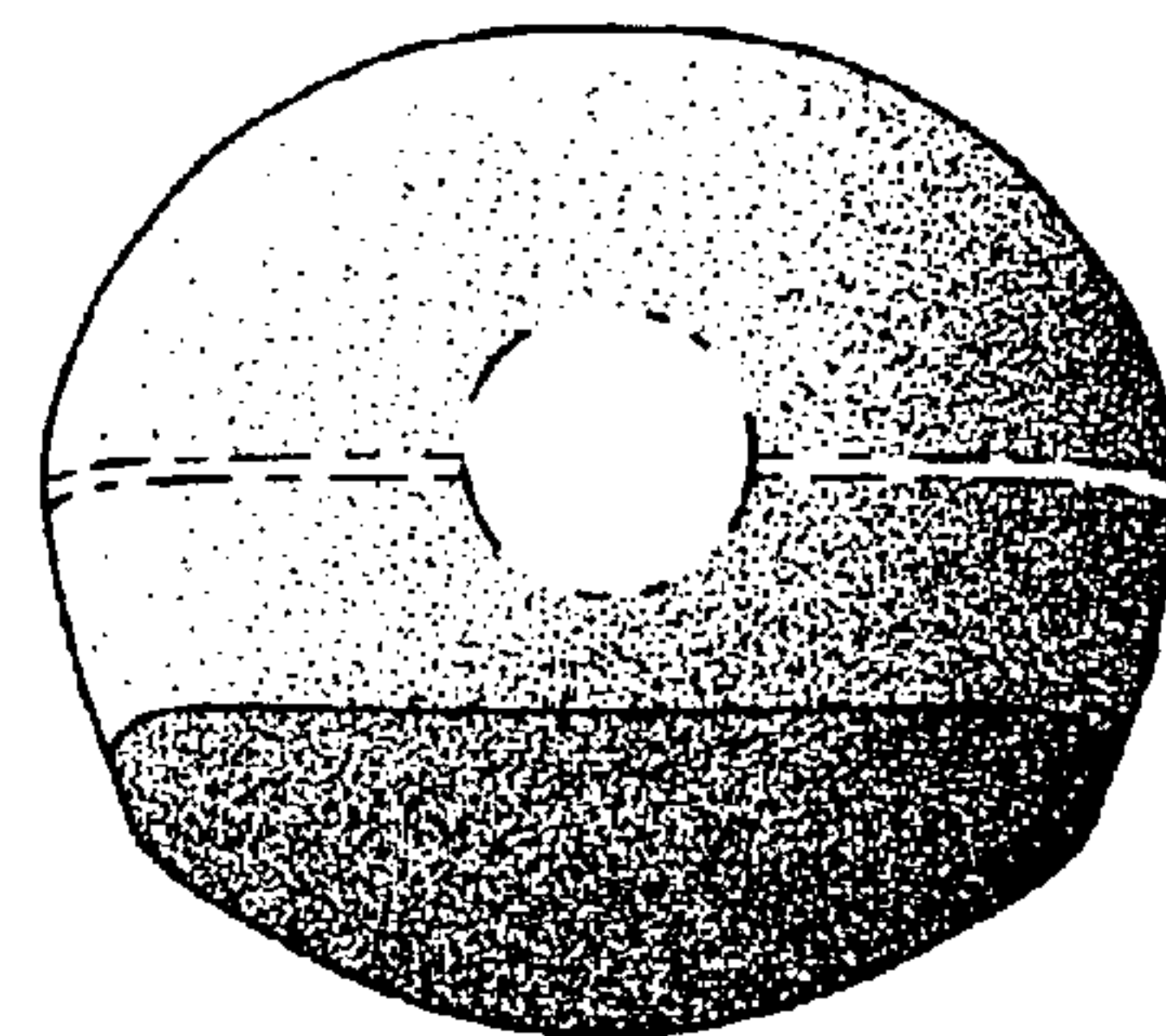
