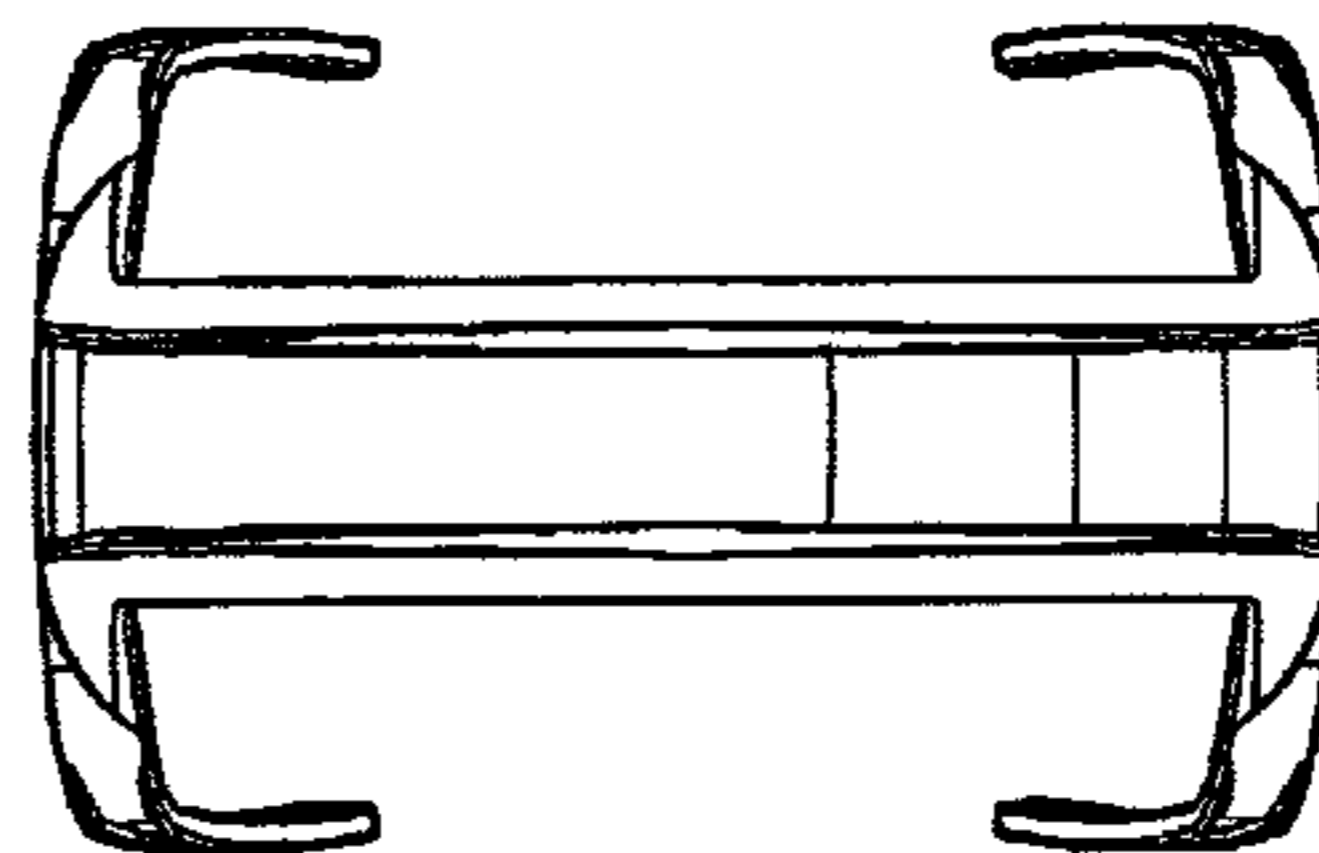
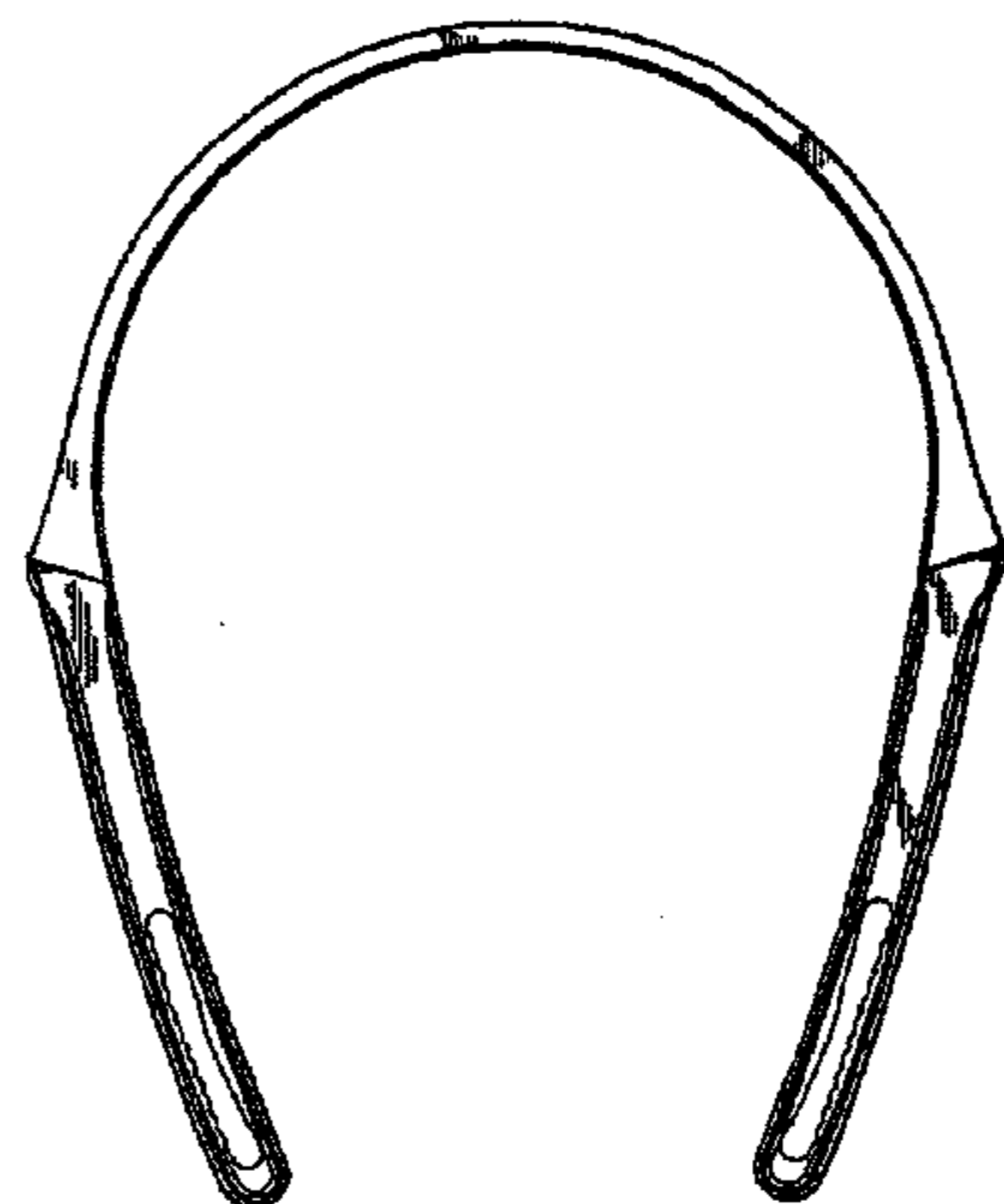
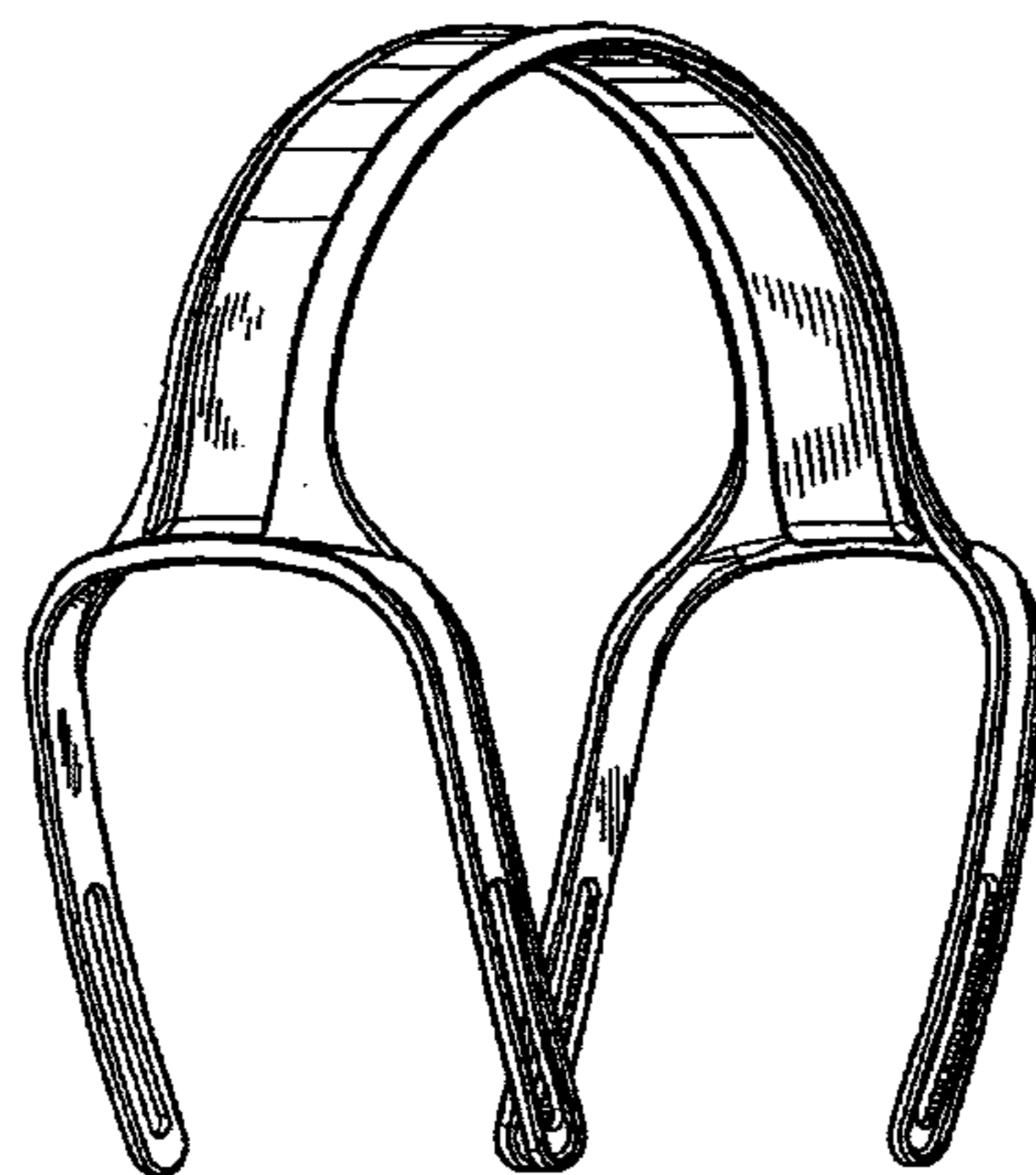
(57) **CLAIM**

The ornamental design for a mounting for a hearing protection device, as shown and described.

DESCRIPTION

FIG. 1 is a left perspective view of a mounting for a hearing protection device showing my new design; FIG. 2 is a right perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a rear elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a right side view thereof; and, FIG. 8 is a bottom plan view thereof.

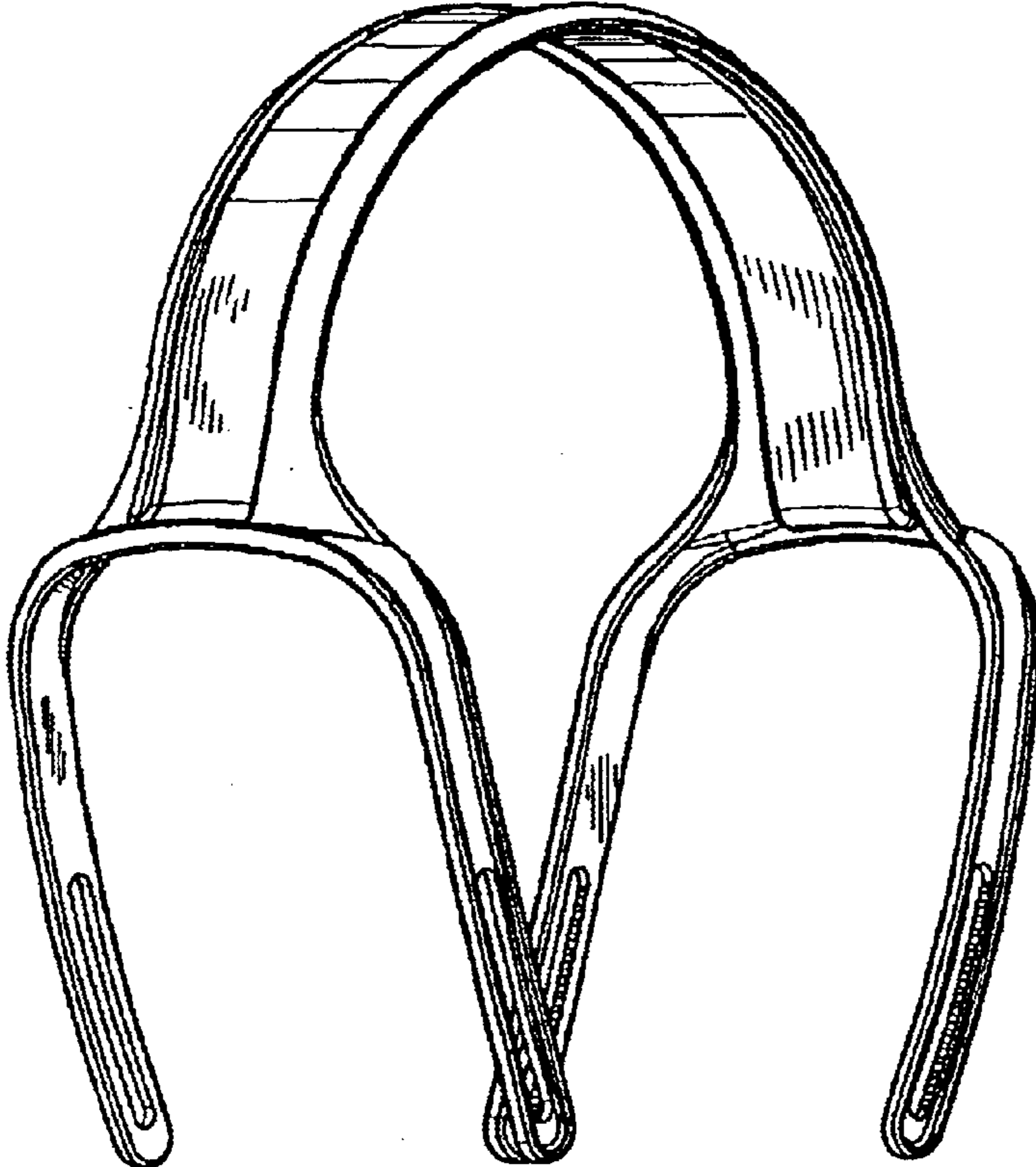

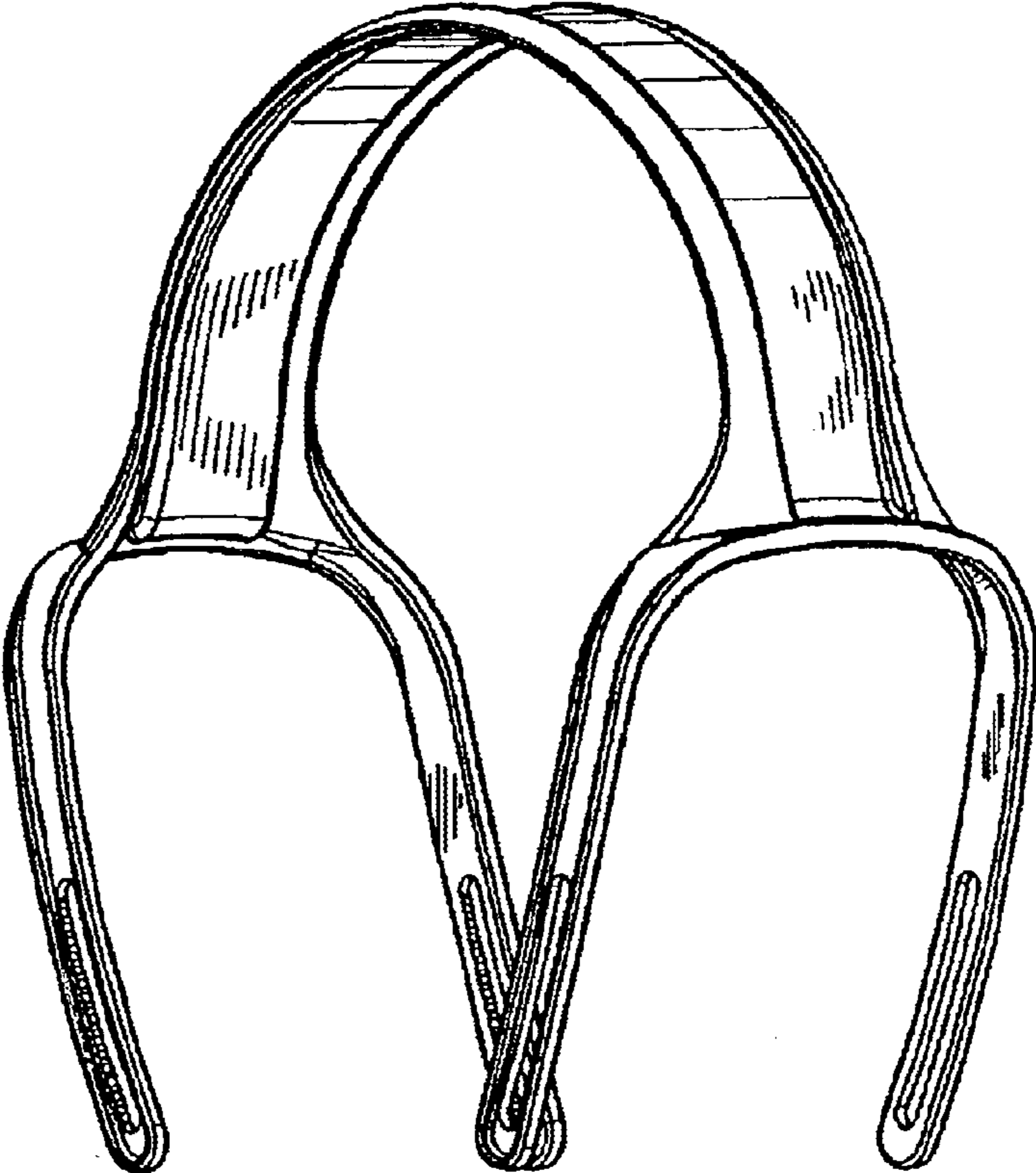

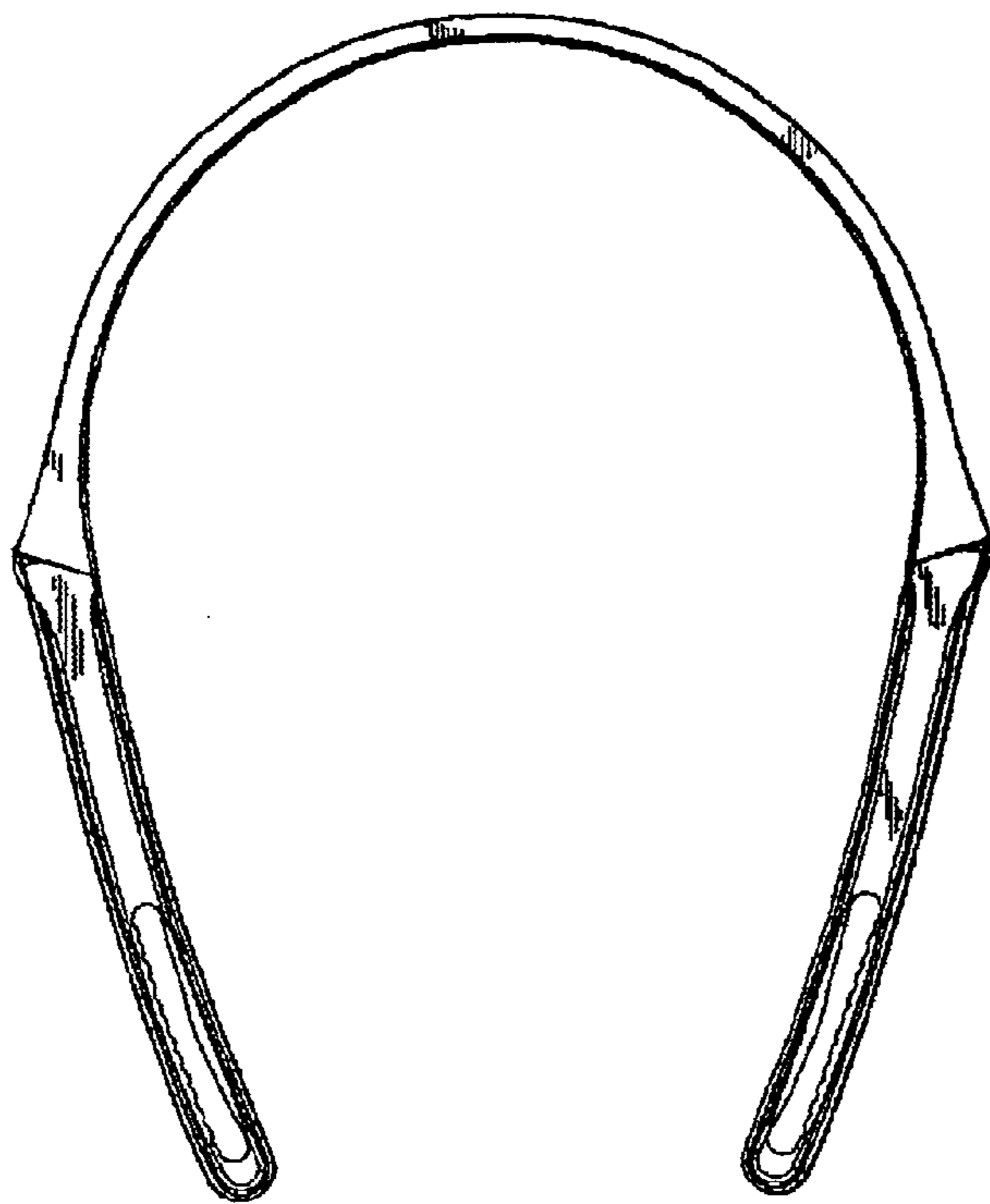

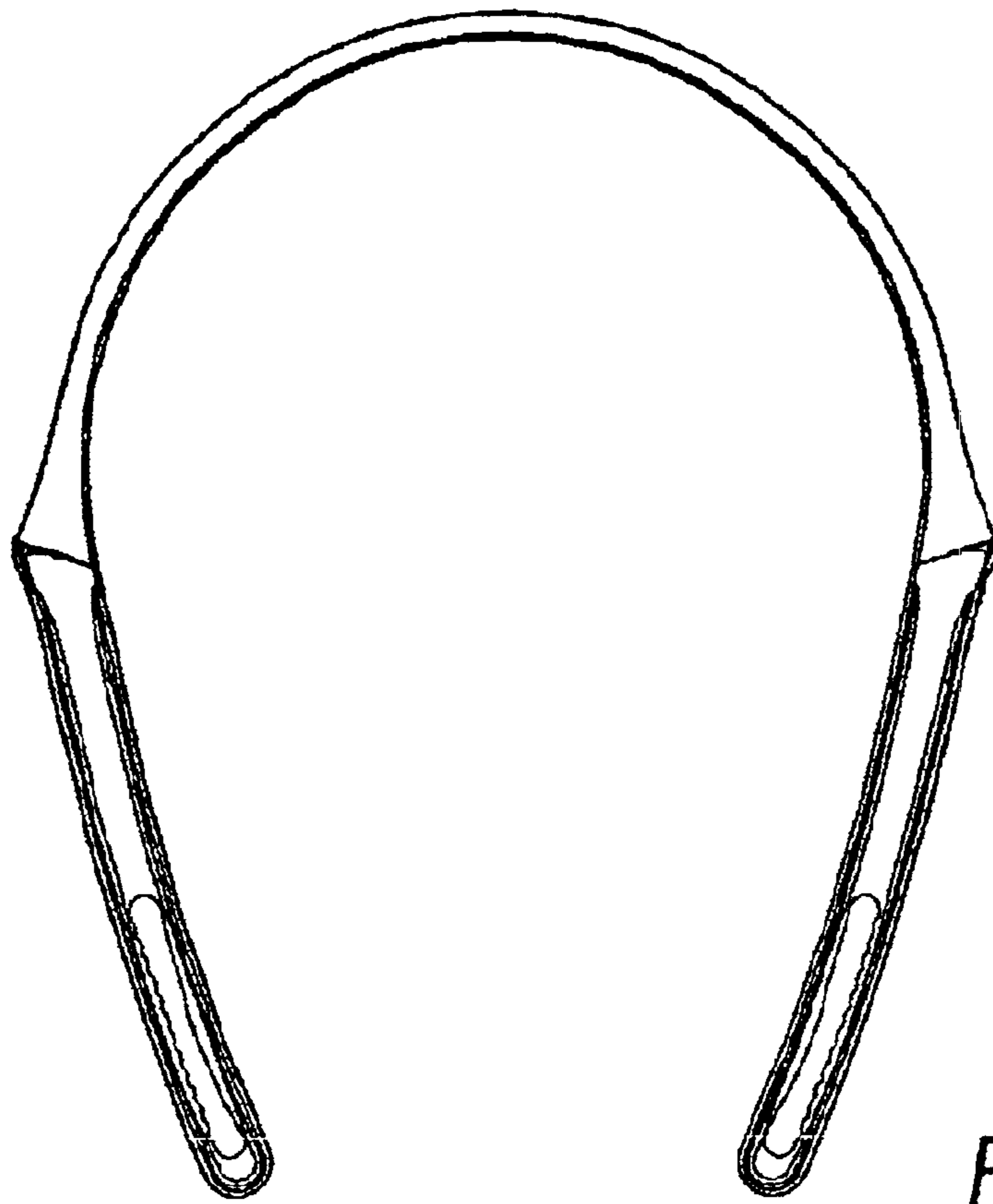

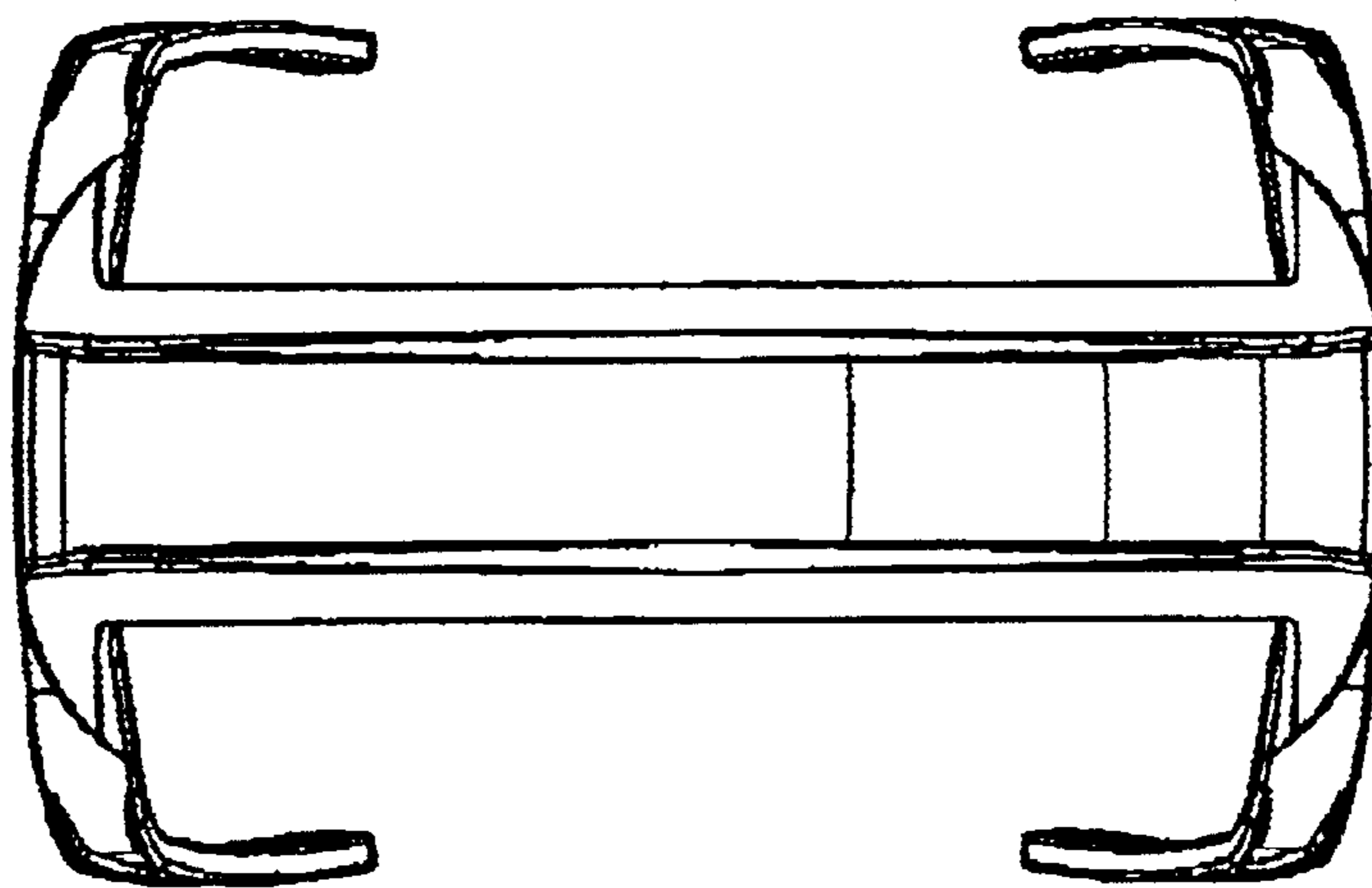

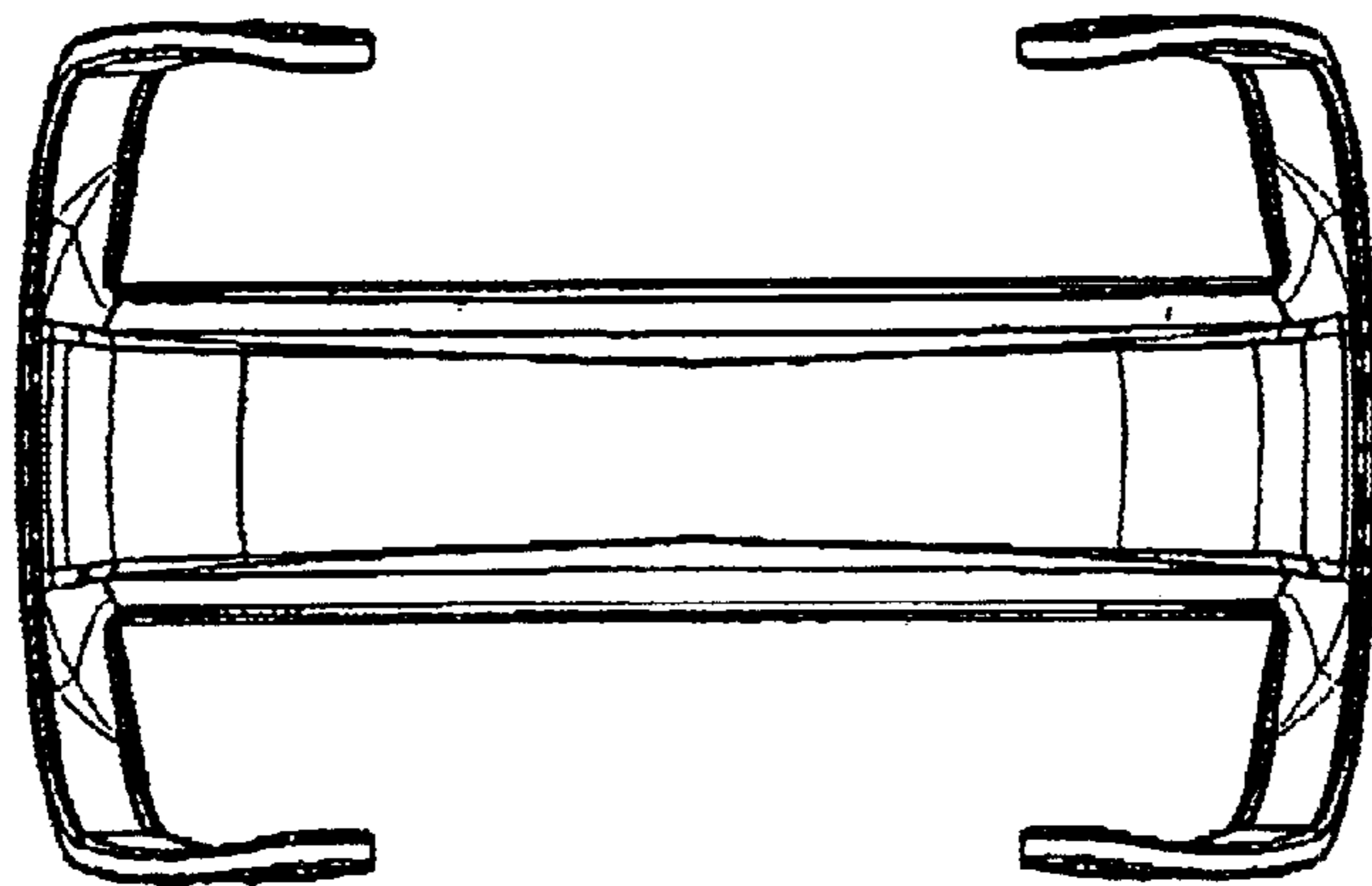
