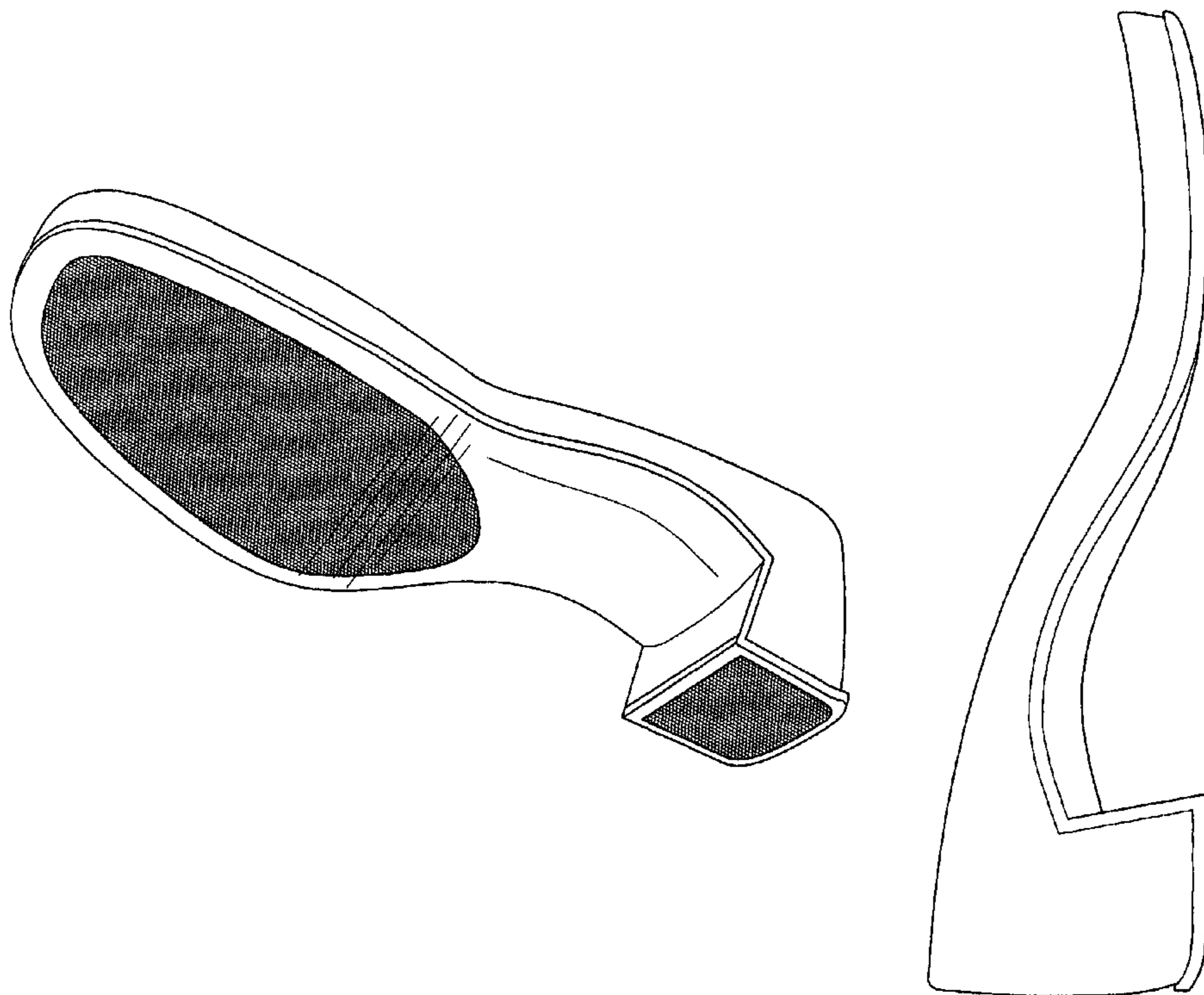
(57) **CLAIM**

I claim the ornamental design for a sole for footwear, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a sole for footwear showing my new design;
 FIG. 2 is a bottom plan view thereof;

 FIG. 4 is a top plan view thereof;

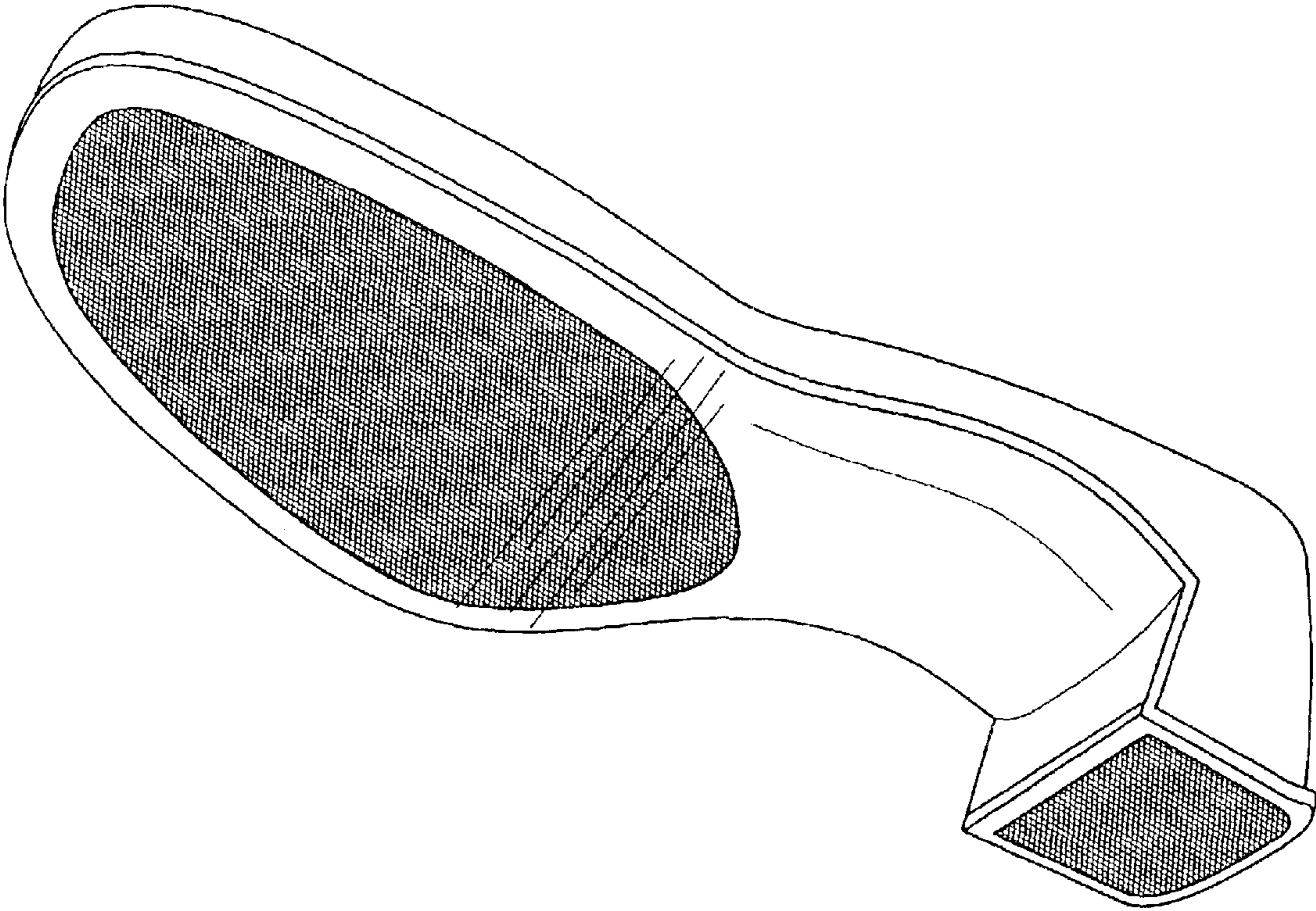

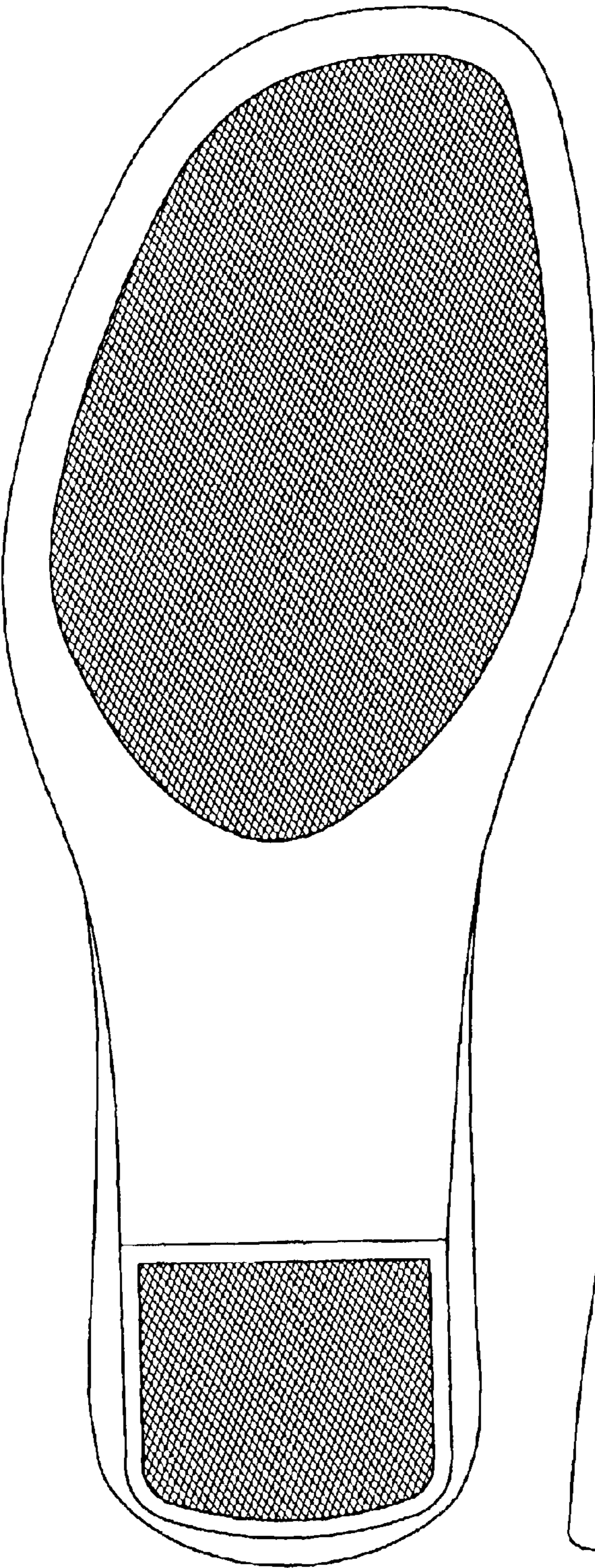

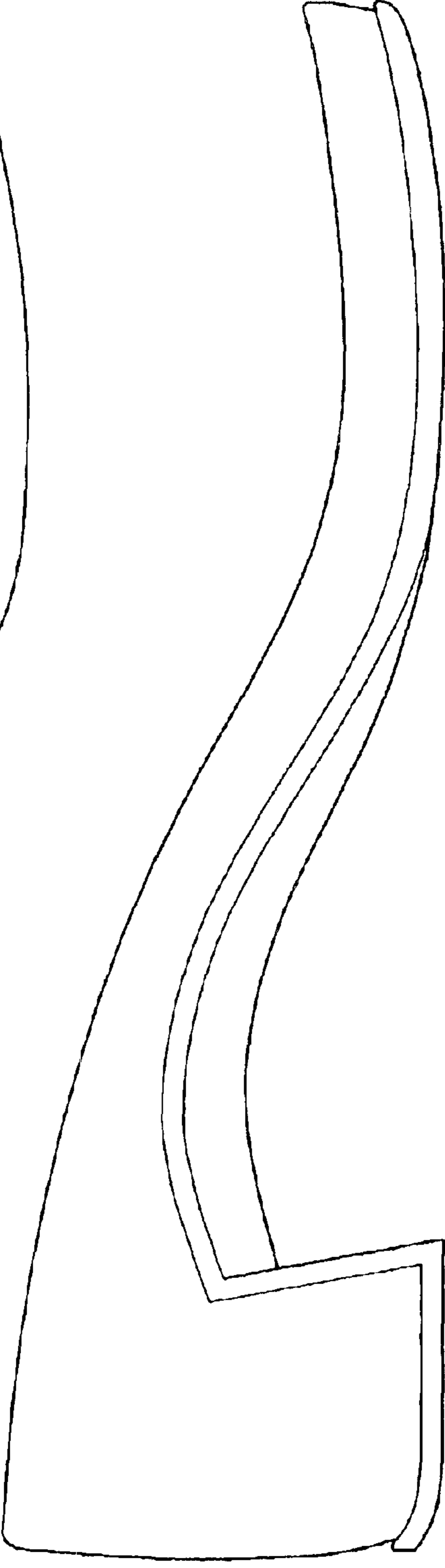

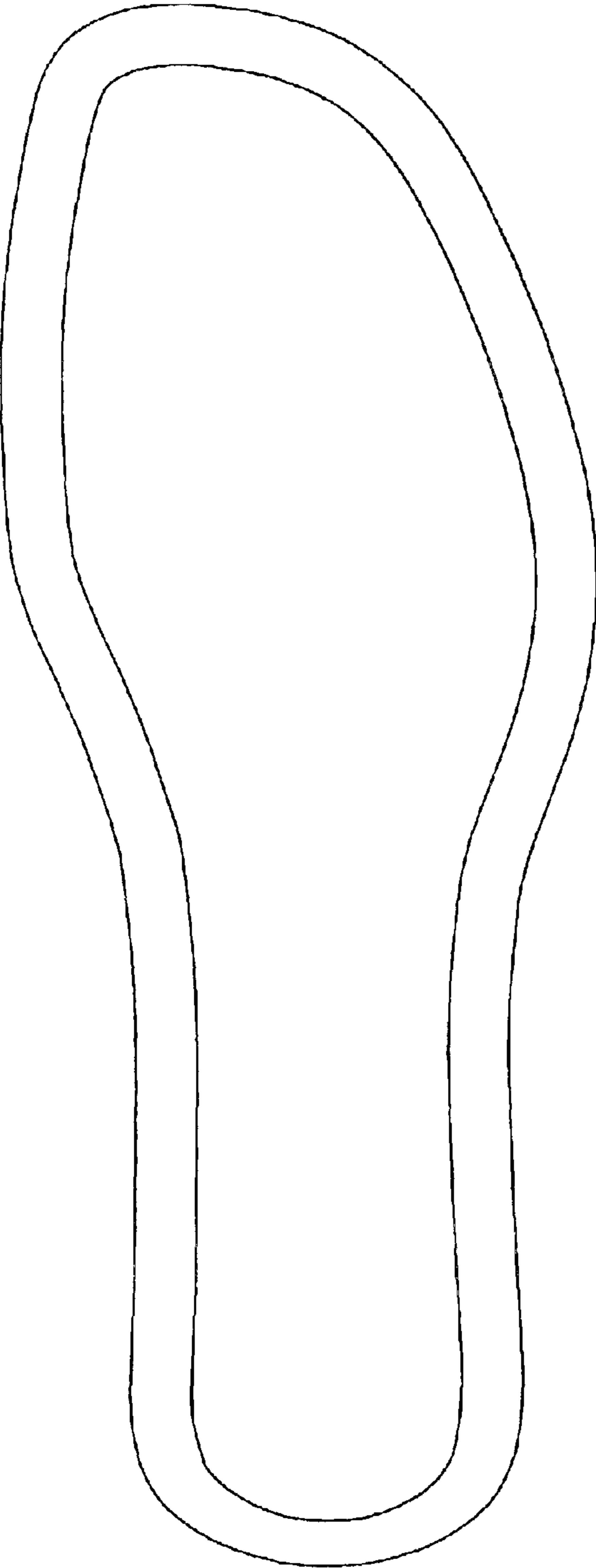

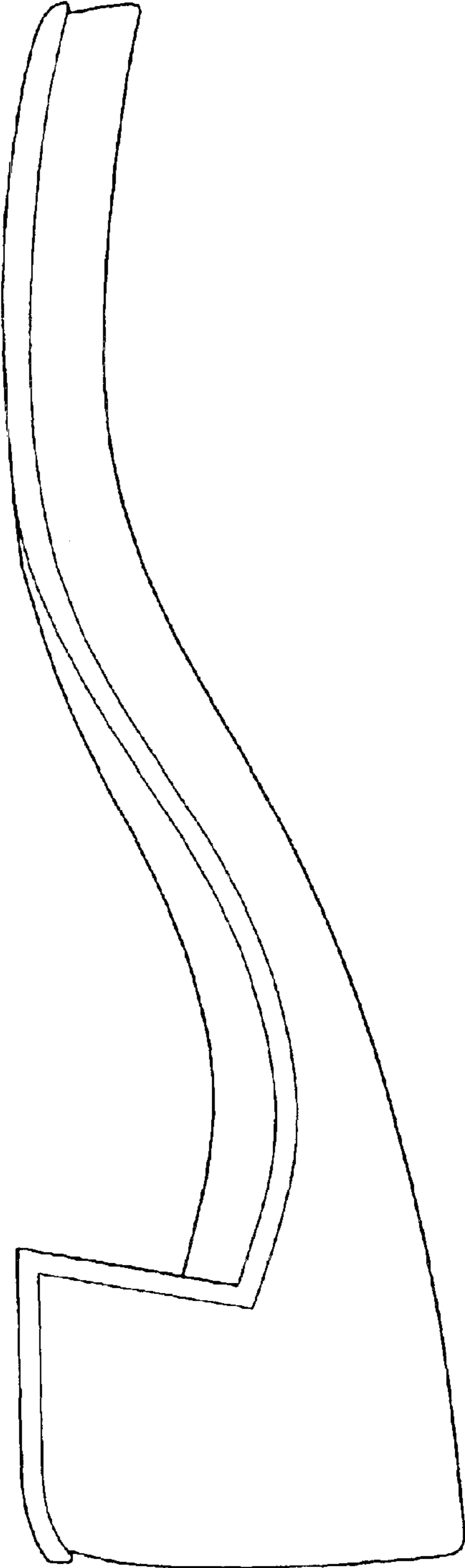

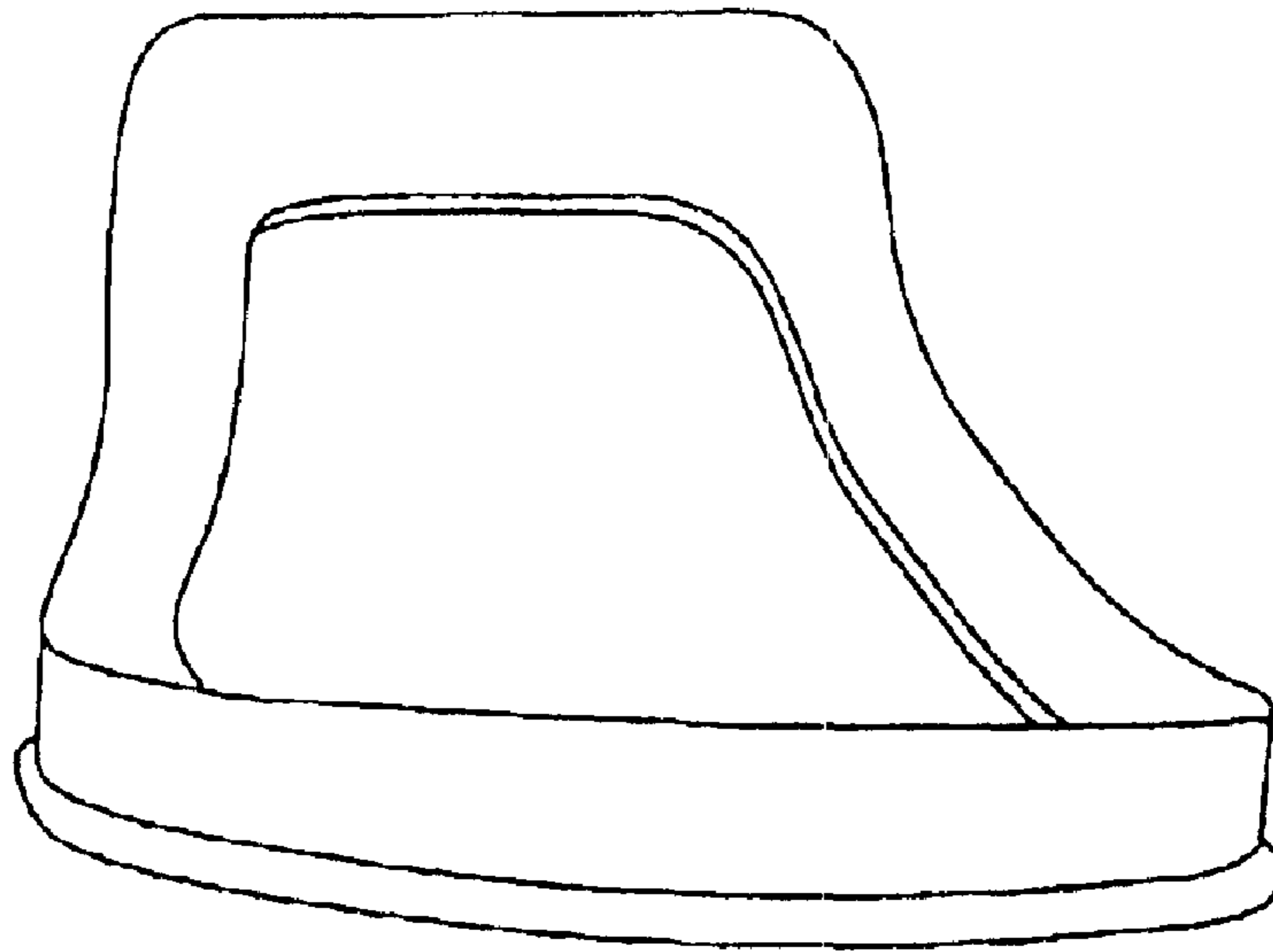

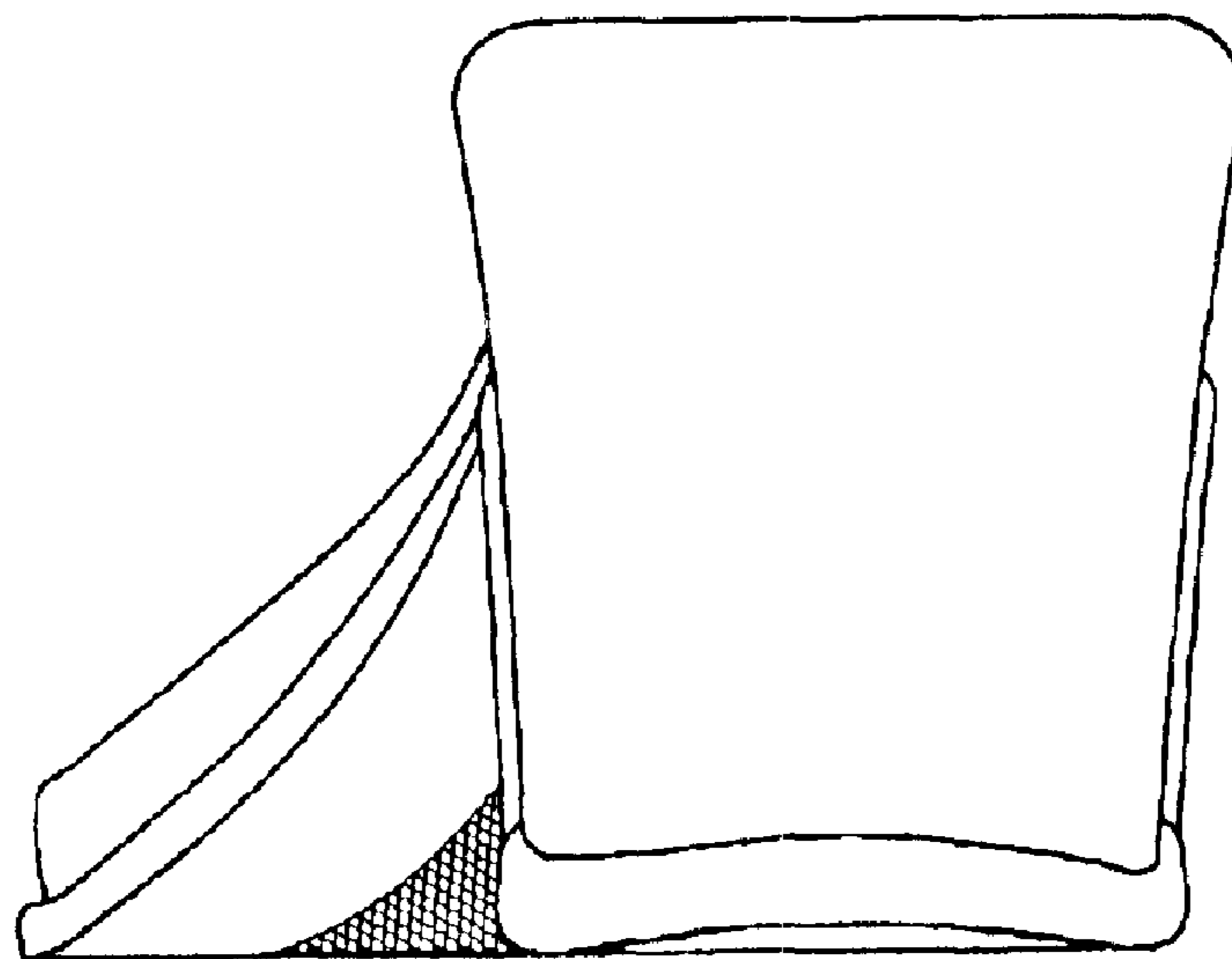
