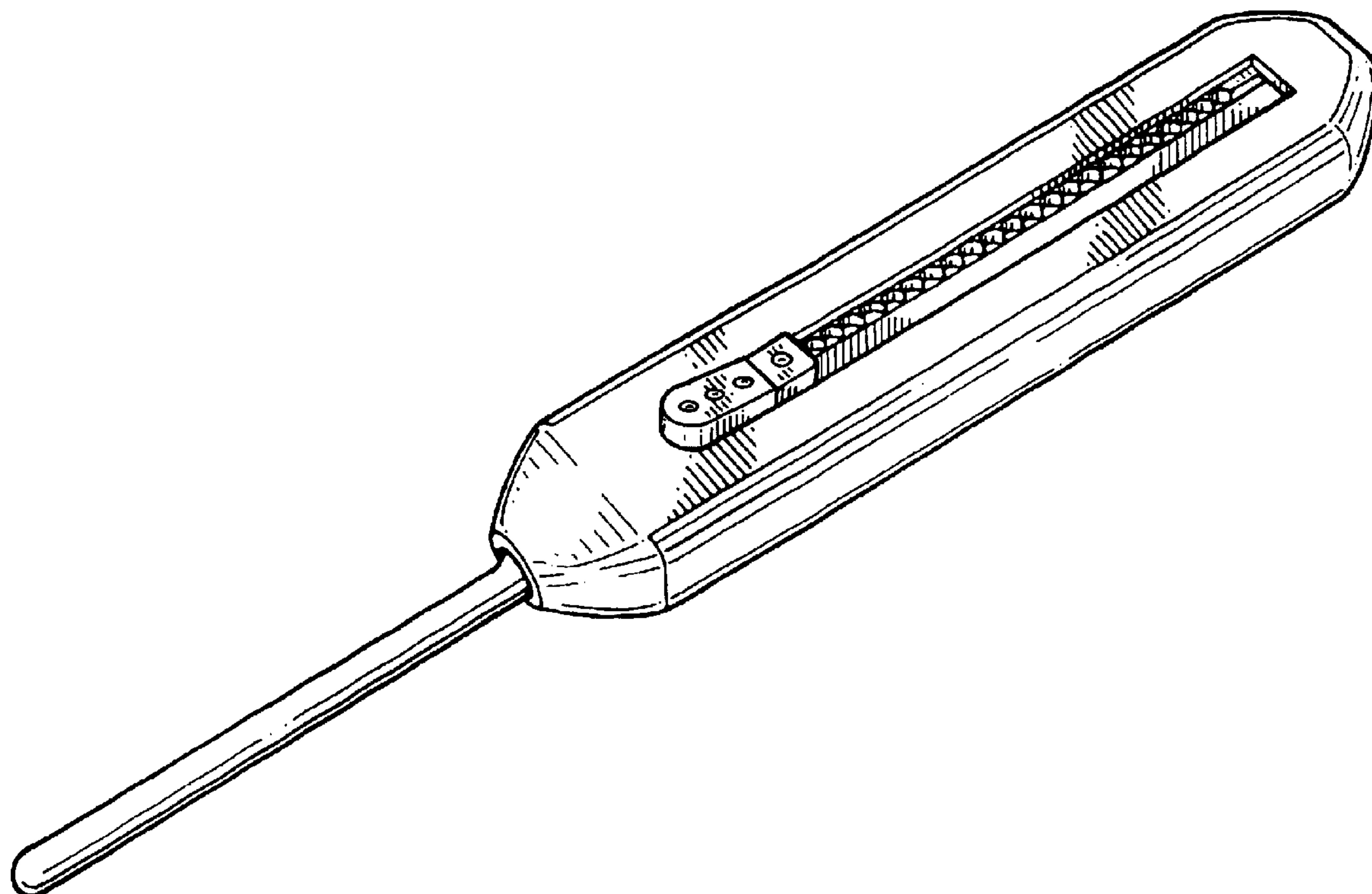
(57) **CLAIM**

The ornamental design for a abrasive glass shaver, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the abrasive glass shaver of the invention with the abrasive rod extended;  
 FIG. 2 is a front perspective view, of the abrasive glass shaver of FIG. 1 with the abrasive rod retracted;  
 FIG. 3 is a top plan view of the abrasive glass shaver of FIG. 1;  
 FIG. 4 is a side elevation view of the abrasive glass shaver of FIG. 1;  
 FIG. 5 is an end elevation view of the abrasive glass shaver FIG. 1; and,  
 FIG. 6 is an opposite end elevation view of the abrasive glass shaver of FIG. 1.

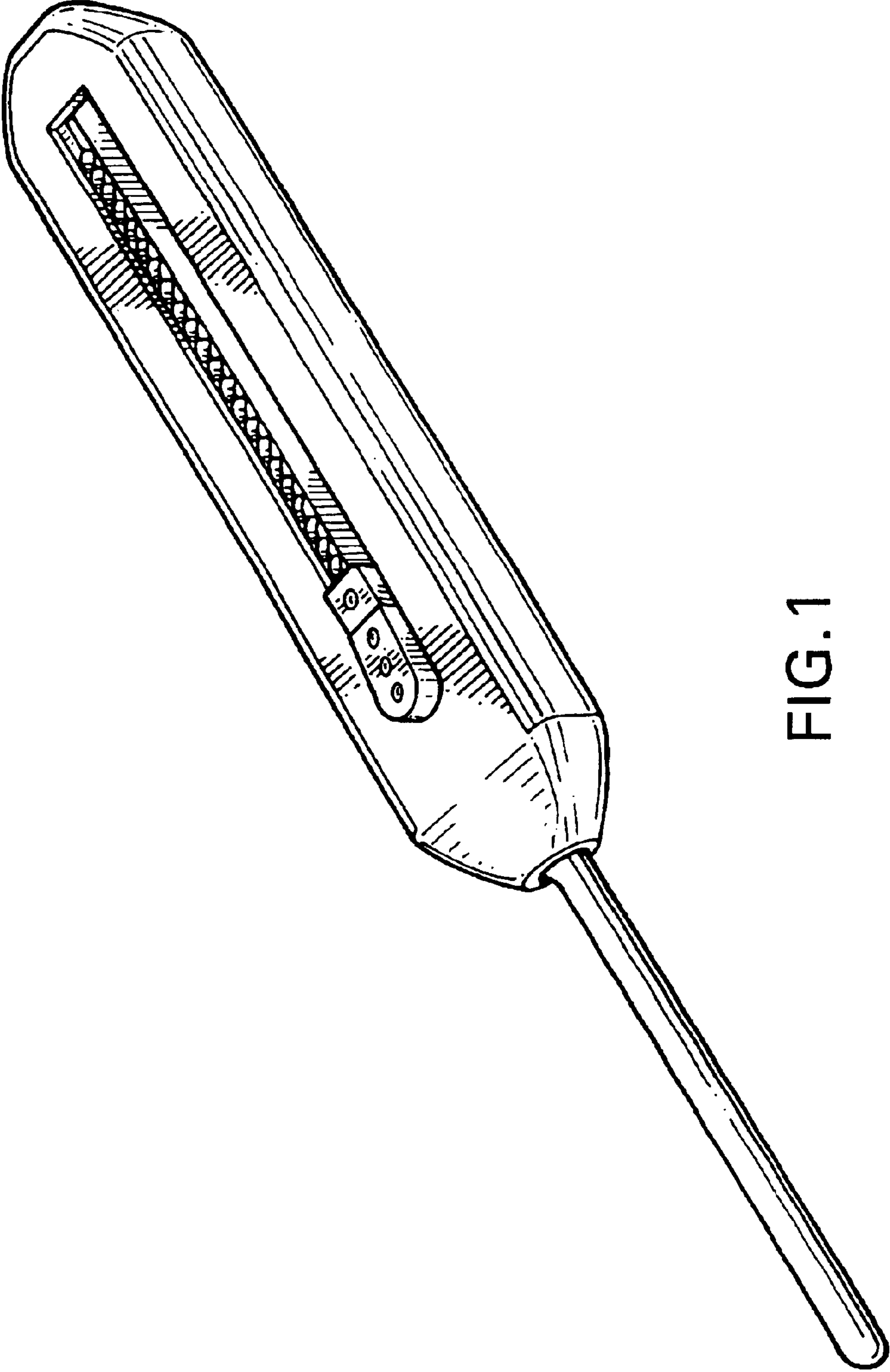

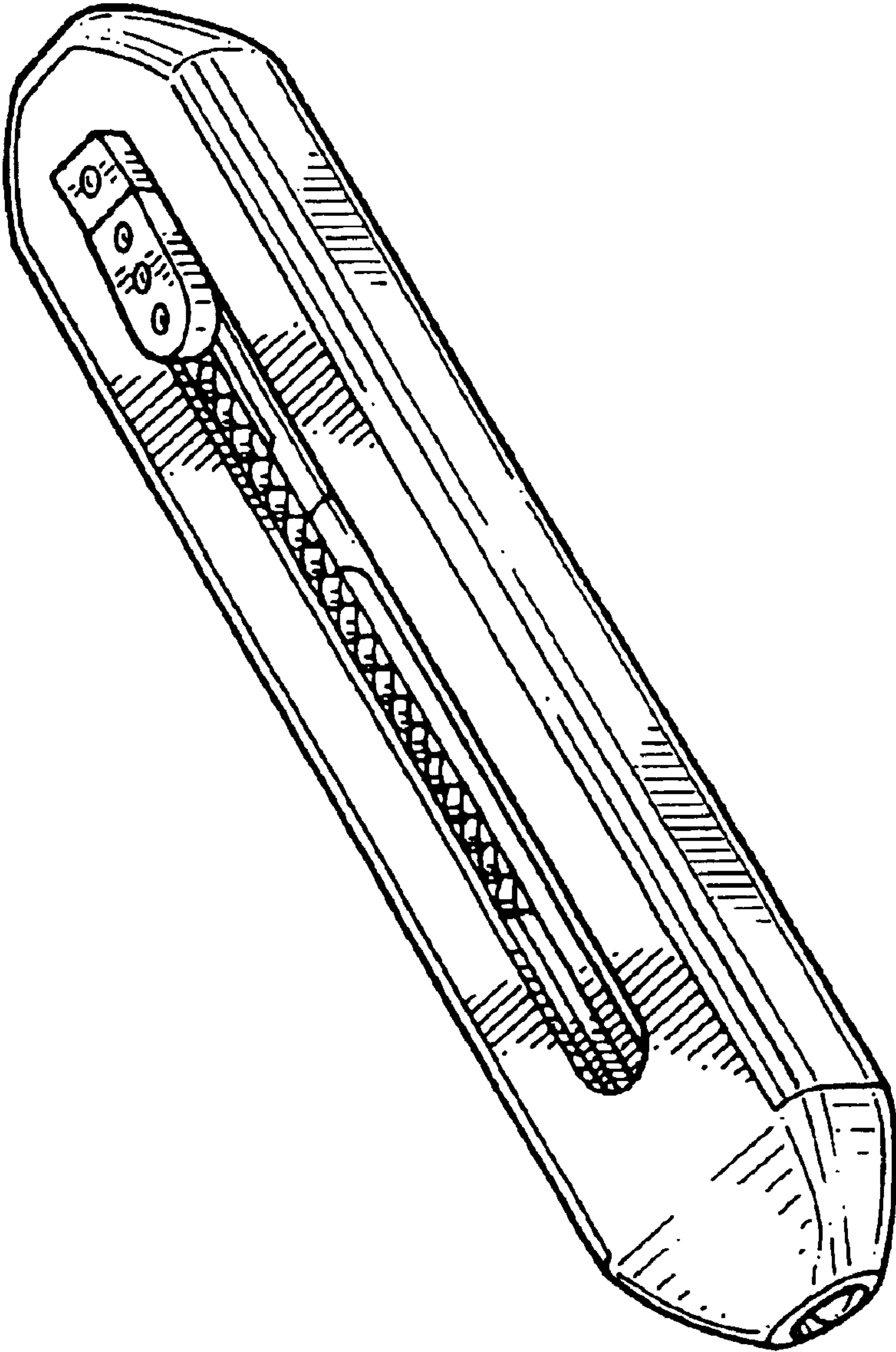

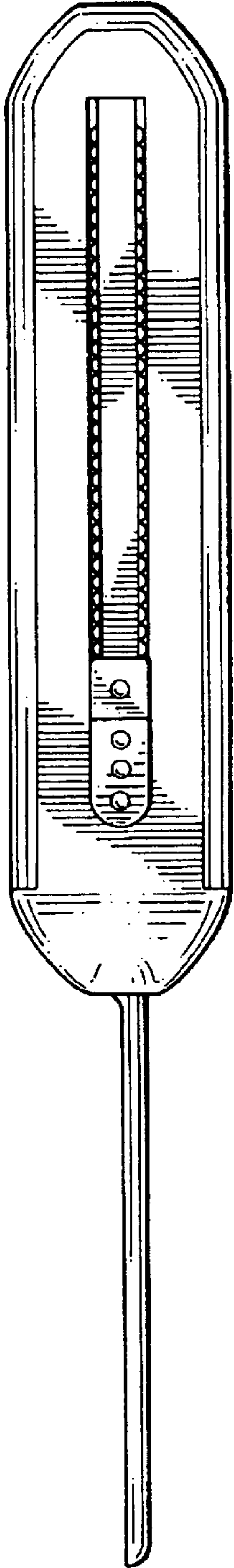

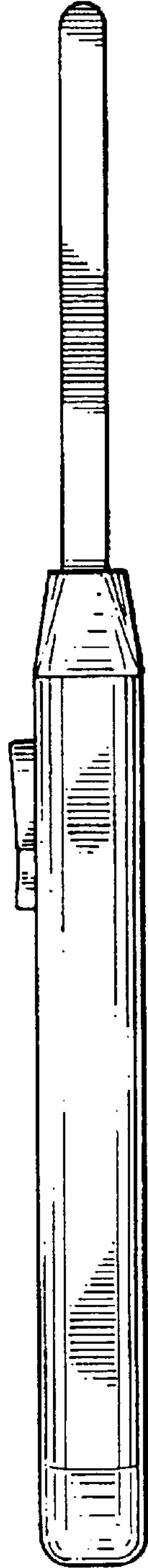

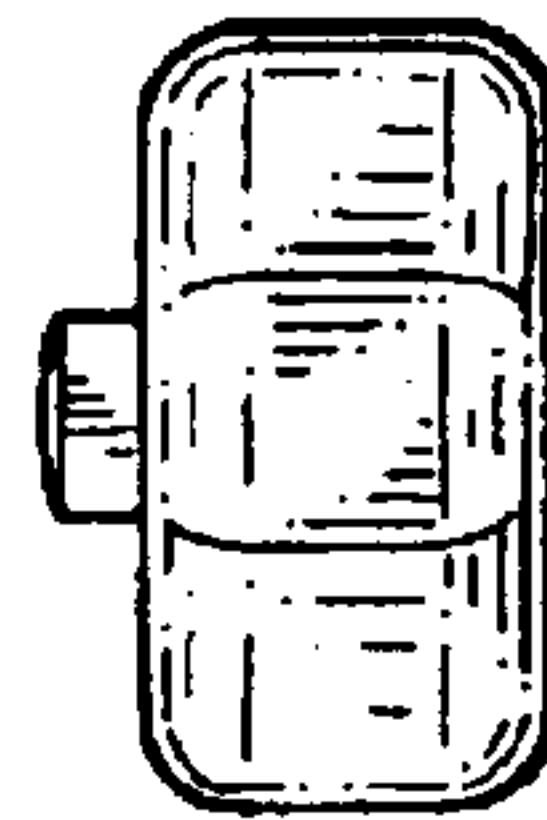

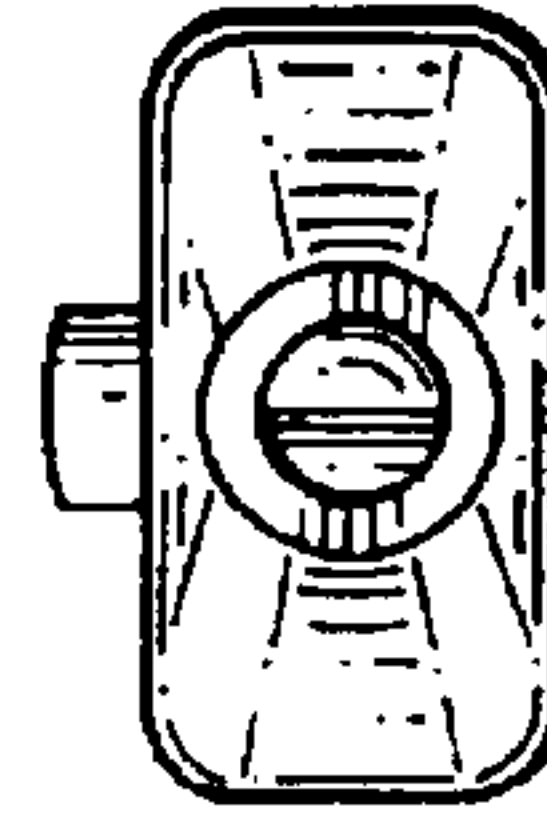
