The ornamental design for a combined balloon bottle and gondola cap, as shown and described.

FIG. 1 is a front elevational view of the combined balloon bottle and gondola cap embodying my new design;

FIG. 2 is a front perspective view of the combined bottle and cap;

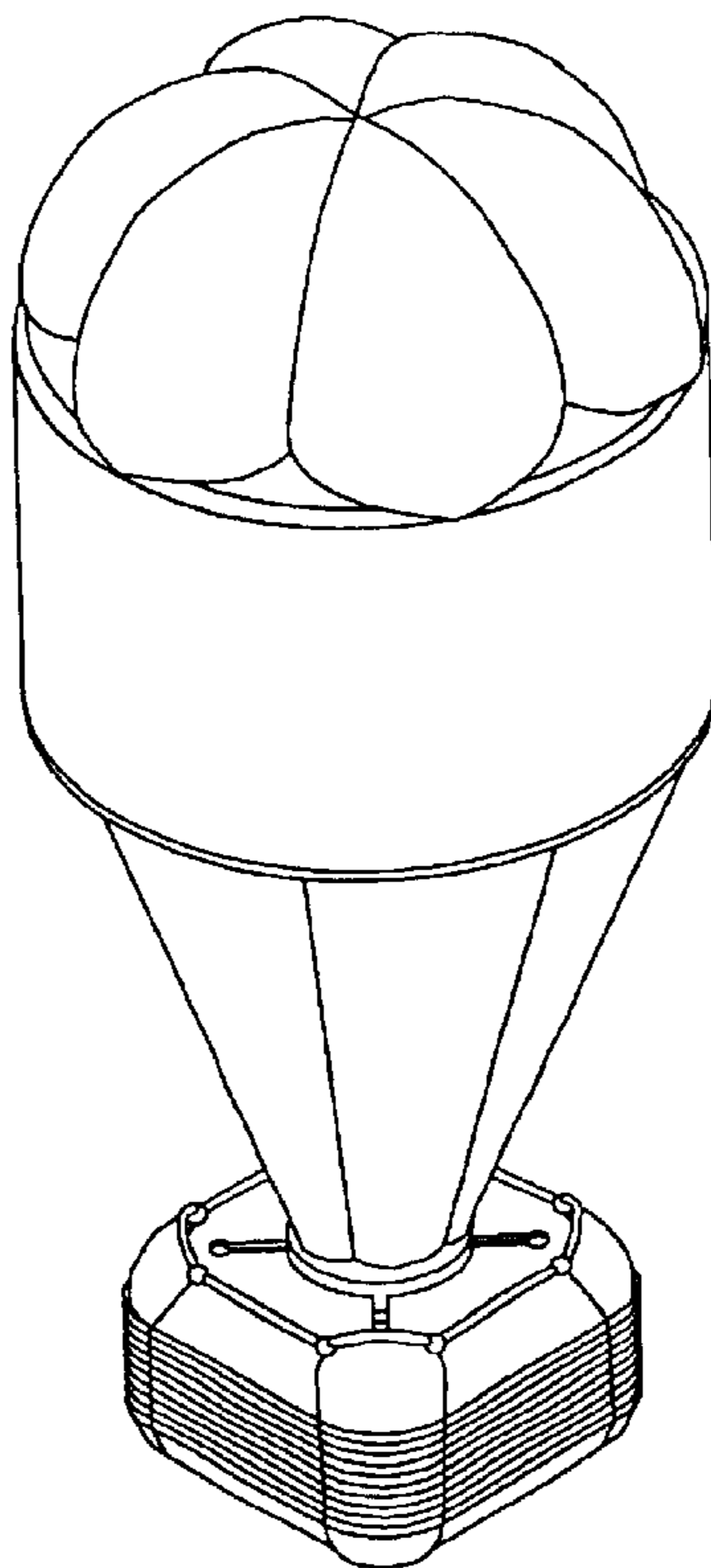
FIG. 3 is a top view of the bottle;

FIG. 4 is a bottom view of the bottle and cap;

FIG. 5 is a front elevation view of the bottle without the cap, the rear, left side and right side being identical except for the conventional screw threading on the bottle neck; and,

FIG. 6 is a front elevation view of the cap without the bottle, the rear, left side and right side being identical except for the conventional screw threading on the interior of the cap.

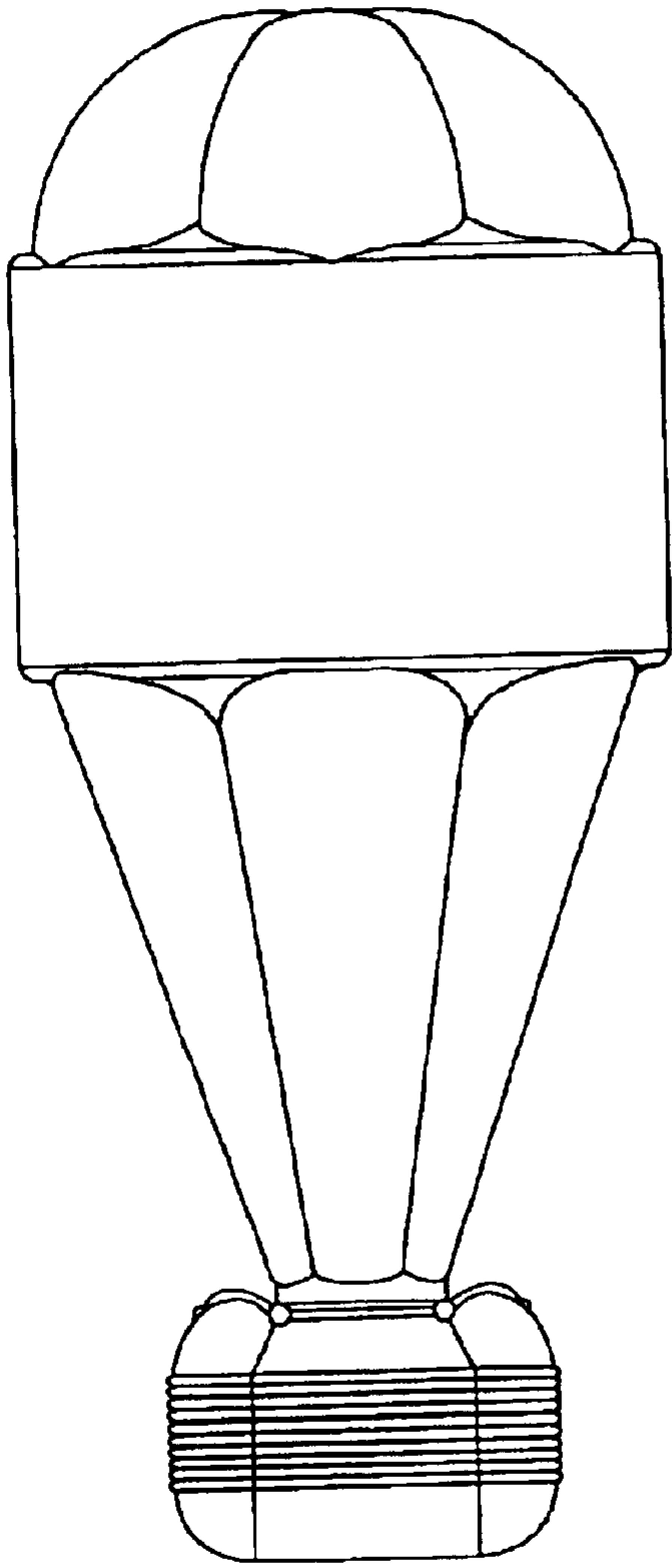

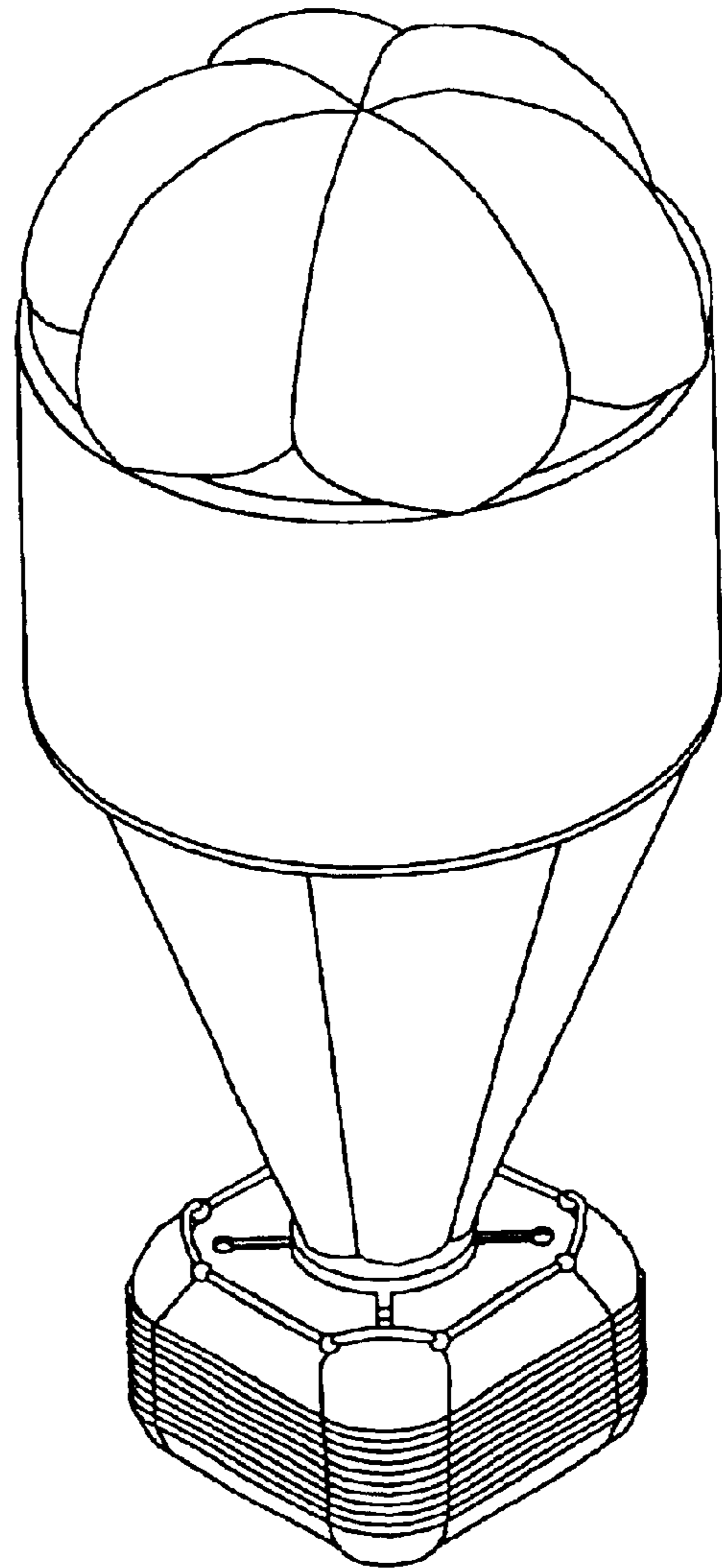

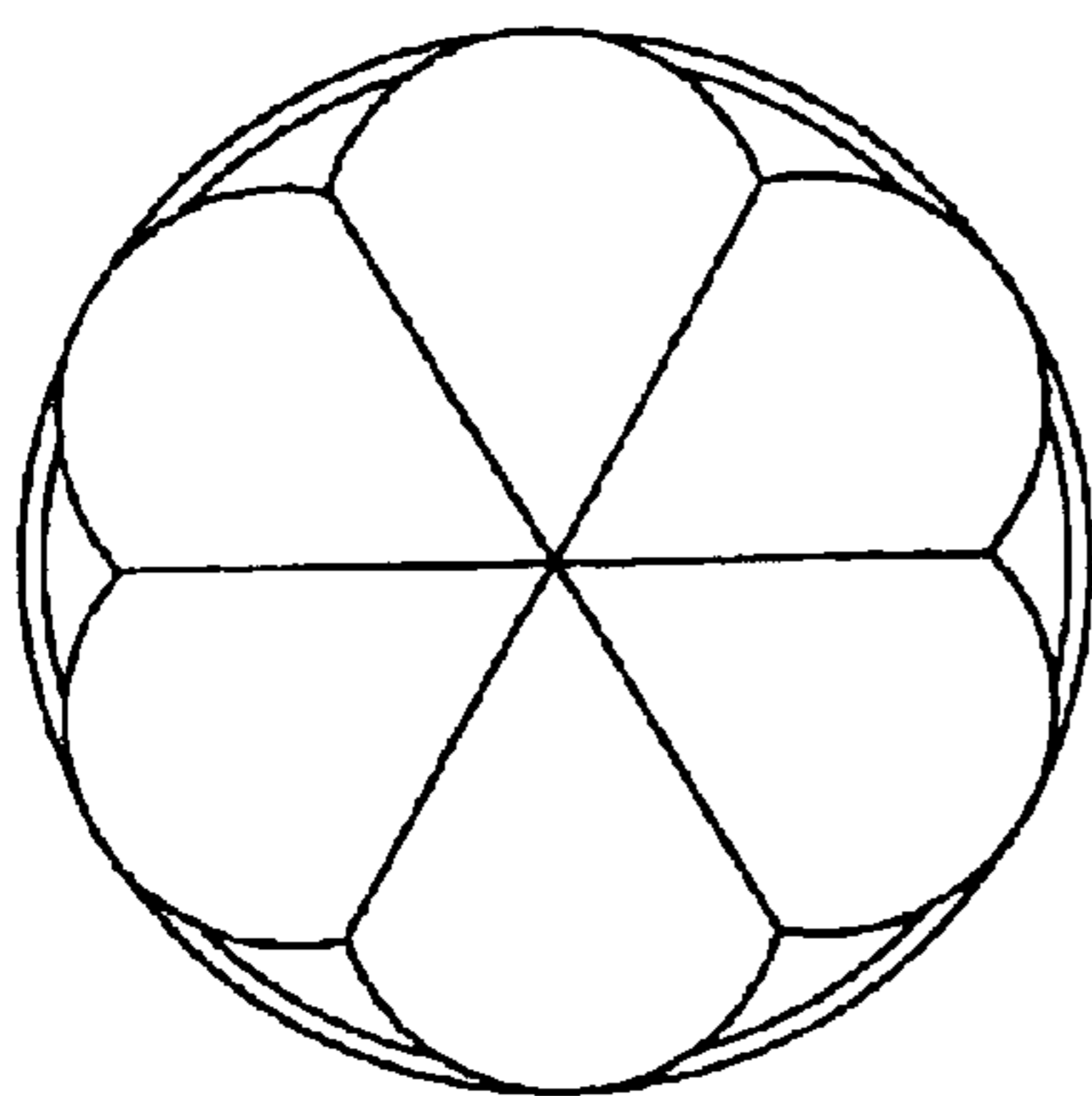

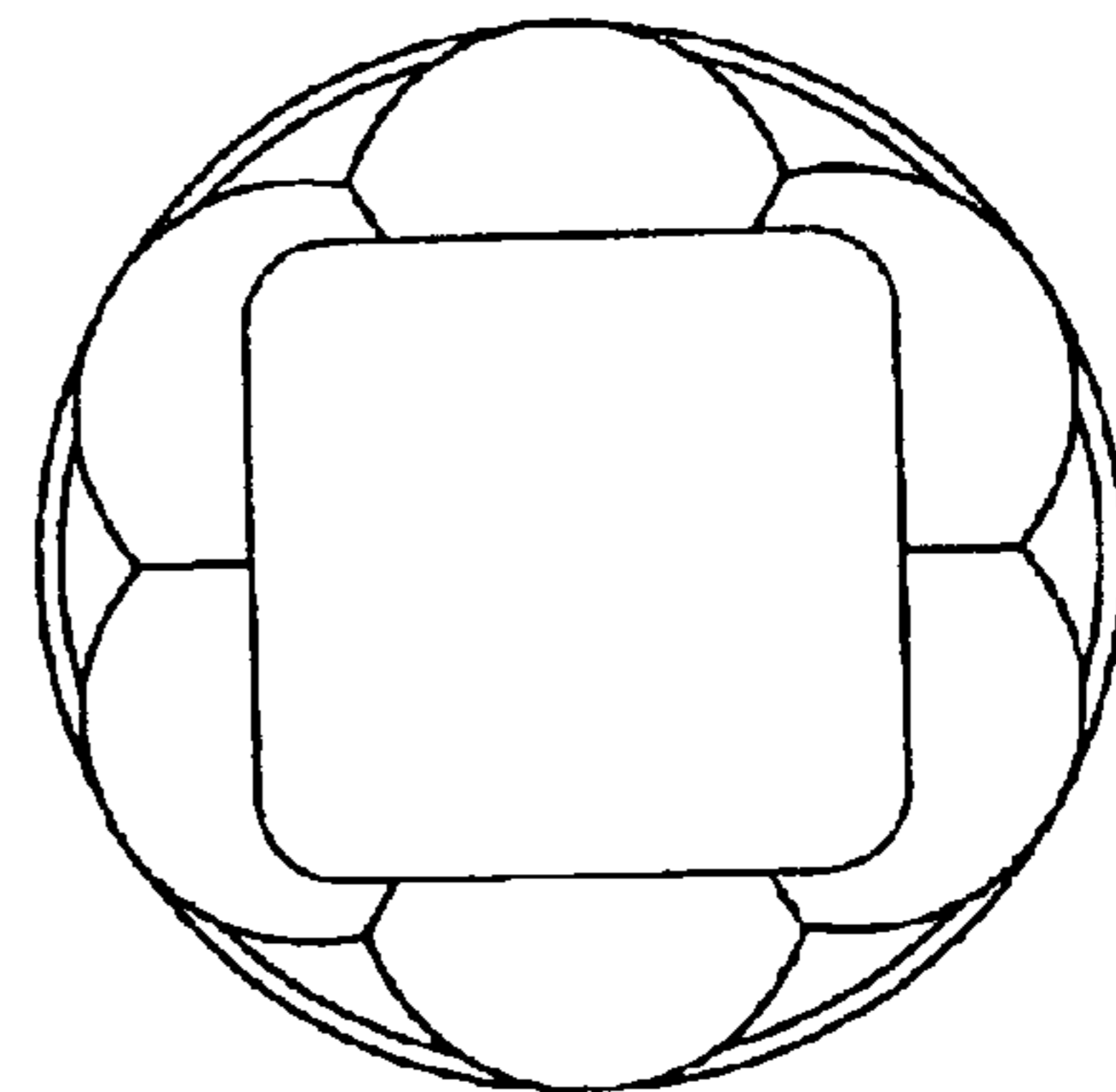

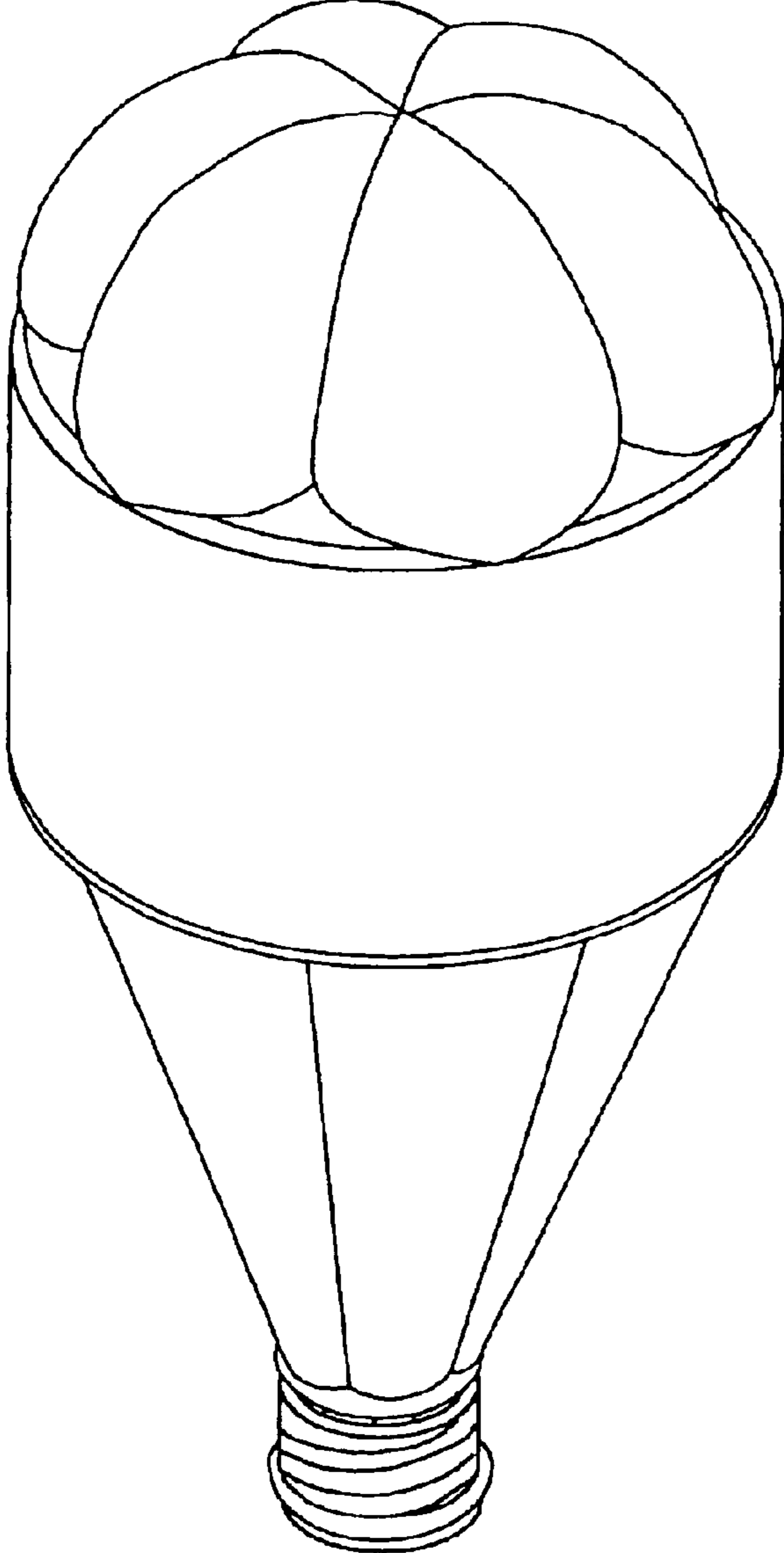

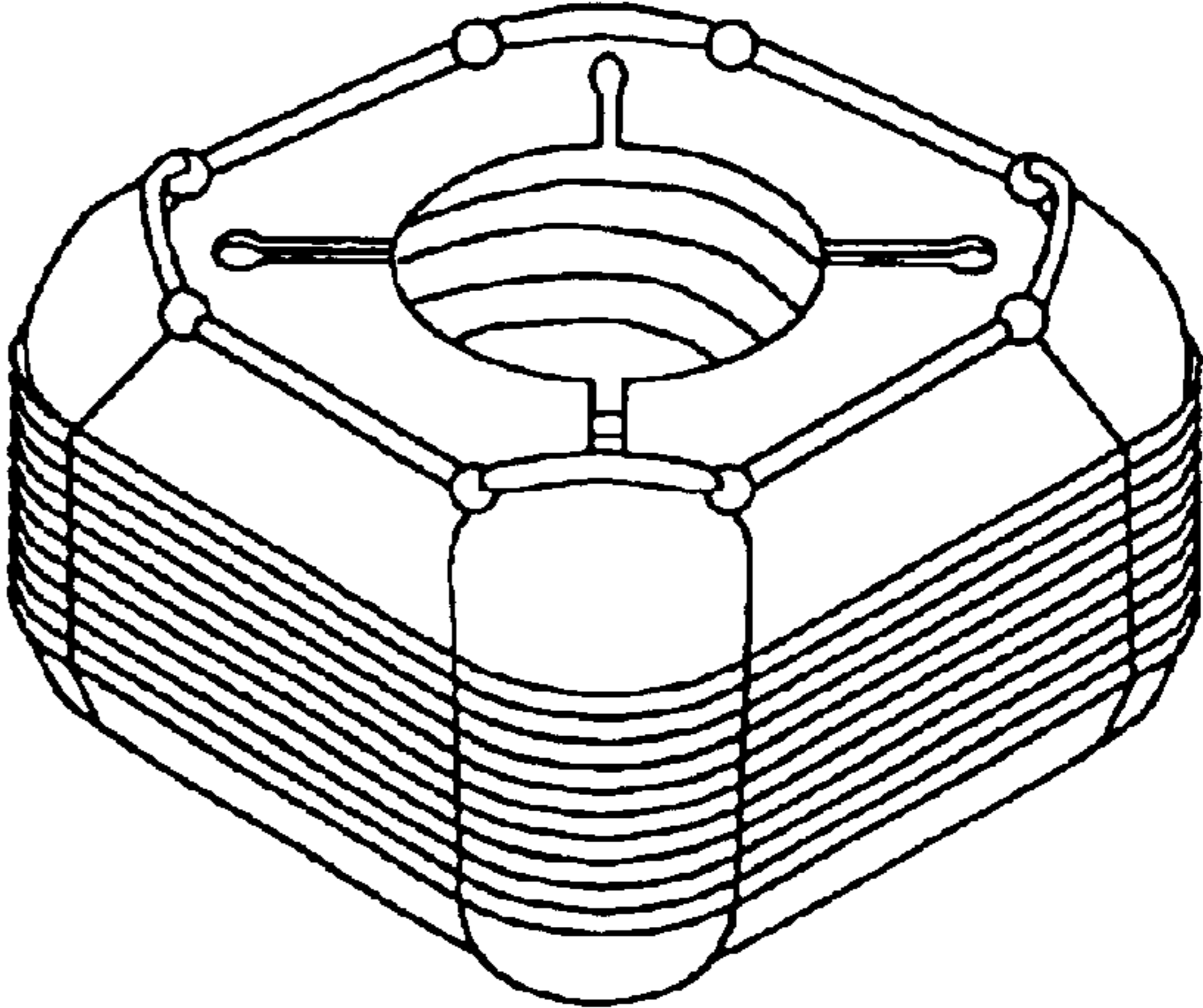
