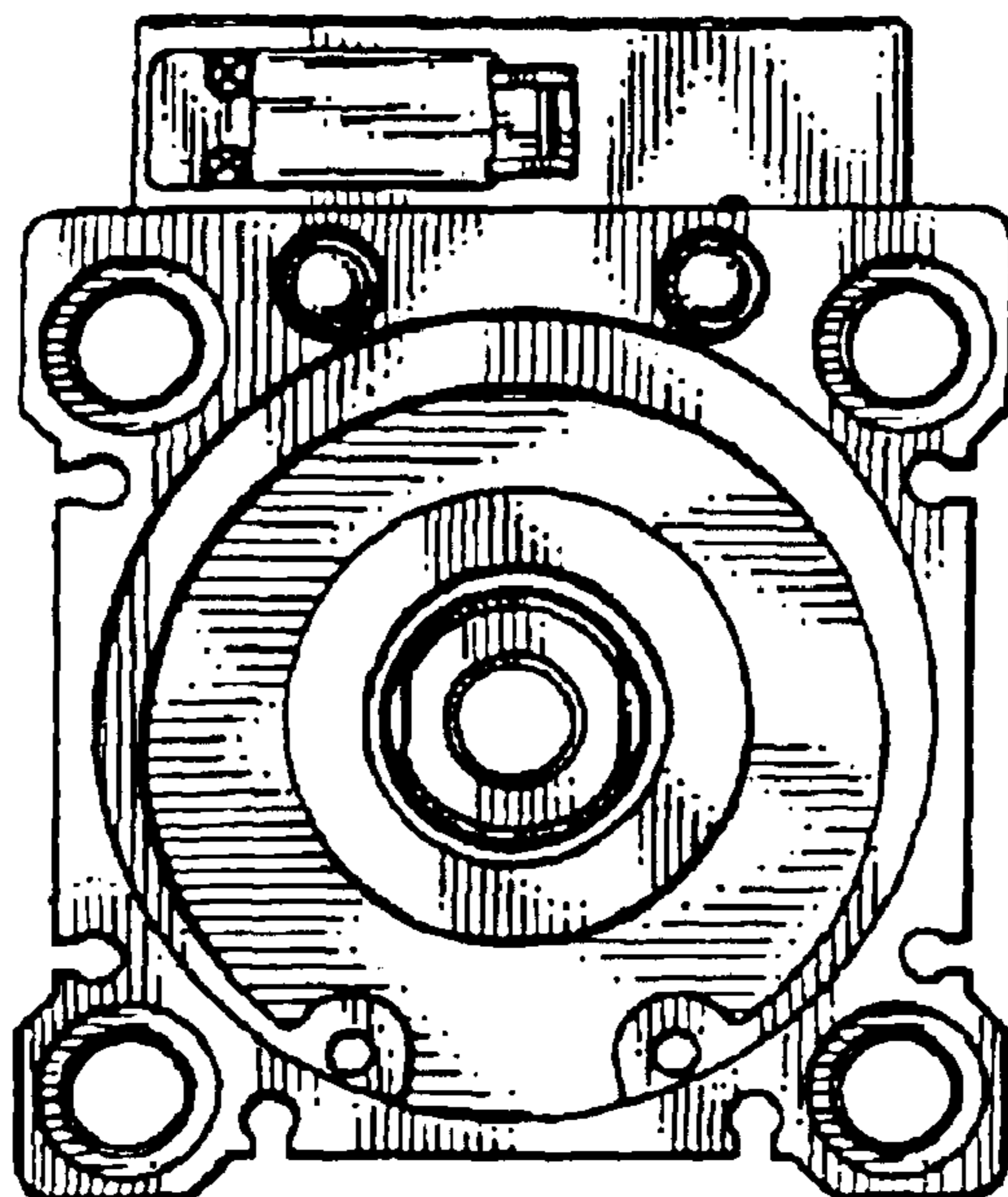
(57) **CLAIM**

The ornamental design for a fluid pressure cylinder, as shown and described.

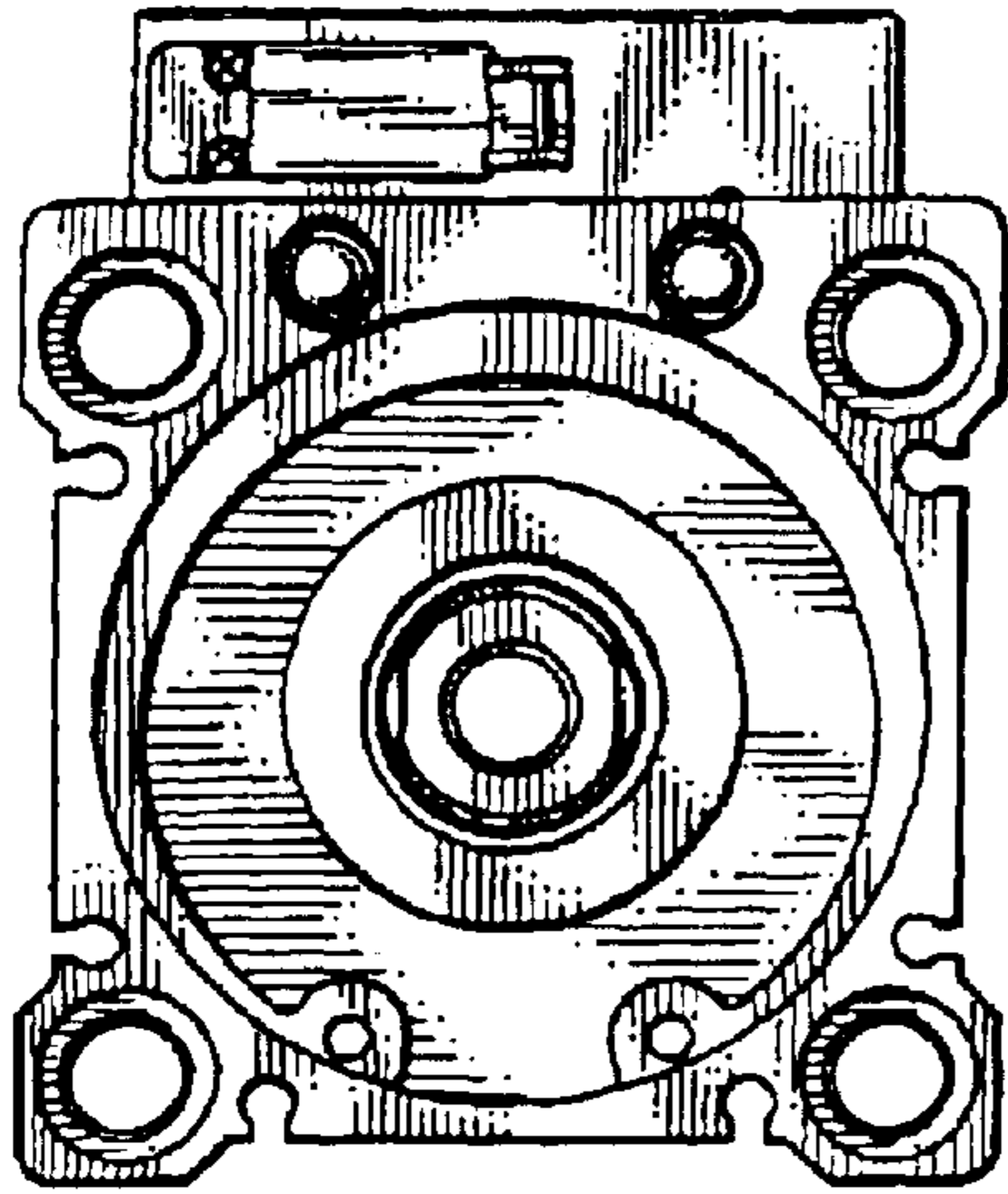
**DESCRIPTION**

 FIG. 24 is a top, rear and right side perspective view thereof.

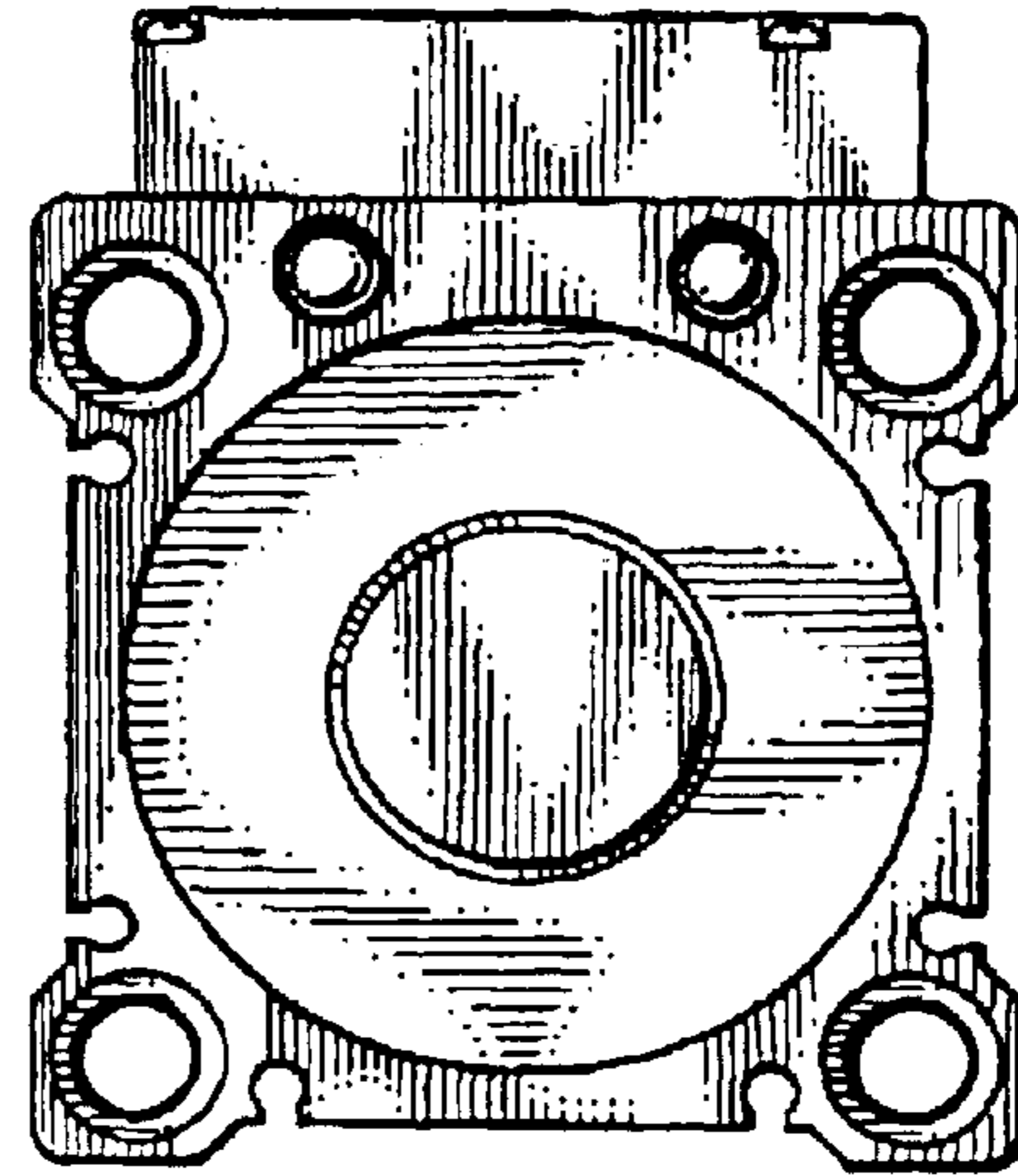

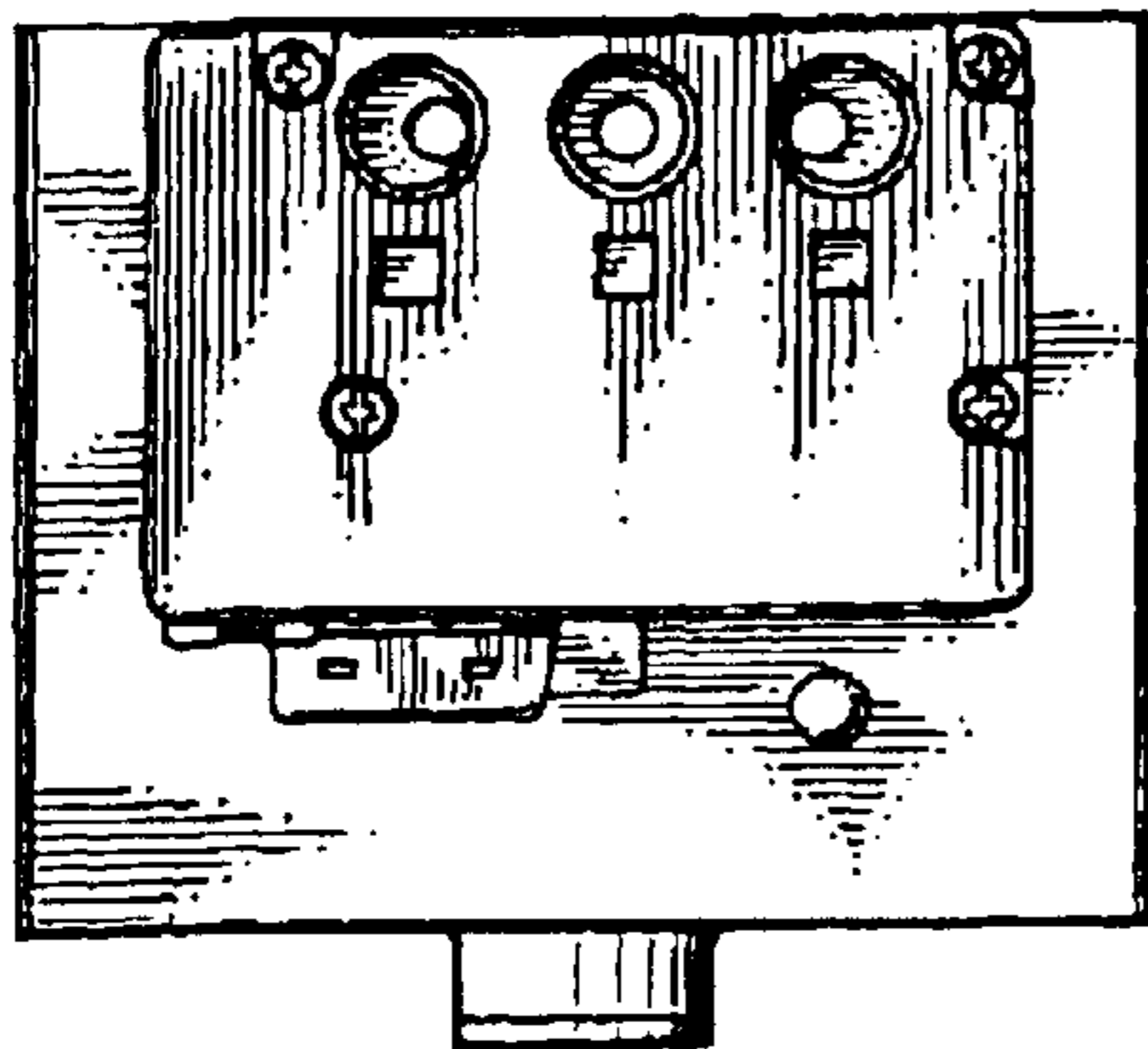

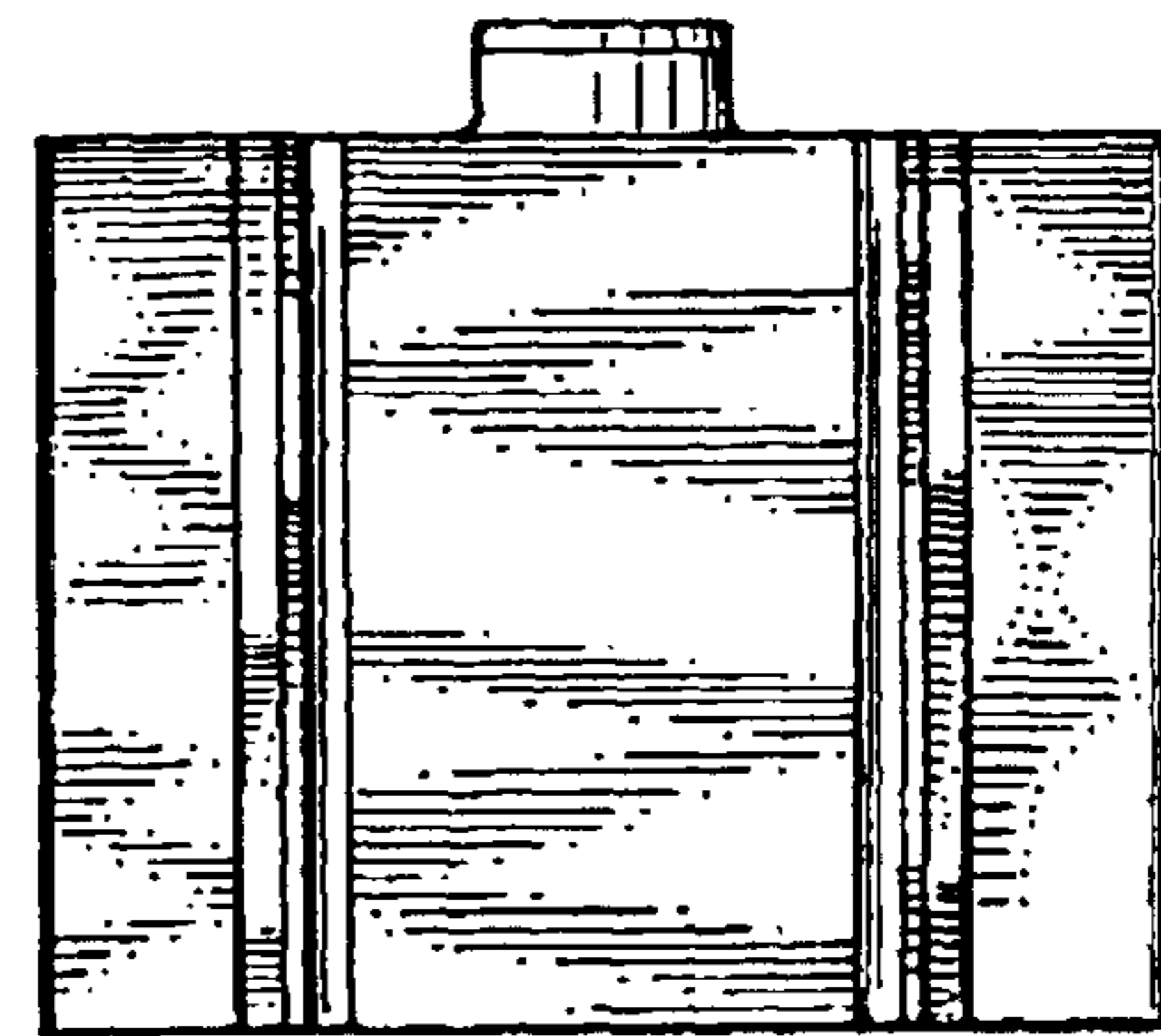

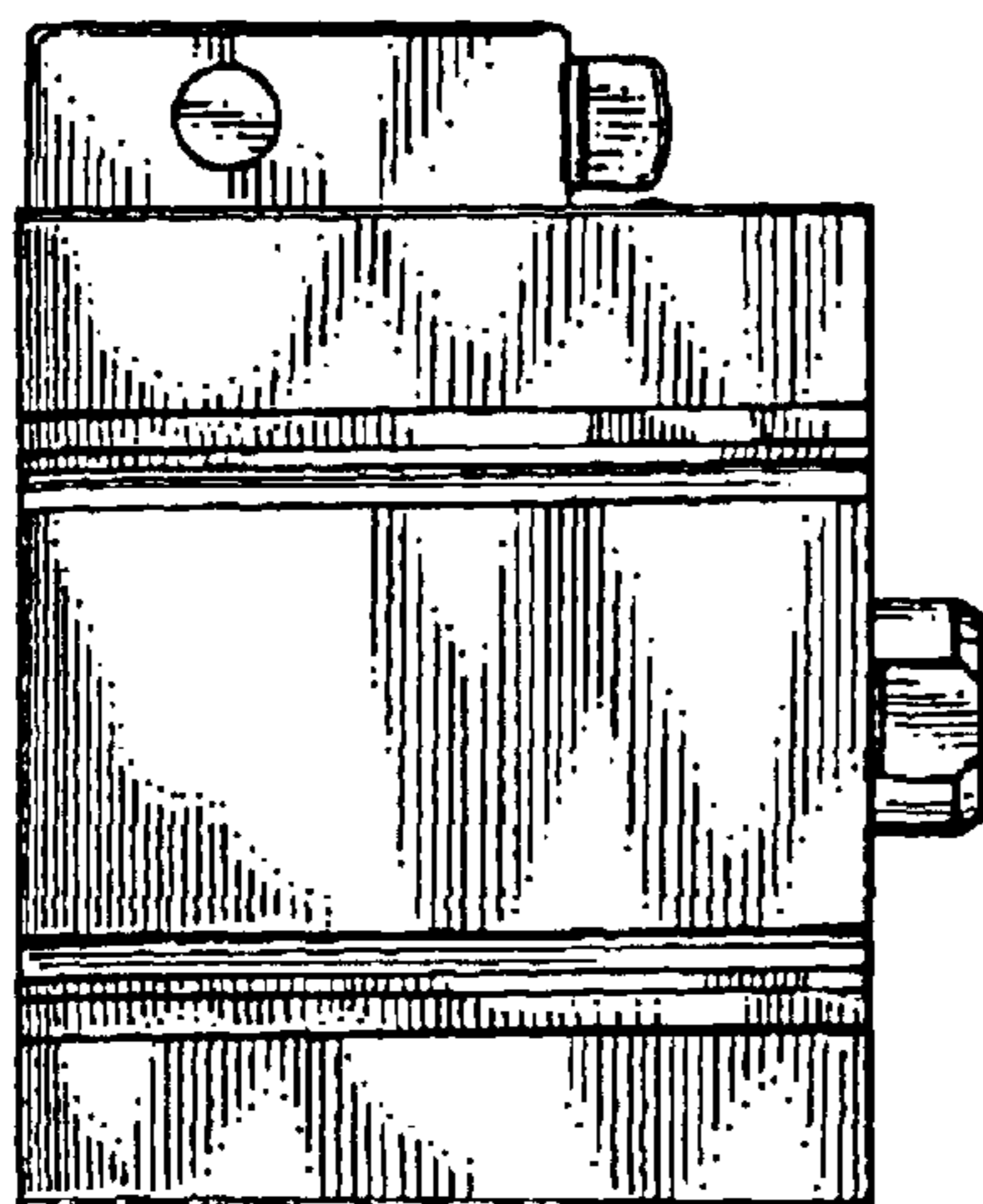

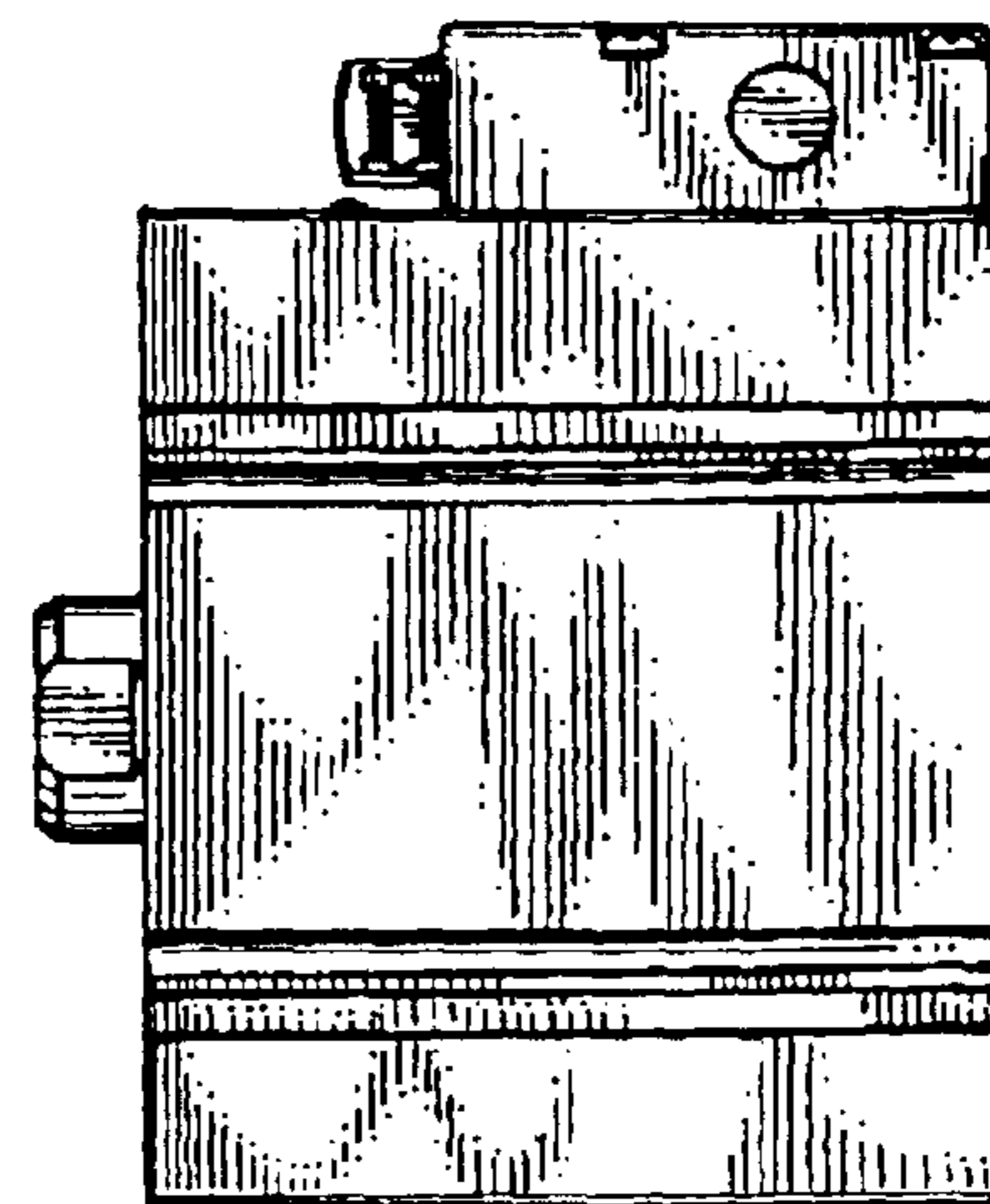

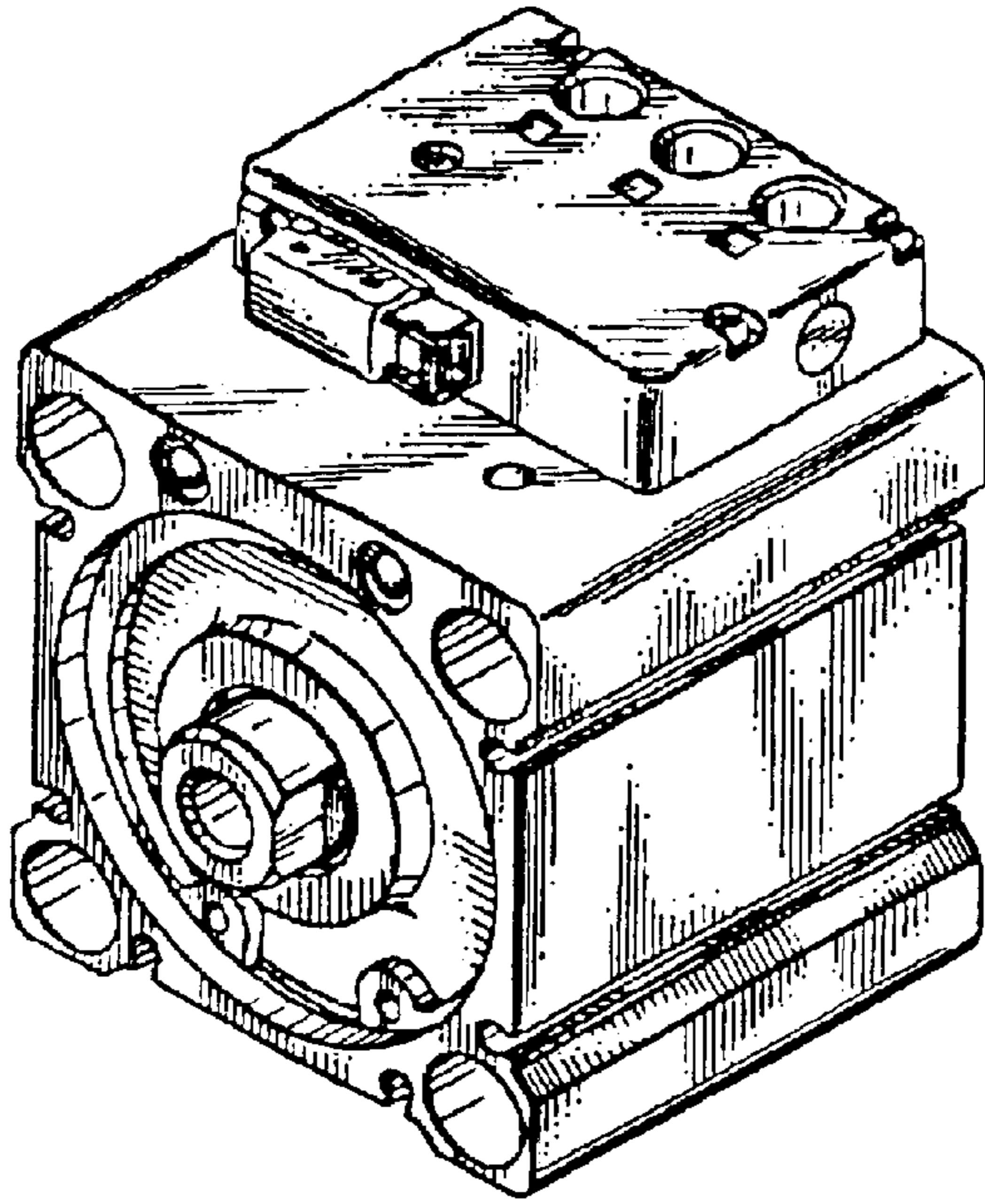

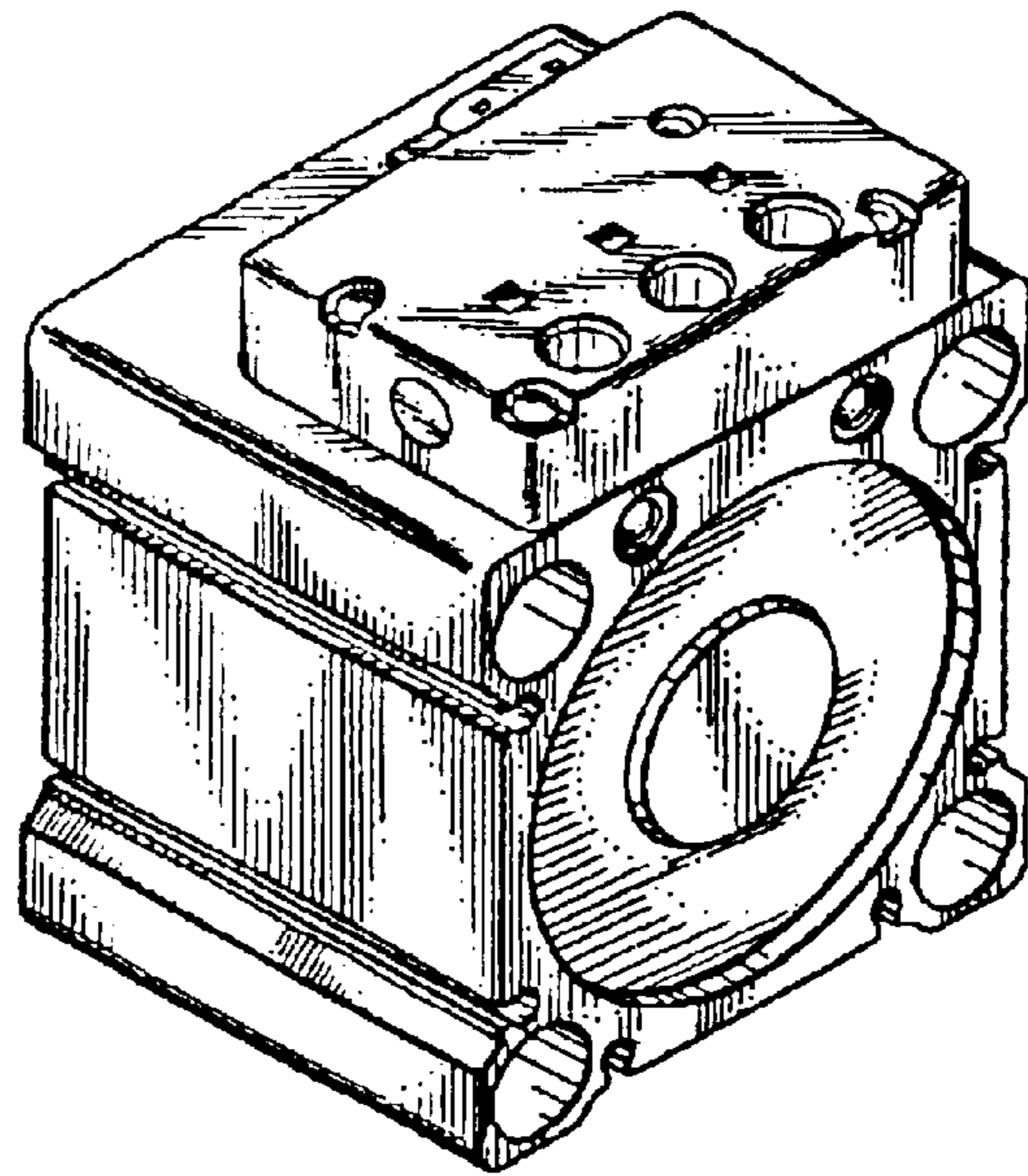

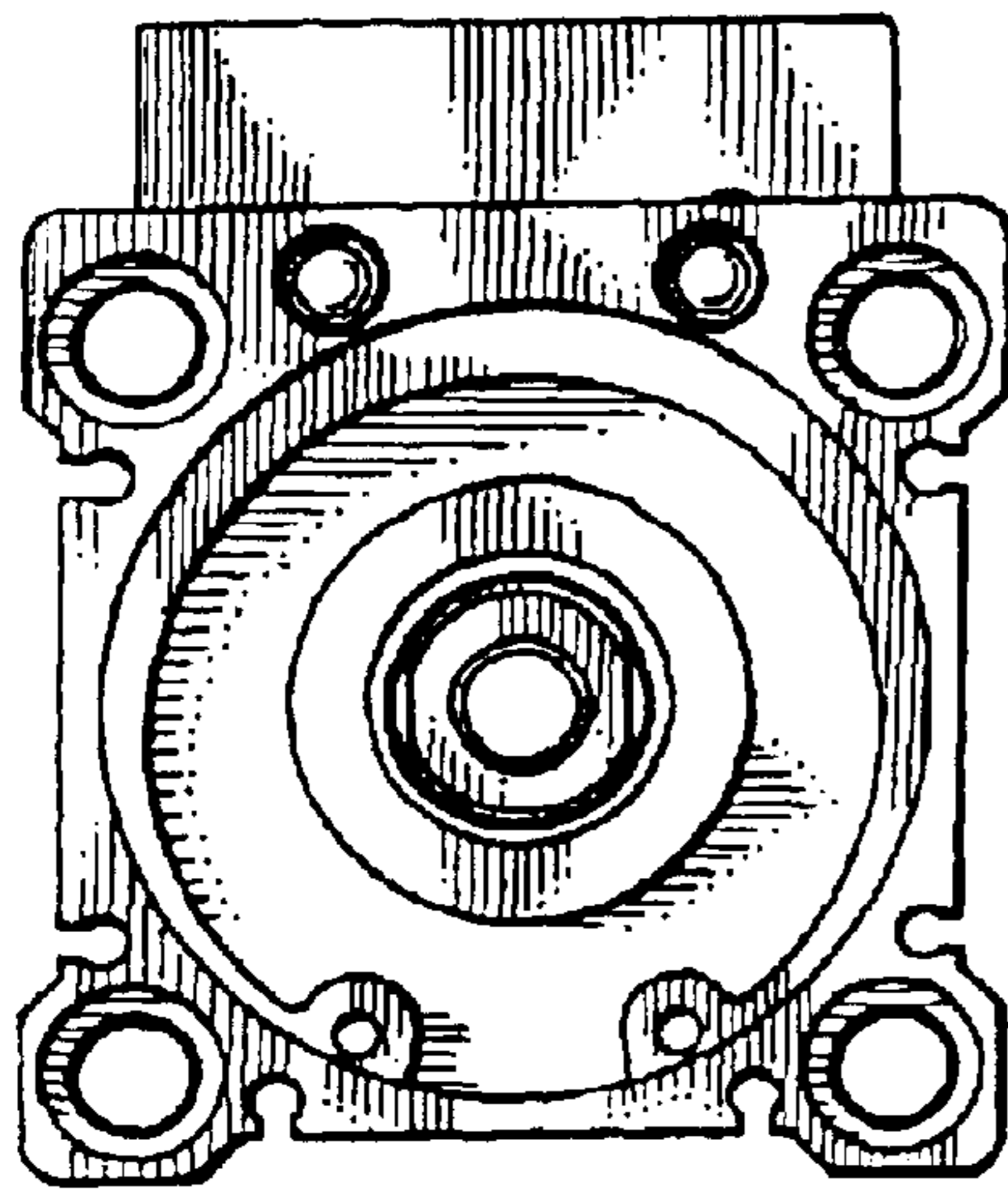

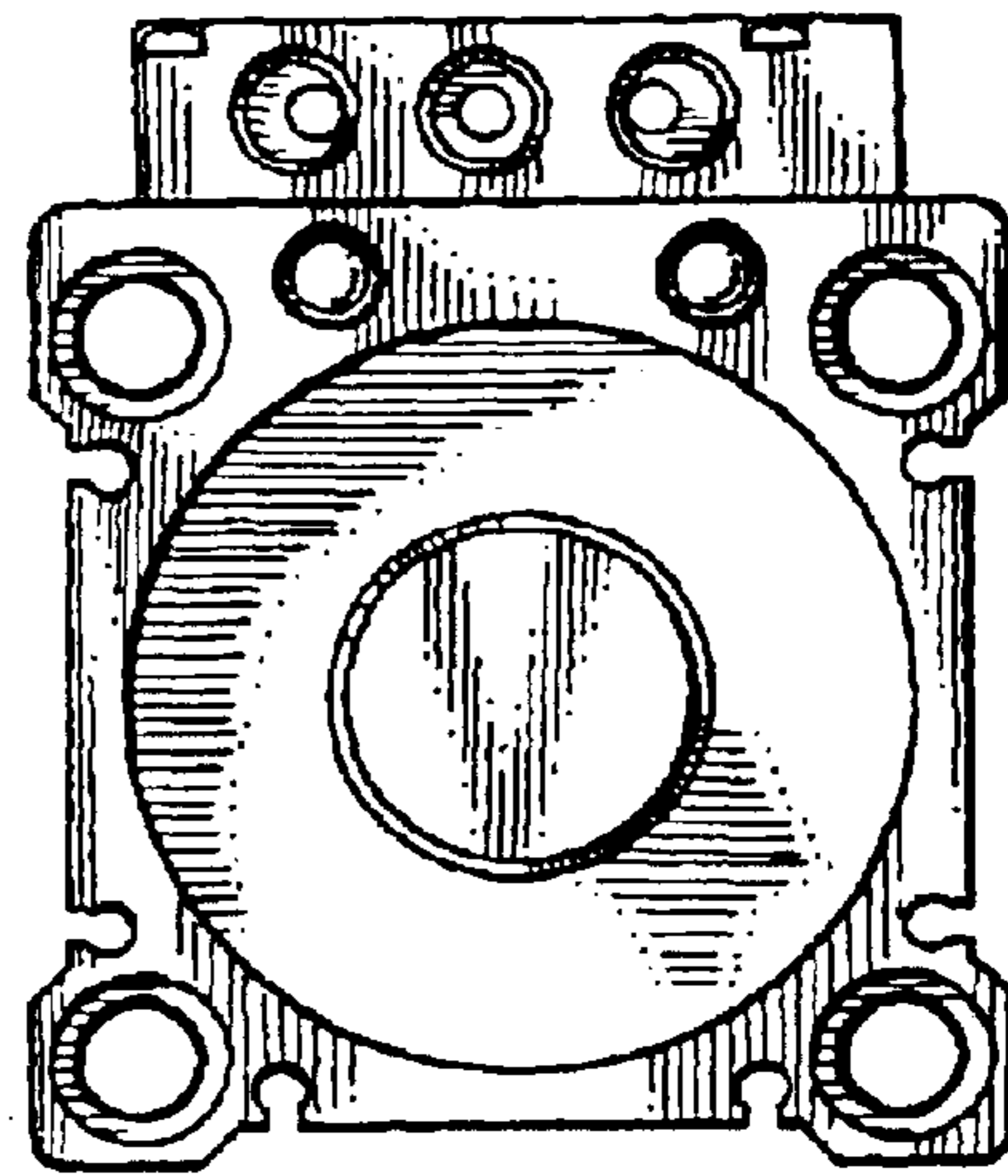

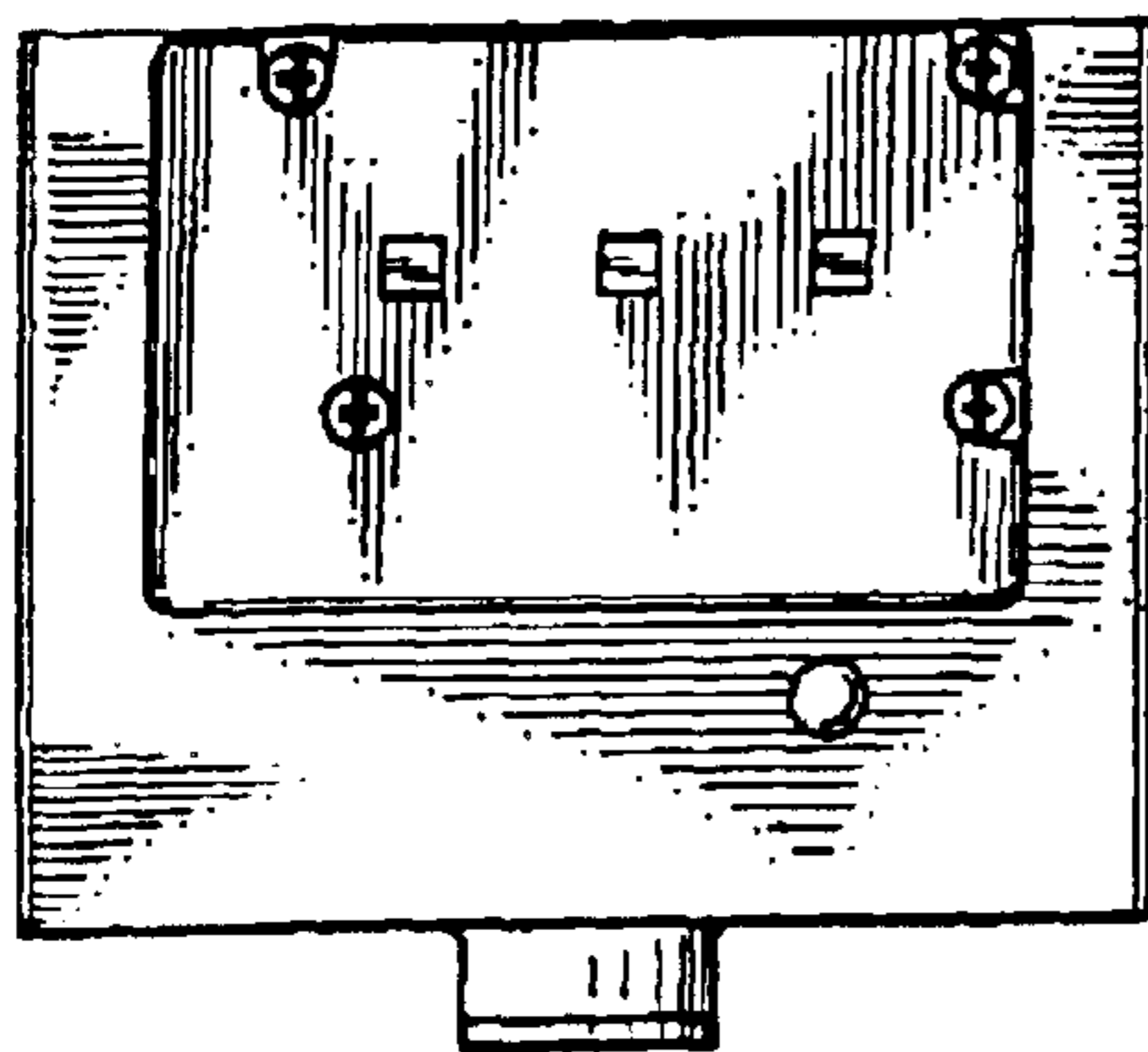

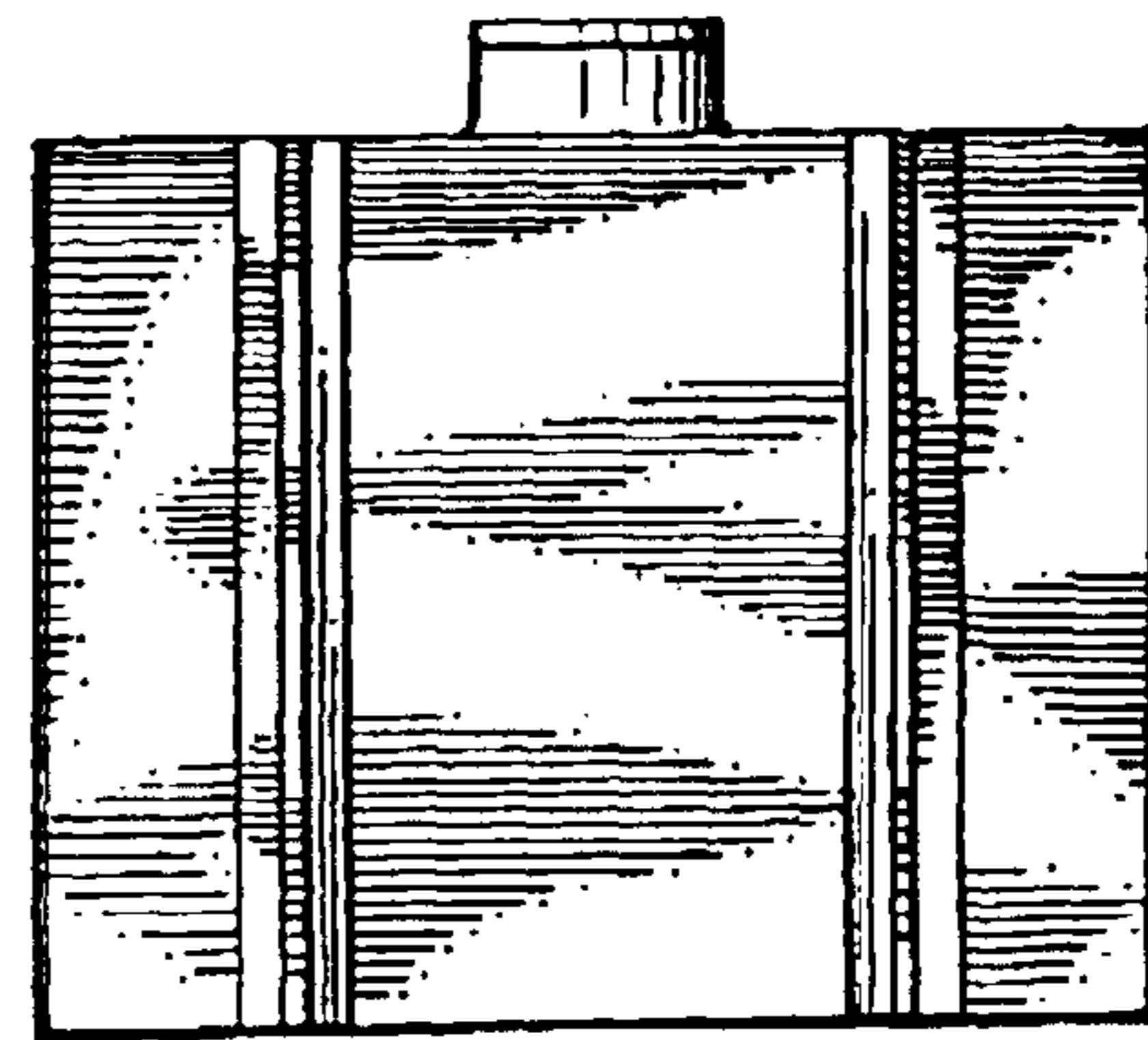

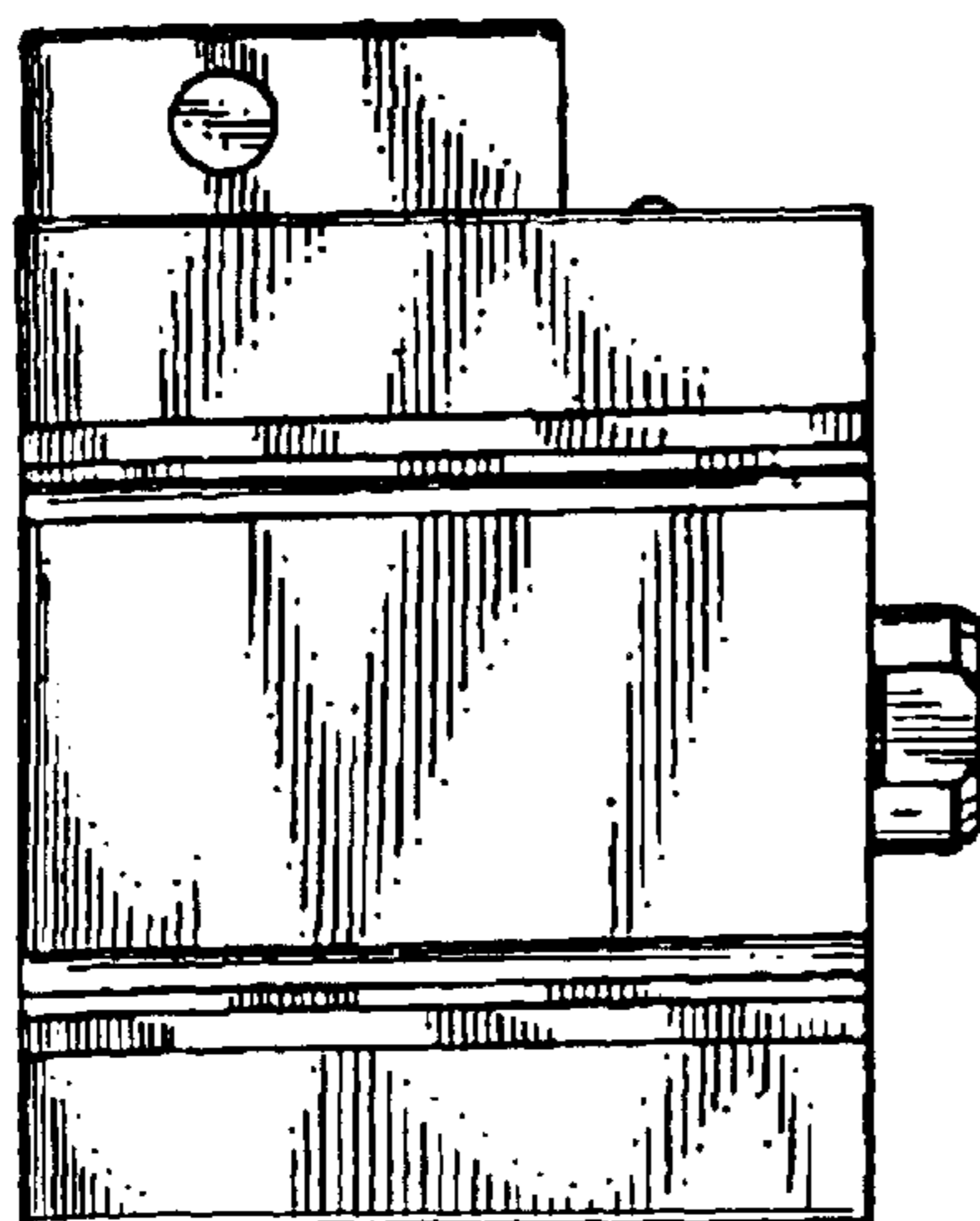

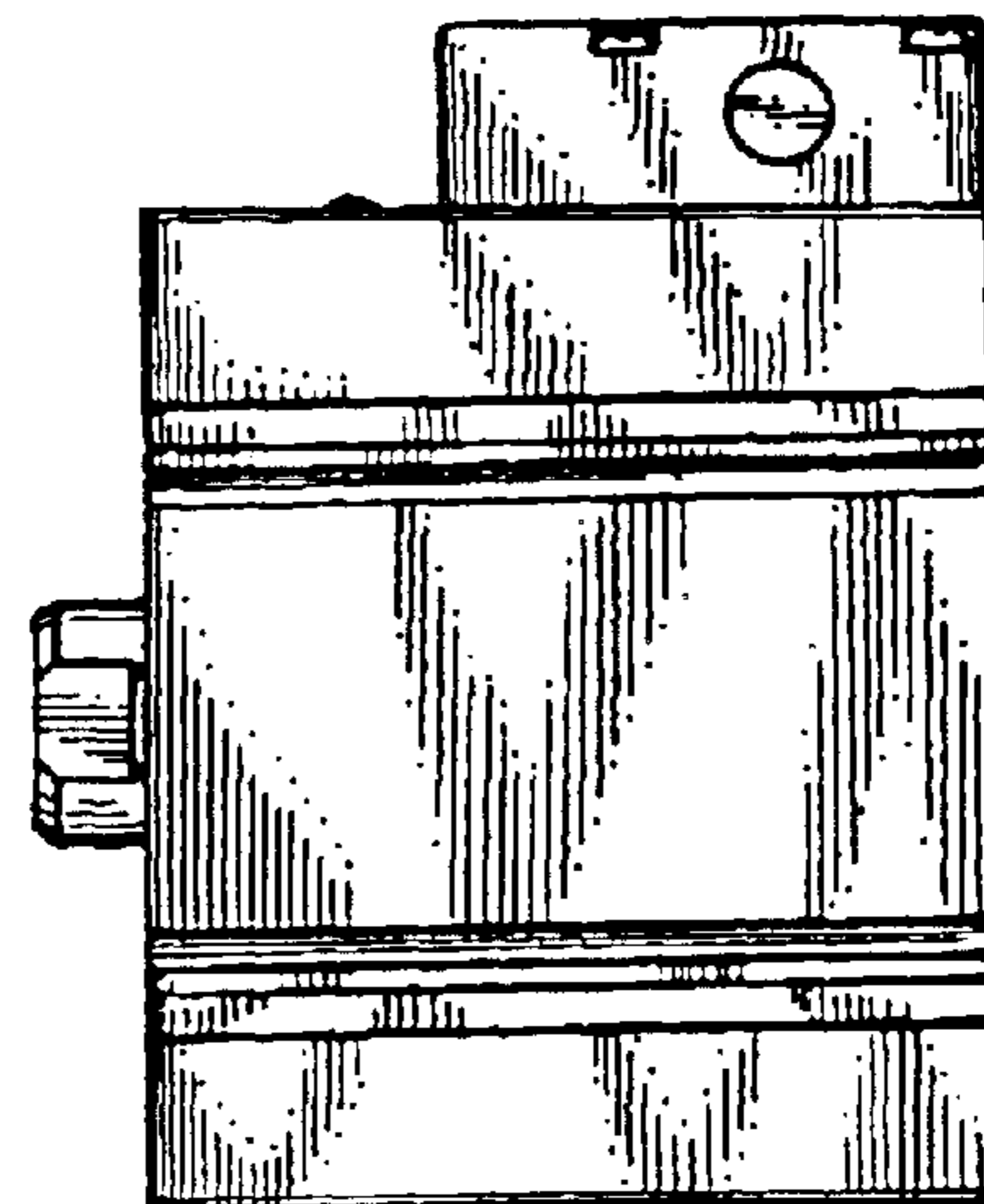

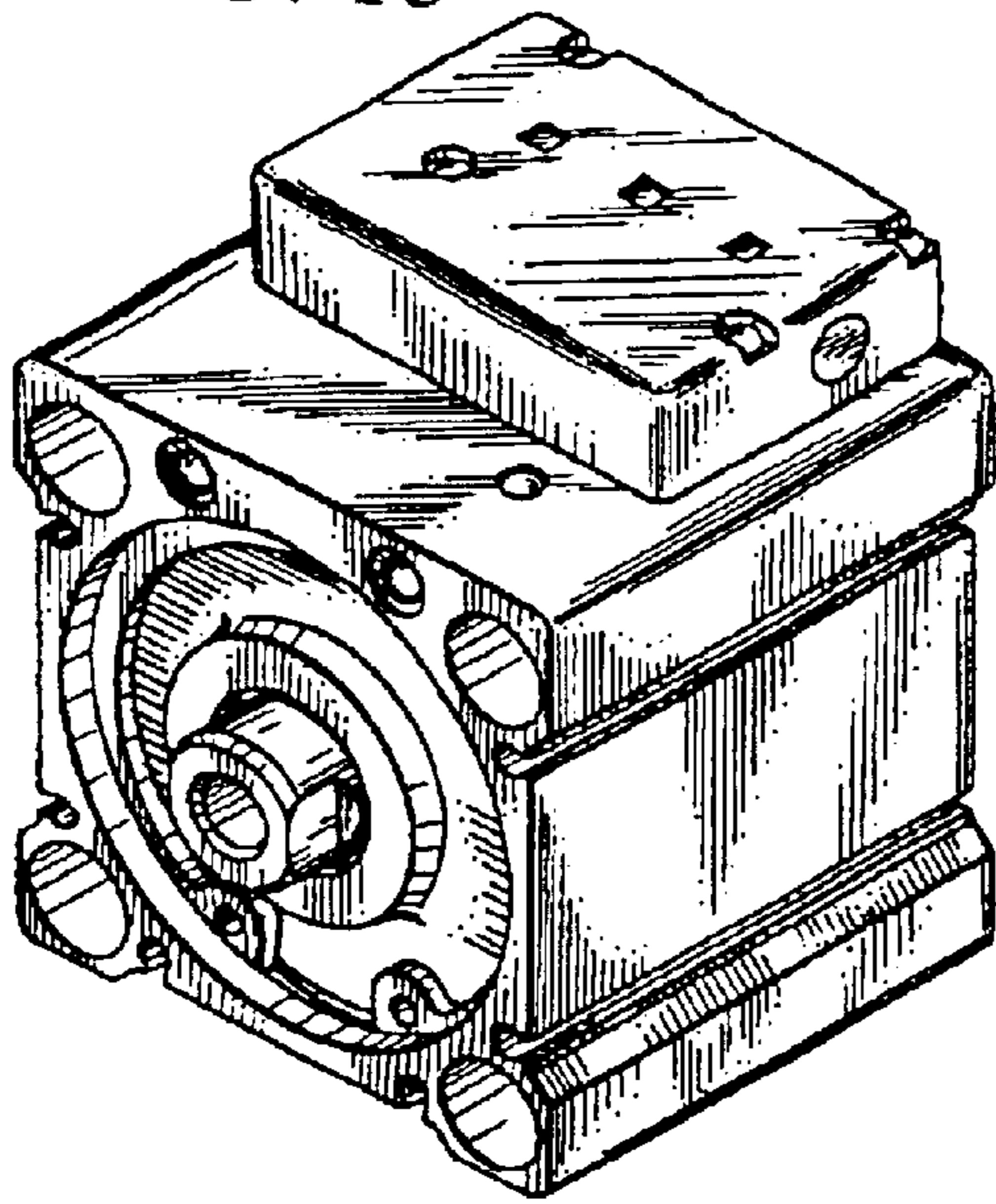

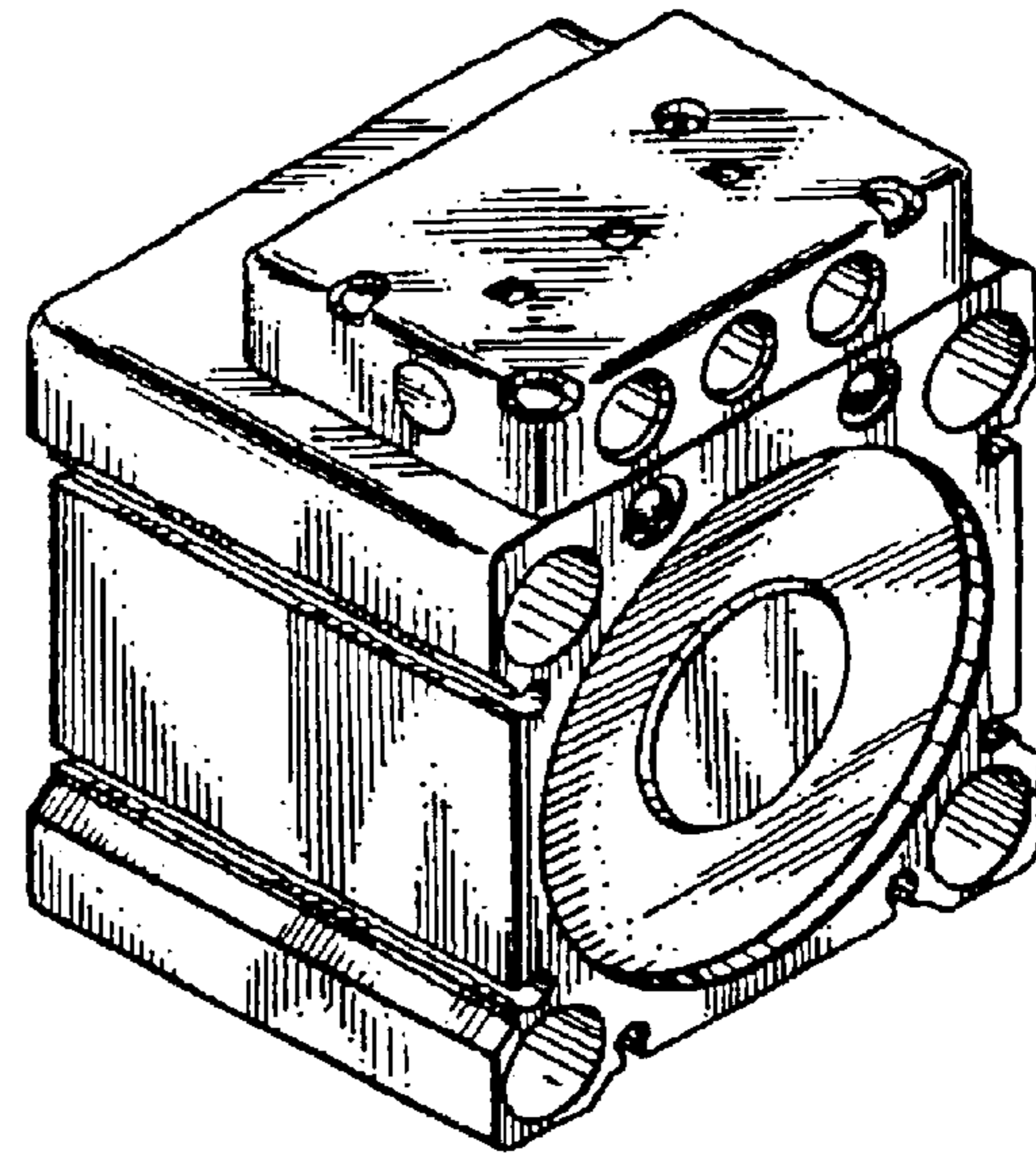

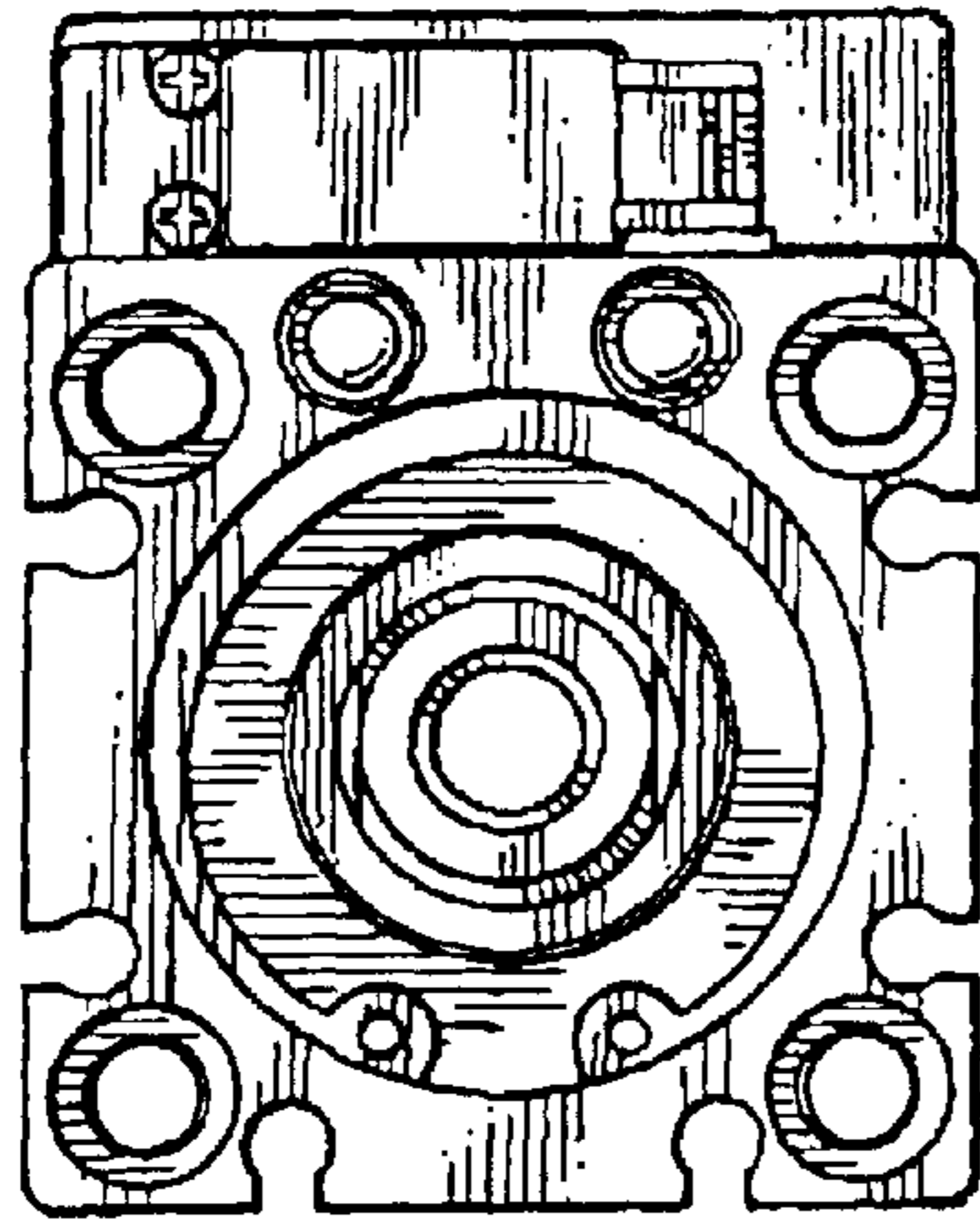

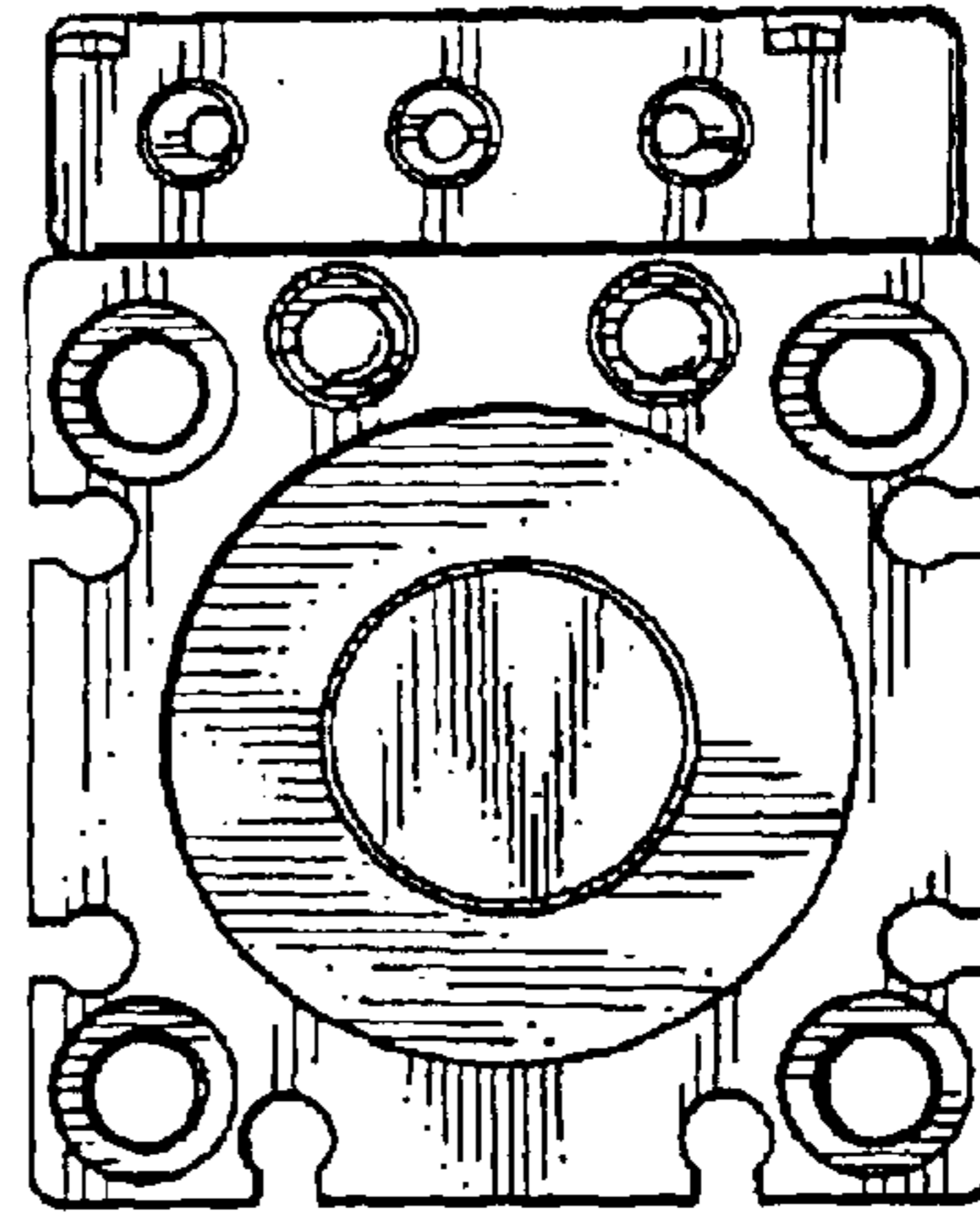

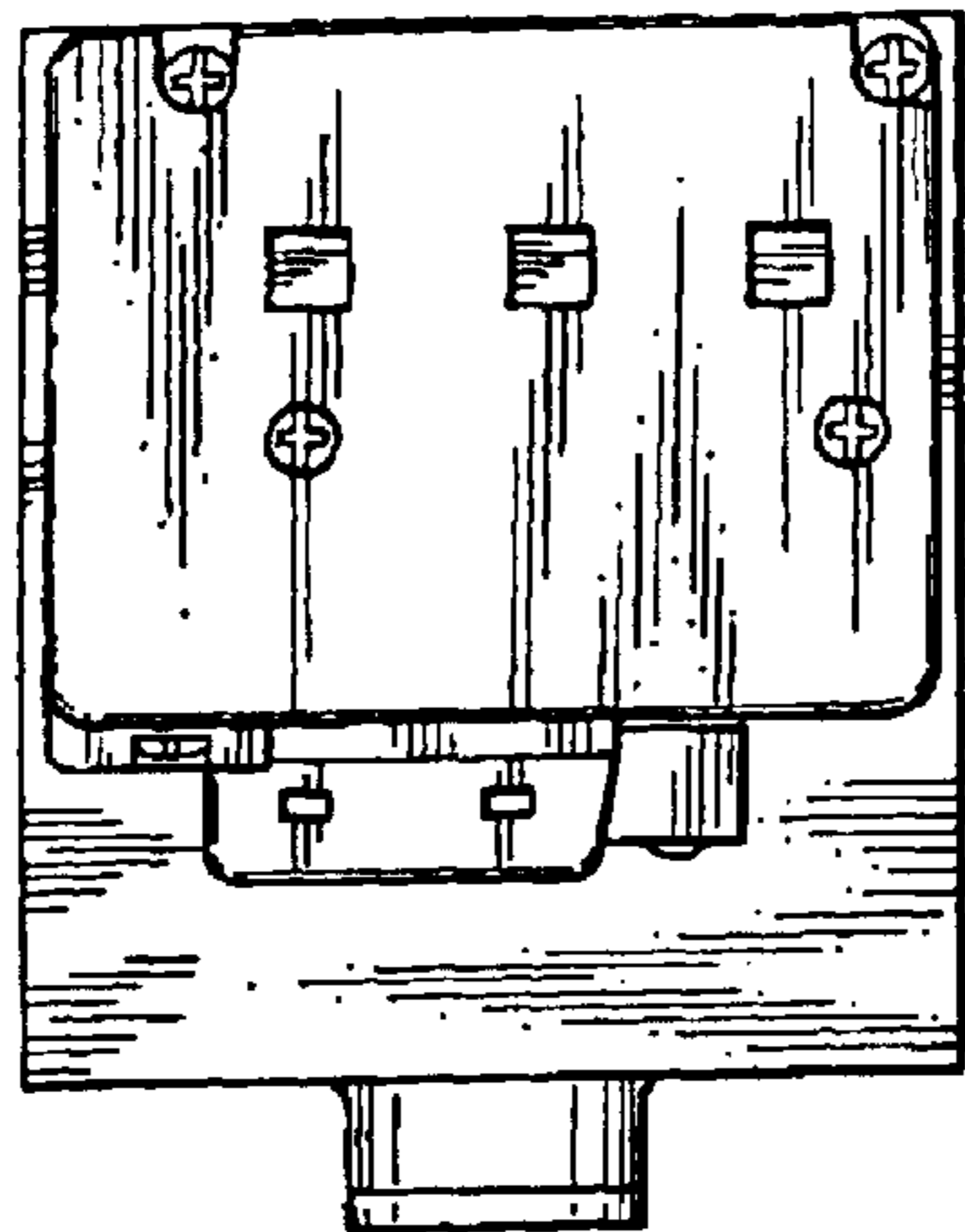

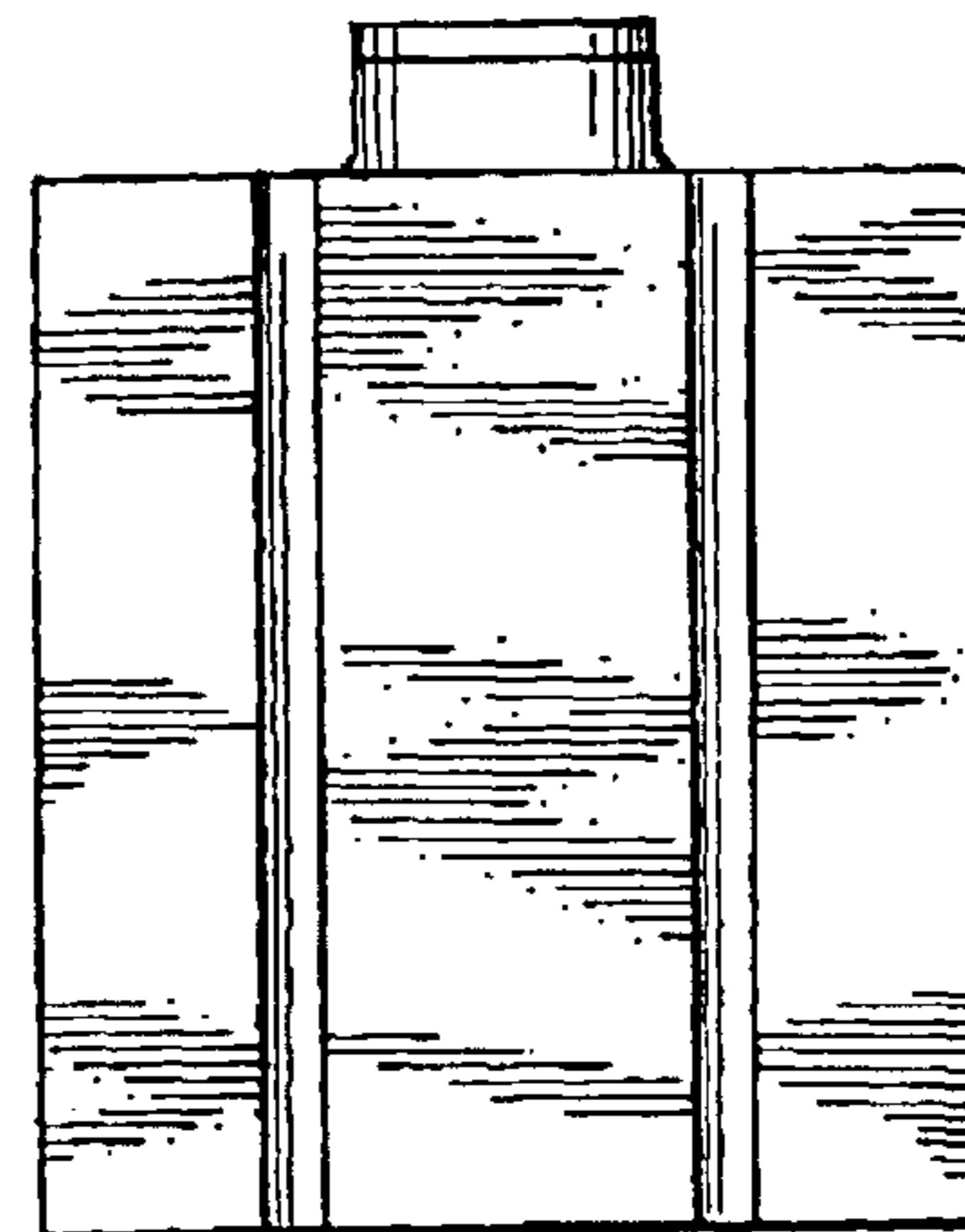

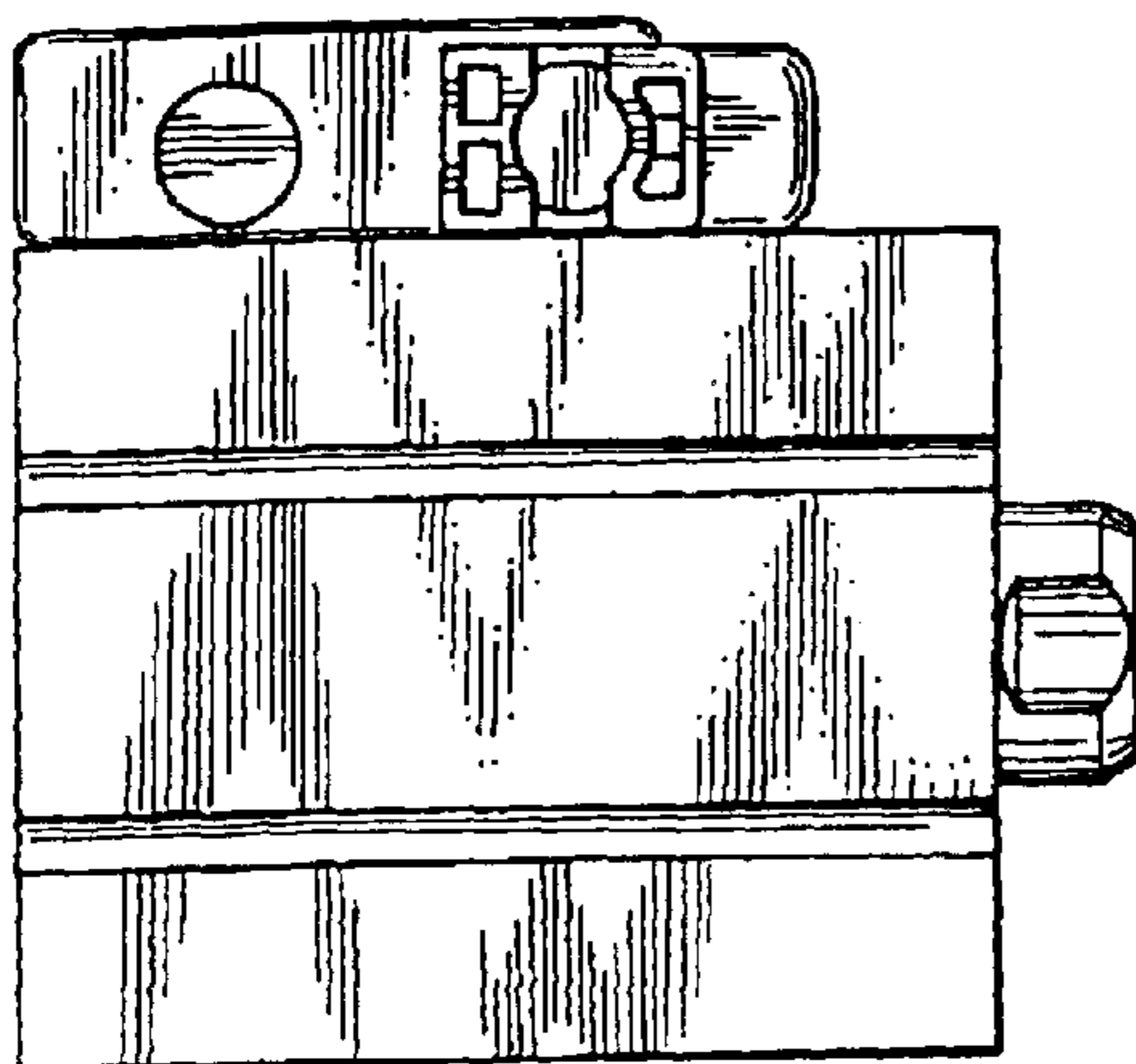

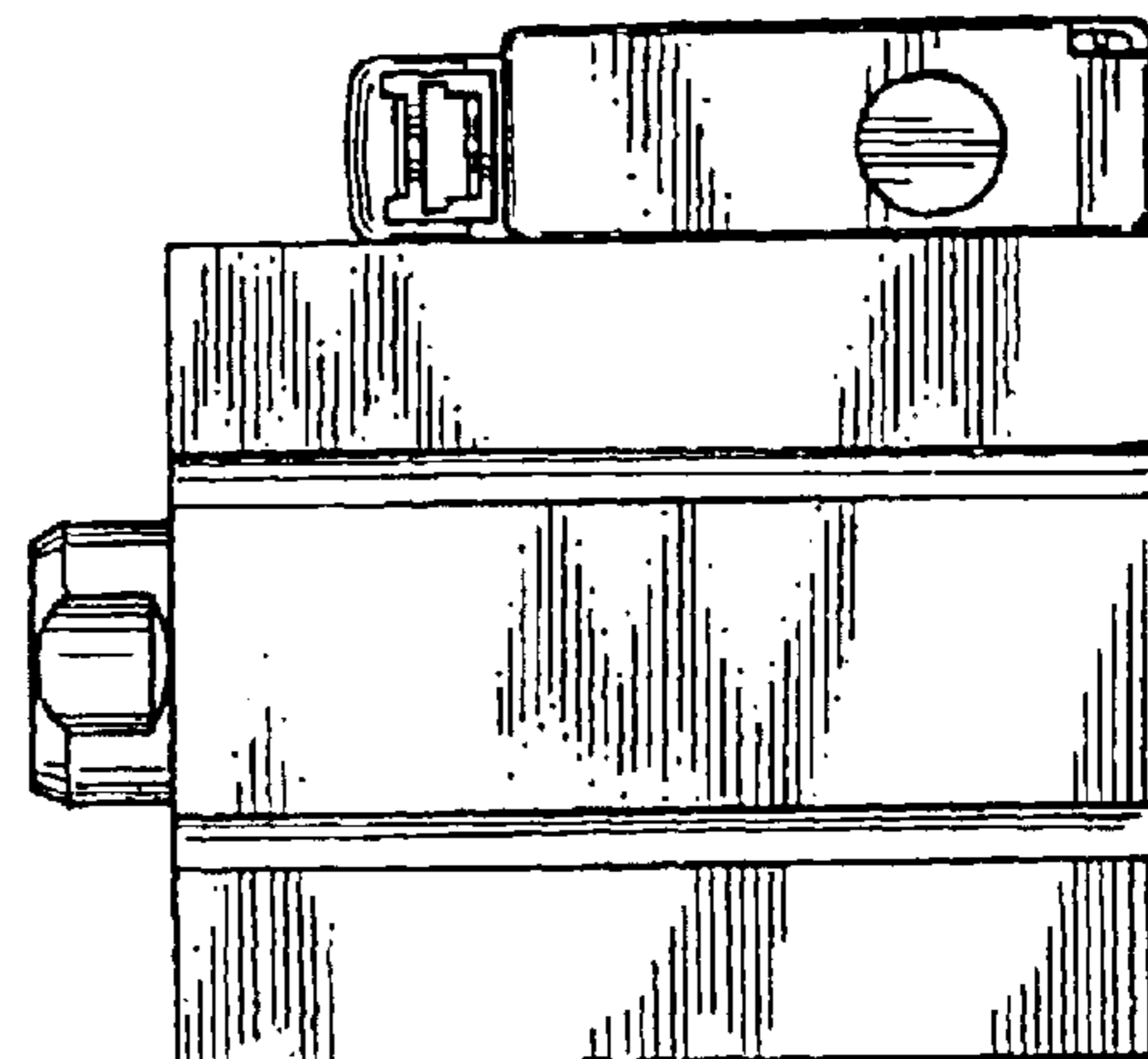

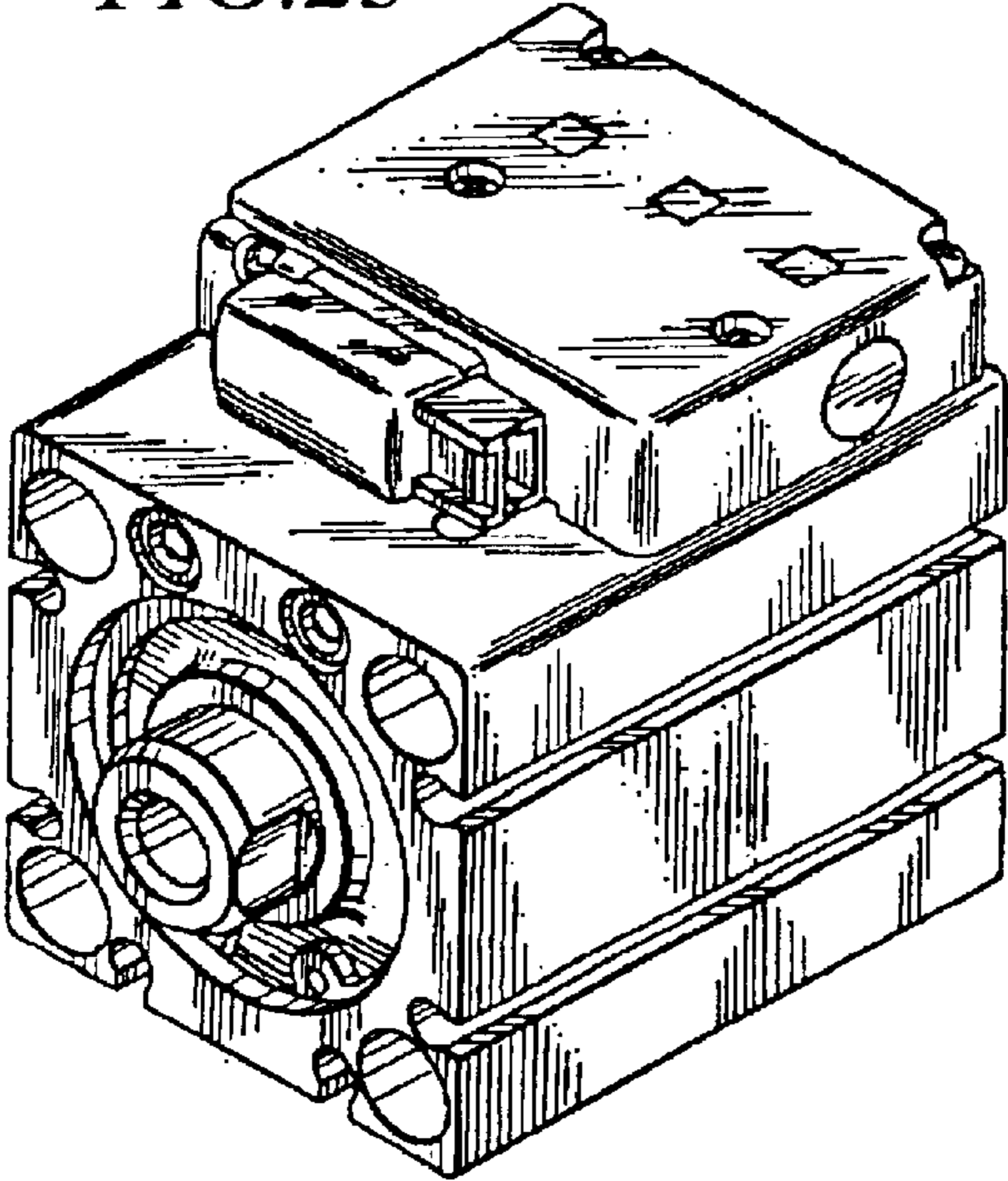
