DESCRIPTION

FIG. 1 is a front orthographic view of an ornamental design of a communication device showing our new design.

FIG. 4 is a right side orthographic view thereof.

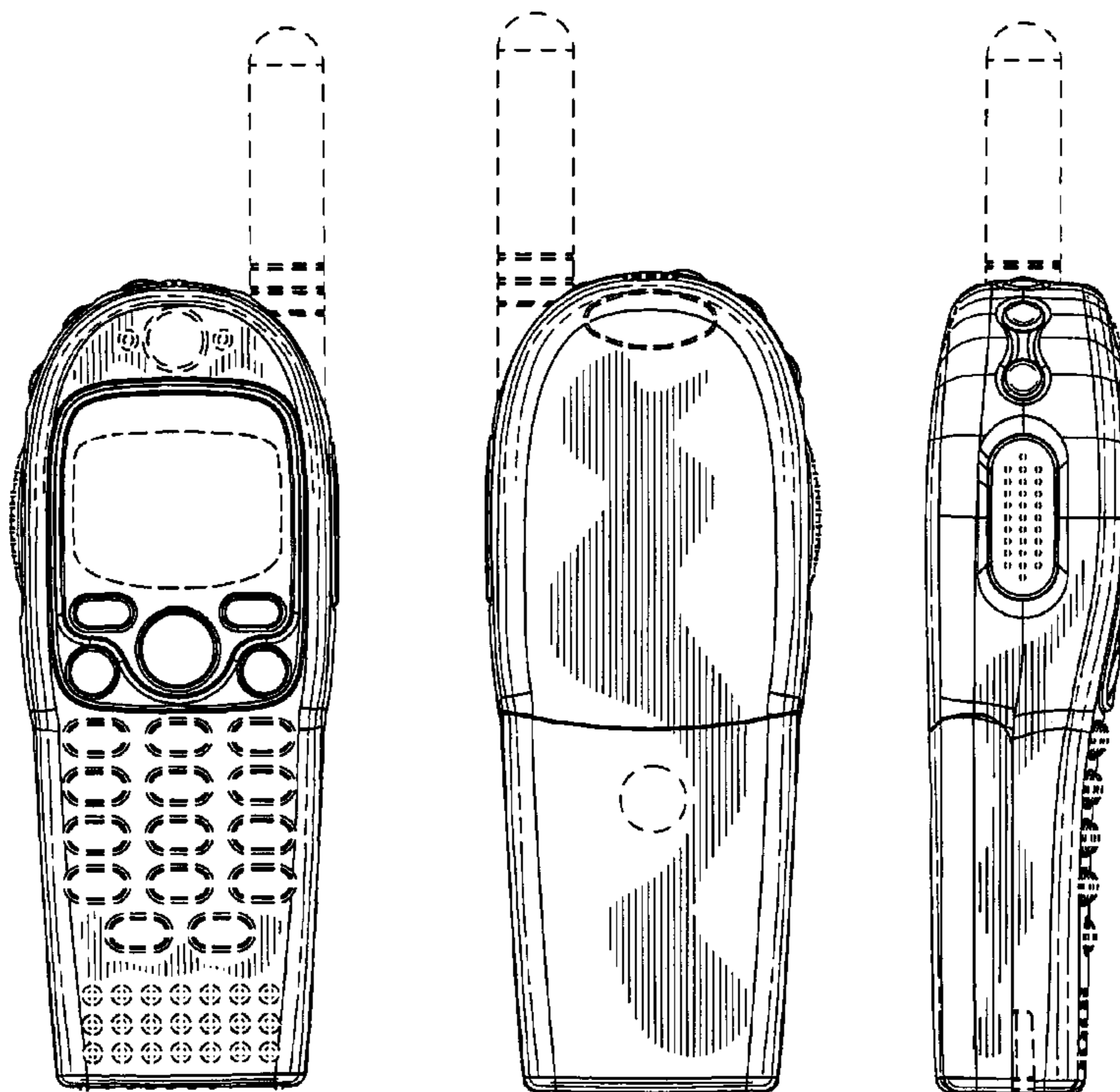
FIG. 5 is a top orthographic view thereof.

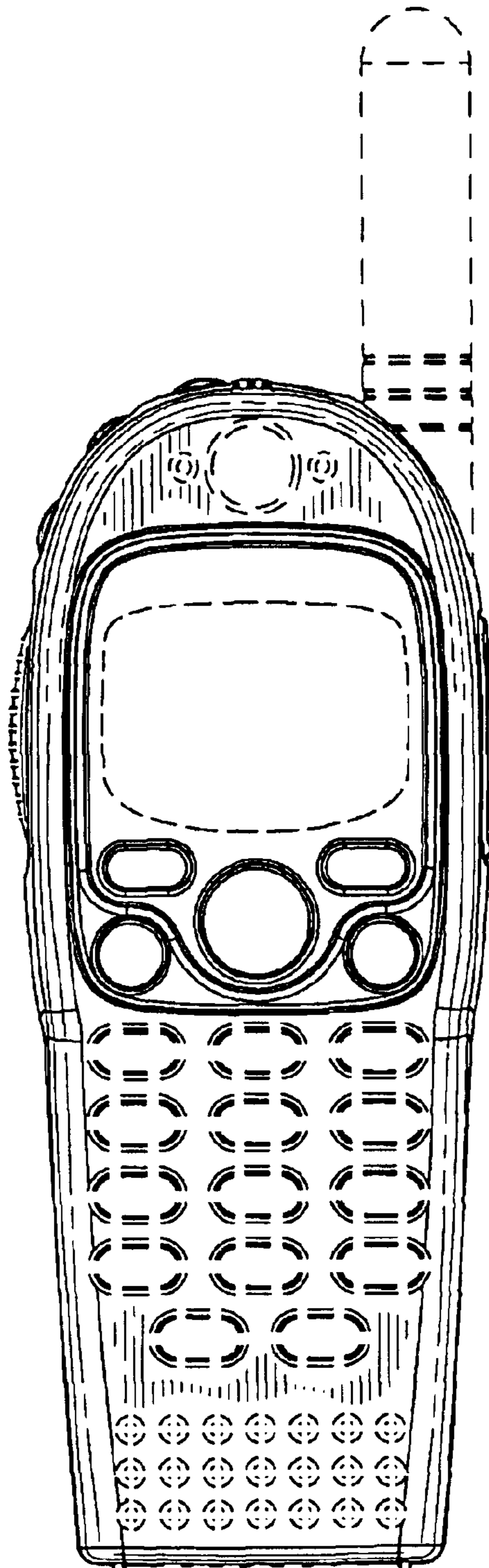

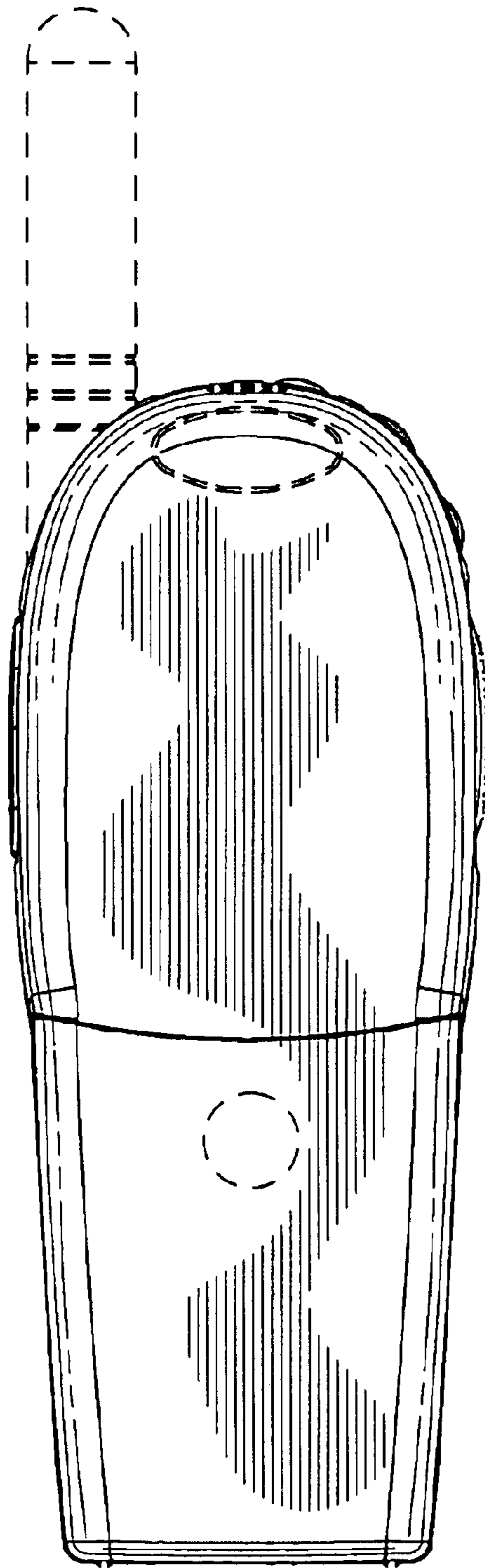

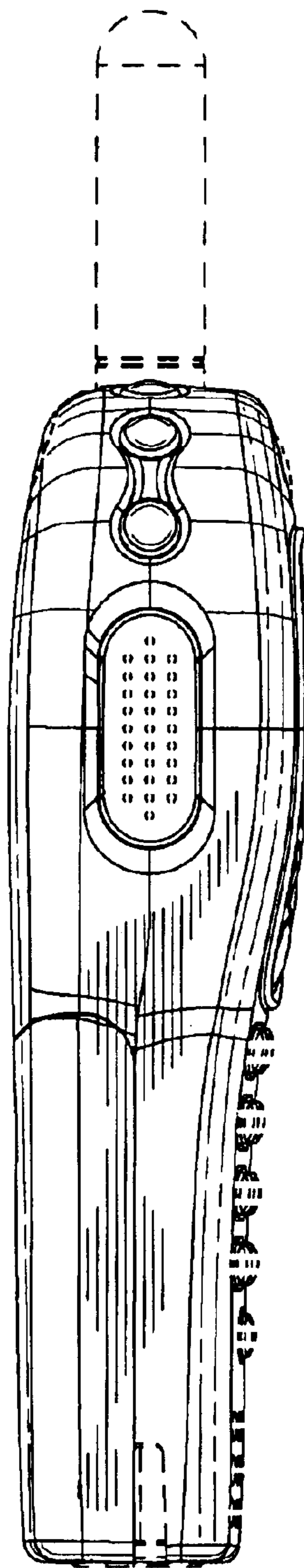

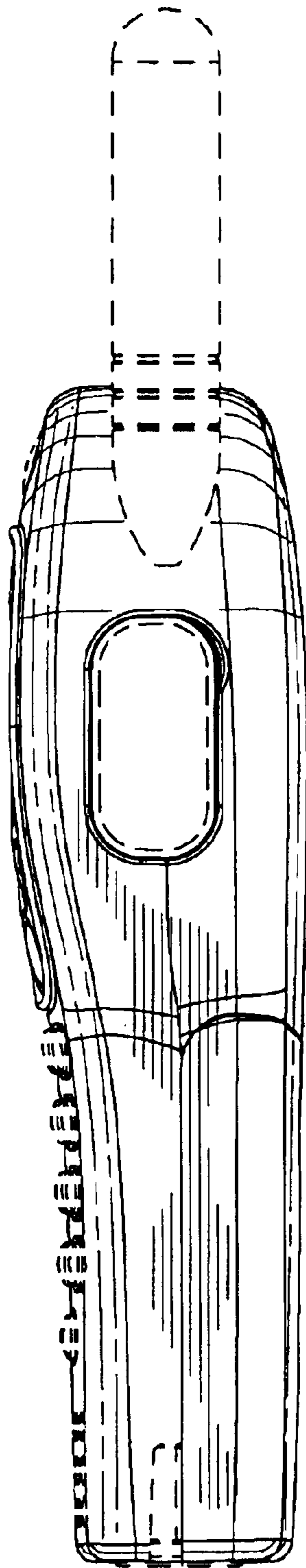

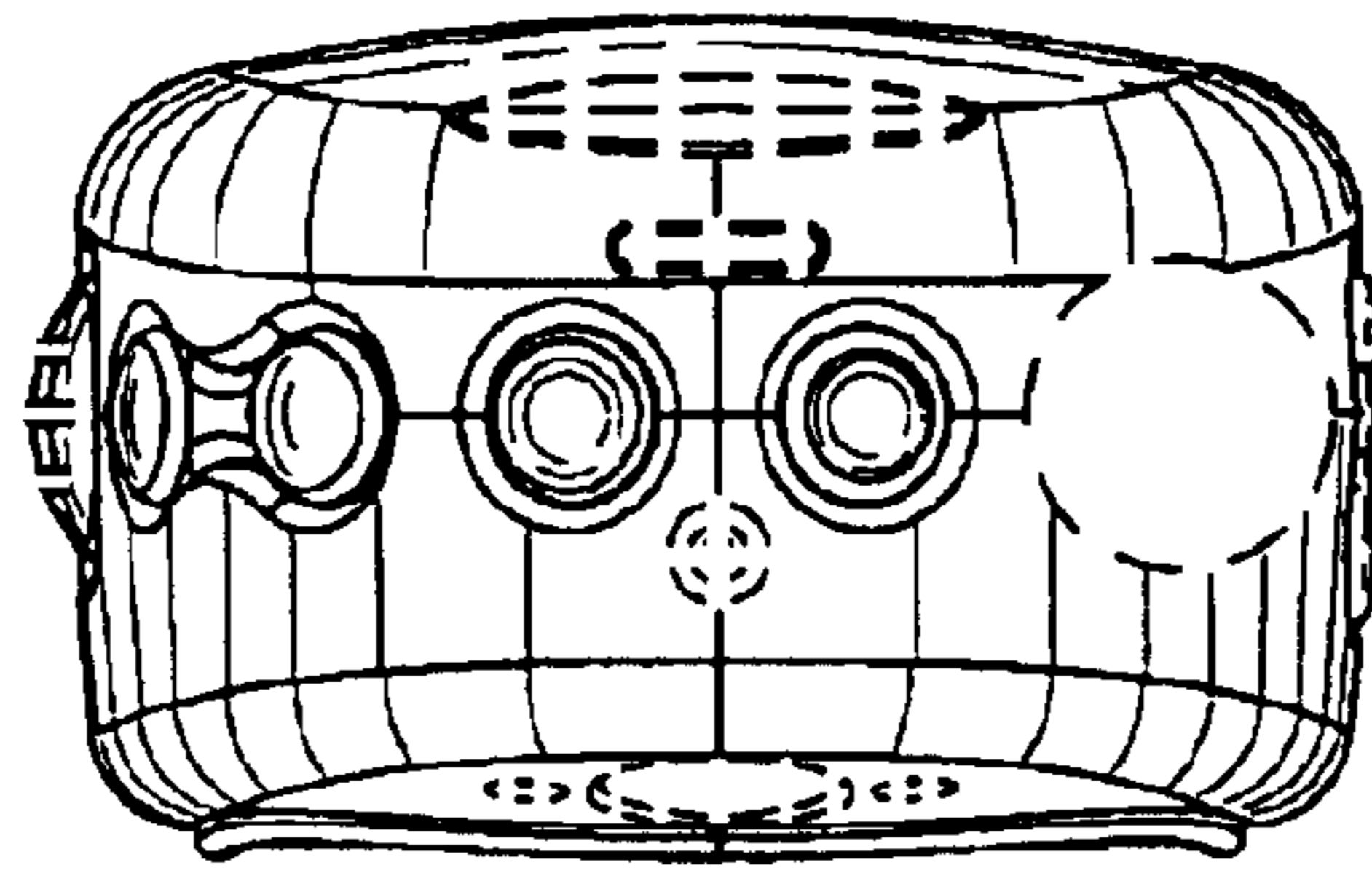

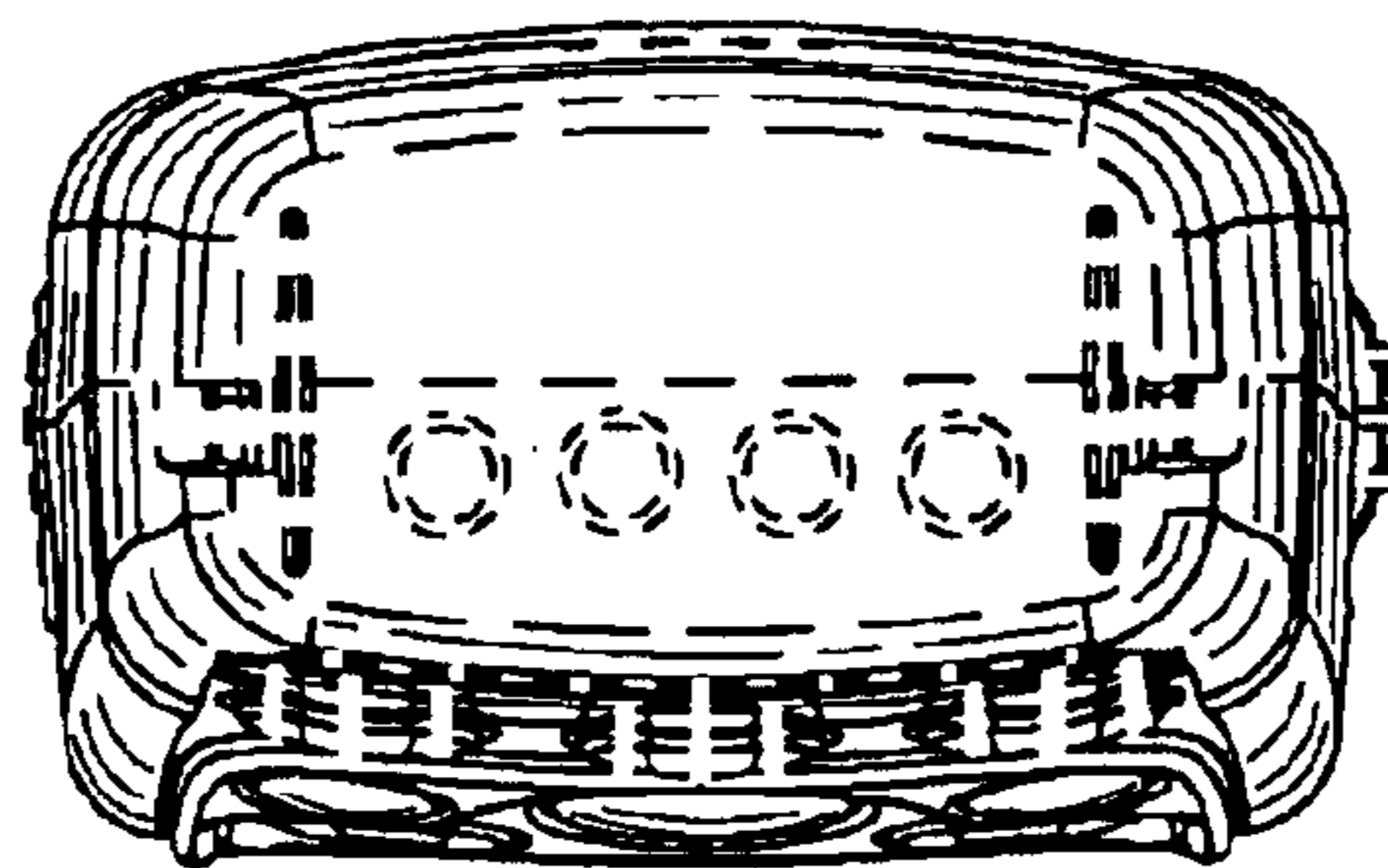

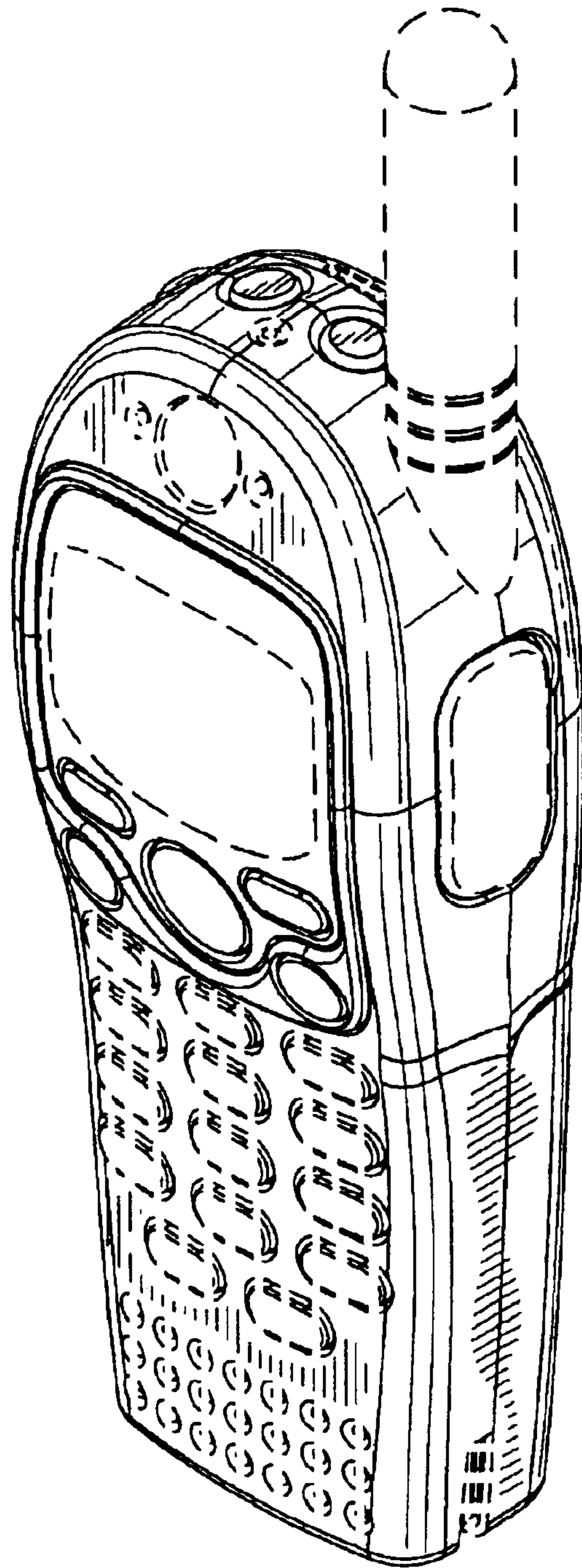
