(57) **CLAIM**

The ornamental design for a portable media player, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a portable media player in accordance with the present design;

FIG. 3 is a back view of the portable media player shown in FIG. 1;

FIG. 4 is a top view of the portable media player shown in FIG. 1;

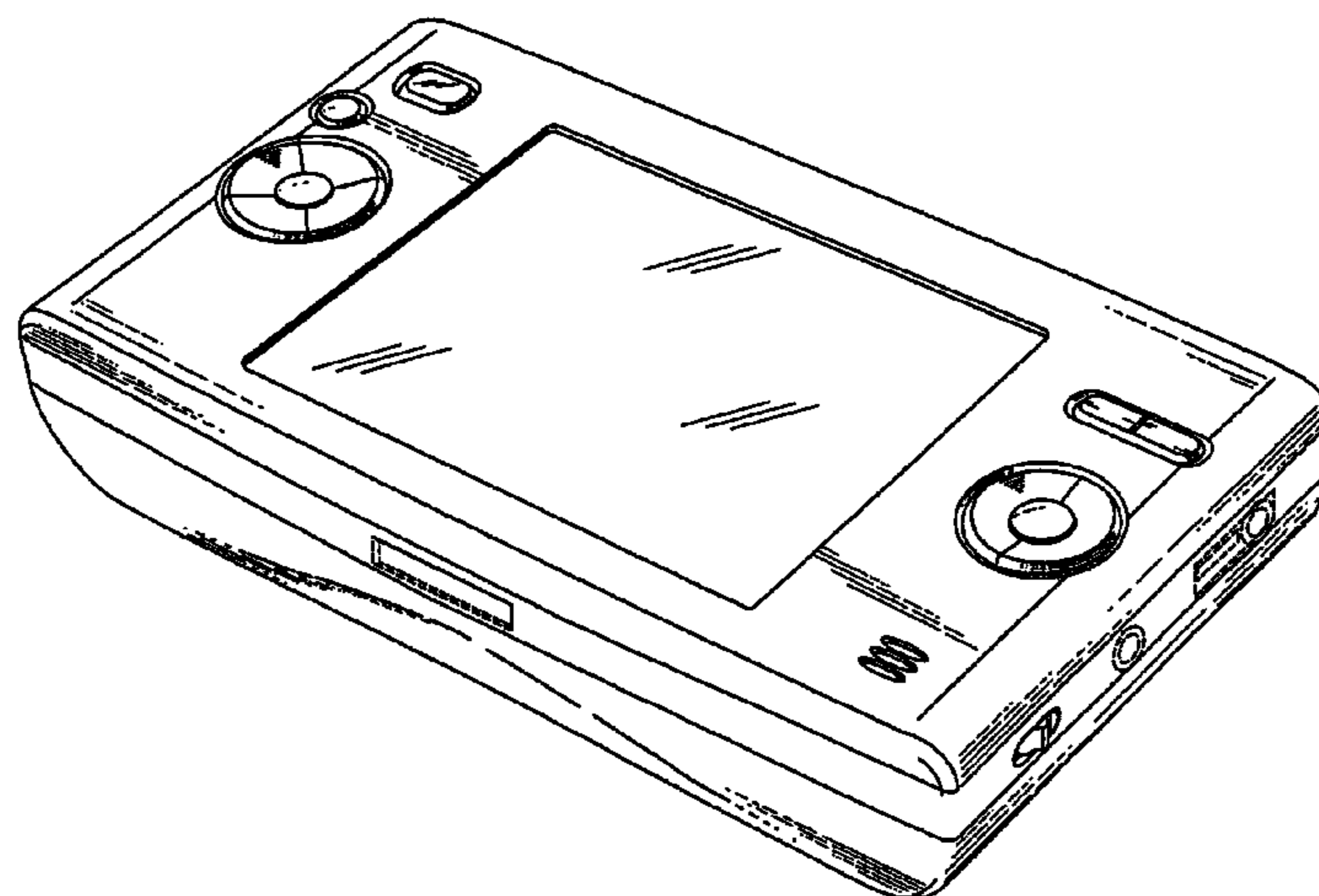
FIG. 5 is a bottom view of the portable media player shown in FIG. 1;

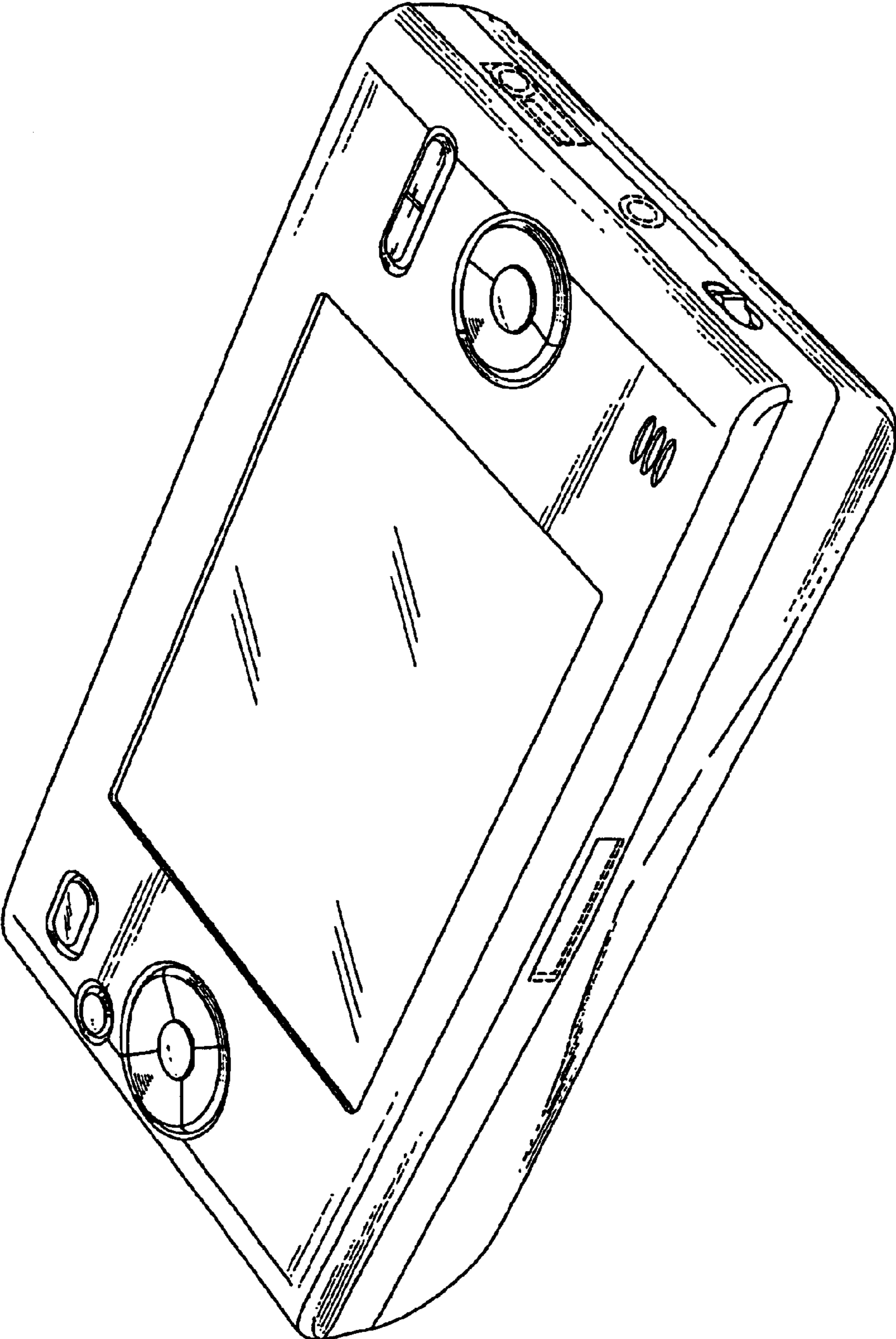

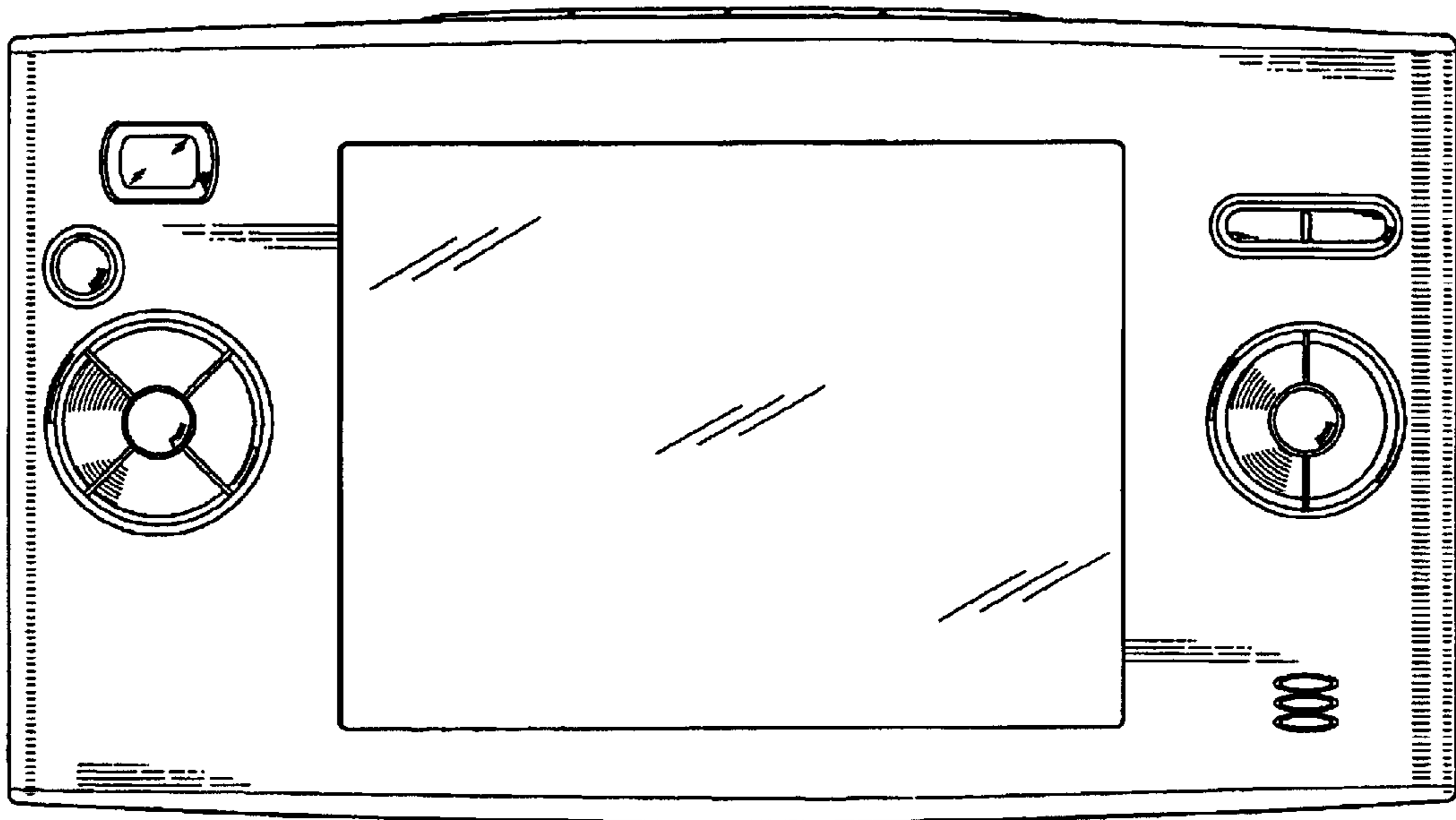

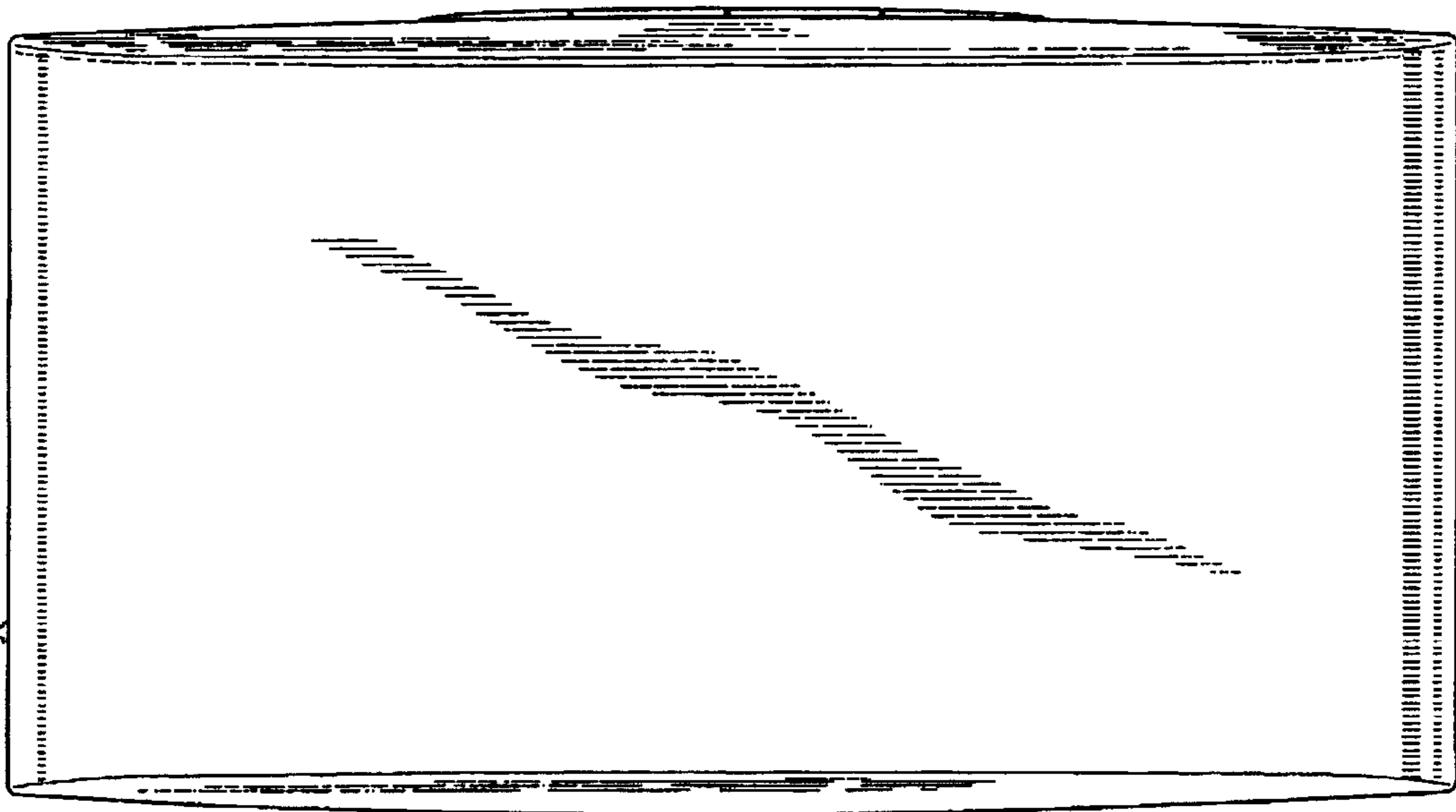

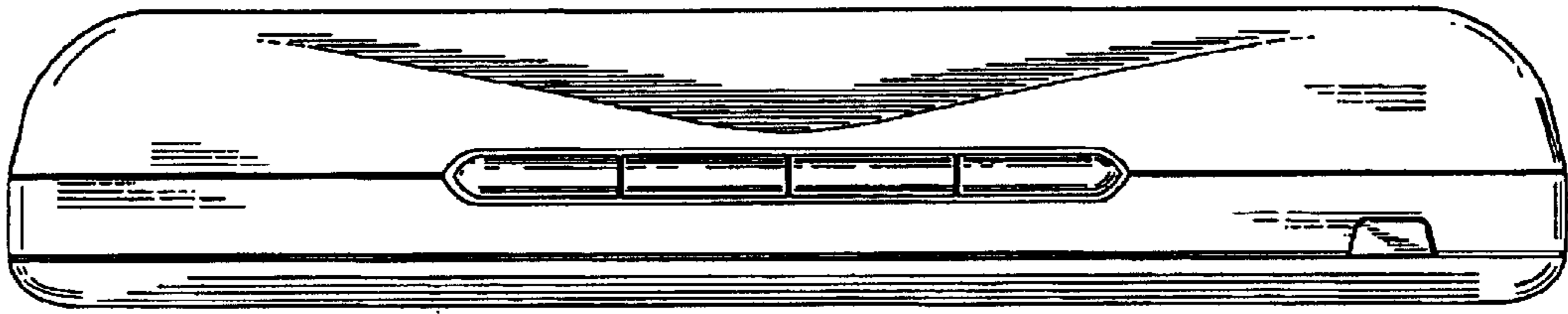

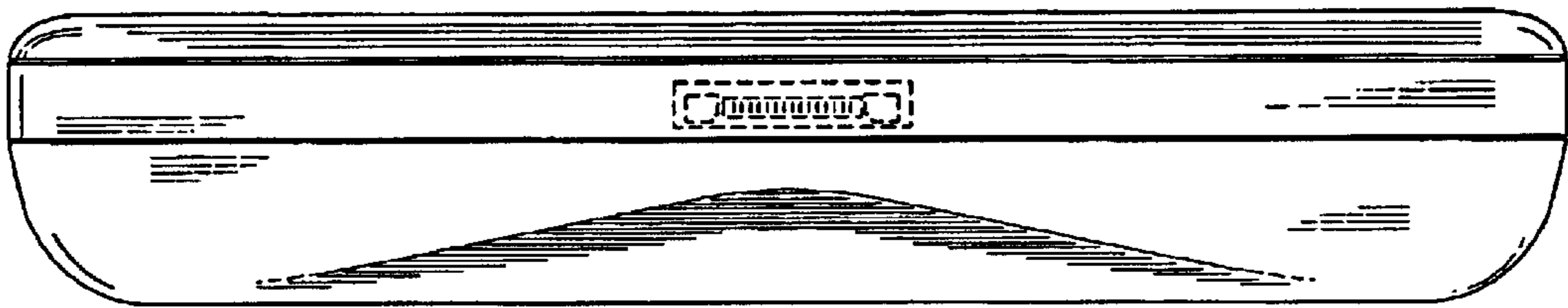

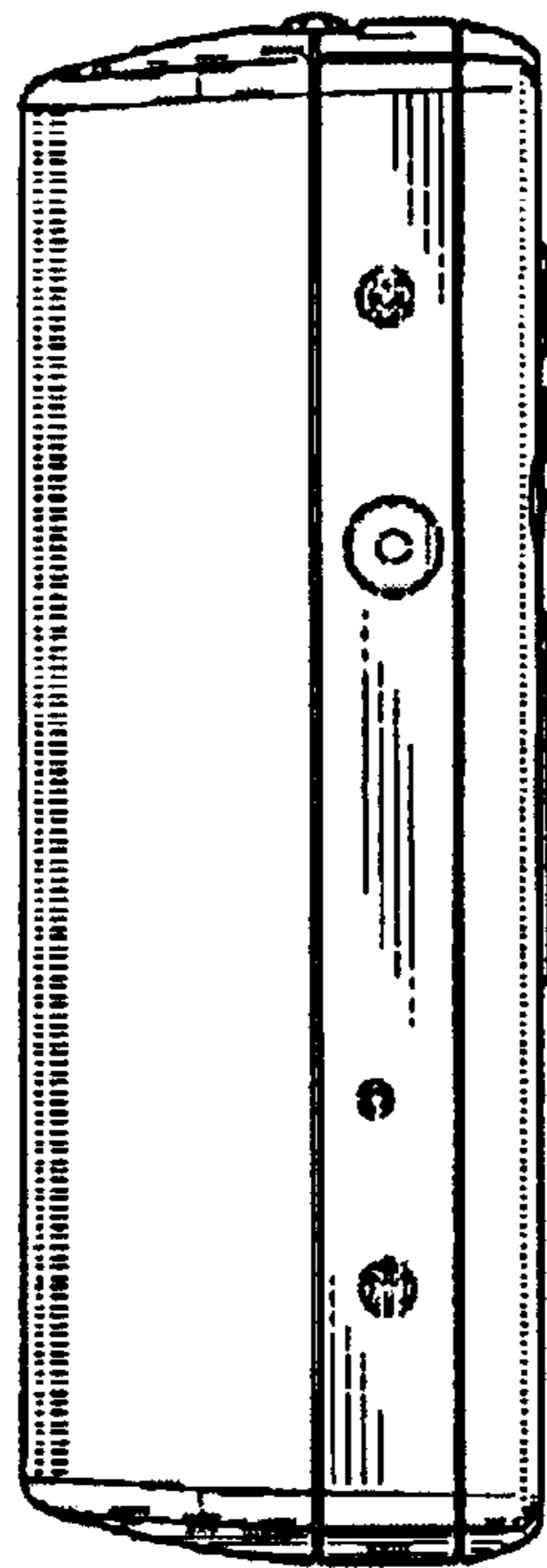

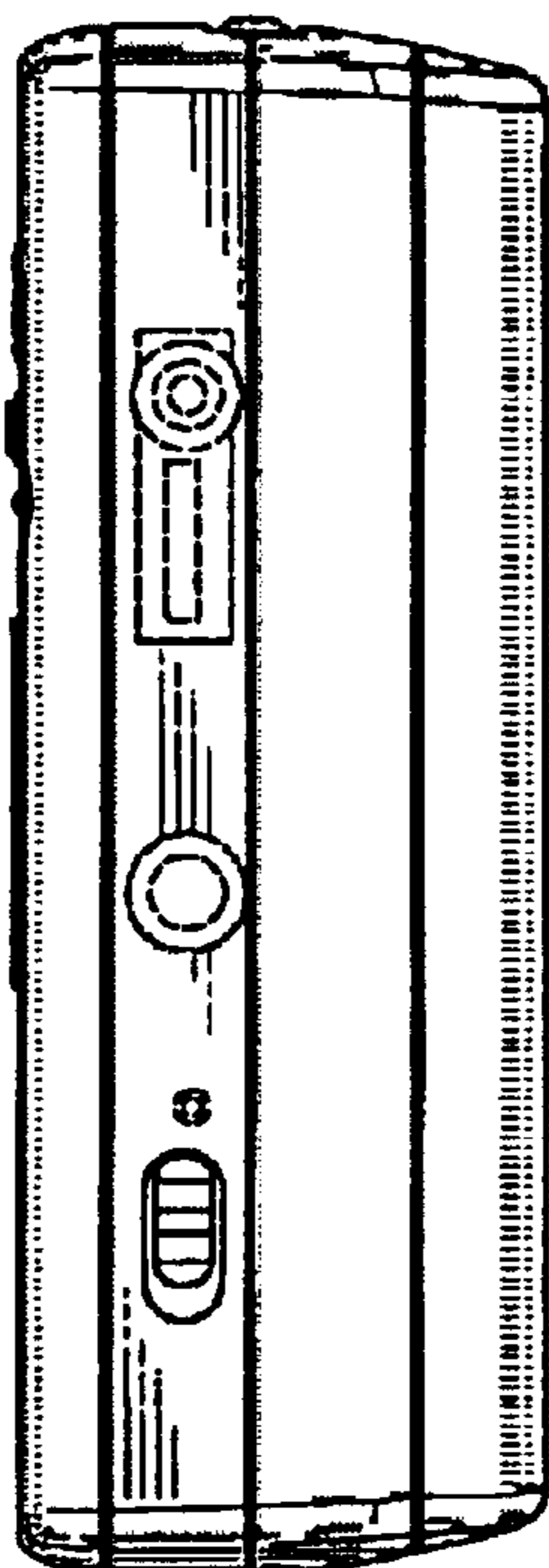
