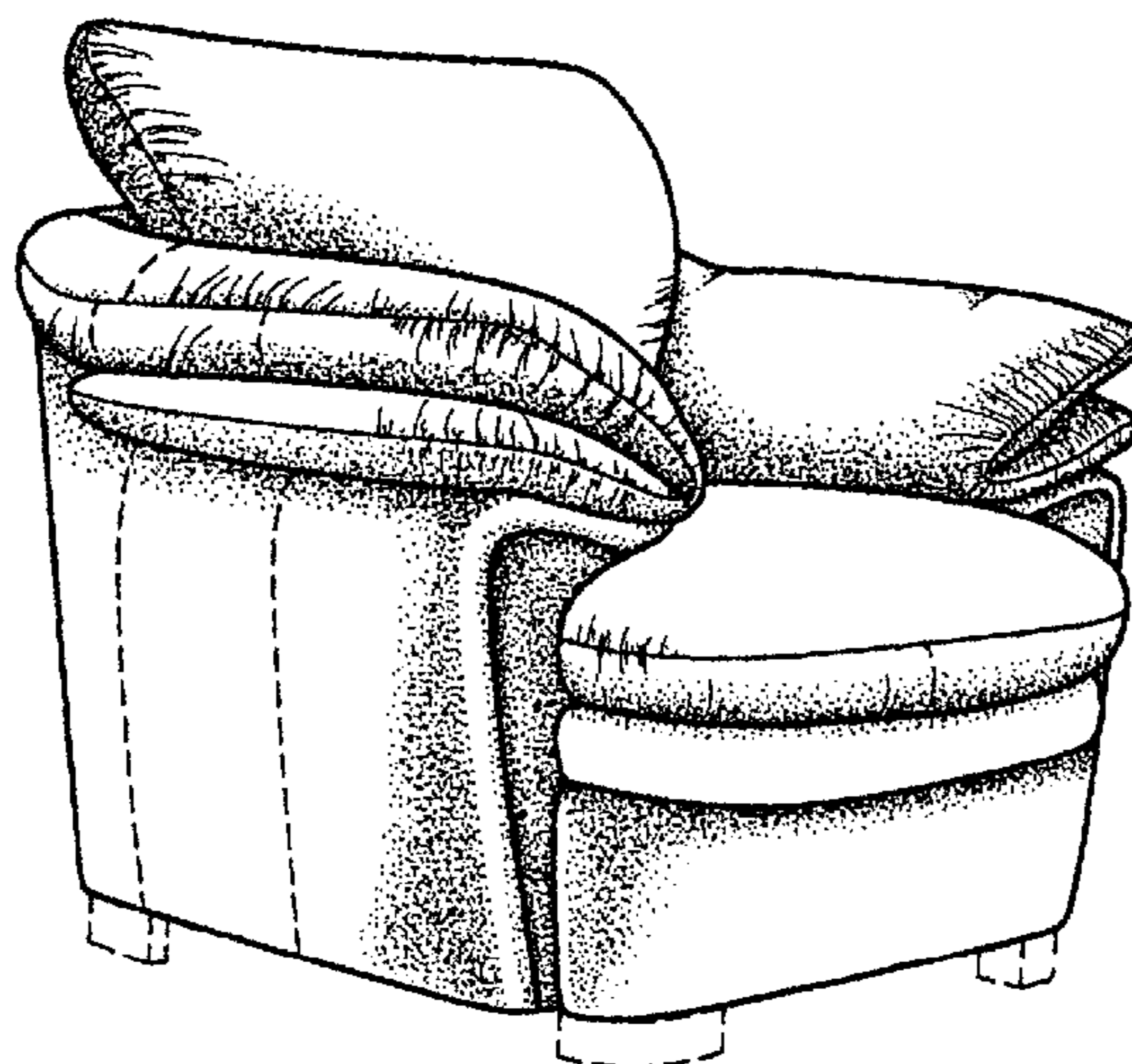
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of one embodiment of my new chair design;
FIG. 2 is a front elevation view of the embodiment of FIG. 1;
FIG. 3 is a left, side elevation view of the embodiment of FIG. 1, with the right side elevational view being a mirror image thereof; and,
FIG. 4 is a rear elevation view of the embodiment of FIG. 1.

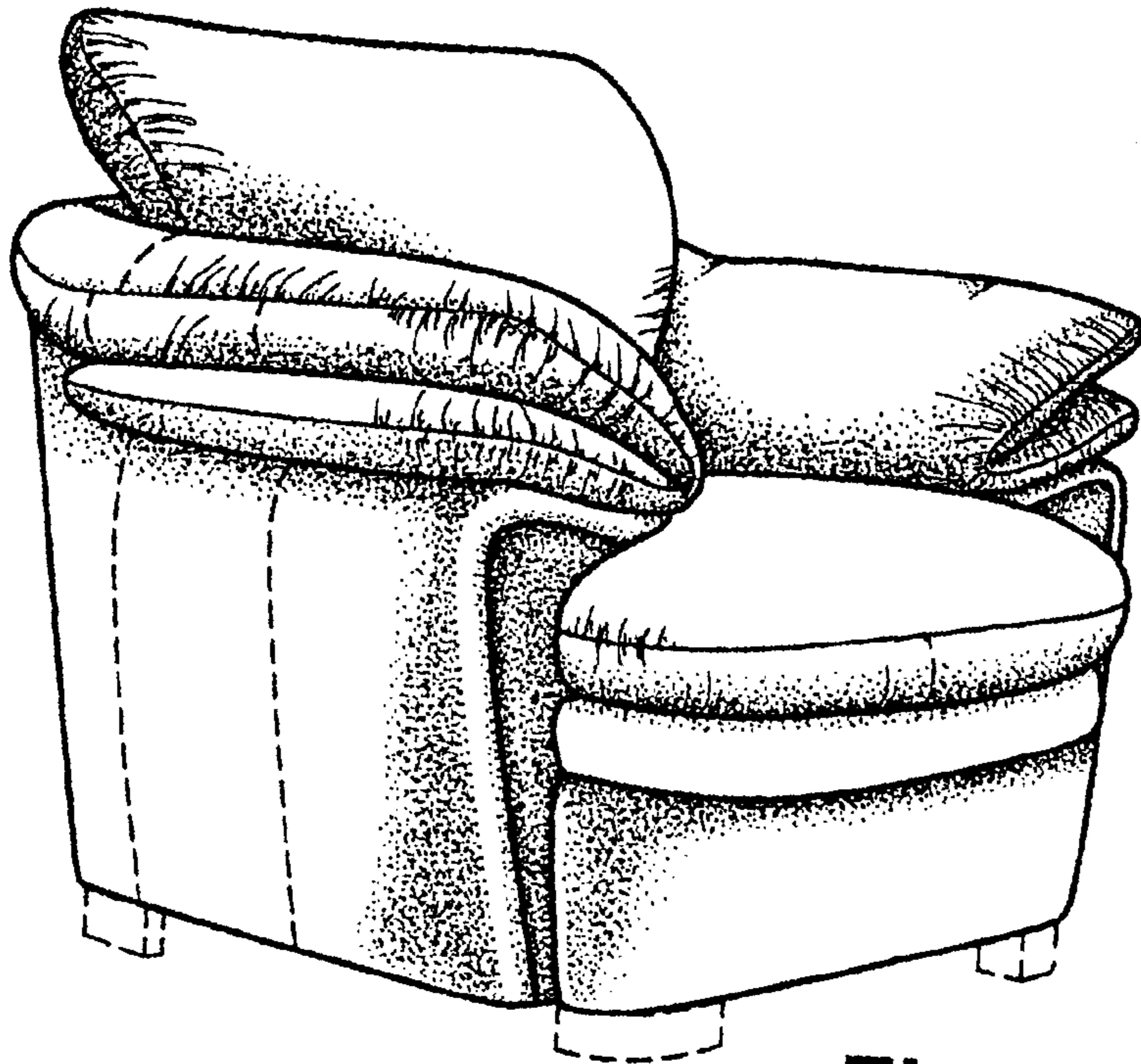

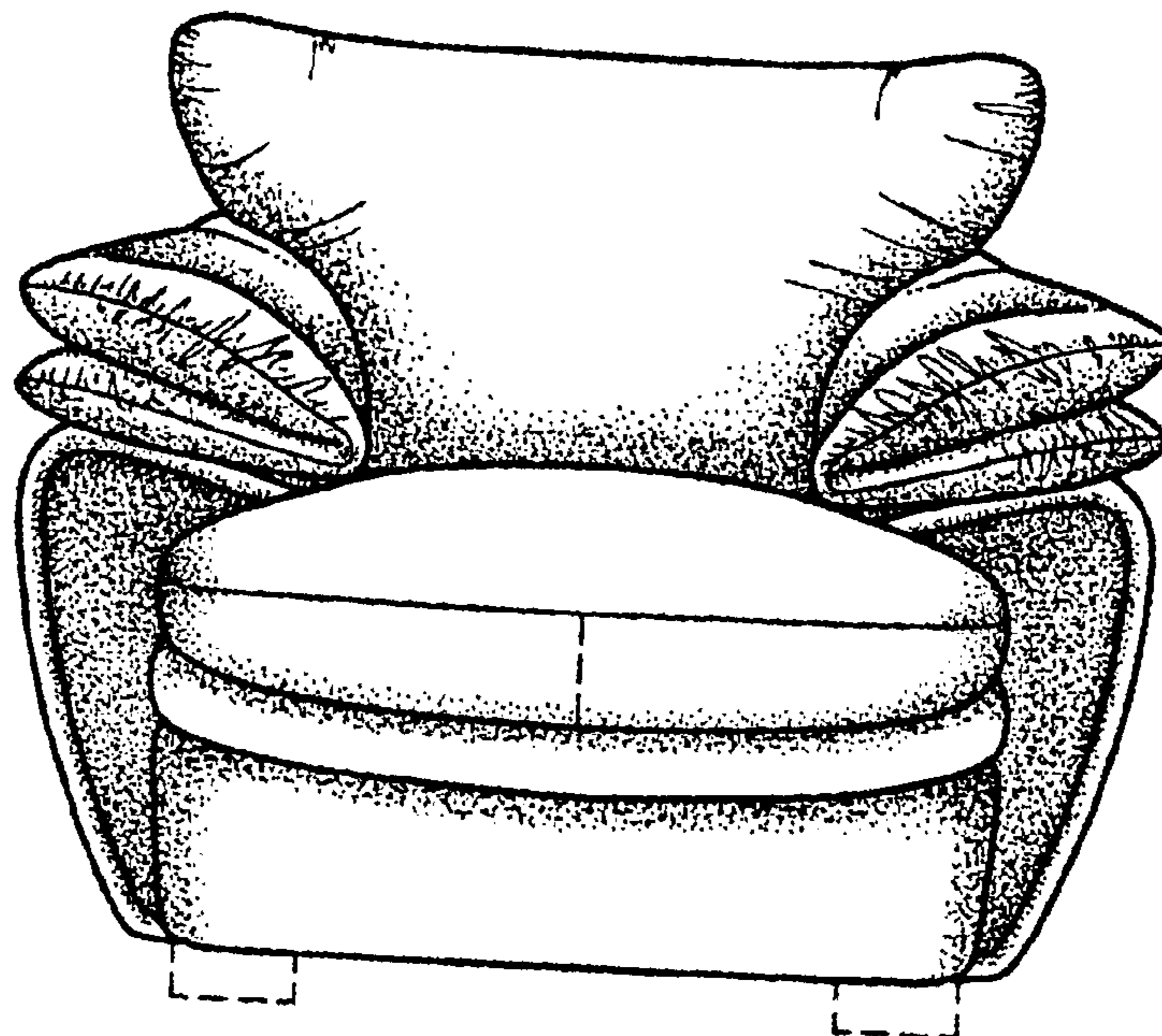

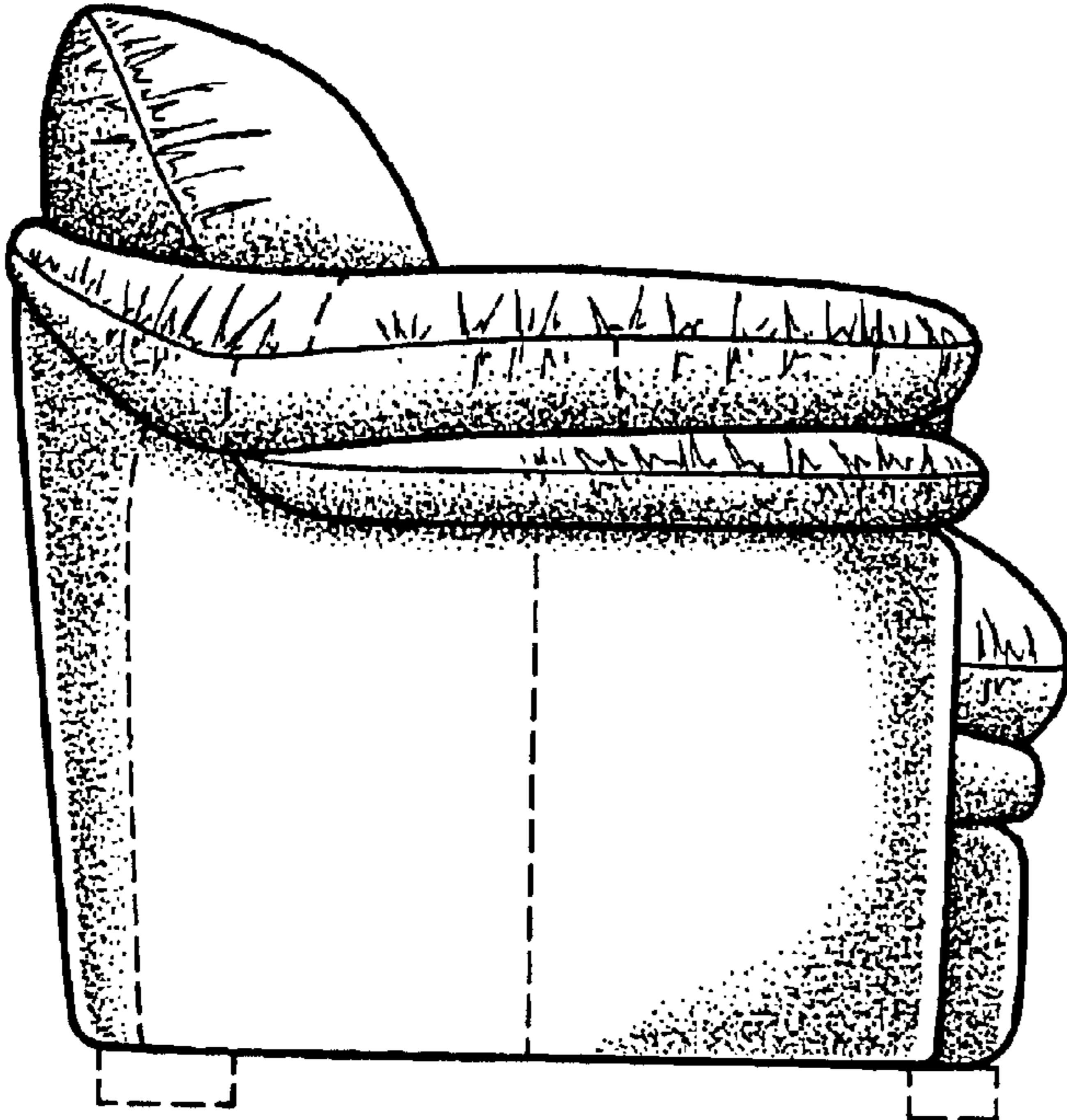

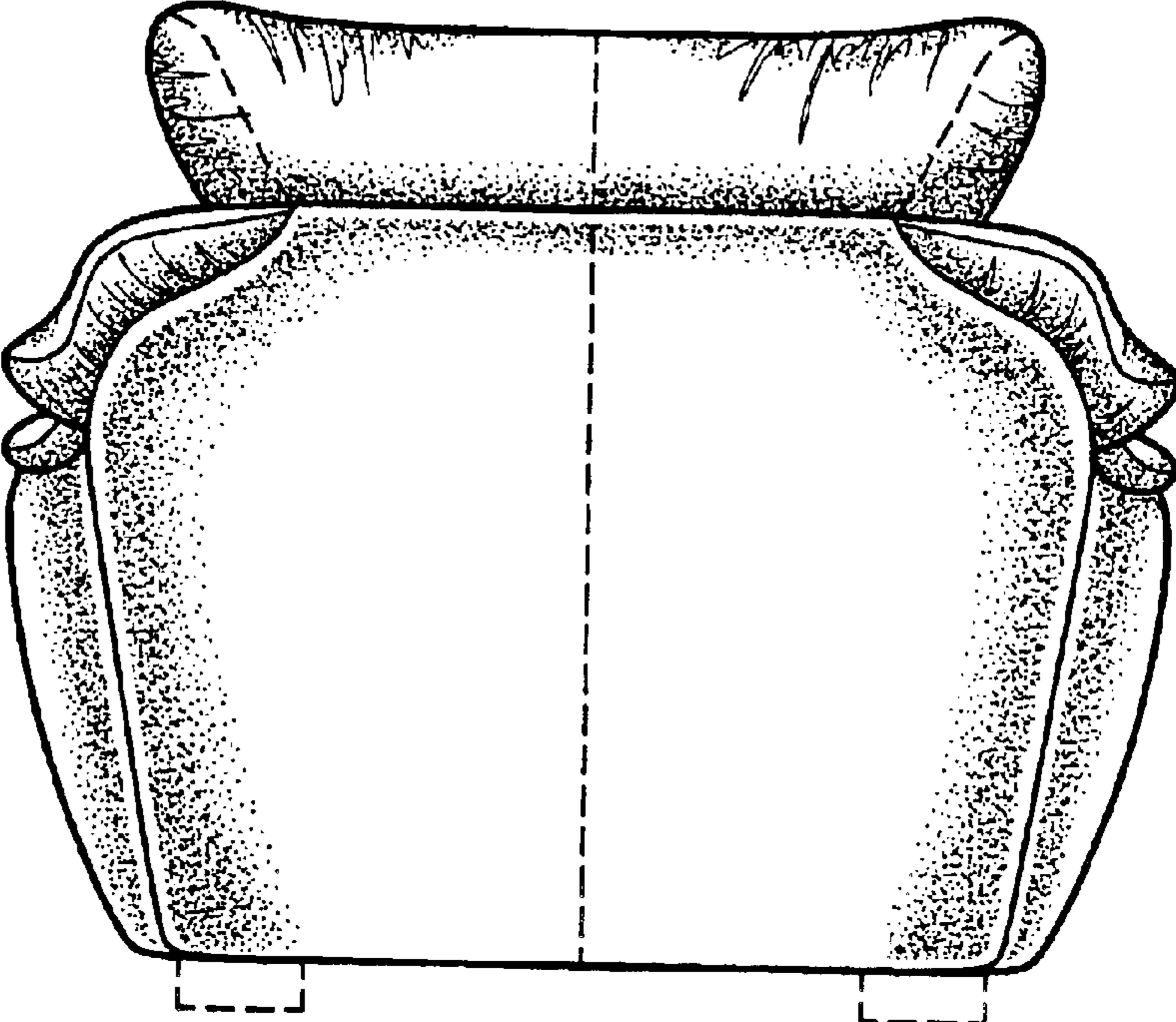
