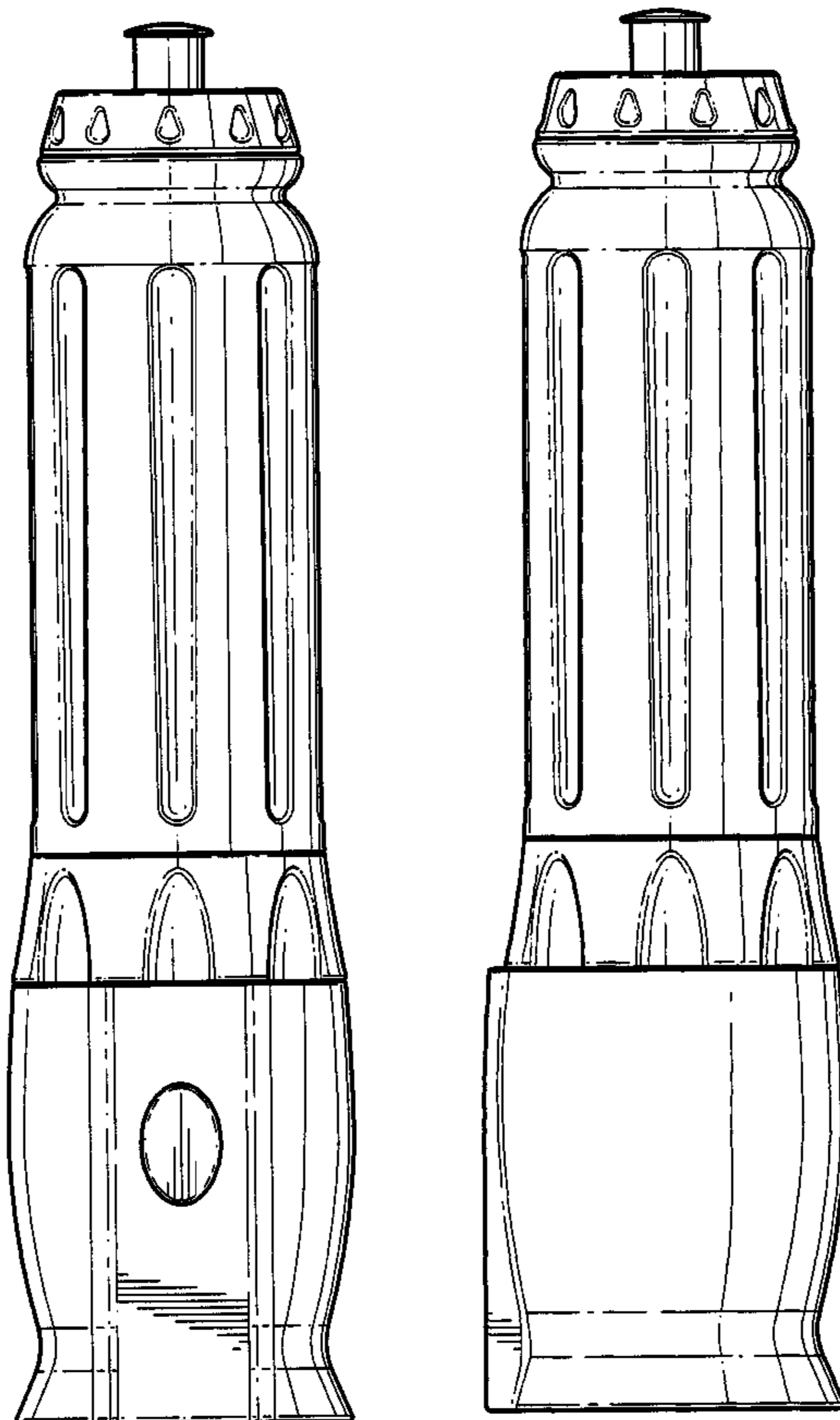
(57) **CLAIM**

The ornamental design for a sport bottle blender, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a sport bottle blender showing my new design;  
 FIG. 2 is a rear elevational view thereof;  
 FIG. 3 is a side elevational view thereof;  
 FIG. 4 is a top plan view thereof;  
 FIG. 5 is a bottom plan view thereof;  
 FIG. 6 is a side elevational view of the sport bottle shown separately for ease of illustration;  
 FIG. 7 is a top plan view of the sport bottle of FIG. 6; and,  
 FIG. 8 is a bottom plan view of the sport bottle of FIG. 6.

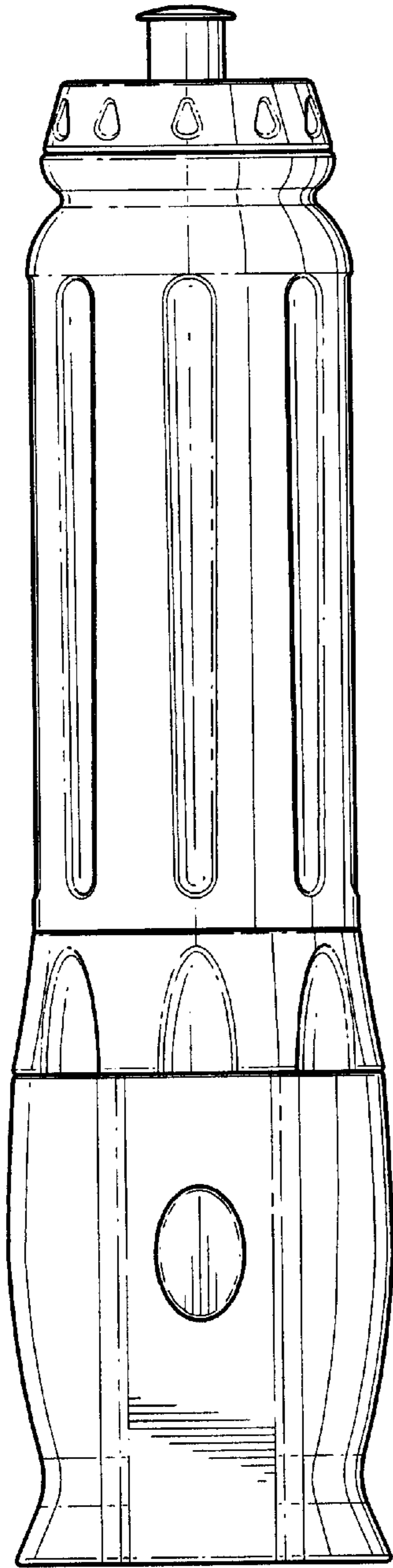

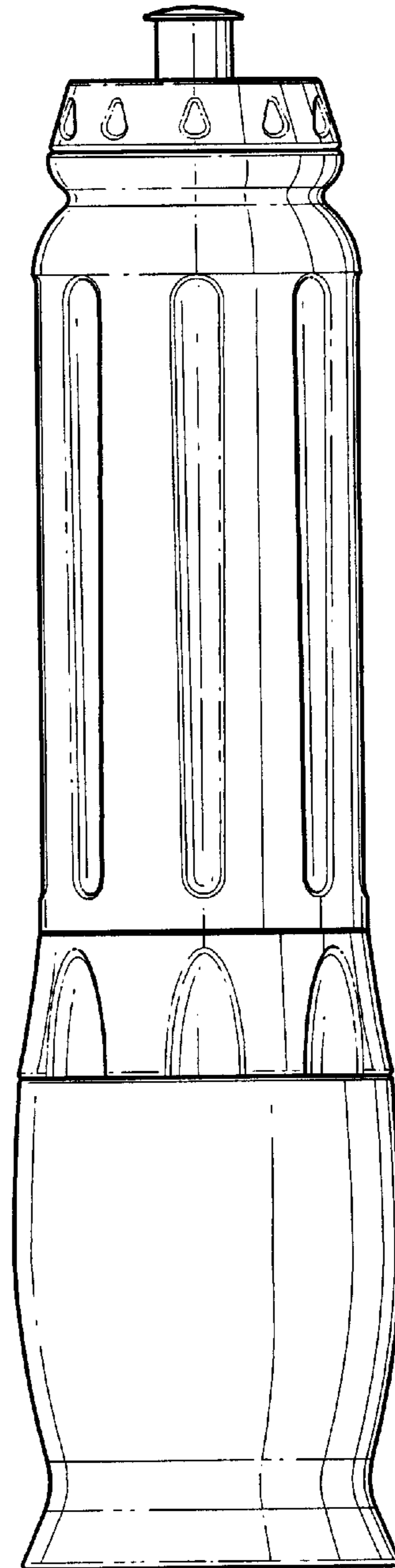

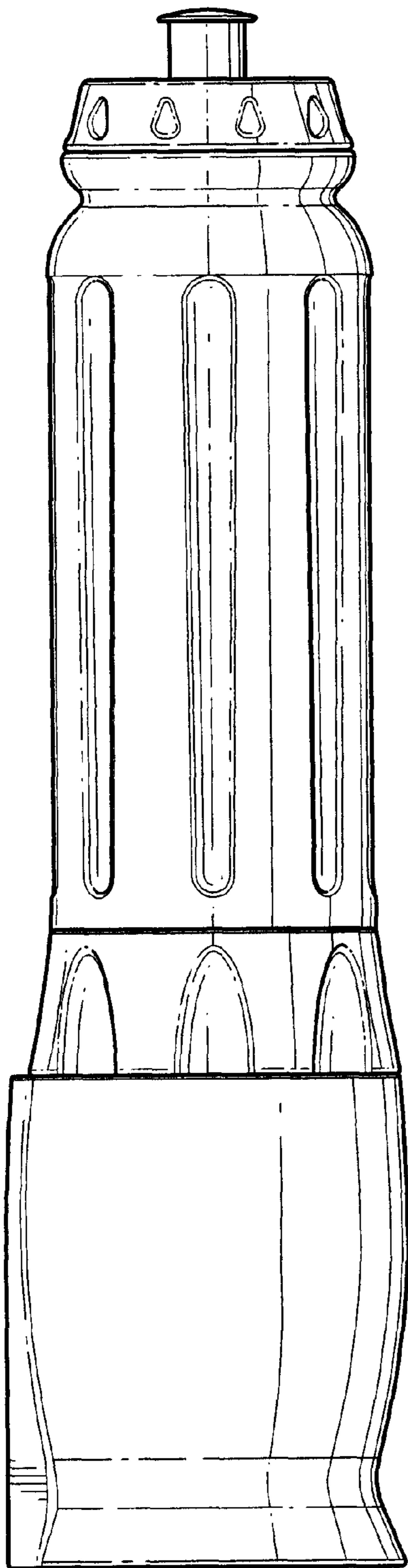

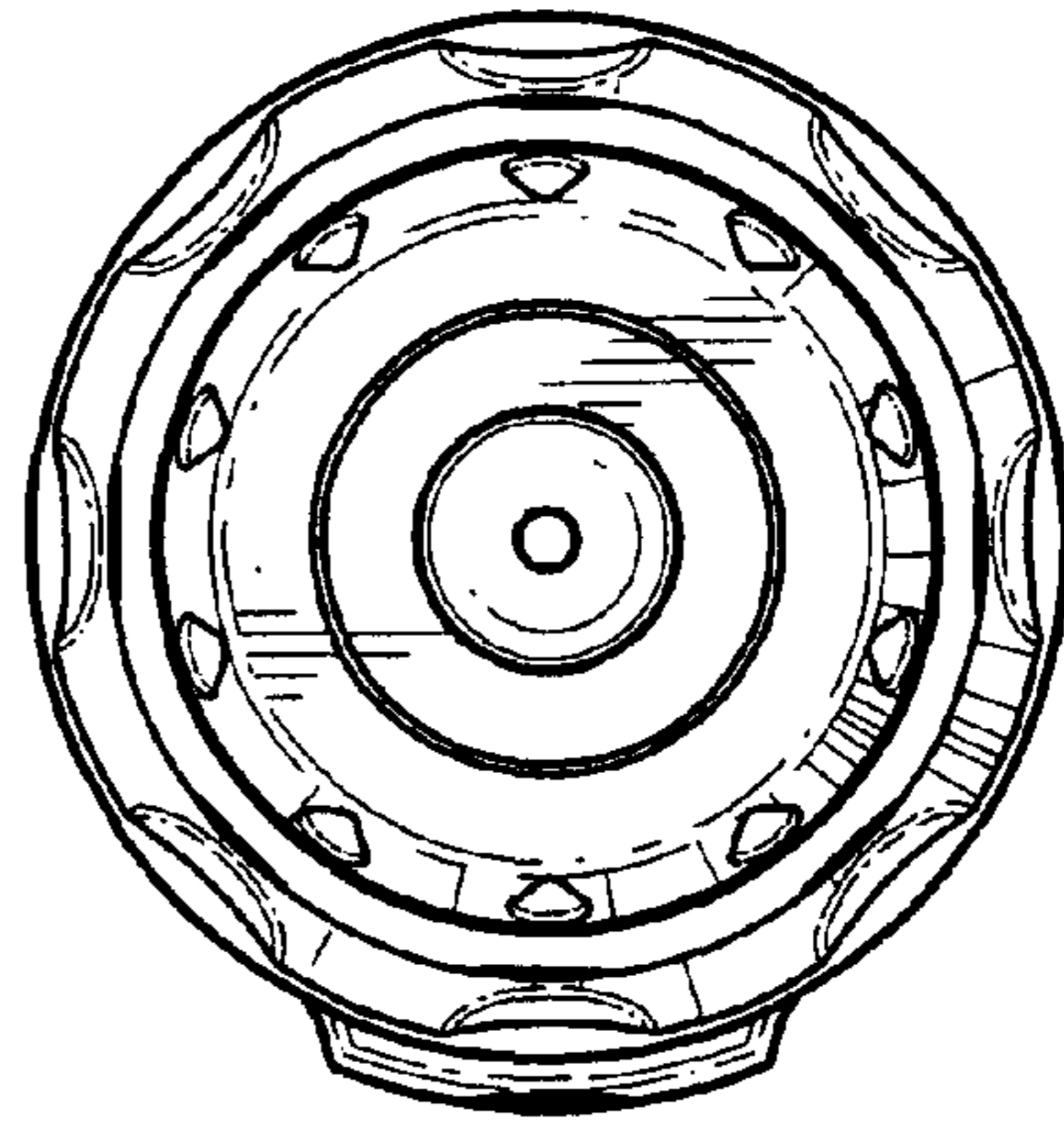

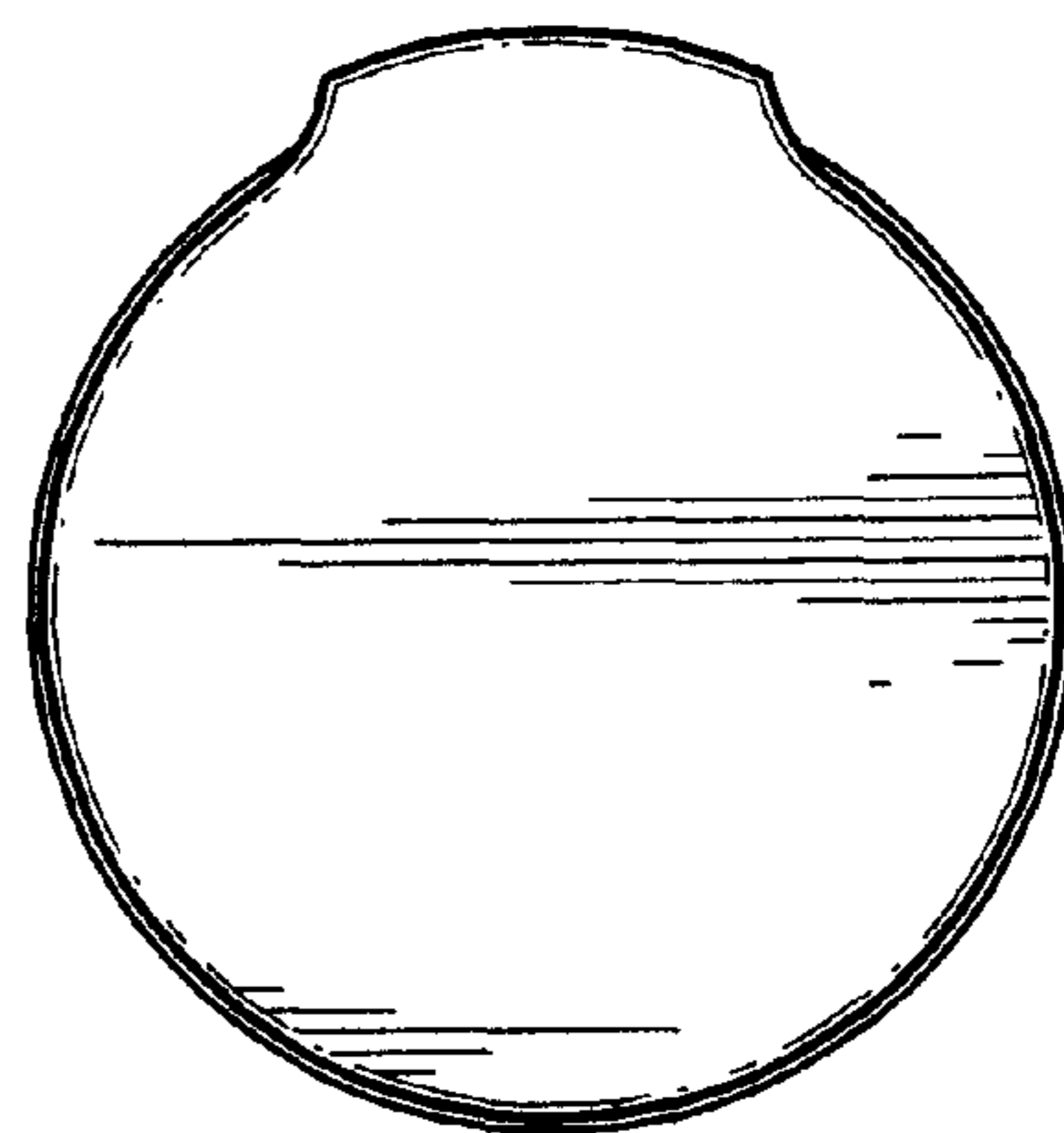

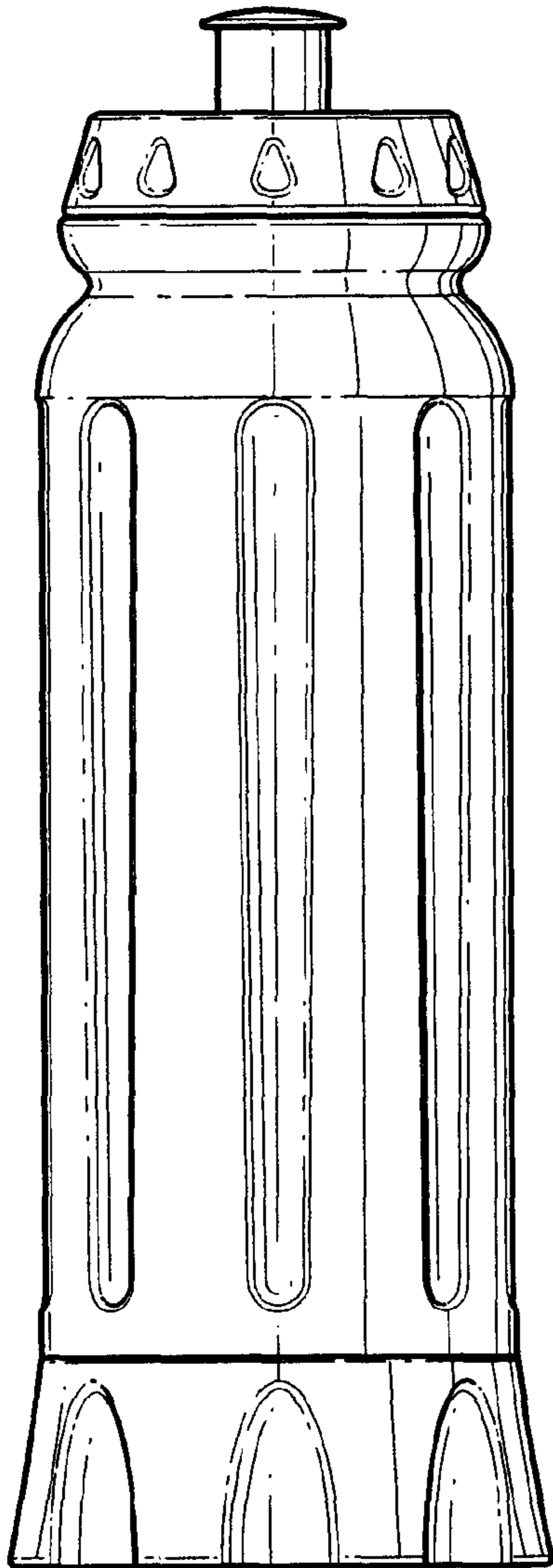

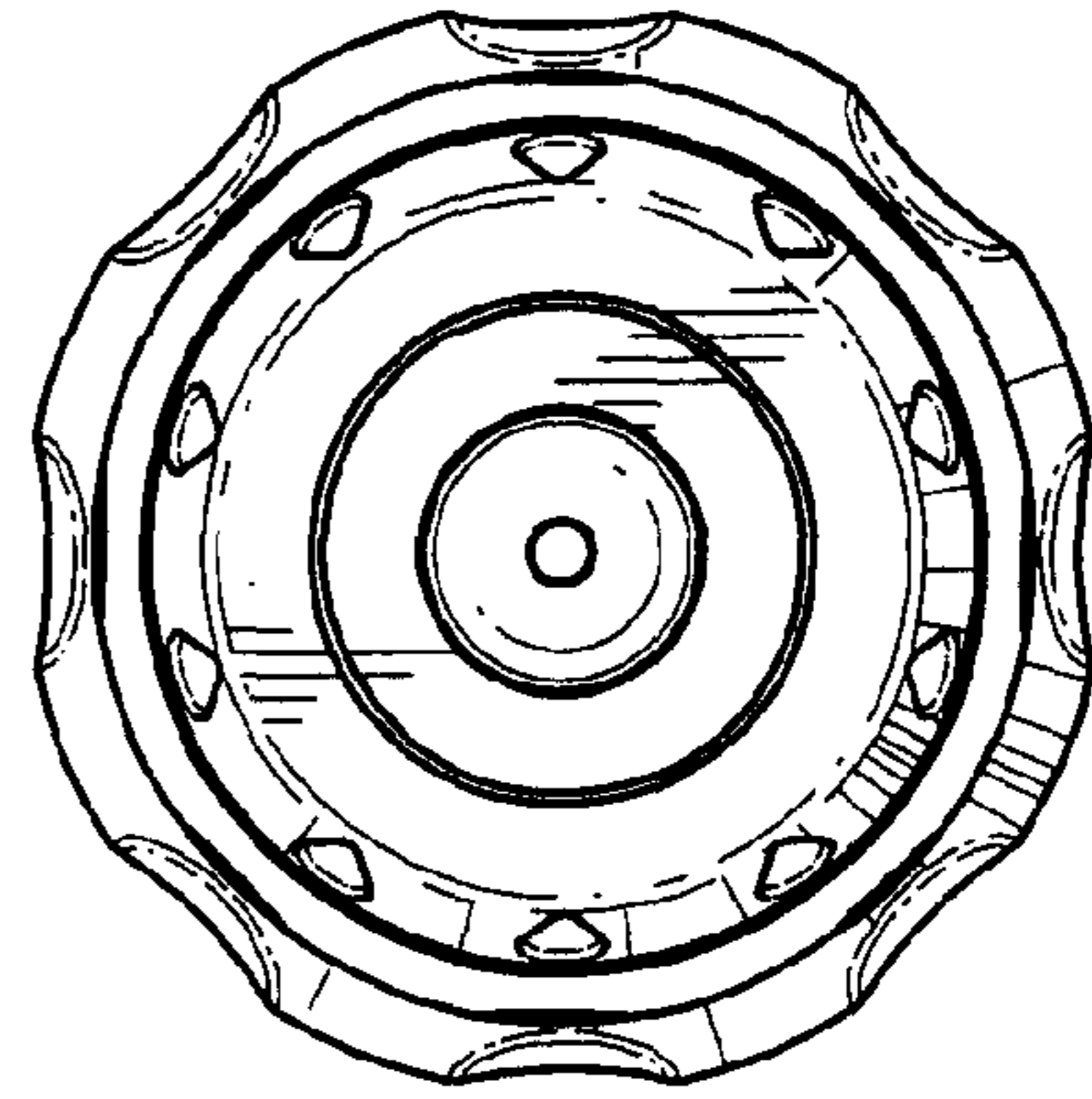

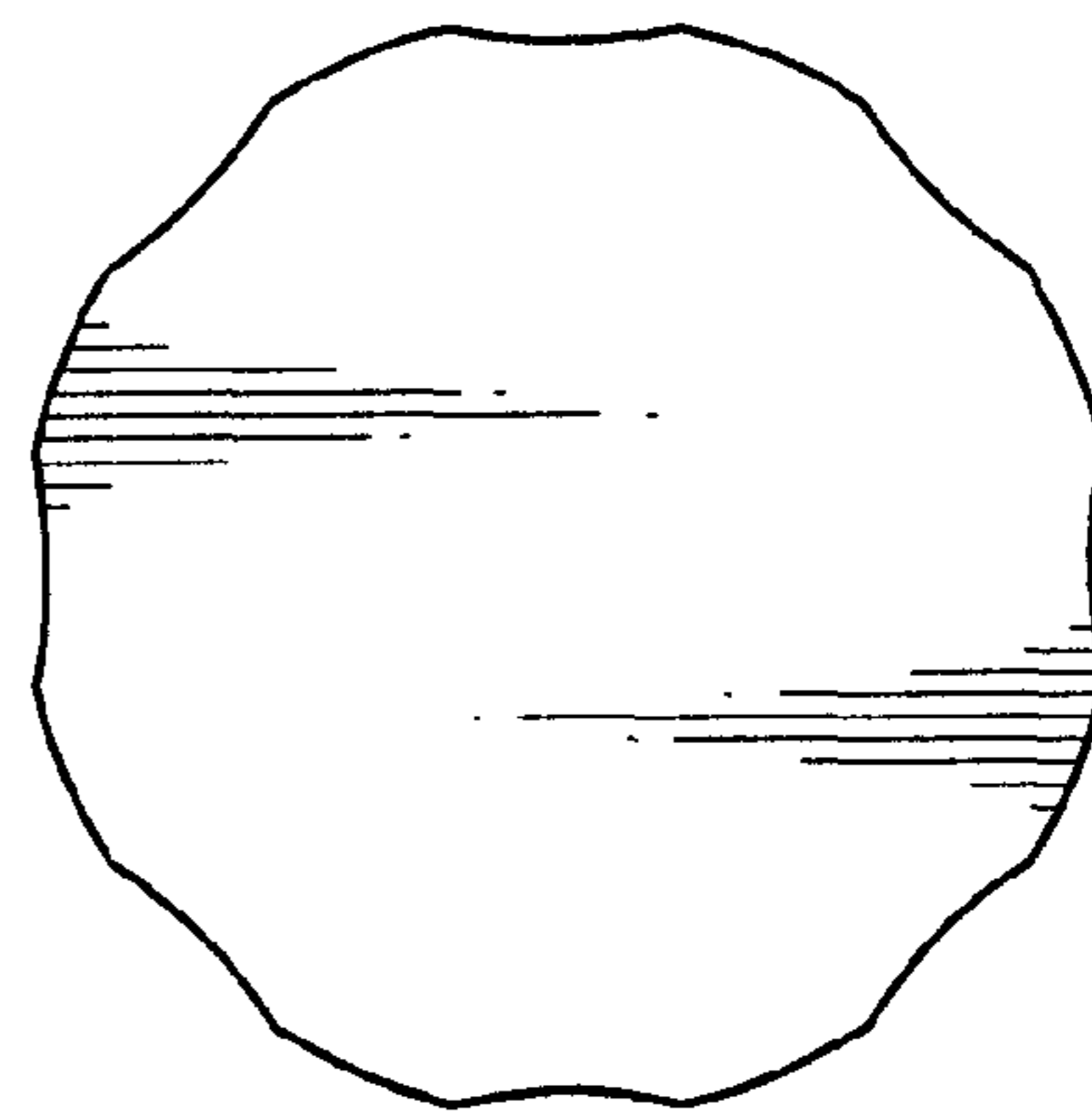
