FIG. 9 is a front and left side view of a deflated folded dunnage bag showing the front and left side; and,

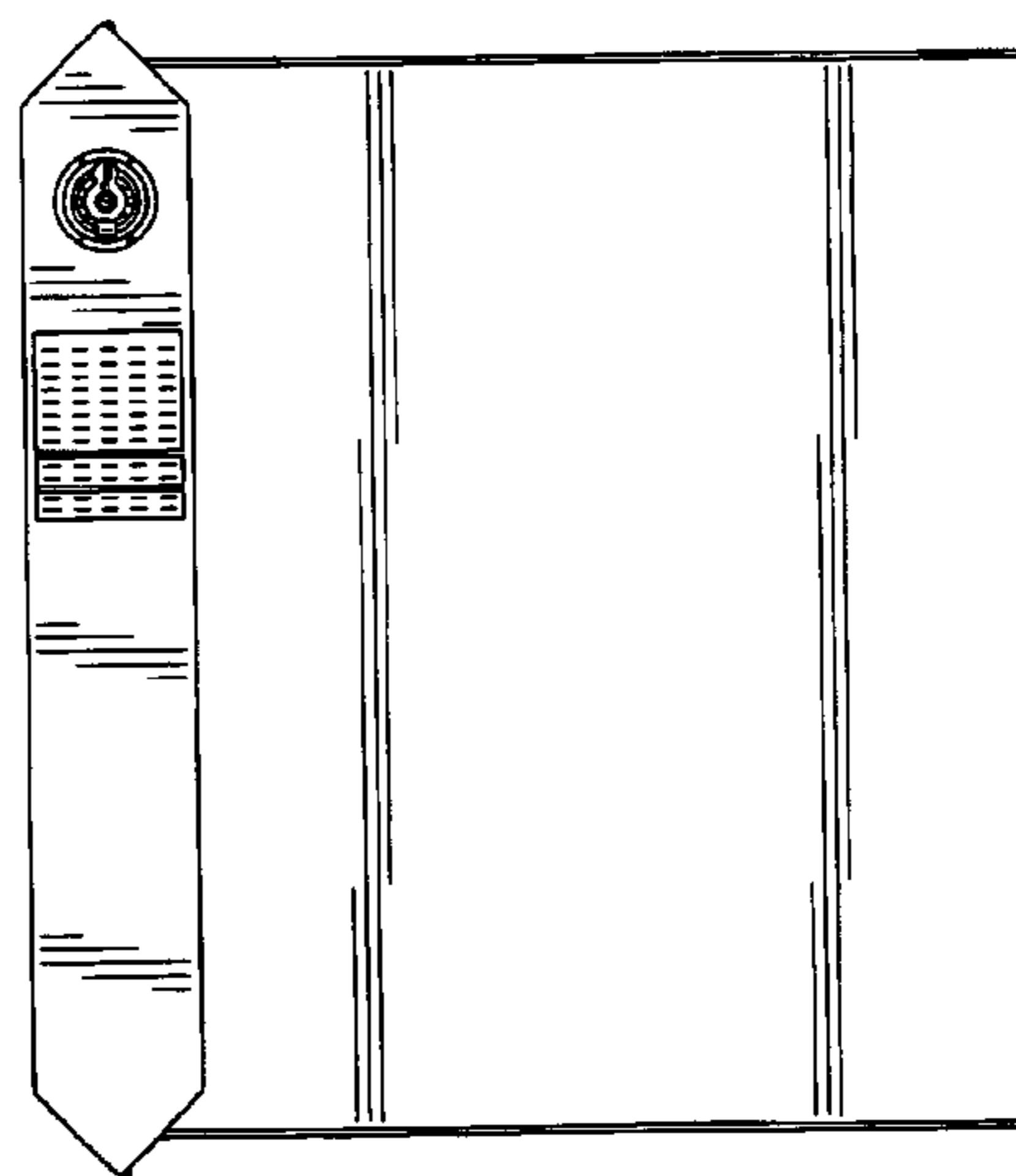
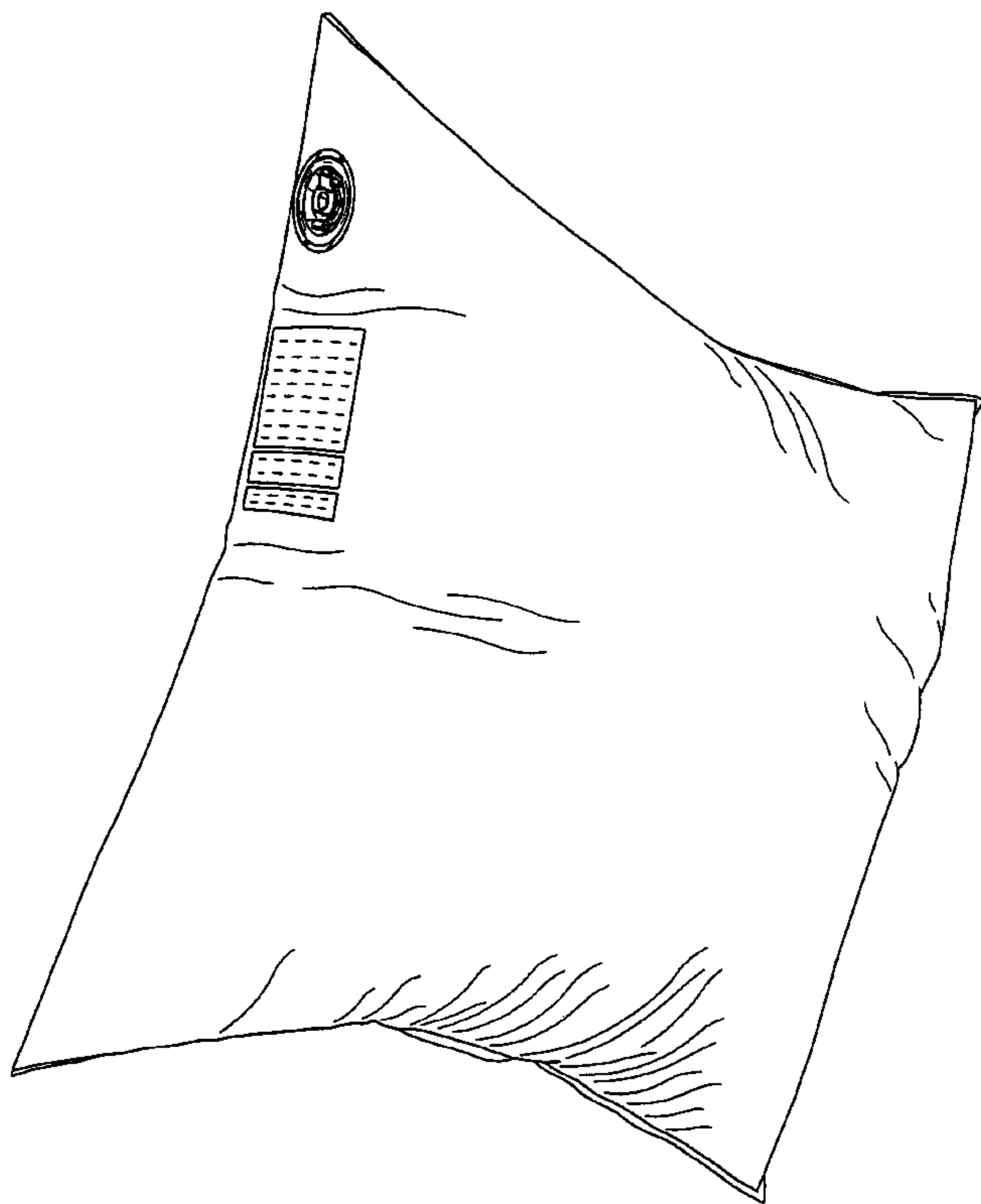
FIG. 10 shows the left side of the inflated dunnage bag mounted between stacks on pallets.

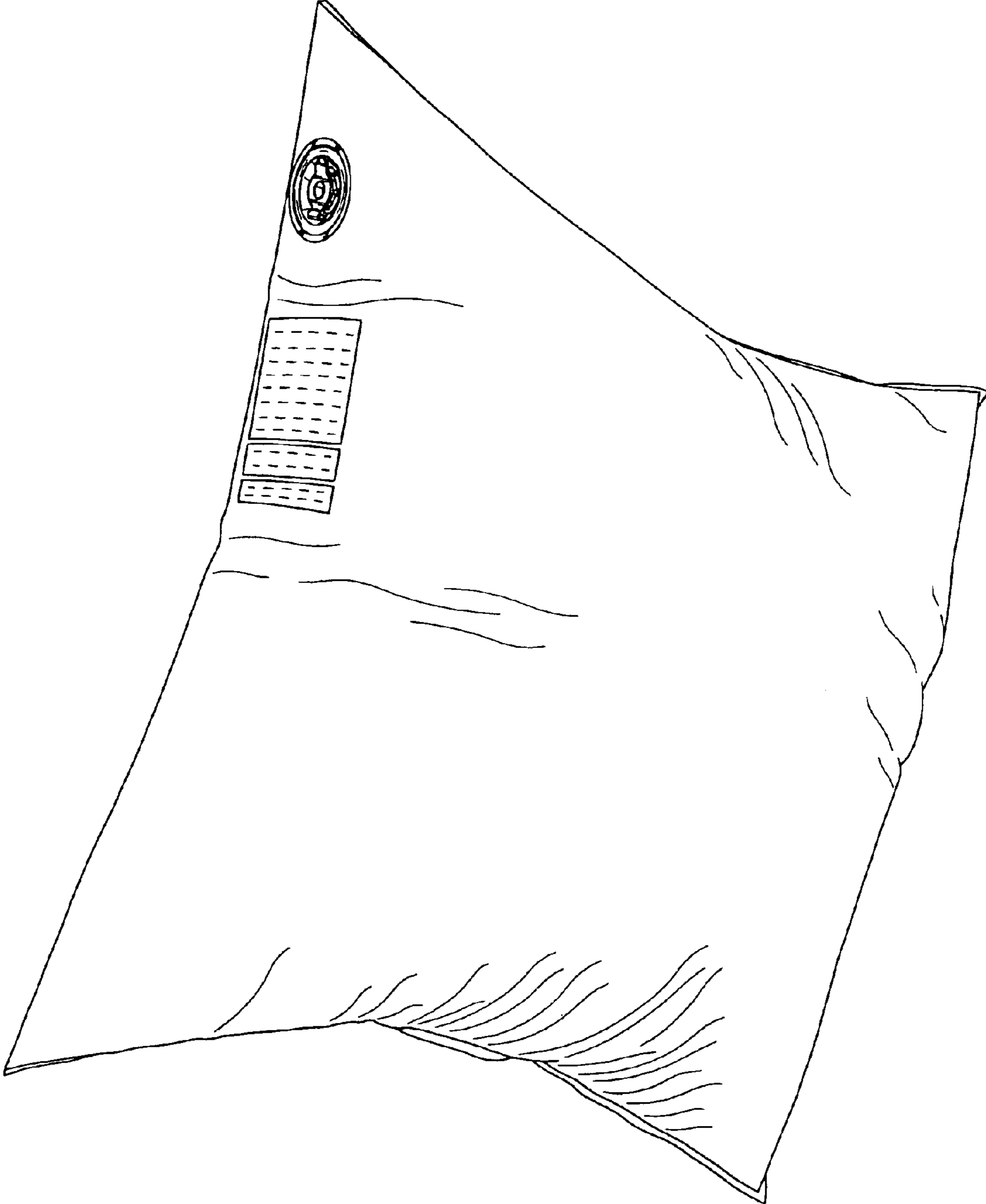

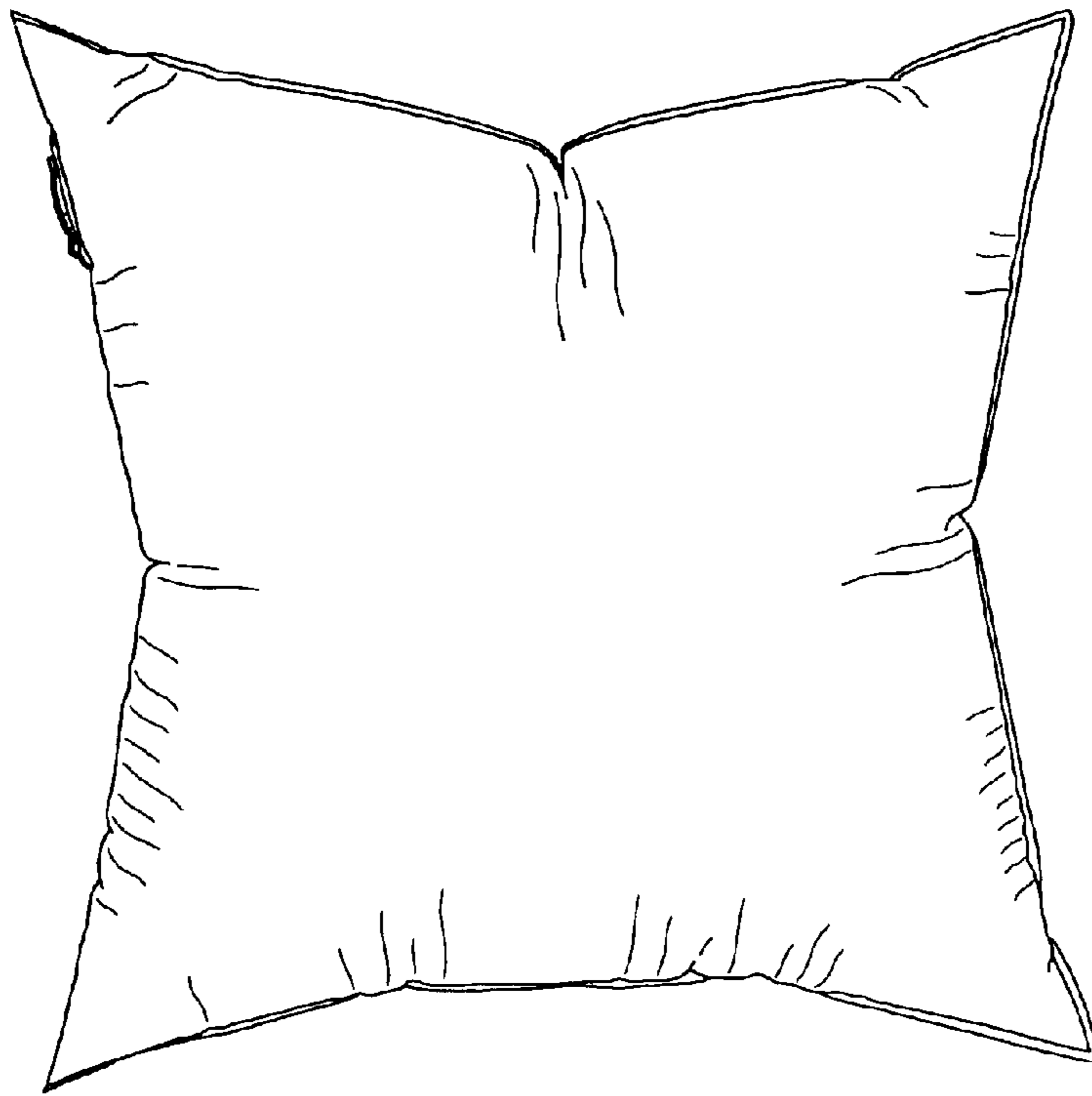

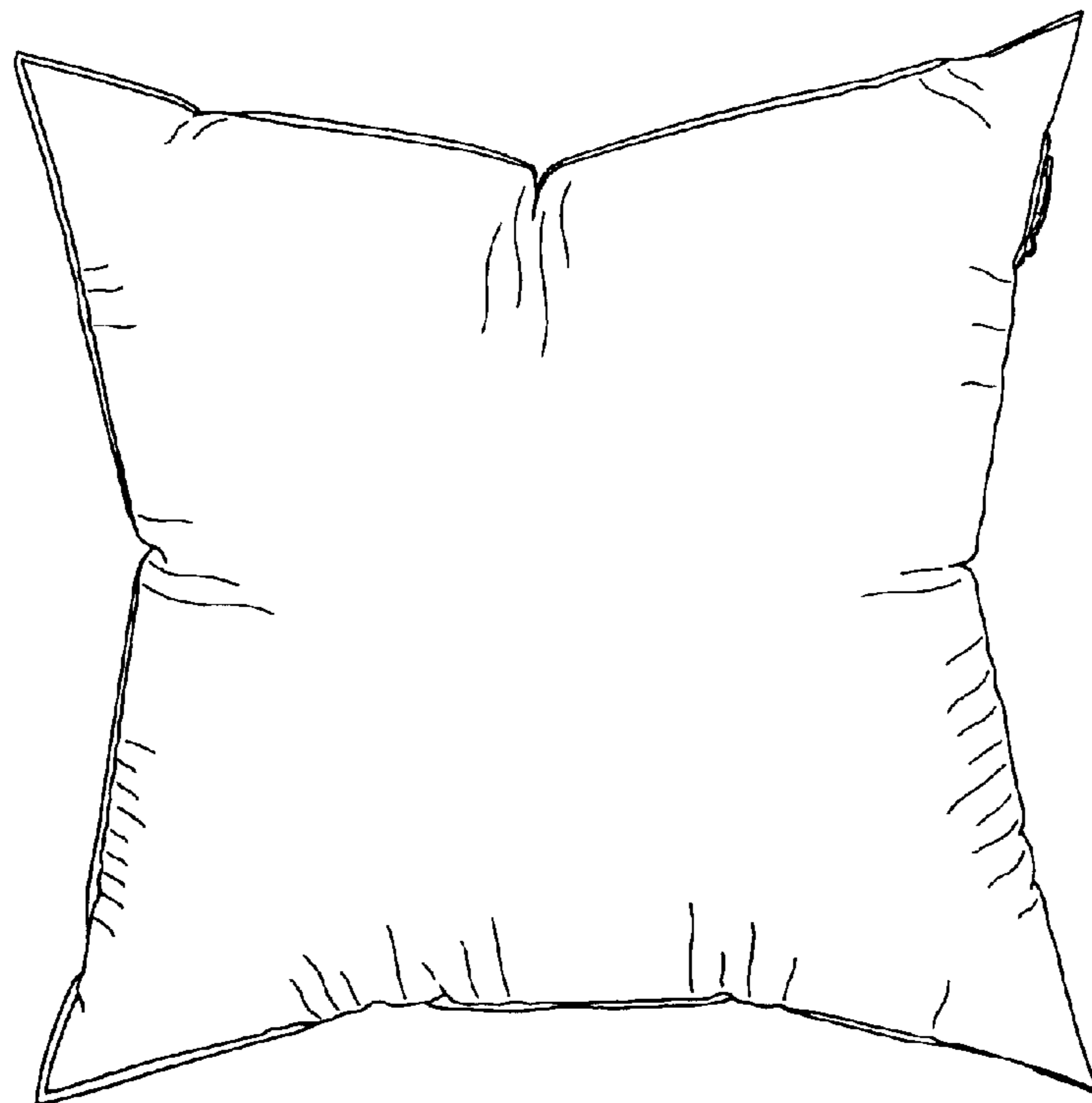

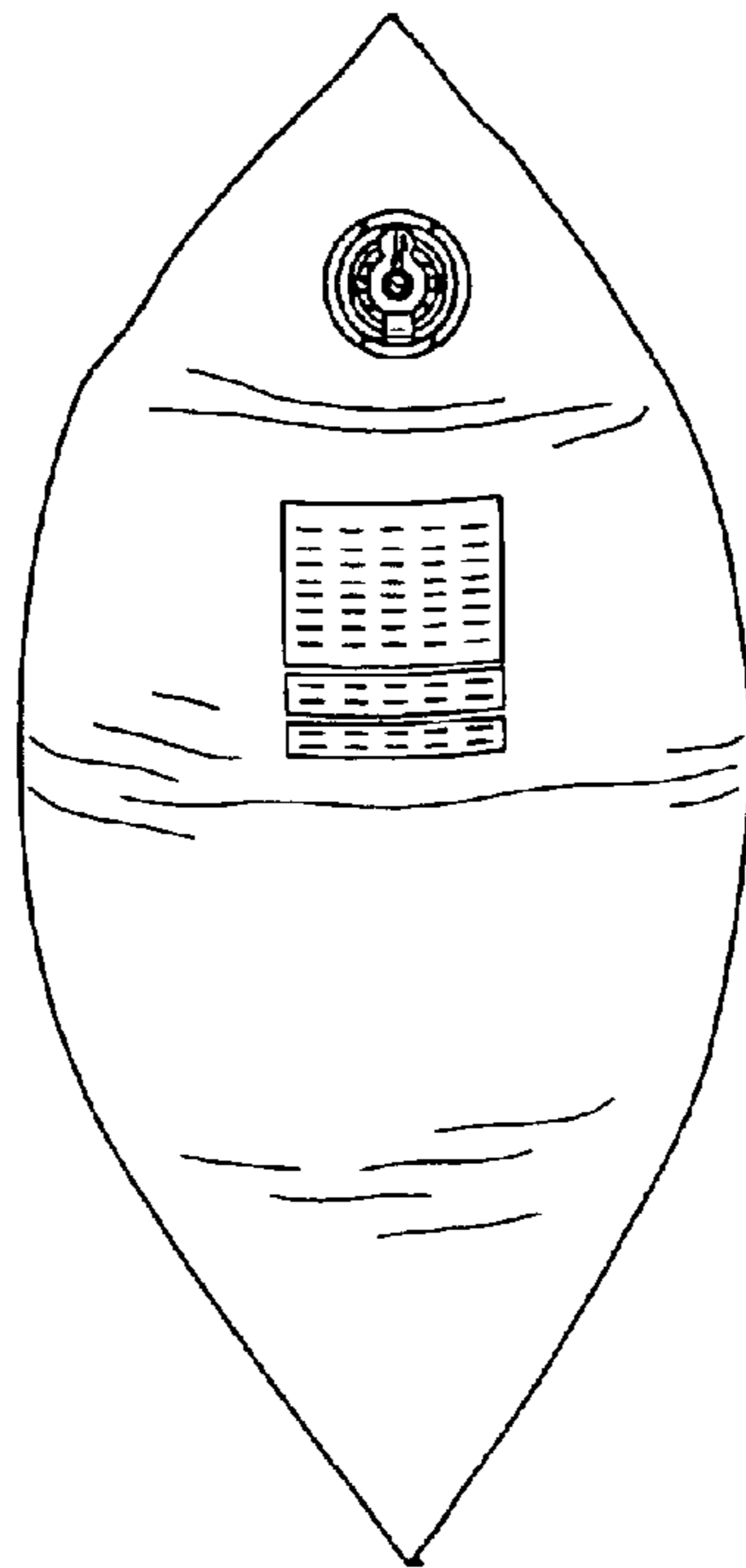

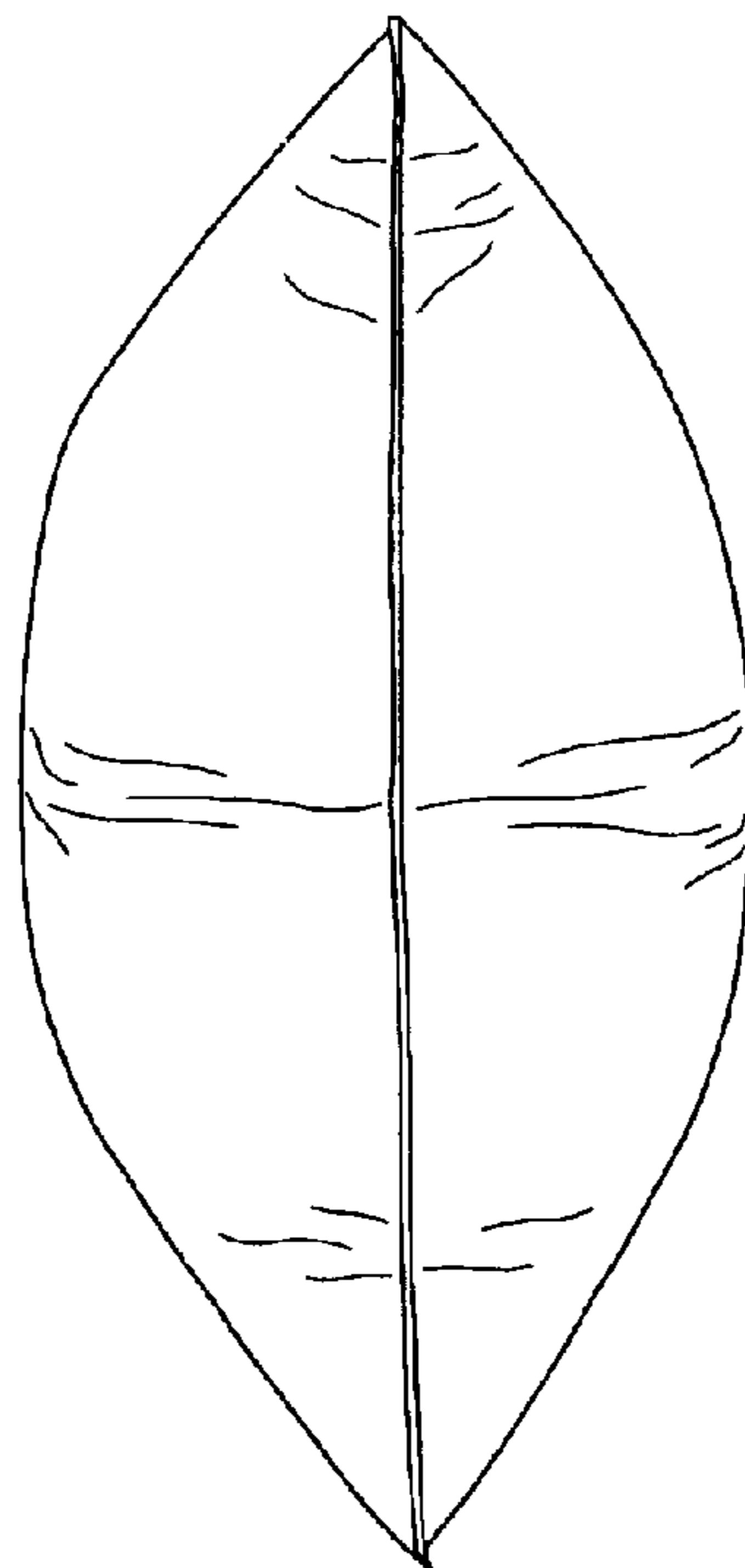

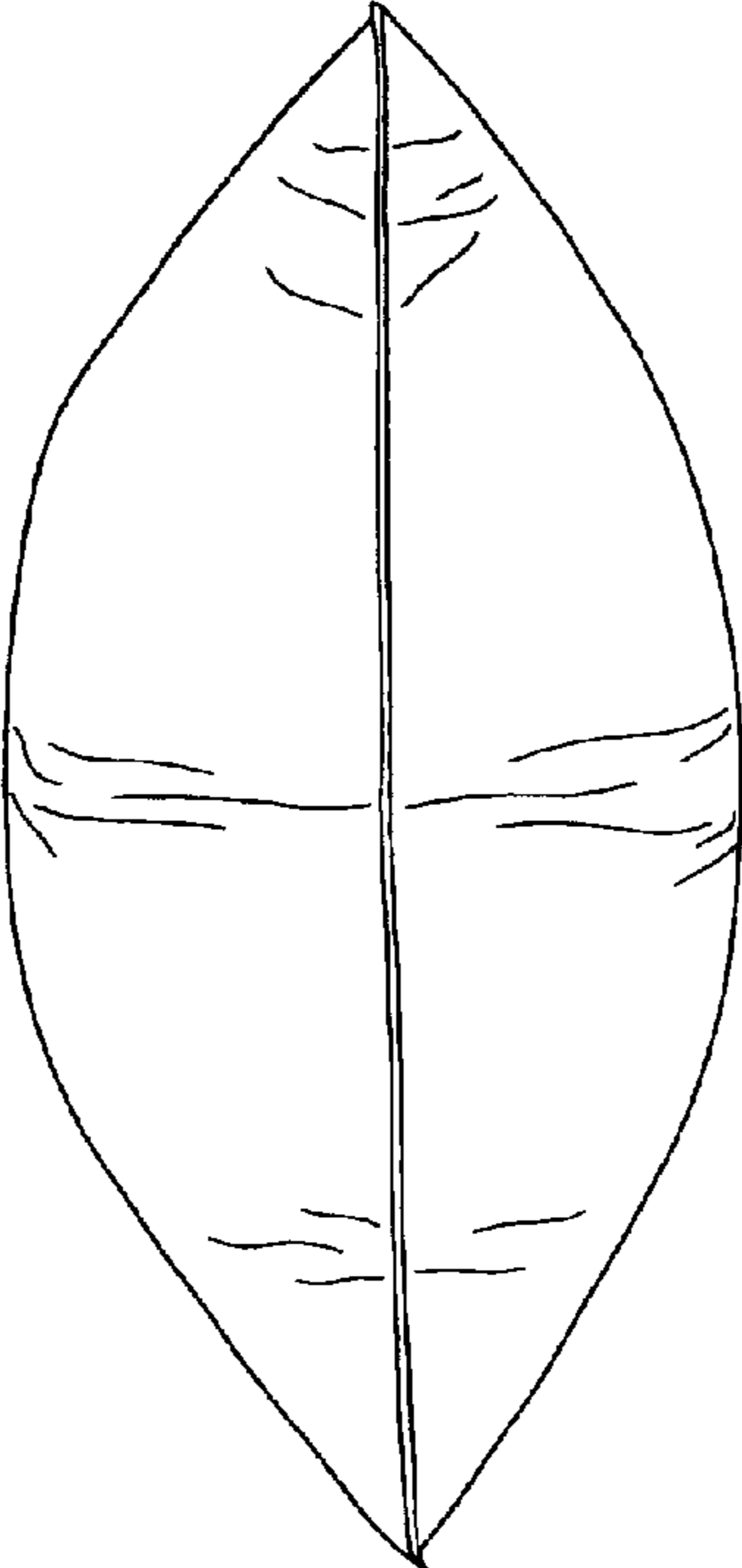

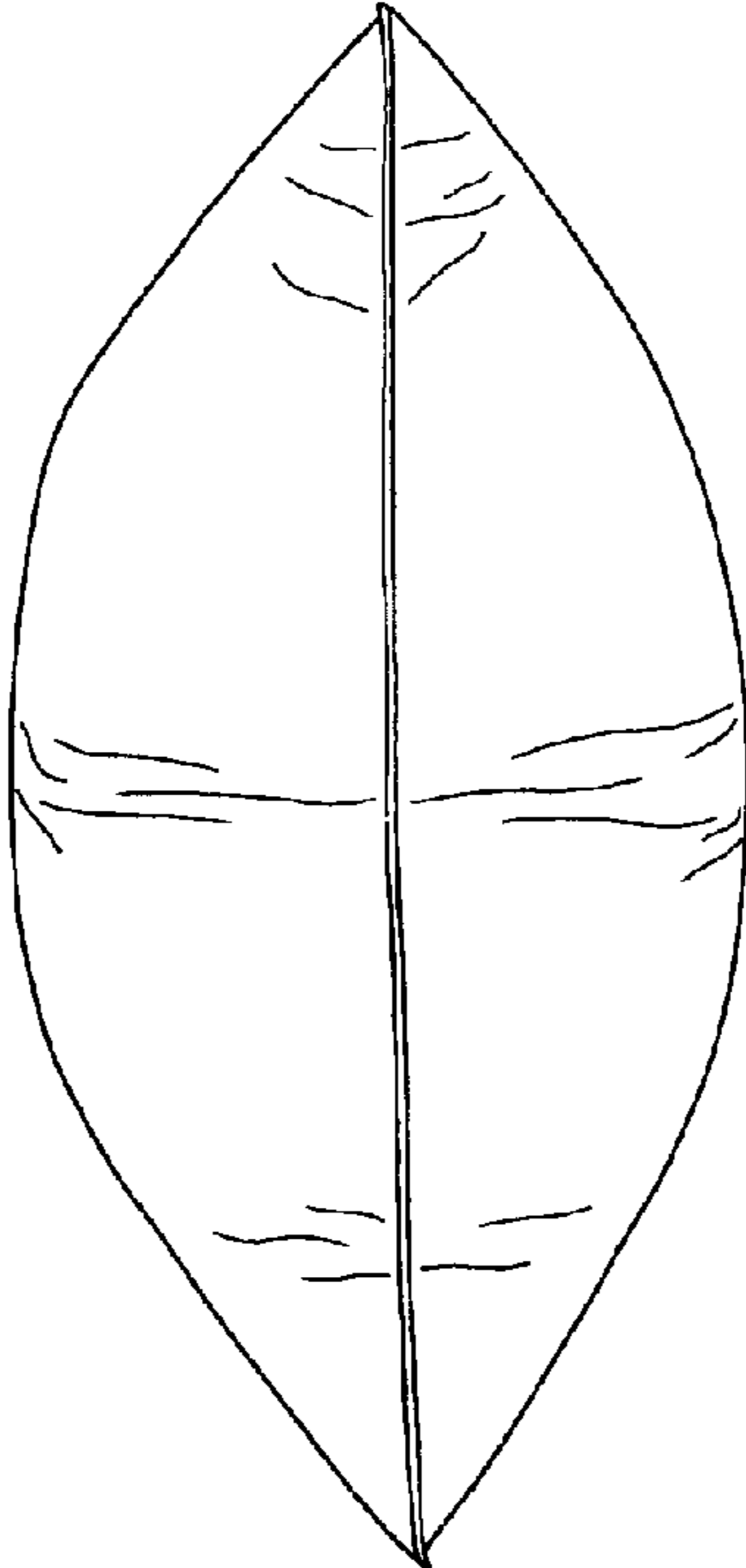

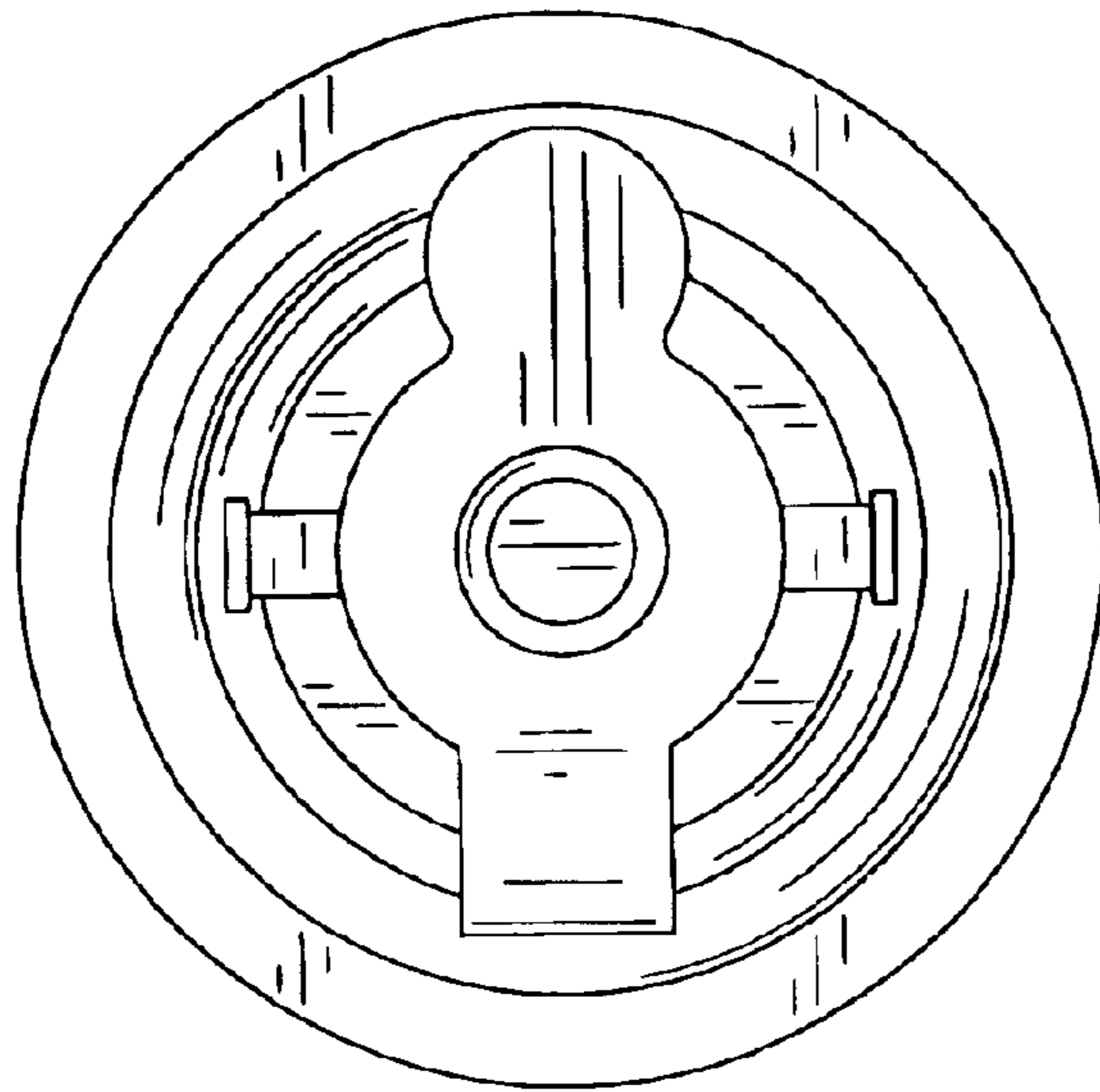

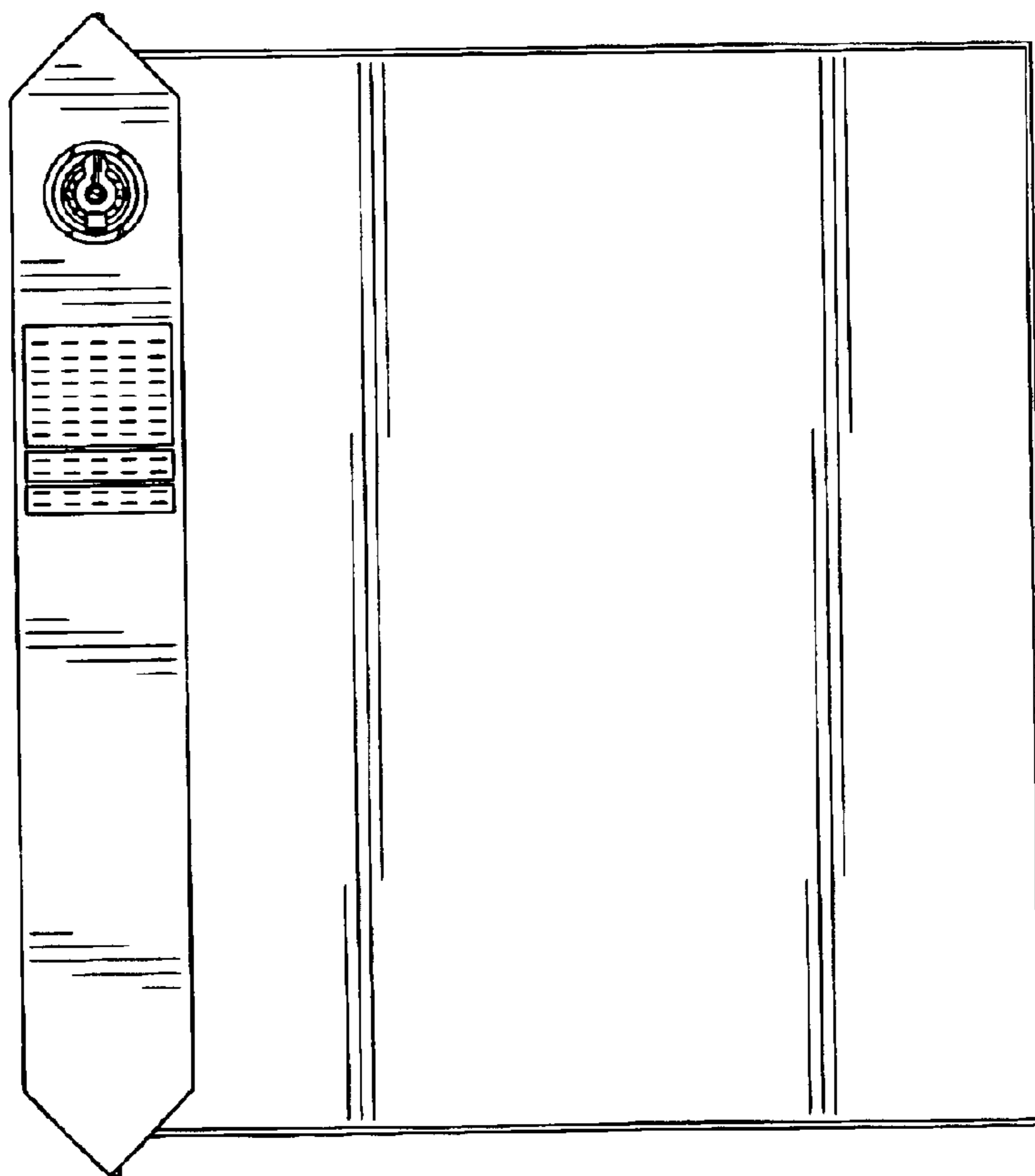

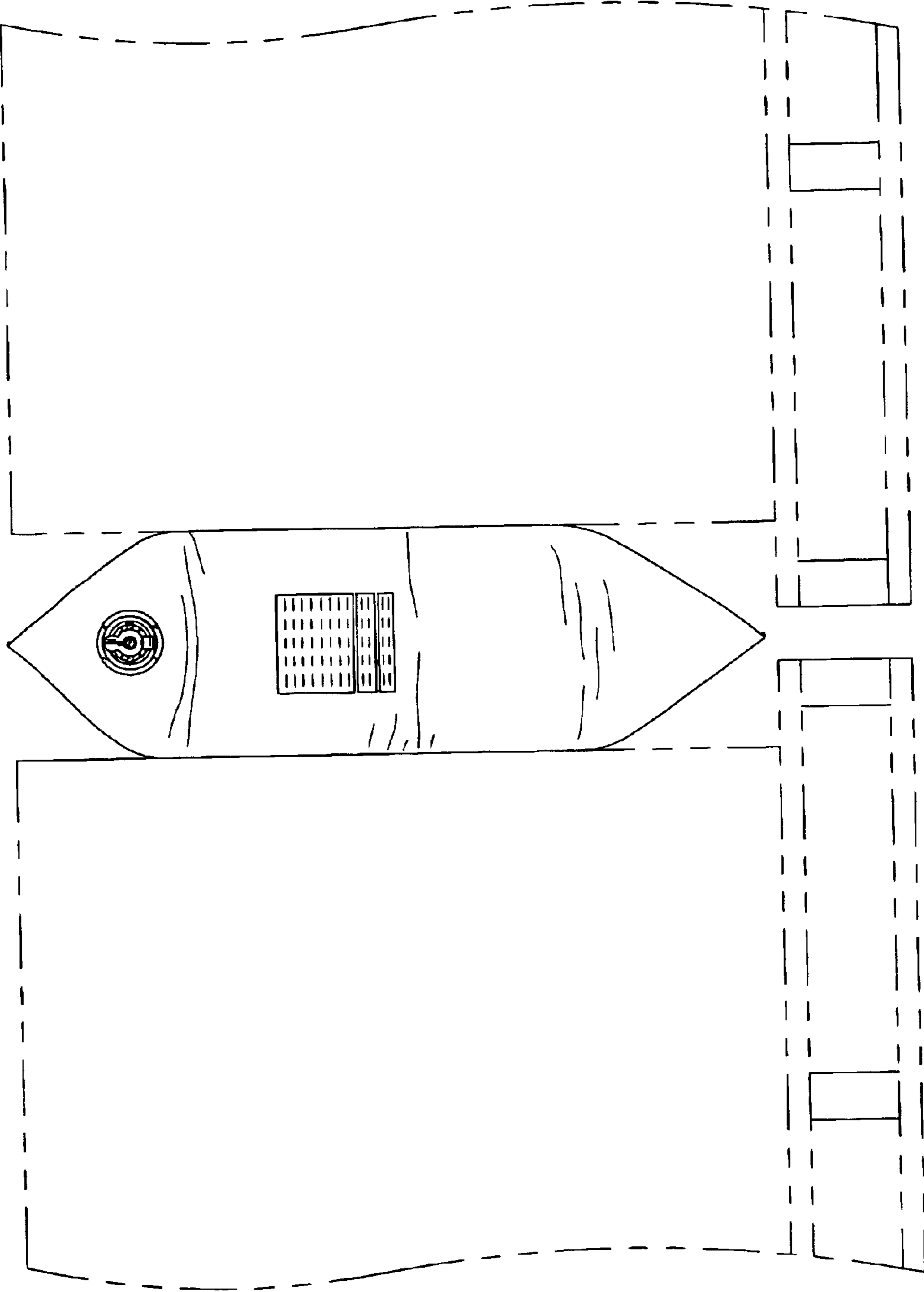
