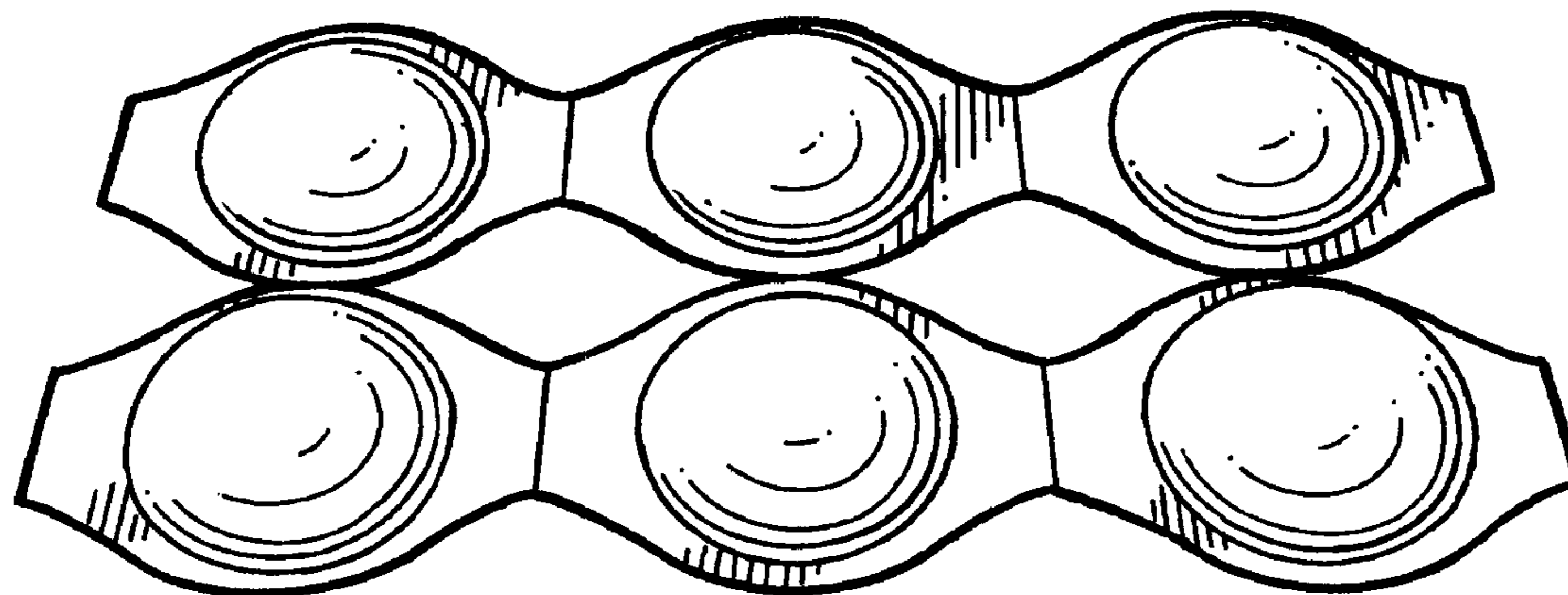
(57) **CLAIM**

The ornamental design for a receptacle, in particular for single-use cosmetic products, as shown and described.

DESCRIPTION

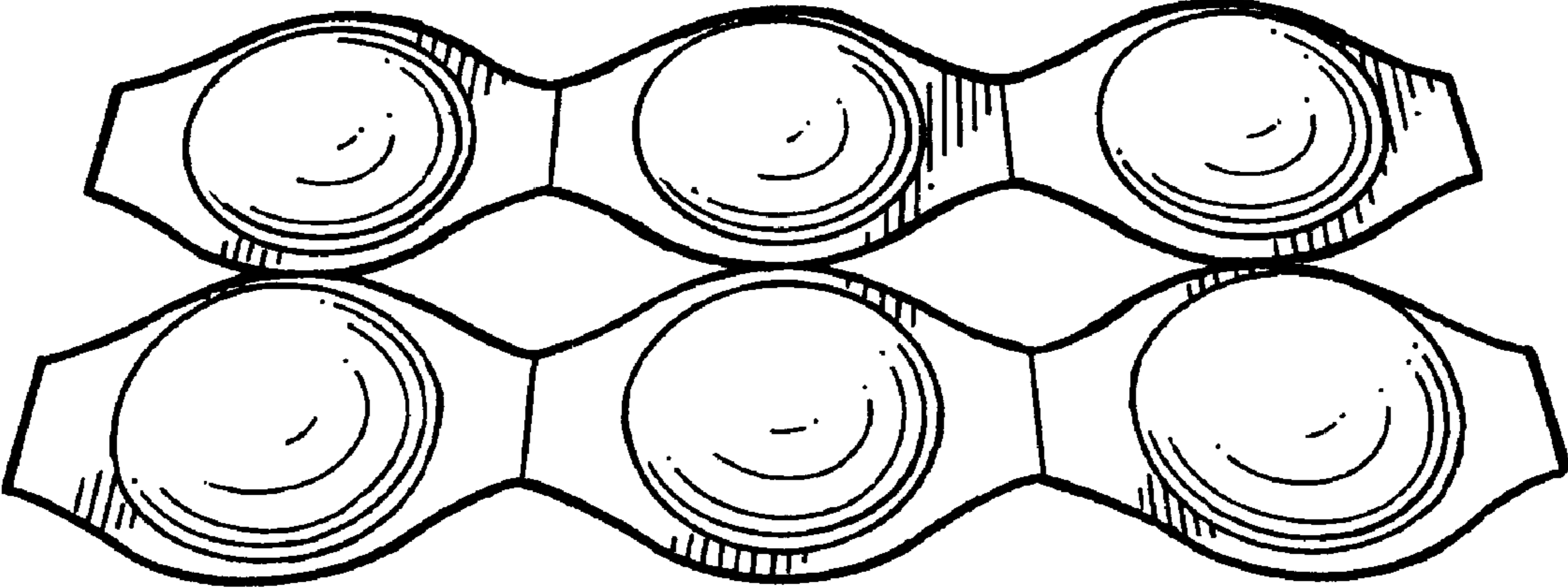

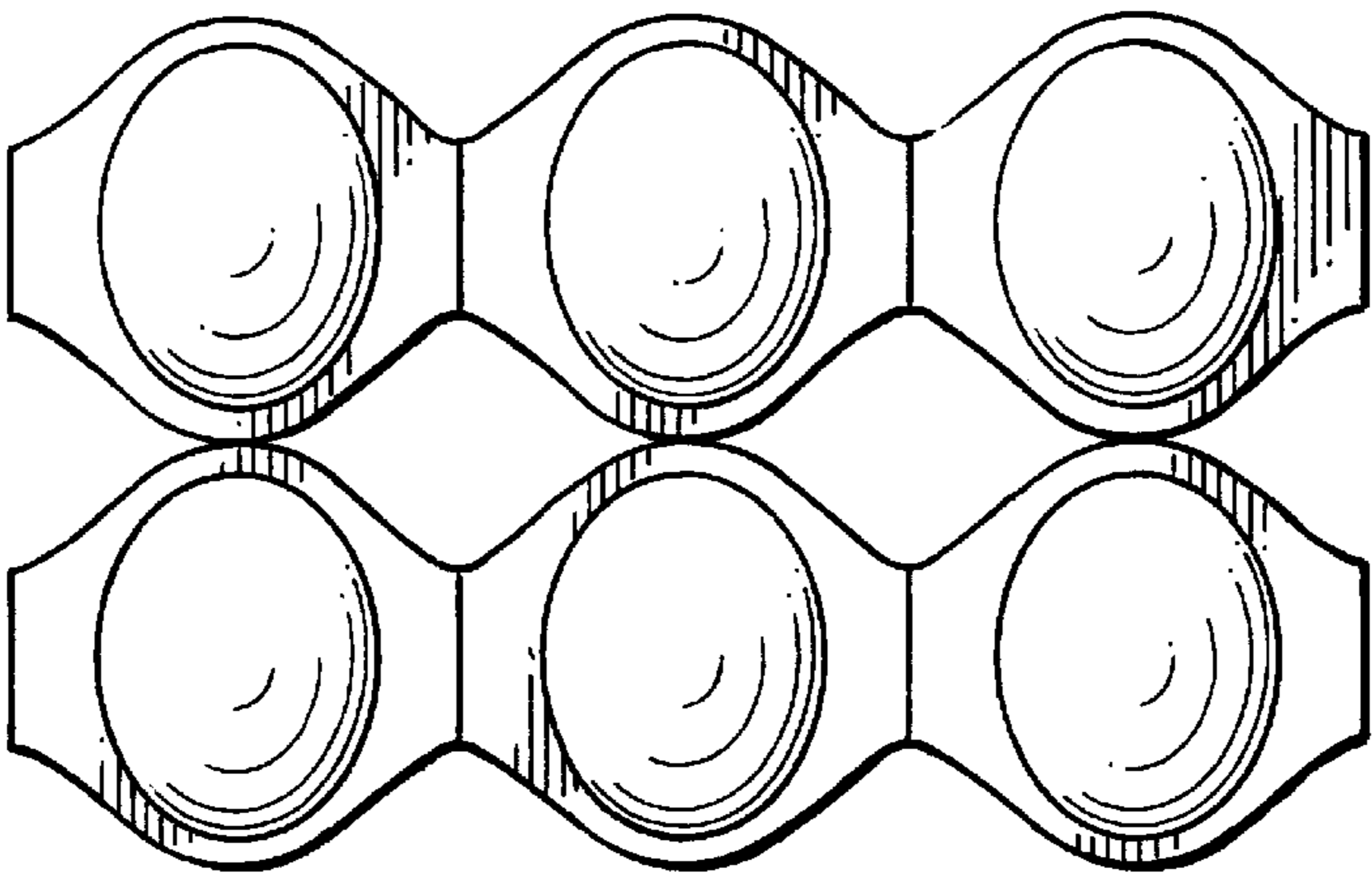

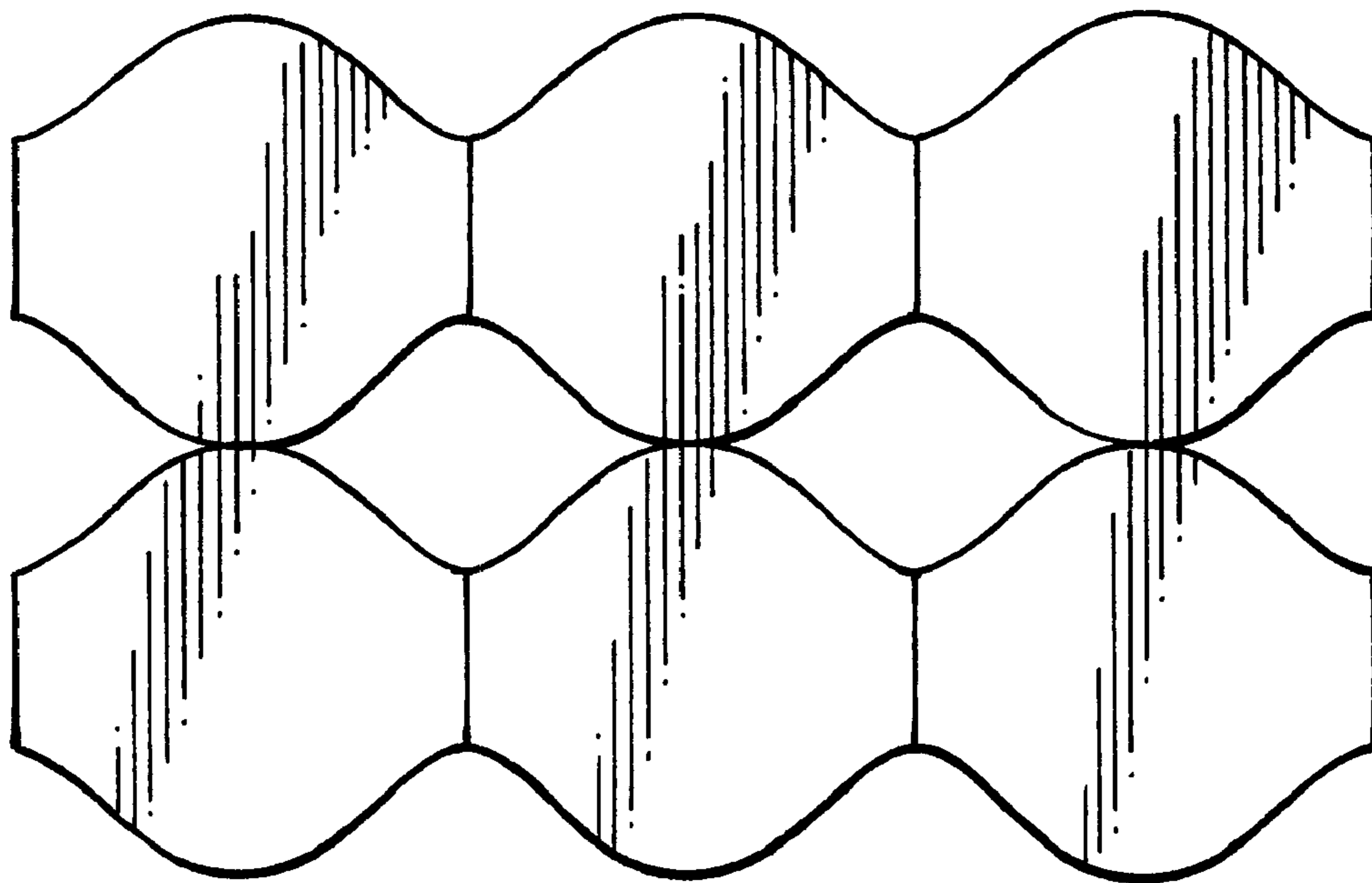
