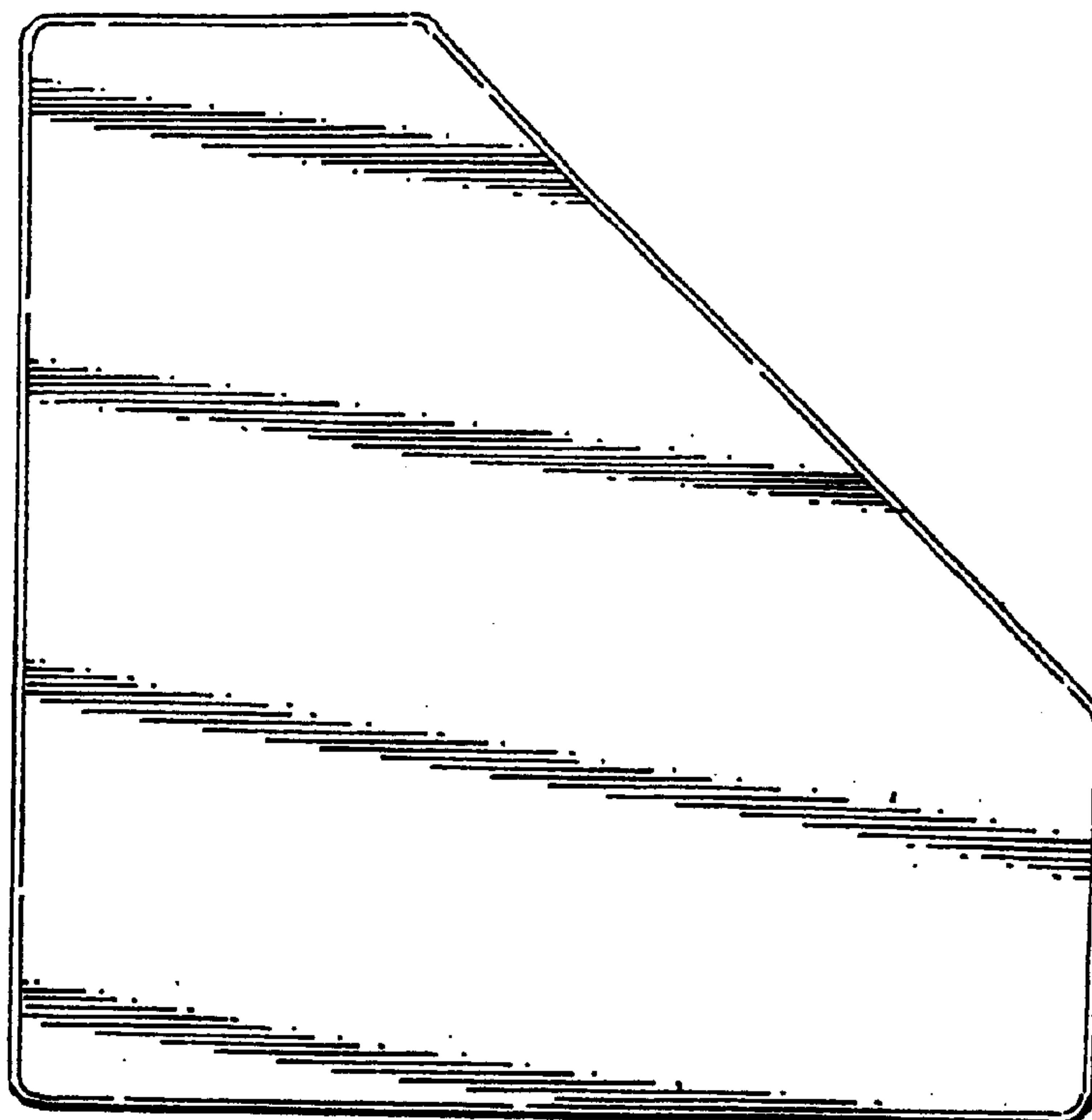
(57) CLAIM

The ornamental design of a pick-up truck box corner protector, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a pick-up truck box corner protector of our design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a front elevational view of a second embodiment of the pick-up truck box corner protector of FIG. 1;
FIG. 8 is a top plan view of FIG. 7;
FIG. 9 is a bottom plan view of FIG. 7;
FIG. 10 is a rear elevational view of FIG. 7;
FIG. 11 is a left side elevational view of FIG. 7; and,
FIG. 12 is a right side elevational view of FIG. 7.

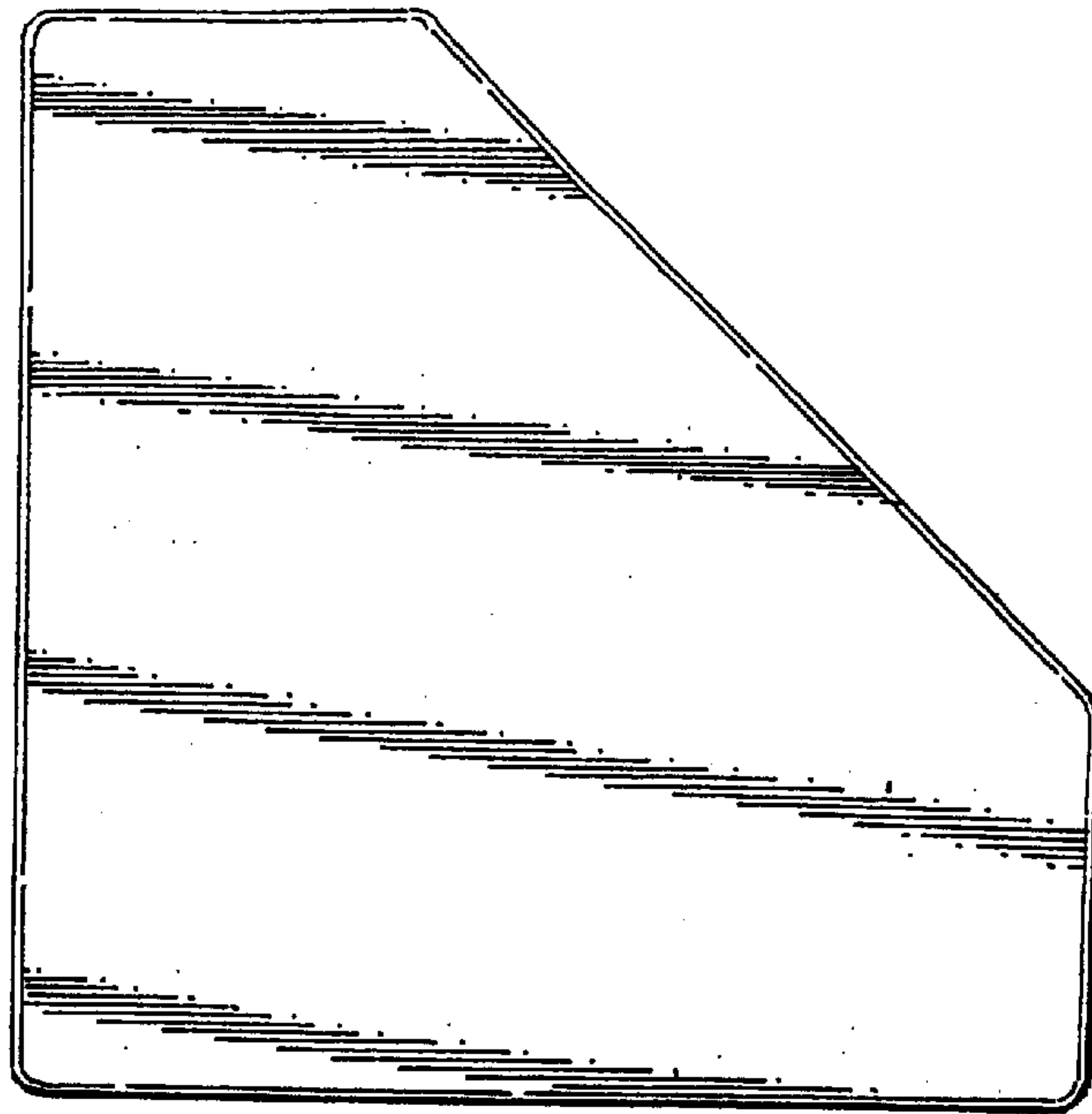

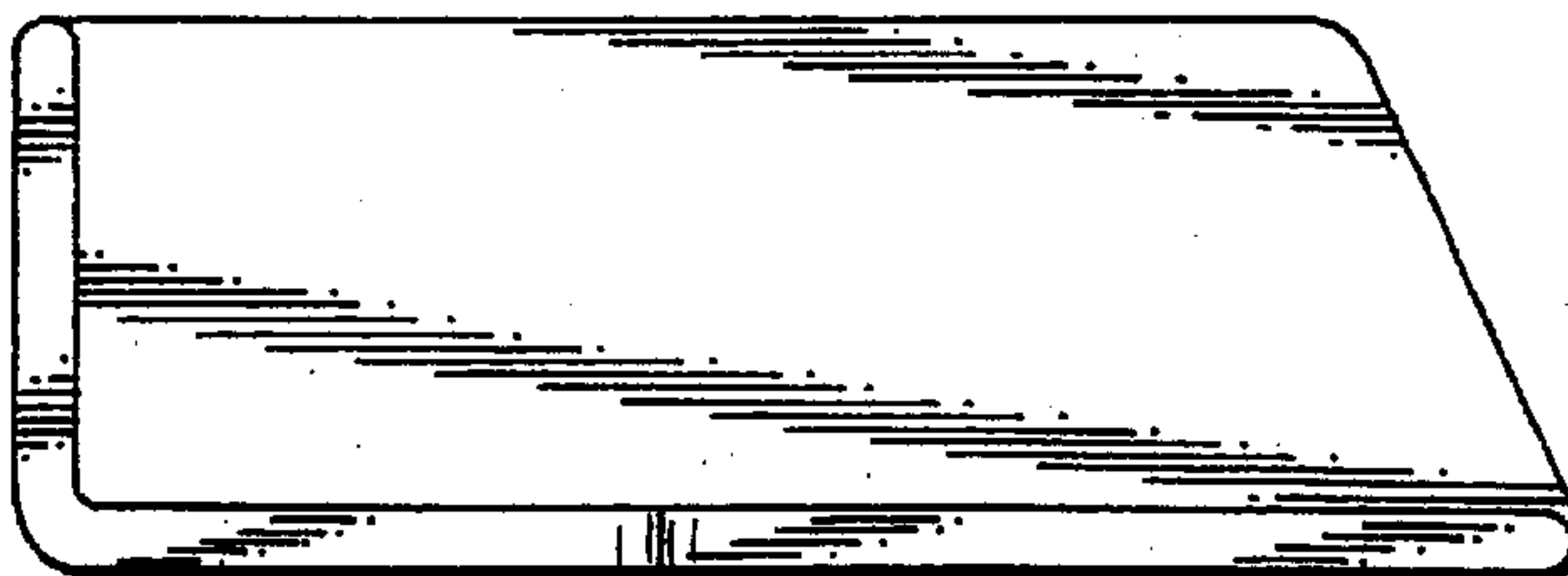

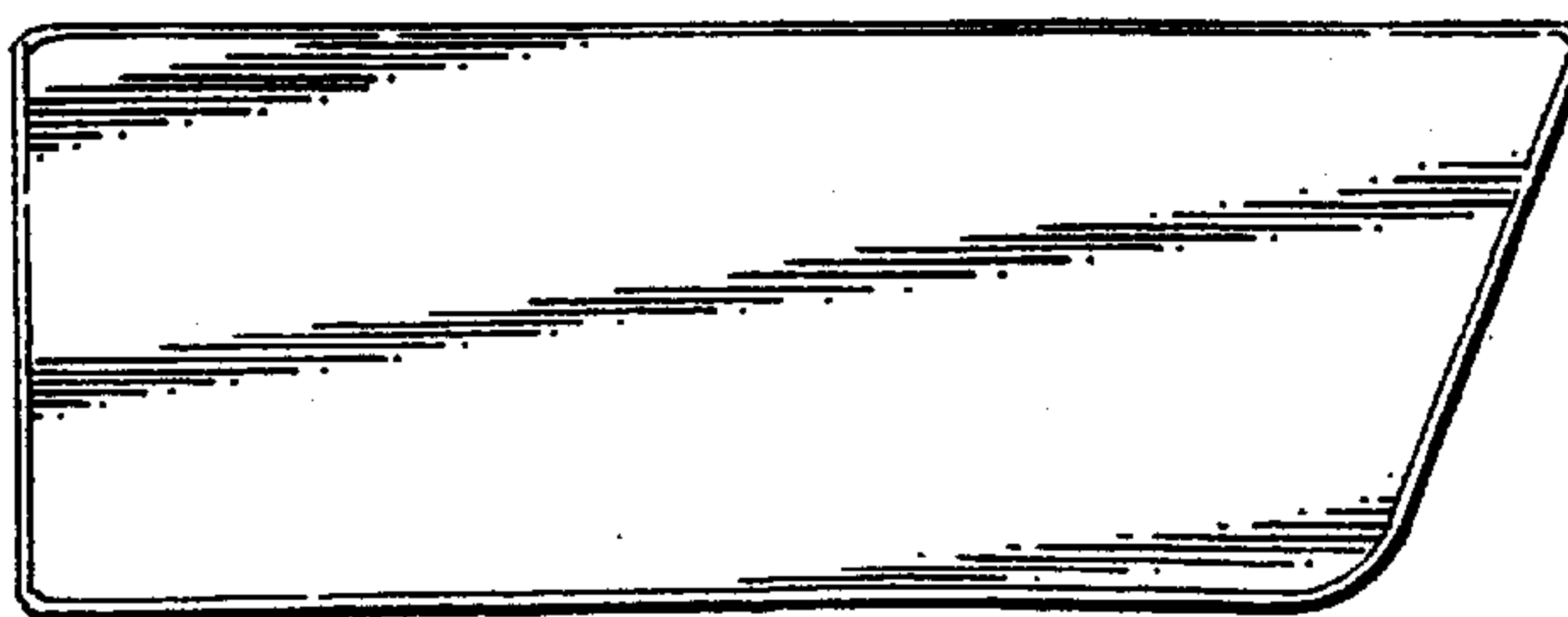

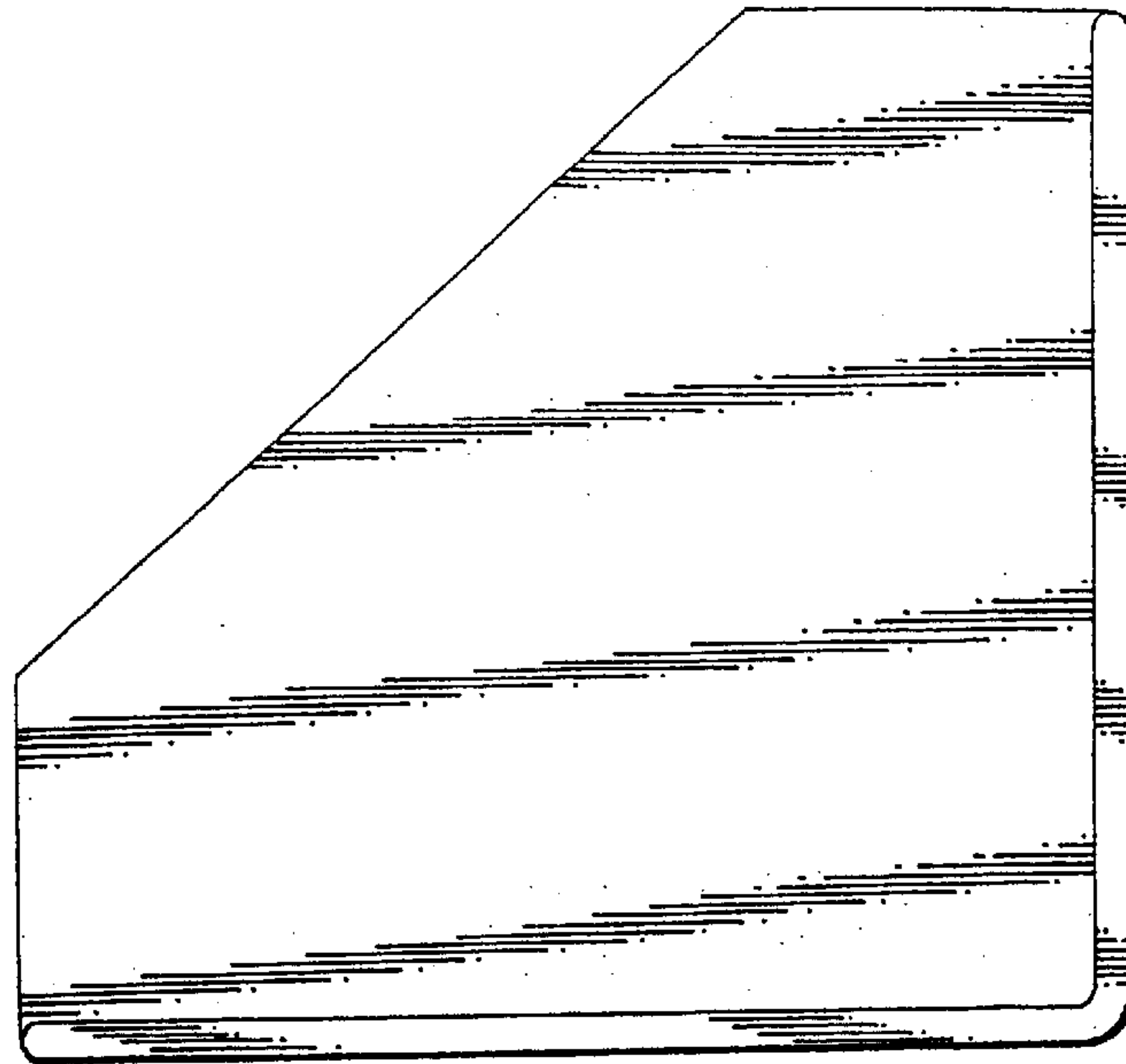

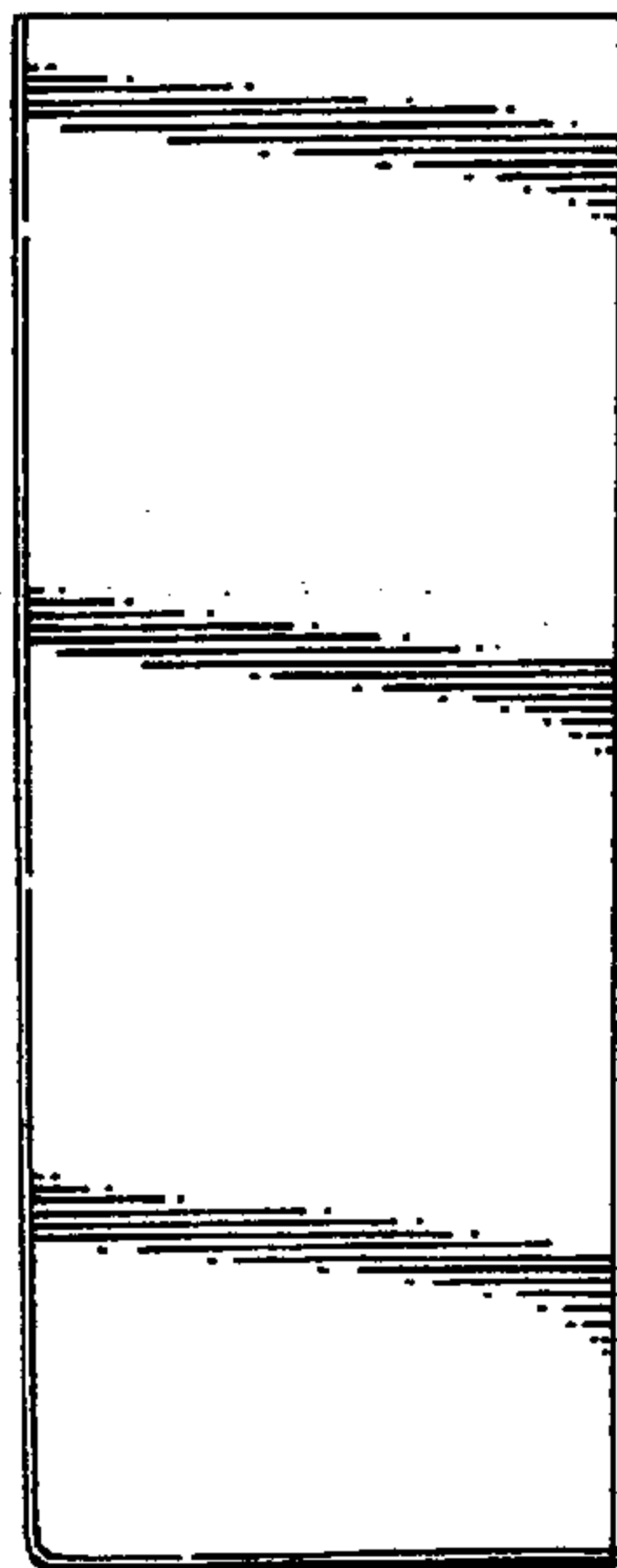

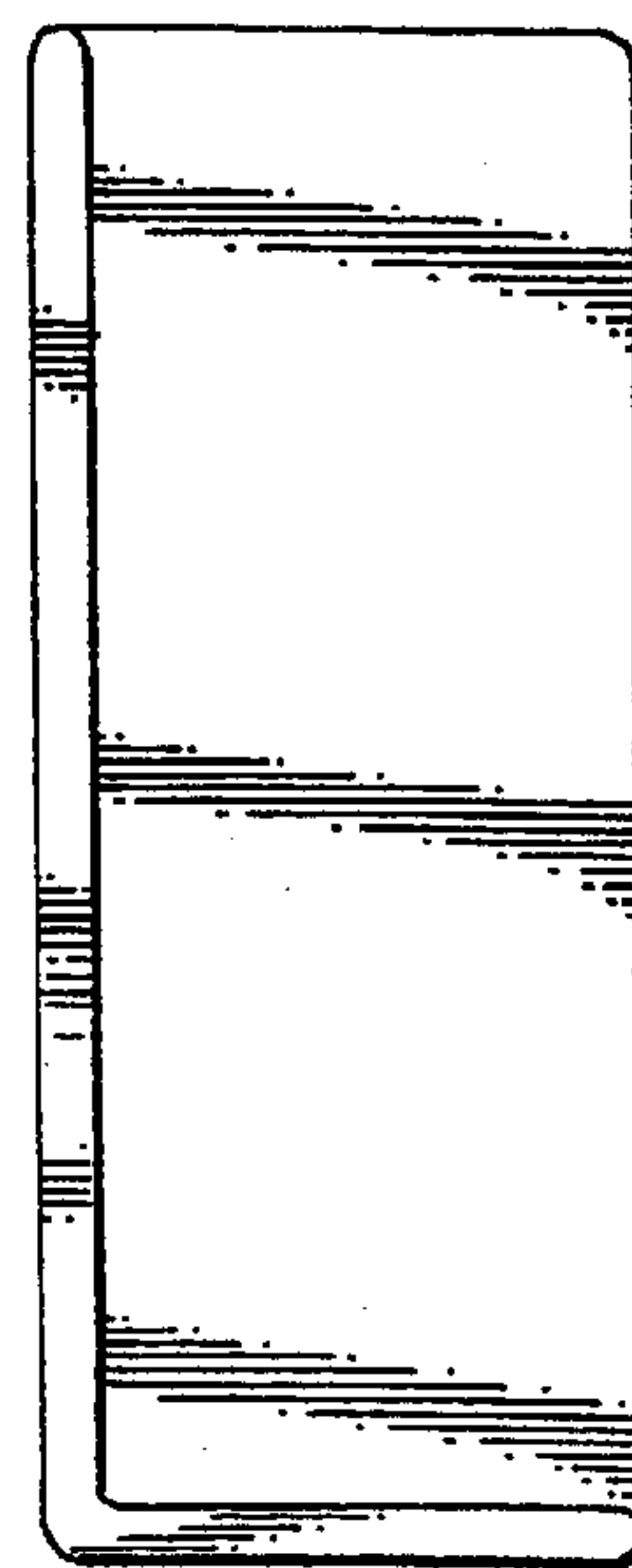

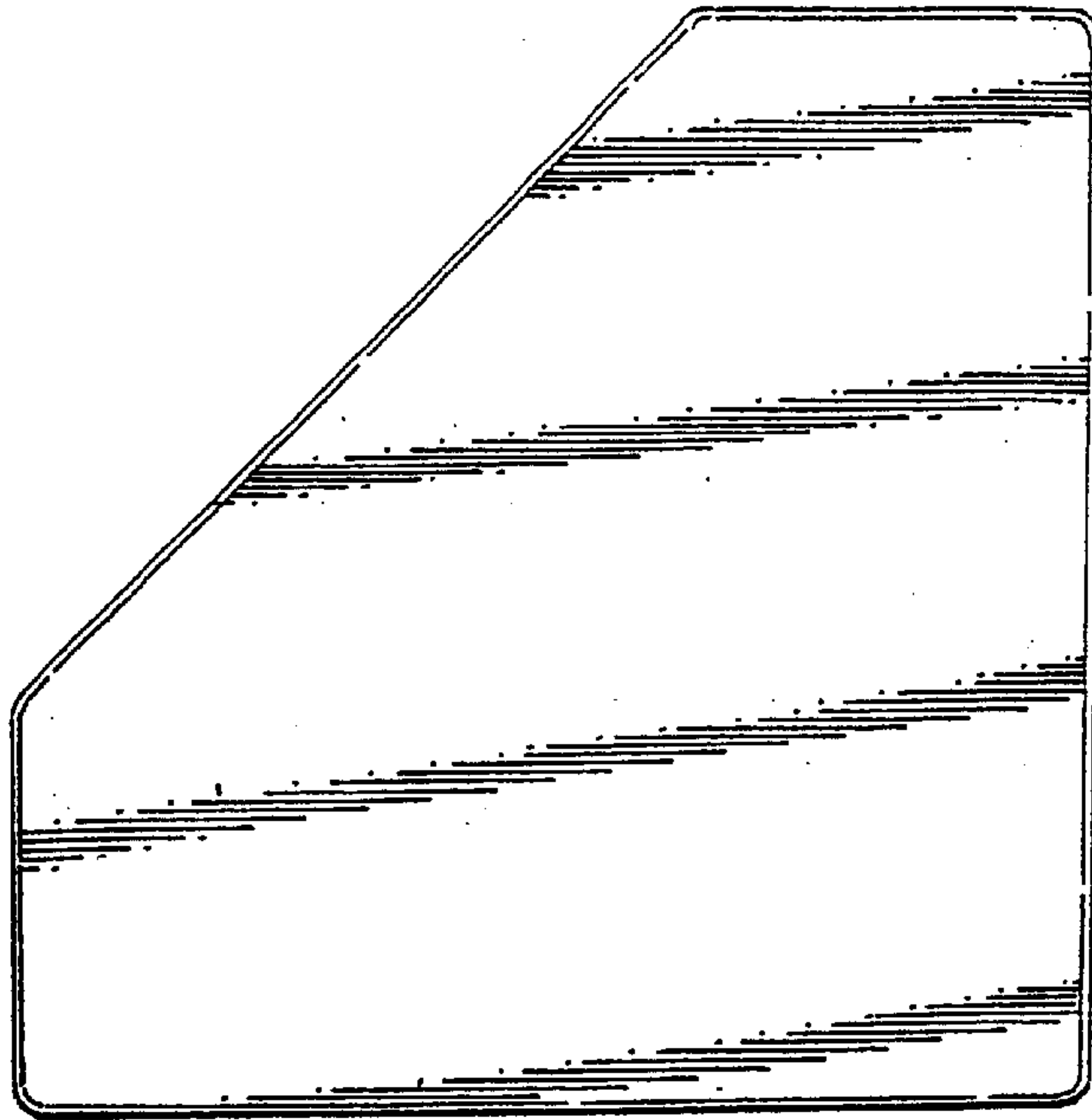

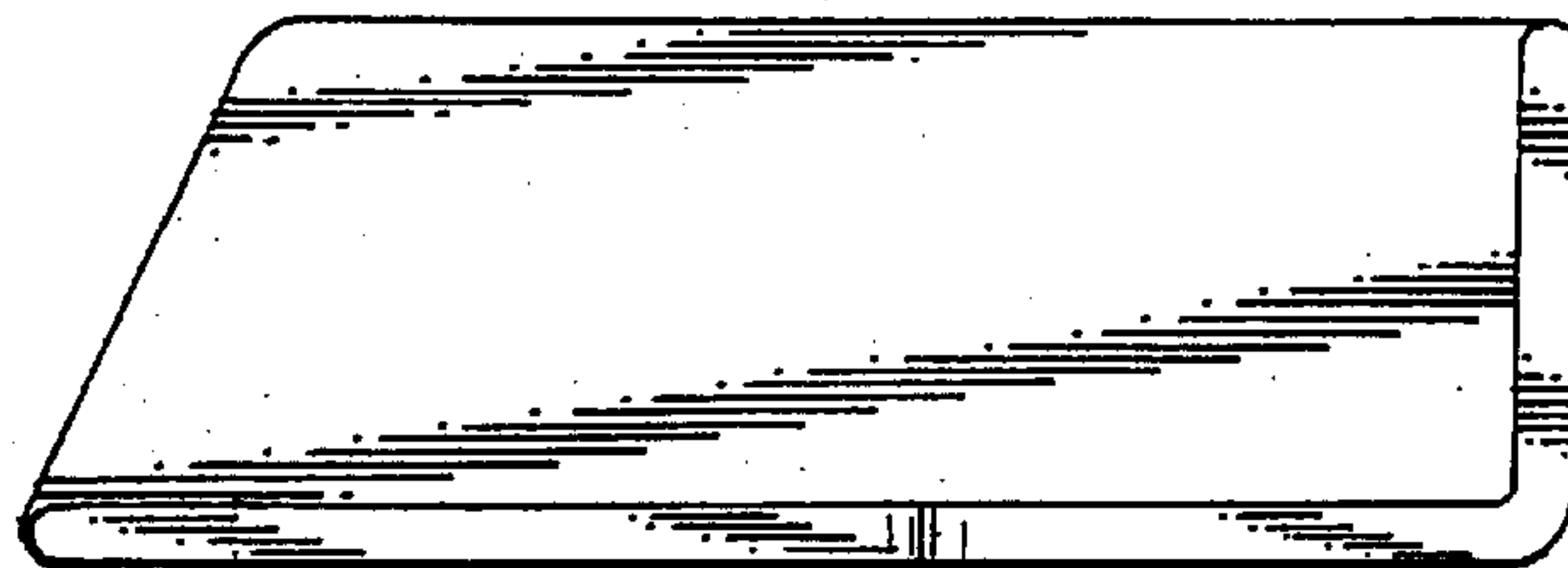

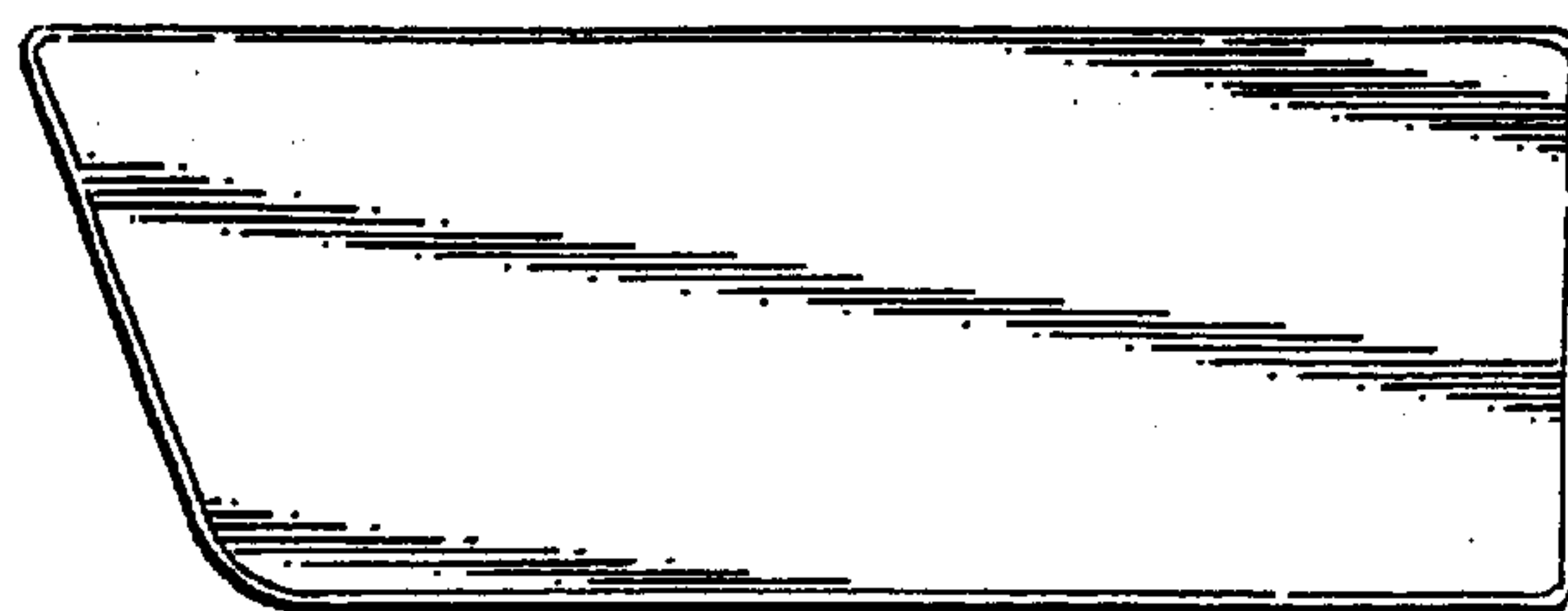

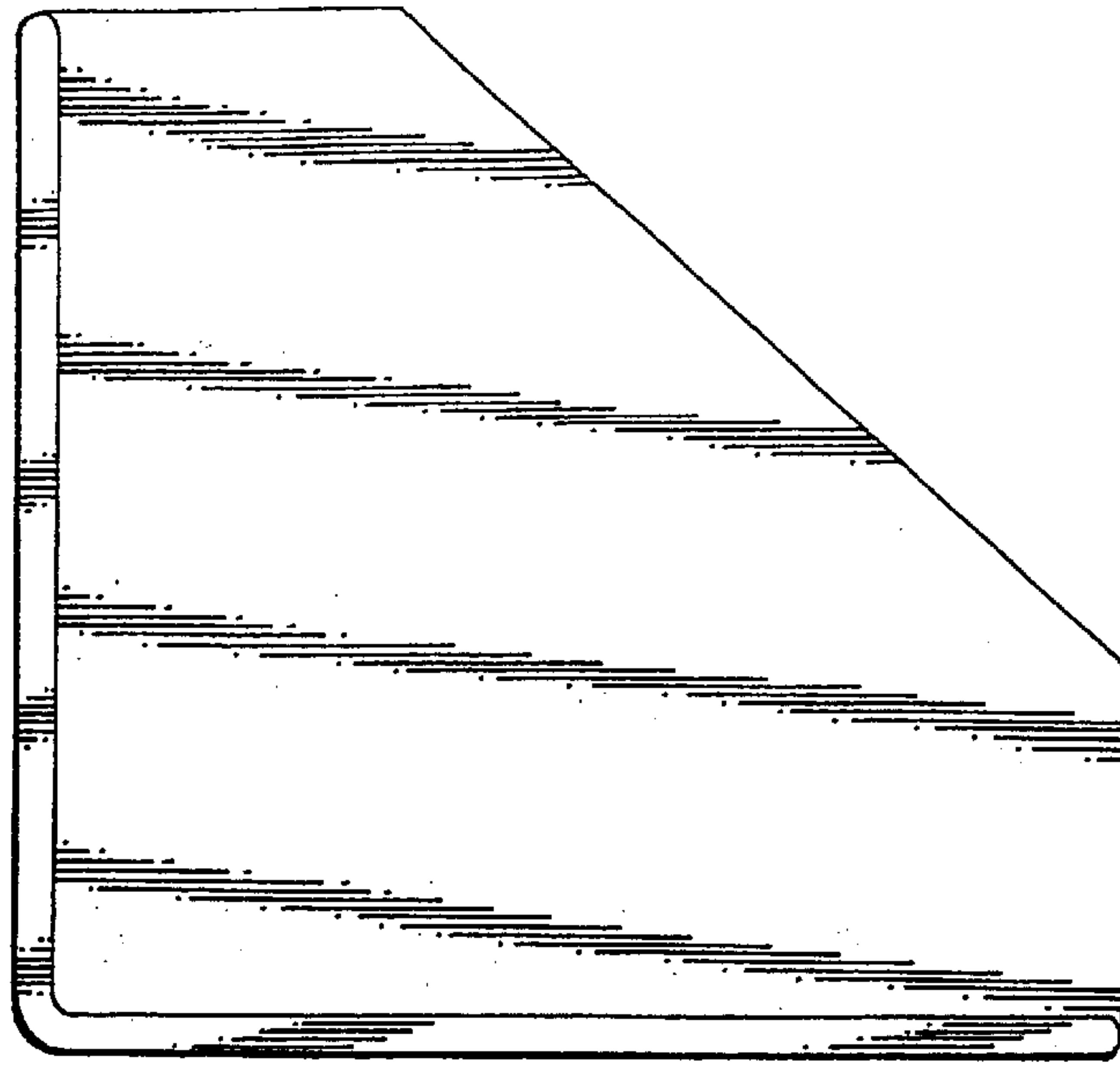

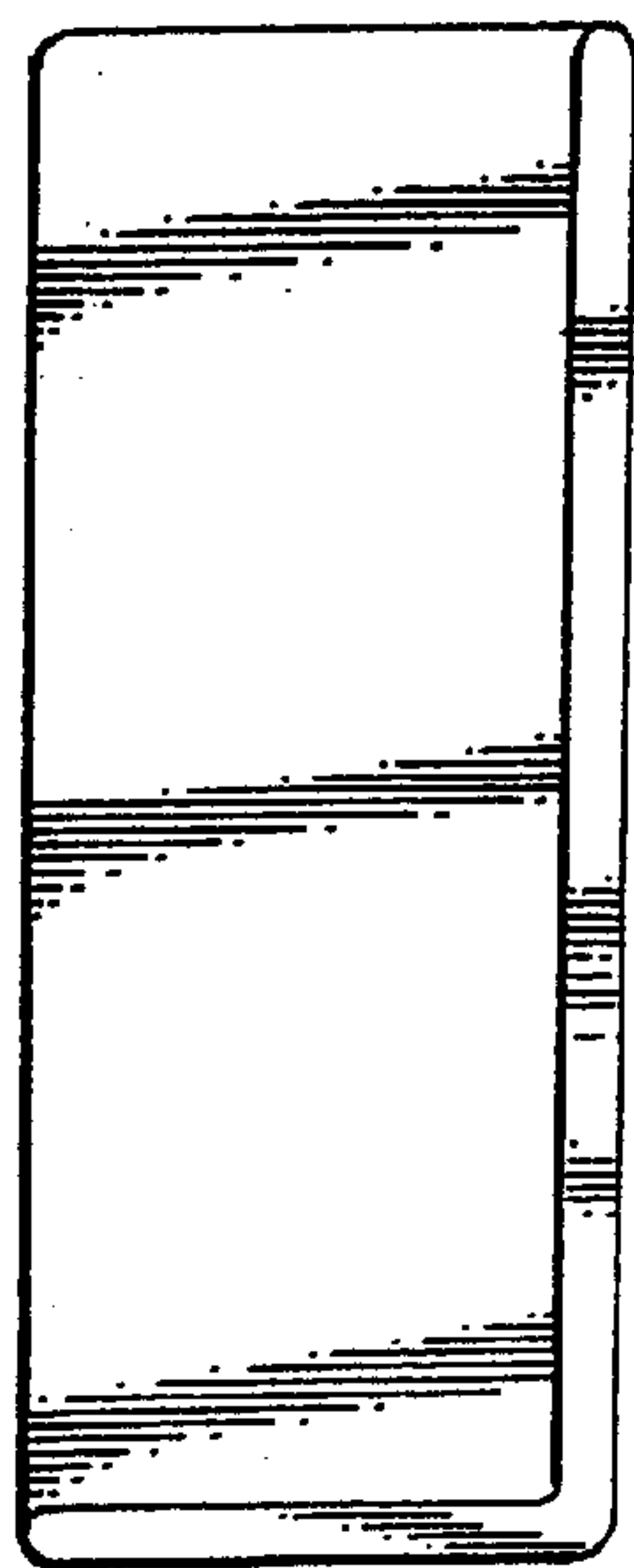

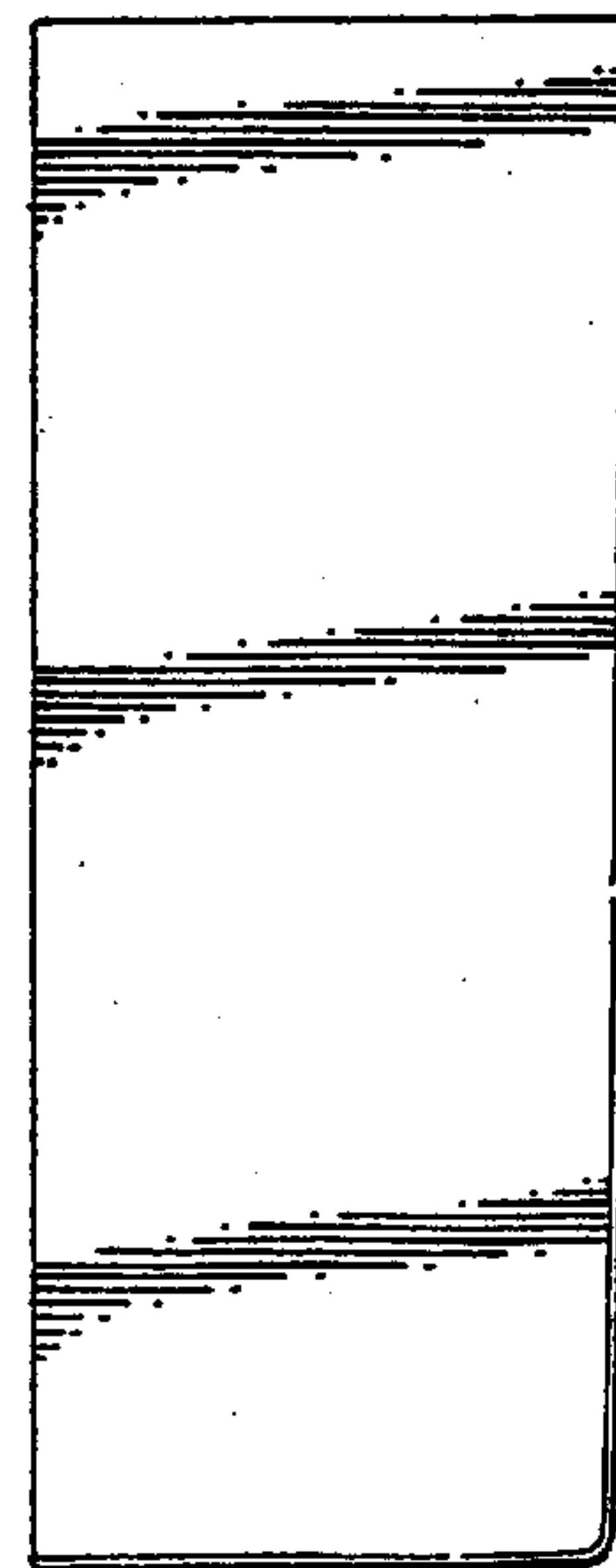
