The ornamental design for a universal hands-free desk unit for cellular telephones, as shown.

DESCRIPTION

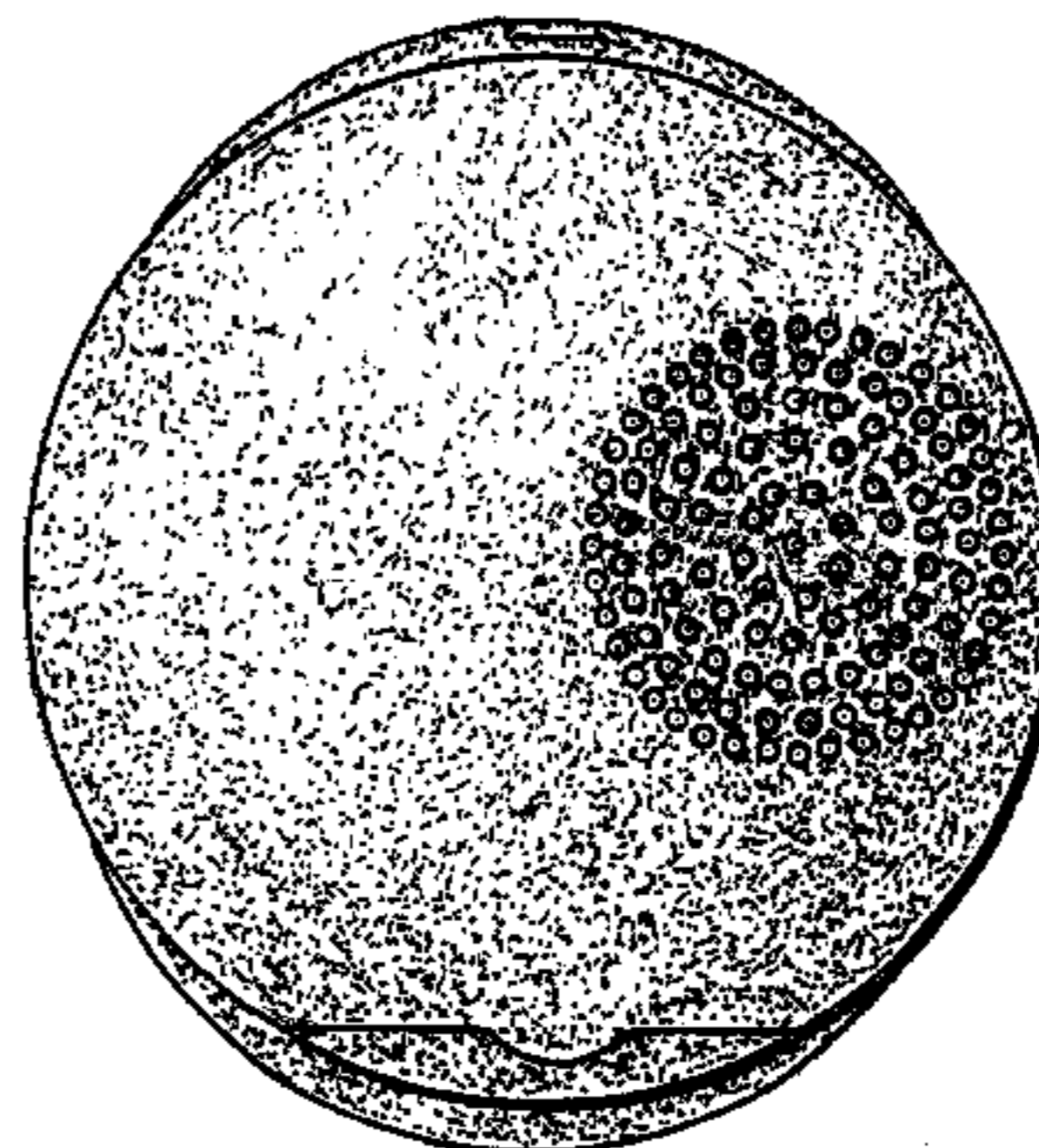
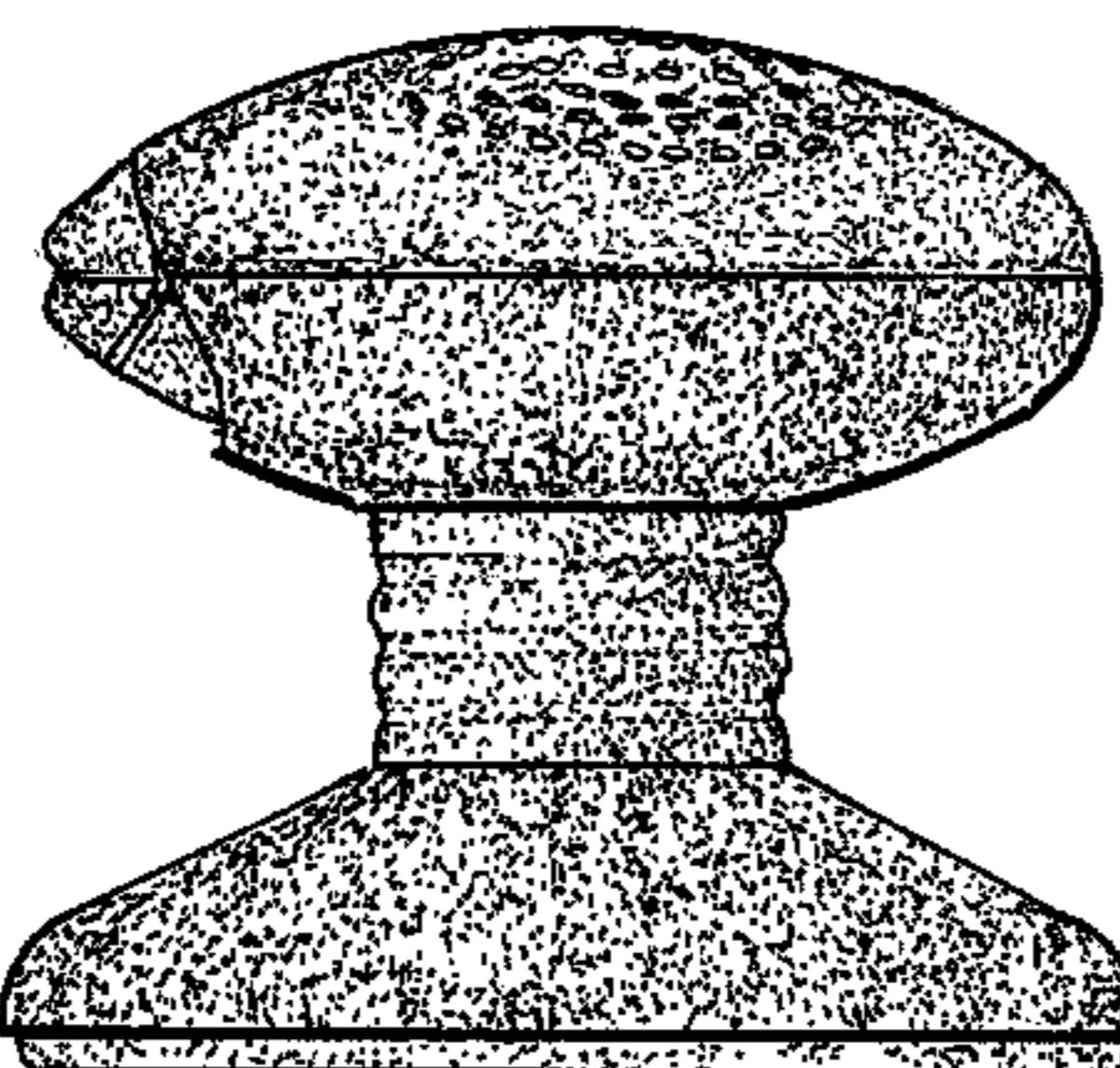
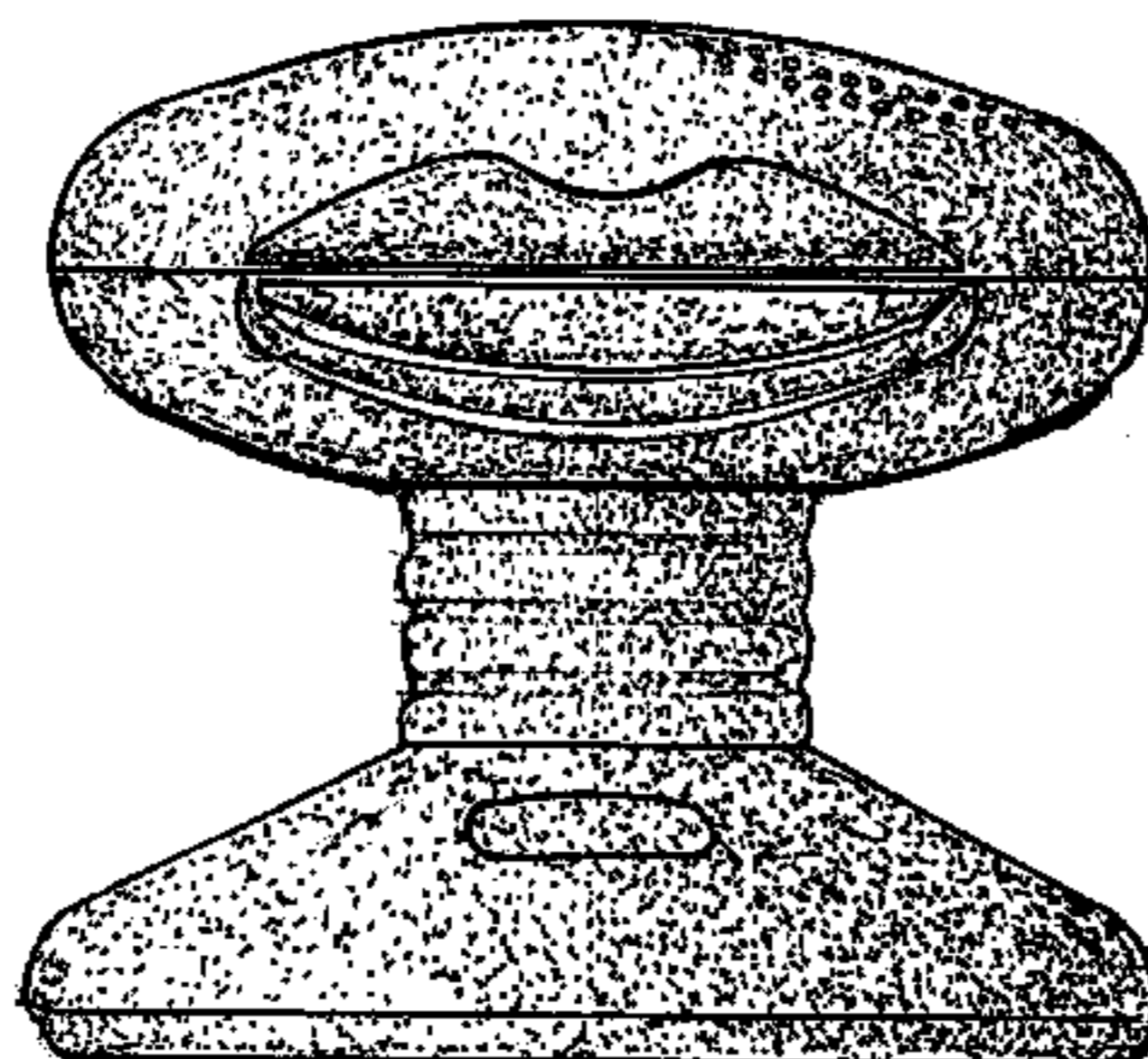

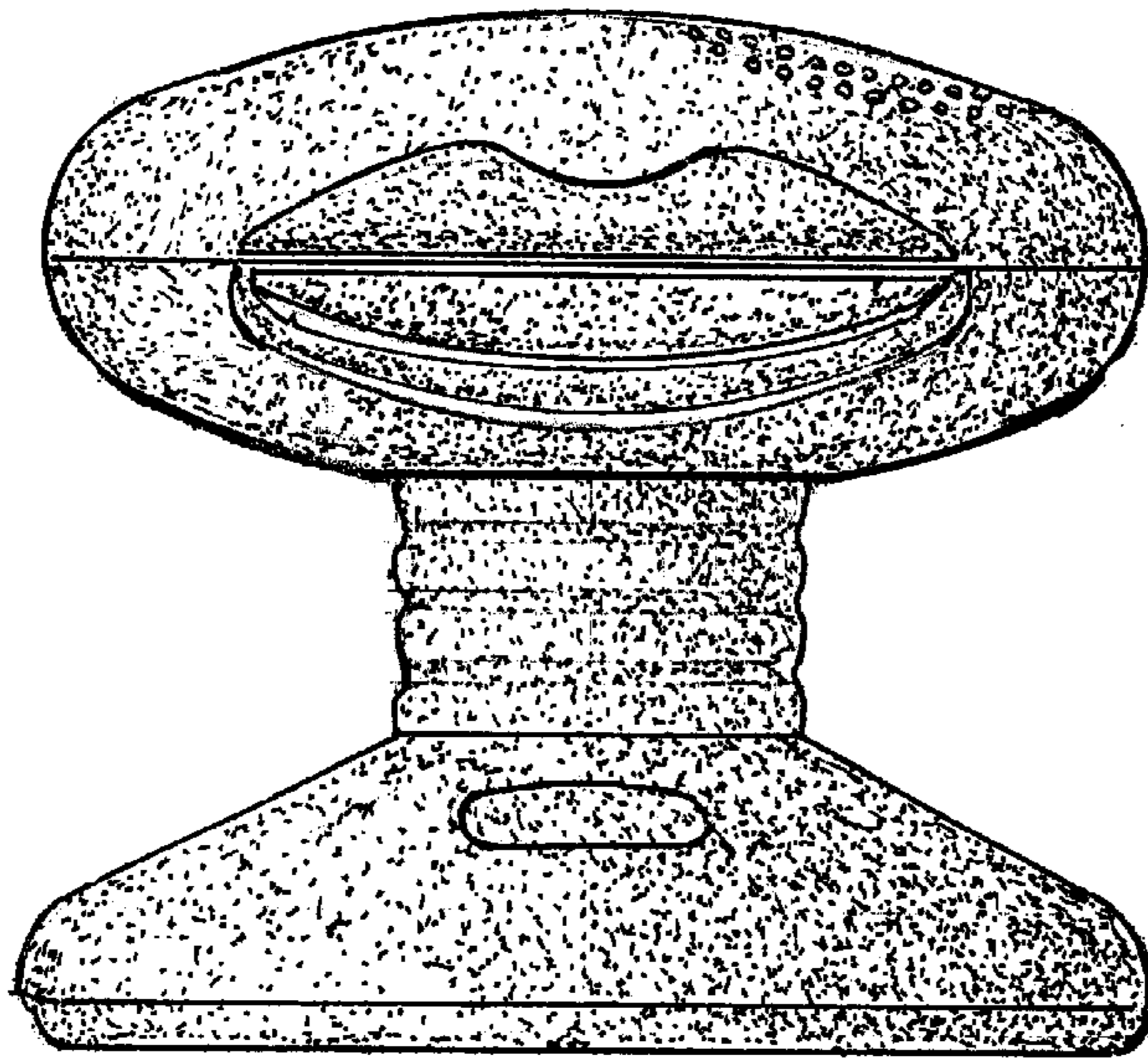

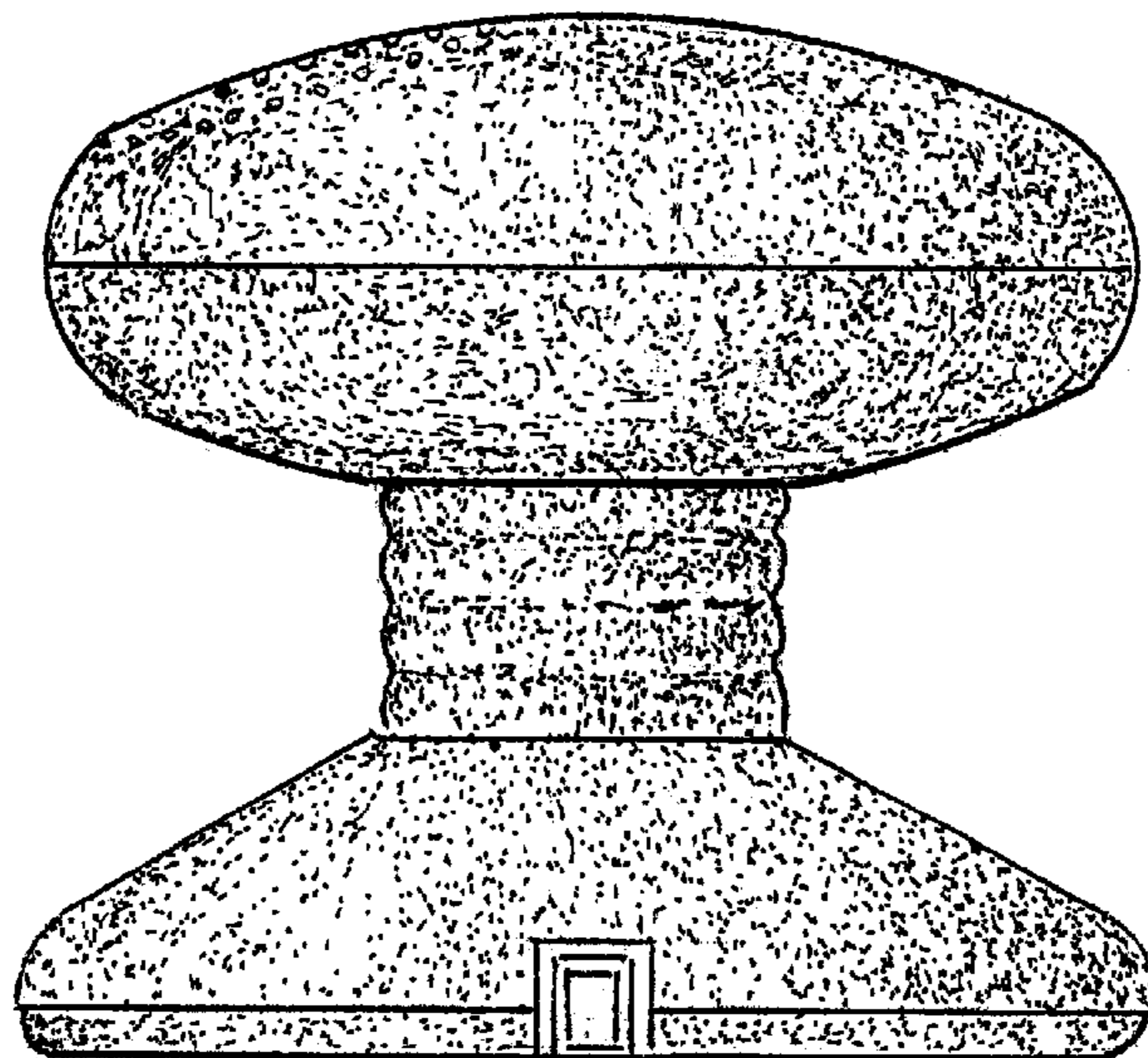

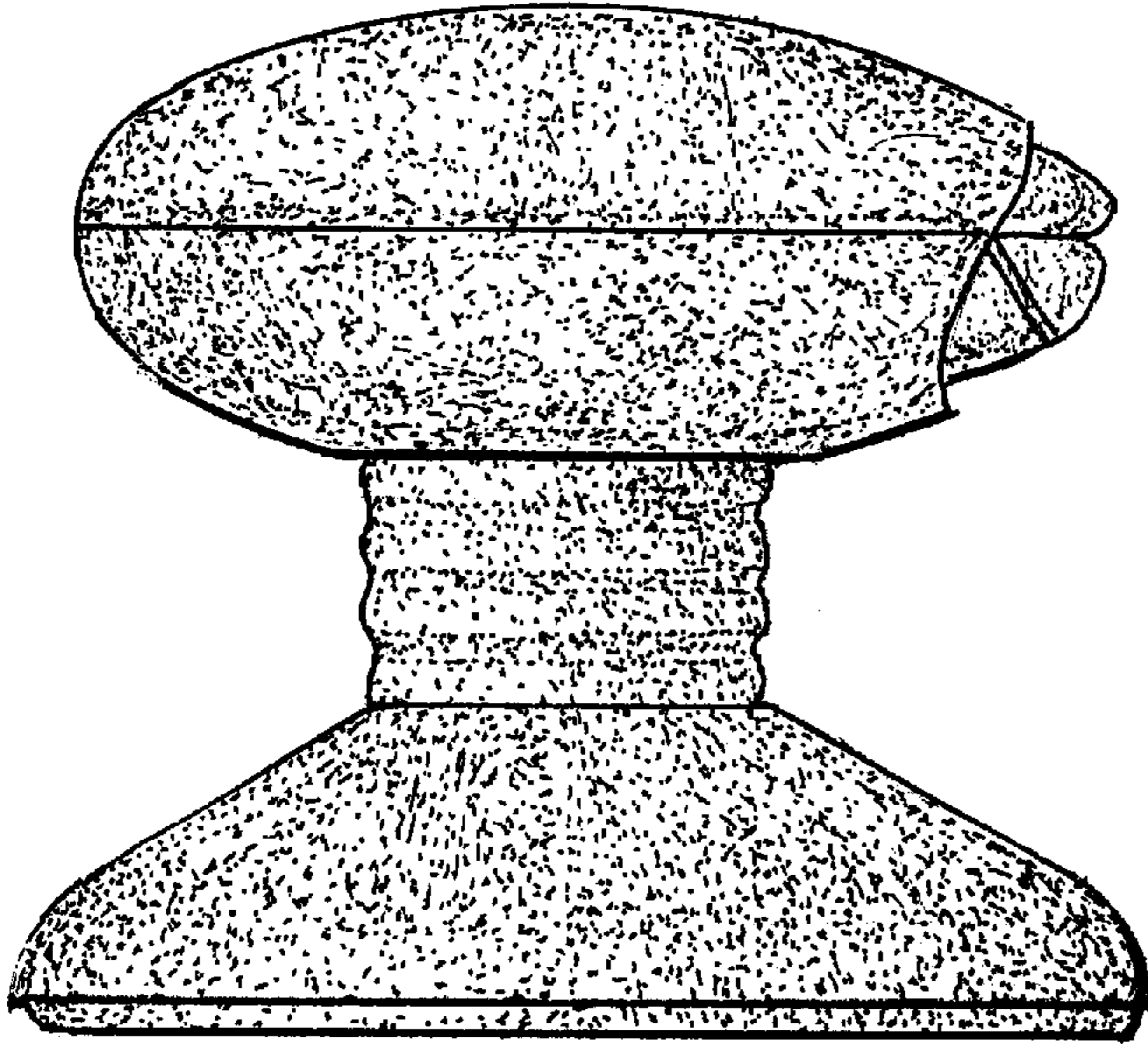
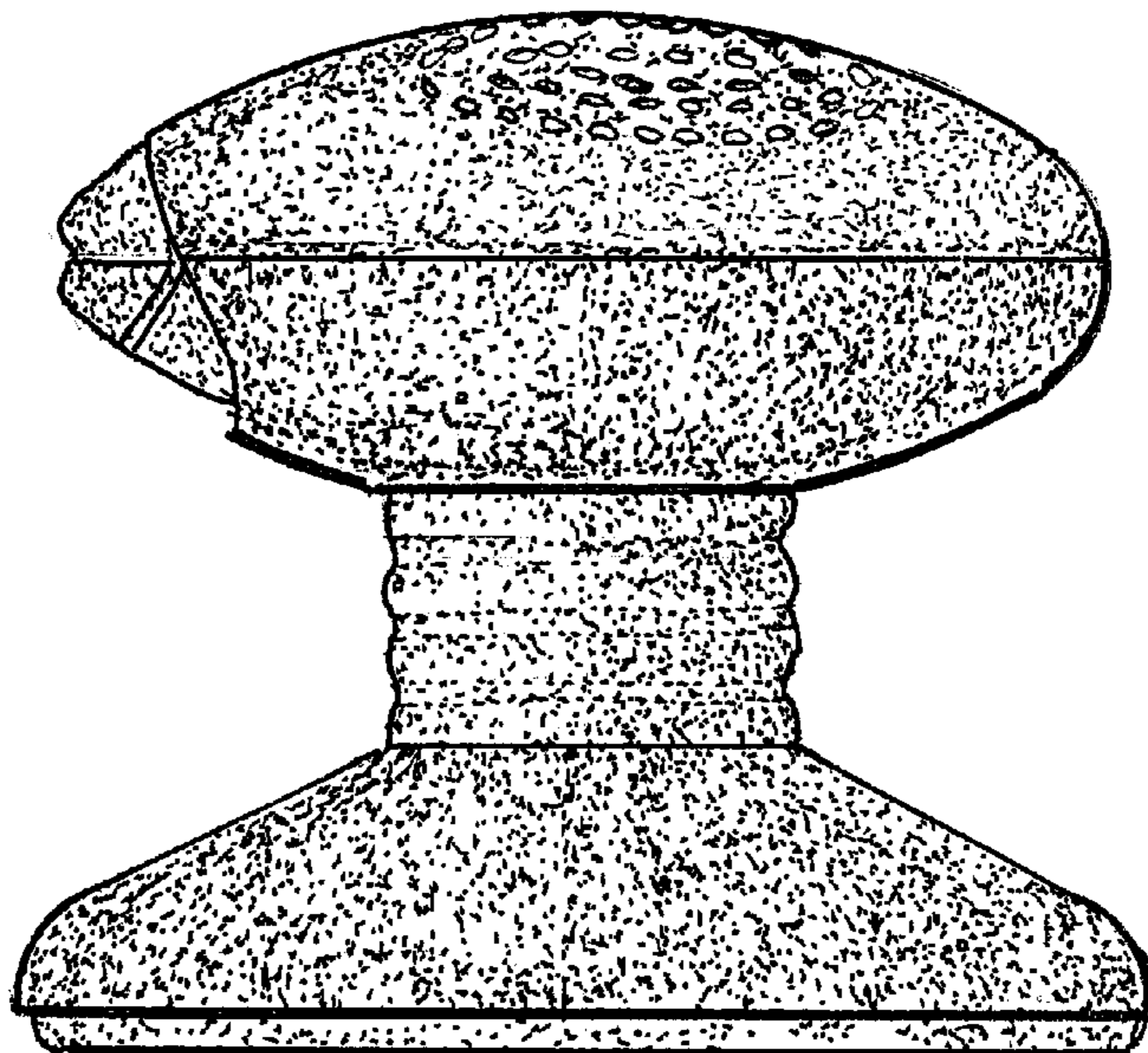

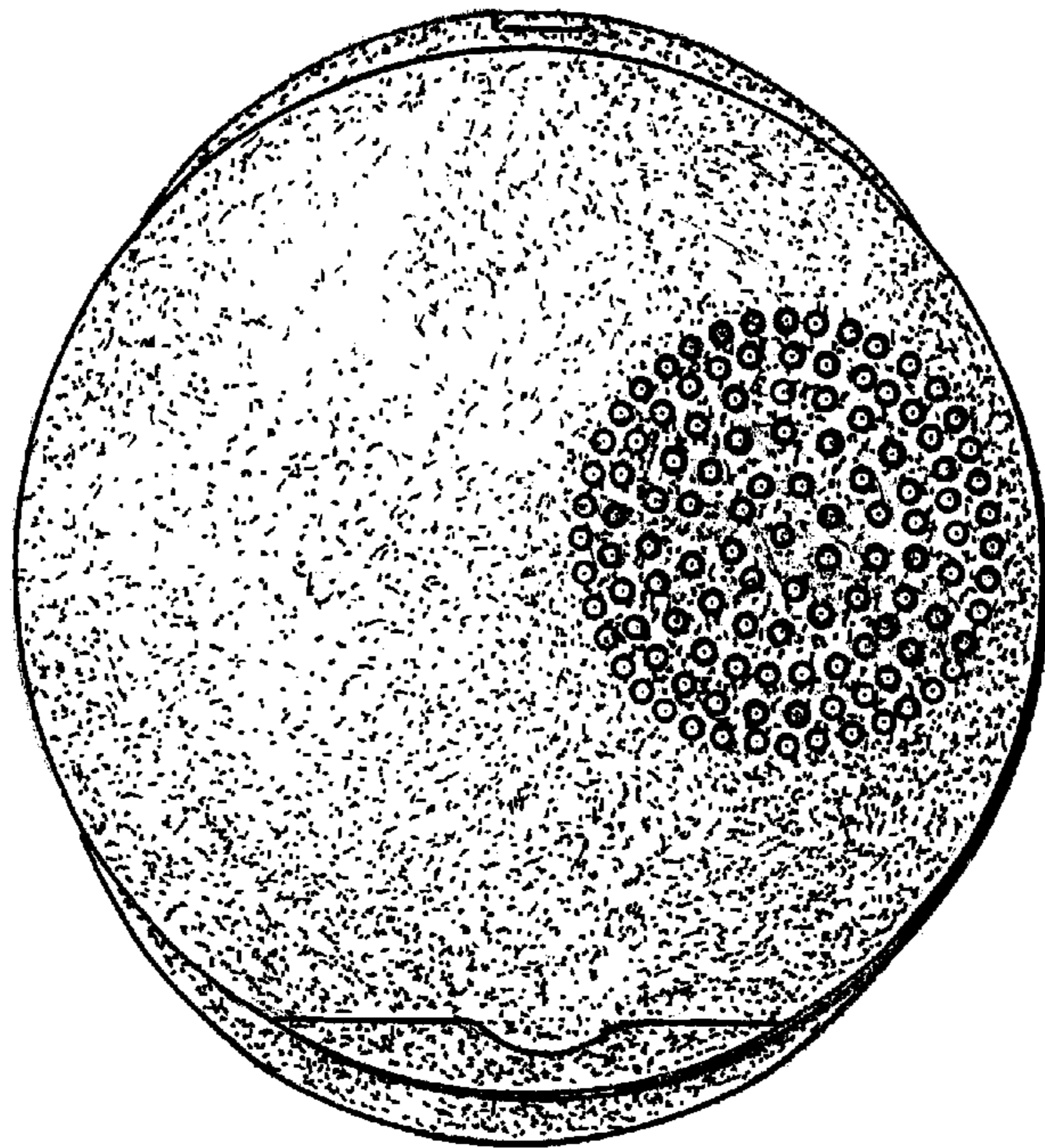
