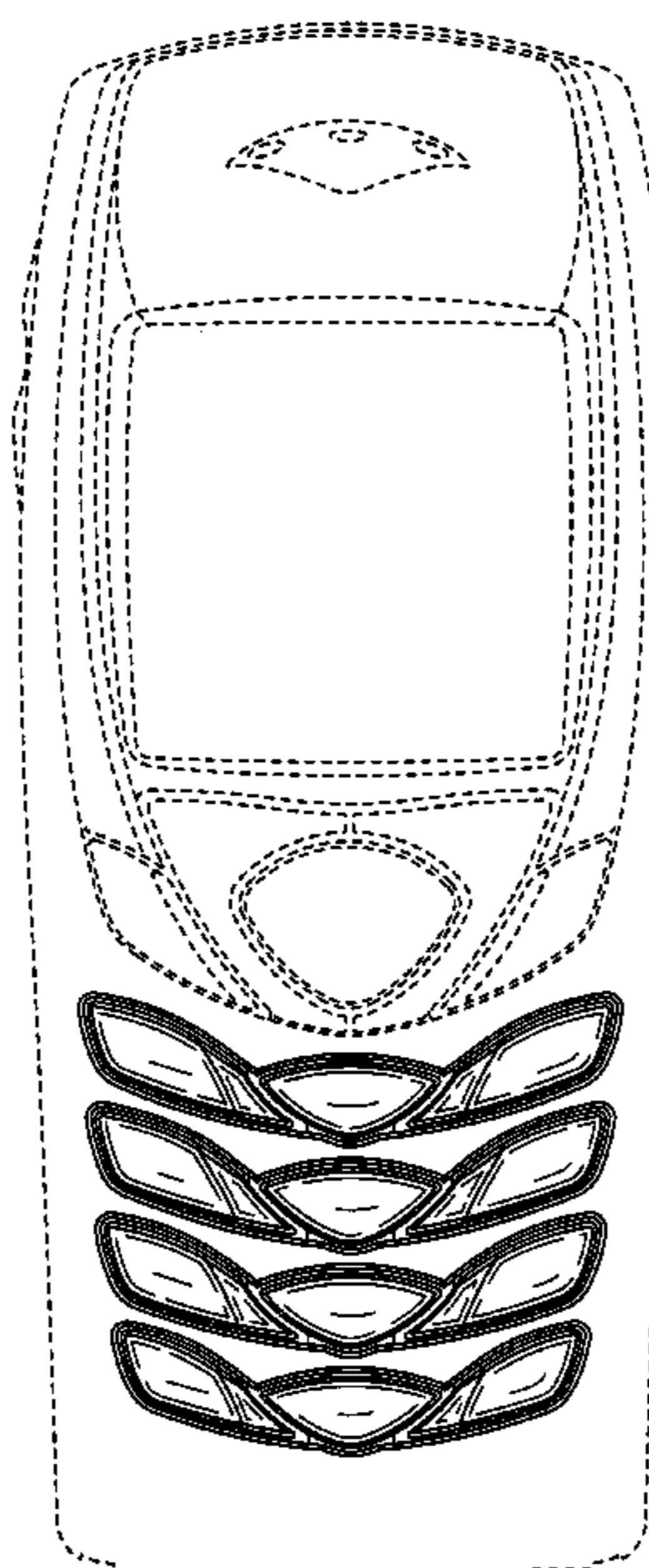
(57) **CLAIM**

The ornamental design of a key button arrangement for a handset, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a key button arrangement for a handset showing our new design; and, FIG. 2 is a perspective view thereof. The uneven broken line showing of the remainder of the handset and keypad in FIGS. 1 and 2 is for illustrative purposes only and forms no part of the claimed design.

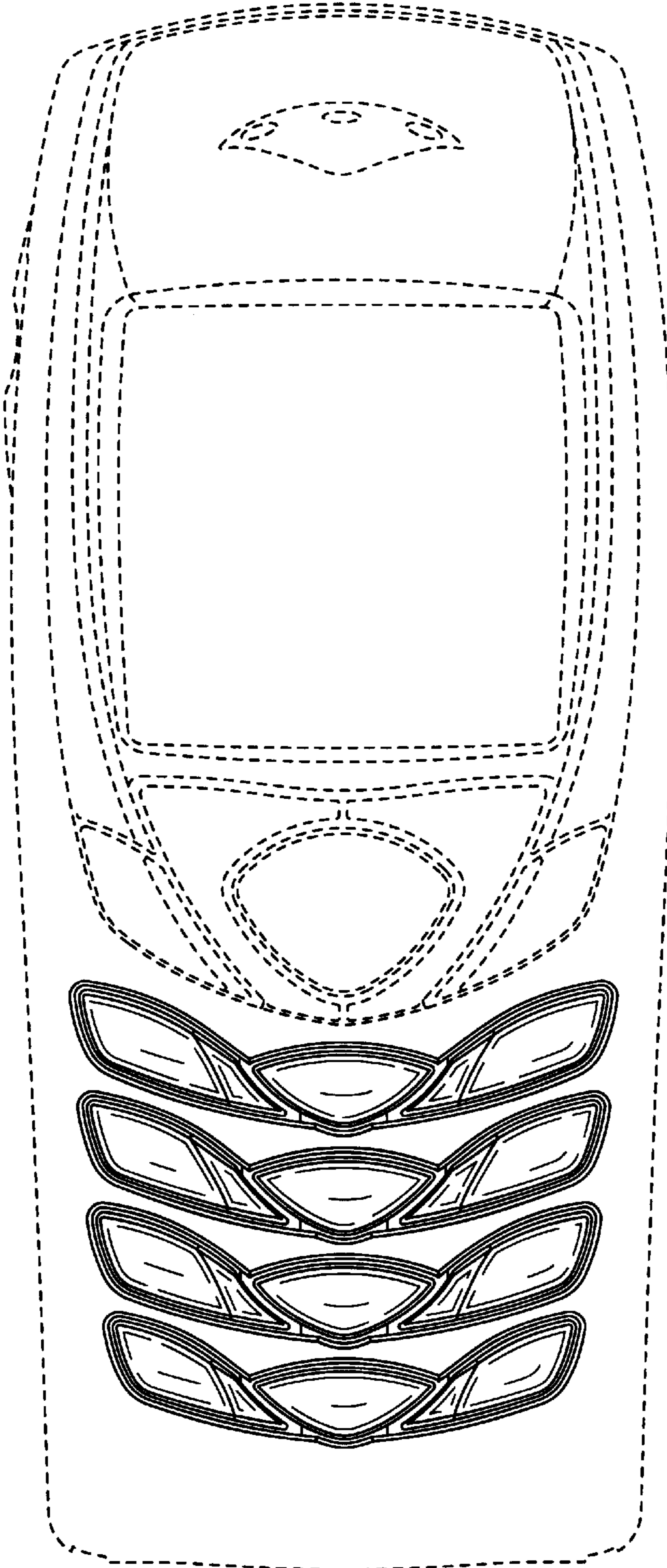

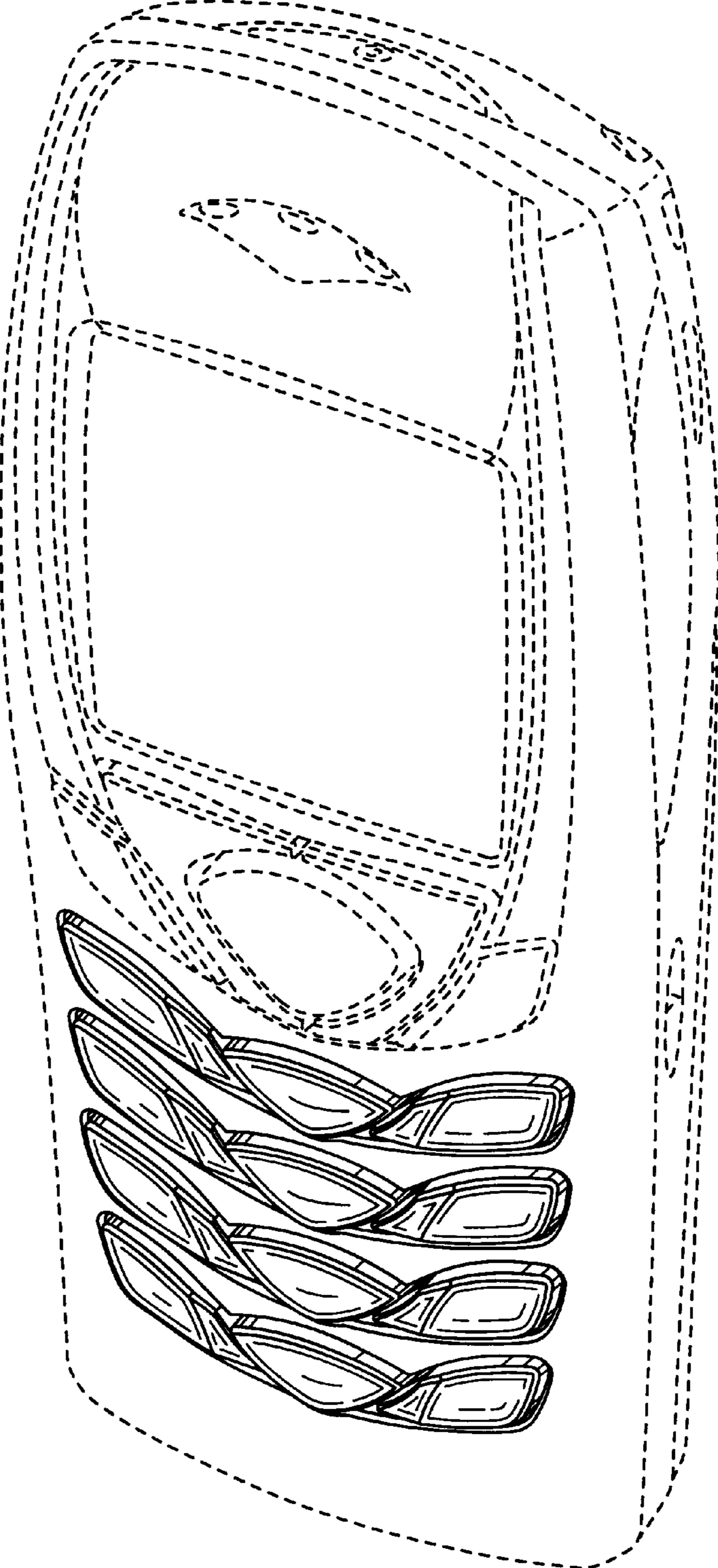
