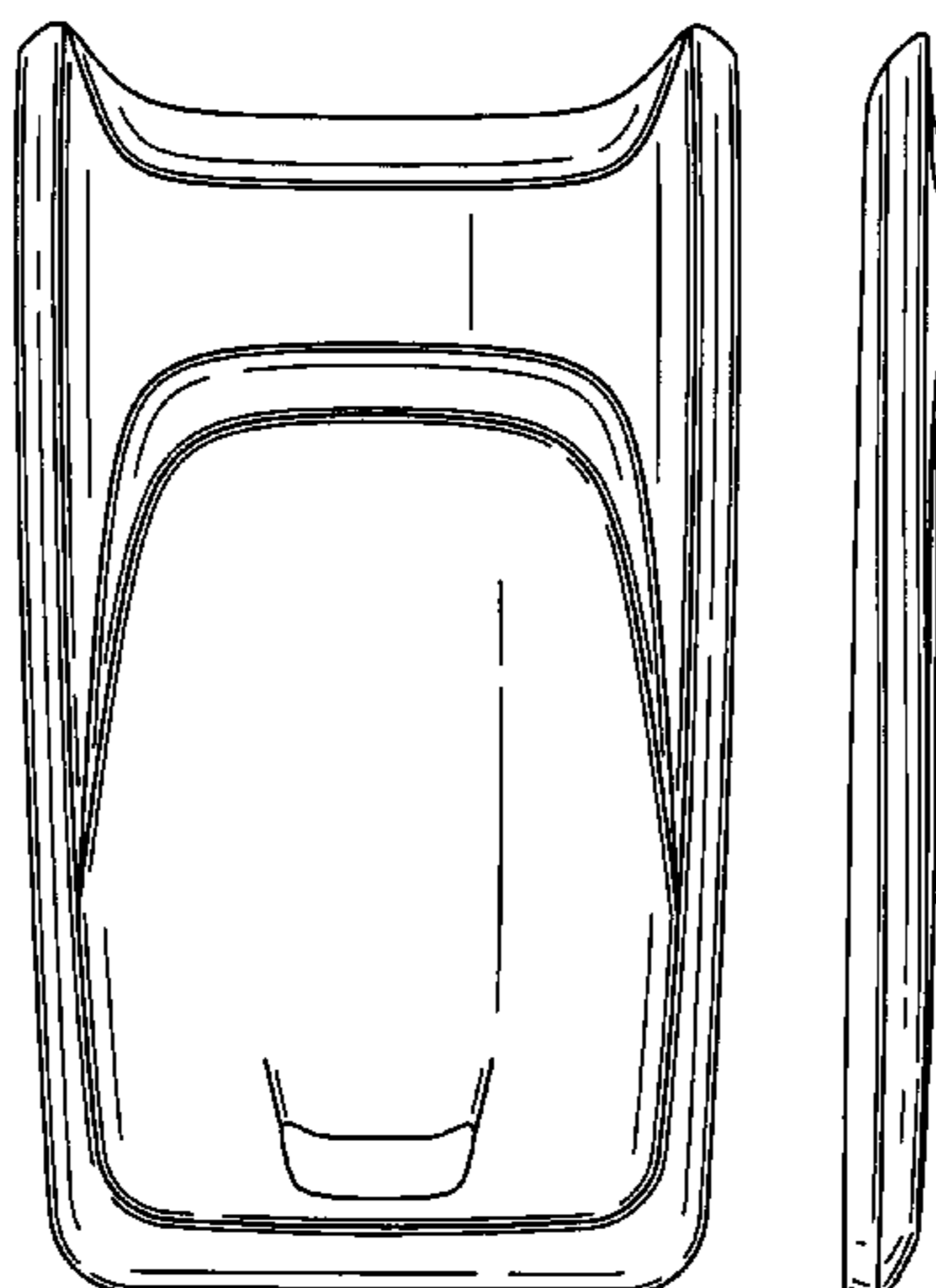

 FIG. 6 is a bottom plan view of a back cover for a handset in FIGS. 1-5 showing my new design in an environment of a handset;
 FIG. 7 is a right side view thereof;
 FIG. 8 is a front view thereof;
 FIG. 9 is a left side view thereof; and,
 FIG. 10 is a perspective front view thereof.

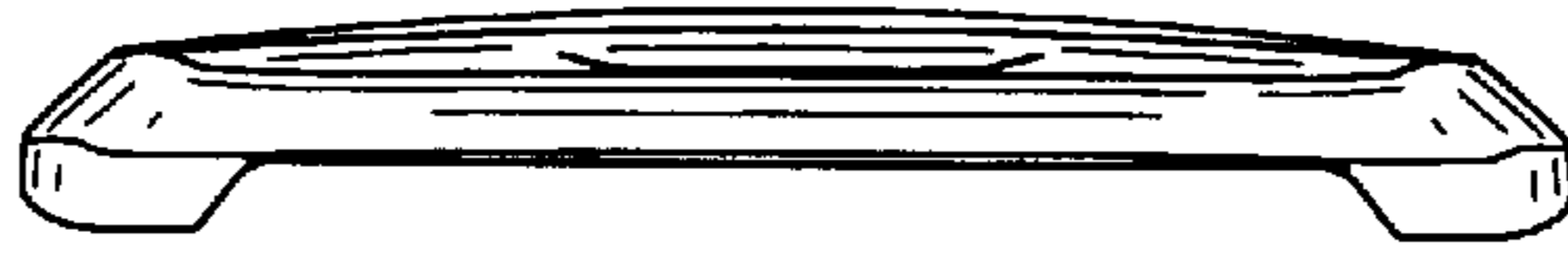

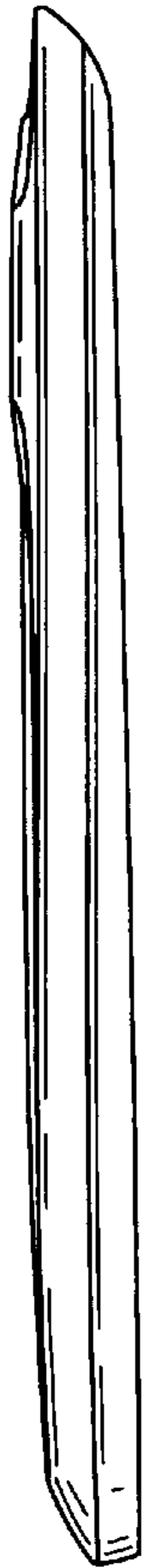

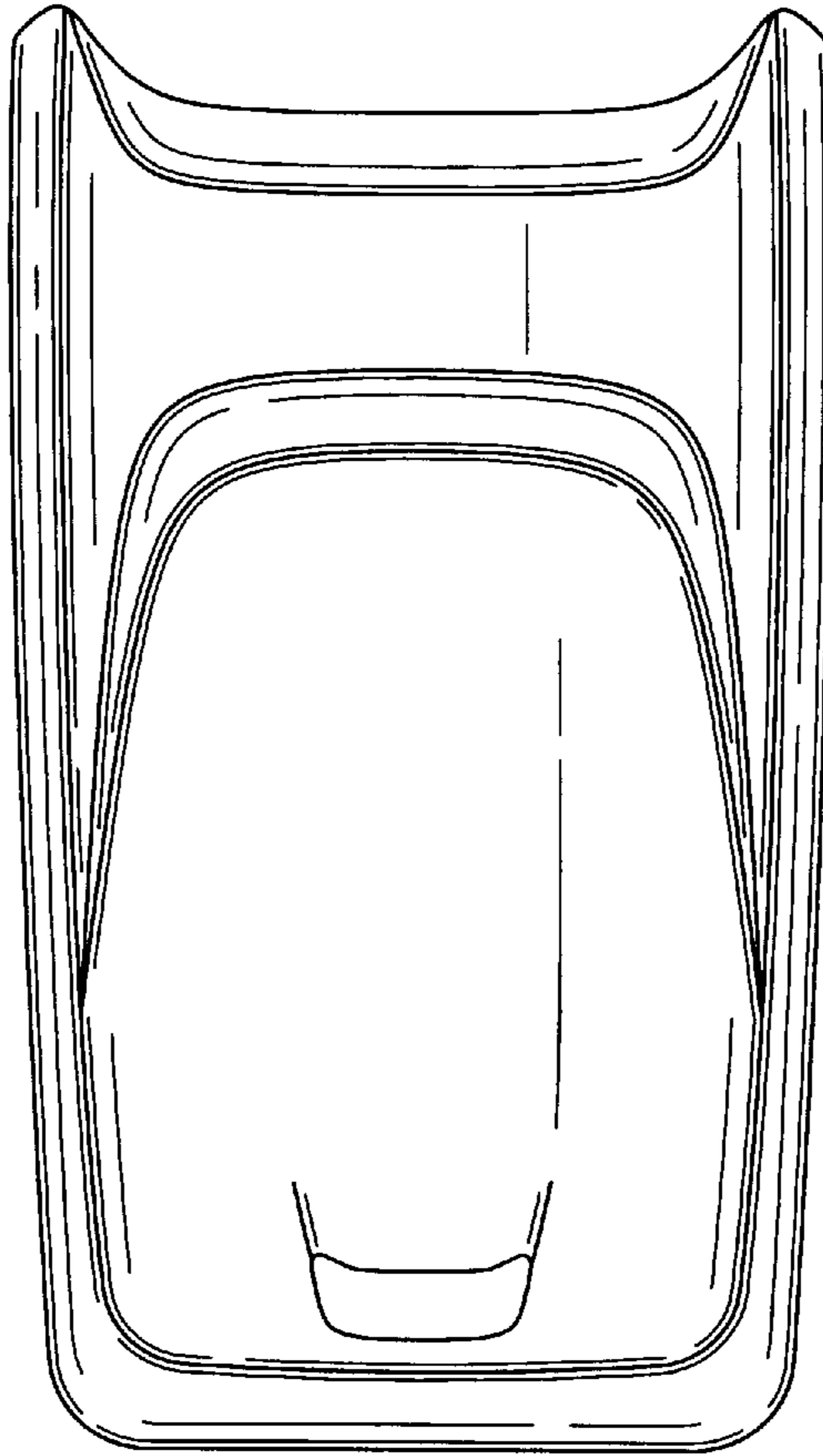

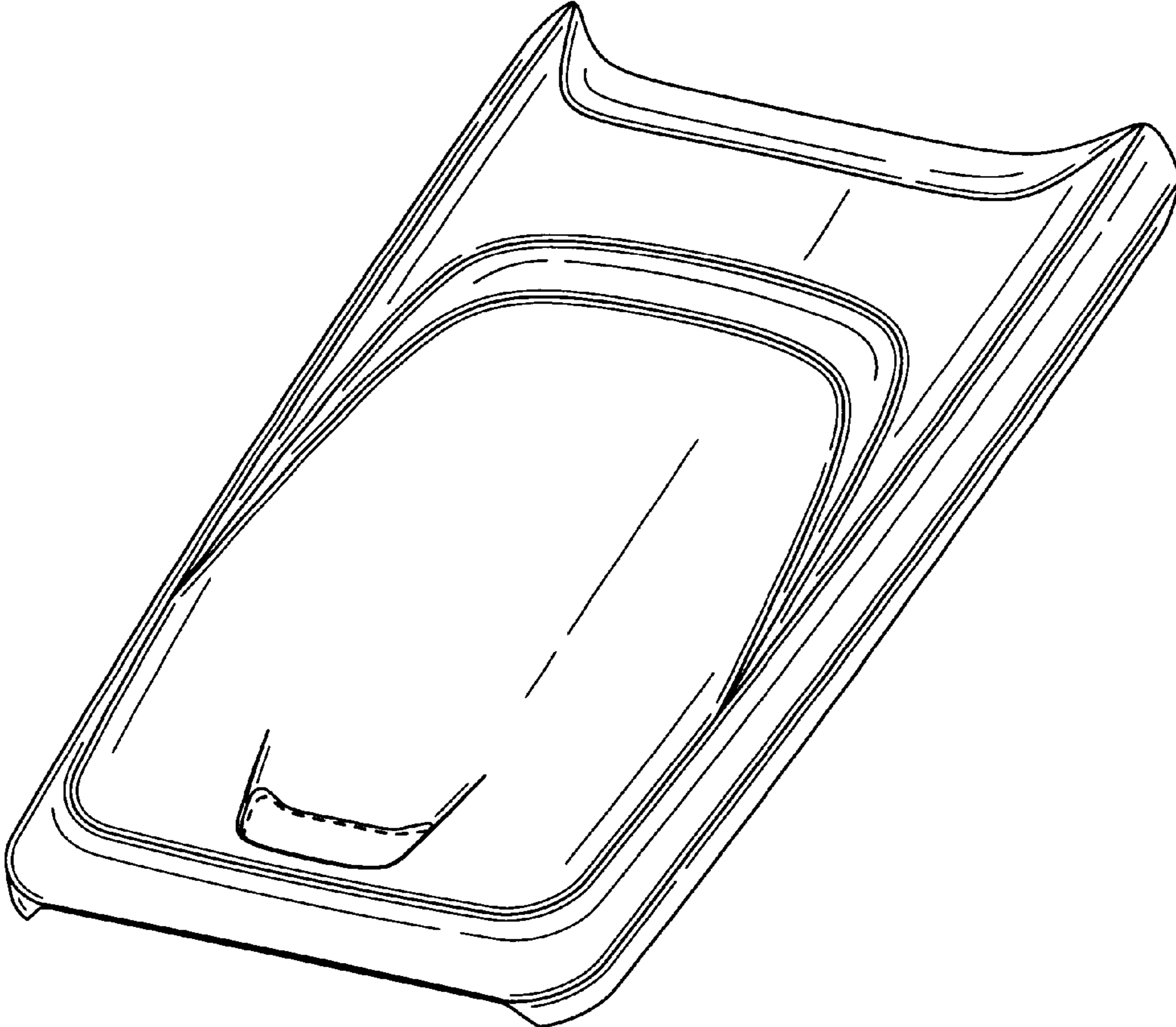

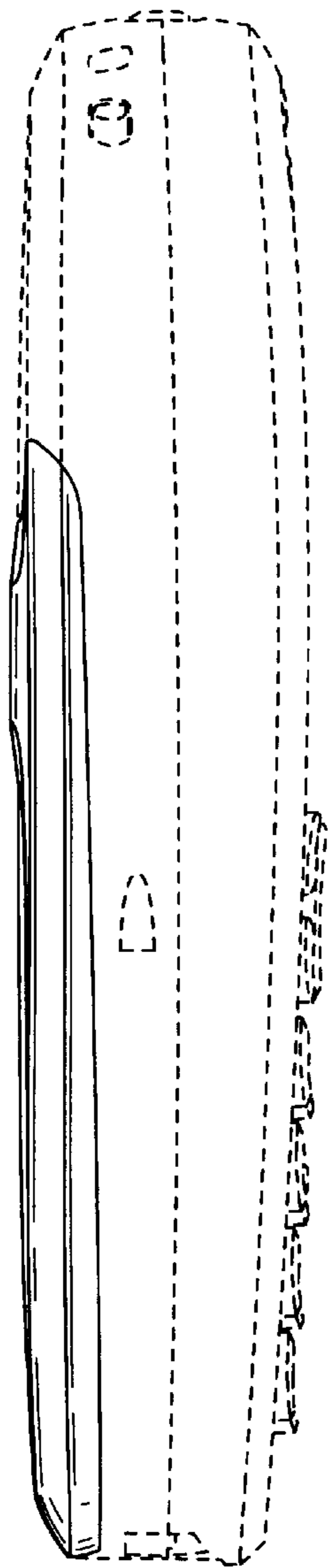
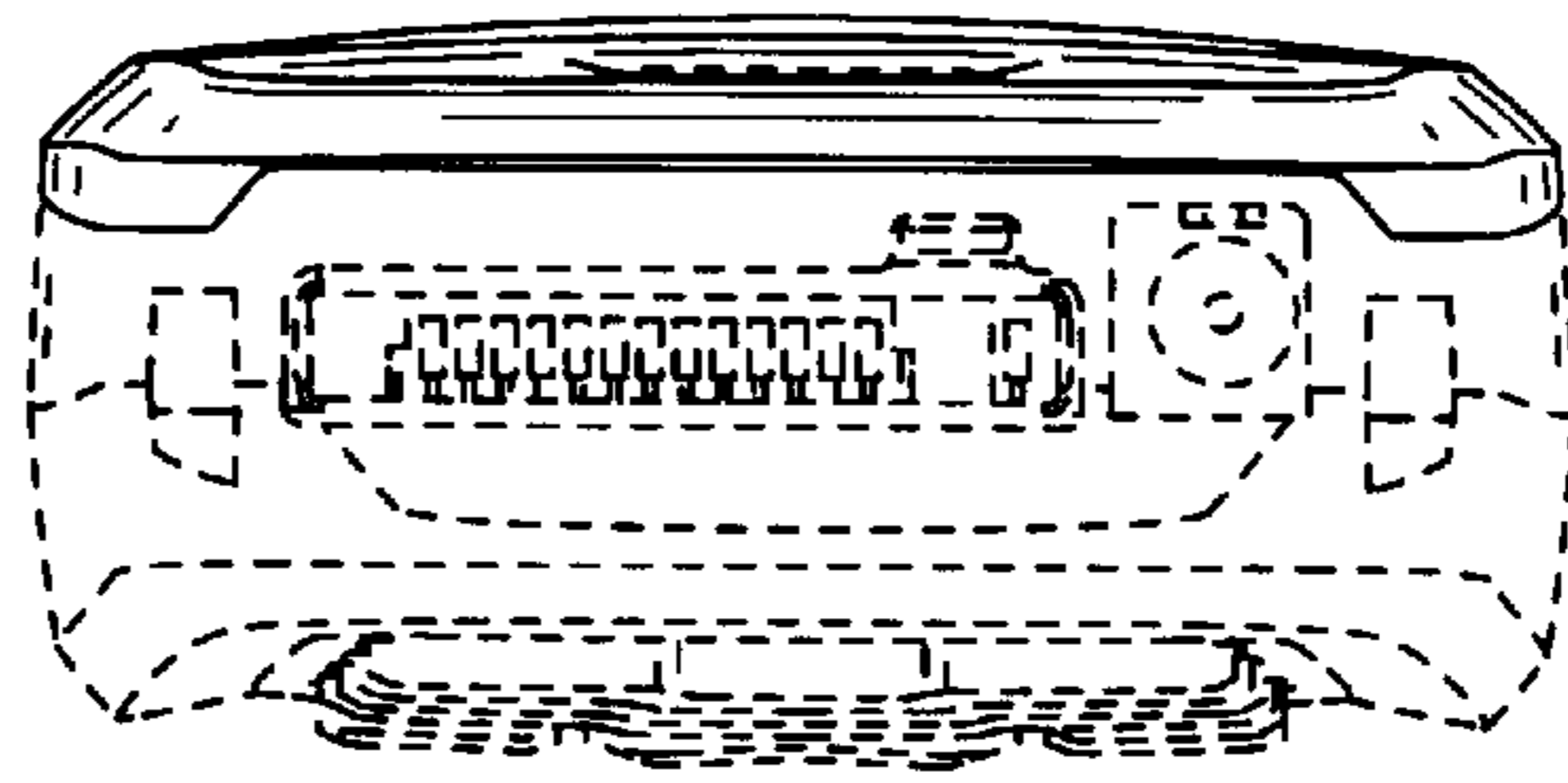

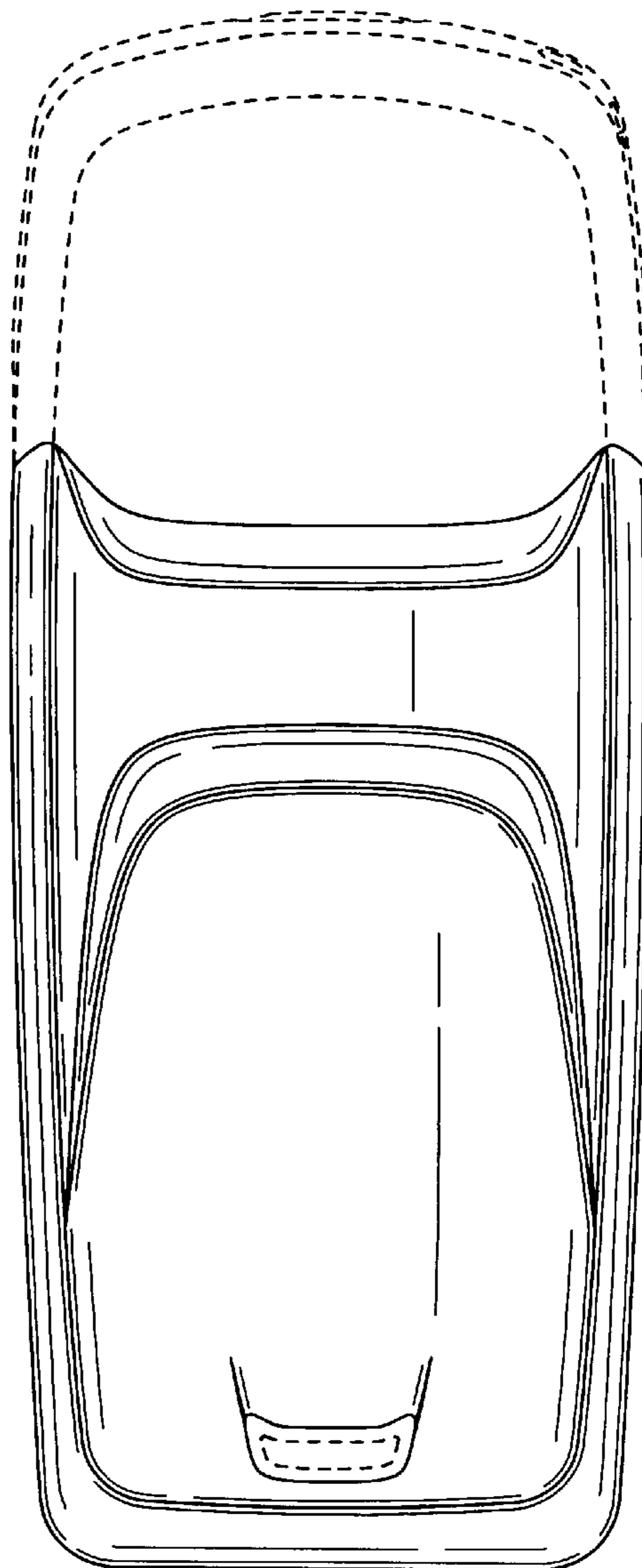

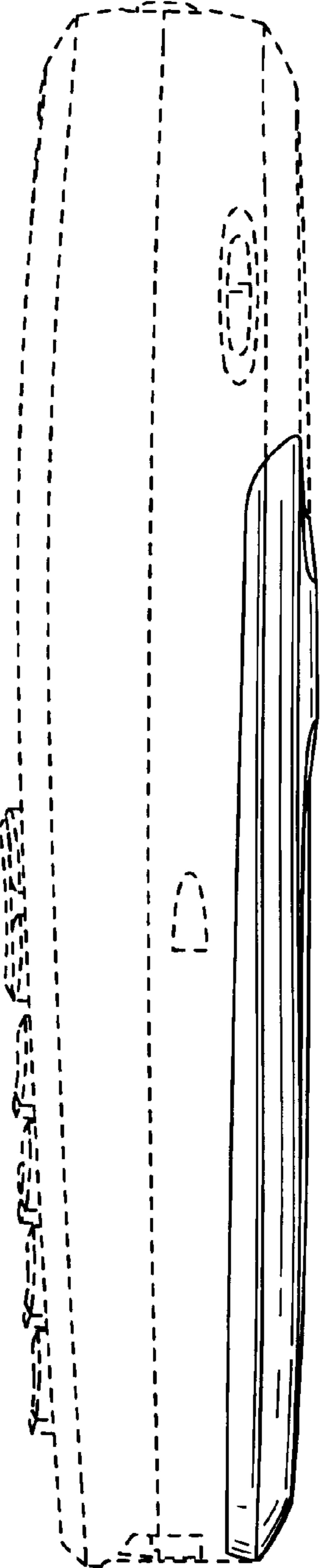

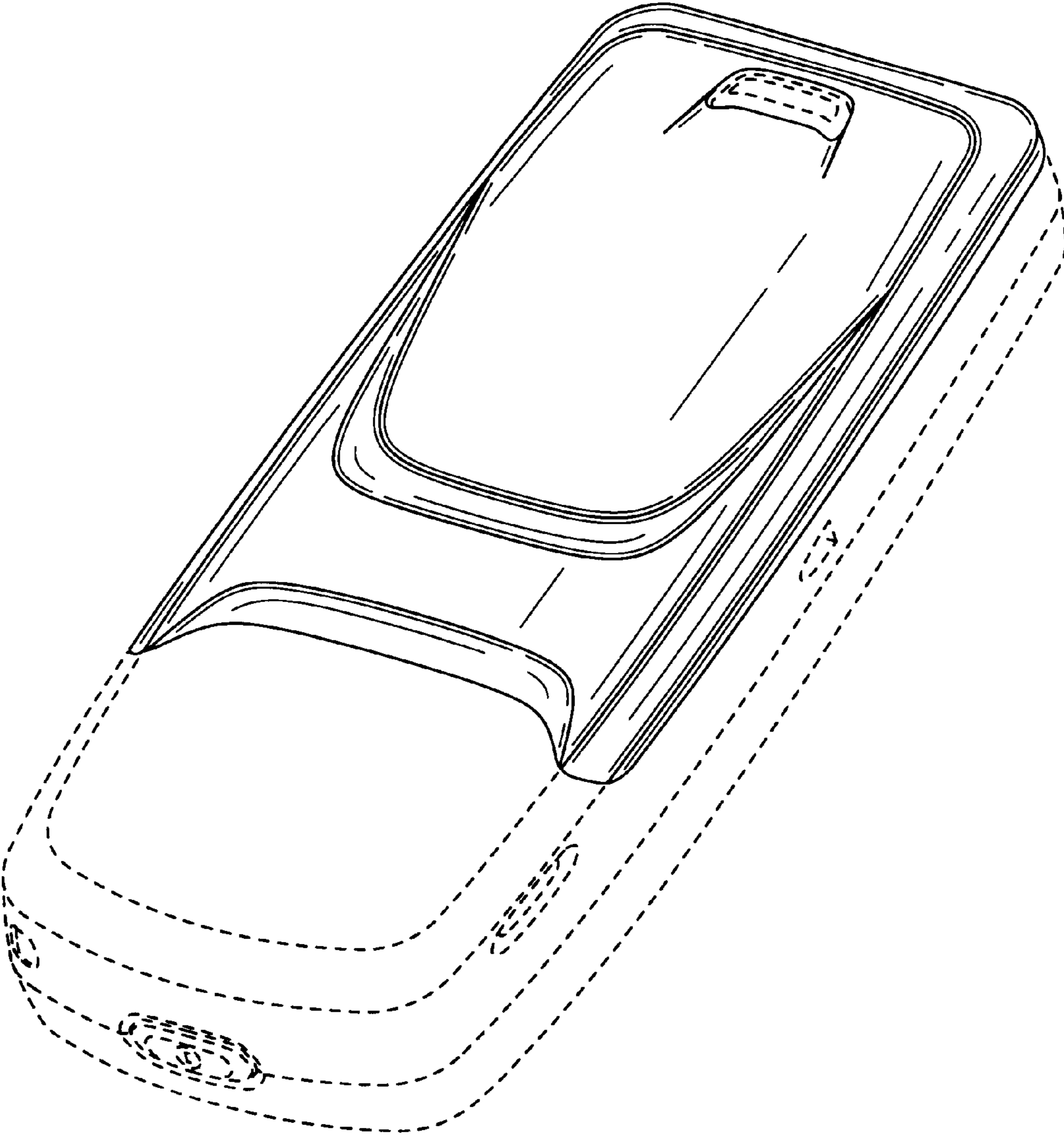
