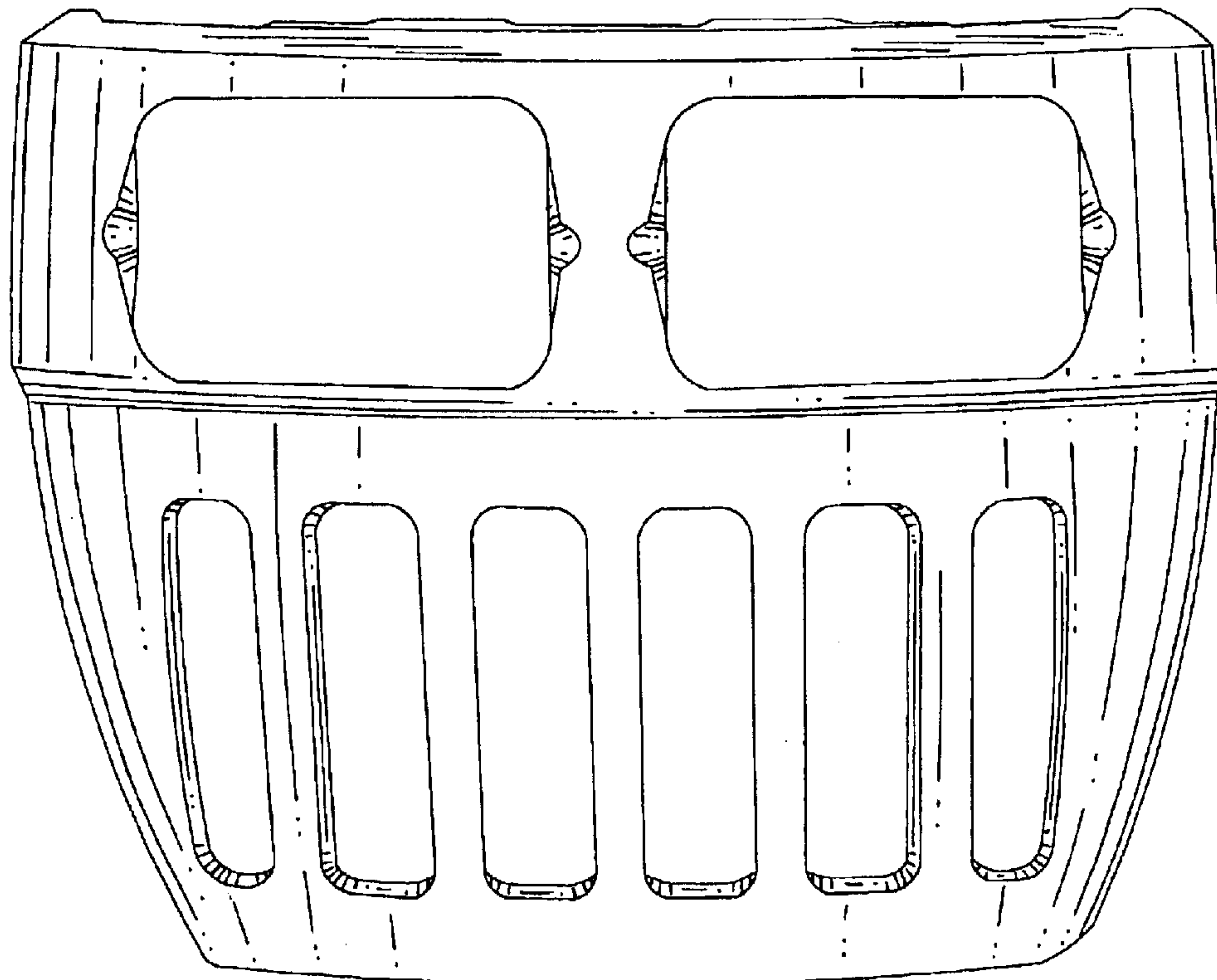
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of our new front grill of a tractor design;

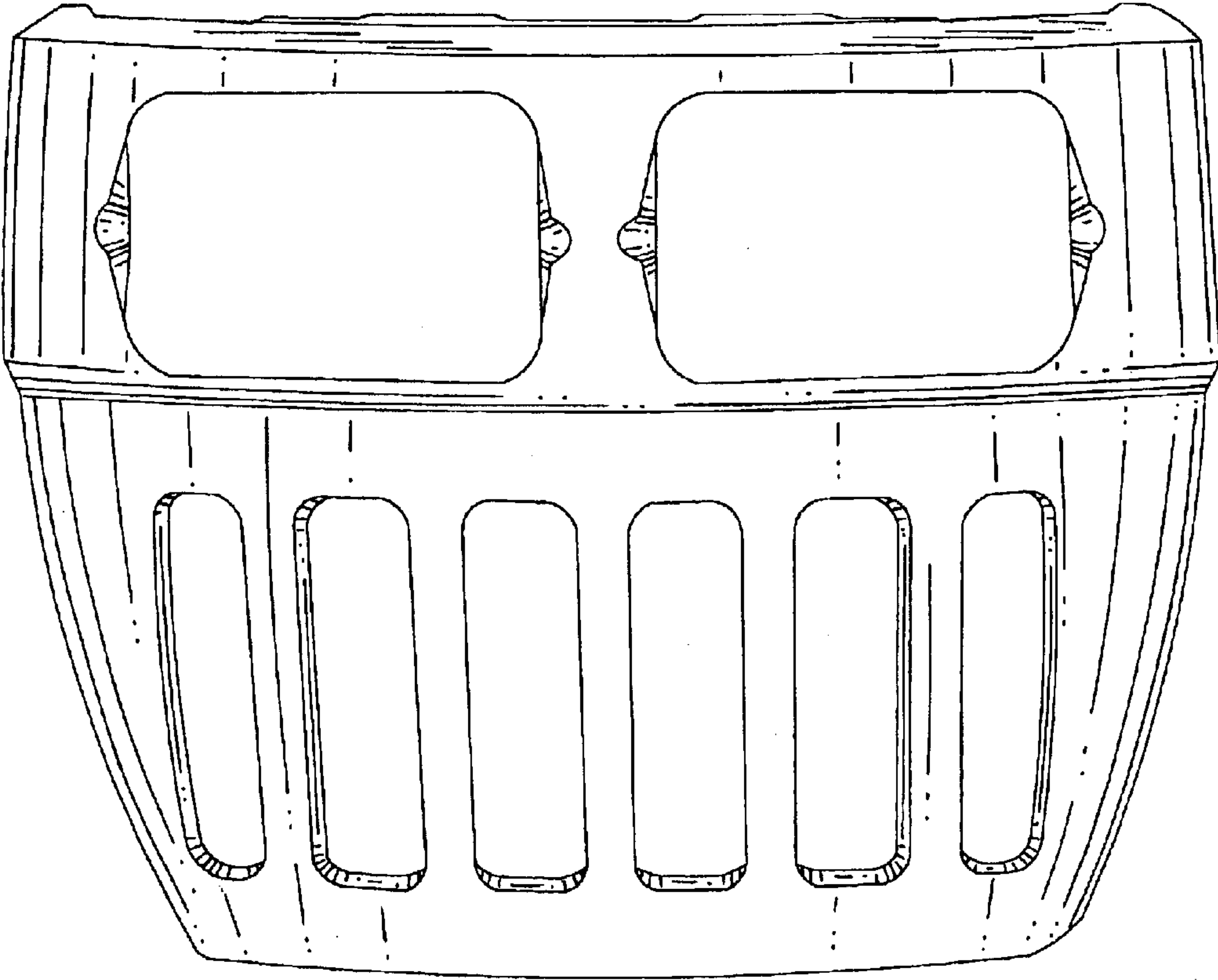

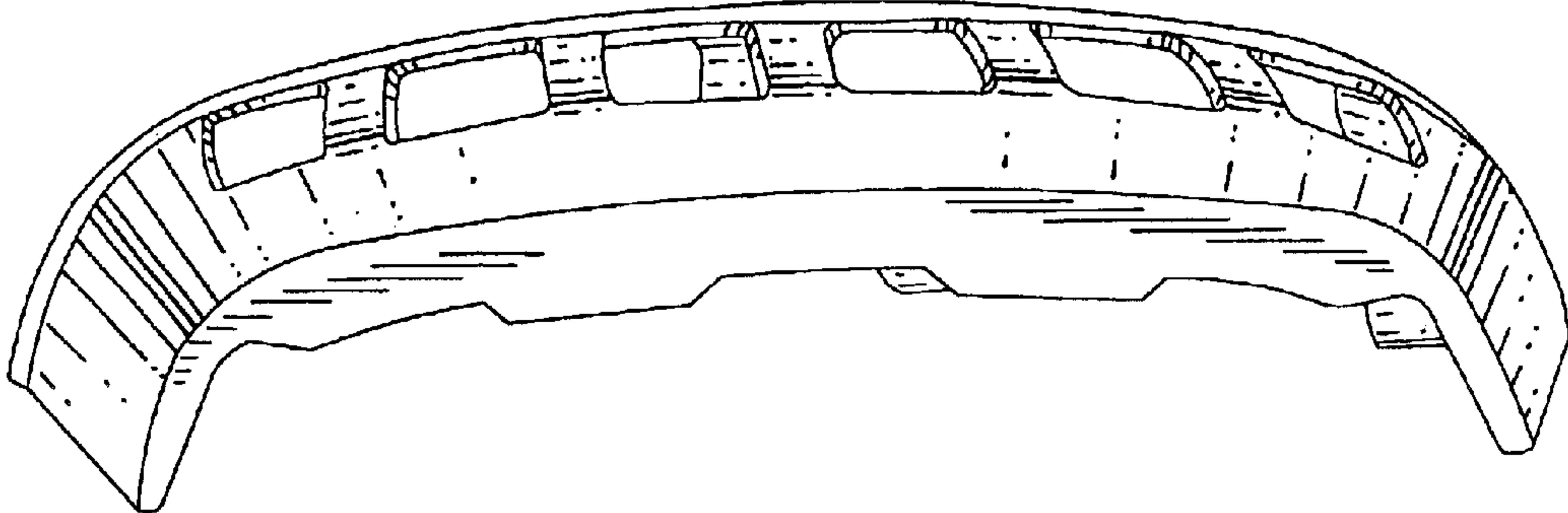

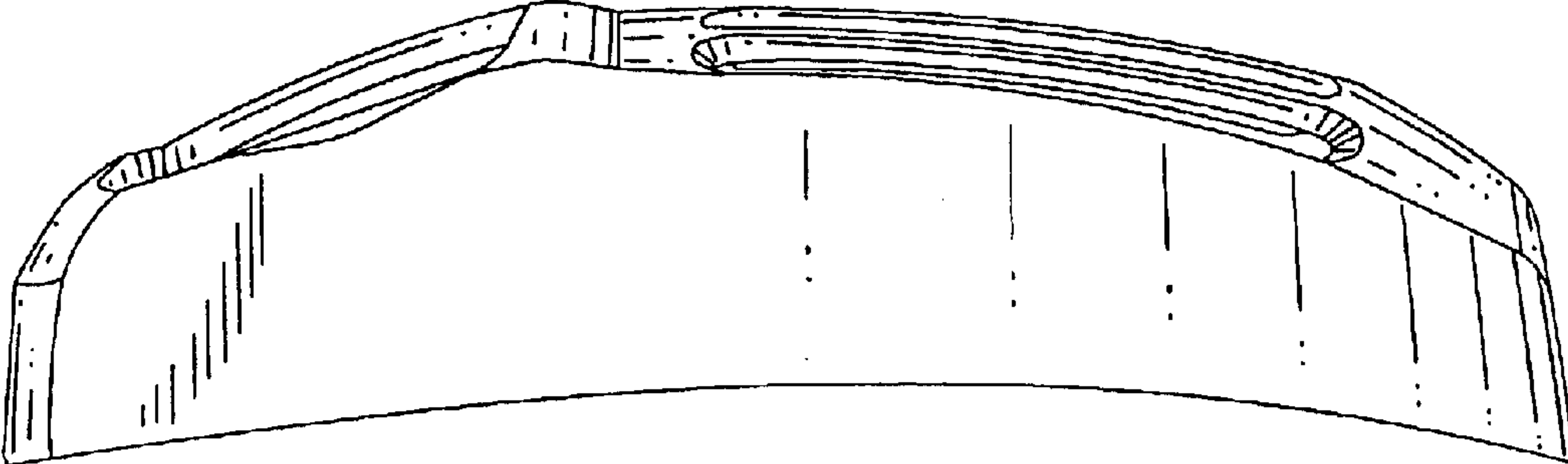
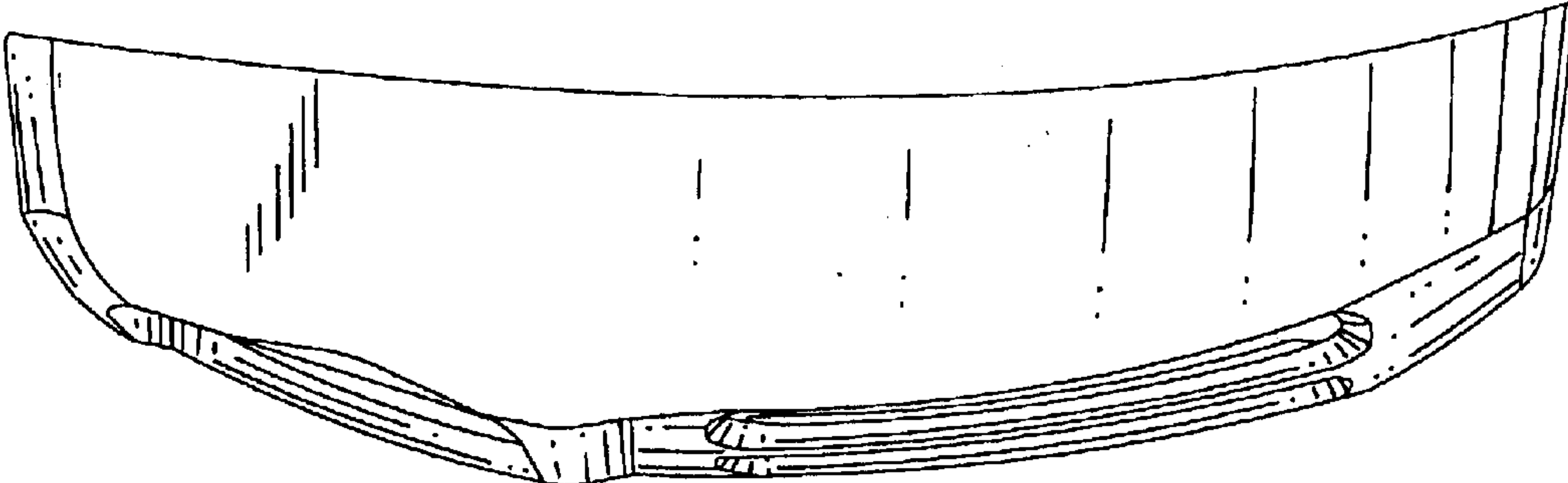

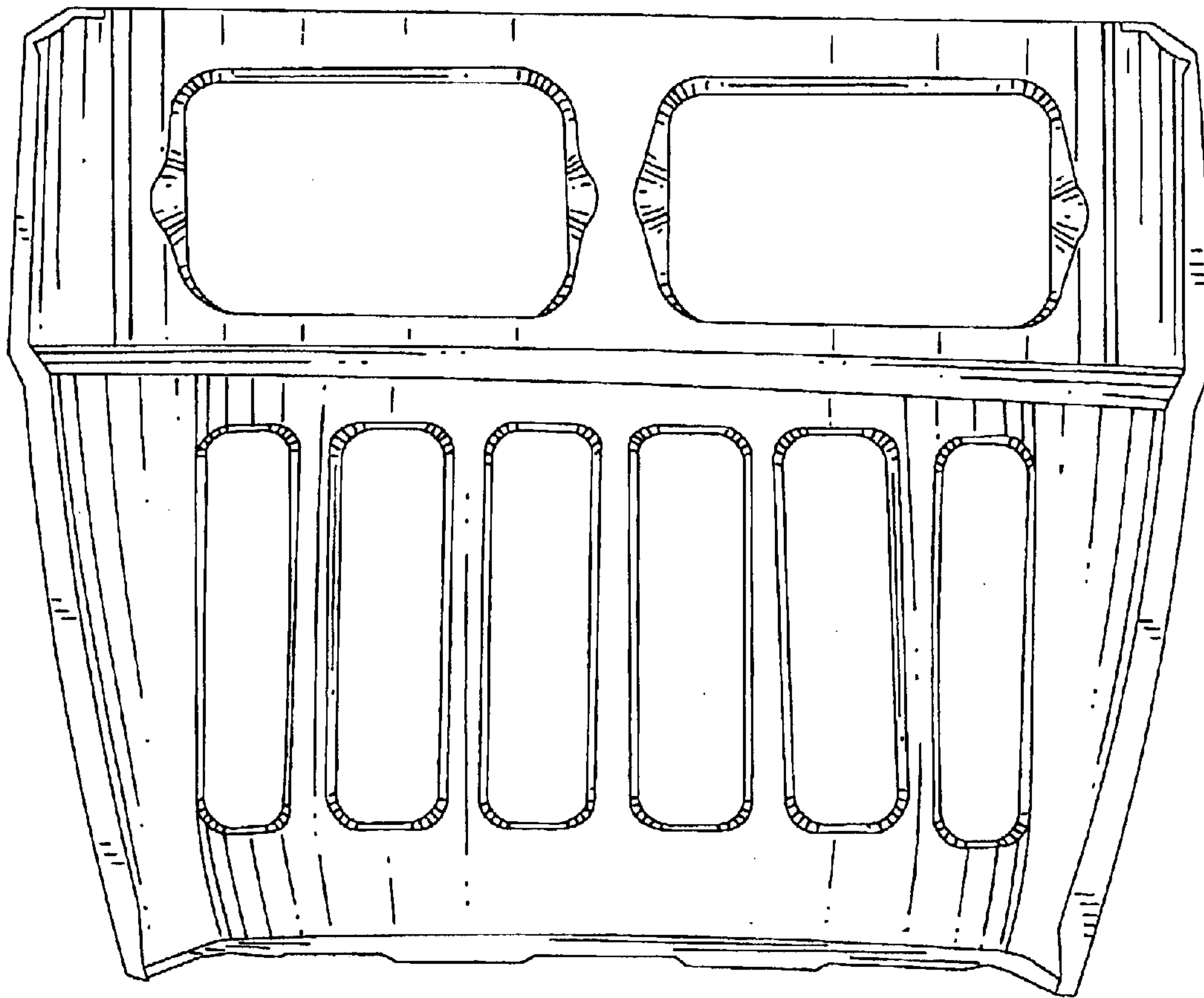

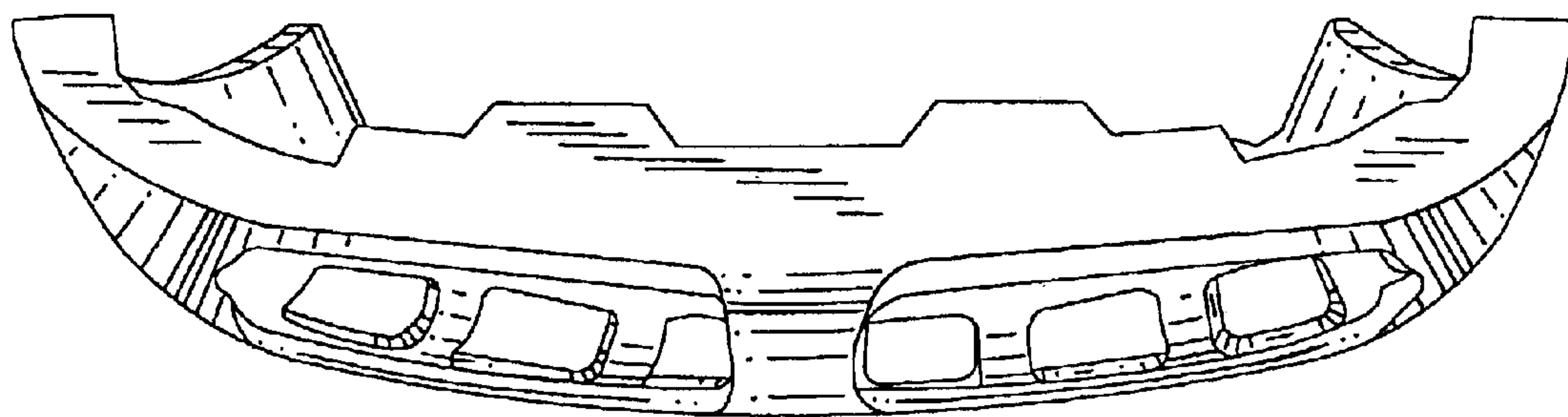
