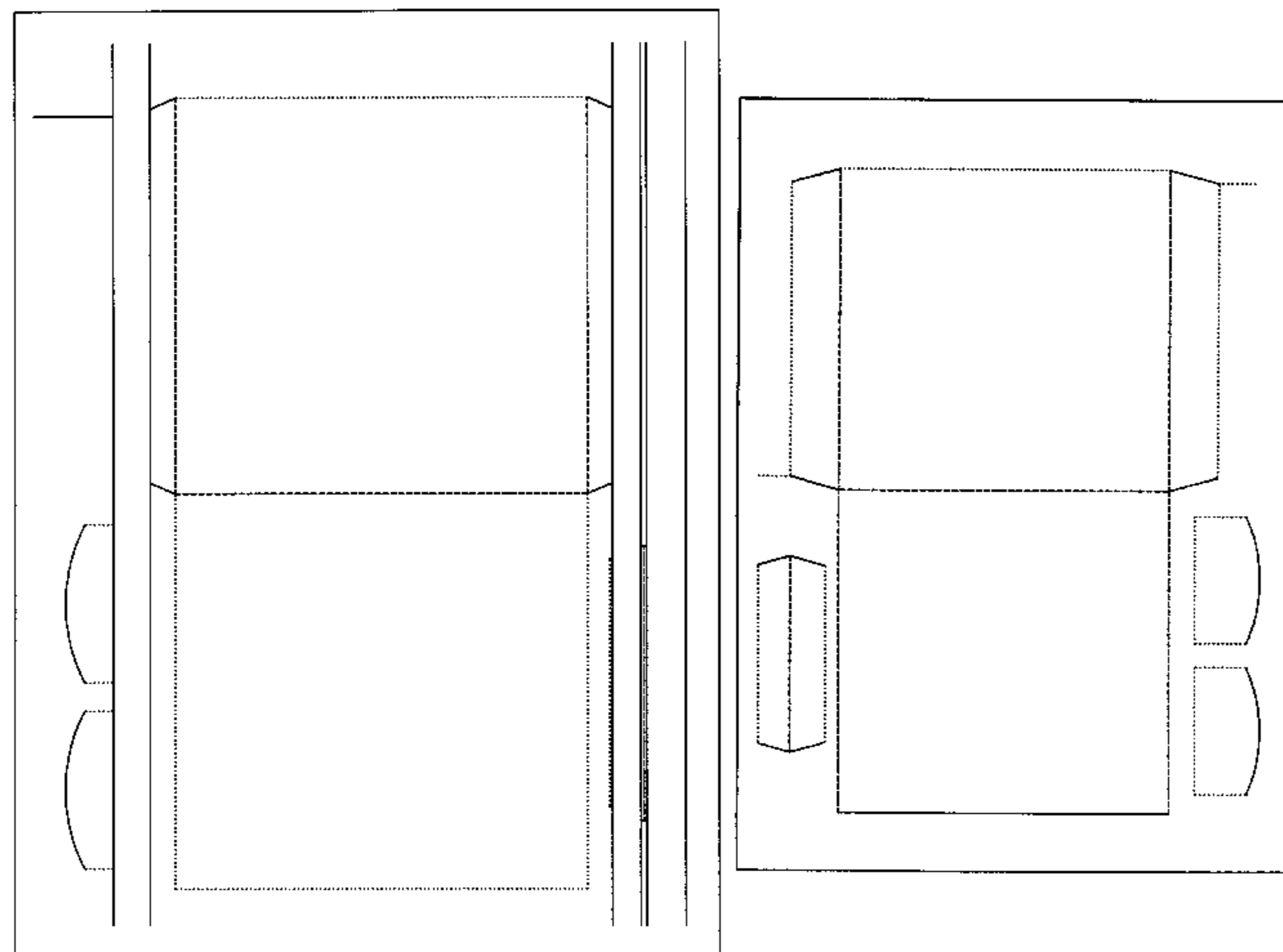
(57) **CLAIM**

The ornamental design for an adhesive perforated sheet for a printed CD wallet, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of an adhesive perforated sheet for a printed CD wallet showing our design; and, FIG. 2 is a bottom plan view of the sheet of FIG. 1.

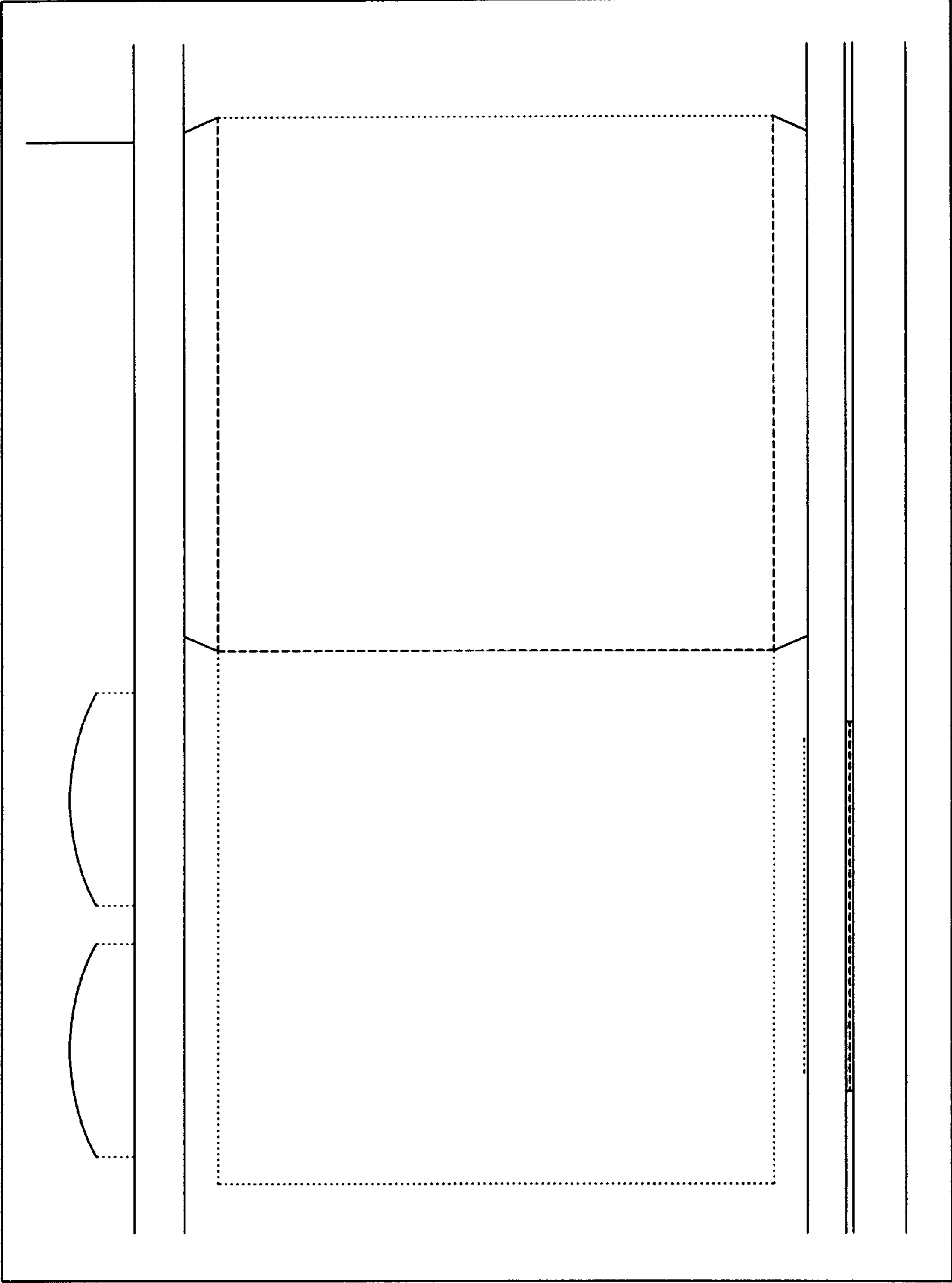

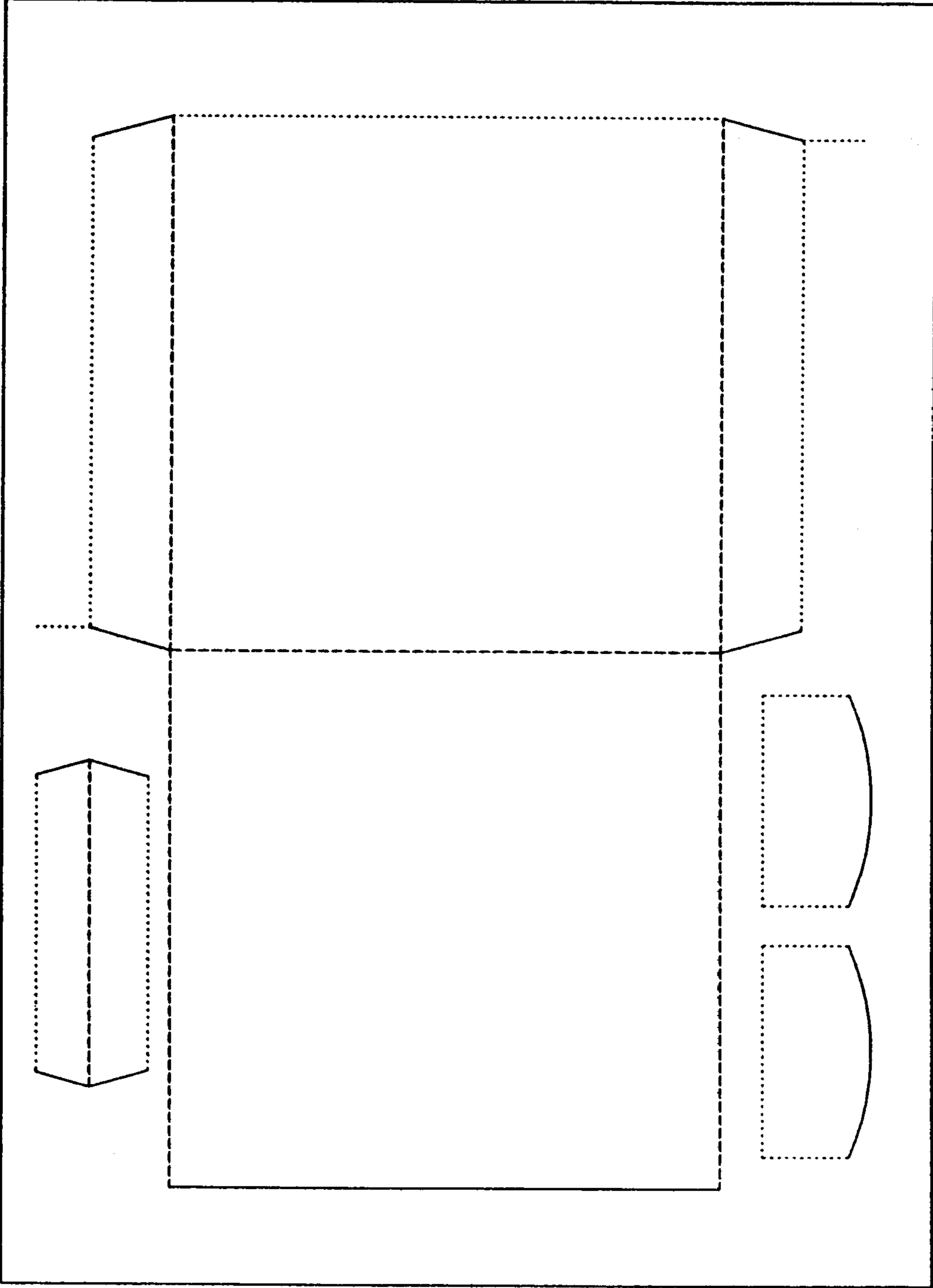
