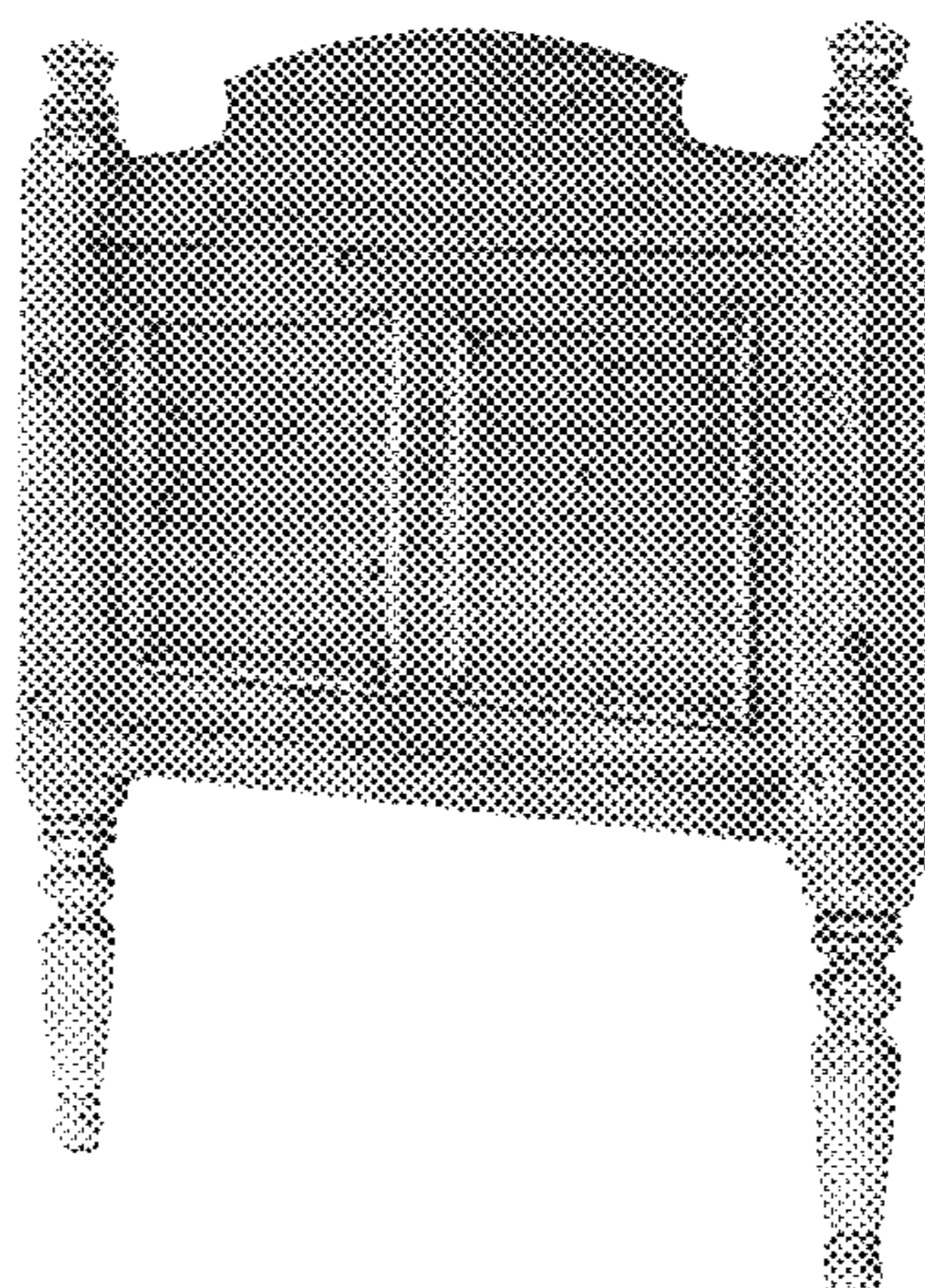
(57) **CLAIM**

The ornamental design for a headboard and/or footboard, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a headboard and/or footboard showing our new design;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a right side elevational view thereof, the left side being a mirror image of the right side;  
 FIG. 4 is a top plan view thereof;  
 FIG. 5 is a perspective view of an alternative embodiment of our new design;  
 FIG. 6 is a front elevational view of the alternative embodiment;  
 FIG. 7 is a right side elevational view of the alternative embodiment, the left side being a mirror image of the right side; and,  
 FIG. 8 is a top plan view of the alternative embodiment.  
 The surfaces or portions of the article not shown in the Figures or described in the specification form no part of the claimed design.

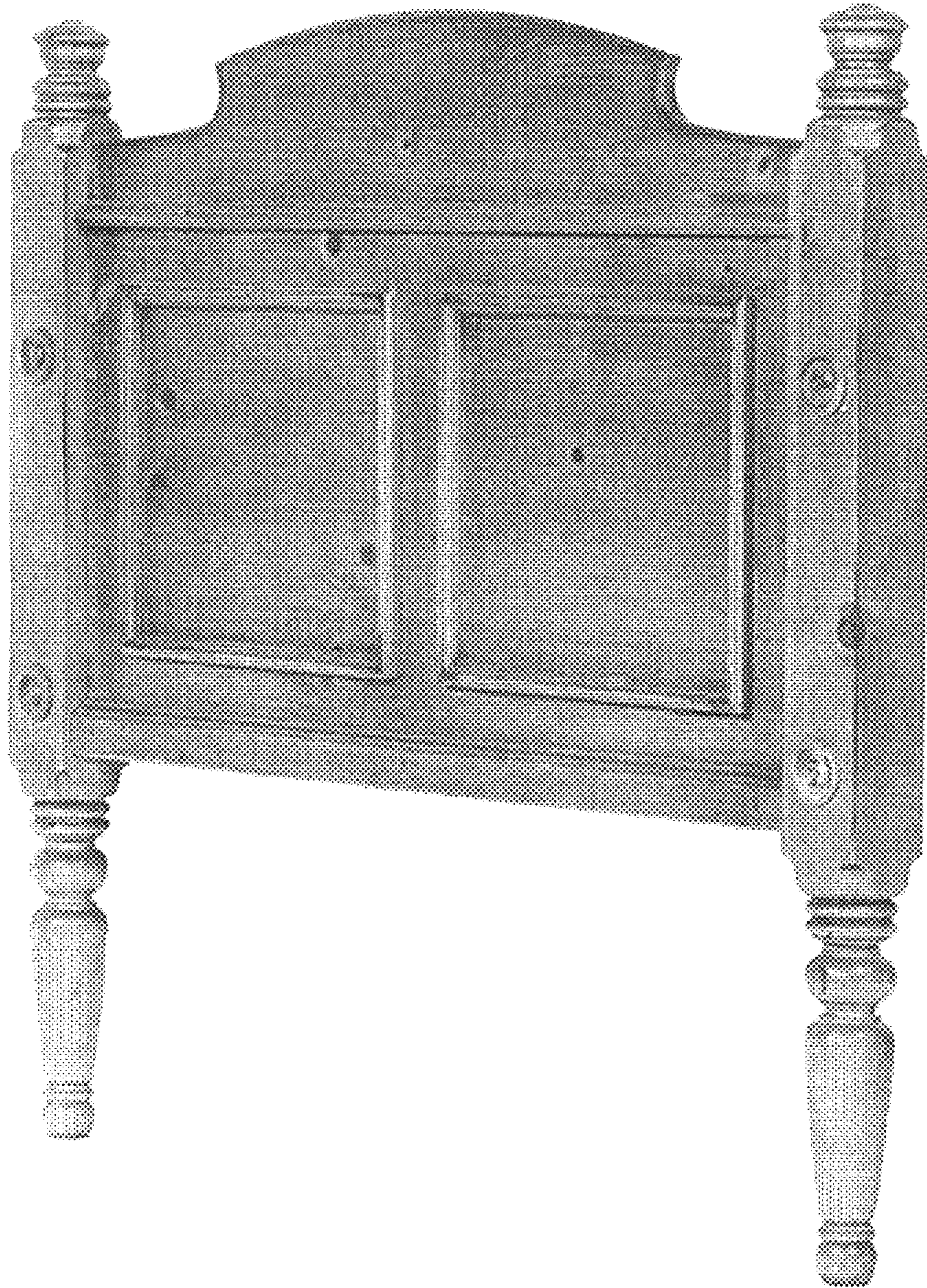

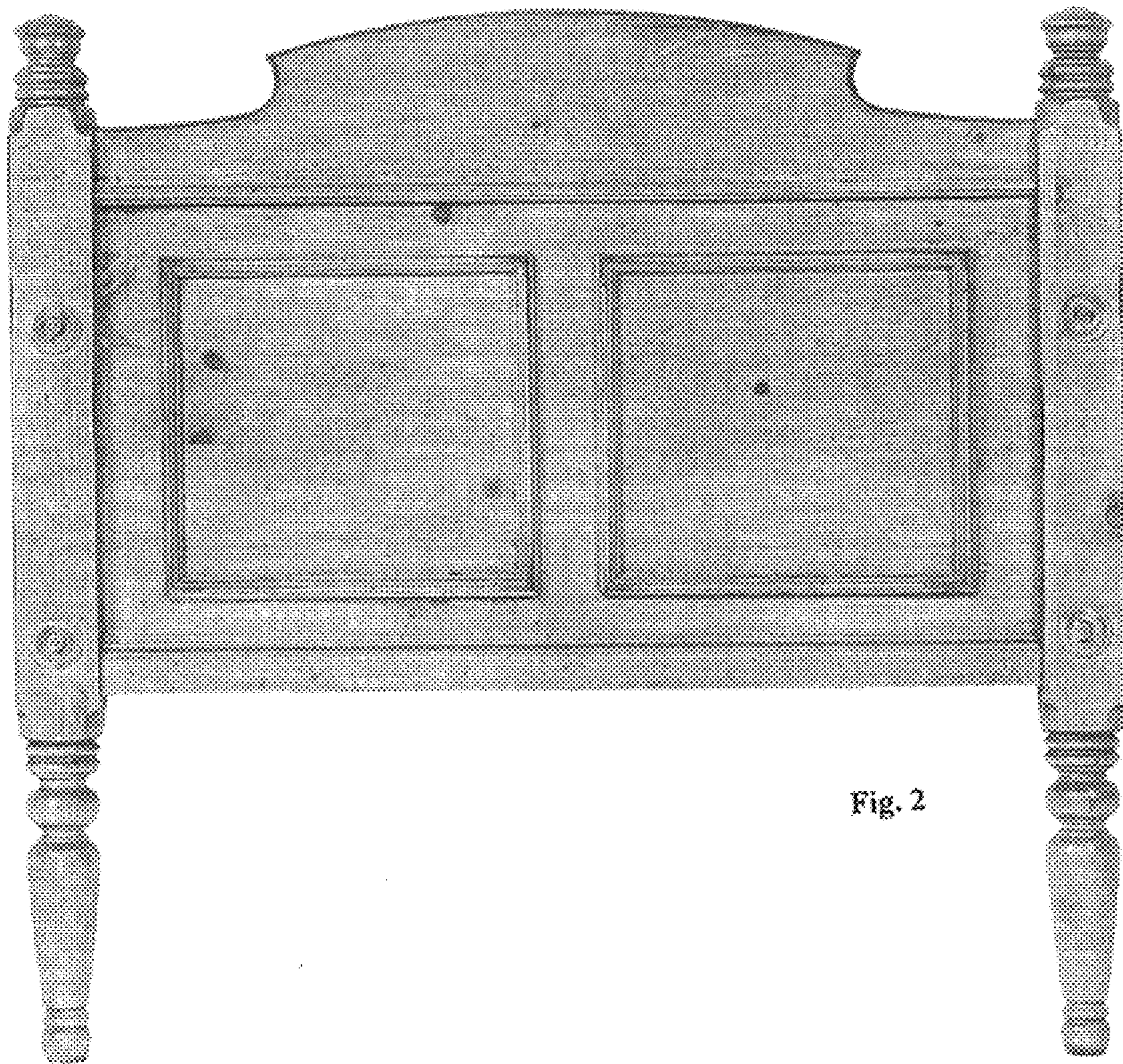

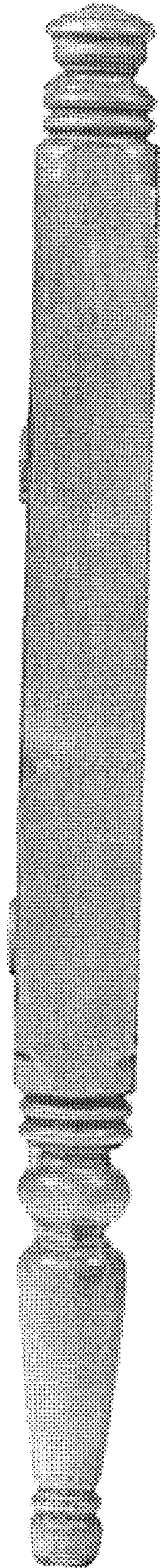

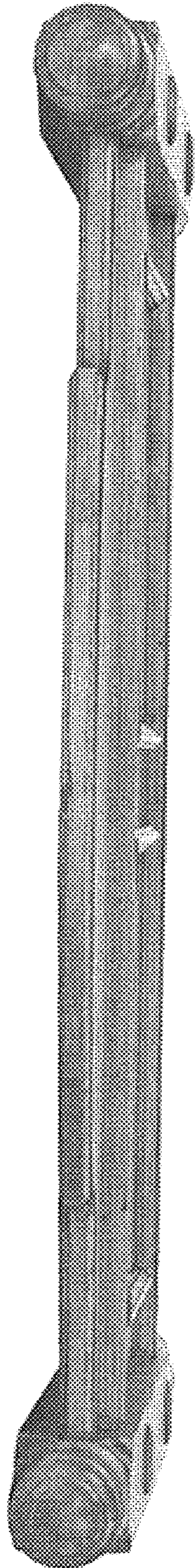

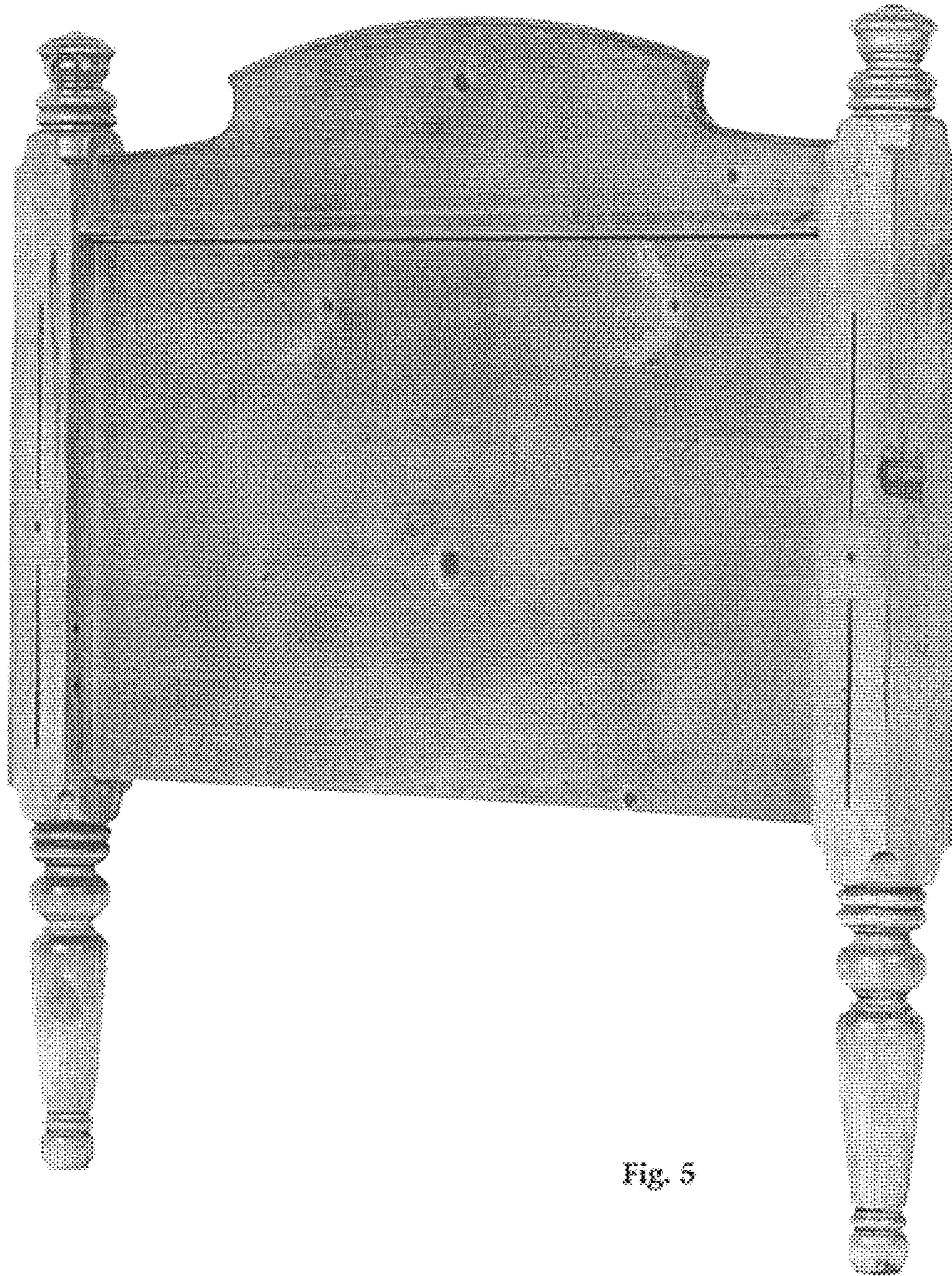

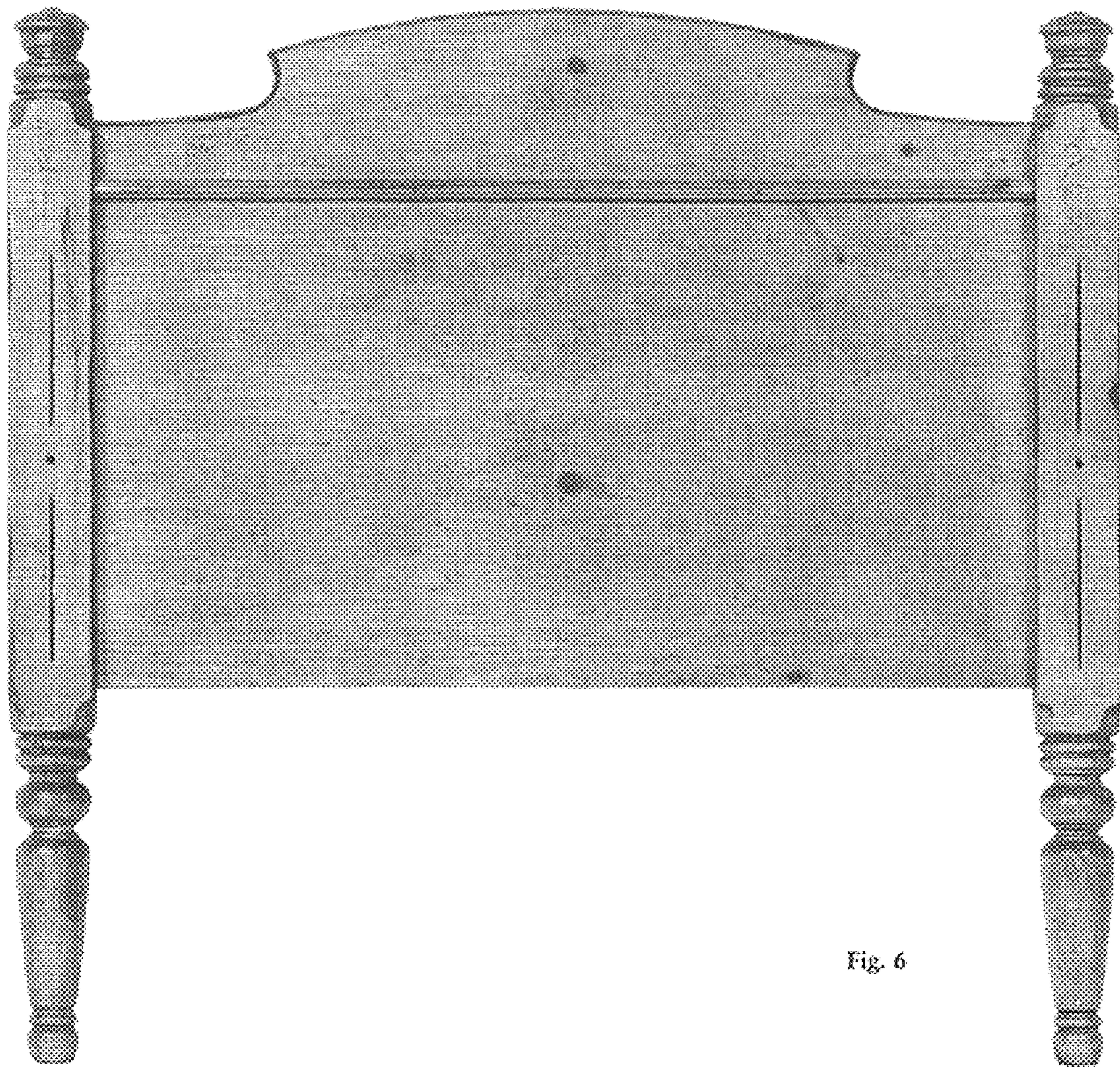

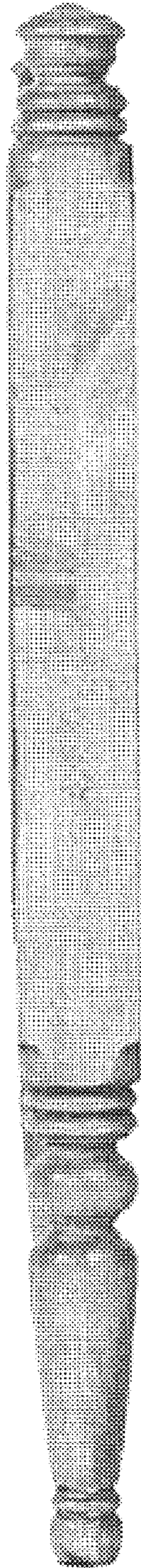

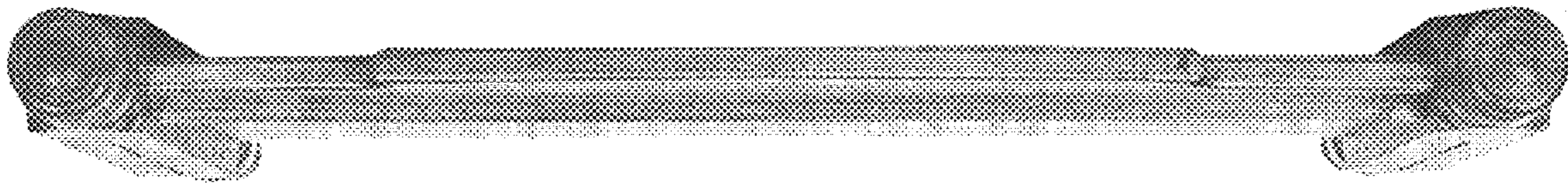
