(57) **CLAIM**

The ornamental design for a bracelet with baubles, as shown and described.

**DESCRIPTION**

FIG. 1 is a front plan view of a bracelet with baubles, showing my new design;

FIG. 2 is a rear plan view of the bracelet and baubles of FIG. 1;

FIG. 3 is a perspective view of a light blue bauble attached to a portion of the bracelet of FIG. 1;

FIG. 4 is a perspective view of the light blue bauble of FIG. 3, taken opposite from the view of FIG. 3;

FIG. 5 is a bottom view of the light blue bauble of FIG. 3;

FIG. 6 is a top view of the light blue bauble of FIG. 3;

FIG. 7 is a perspective view of a light green bauble attached to a portion of the bracelet of FIG. 1;

FIG. 8 is a perspective view of the light green bauble of FIG. 7, taken opposite from the view of FIG. 7;

FIG. 9 is a bottom view of the light green bauble of FIG. 7;

FIG. 10 is a top view of the light green bauble of FIG. 7;

FIG. 11 is a perspective view of a crystal clear bauble attached to a portion of the bracelet of FIG. 1;

FIG. 12 is a perspective view of the crystal clear bauble of FIG. 11, taken opposite from the view of FIG. 11;

FIG. 13 is a bottom view of the crystal clear bauble of FIG. 11;

FIG. 14 is a top view of the crystal clear bauble of FIG. 11;

FIG. 15 is a perspective view of a dark blue bauble attached to a portion of the bracelet of FIG. 1;

FIG. 16 is a perspective view of the dark blue bauble of FIG. 15, taken opposite from the view of FIG. 15;

FIG. 17 is a bottom view of the dark blue bauble of FIG. 15;

FIG. 18 is a top view of the dark blue bauble of FIG. 15;

FIG. 19 is a perspective view of an amethyst bauble attached to a portion of the bracelet of FIG. 1;

FIG. 20 is a perspective view of the amethyst bauble of FIG. 19, taken opposite from the view of FIG. 19;

FIG. 21 is a bottom view of the amethyst bauble of FIG. 19;

FIG. 22 is a top view of the amethyst bauble of FIG. 19;

FIG. 23 is a perspective view of a yellow bauble attached to a portion of the bracelet of FIG. 1;

FIG. 24 is a perspective view of the yellow bauble of FIG. 23, taken opposite from the view of FIG. 23;

FIG. 25 is a bottom view of the yellow bauble of FIG. 23;

FIG. 26 is a top view of the yellow bauble of FIG. 23;

FIG. 27 is a perspective view of a scarlet red bauble attached to a portion of the bracelet of FIG. 1;

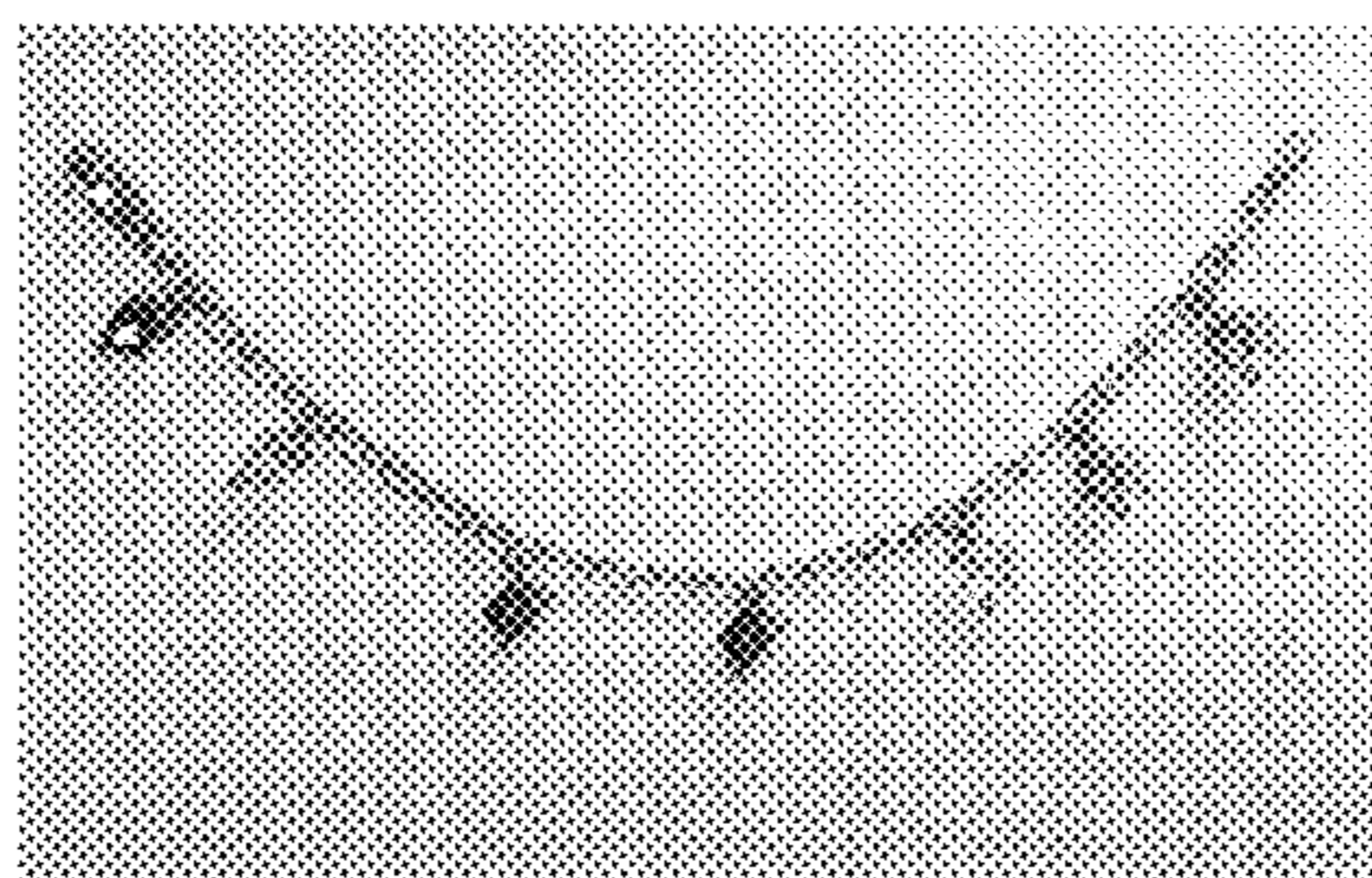
FIG. 28 is a perspective view of the scarlet red bauble of FIG. 27, taken opposite from the view of FIG. 27;

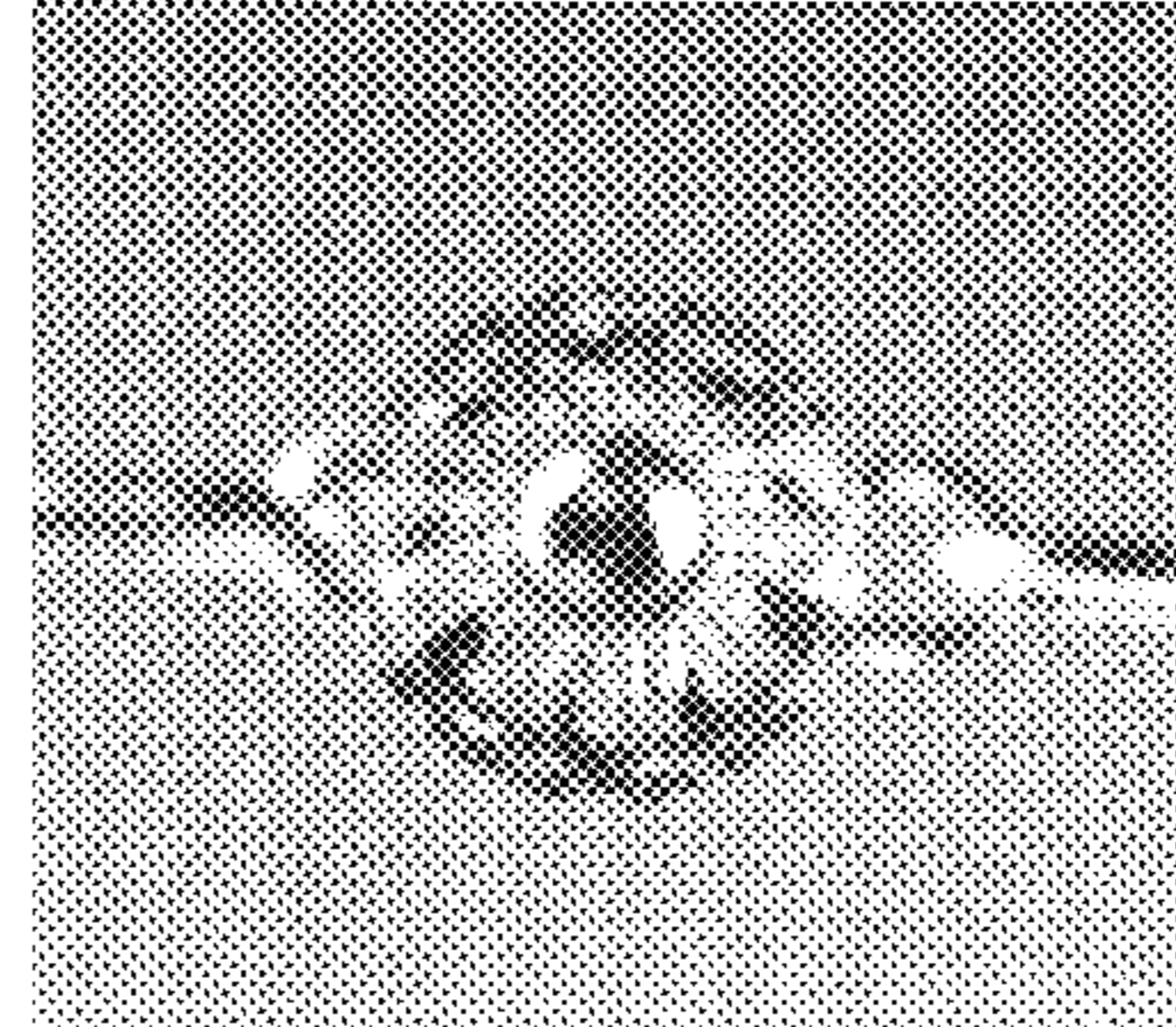

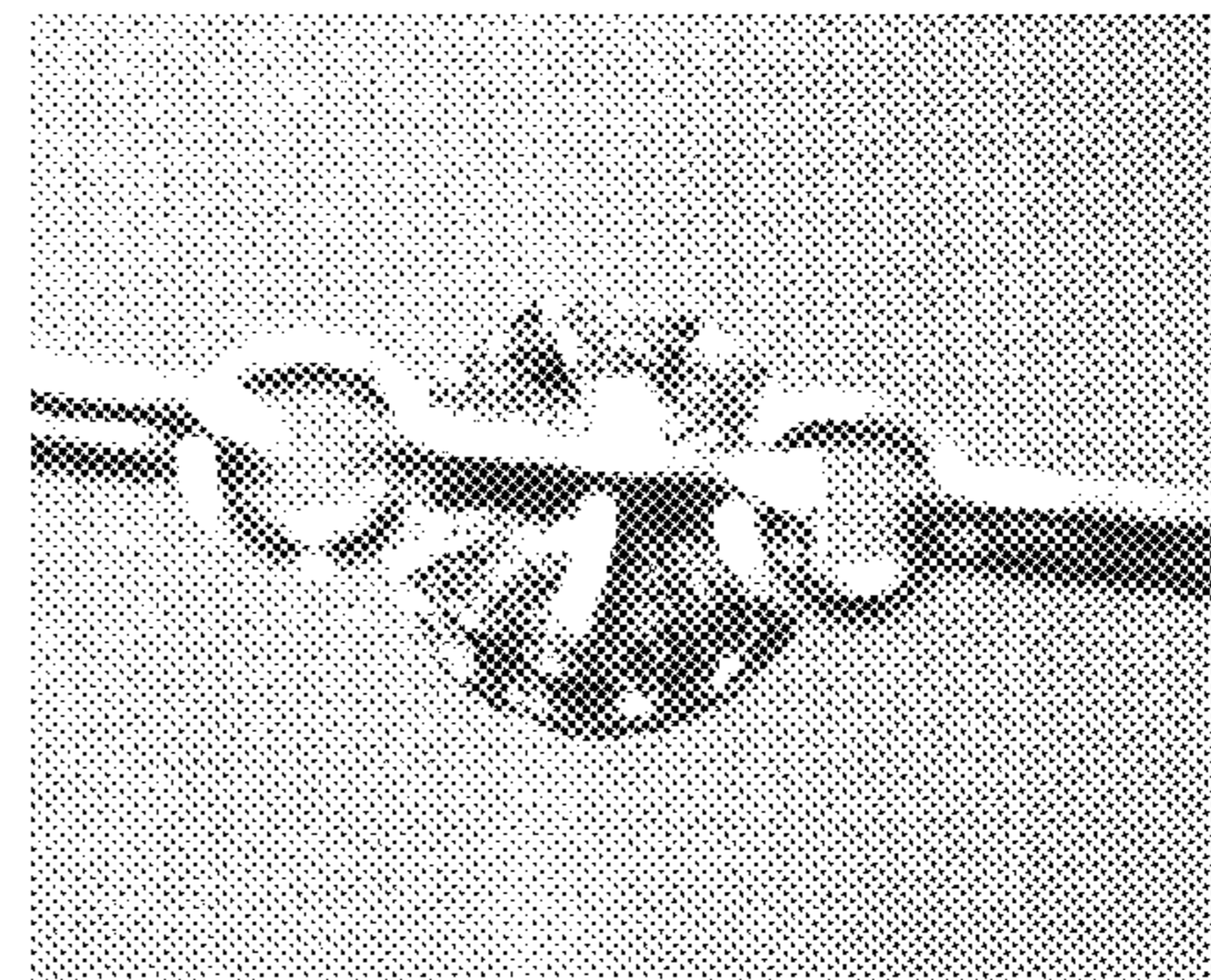

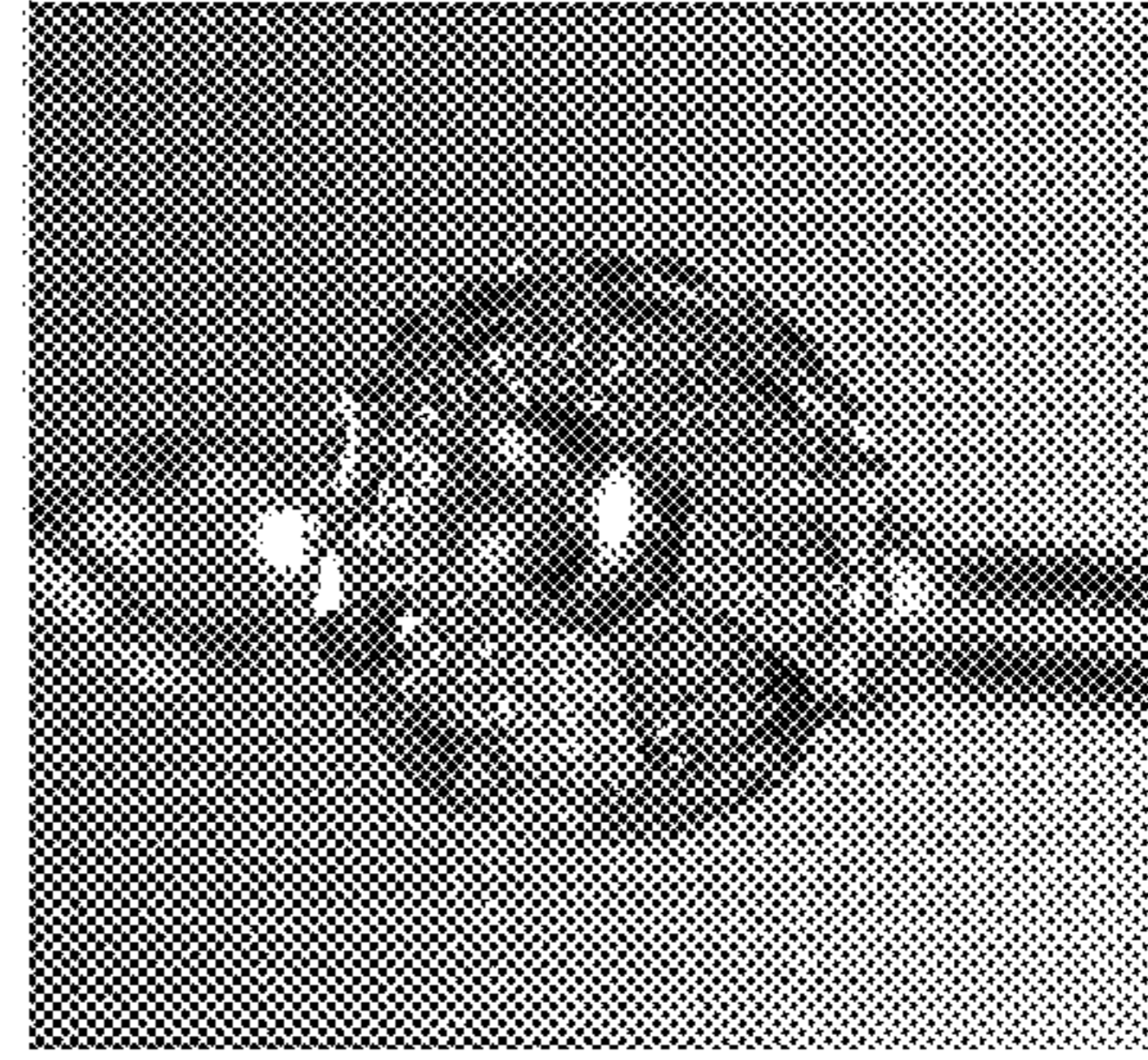

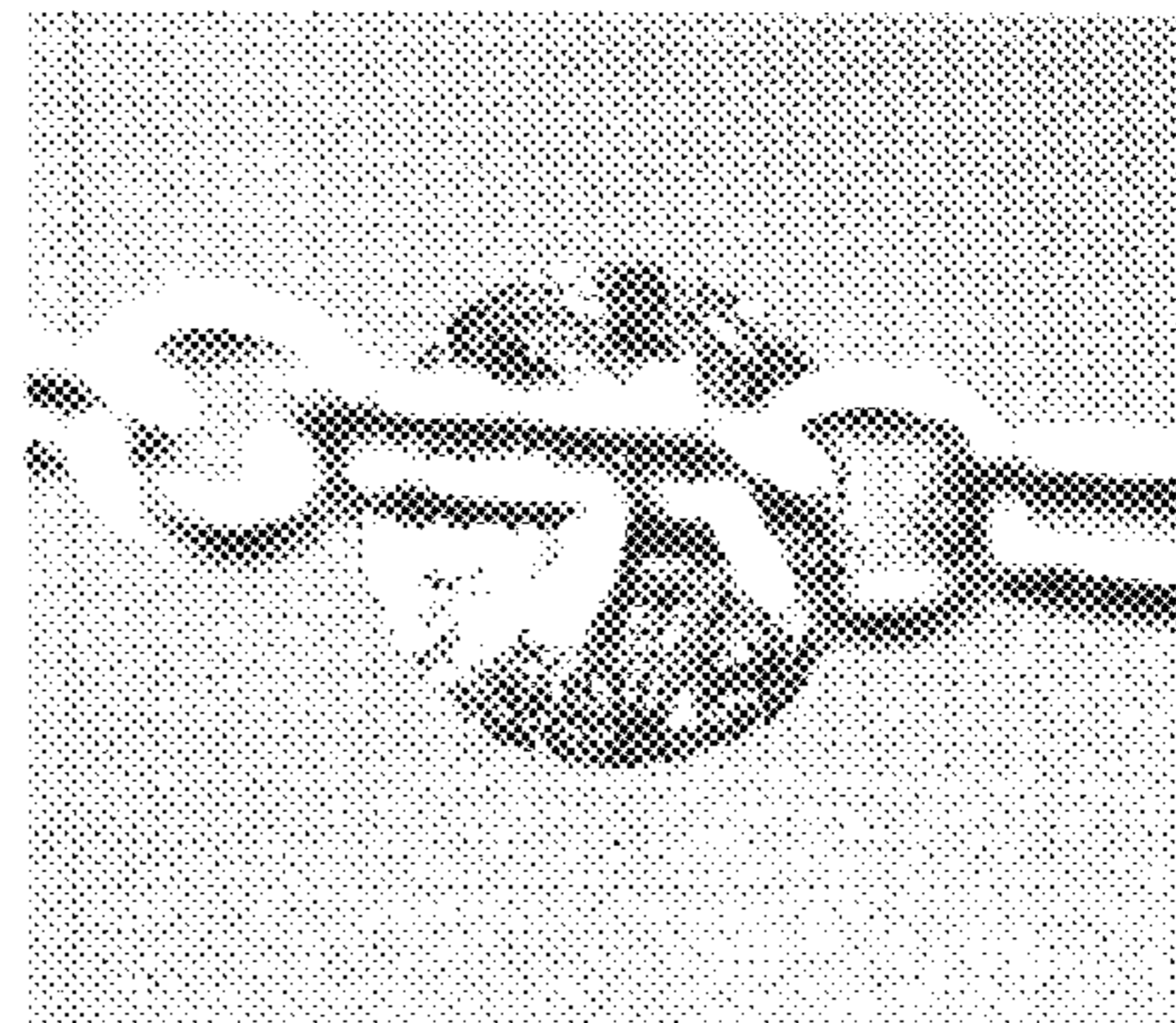

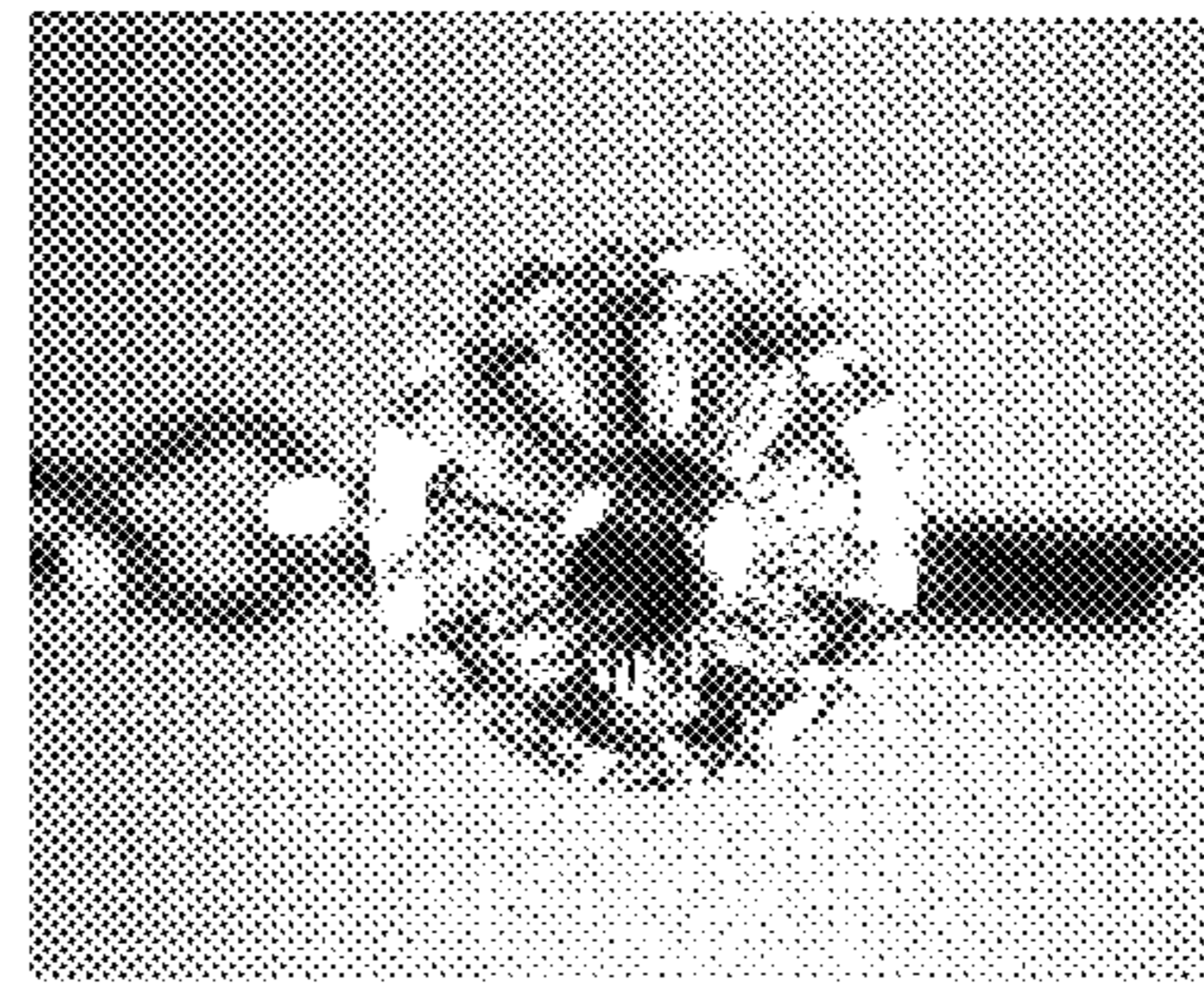

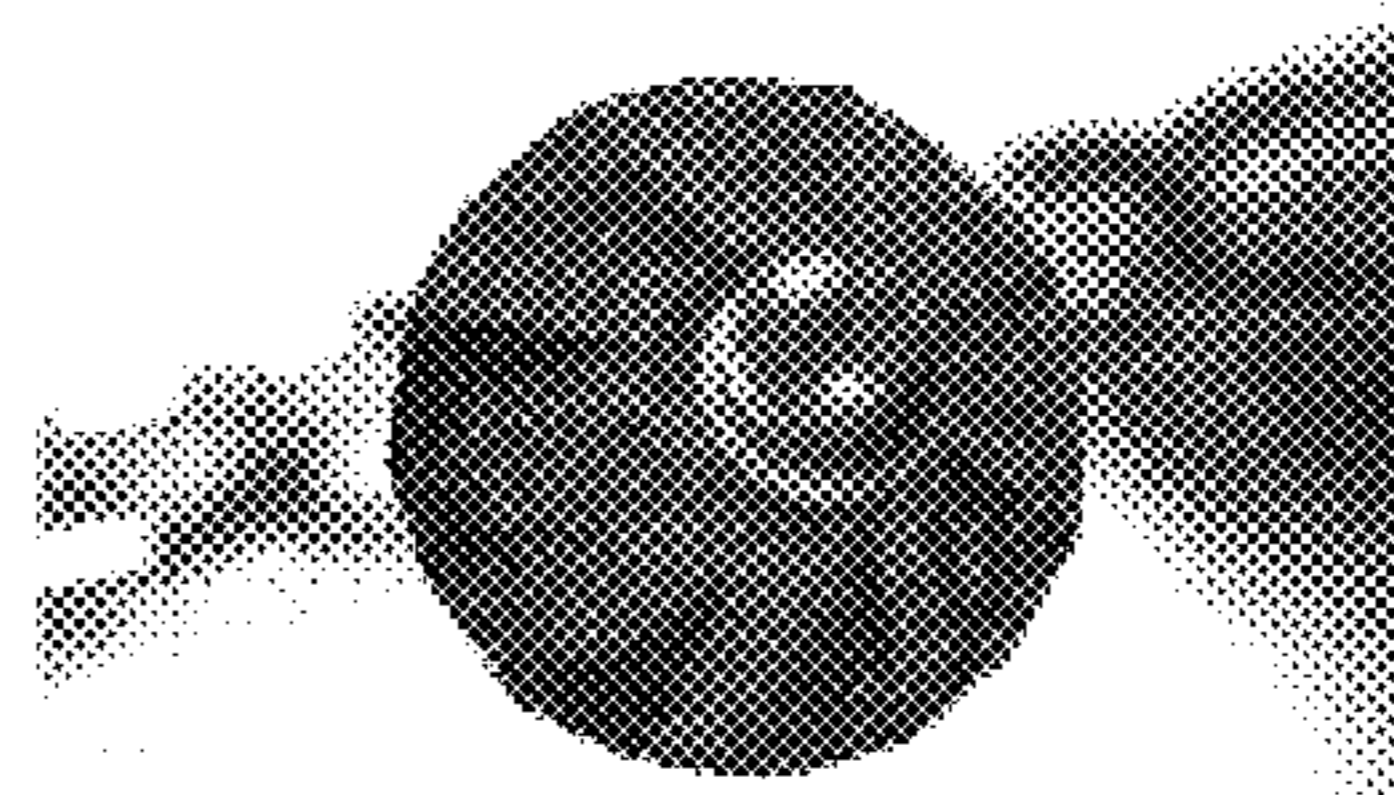

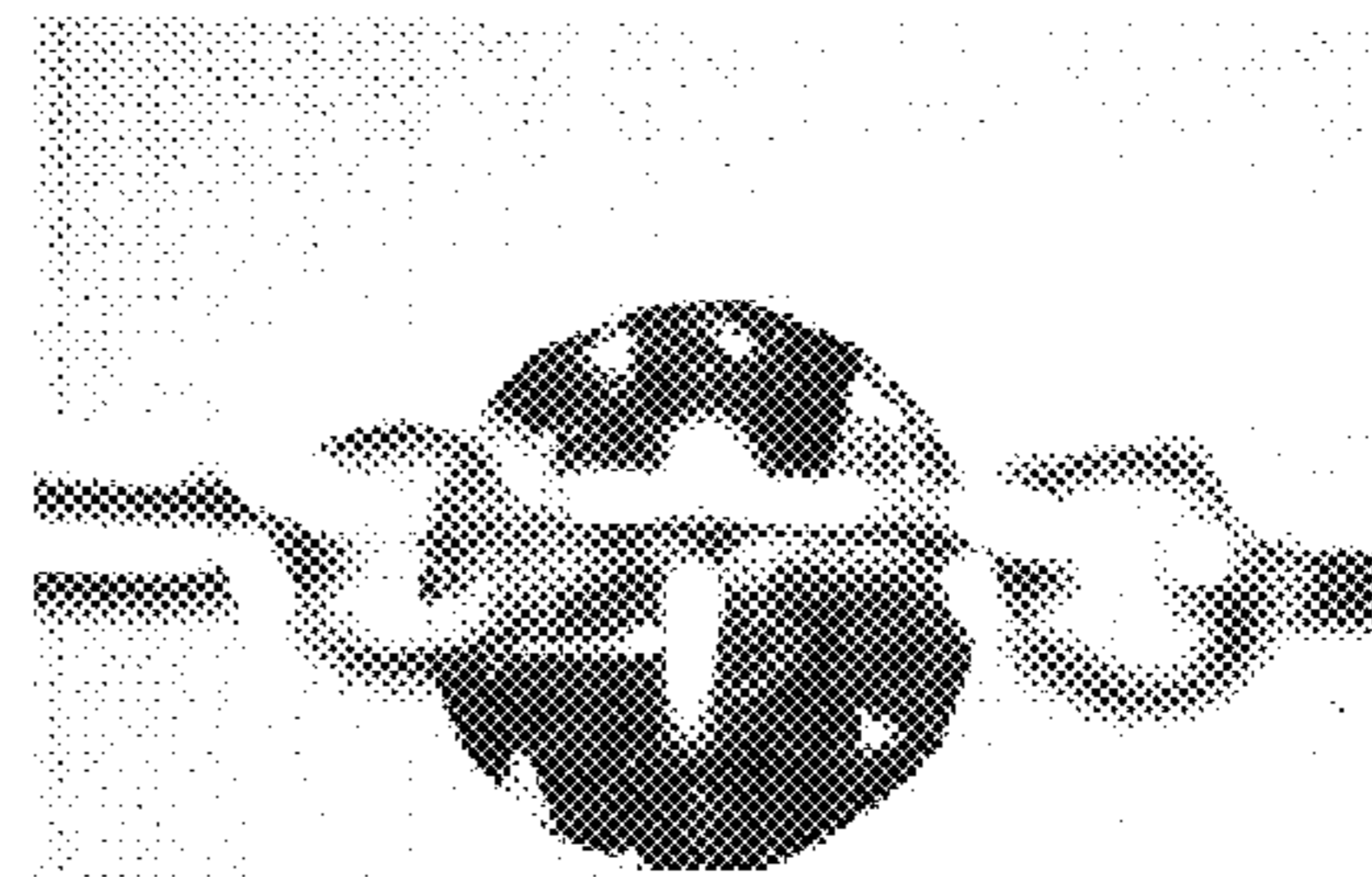

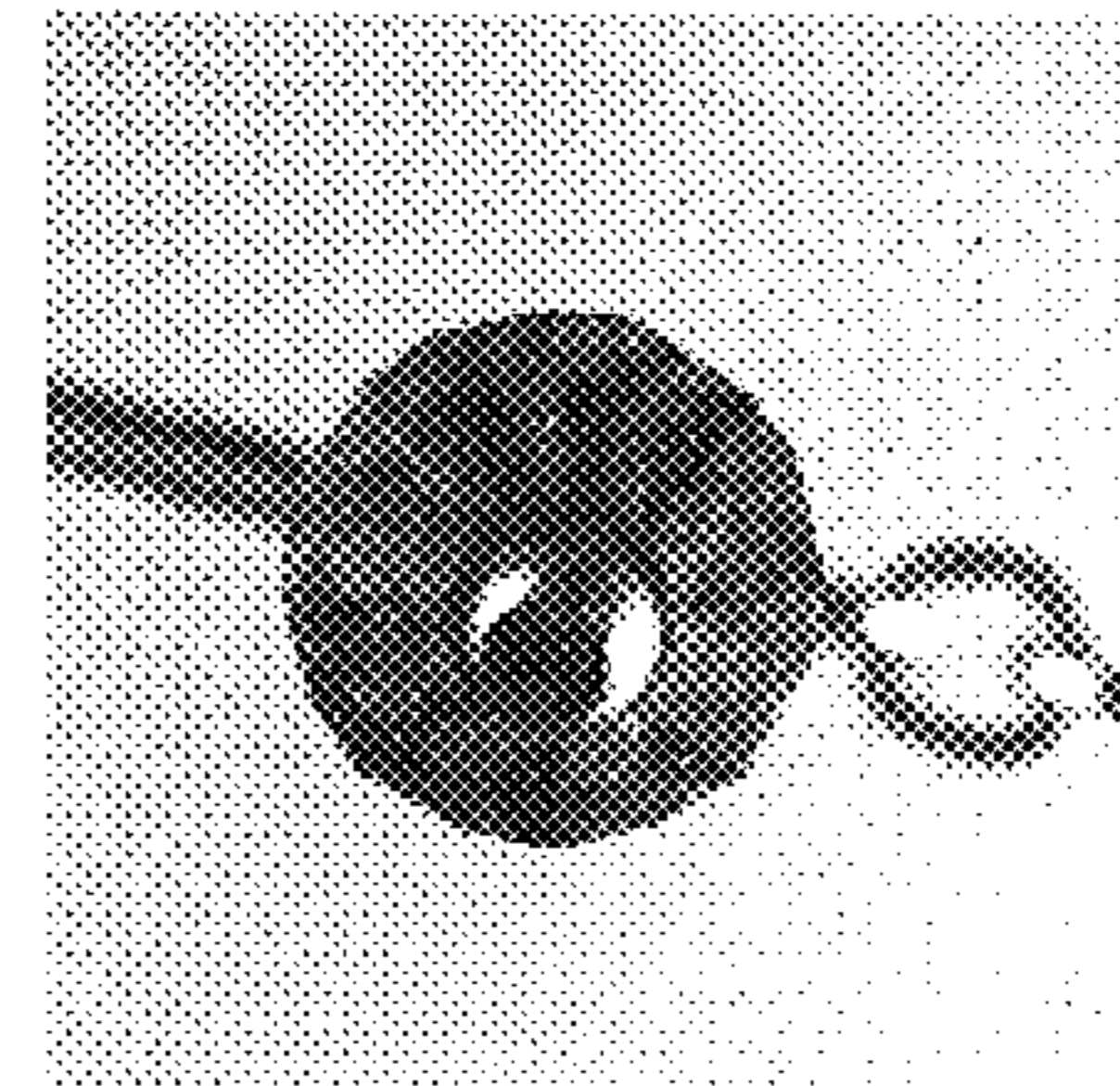

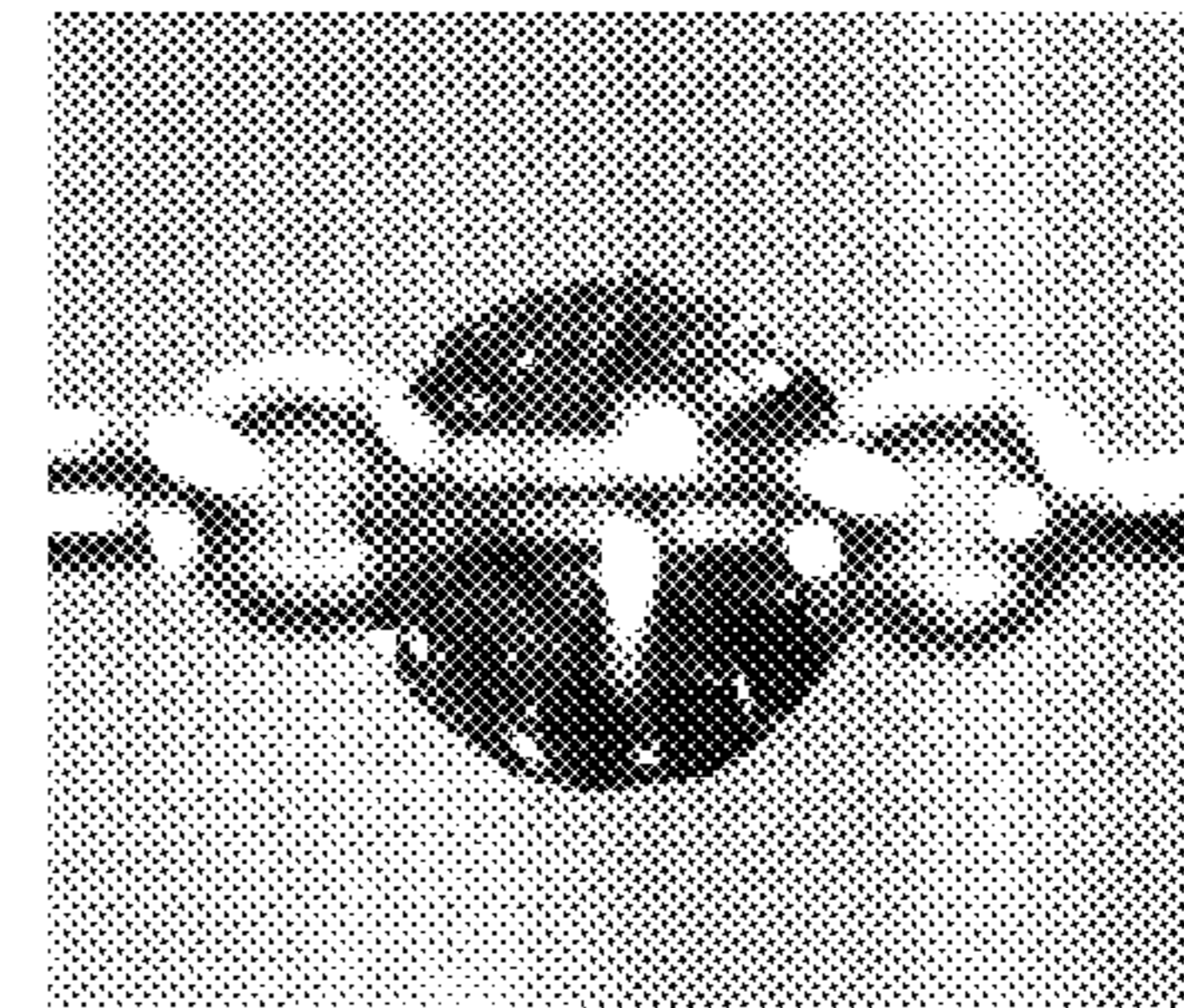

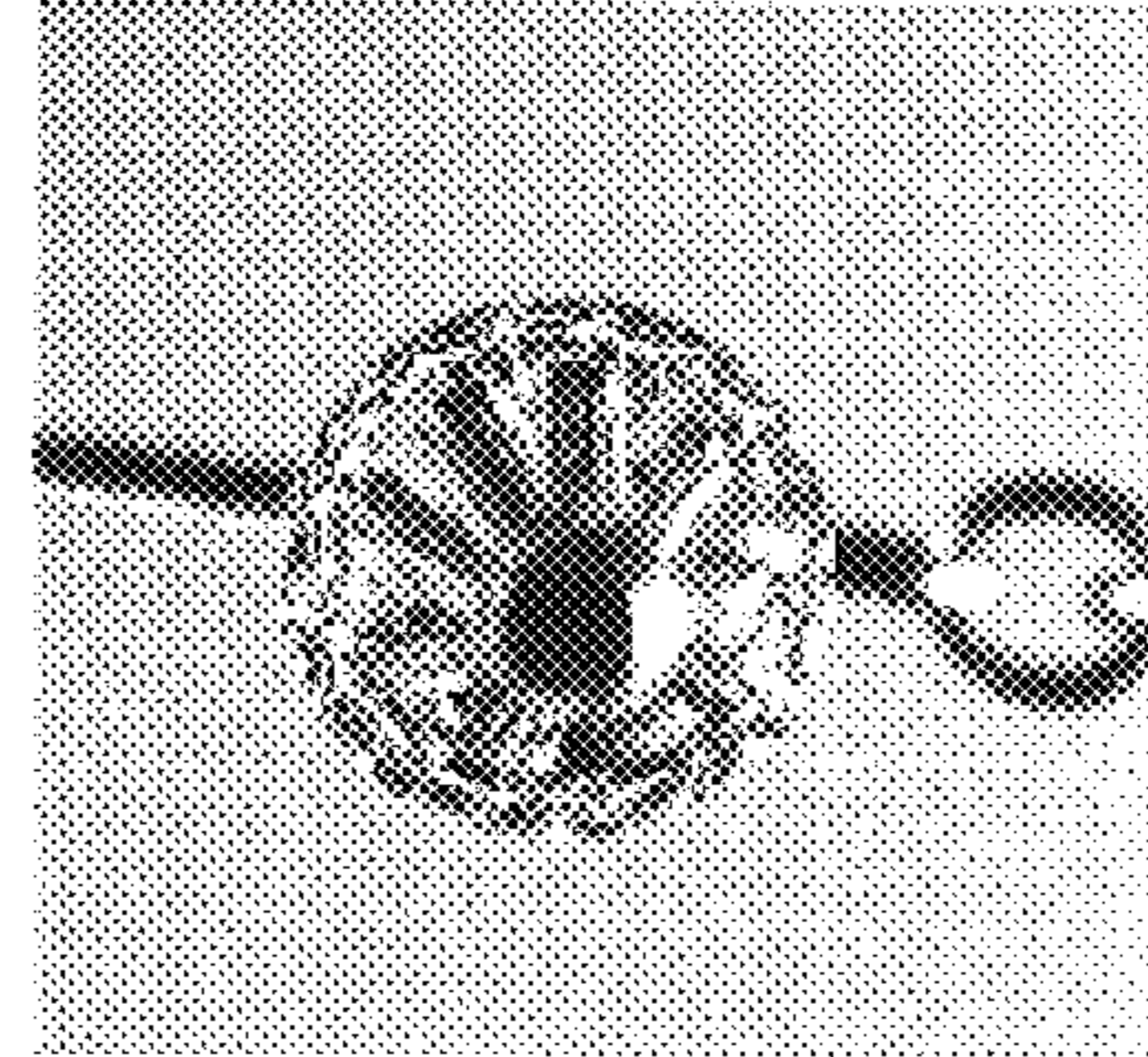

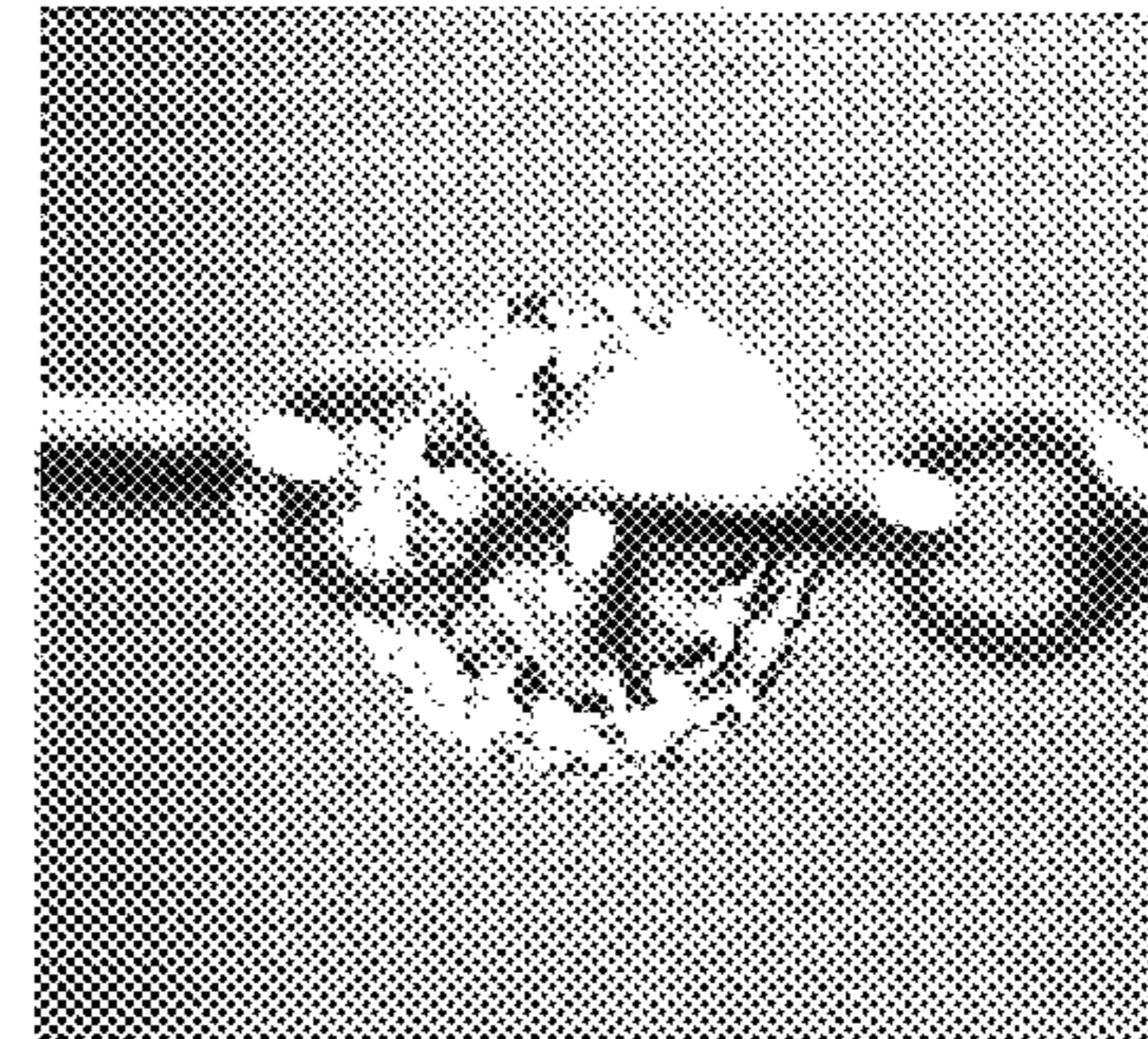

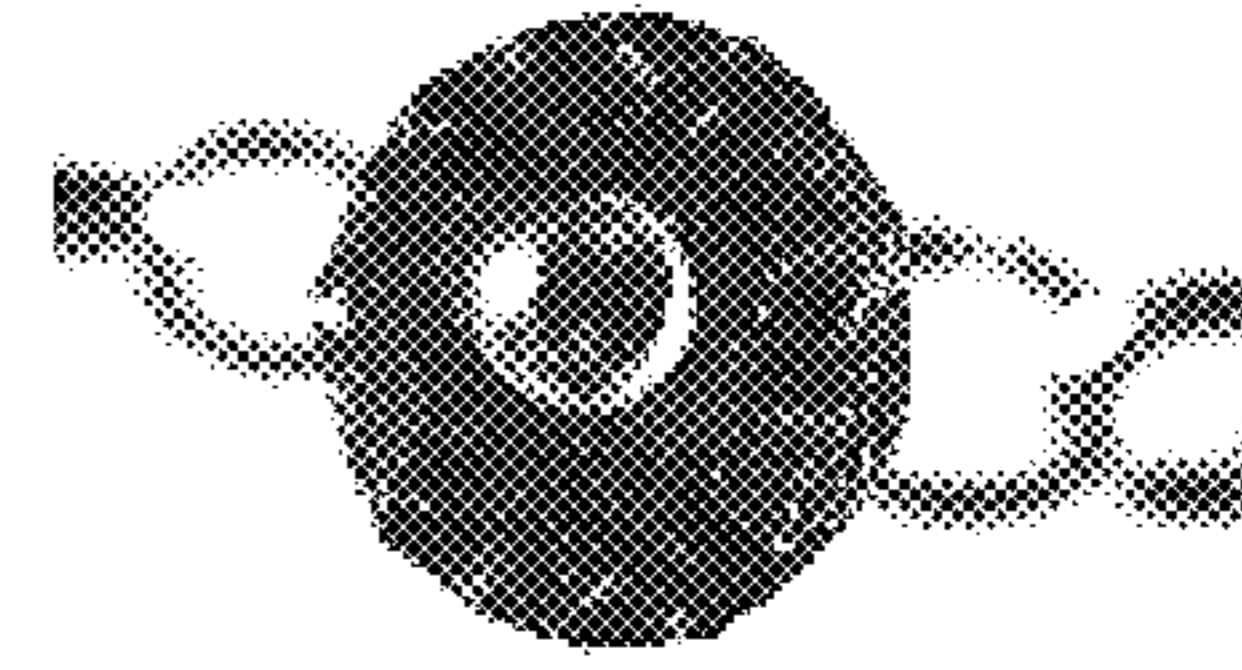

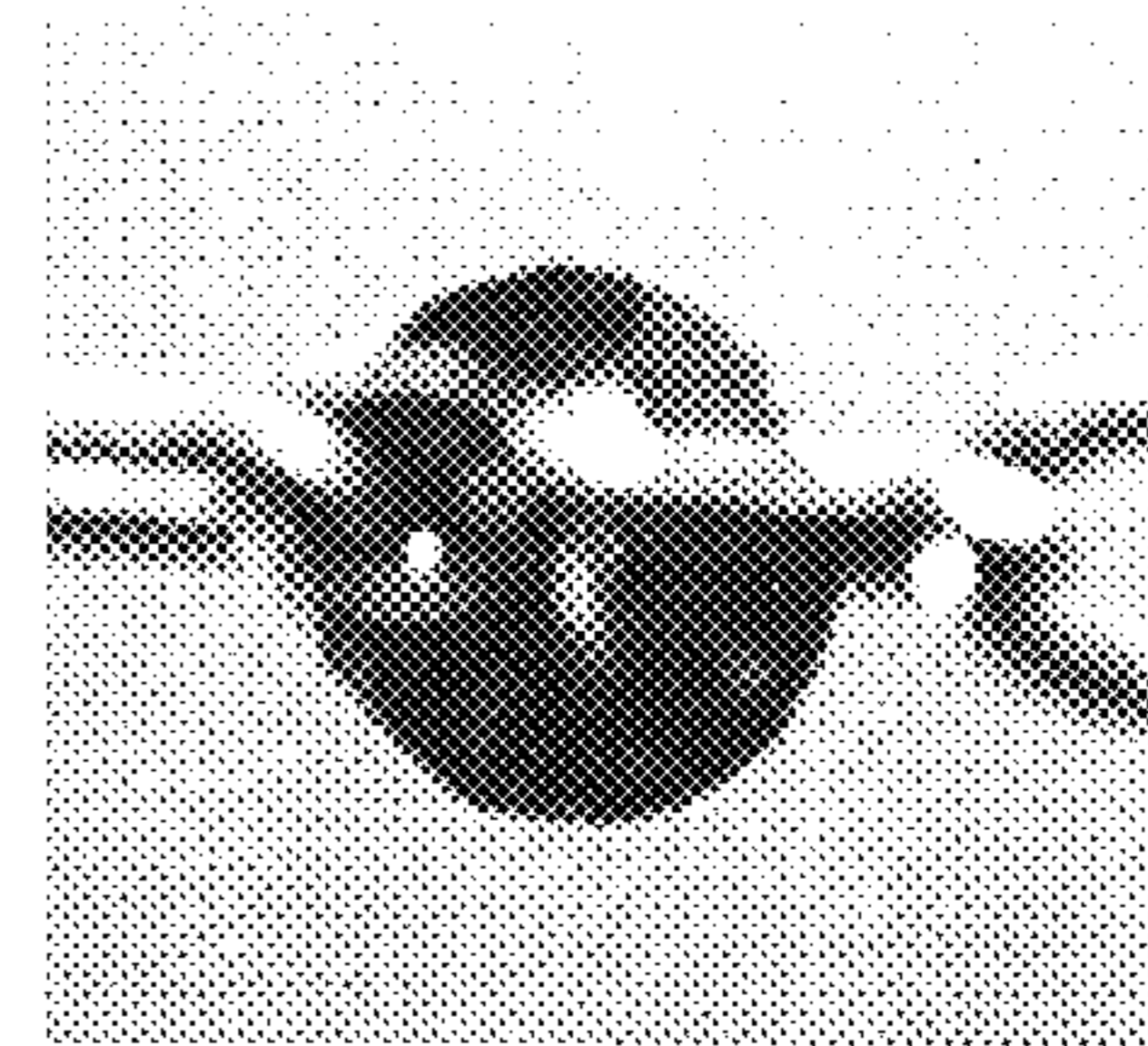

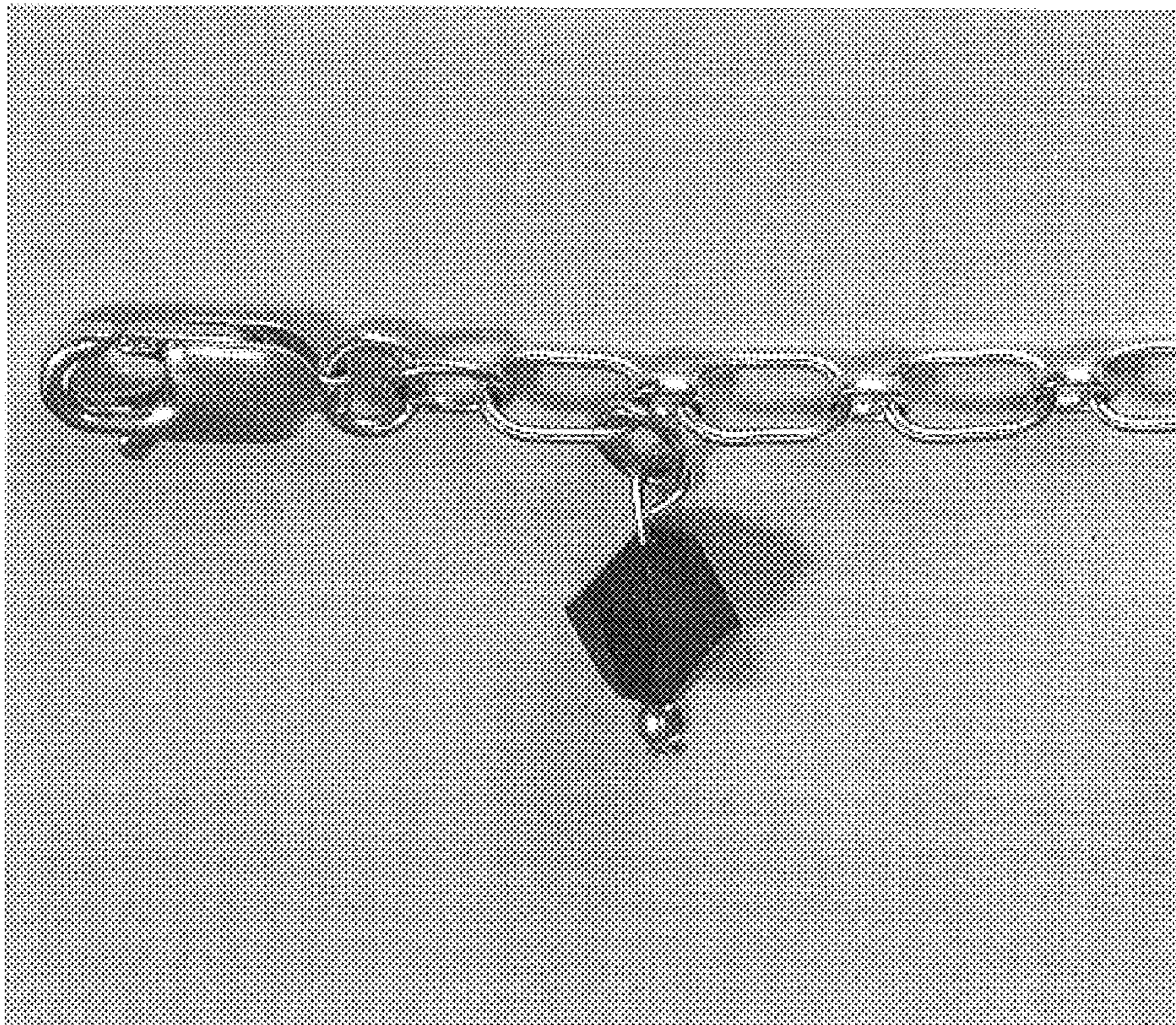
