(57) **CLAIM**

I claim the ornamental design for a trolley handle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a trolley handle according to an embodiment of the present invention.

FIG. 2 is a perspective view of a trolley handle according to an alternative embodiment of the present invention.

FIG. 3 is a perspective view of a trolley handle according to another alternative embodiment of the present invention.

FIG. 4 is a front view of a trolley handle according to yet another alternative embodiment of the present invention.

FIG. 5 is a rear view of the embodiment of FIG. 4.

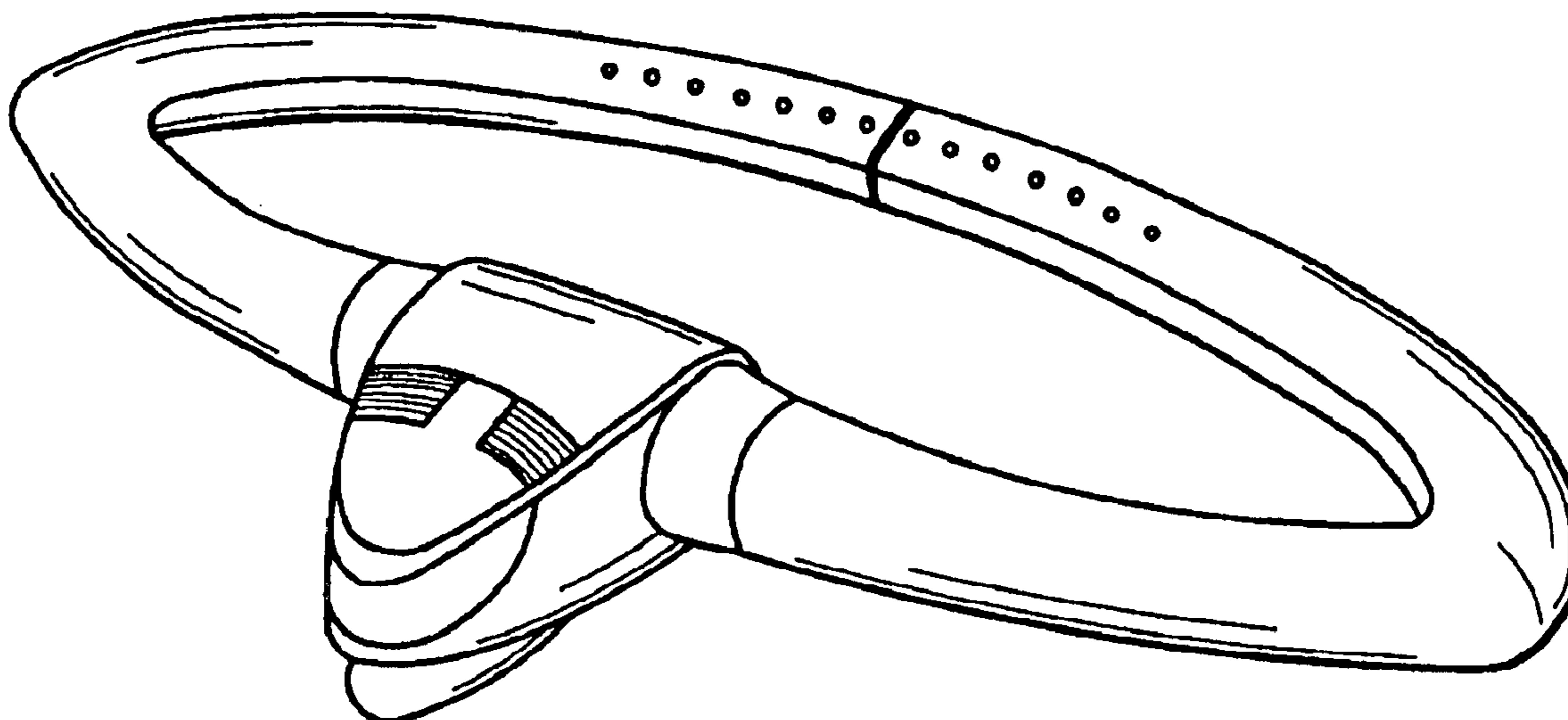
FIG. 6 is a side view of the embodiment of FIG. 4; and,

FIG. 7 is a top view of the embodiment of FIG. 4.

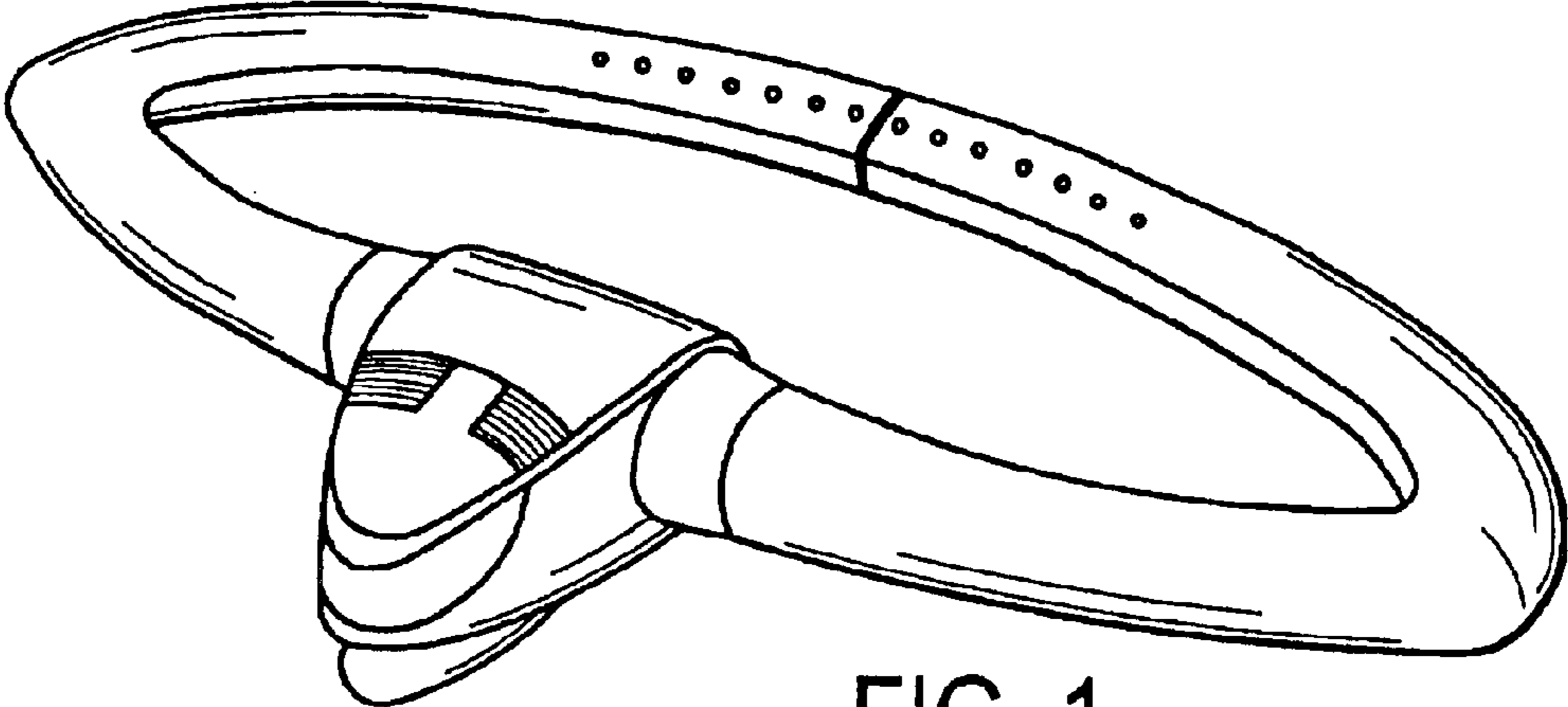

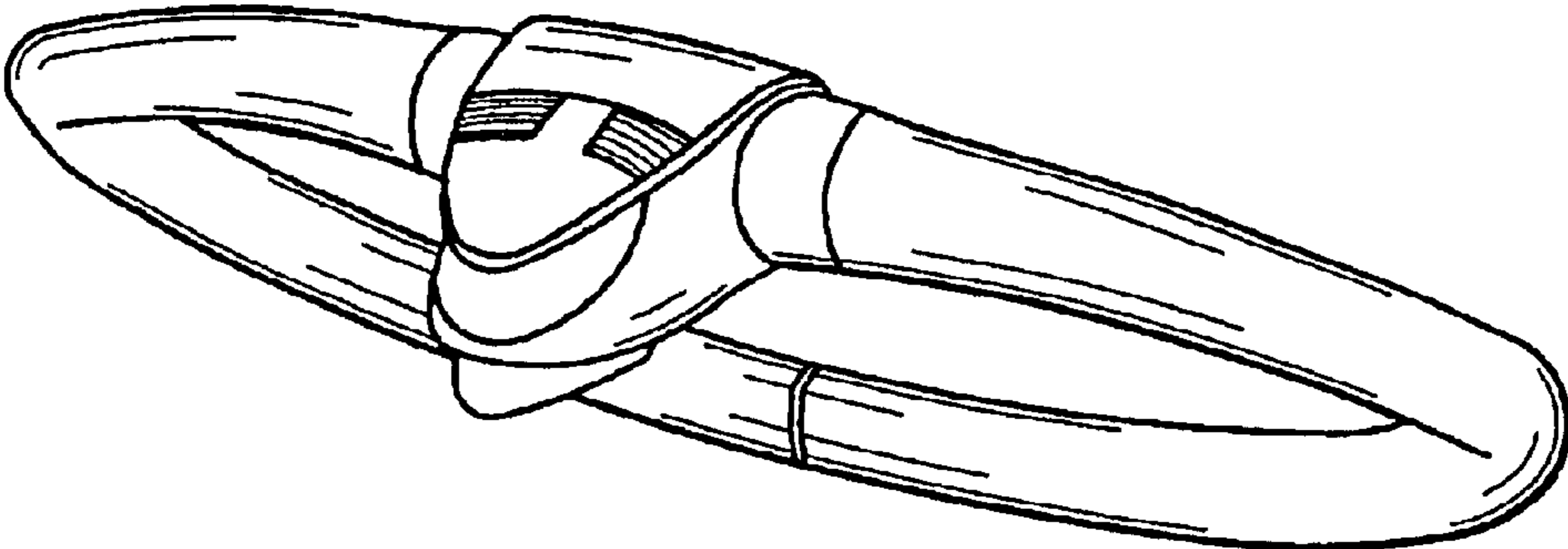

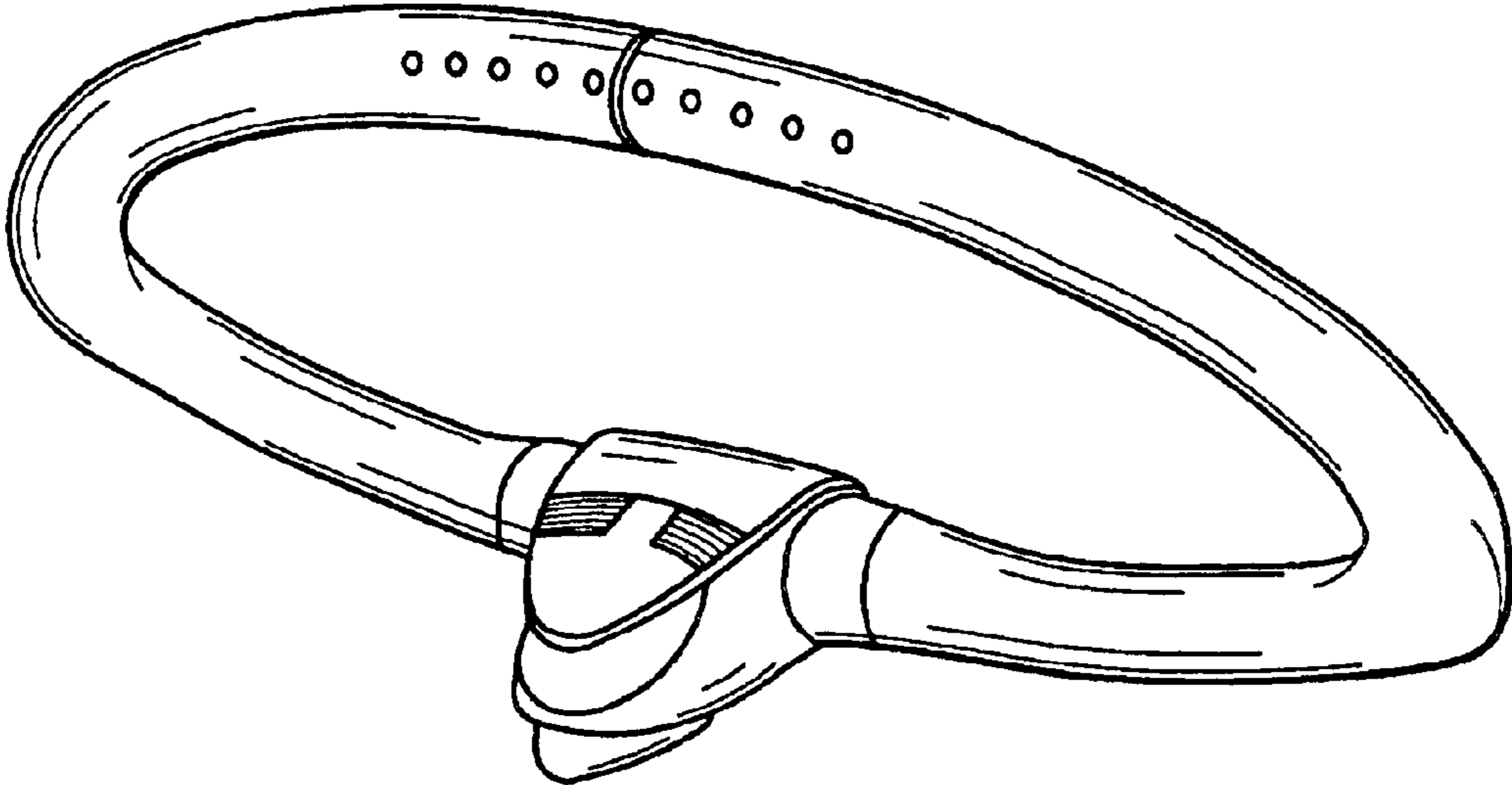

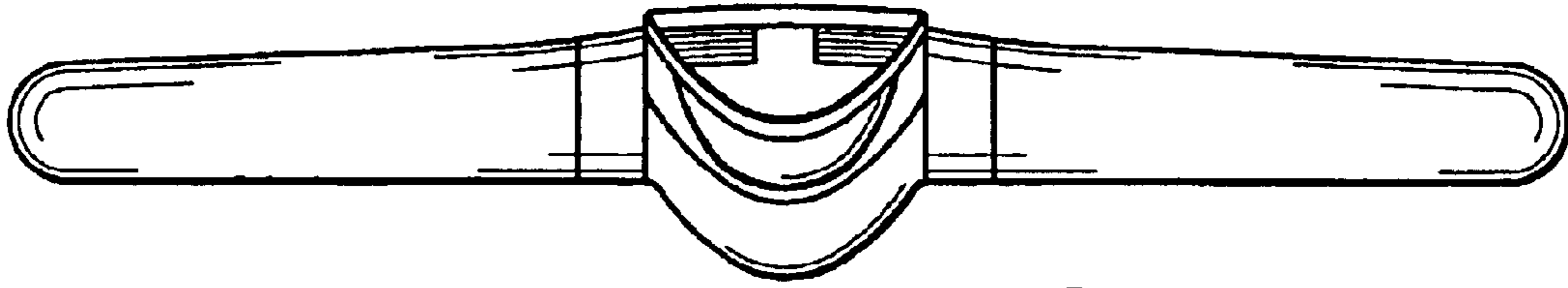

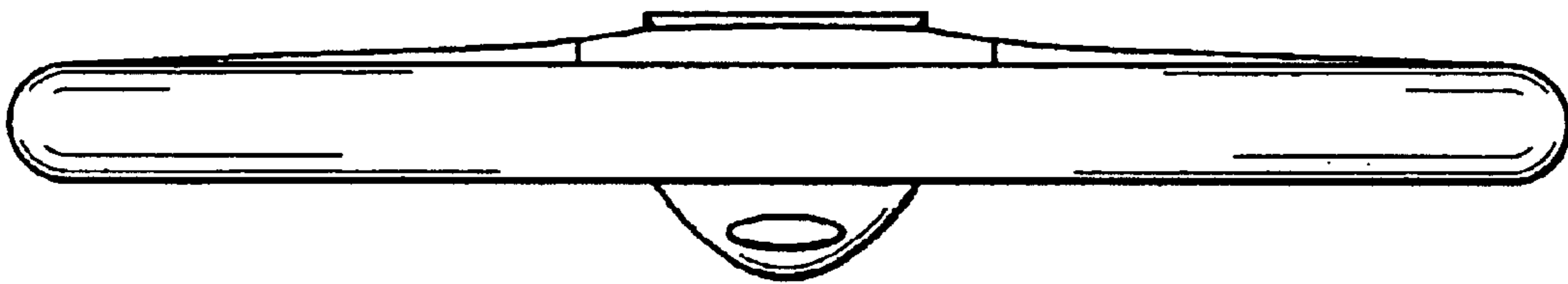

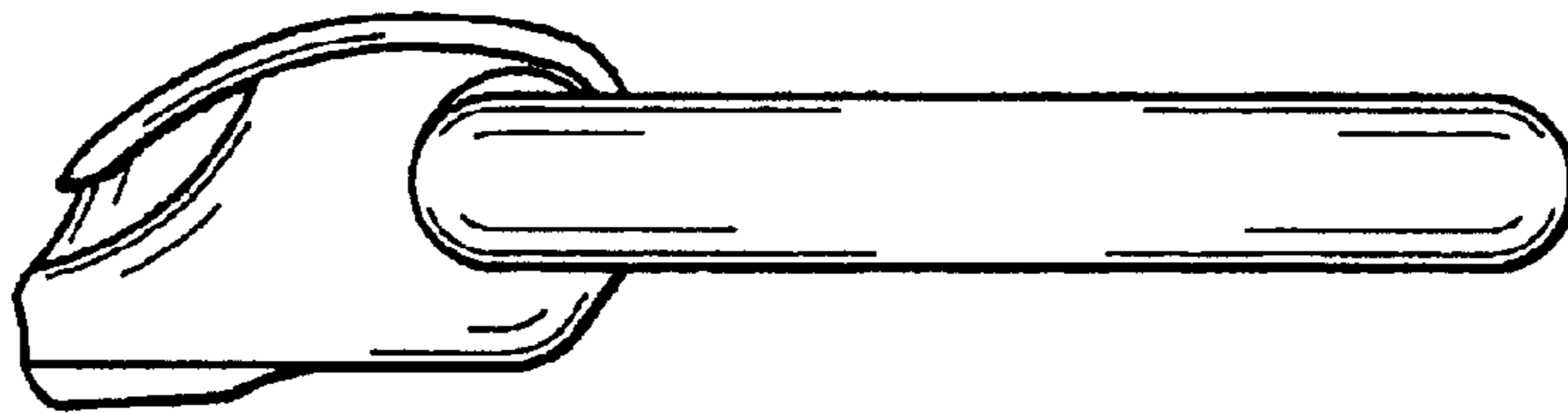

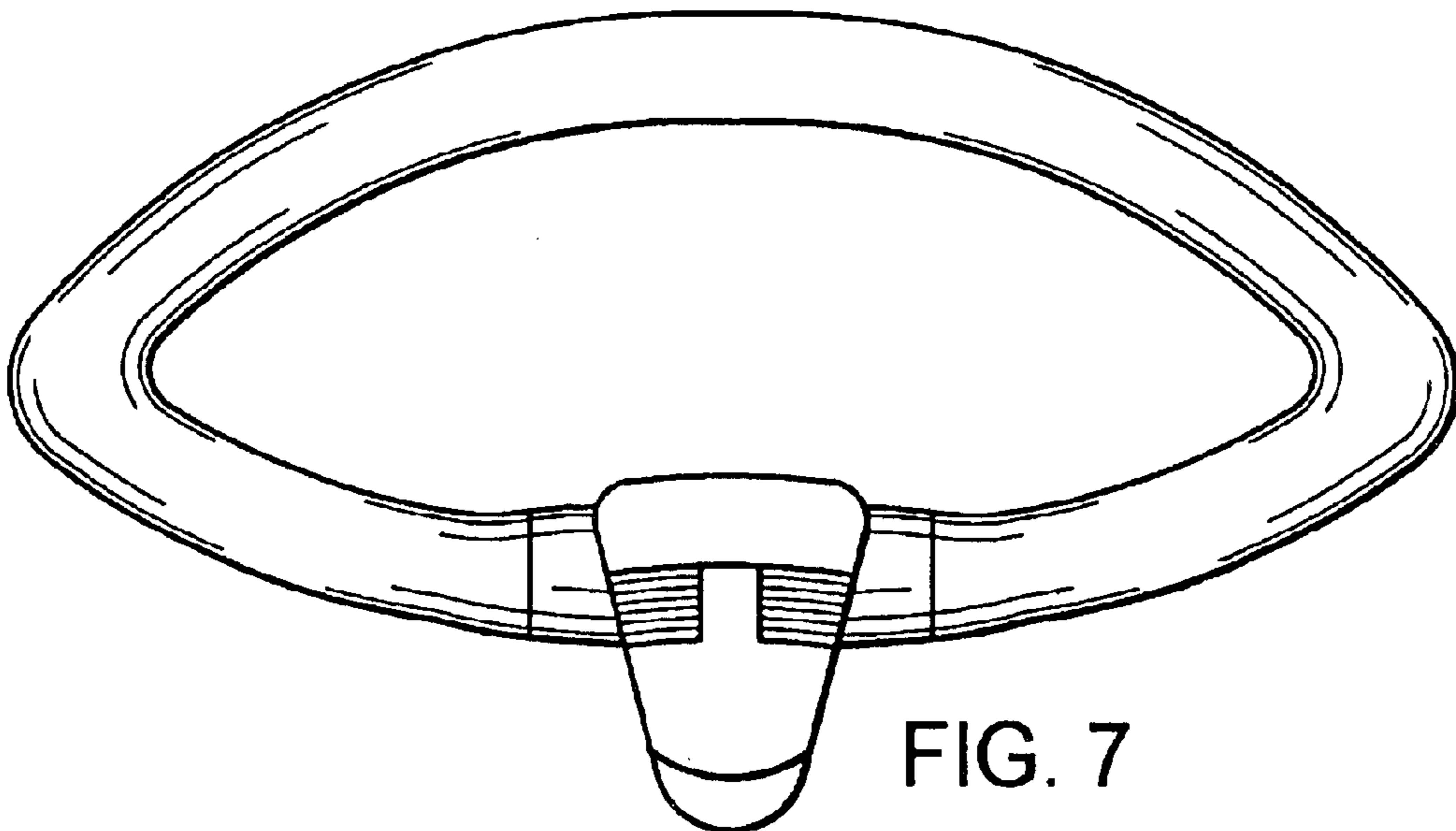
