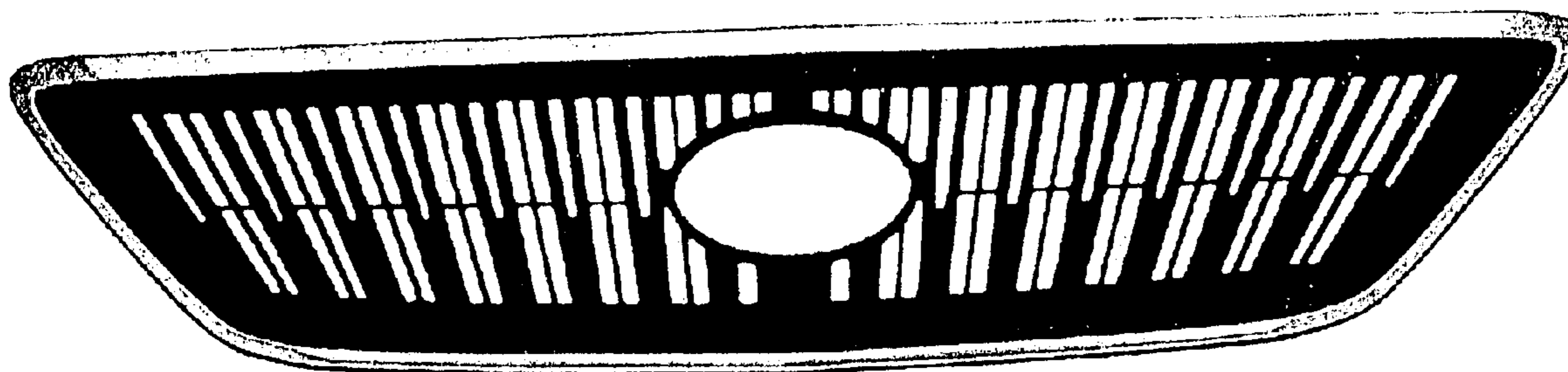
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a left-front perspective view of a grill for an
automobile of my new design;
FIG. 2 is a front view of the design of FIG. 1;
FIG. 3 is a rear view of the design of FIG. 1;
FIG. 4 is a top view of the design of FIG. 1;
FIG. 5 is a bottom view of the design of FIG. 1;

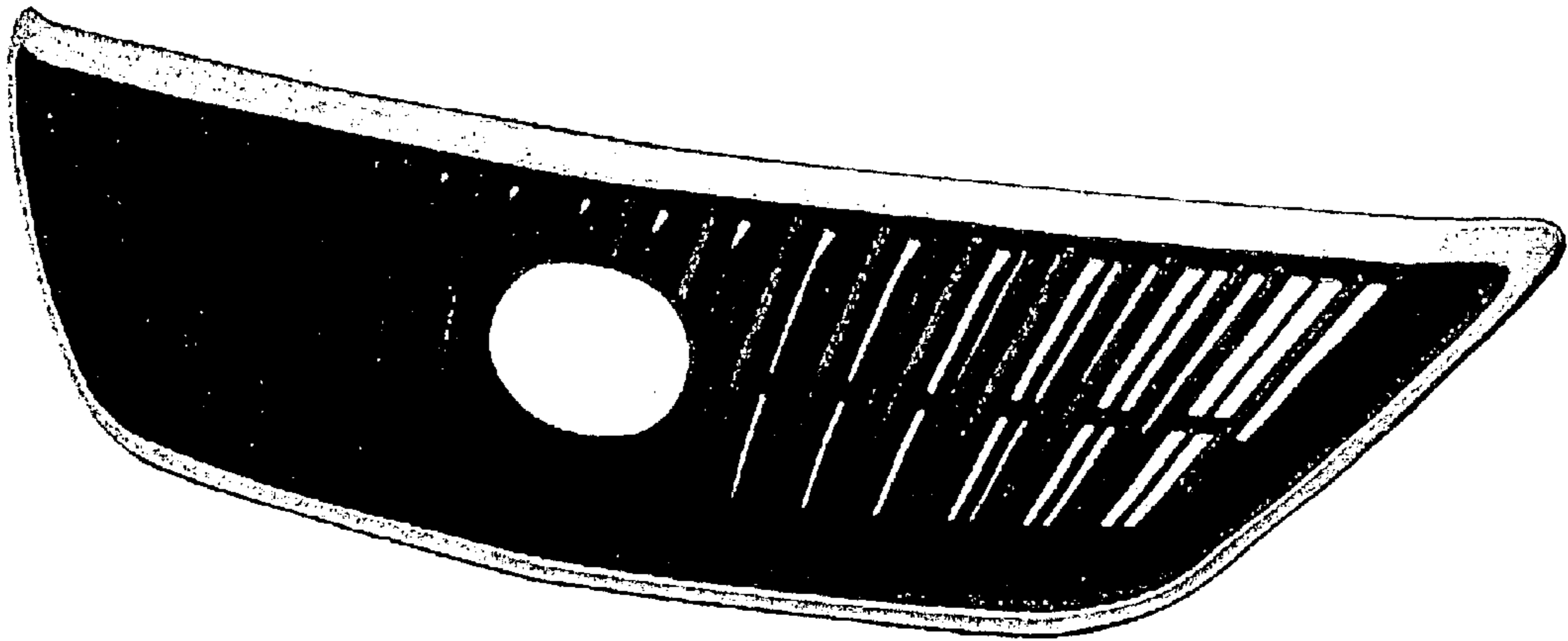

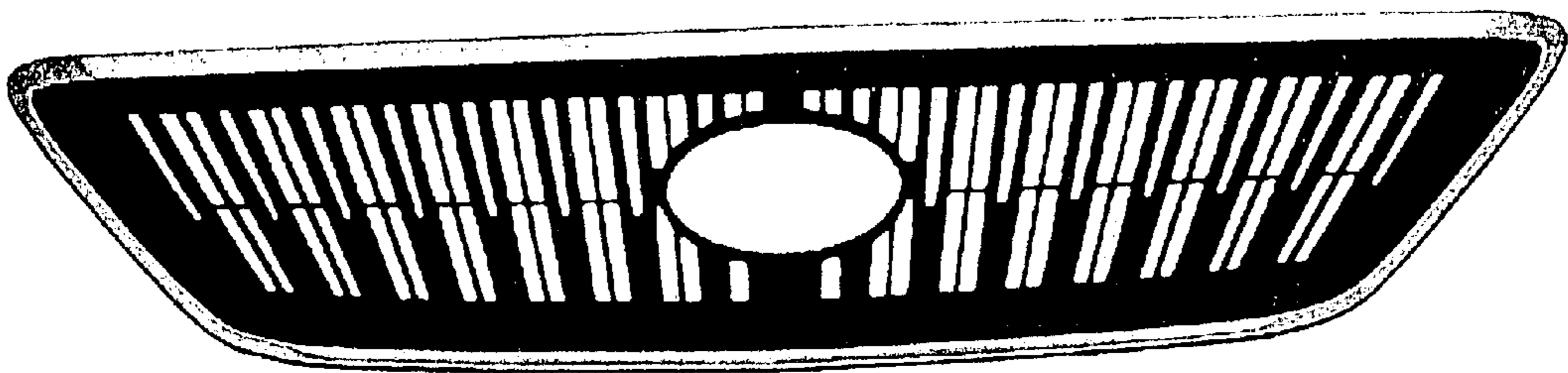

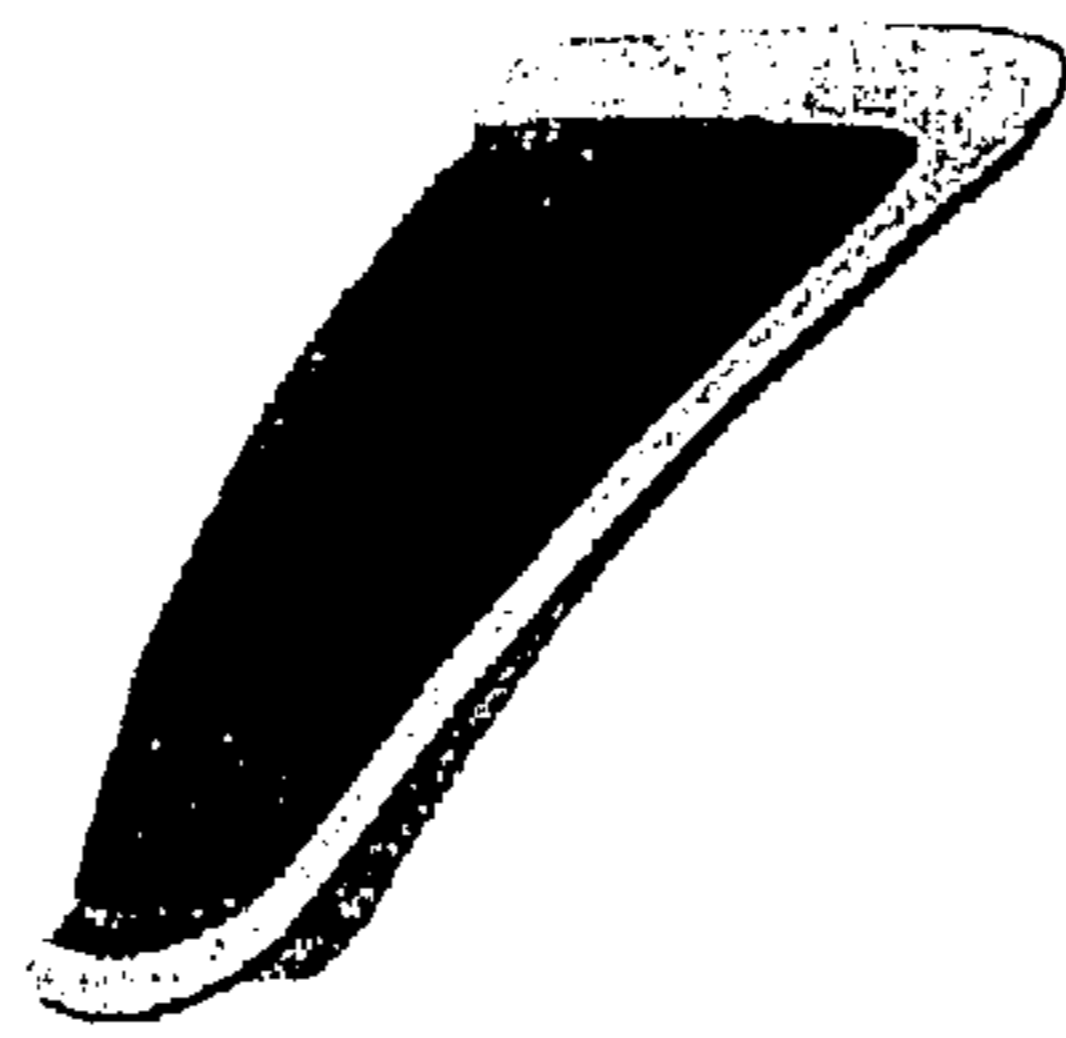

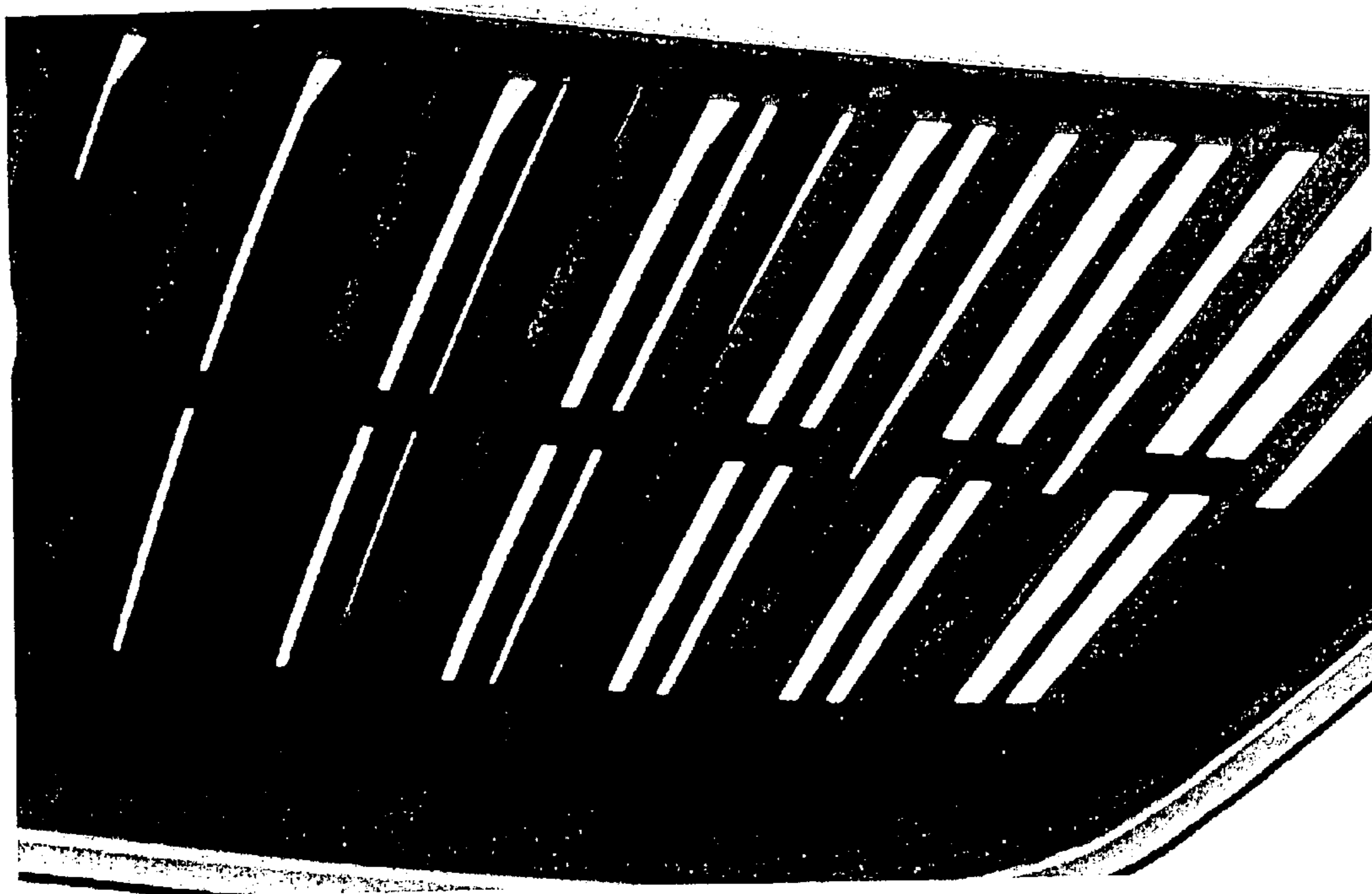
