The vehicle side mirror illustrated in FIGS. 1-7 is left-handed, and FIGS. 8-14 illustrate the right-handed version of the mirror having the same design. The broken line showing of the rectangular area in FIGS. 7 and 14 are for illustrative purposes only and forms no part of the claimed design.

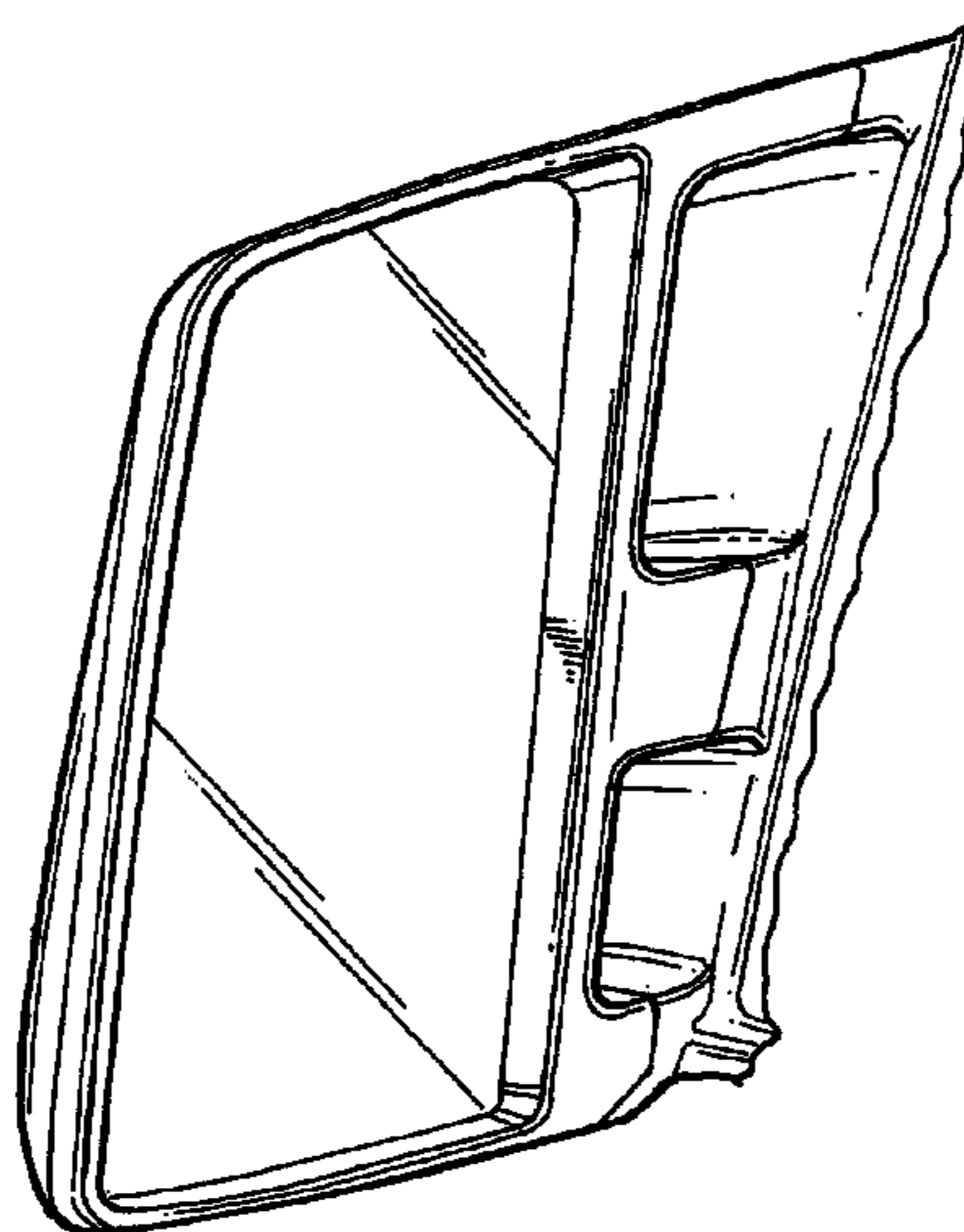

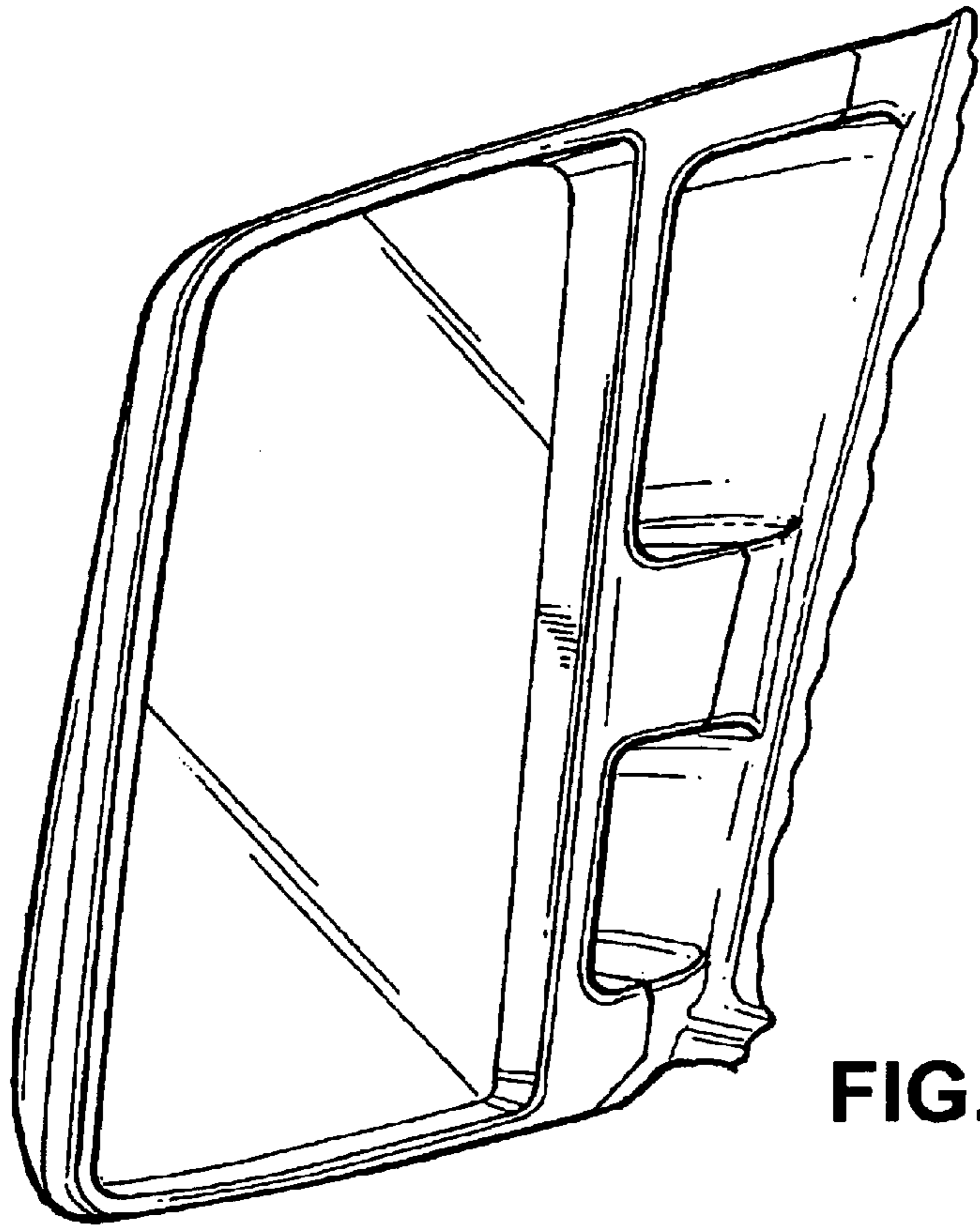

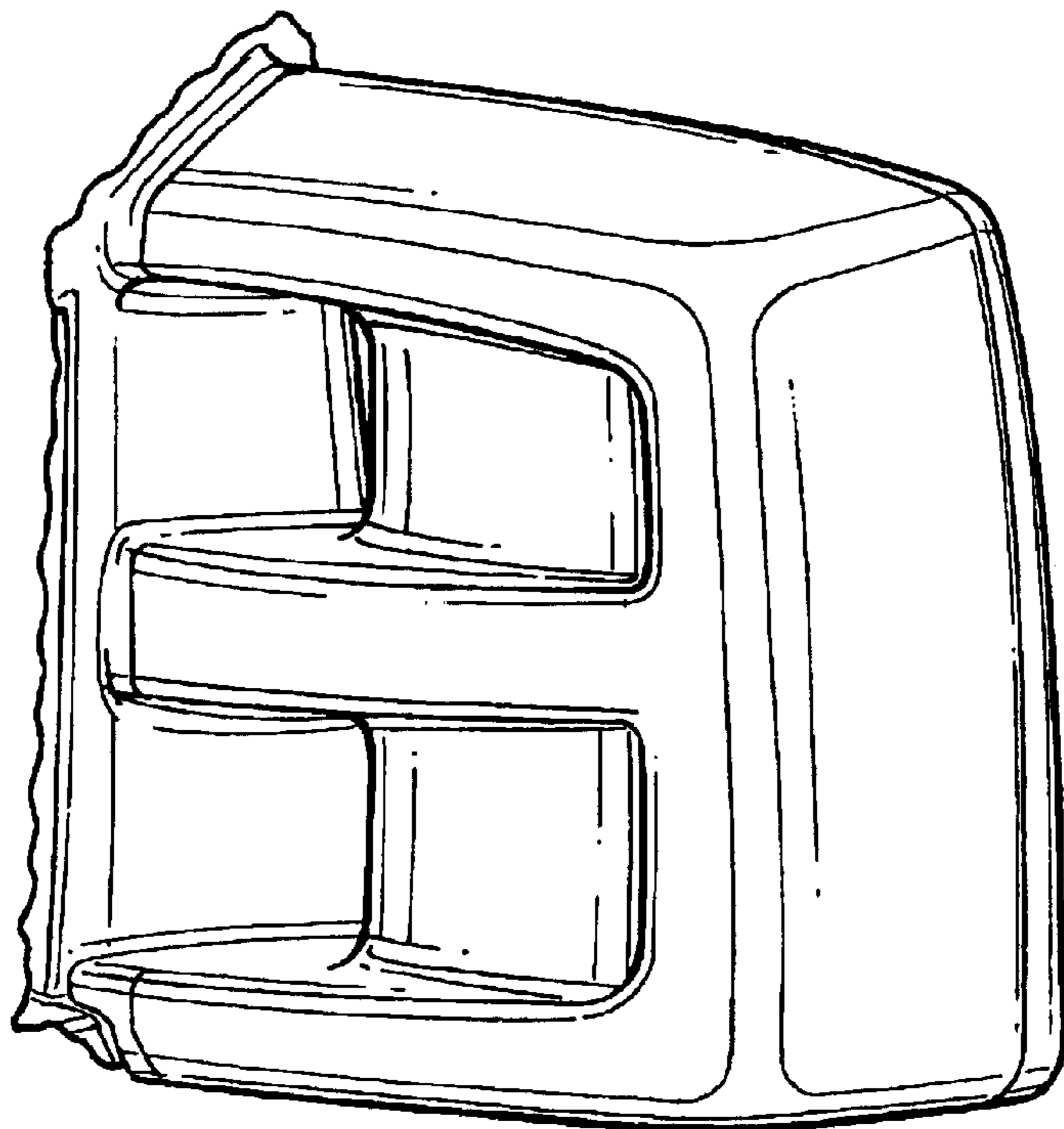

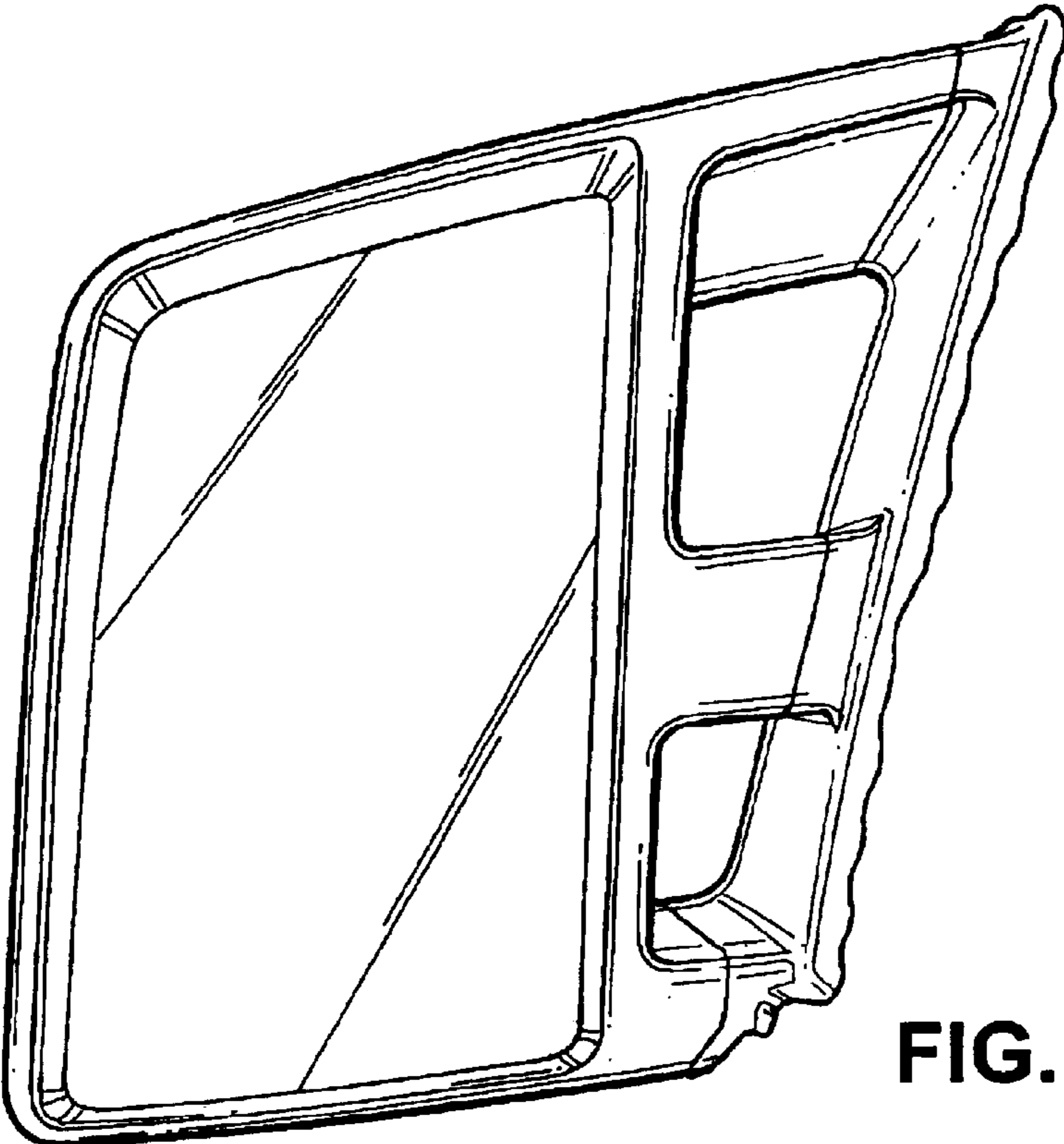

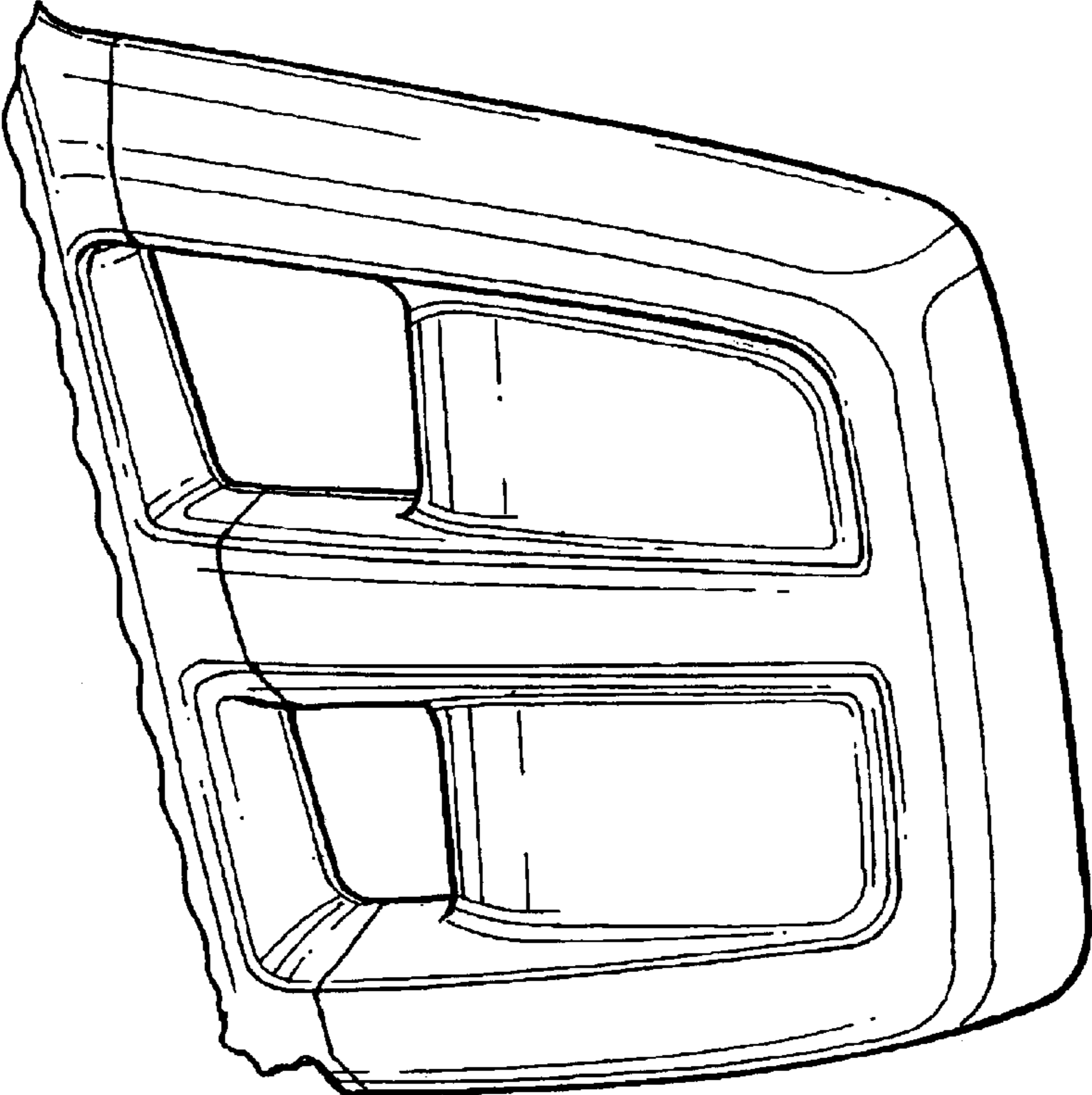

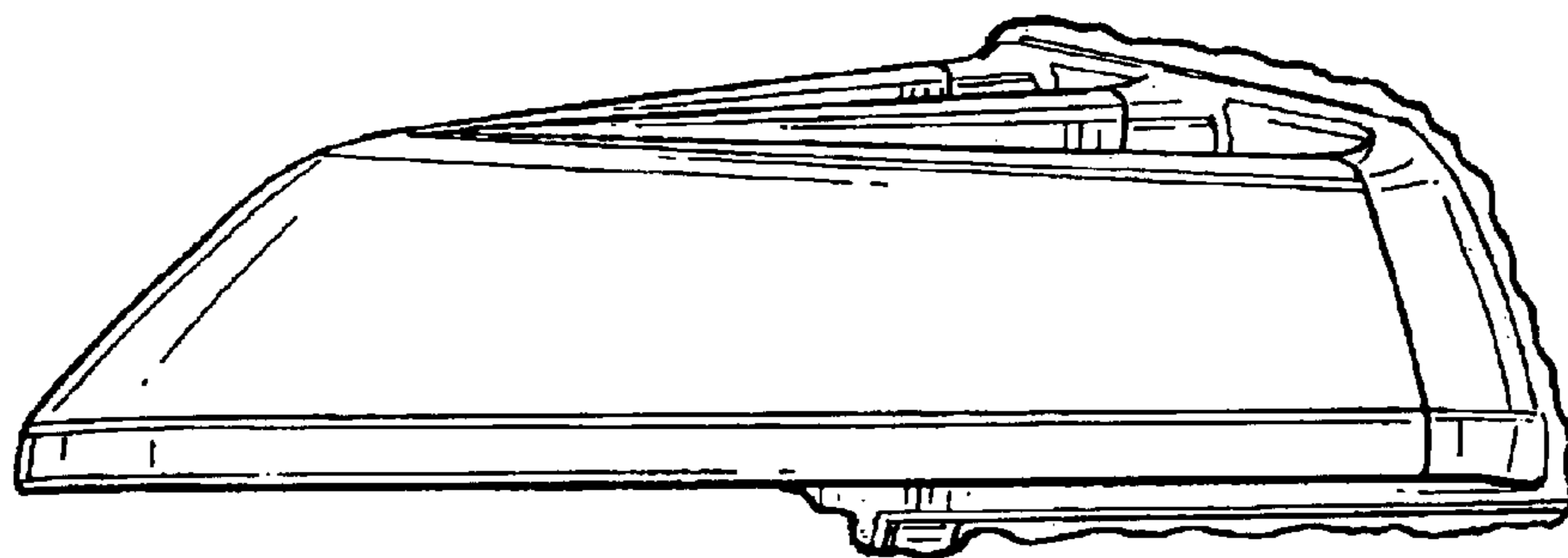

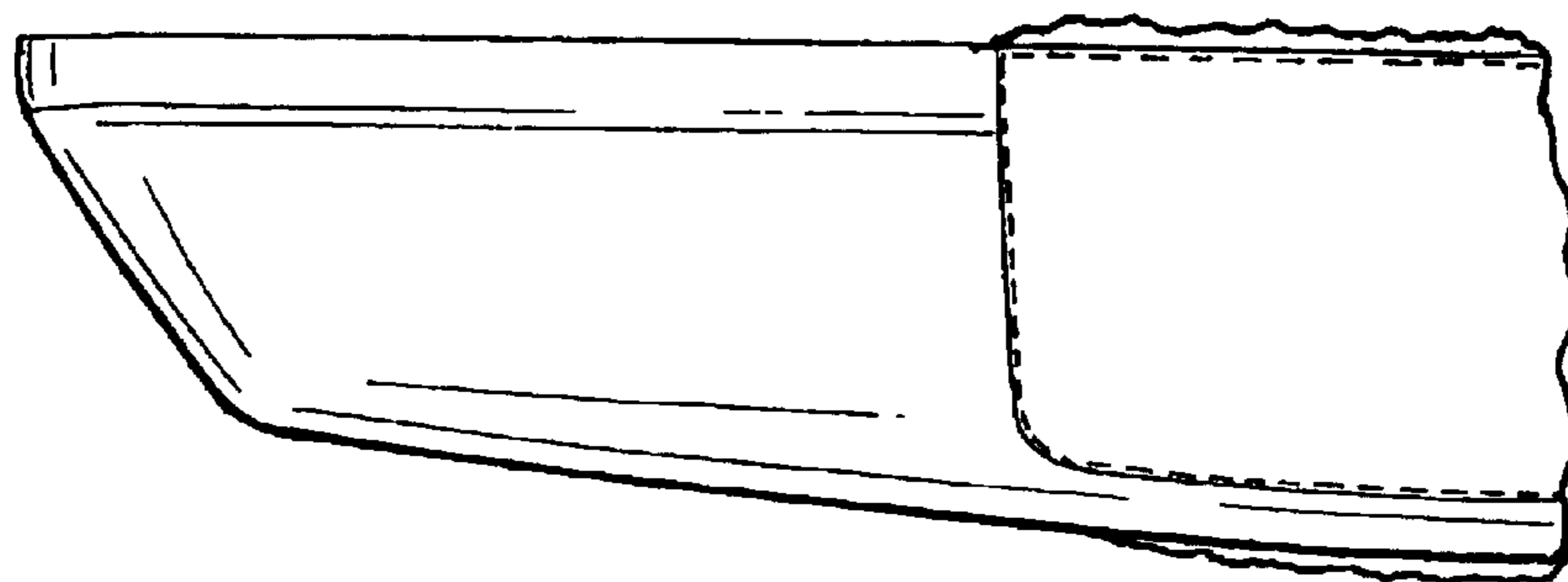

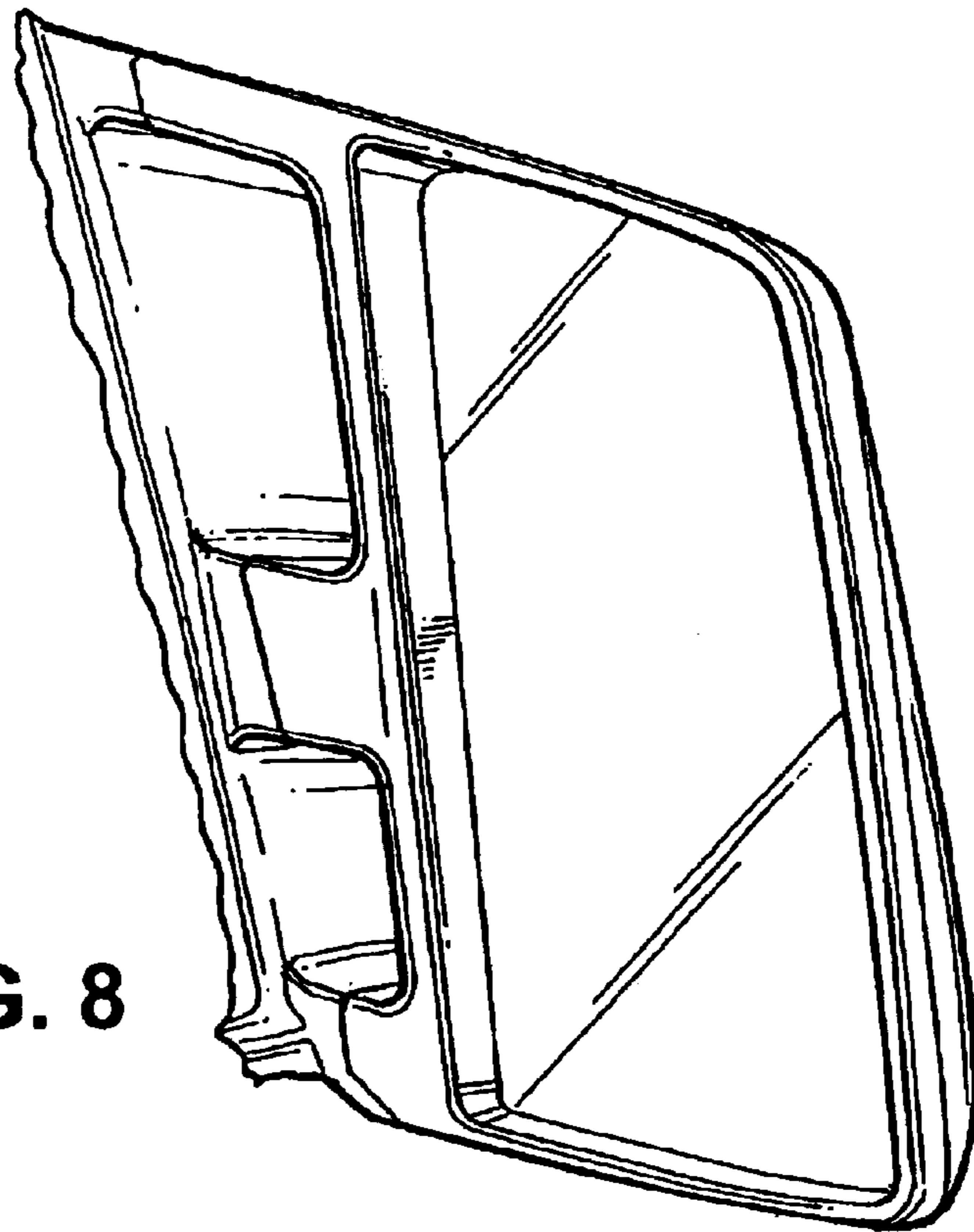

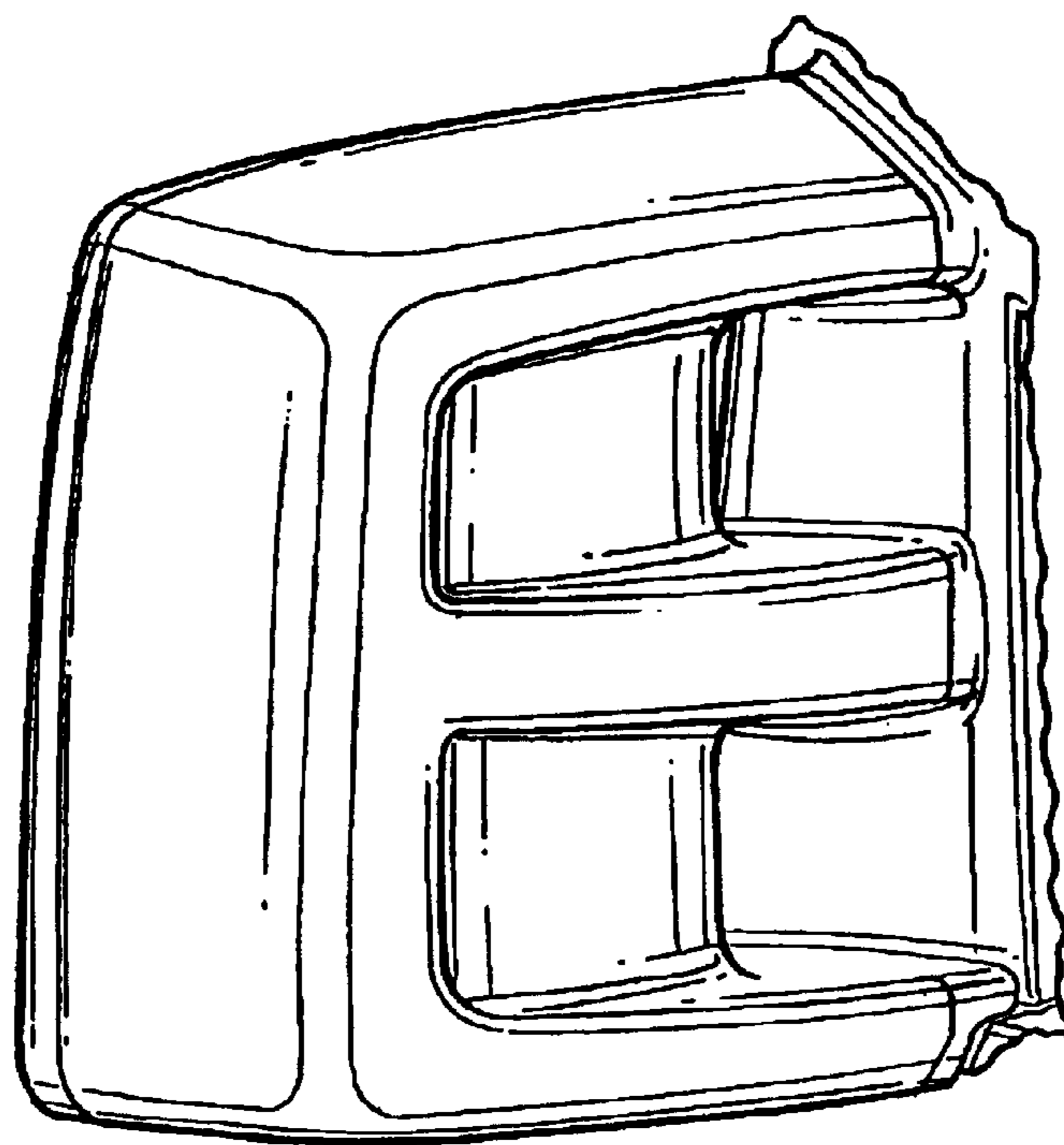

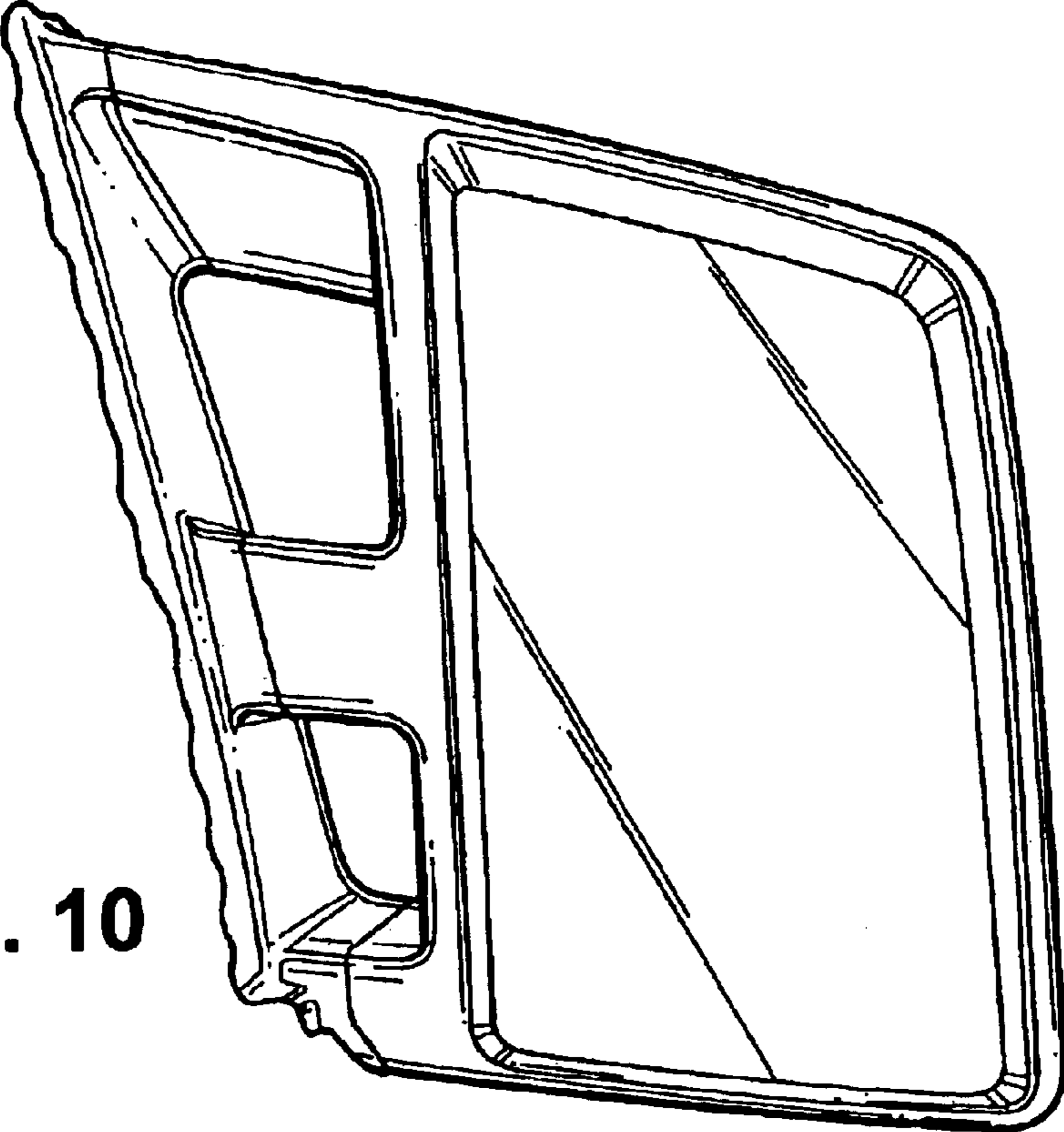

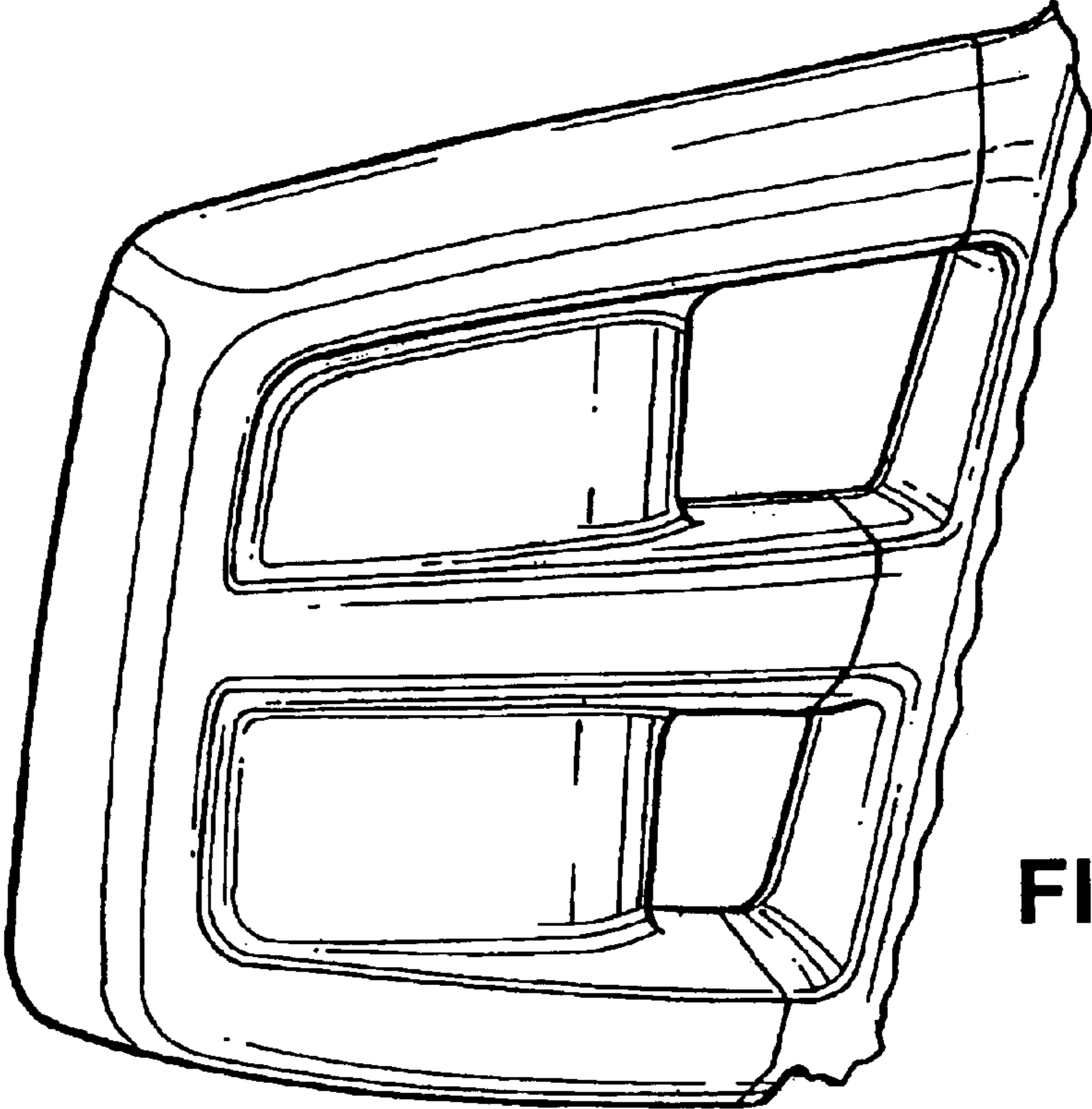

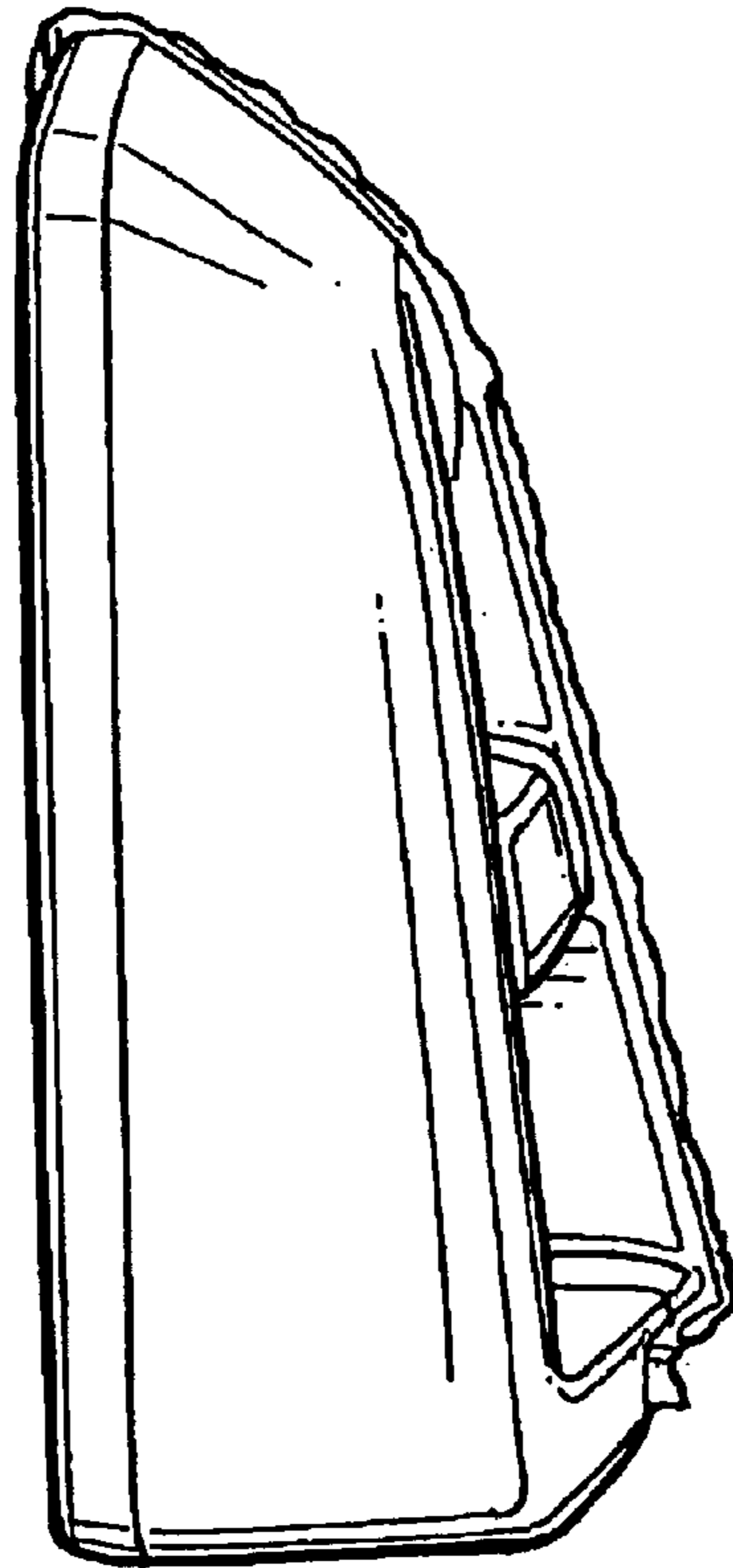

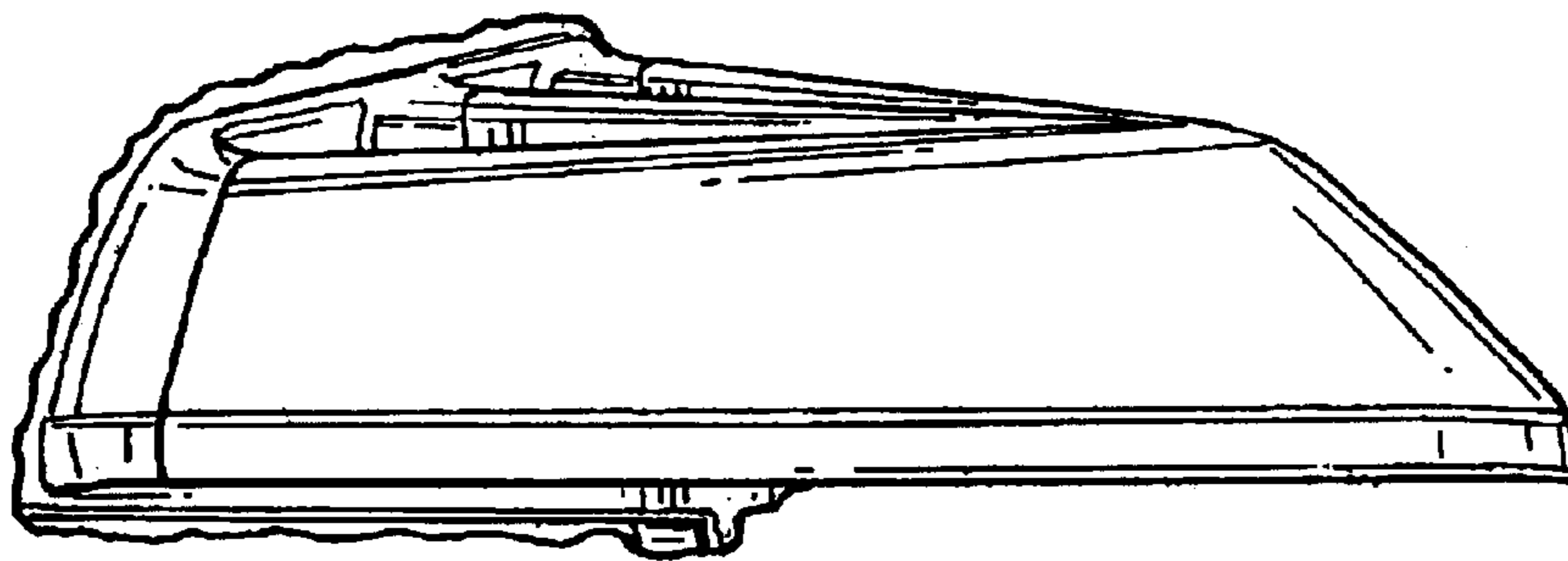

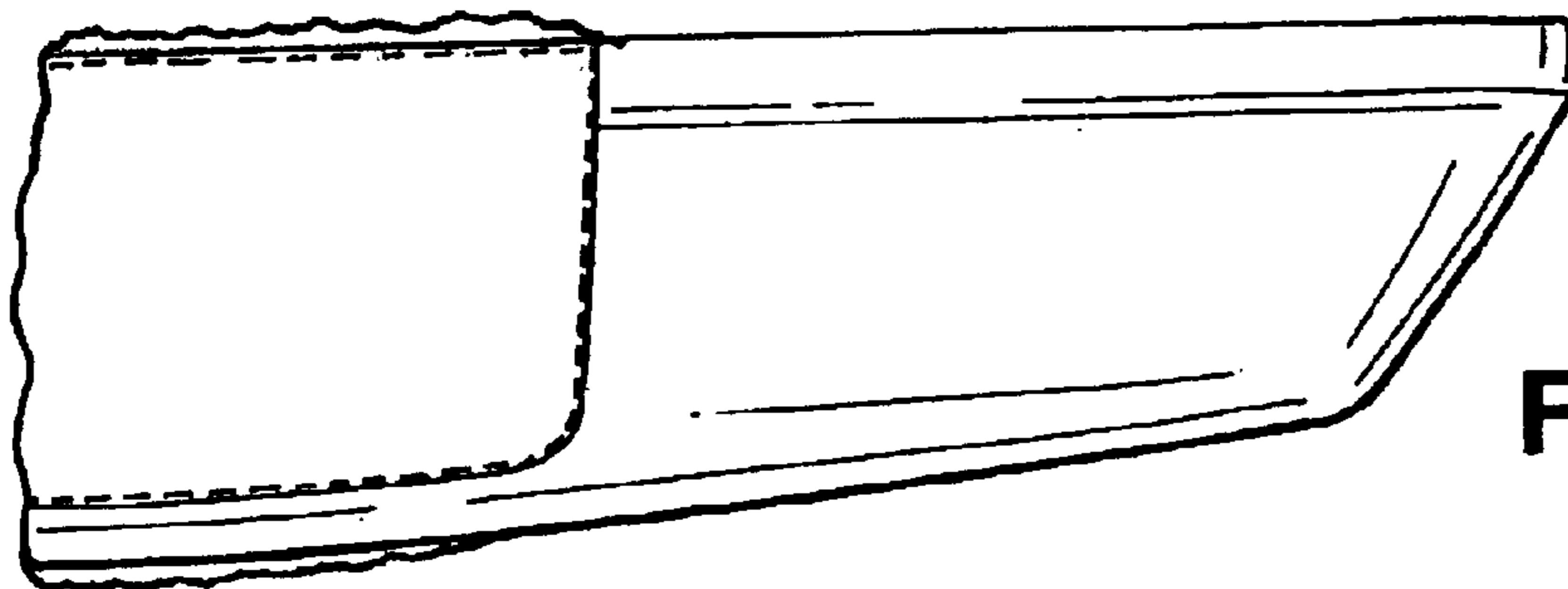
