(57) **CLAIM**

The ornamental design for an applicator, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, right perspective view of a design for an applicator with a transparent or translucent cap according to the present invention;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a back elevational view thereof;

FIG. 4 is left-side elevational view thereof;

FIG. 5 is right-side elevational view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof; and

FIG. 8 is a perspective view thereof with the cap on the bottom end and the applicator in a use position;

FIG. 9 is a front, right perspective view of a design for an applicator according to the present invention;

FIG. 10 is a front elevational view thereof;

FIG. 11 is a back elevational view thereof;

FIG. 12 is left-side elevational view thereof;

FIG. 13 is right-side elevational view thereof;

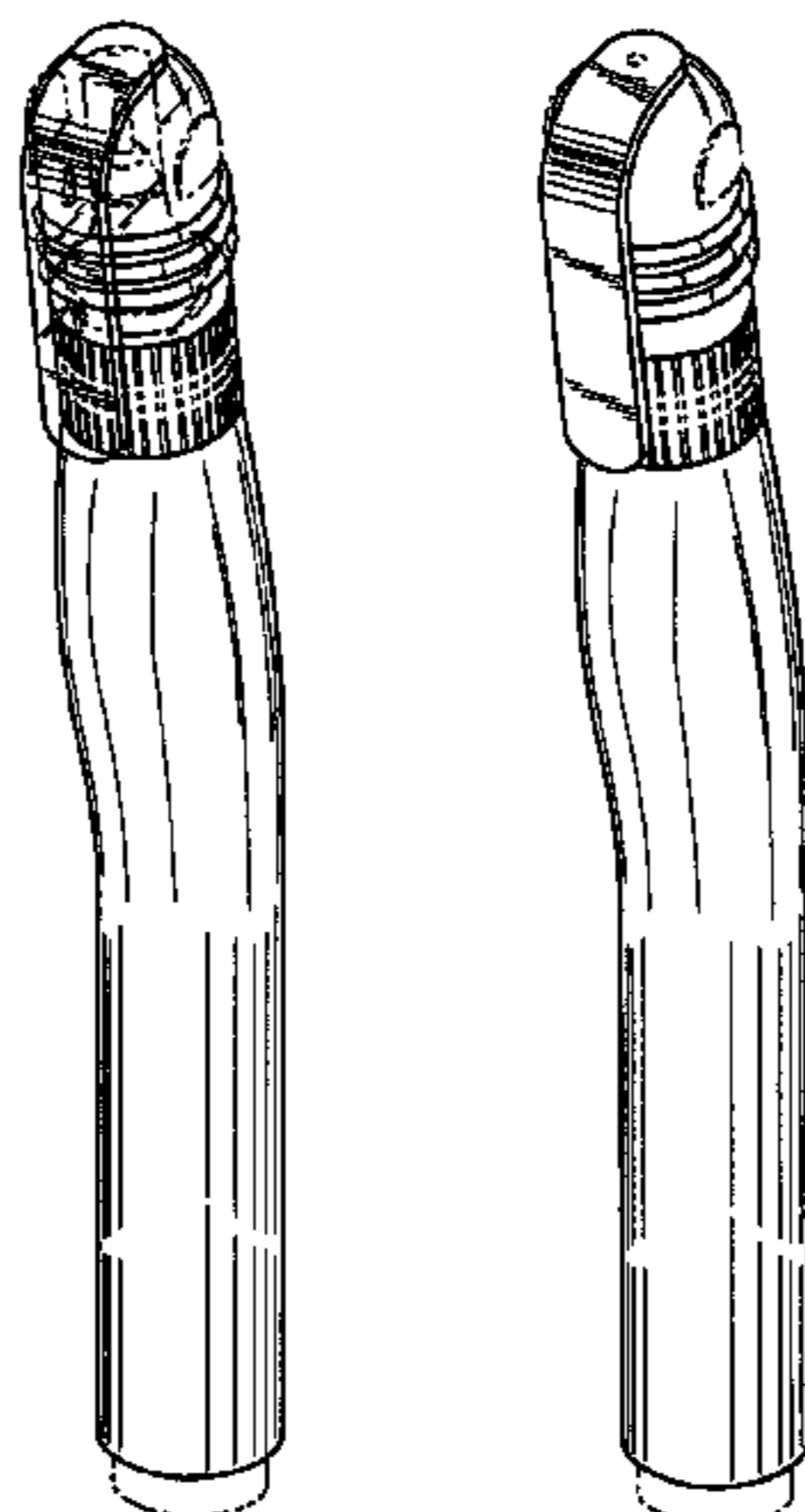
FIG. 14 is a top plan view thereof;

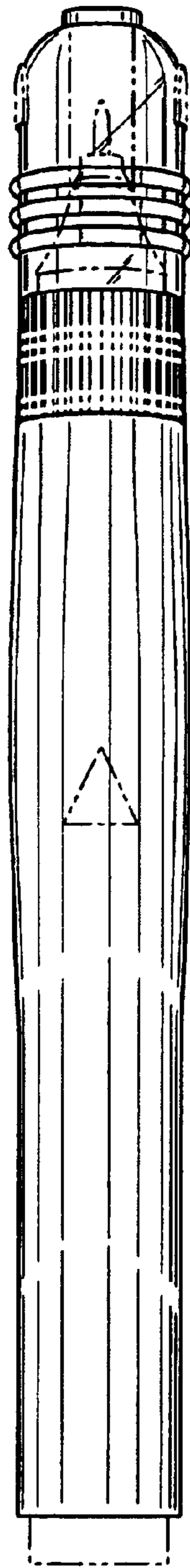

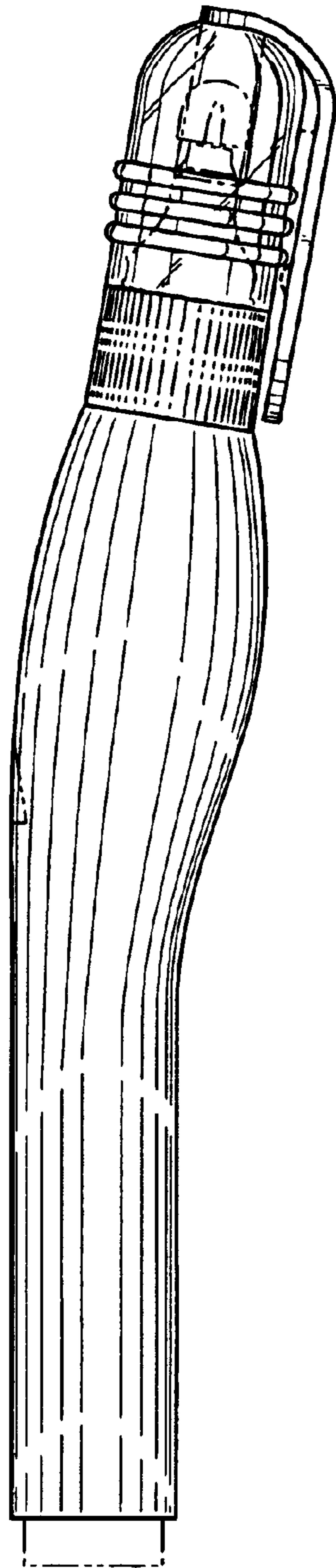

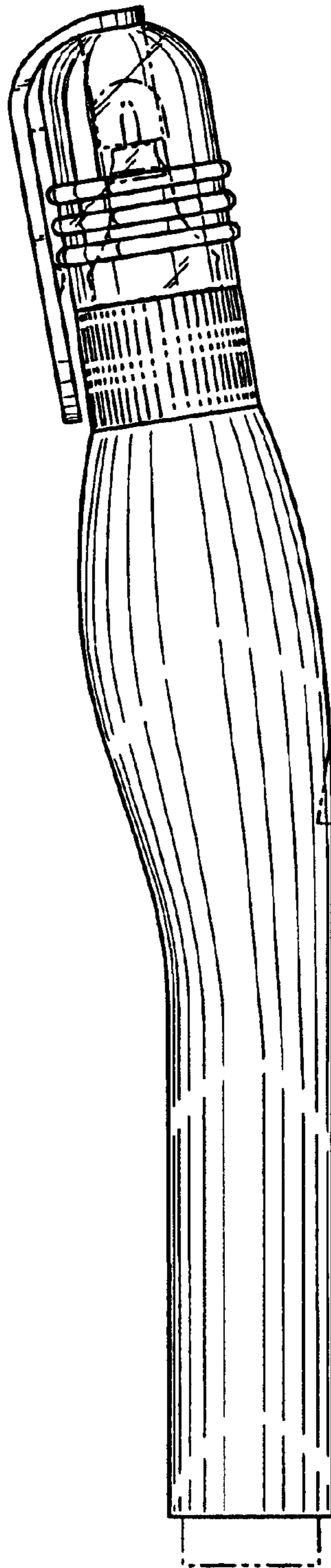

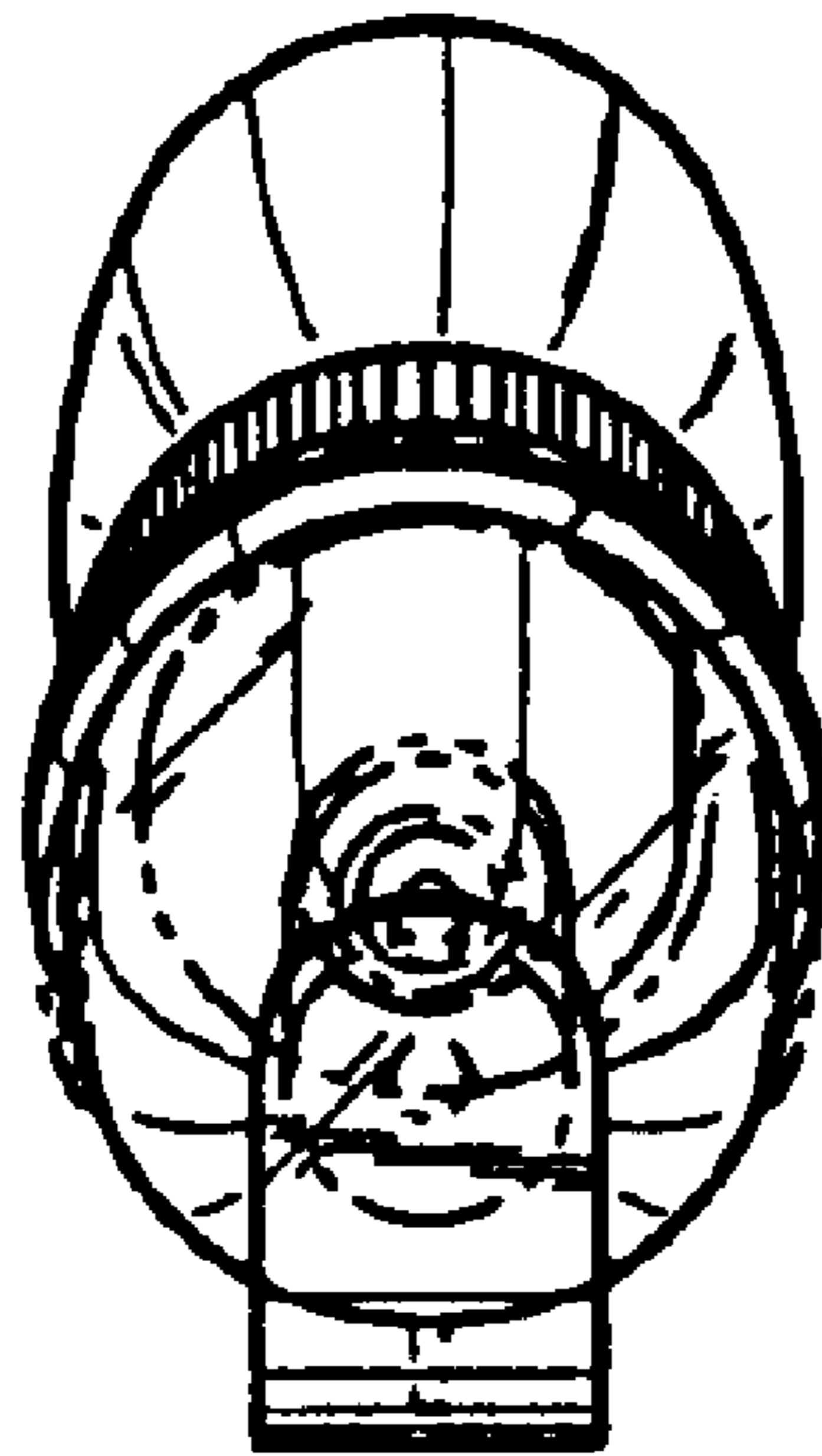

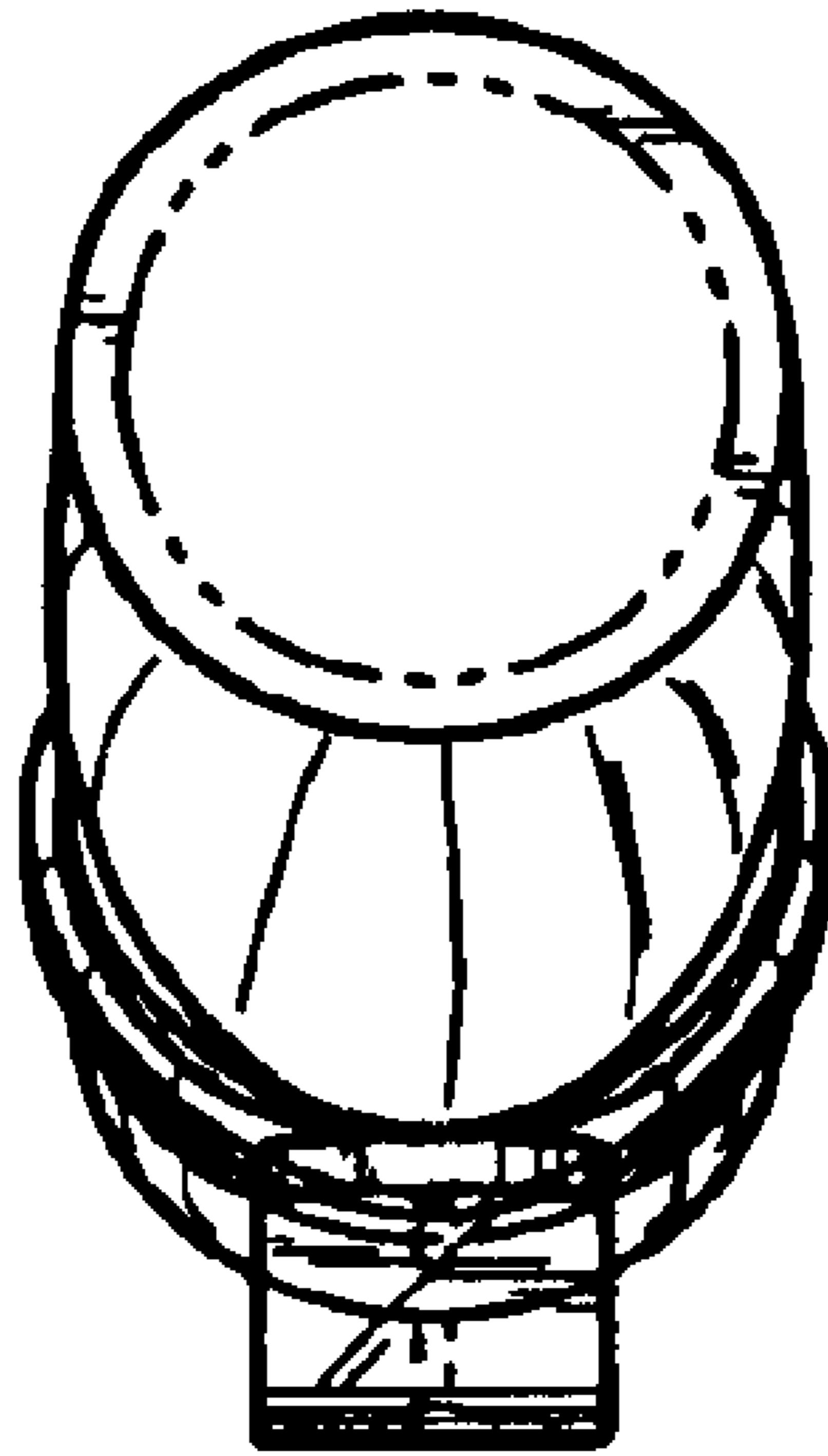

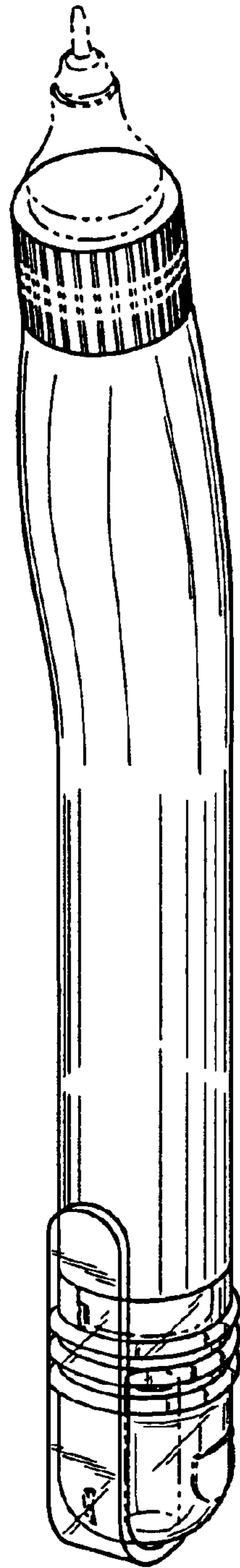

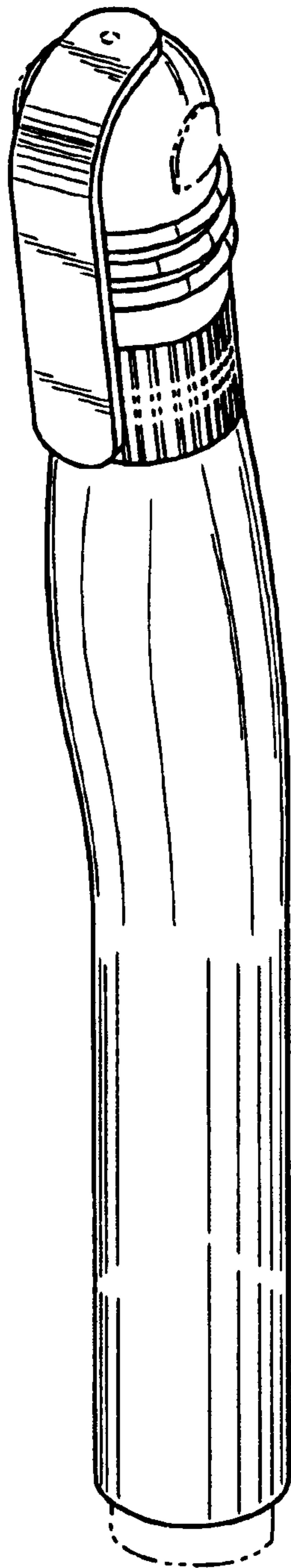




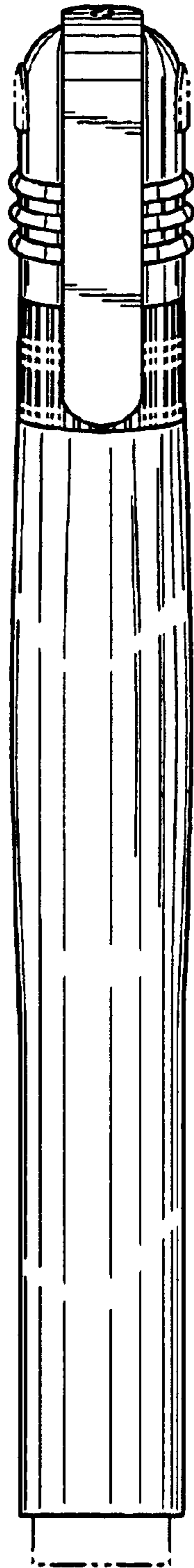

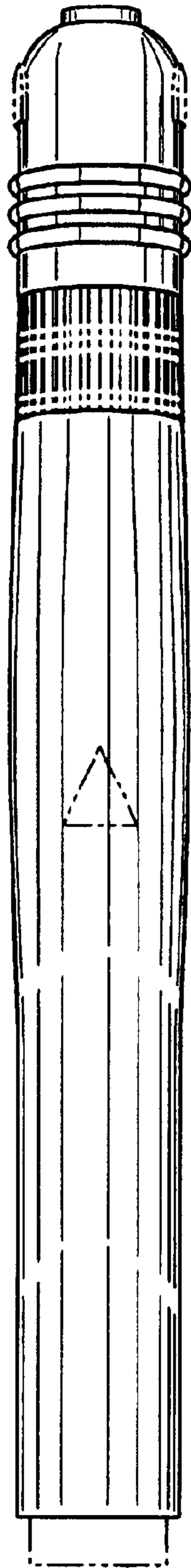

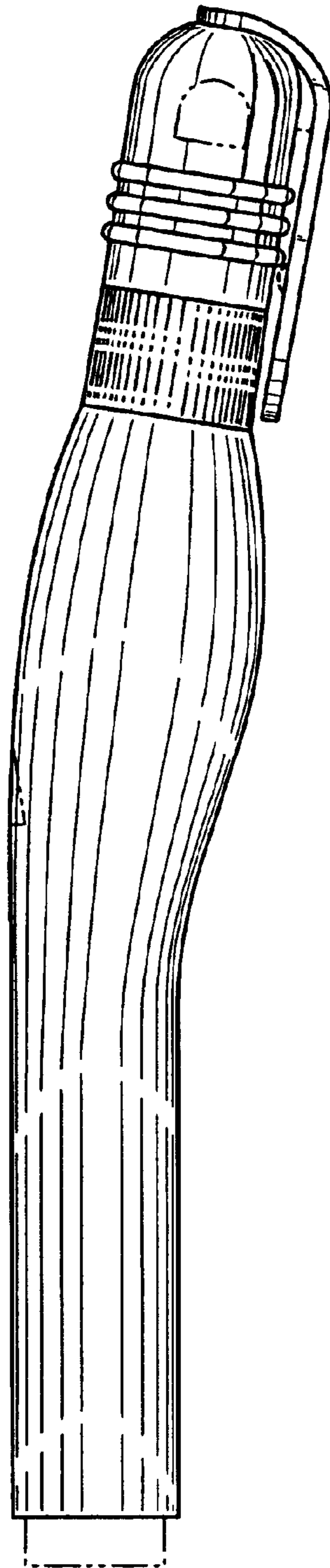

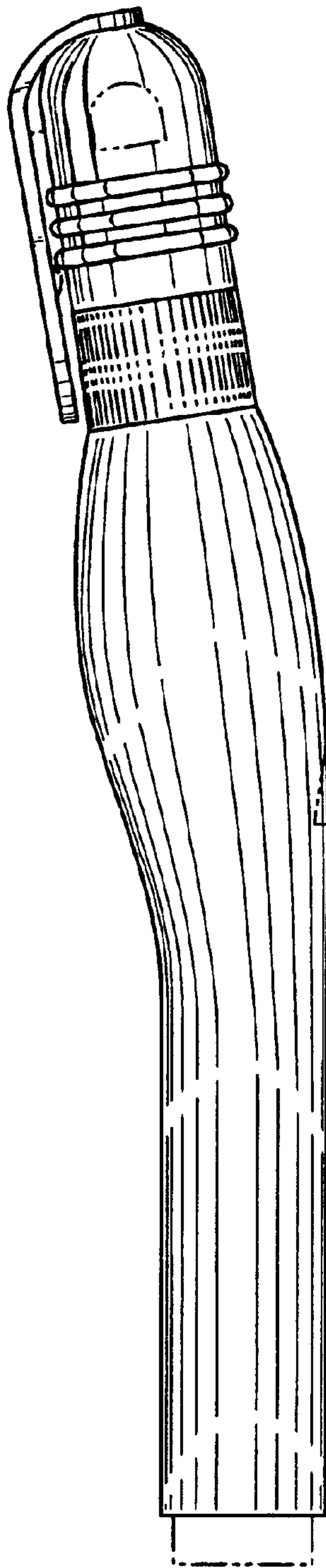

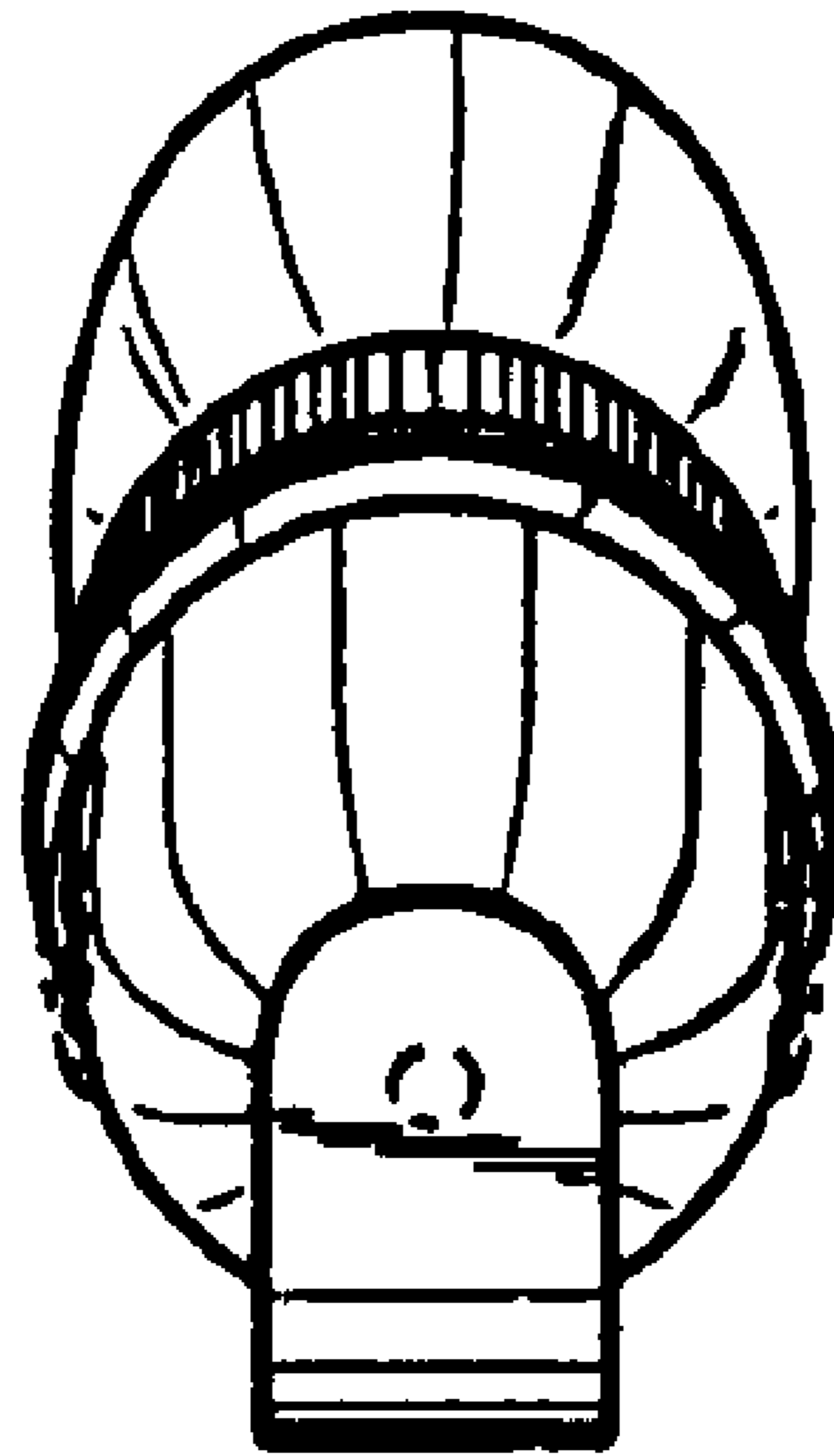

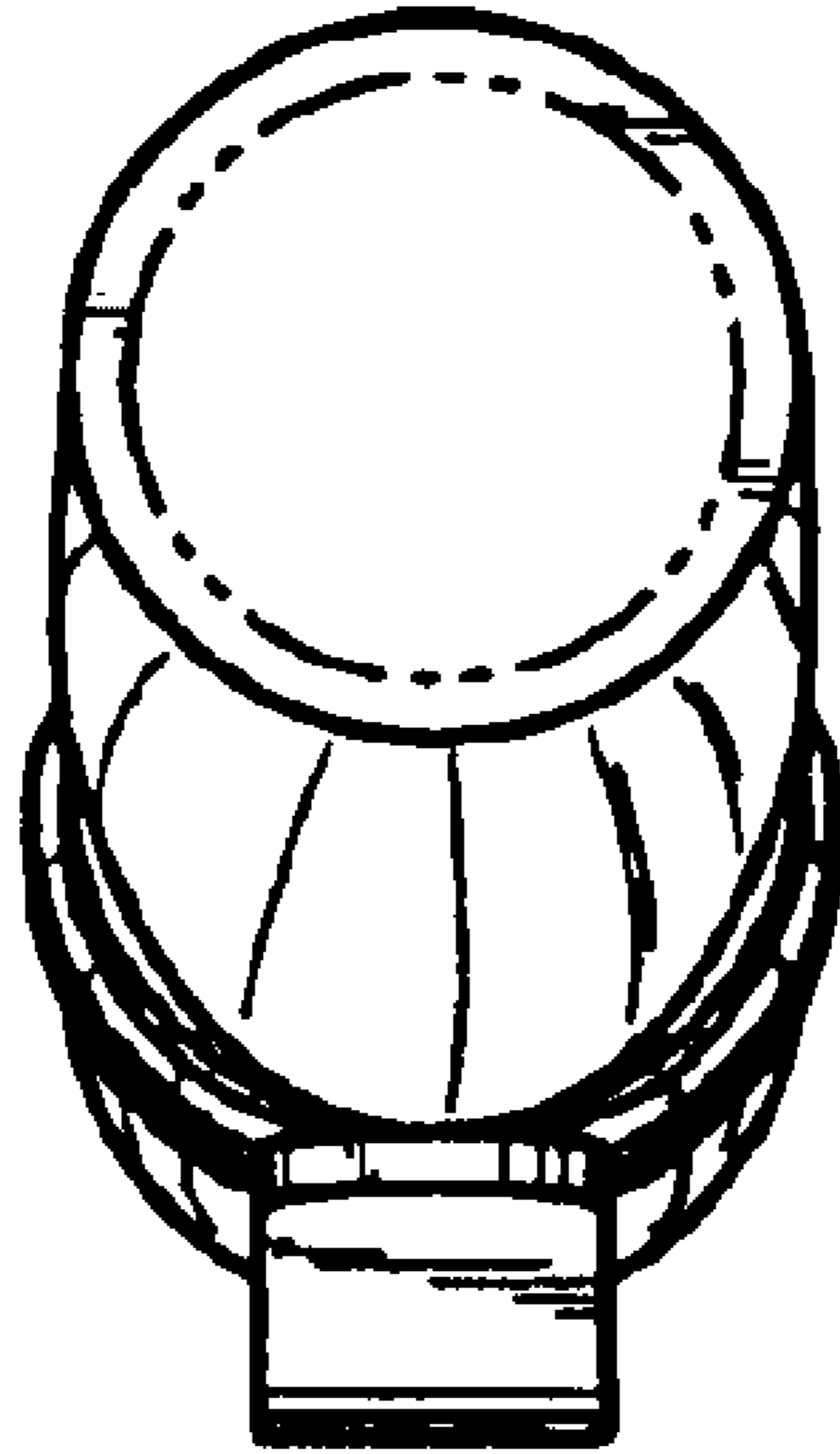

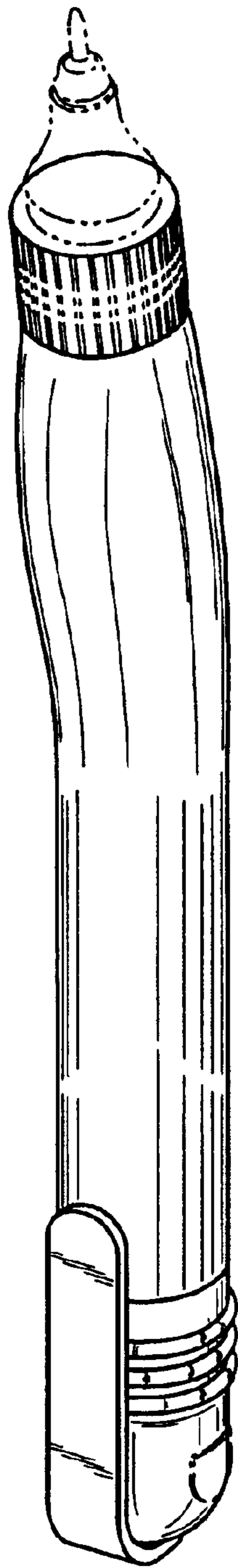
