DESCRIPTION

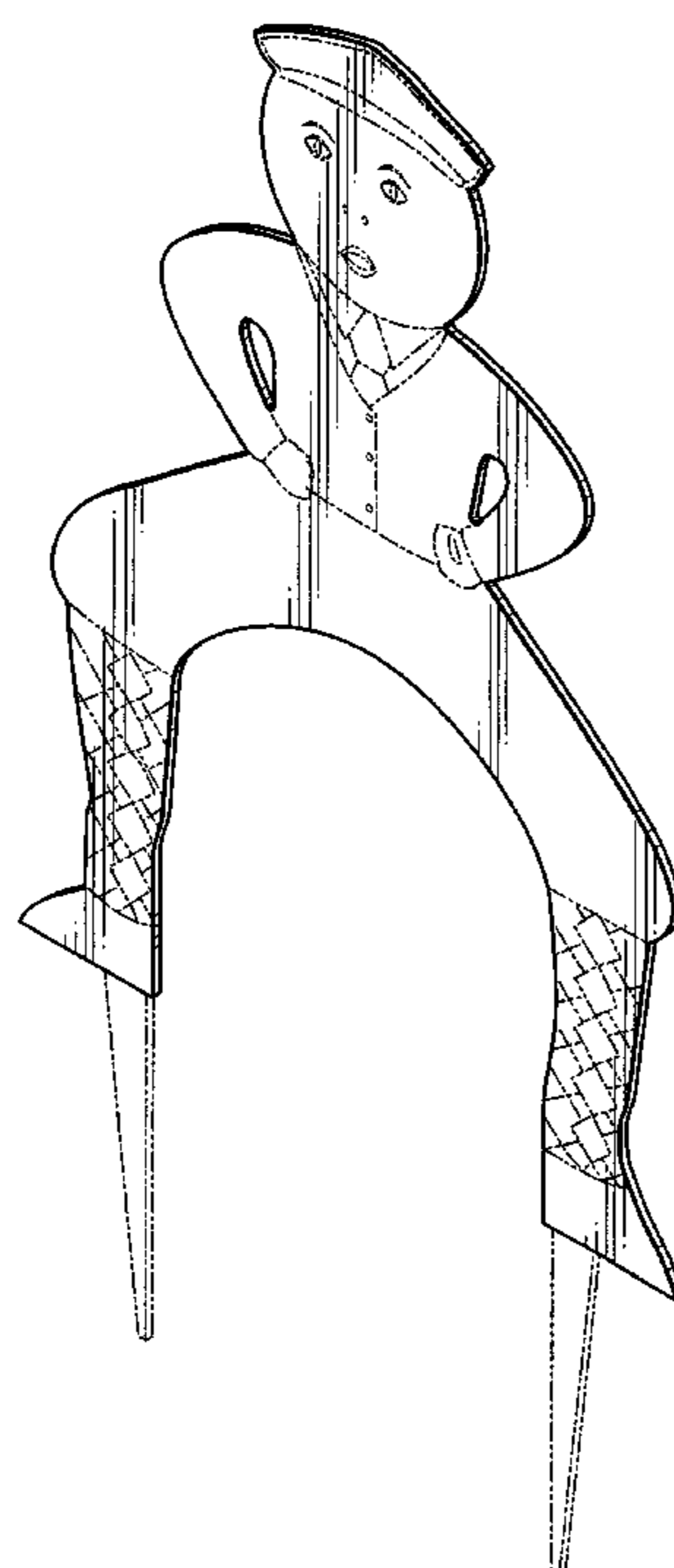
FIG. 1 is a perspective view of the front of the croquet wicket;

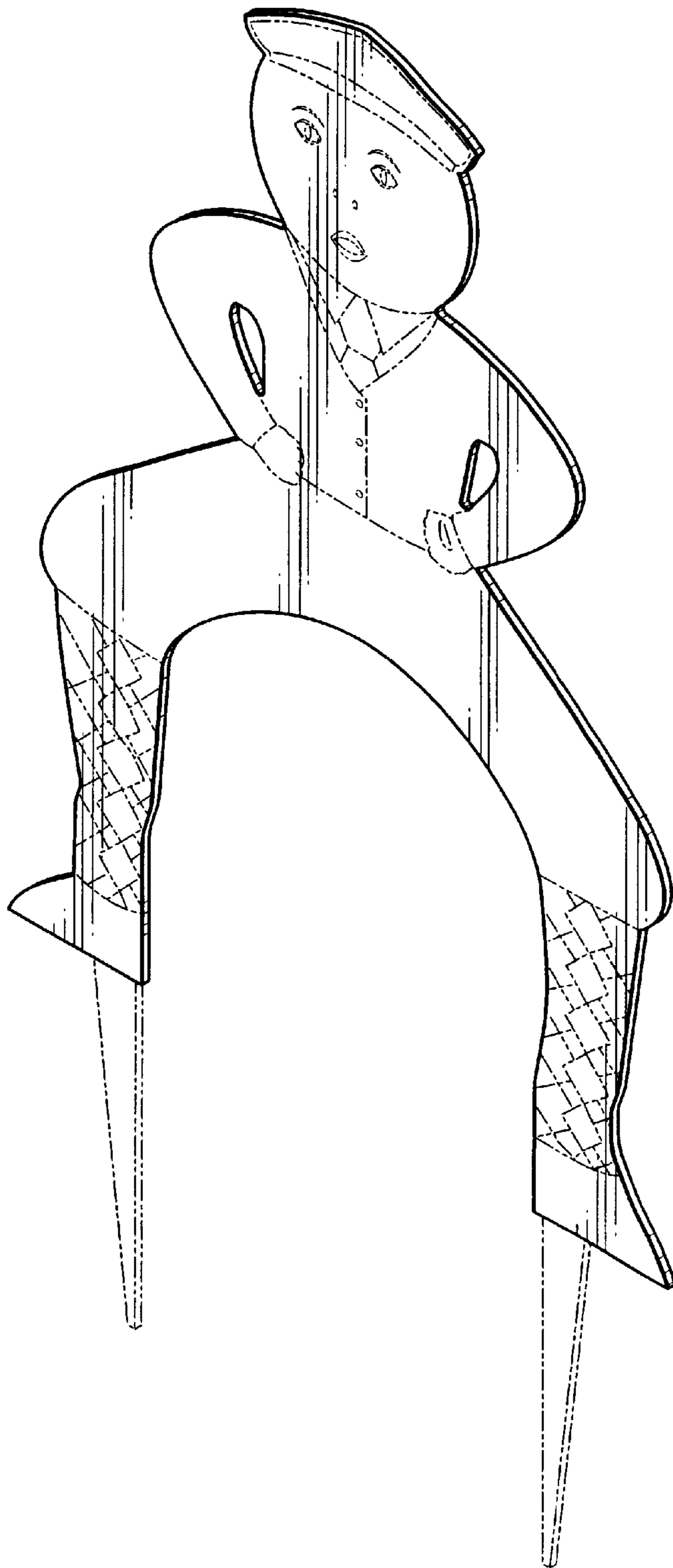

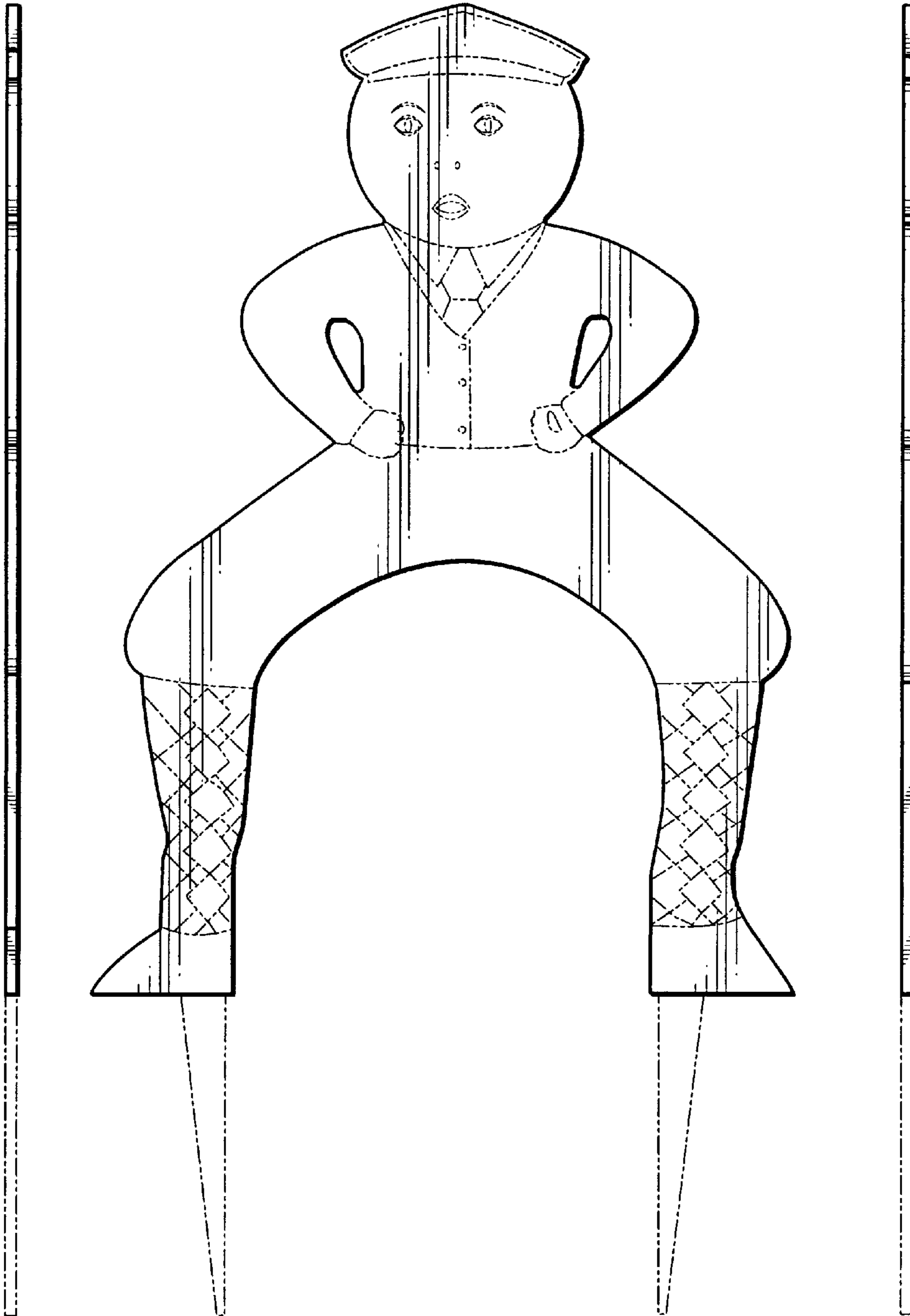

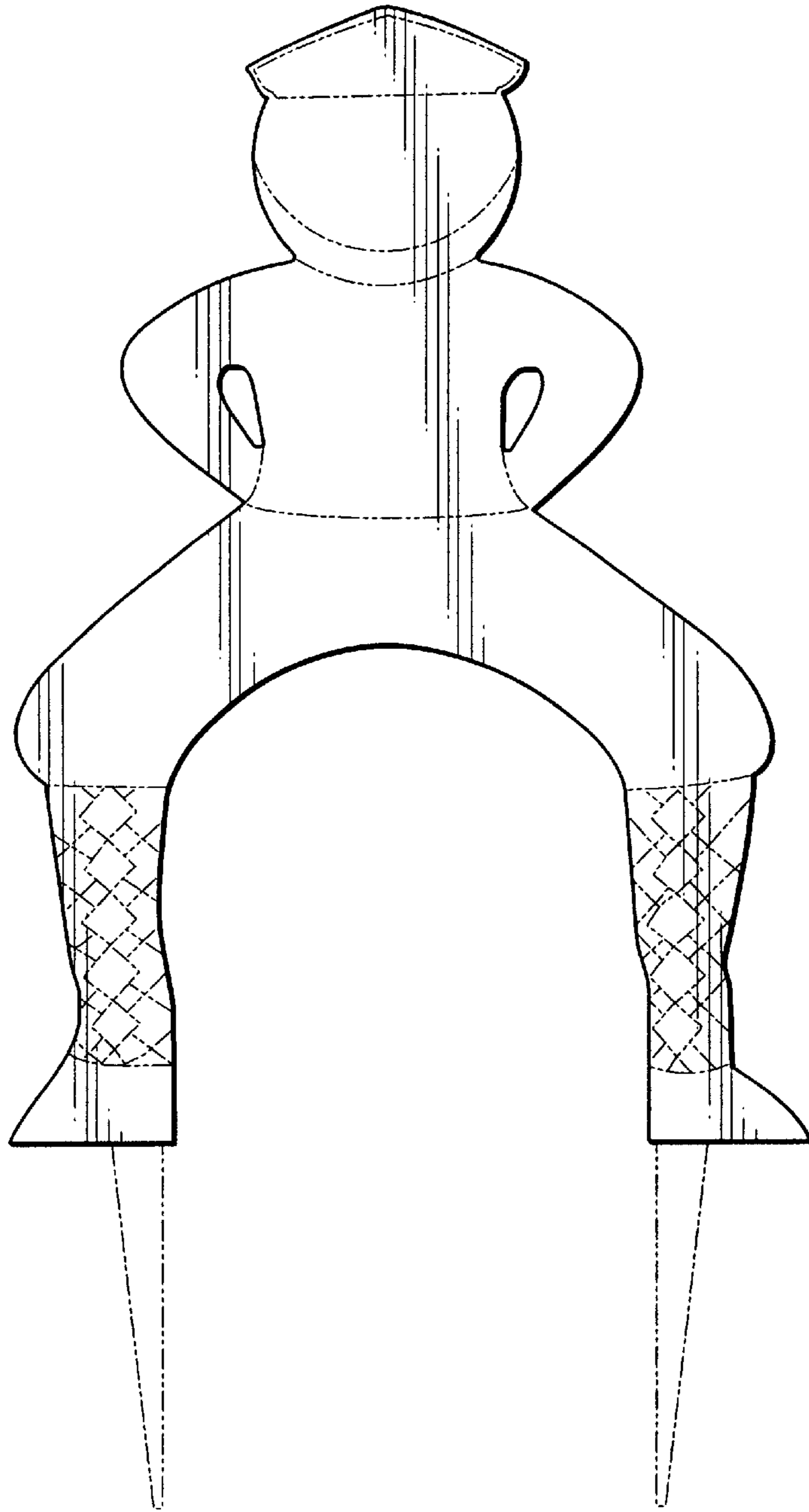
