We claim the ornamental design for a wrestling ear guard, as shown and described.

DESCRIPTION

FIG. 1 is a left side perspective view of a wrestling ear guard showing our new design;
FIG. 2 is a left side view thereof;
FIG. 3 is a left end view thereof;
FIG. 4 is a right end view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.
The straps shown in broken lines are for illustrative purposes only and form no part of the claimed design.

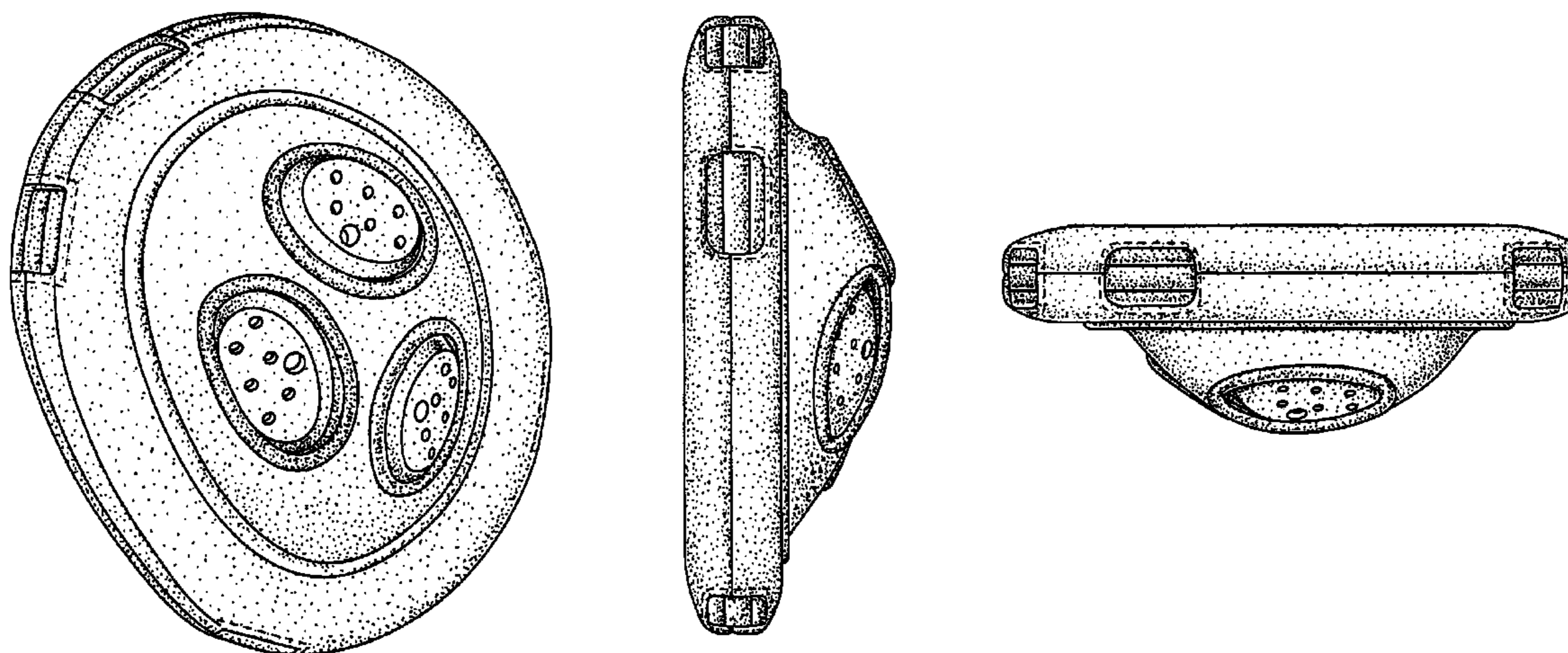

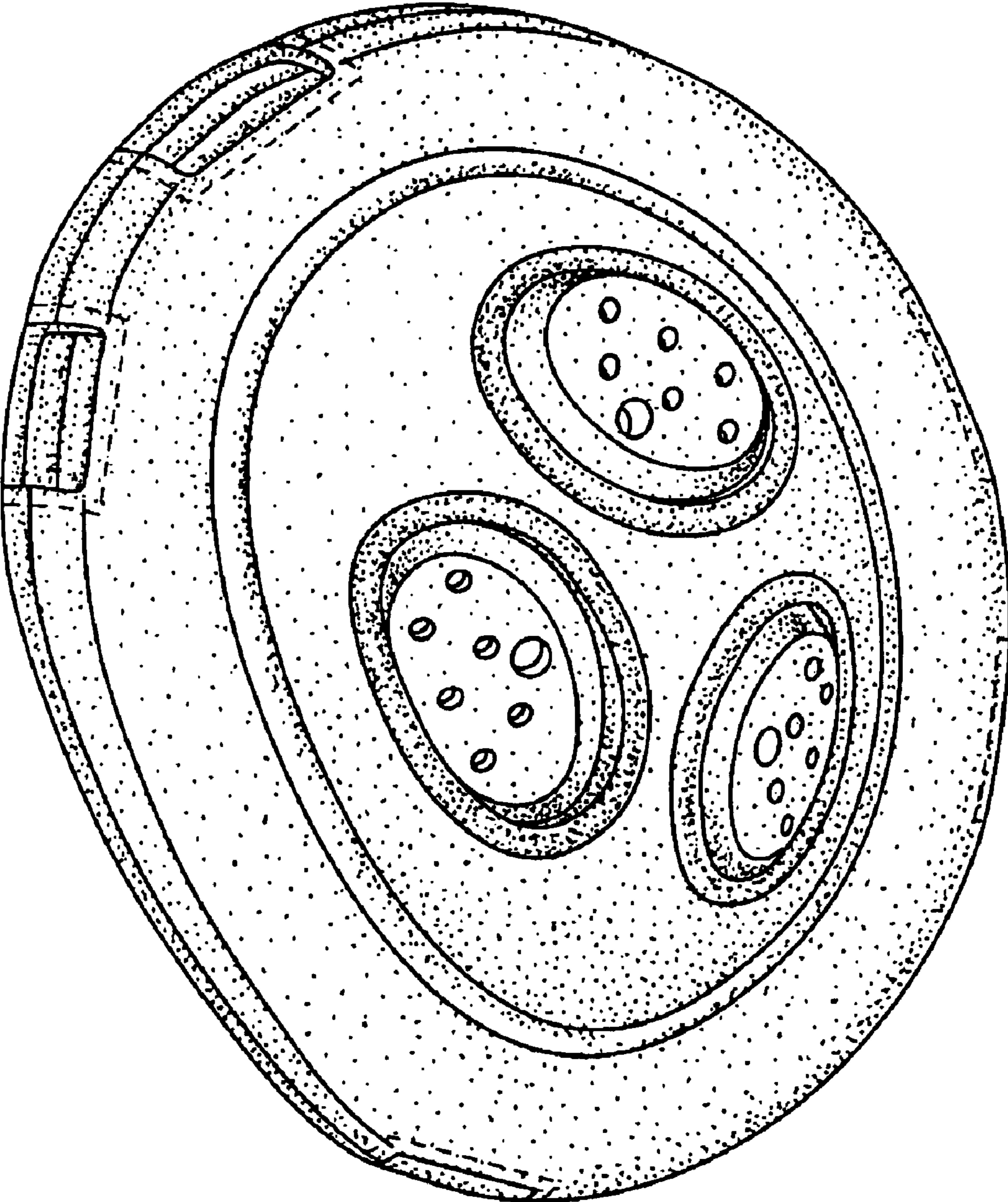

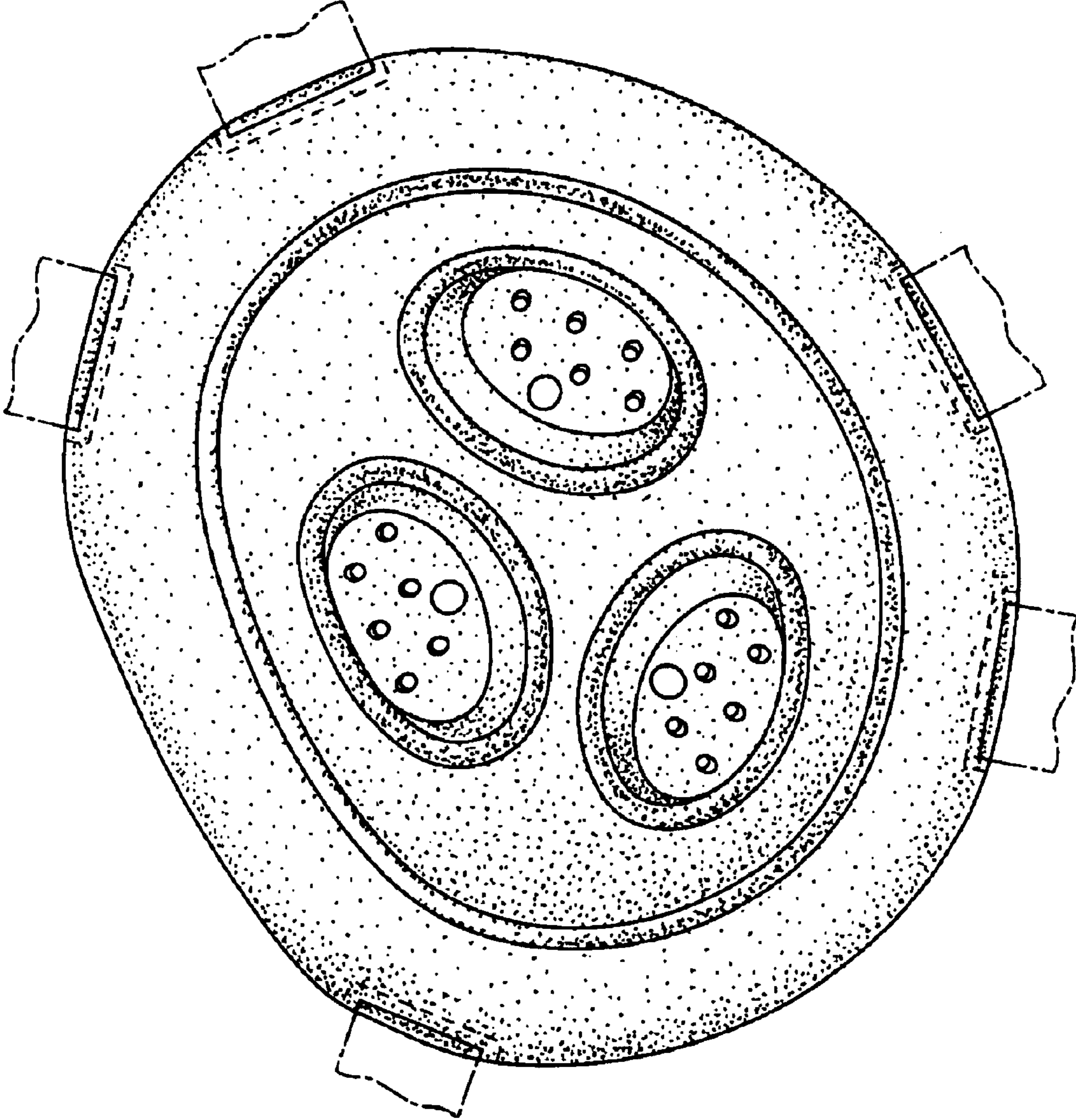

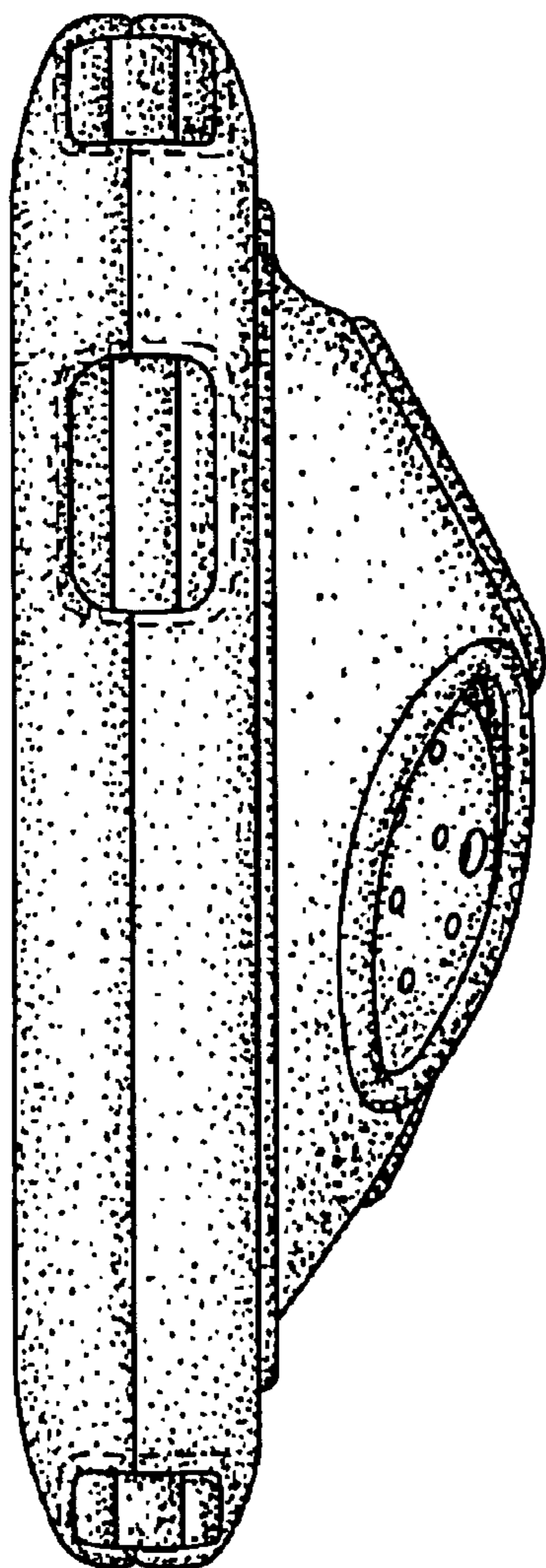

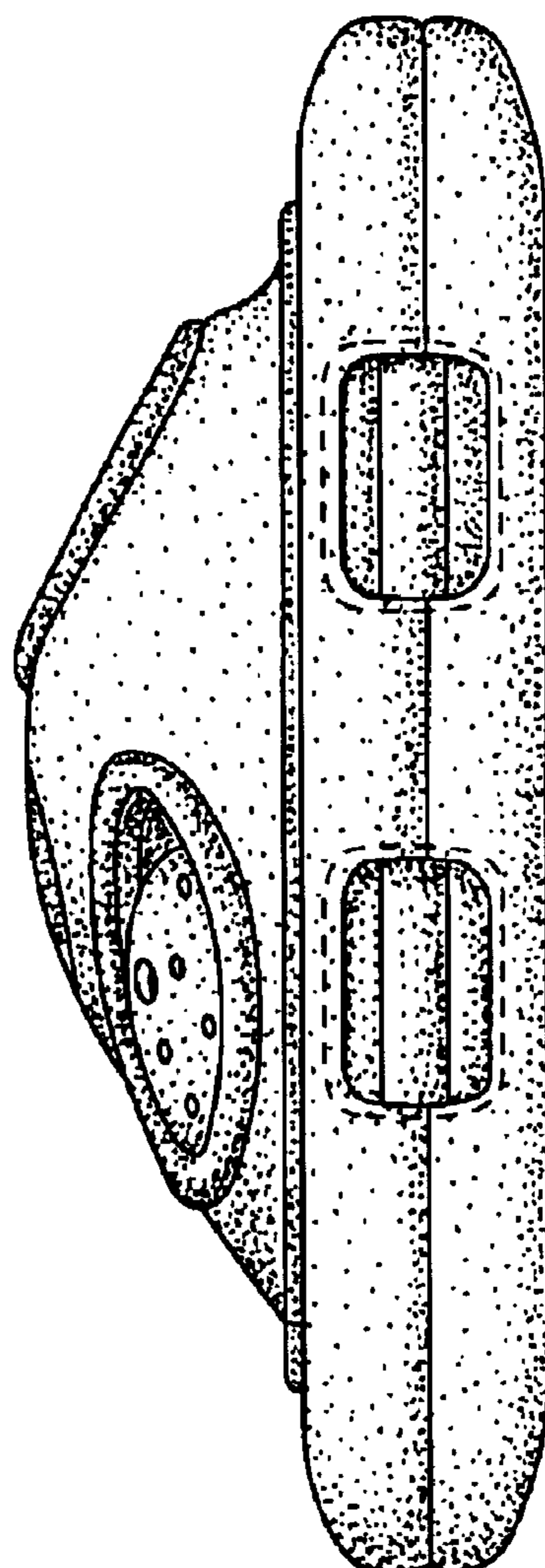

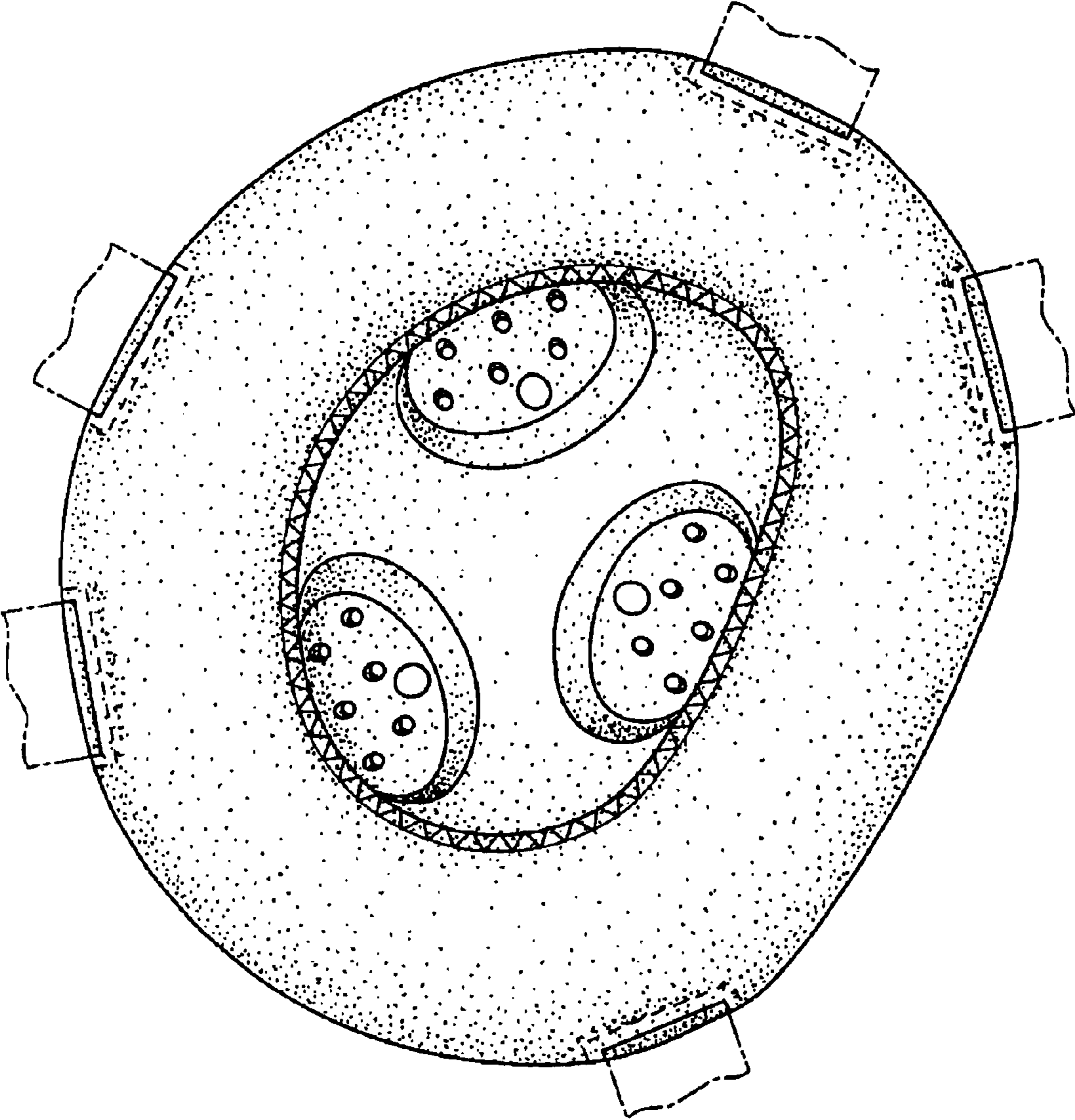

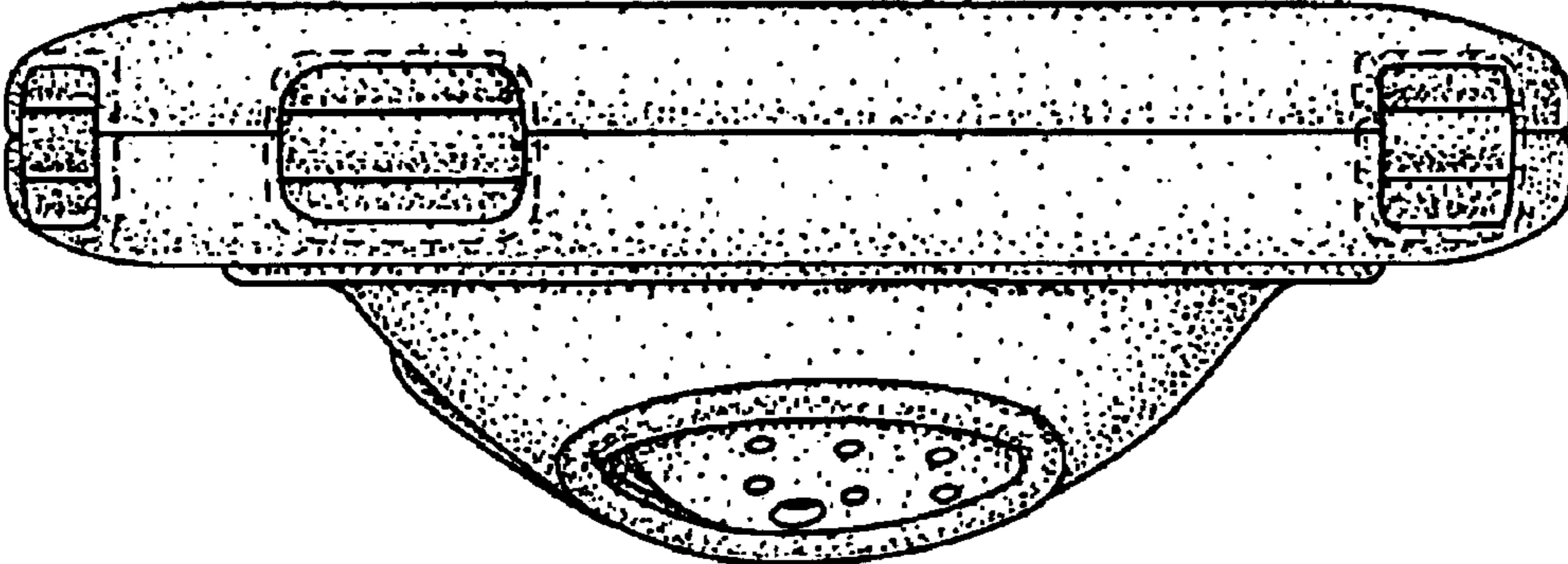
