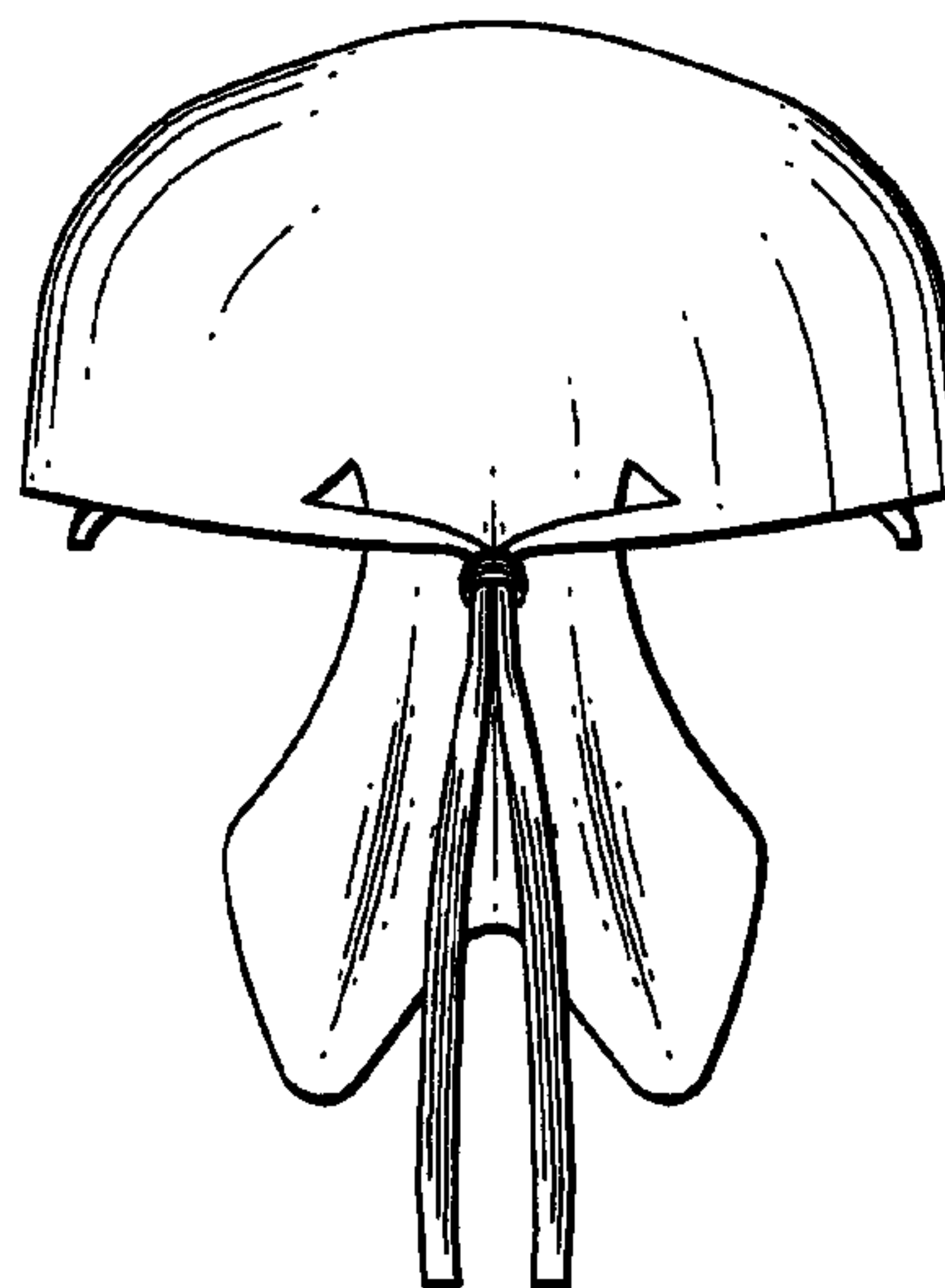
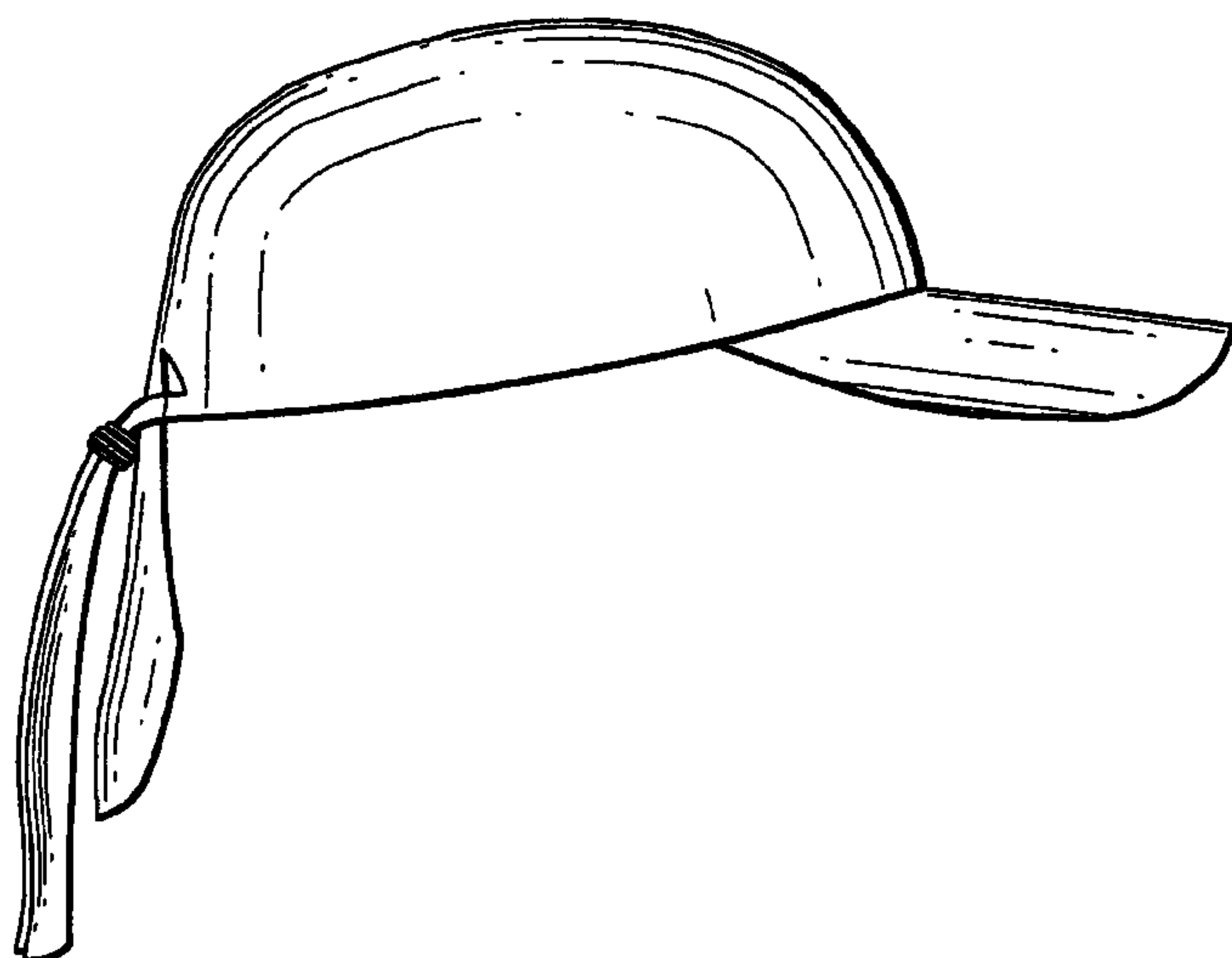
(57) **CLAIM**

The ornamental design for a headgear having regular bill and rear tie enclosure, as shown and described.

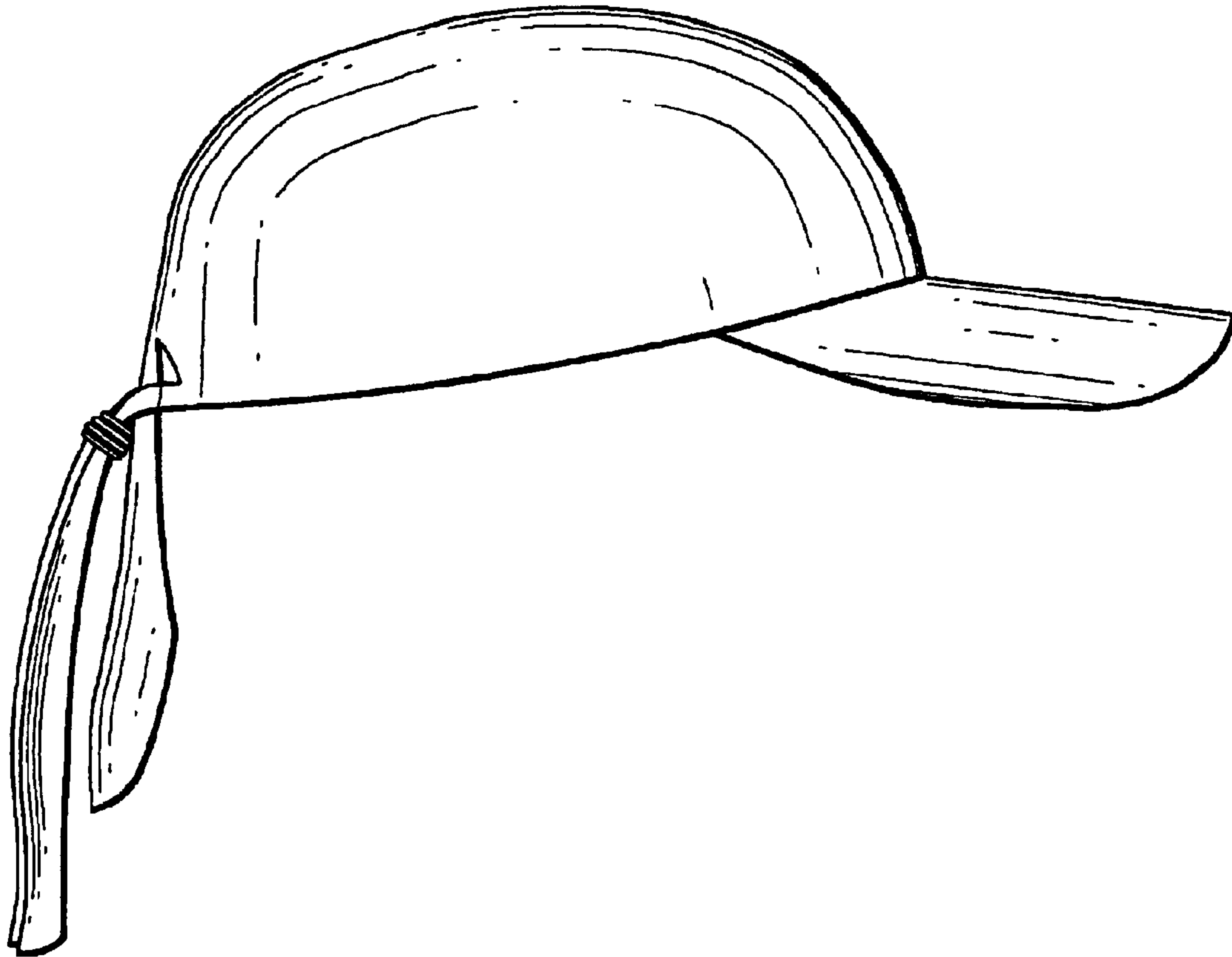
**DESCRIPTION**

FIG. 1 is a right side, elevation view of a headgear having regular bill and rear tie enclosure embodying my design; FIG. 2 is a top view of the headgear having regular bill and rear tie enclosure; FIG. 3 is a left side elevation view of the headgear having regular bill and rear tie enclosure; FIG. 4 is a bottom view of the headgear having regular bill and rear tie enclosure; FIG. 5 is a front elevation view of the headgear having regular bill and rear tie enclosure; and, FIG. 6 is a rear elevation view of the headgear having regular bill and rear tie enclosure.

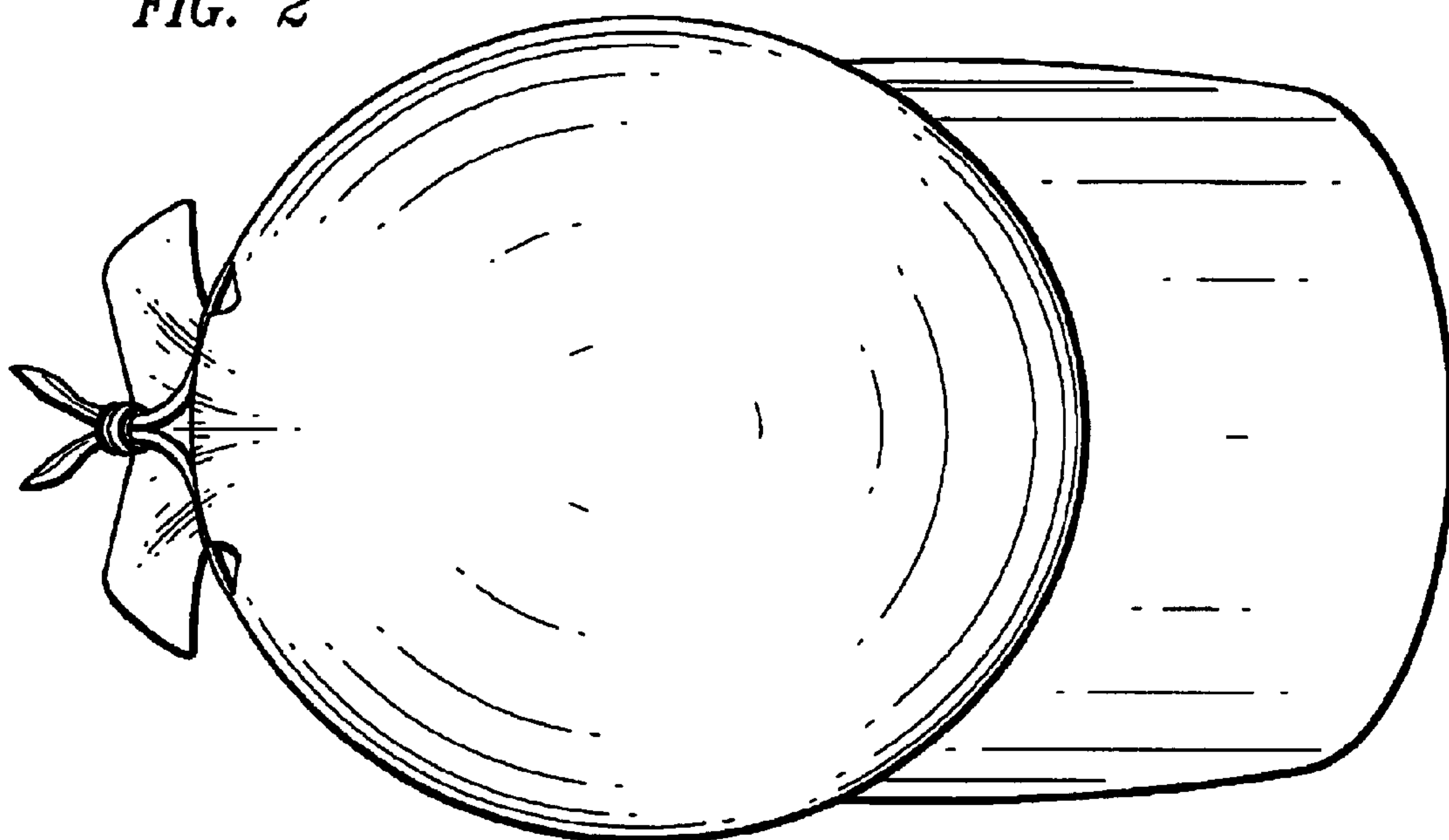

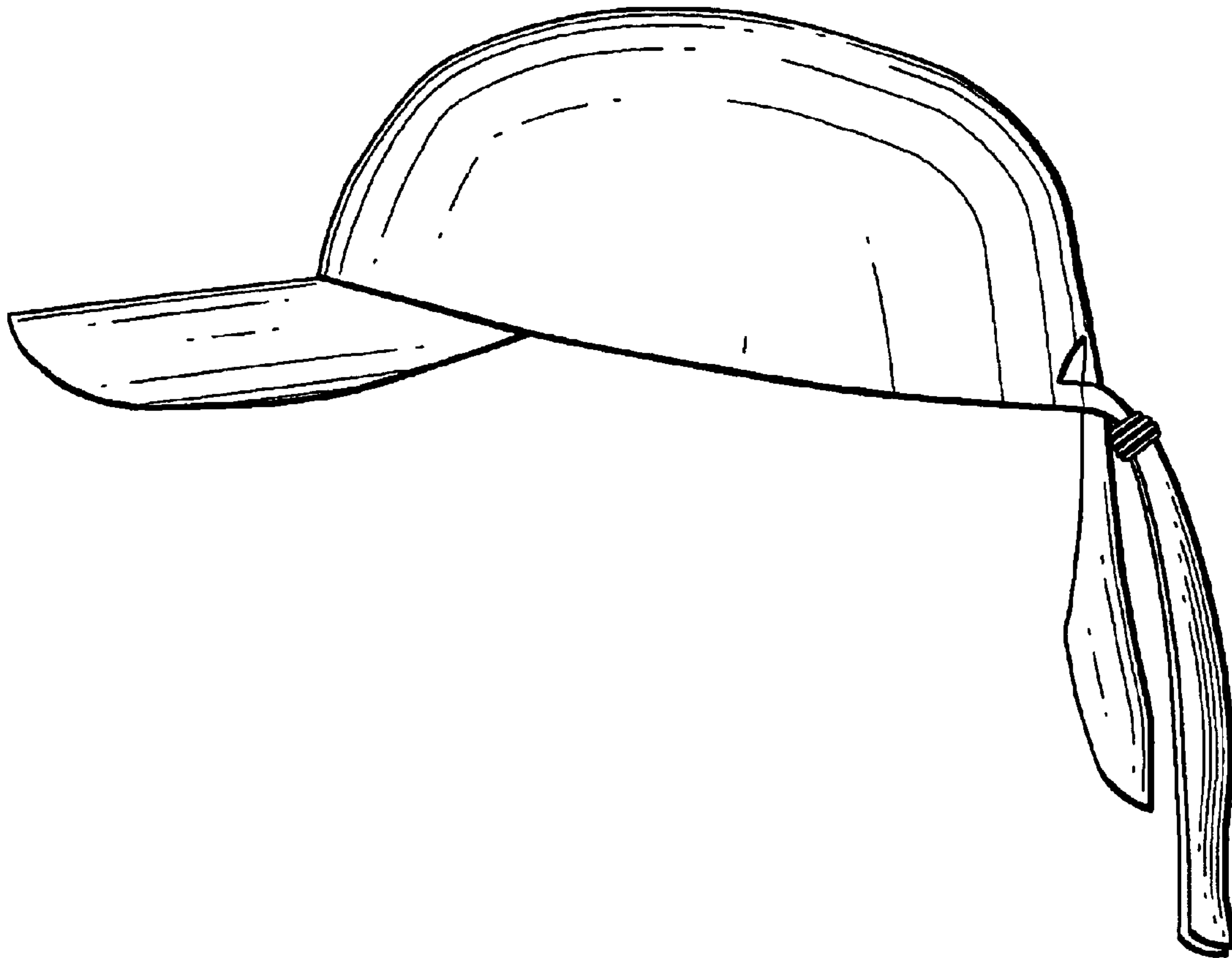

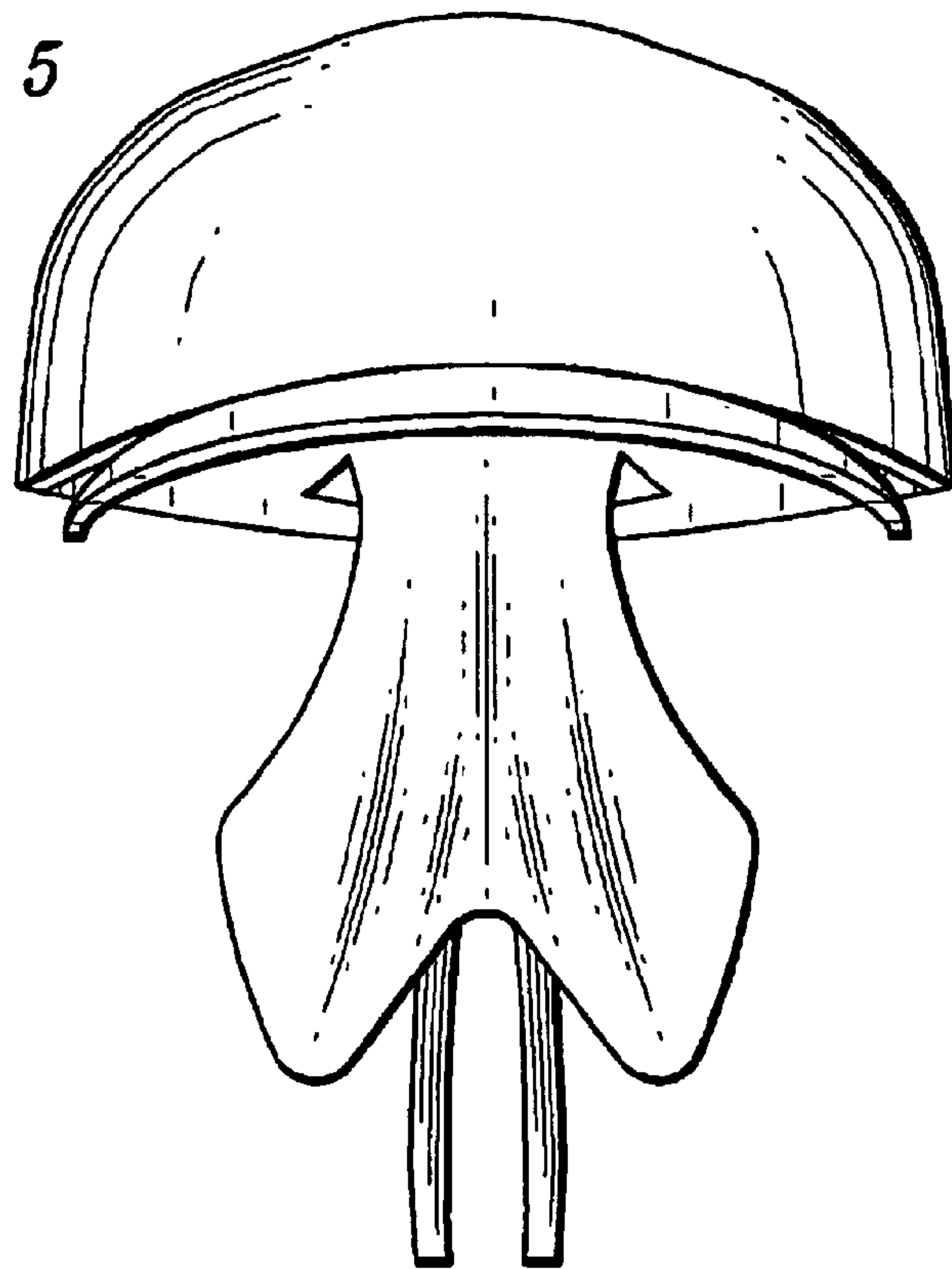
