(57) **CLAIM**

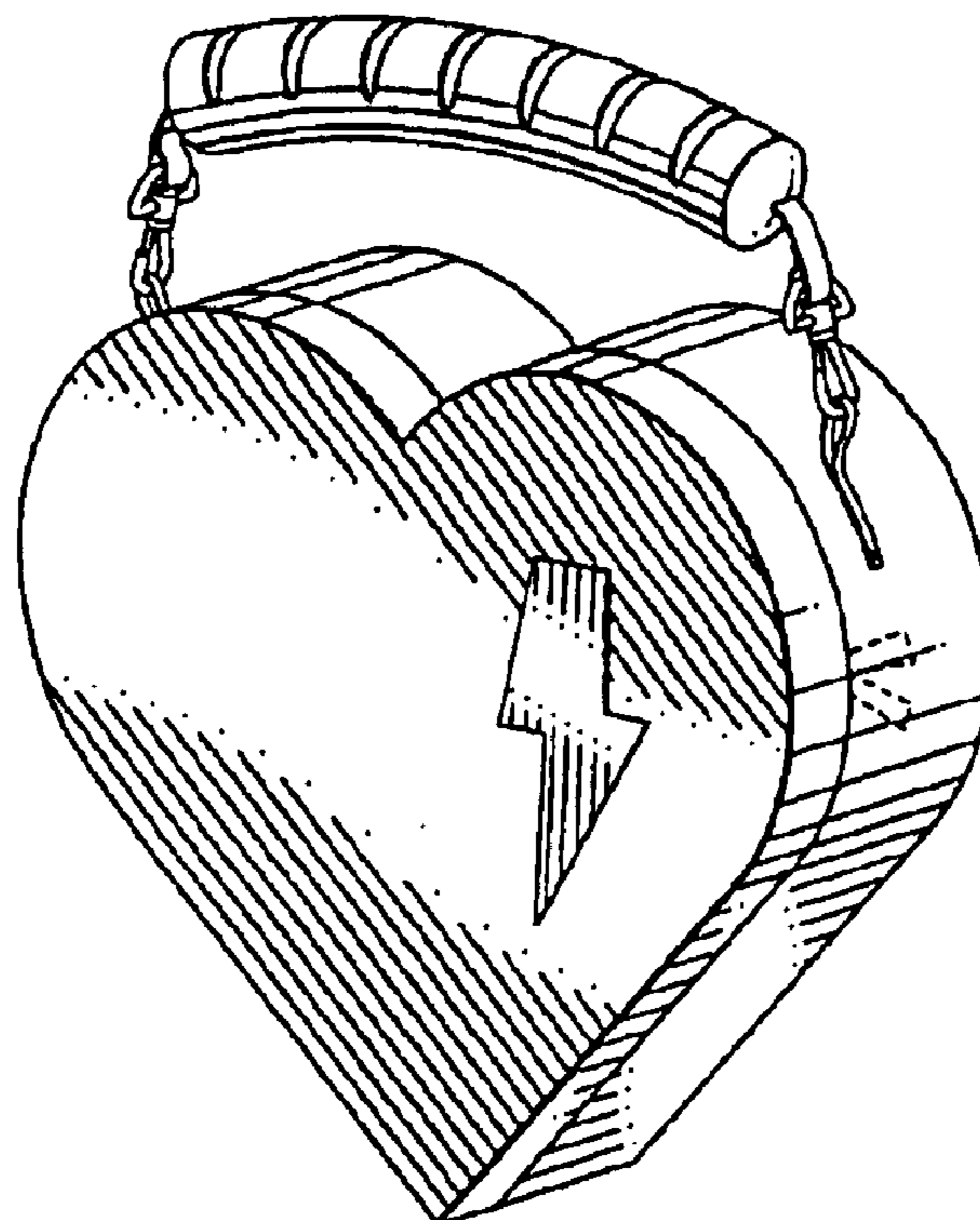
The ornamental design for a carrying case for the portable external defibrillator, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the carrying case for a portable external defibrillator;
FIG. 2 is a front view thereof;

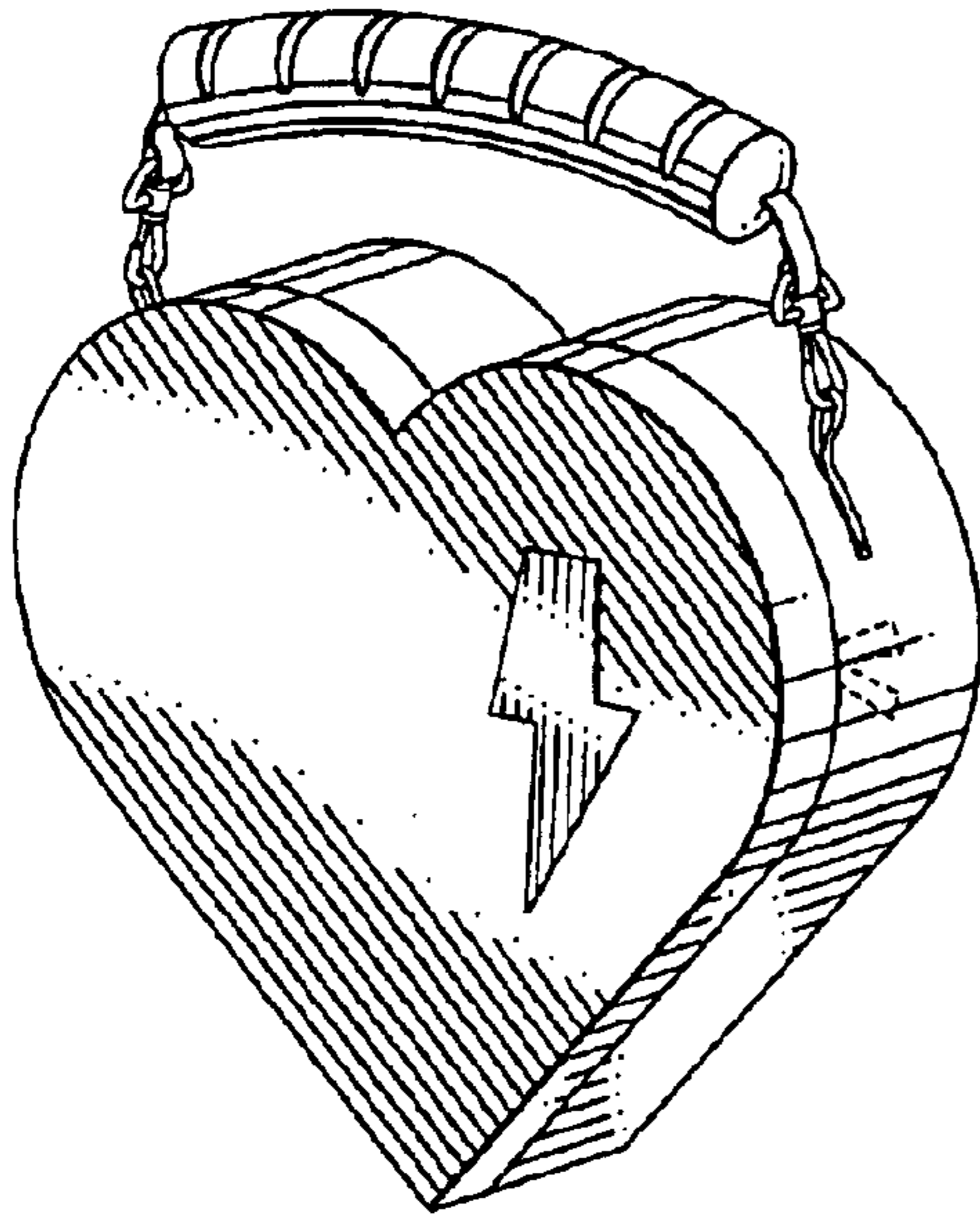

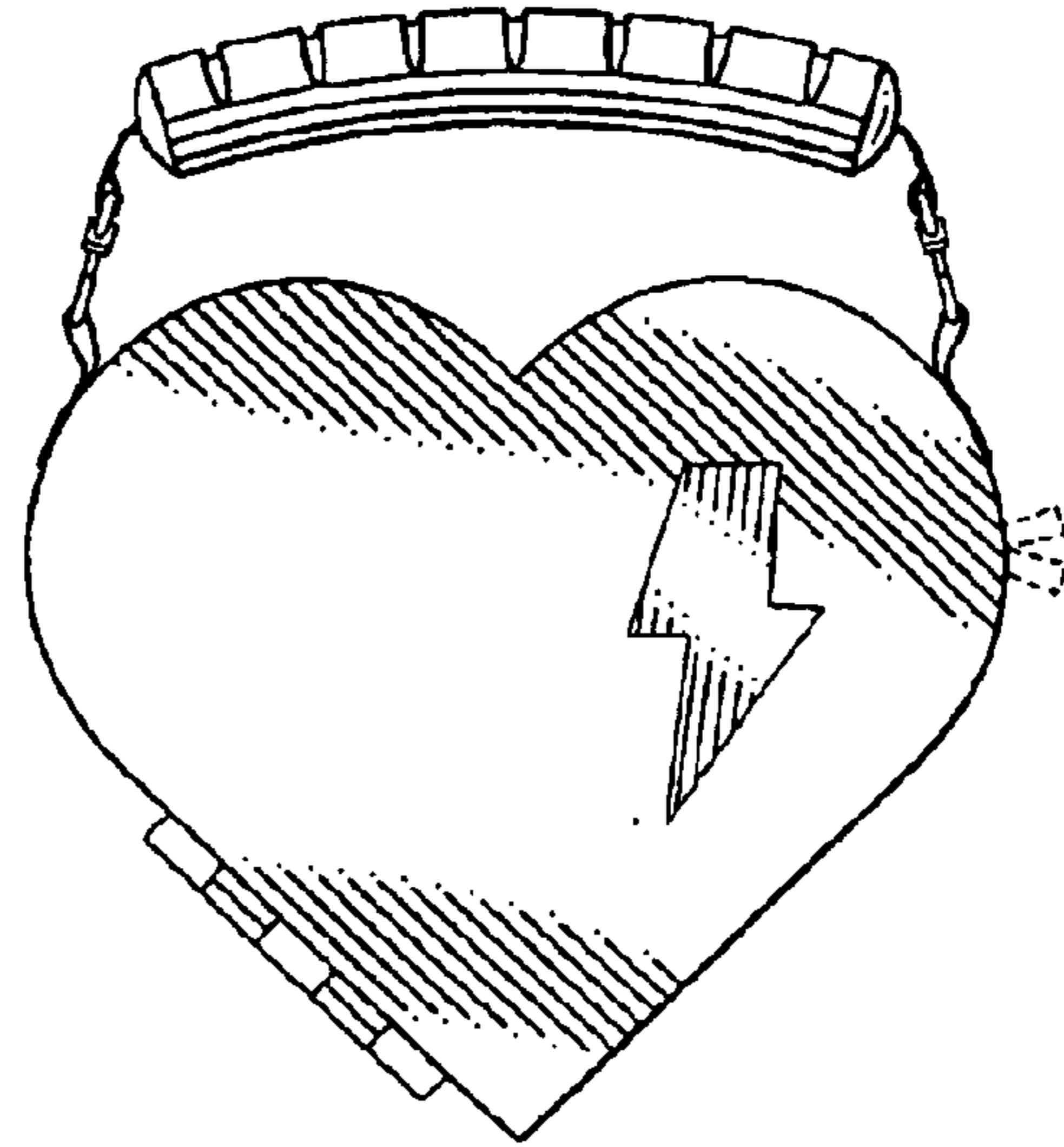

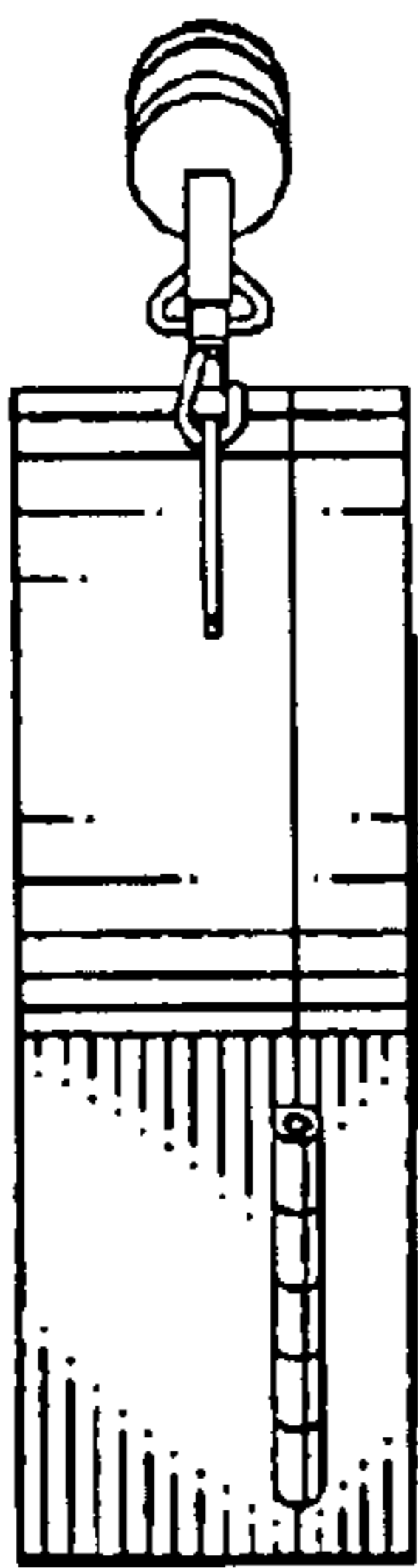

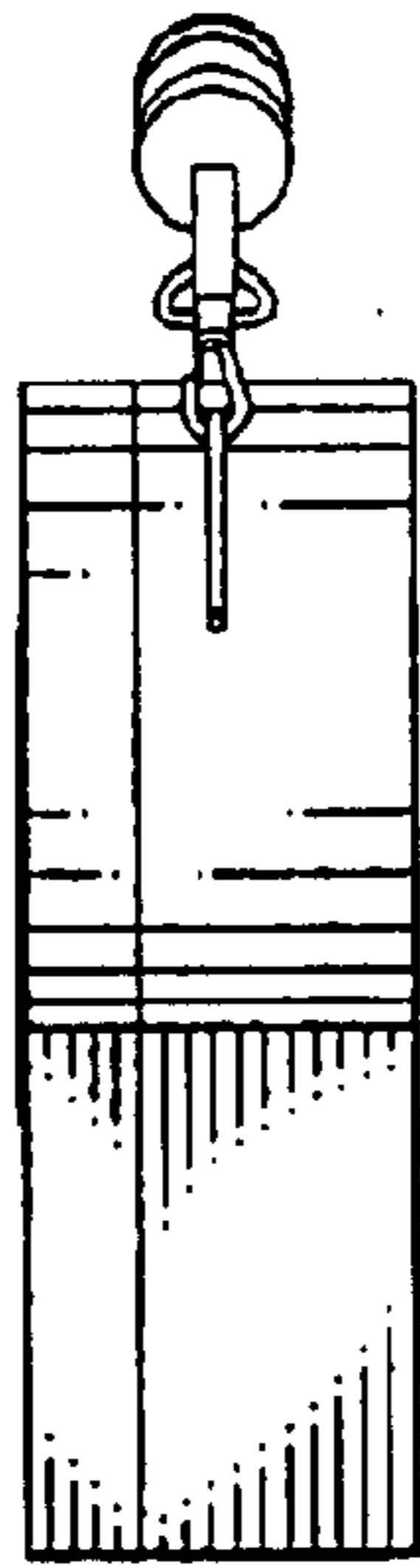

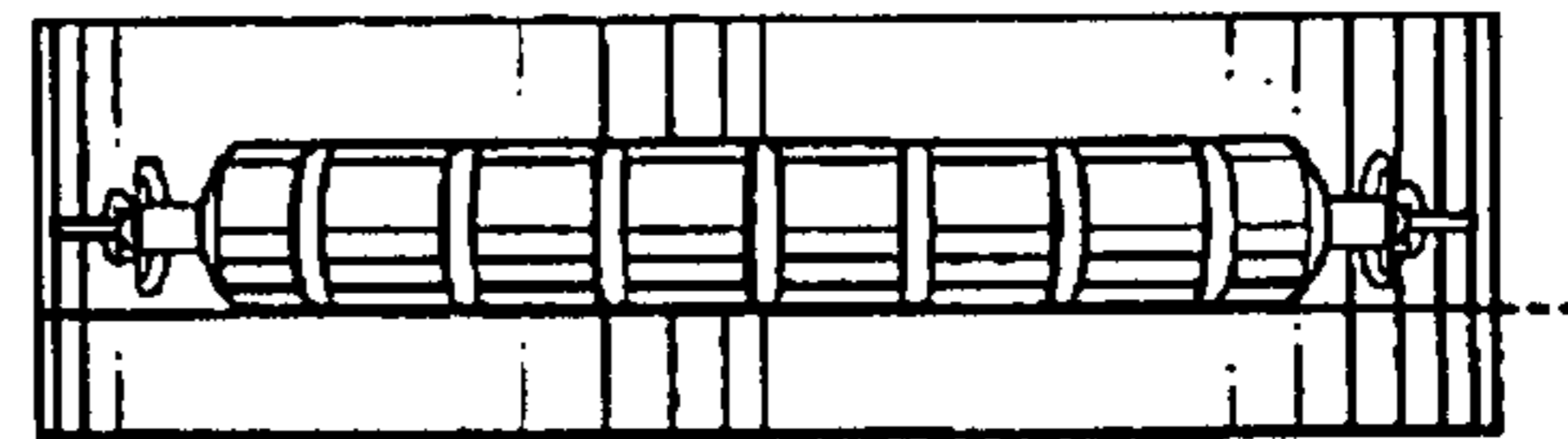

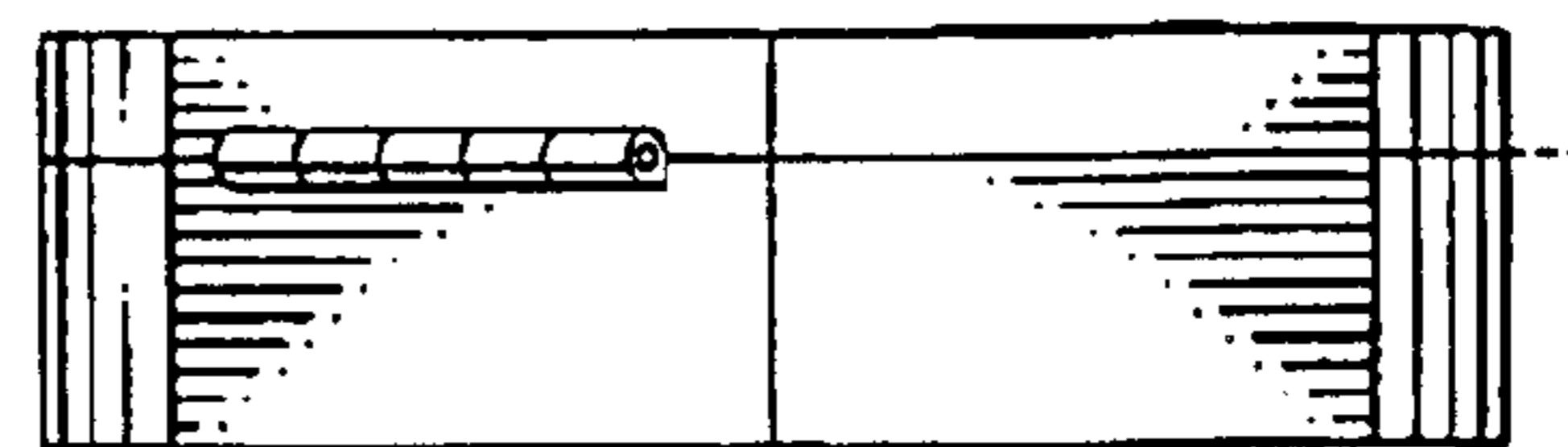

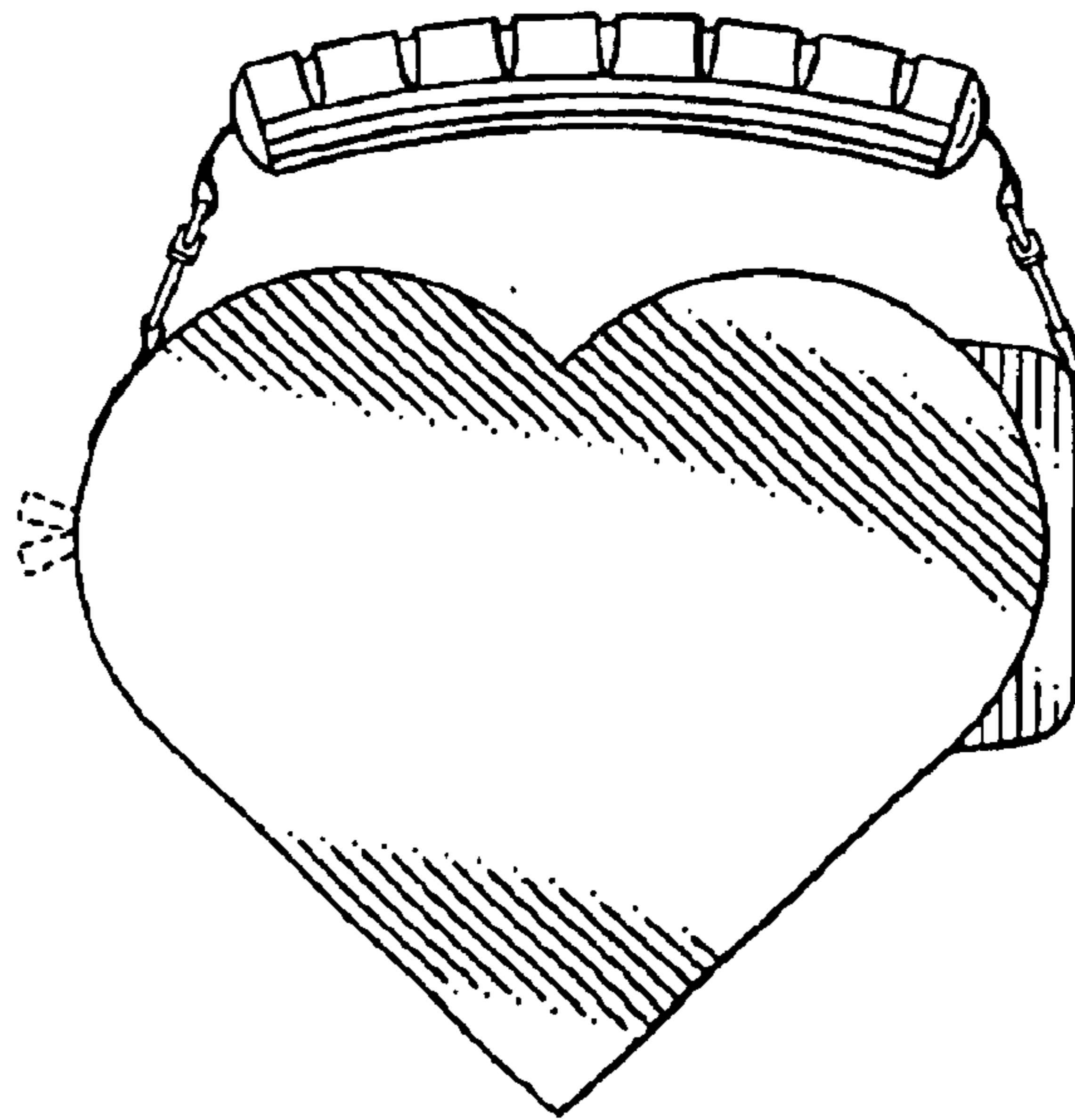

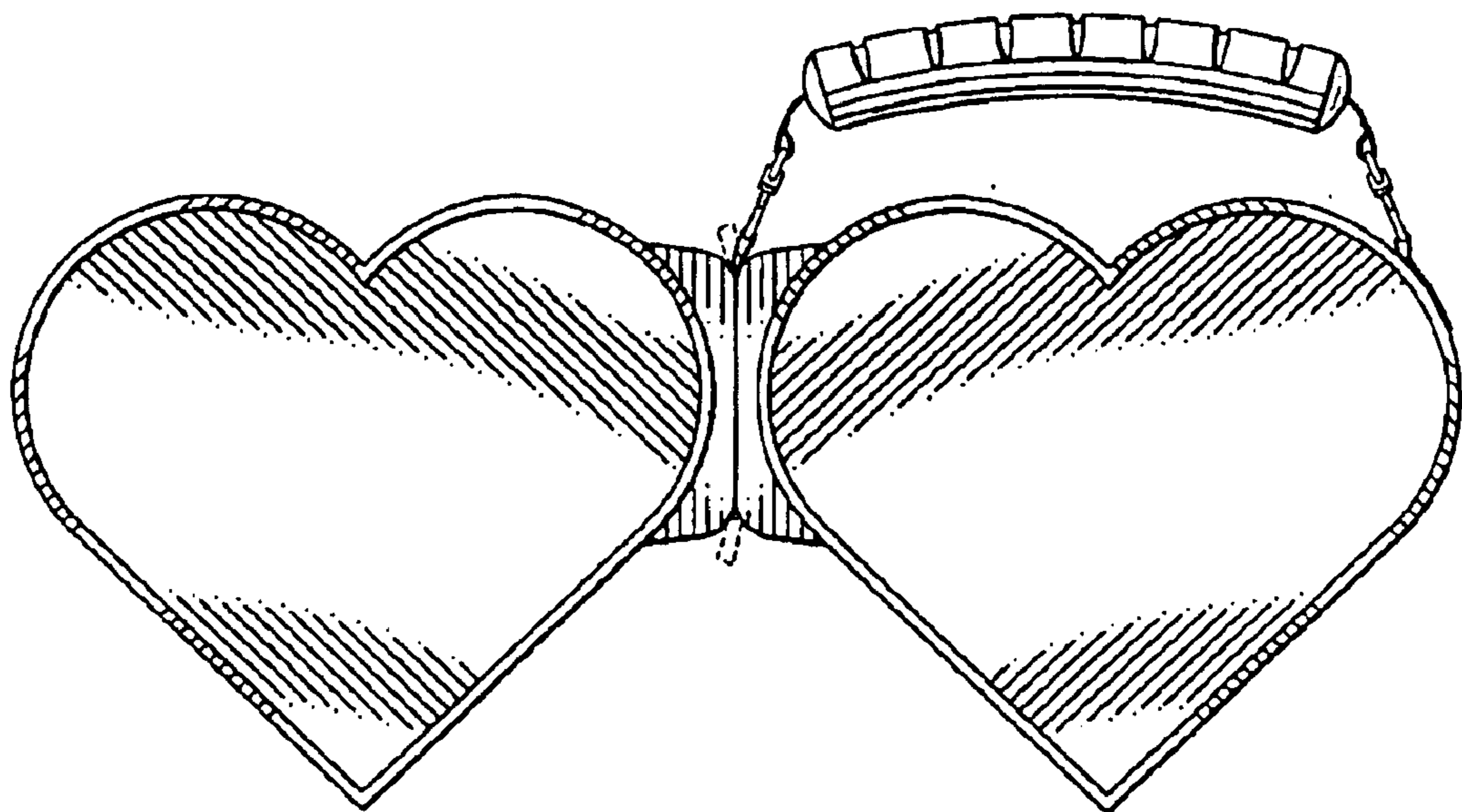

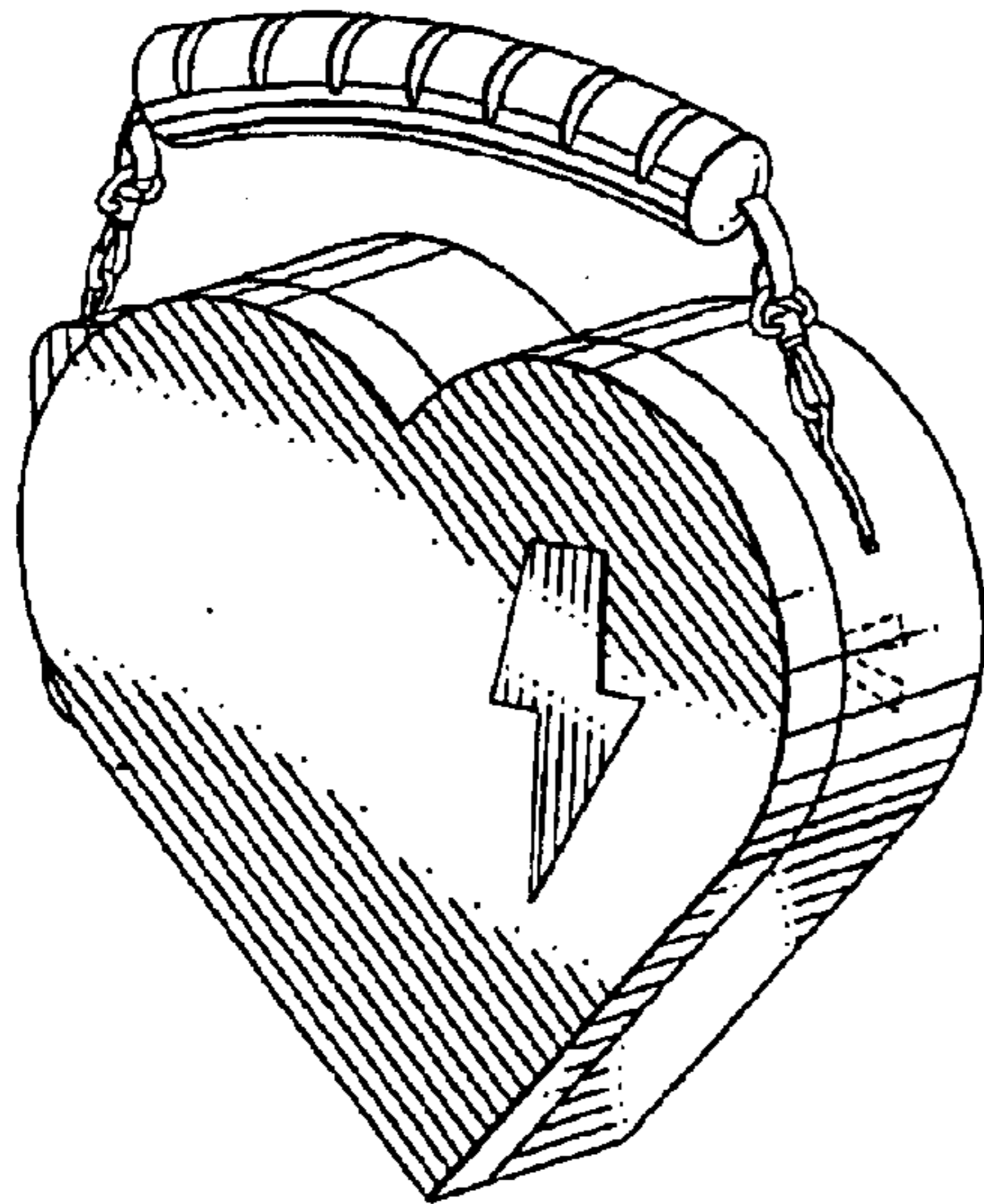

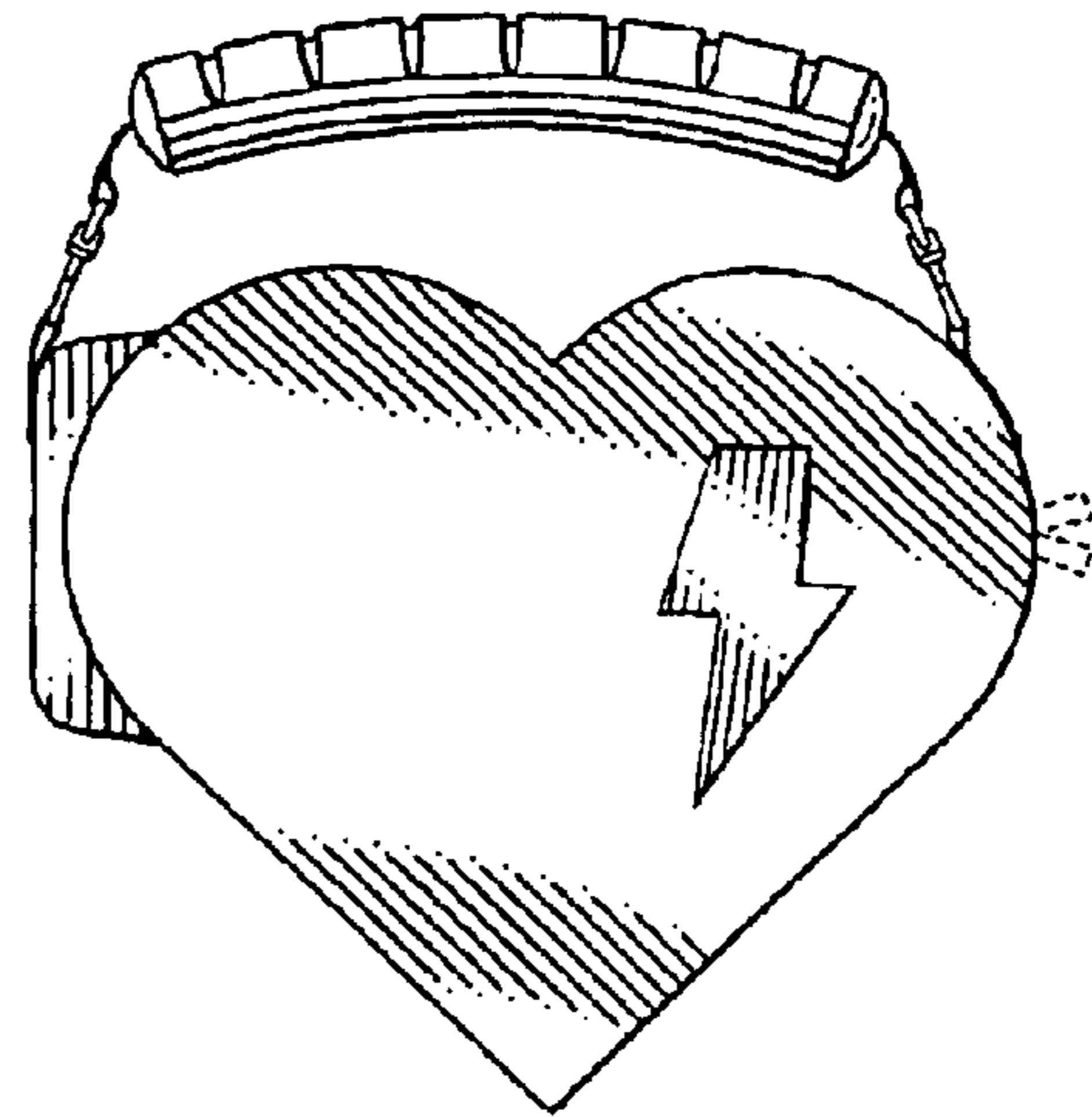

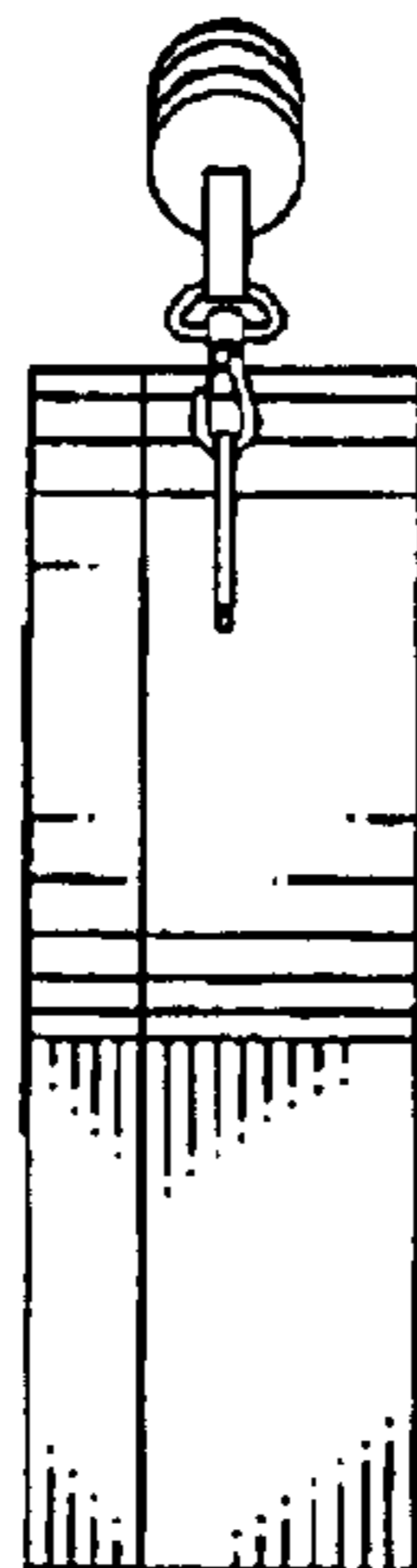

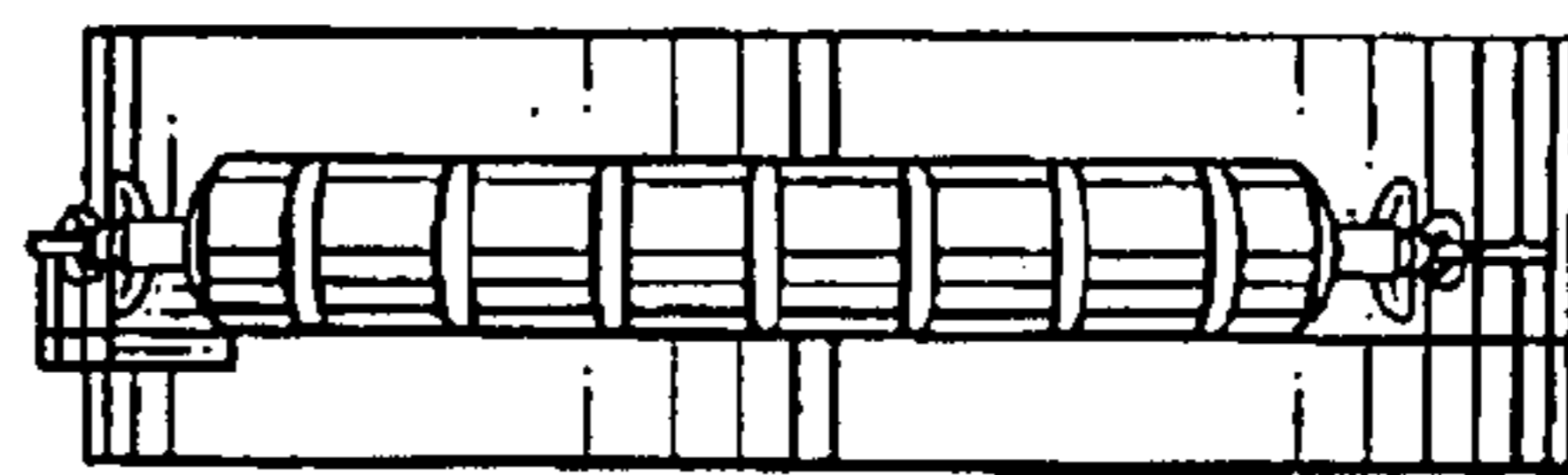

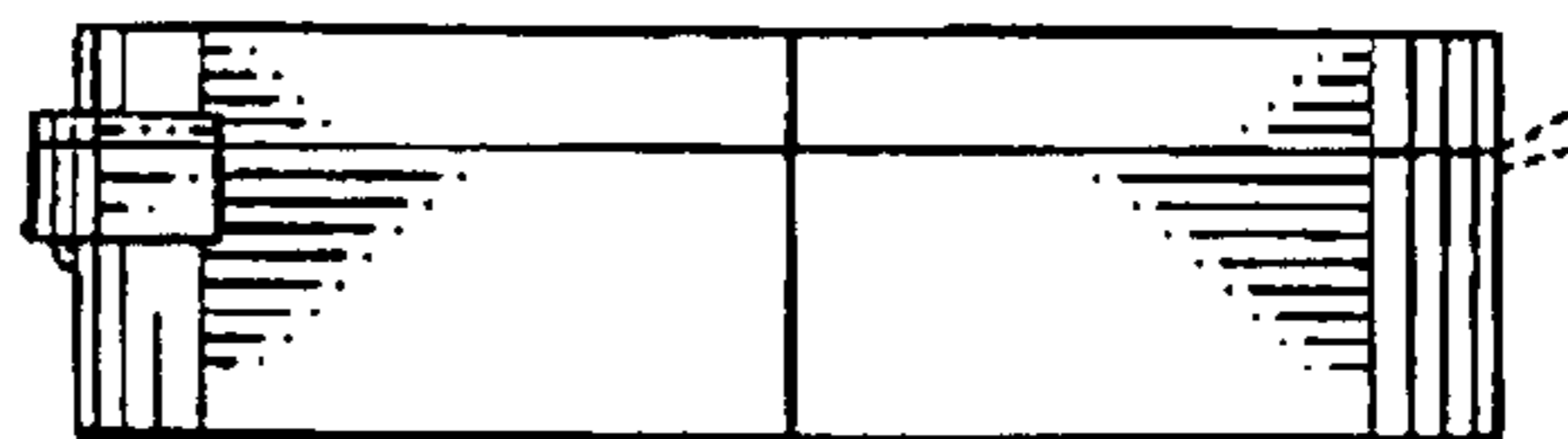

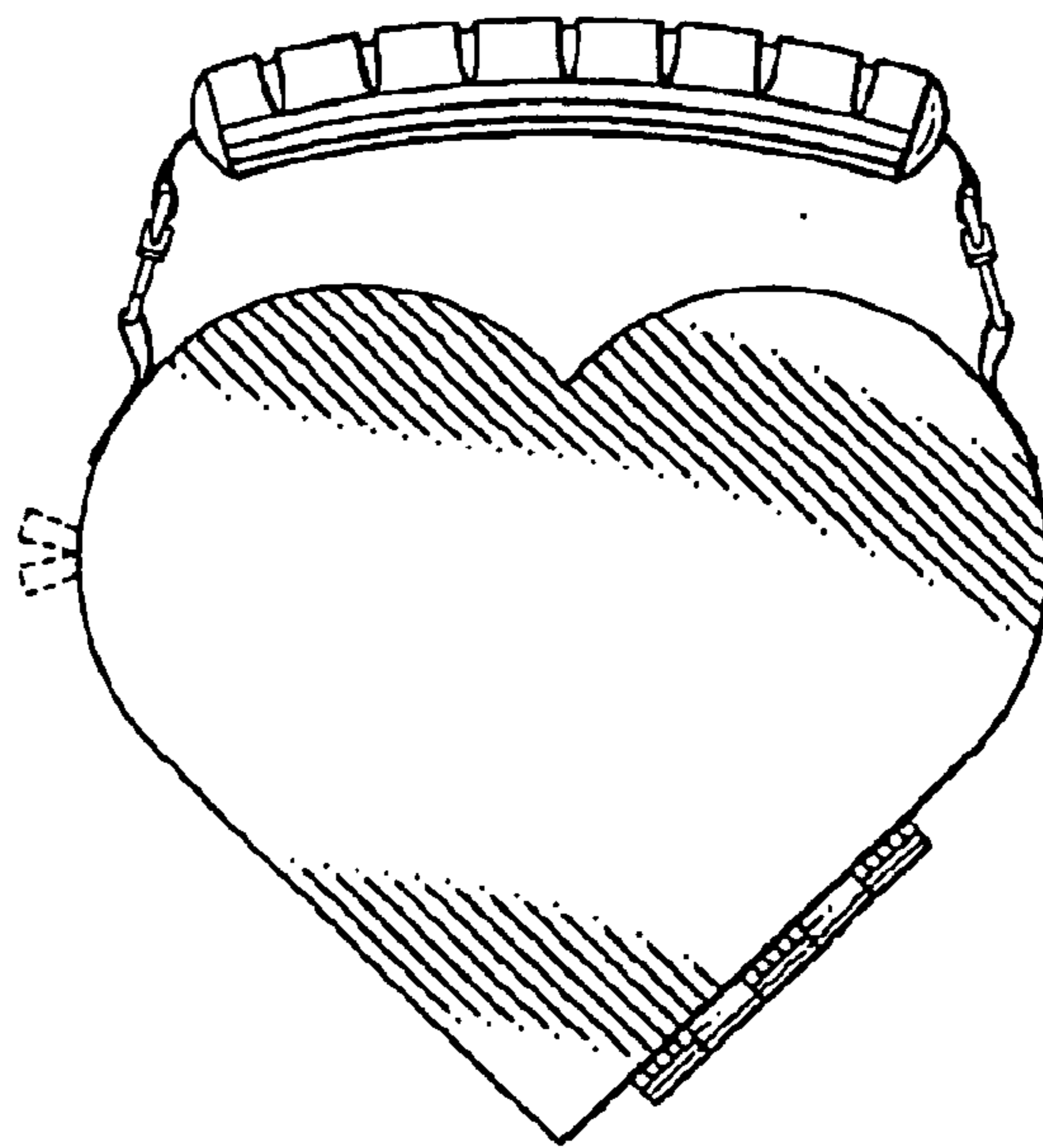

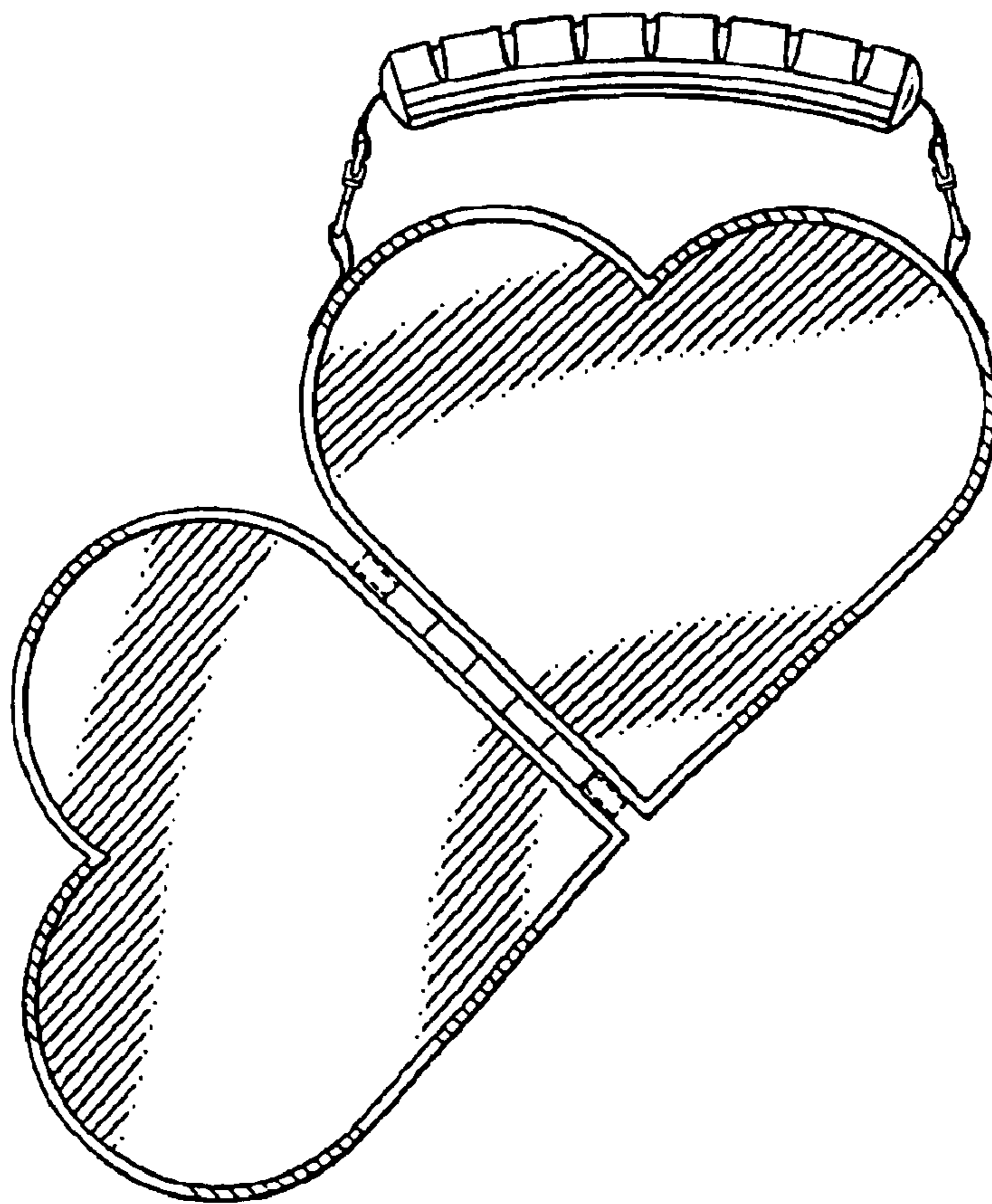
