DESCRIPTION

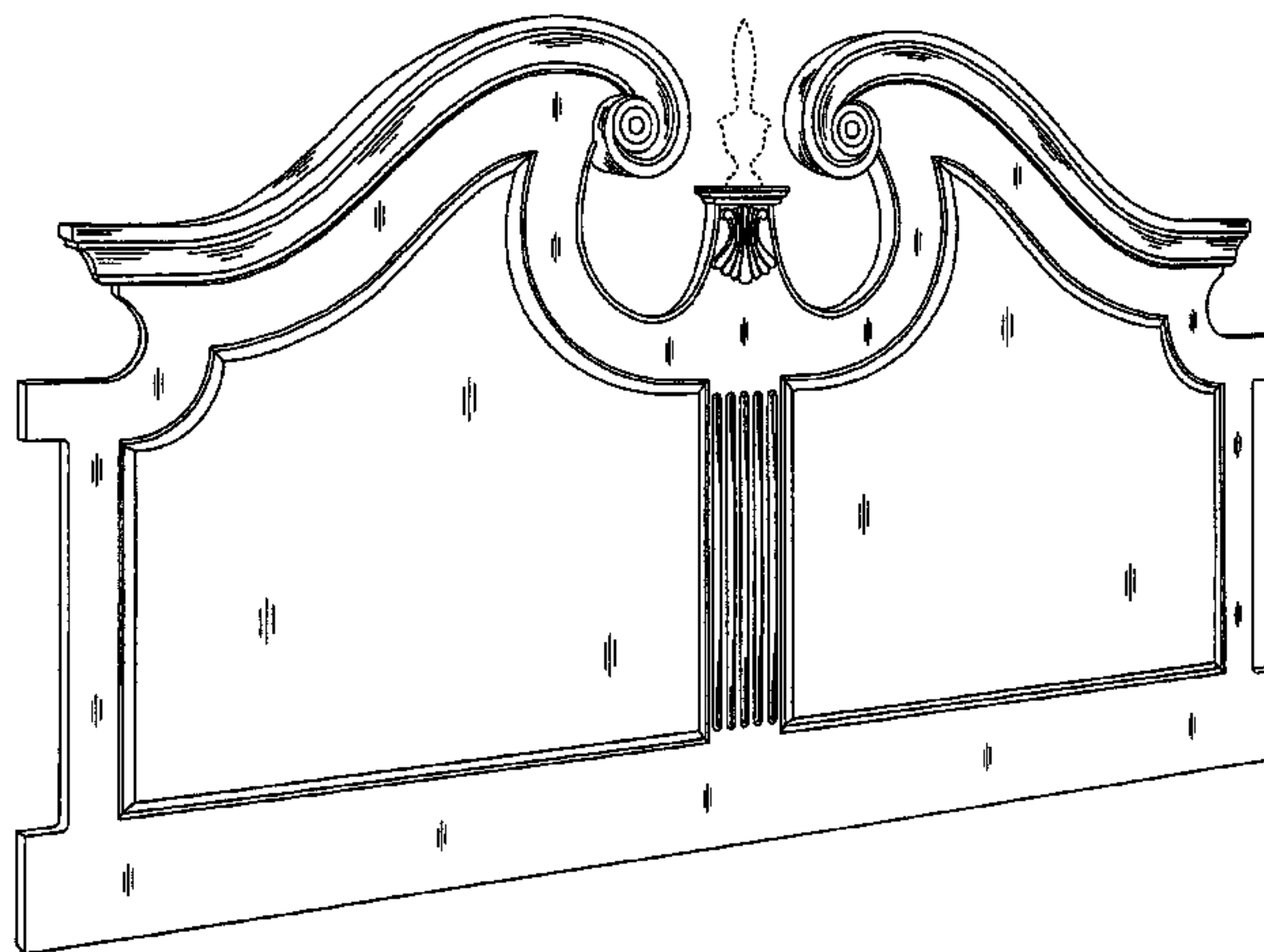
FIG. 1 is a left front perspective view of a headboard showing my new design;

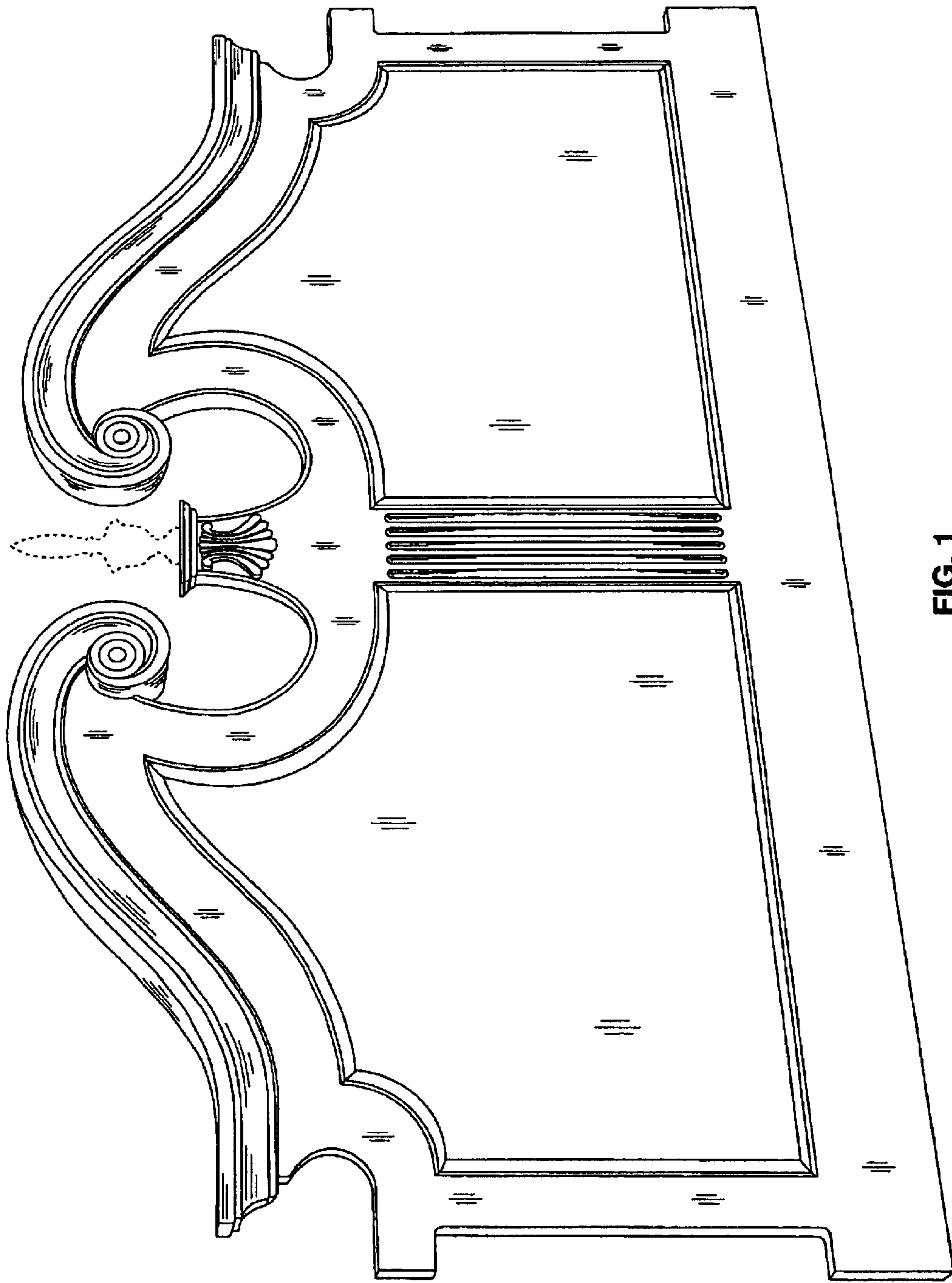

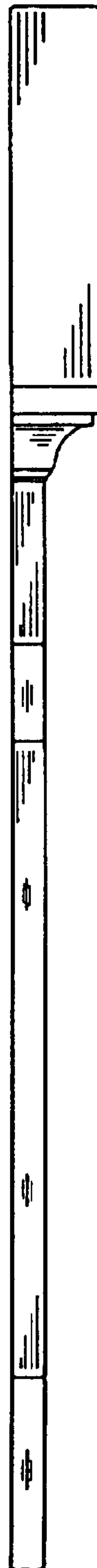

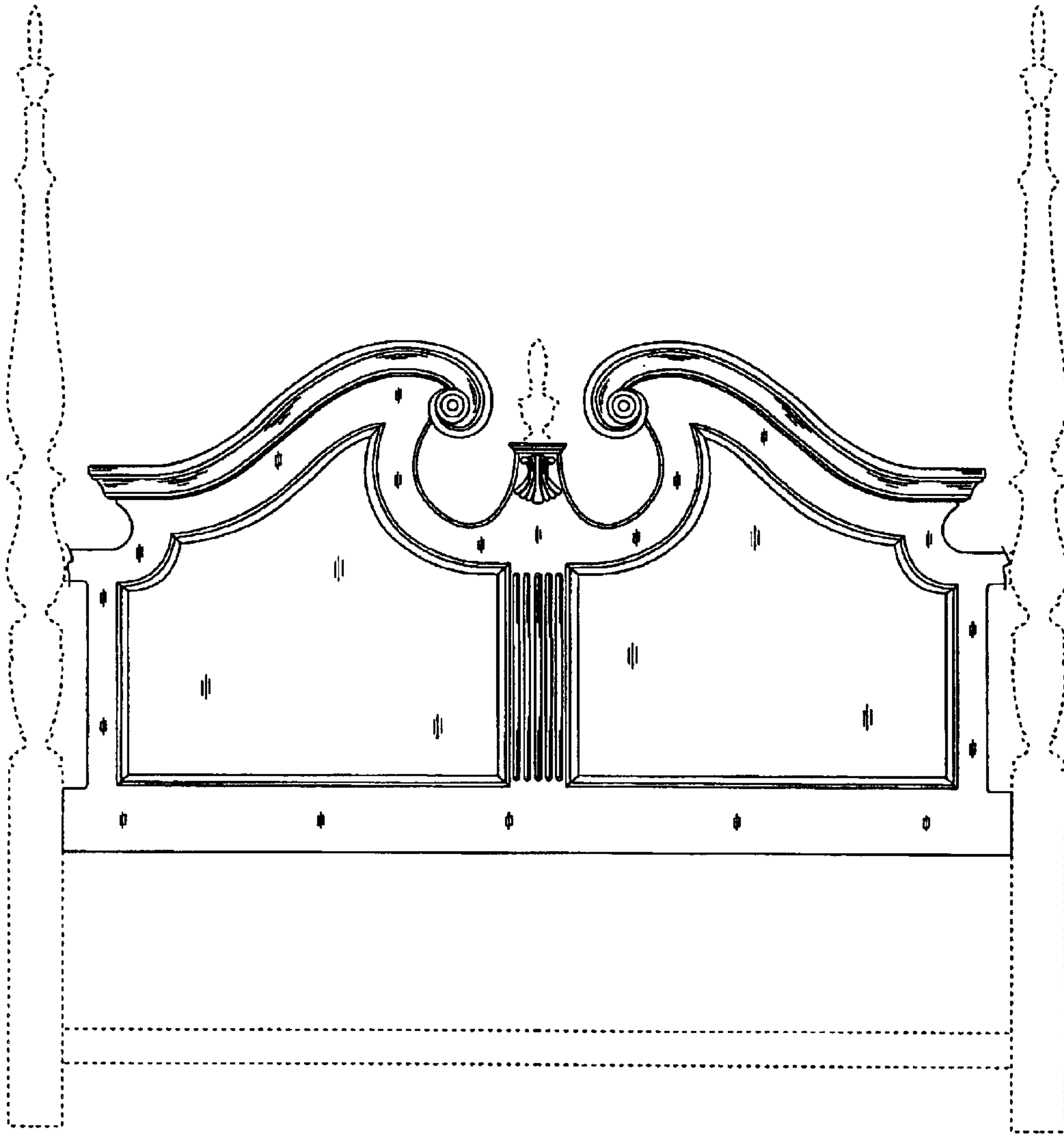
