FIG. 3 is a front view of the lid of FIG. 1;

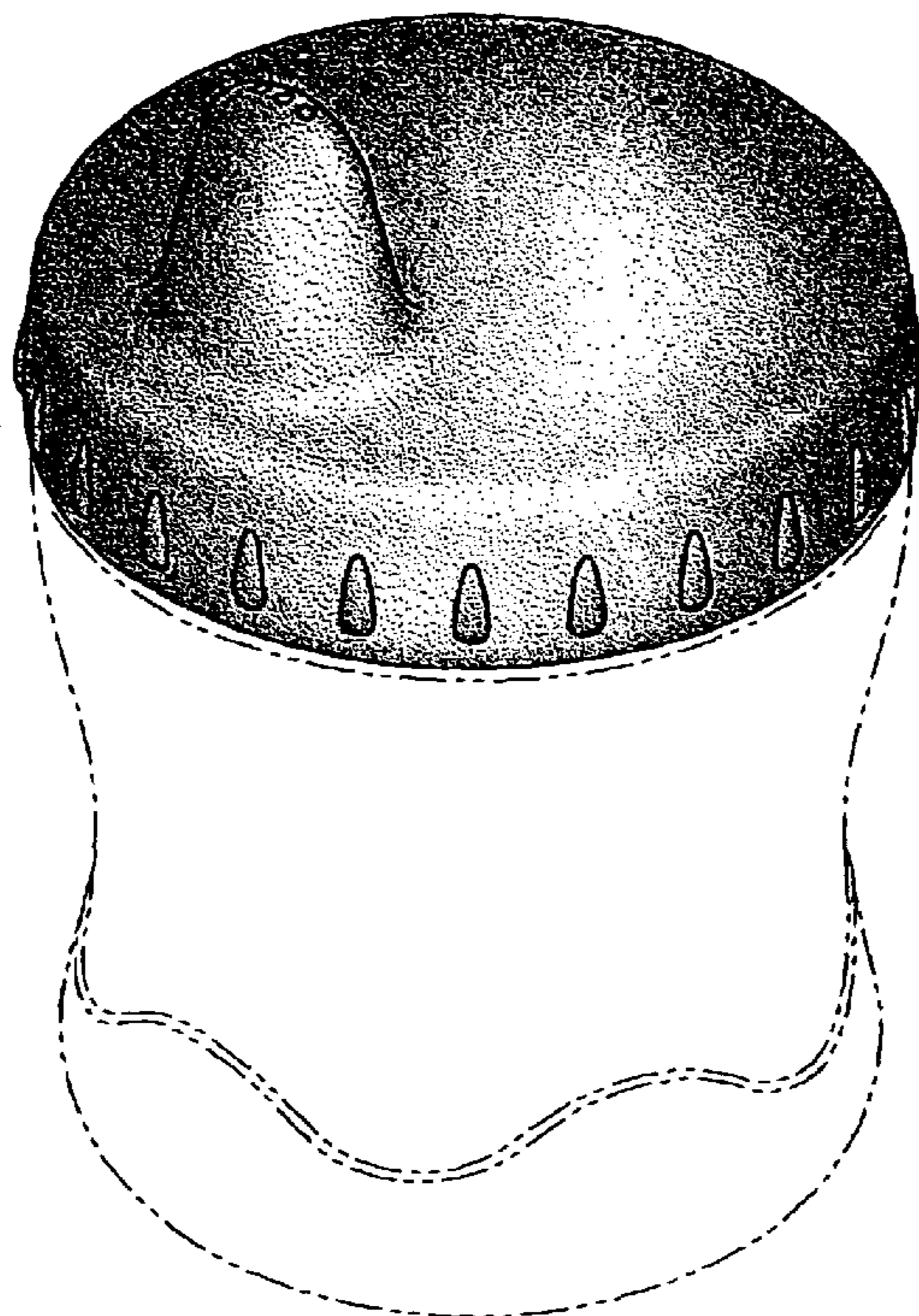
FIG. 4 is a rear view of the lid of FIG. 1;

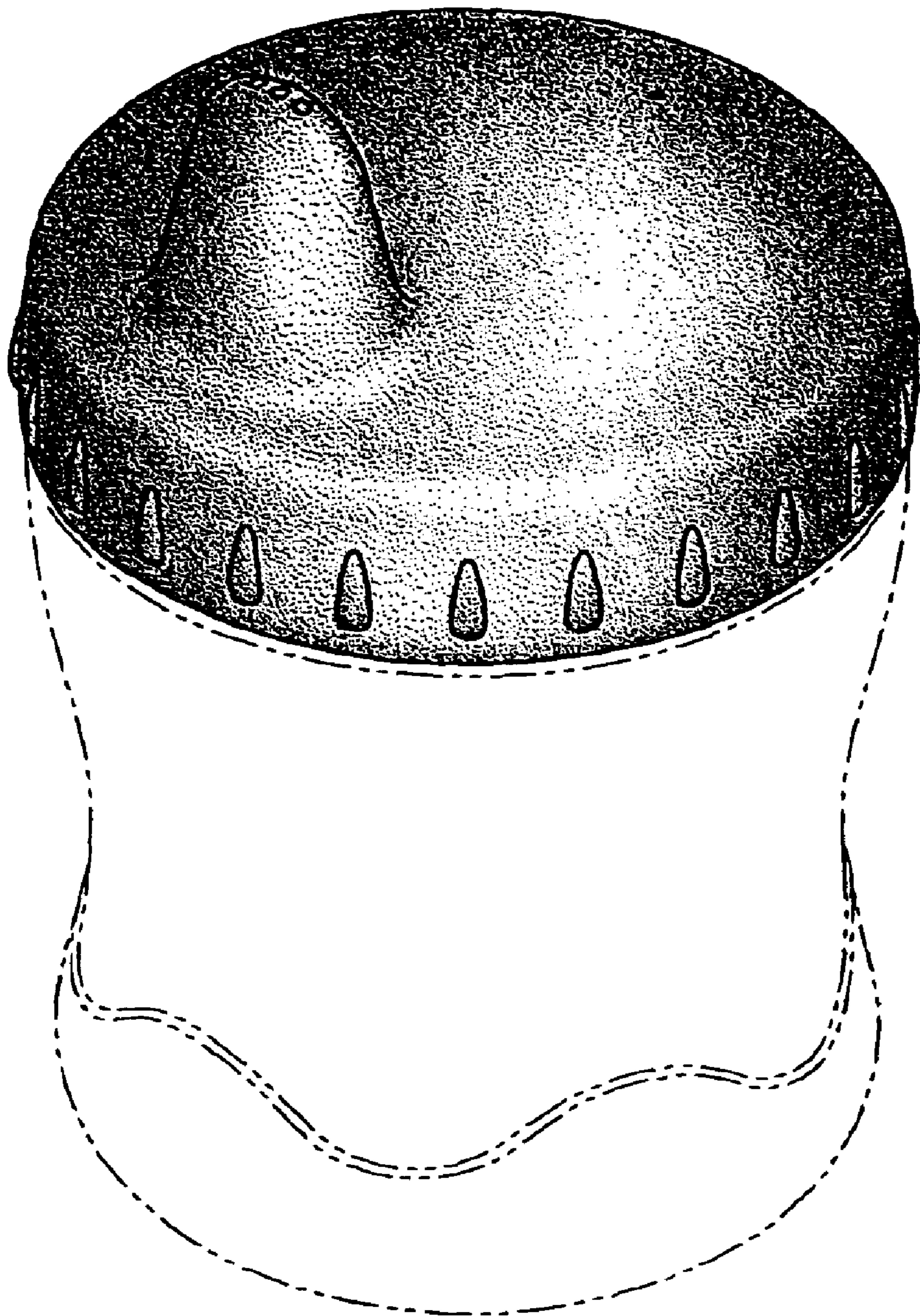
FIG. 5 is a side view of the lid of FIG. 1, the opposite side being the same; and,

FIG. 6 is a top view of the lid of FIG. 1.

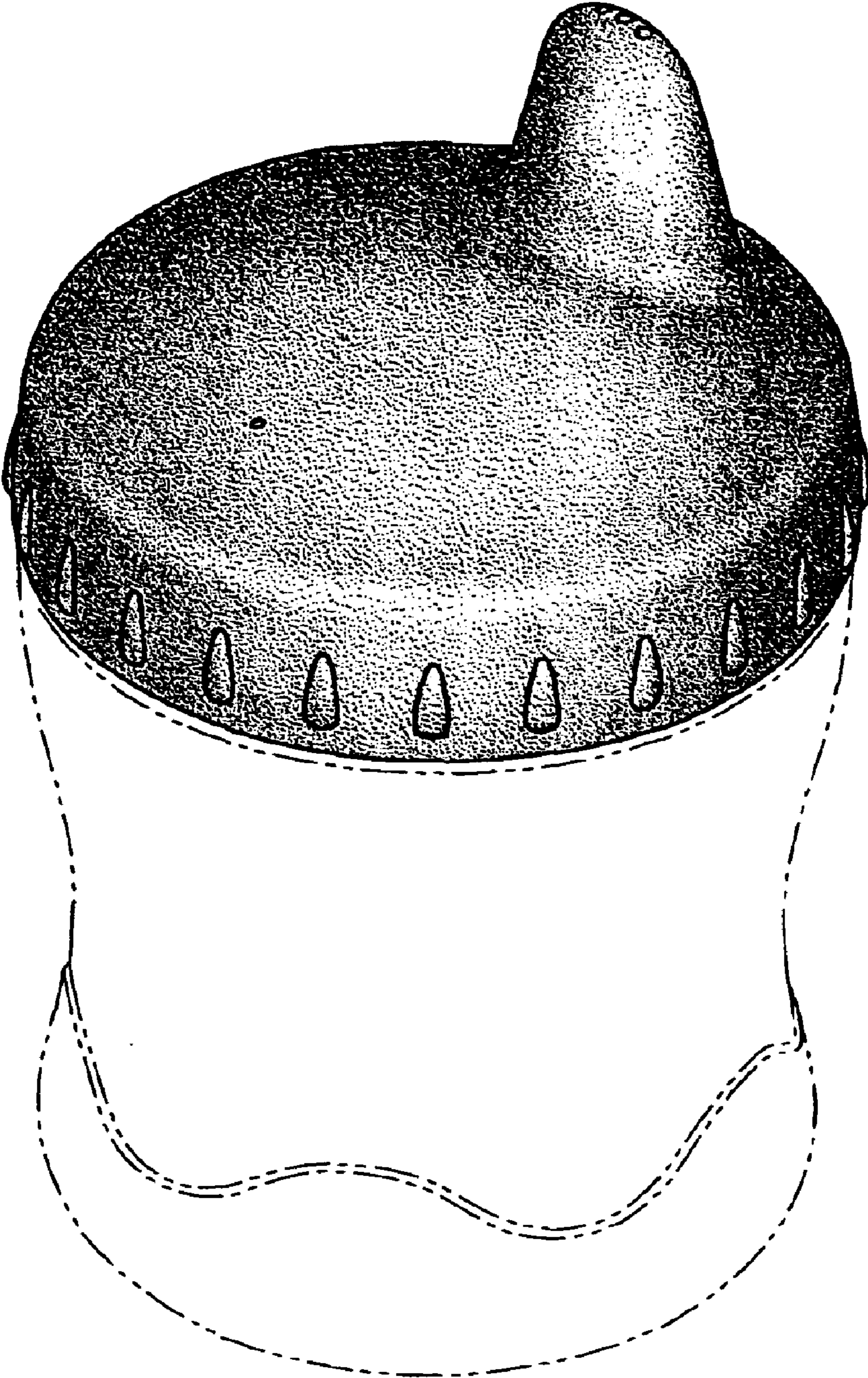
The broken line showing in FIGS. 1 through 5 is for illustrative purposes only and forms no part of the claimed design.

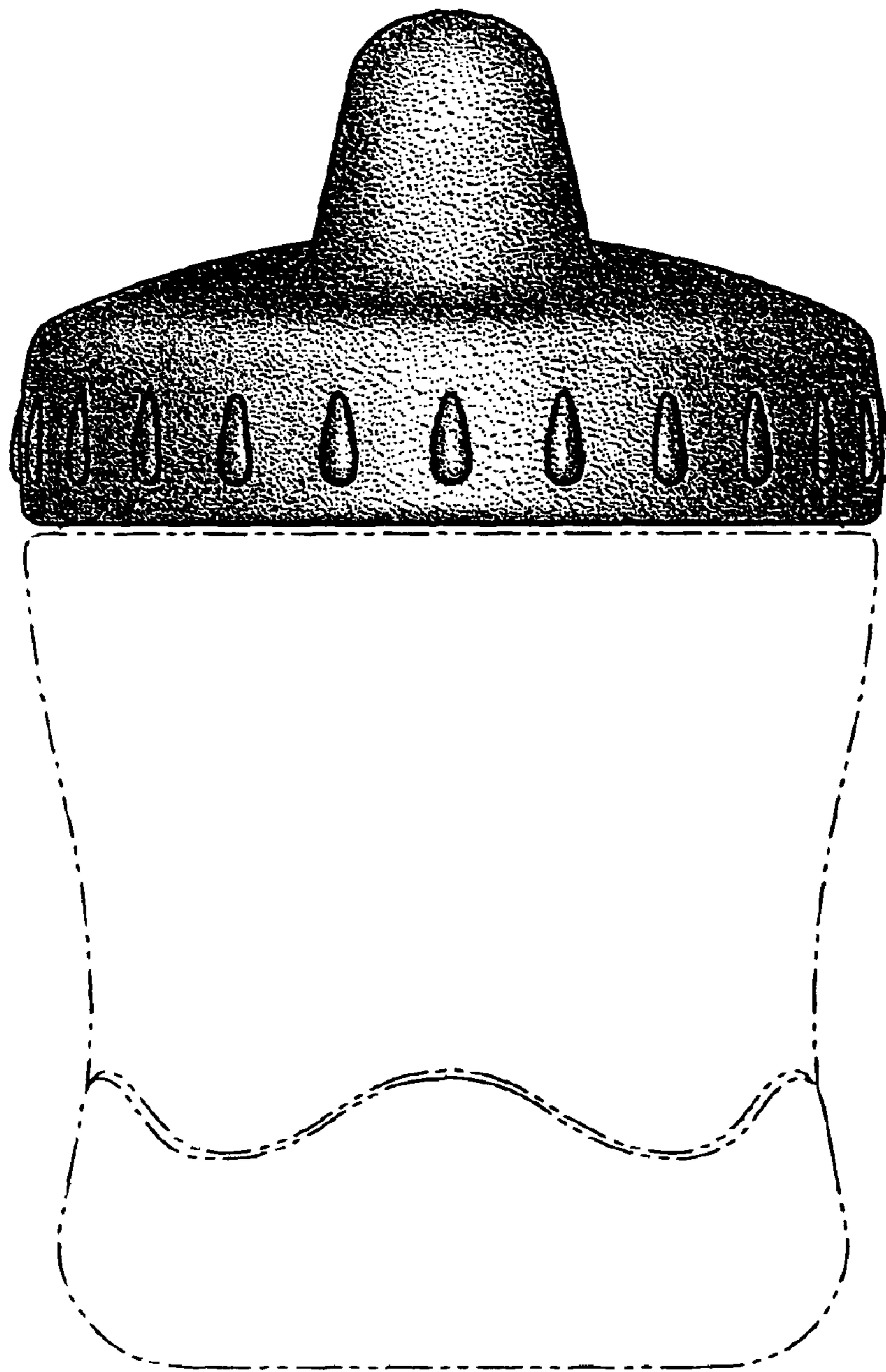




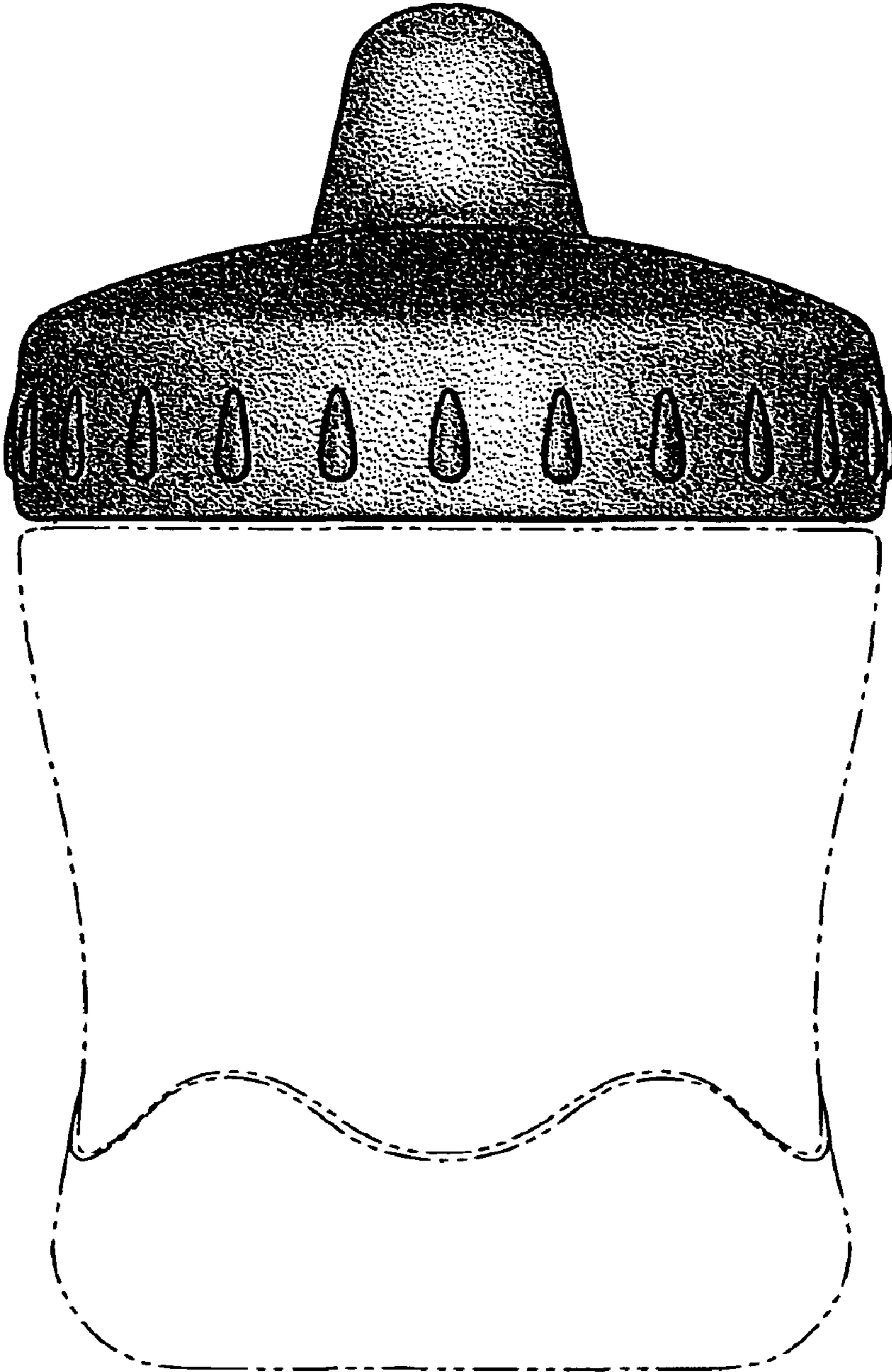

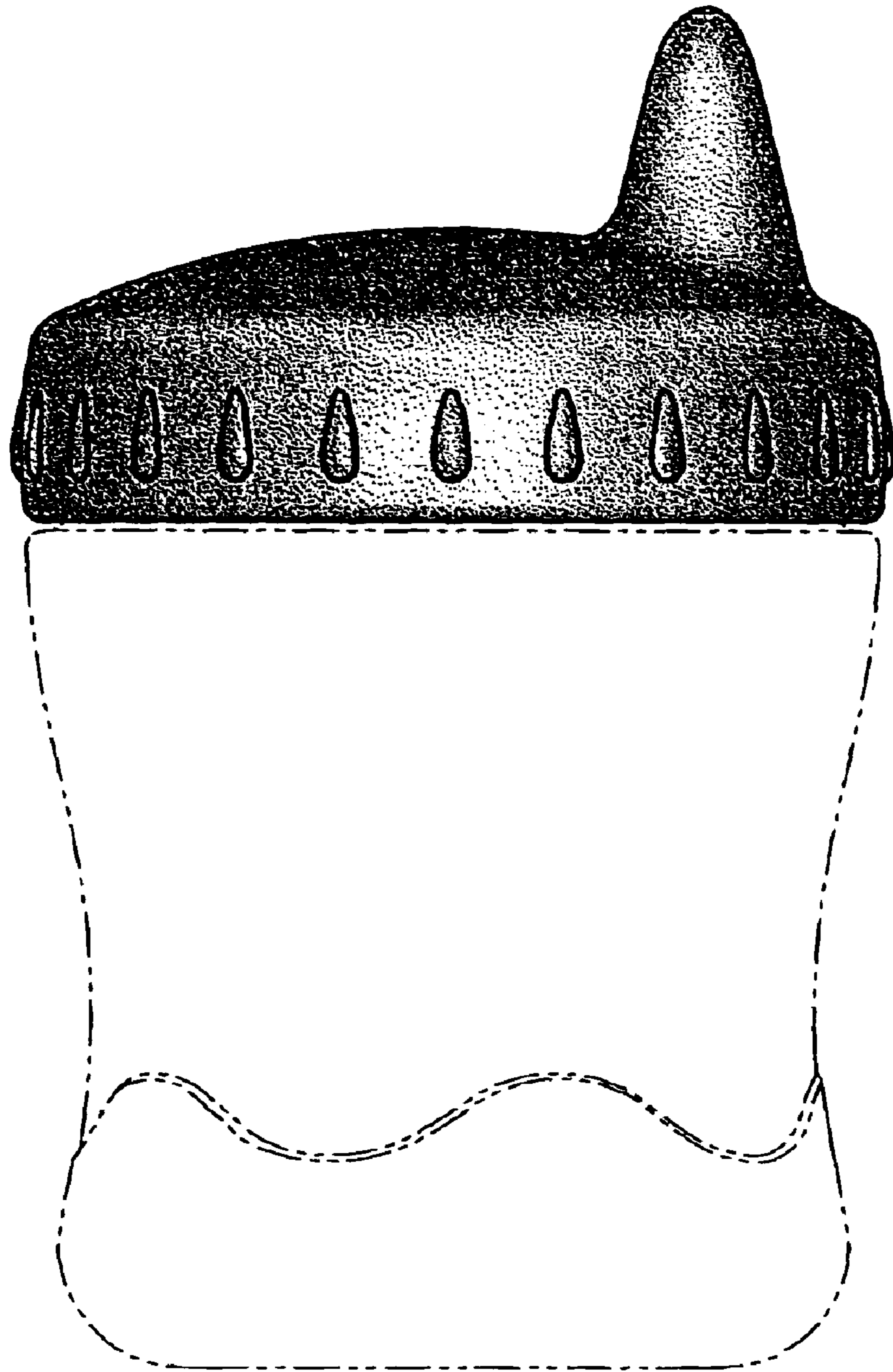

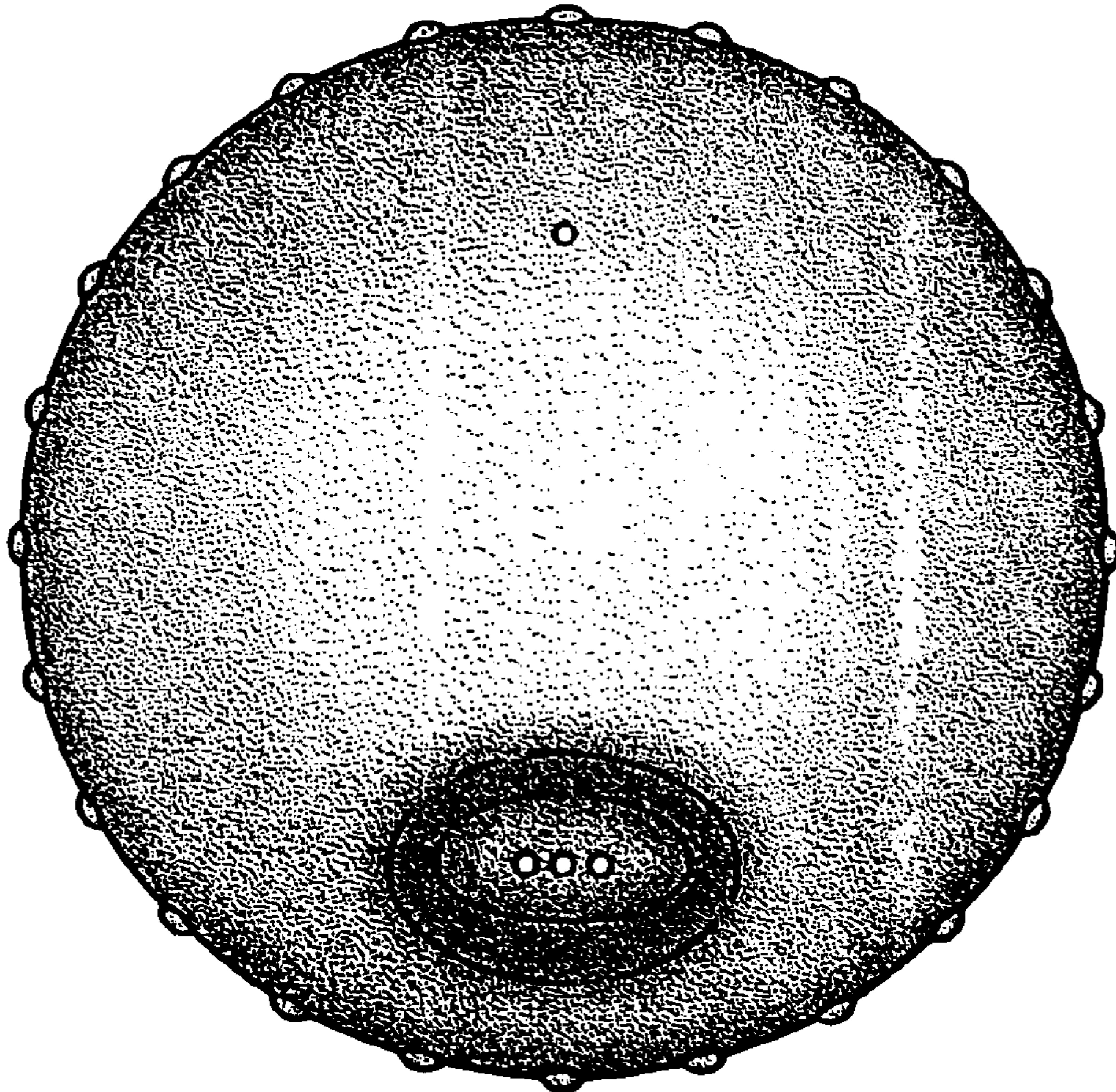
