(57) **CLAIM**

The ornamental design for a glass bowl for stand mixer, as shown and described.

DESCRIPTION

FIG. 1 is an upper perspective view of a glass bowl for a stand mixer showing our new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevation thereof;

FIG. 4 is a rear elevation thereof;

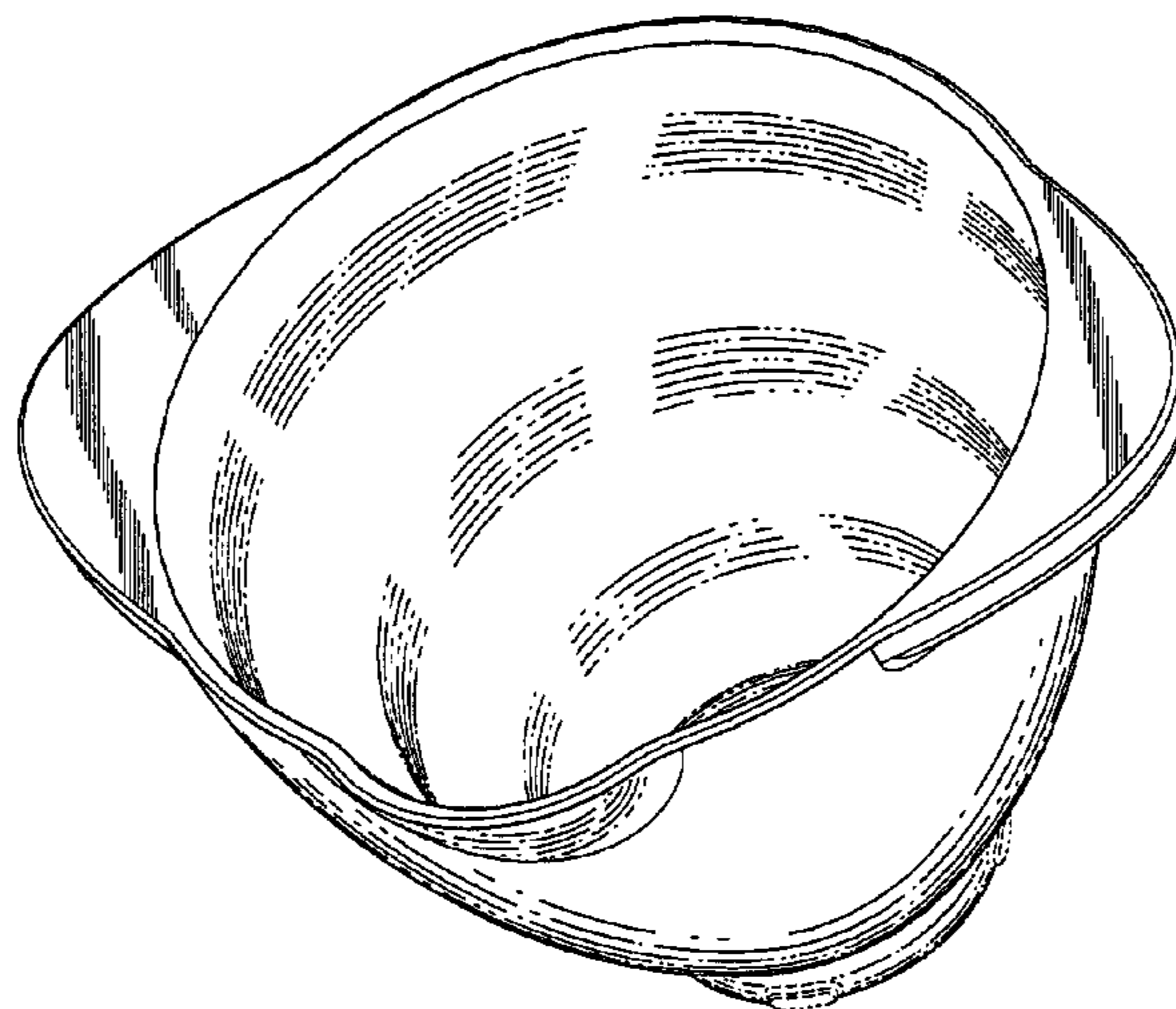
FIG. 5 is a bottom plan view thereof;

FIG. 6 is an end elevation view thereof; and,

FIG. 7 is an end elevation view of the end opposite that shown in FIG. 6.

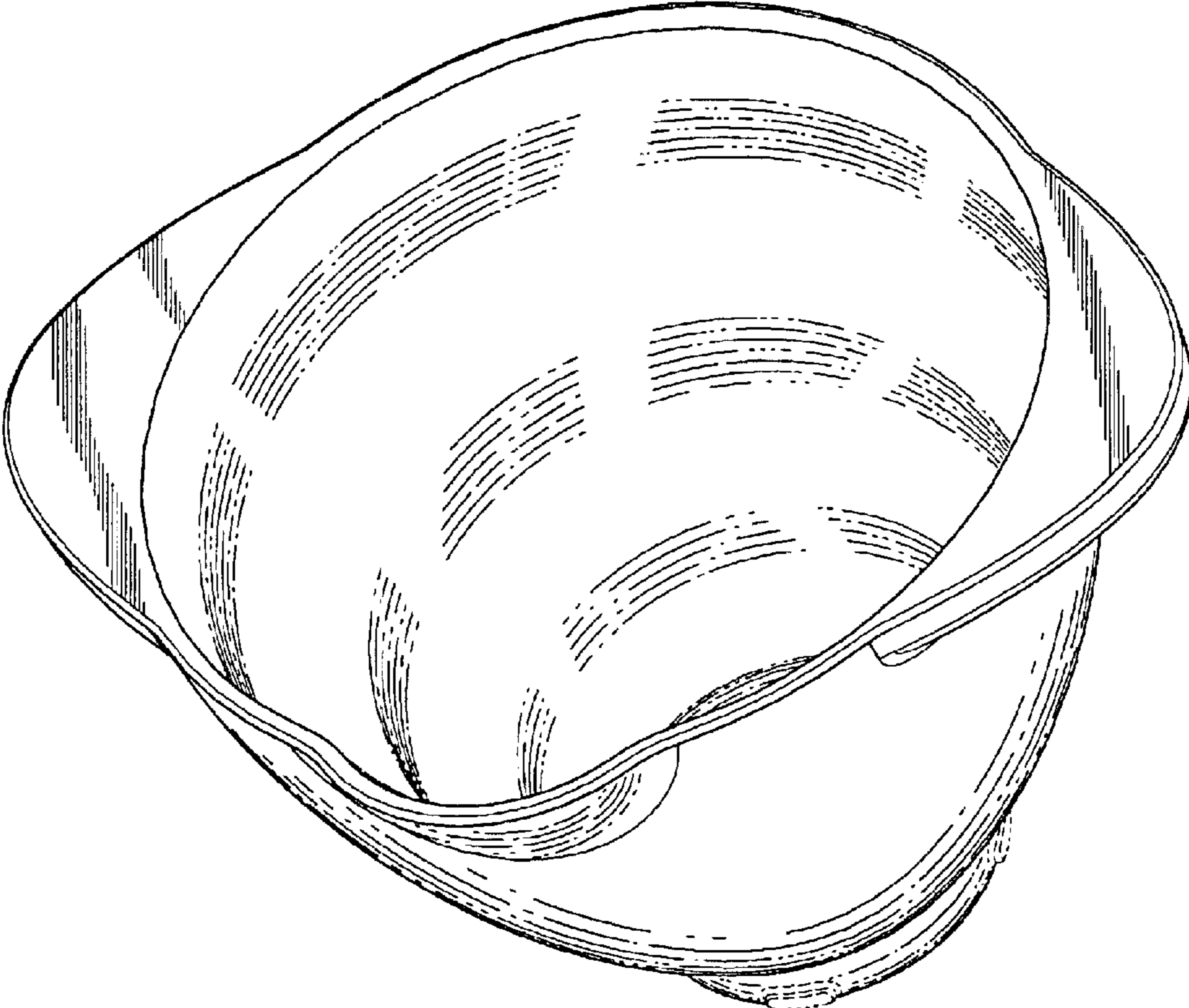

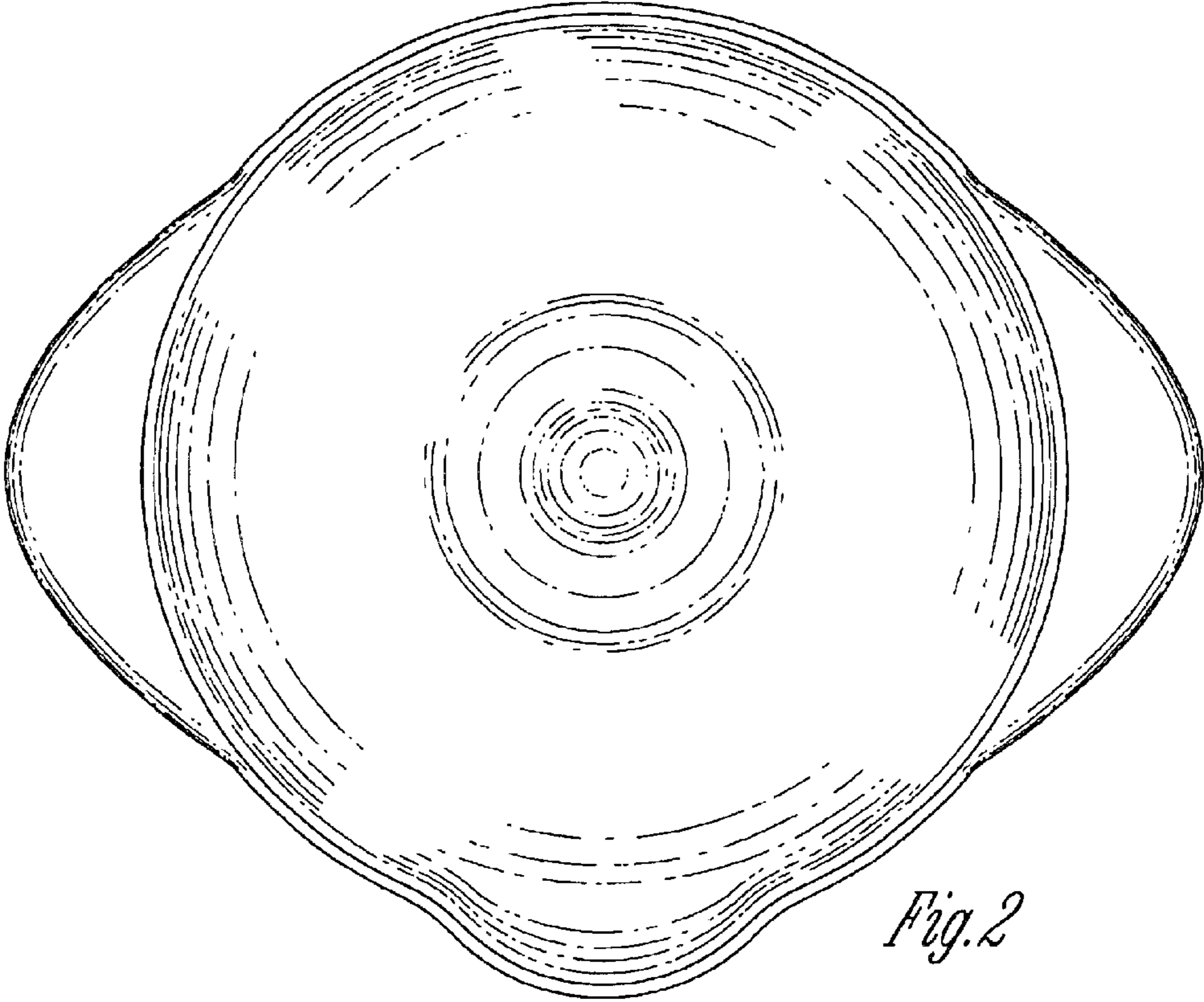

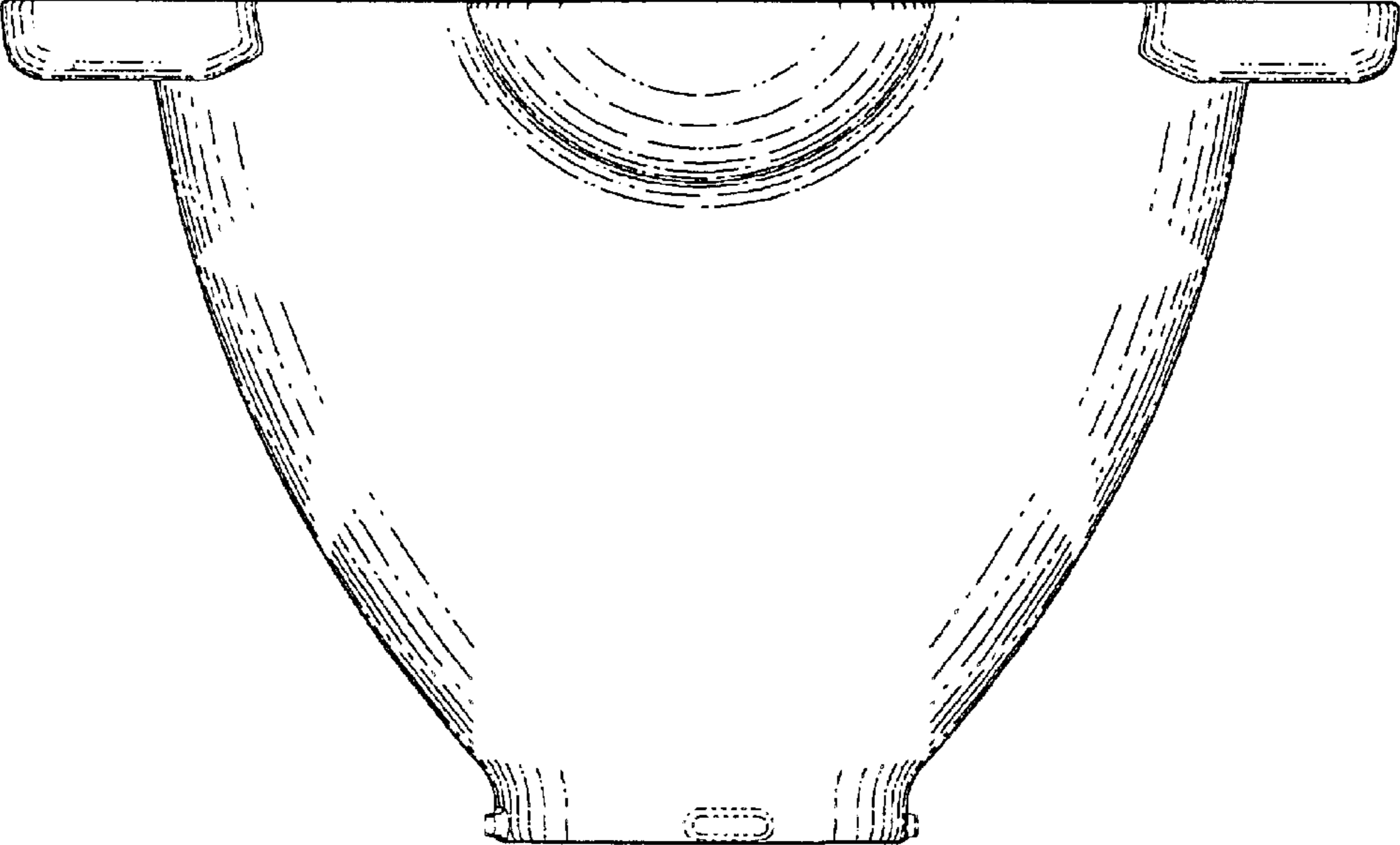

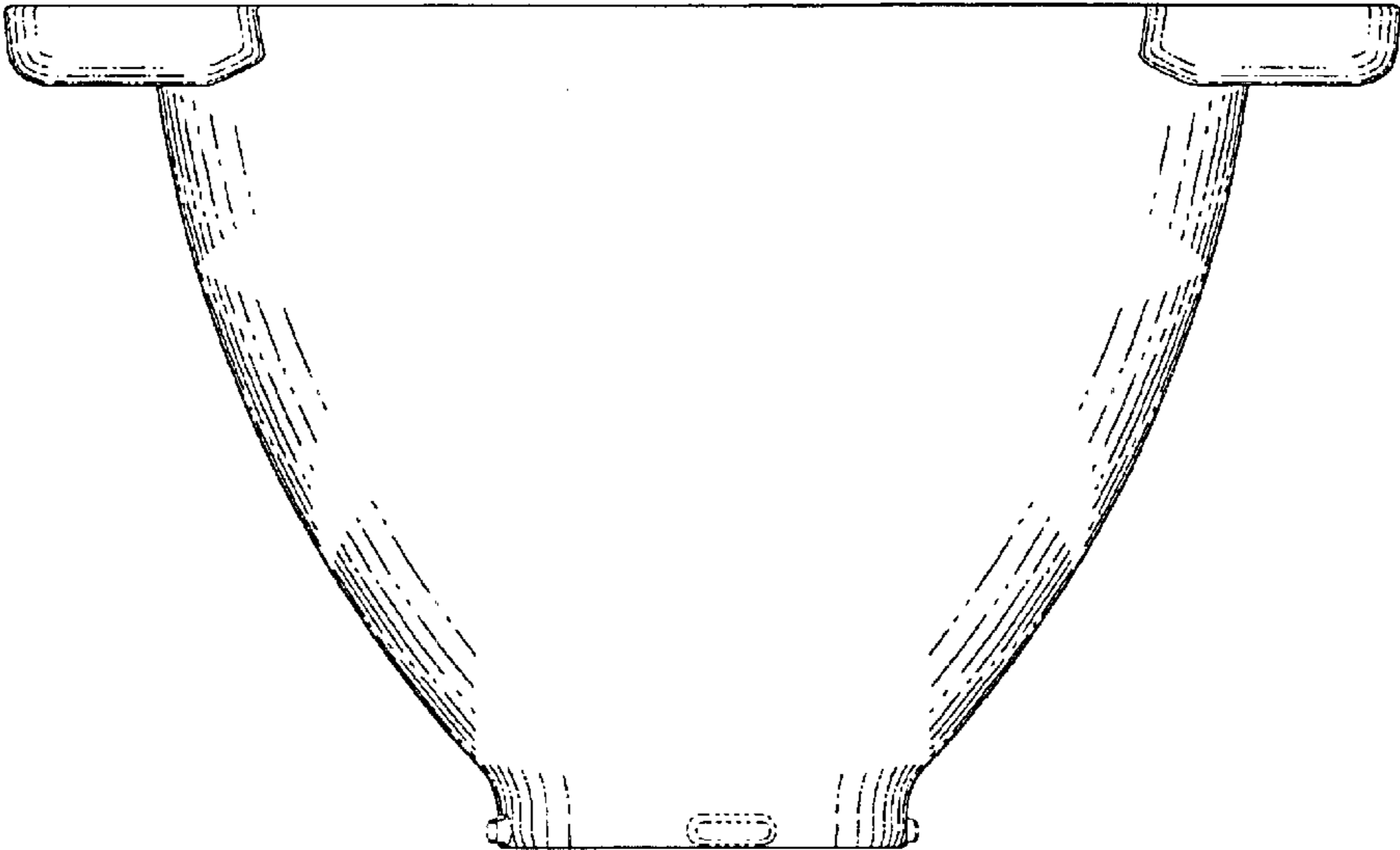

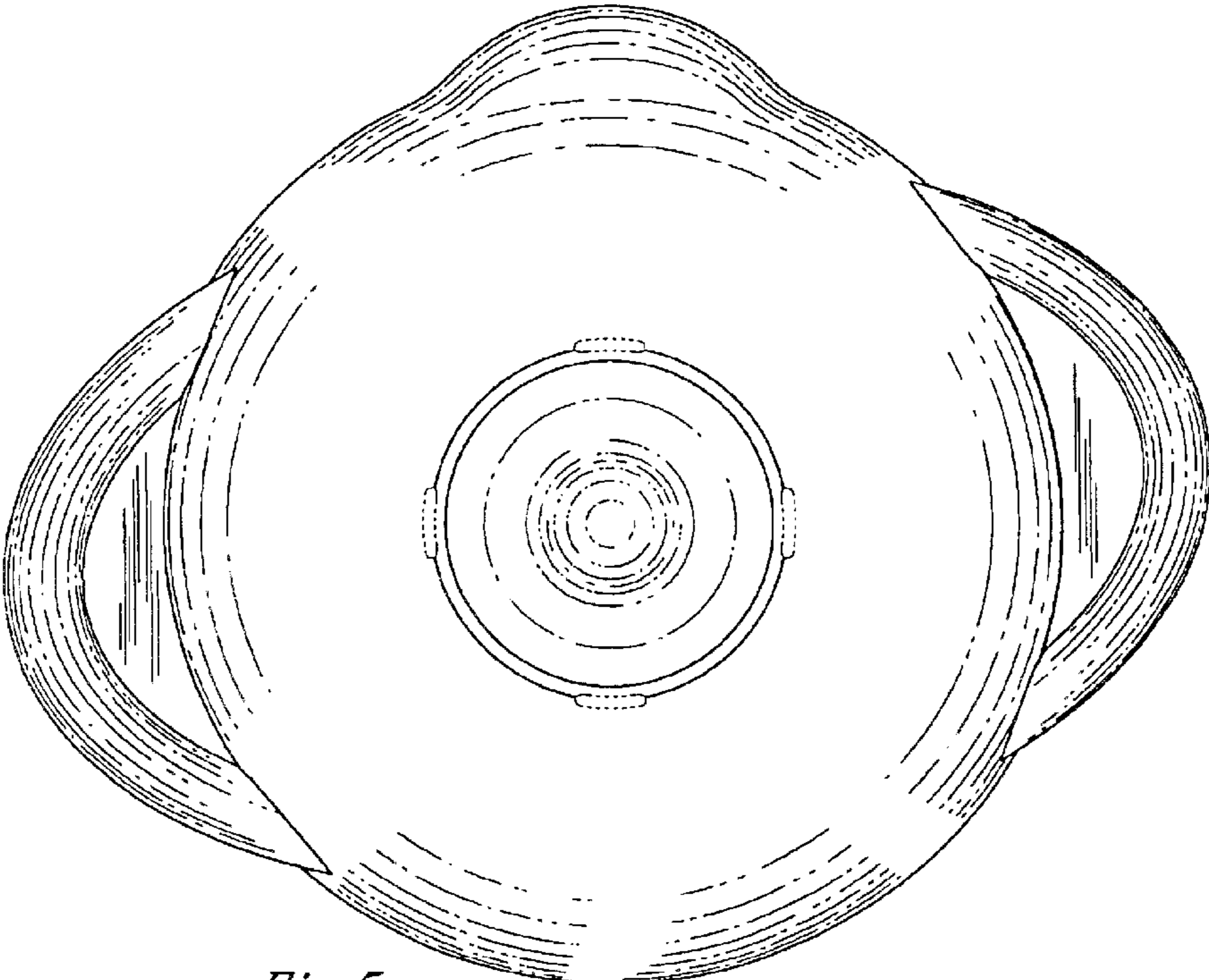

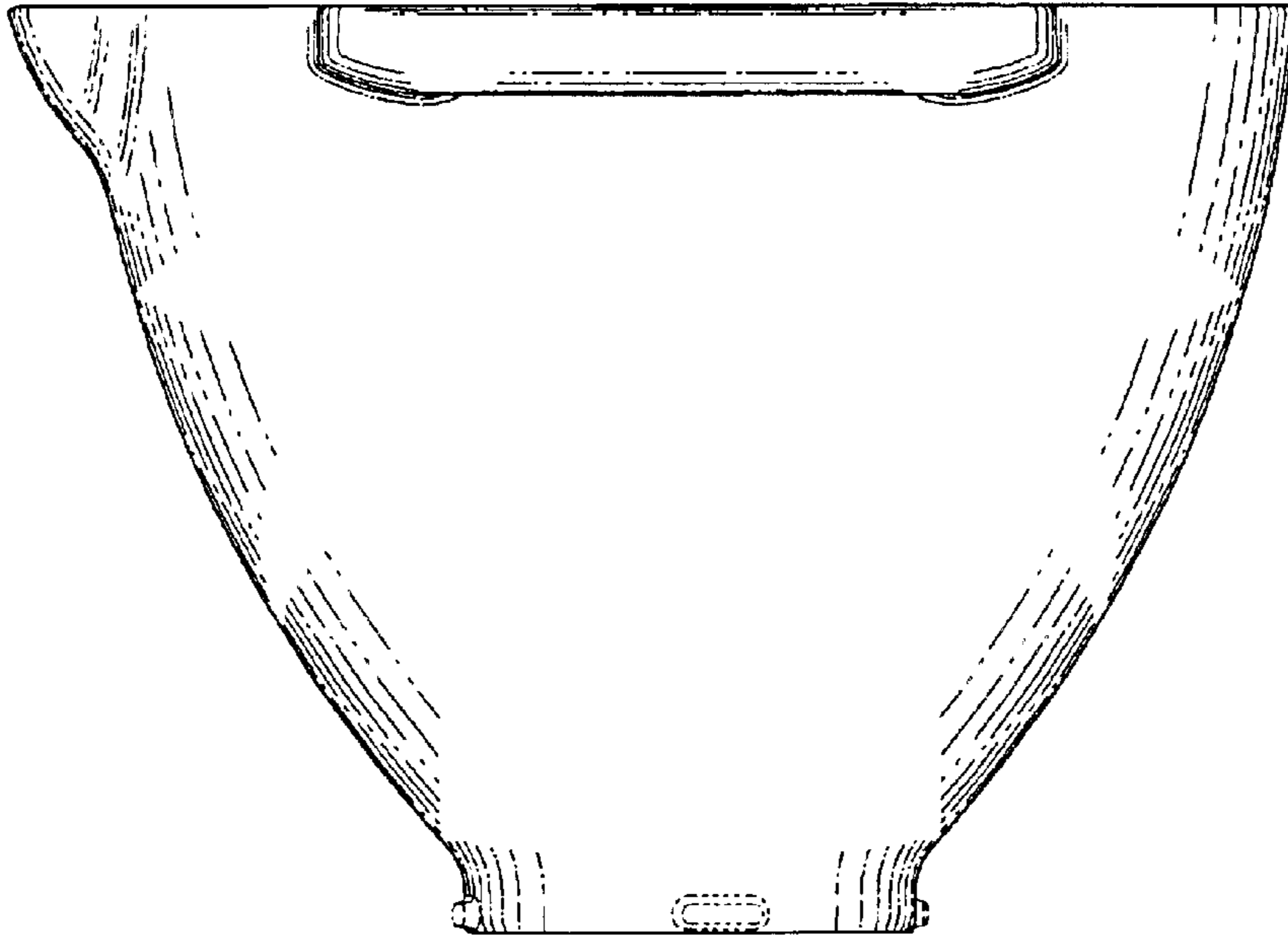

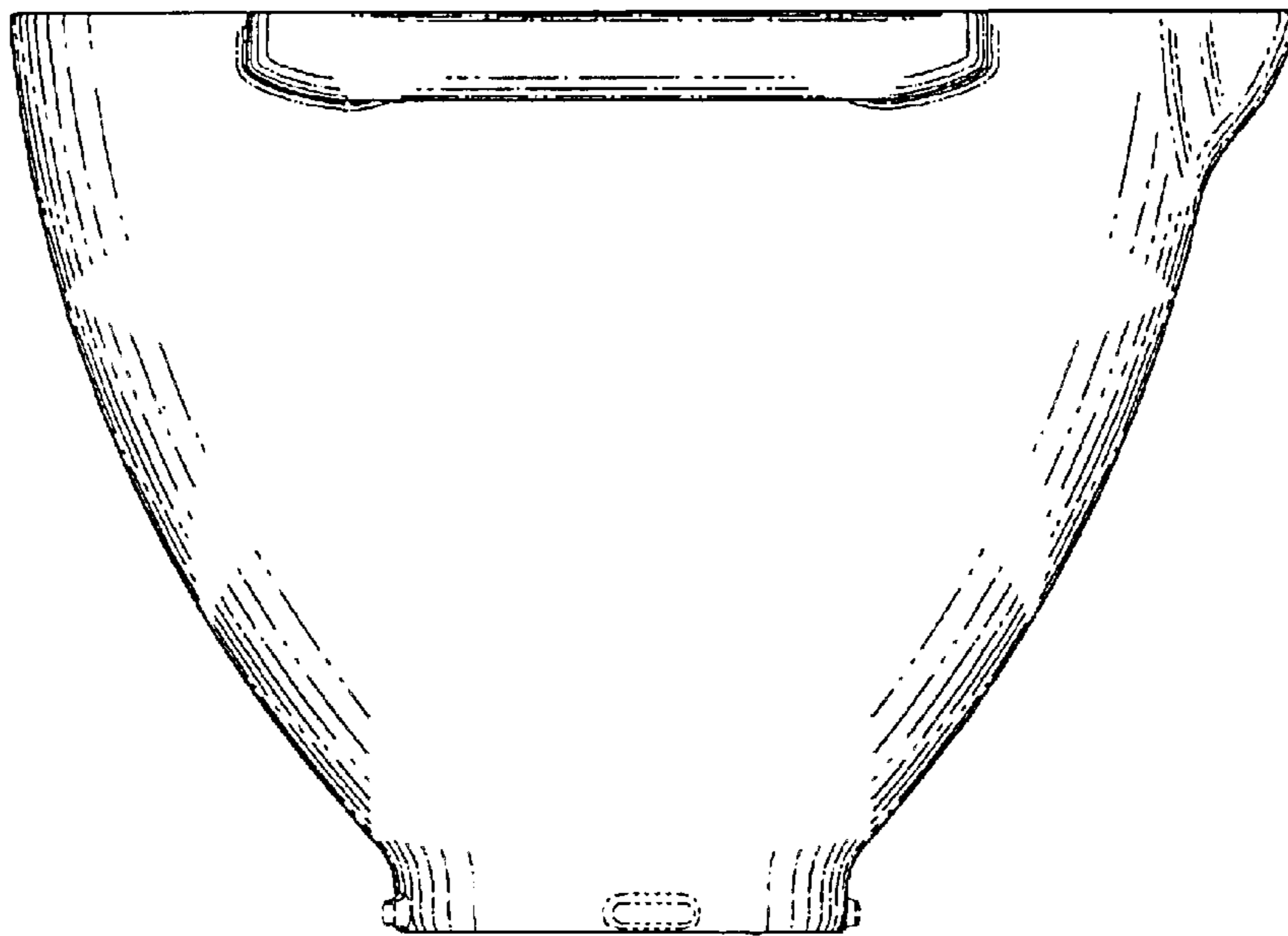
