(57) **CLAIM**

The ornamental design for a handheld biothreat detector, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an air sampling handheld biothreat detector with the sampler intake vent closed;

FIG. 2 is a perspective view of FIG. 1 with the sampler intake vent open;

FIG. 3 is a rear perspective view of the air sampling handheld biothreat detector shown in FIGS. 1 and 2;

FIG. 4 is a front elevational view of the air sampling handheld biothreat detector with the sampler intake vent open;

FIG. 5 is a rear elevational view of the air sampling handheld biothreat detector;

FIG. 6 is a right side elevational view of the air sampling handheld biothreat detector;

FIG. 7 is a left side elevational view of the air sampling handheld biothreat detector;

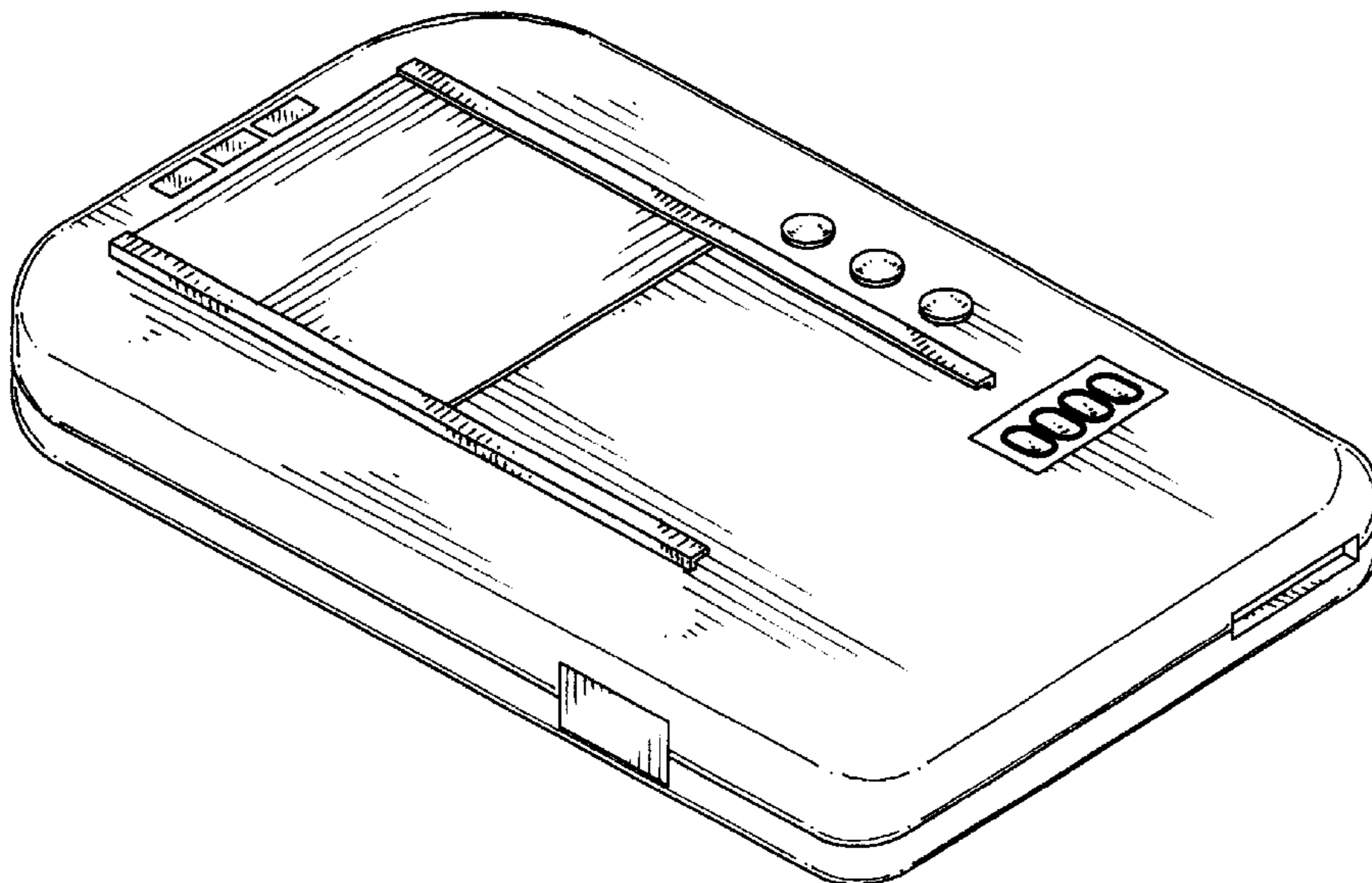
FIG. 8 is a top plan view of the air sampling handheld biothreat detector;

FIG. 9 is a bottom plan view of the air sampling handheld biothreat detector; and,

FIG. 10 is a perspective view showing the environment of an auxiliary docking station in phantom lines for extending the function and capability of the handheld detector.

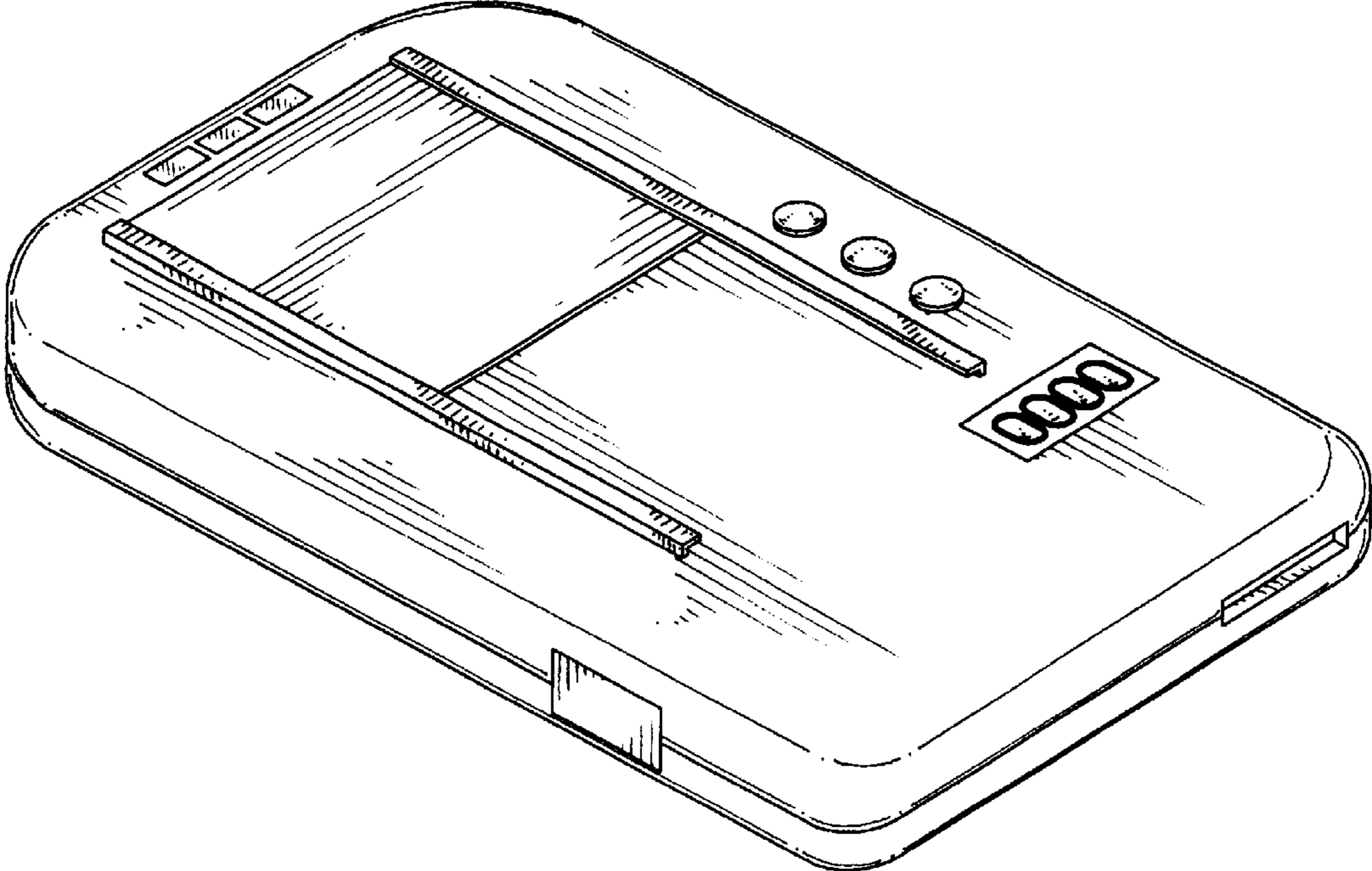

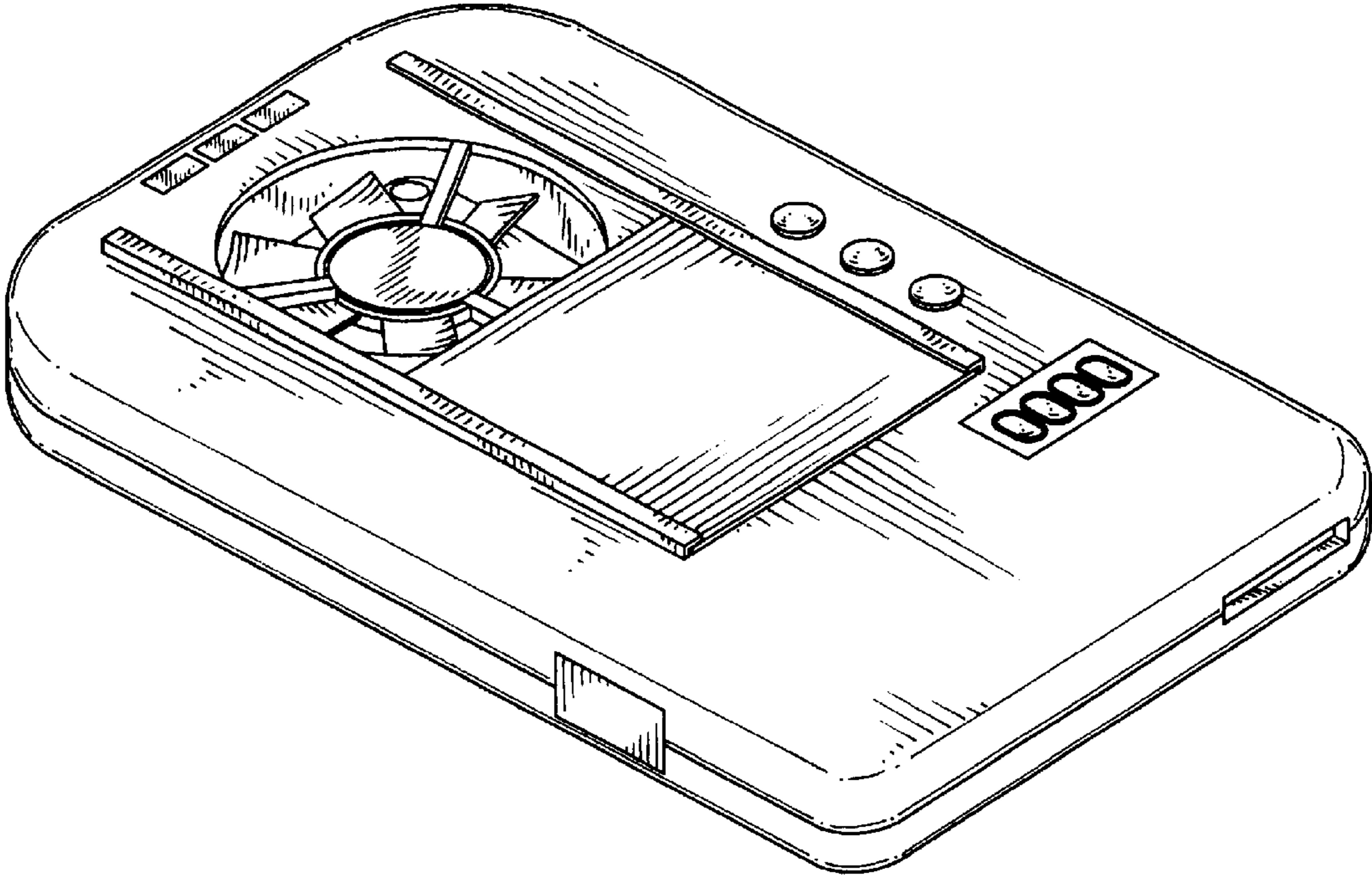

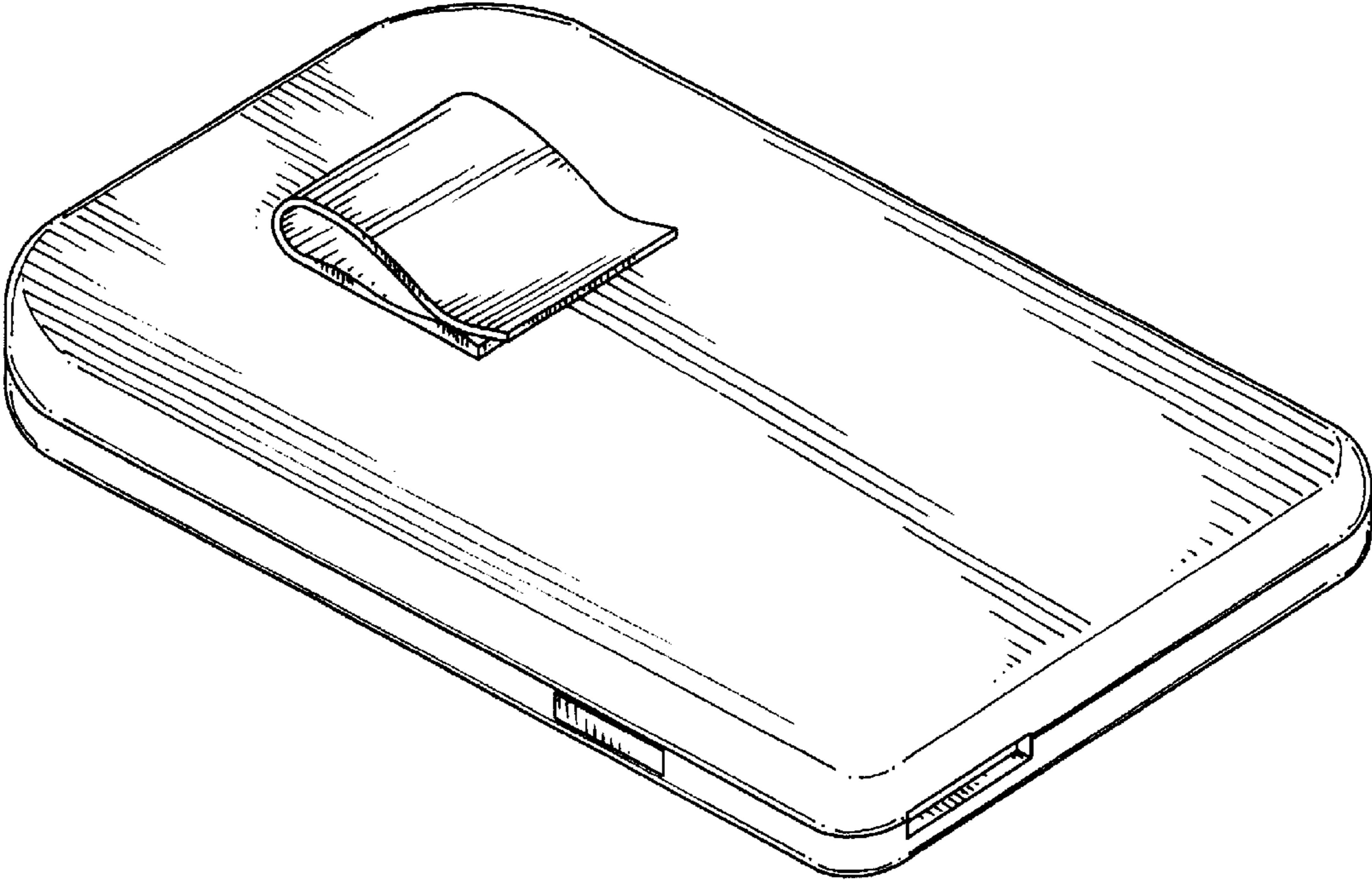

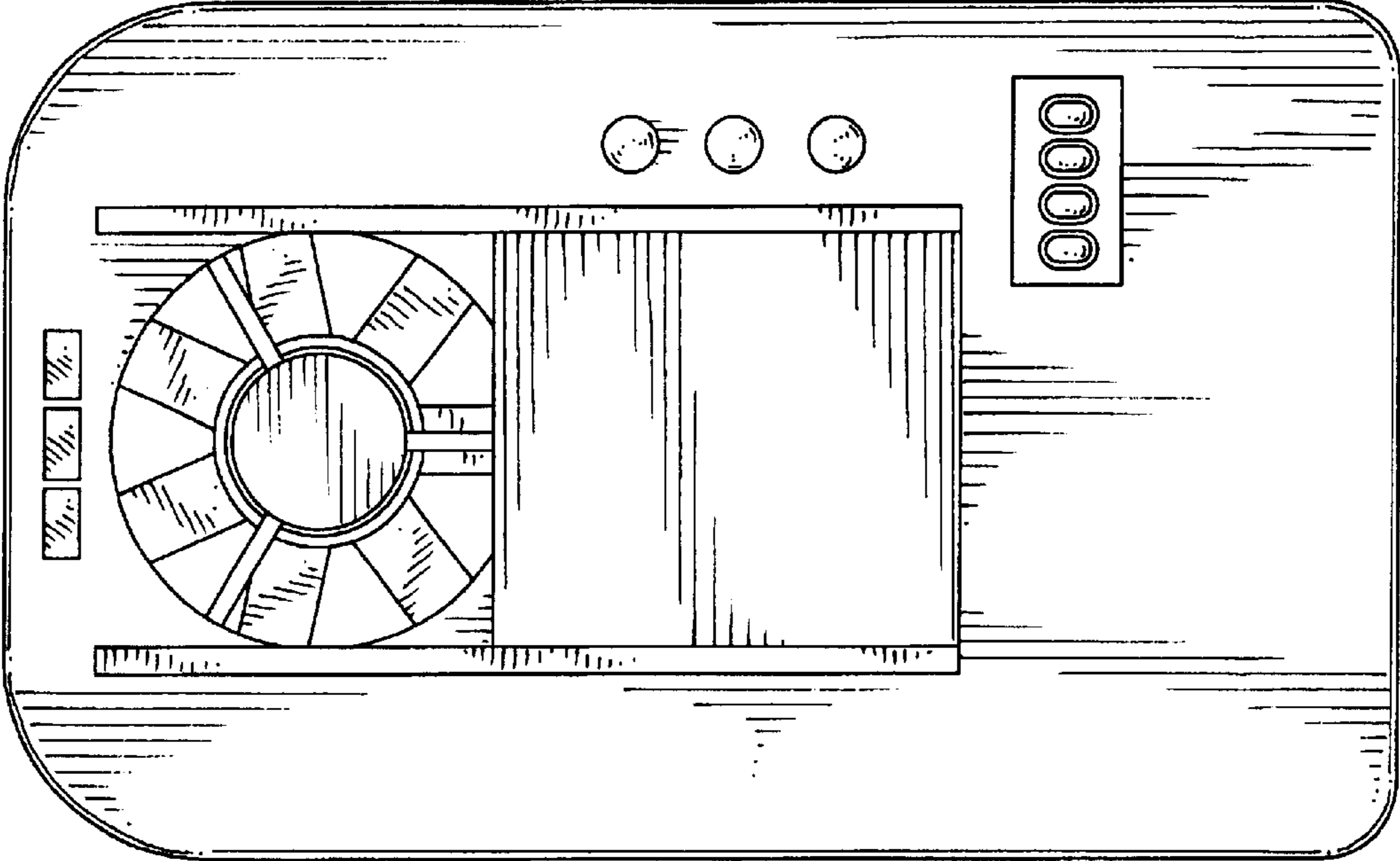

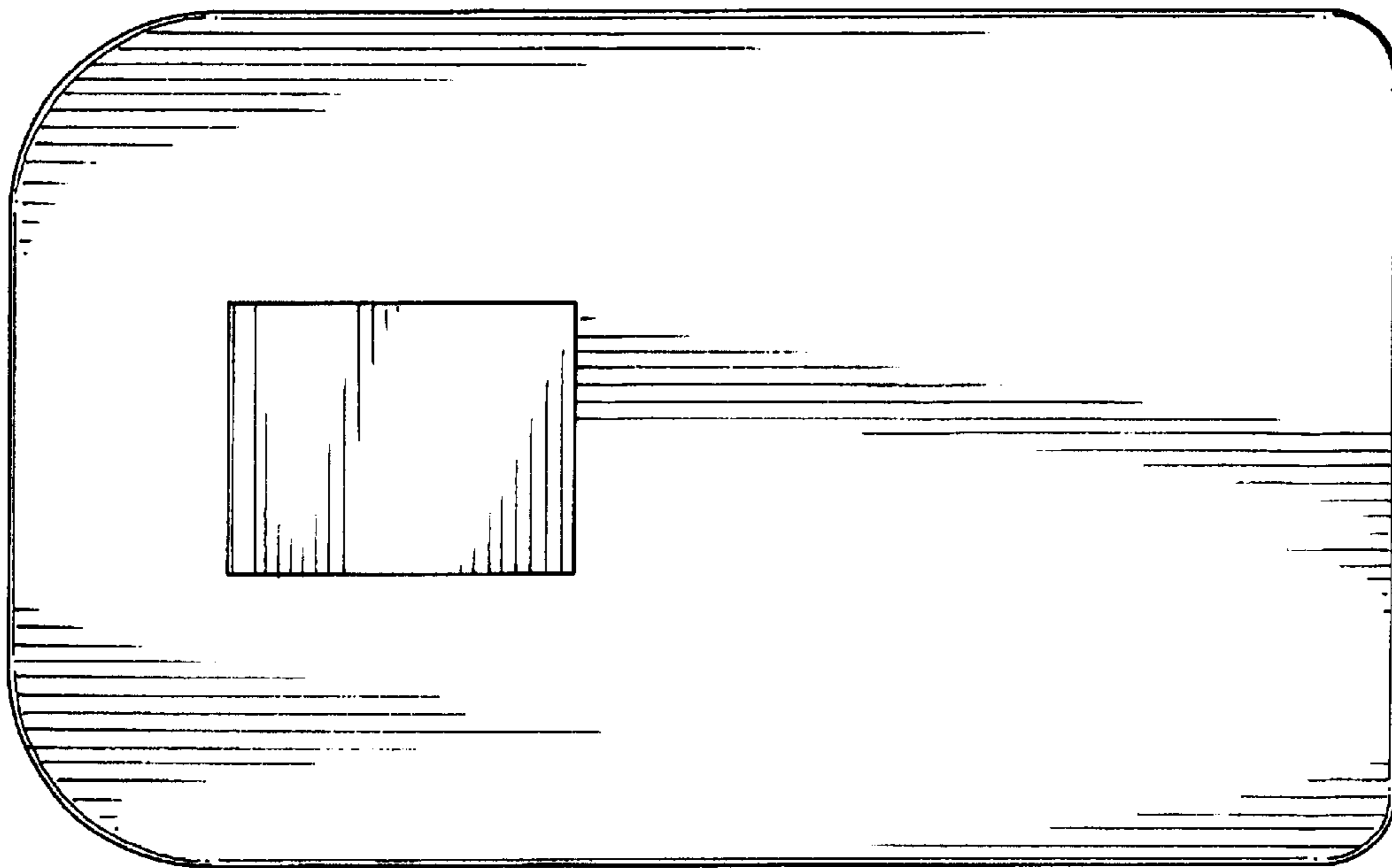

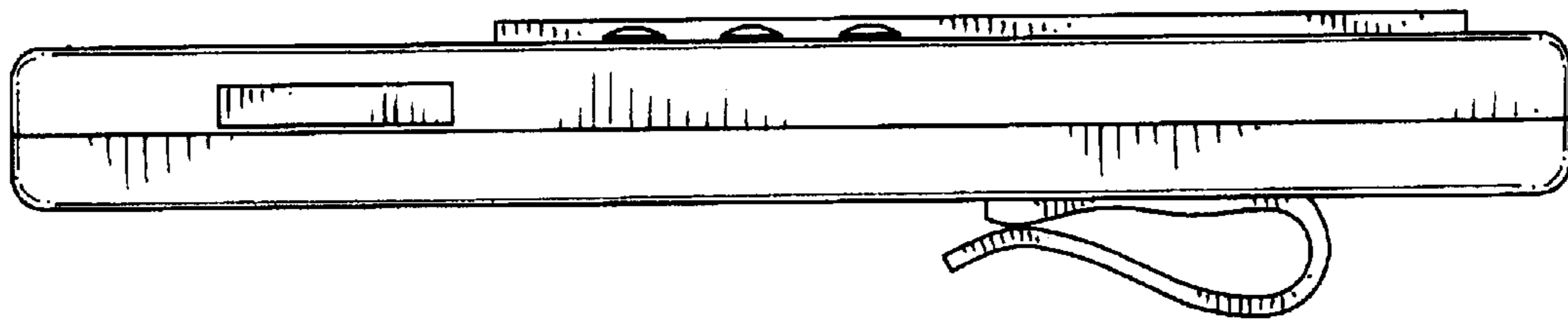

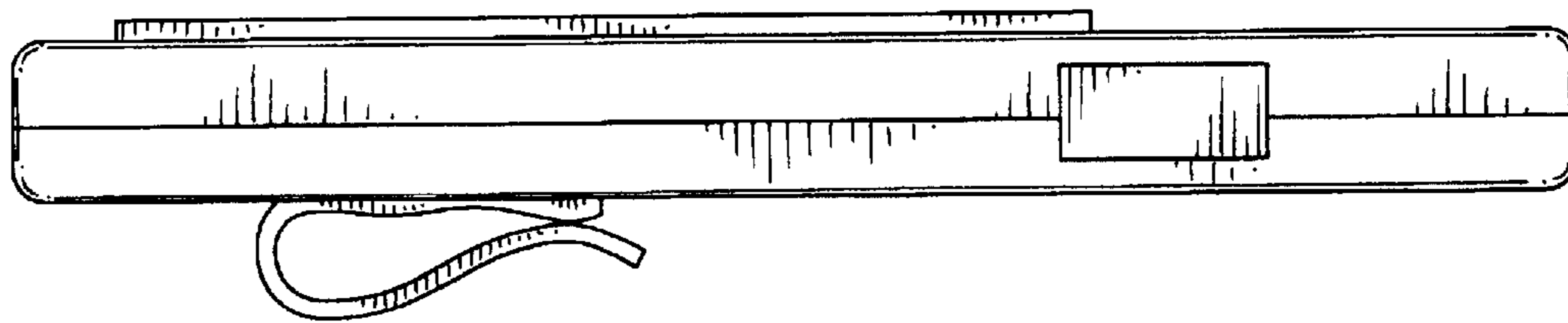

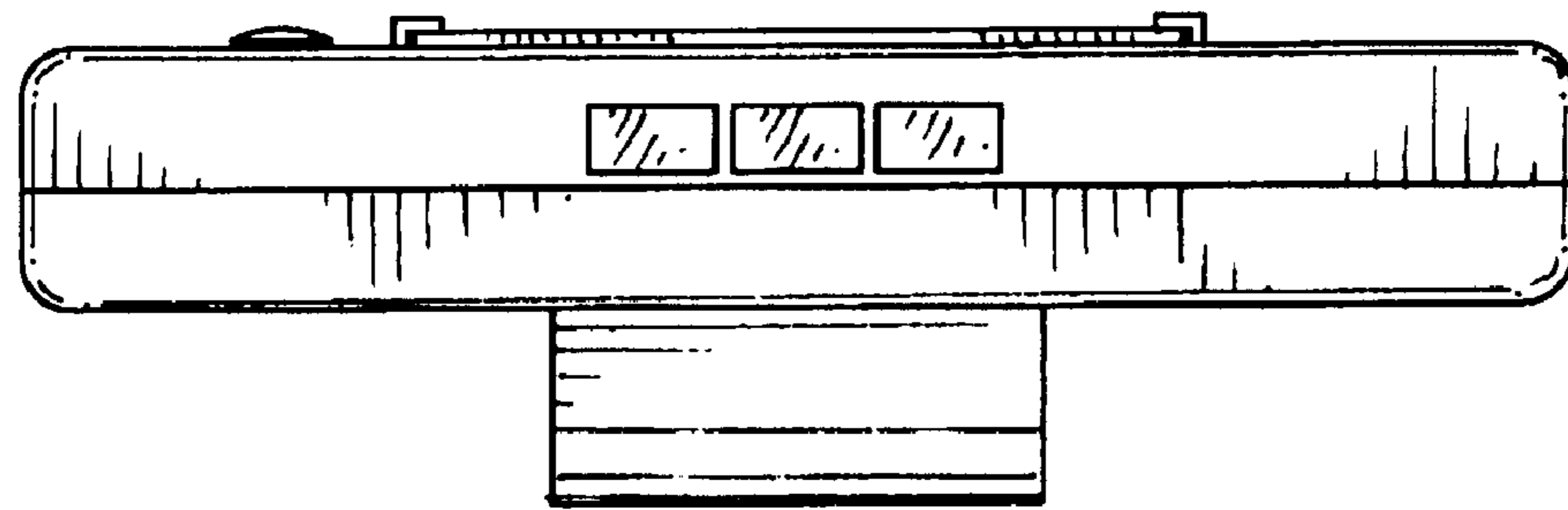

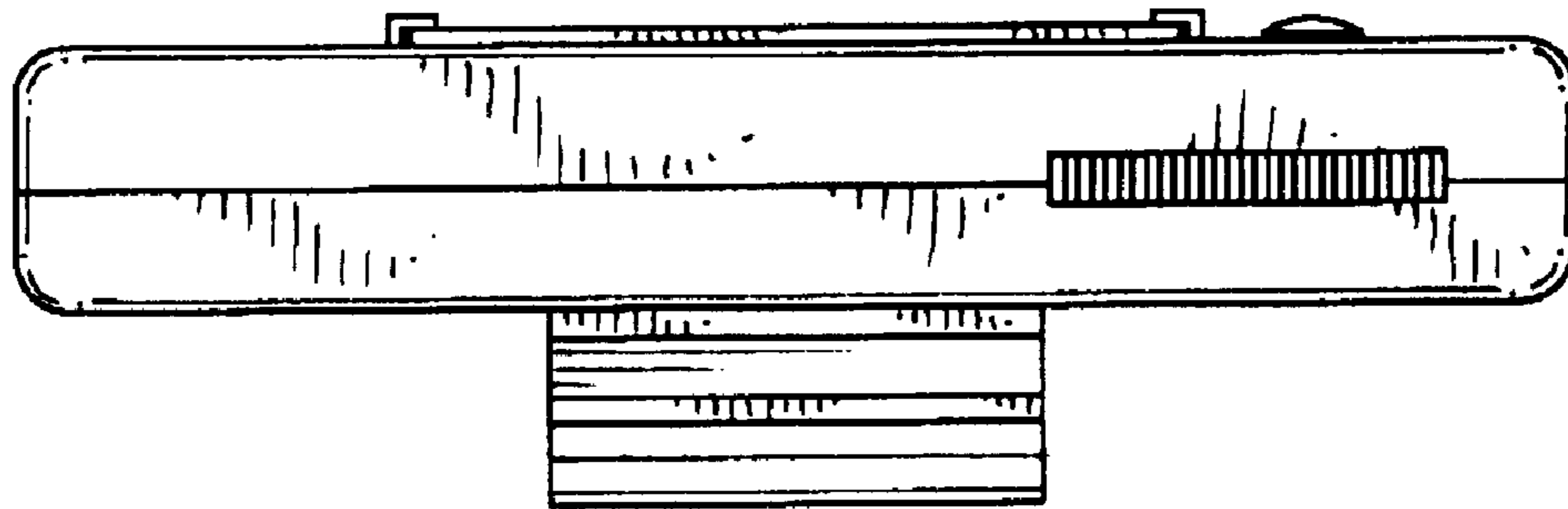

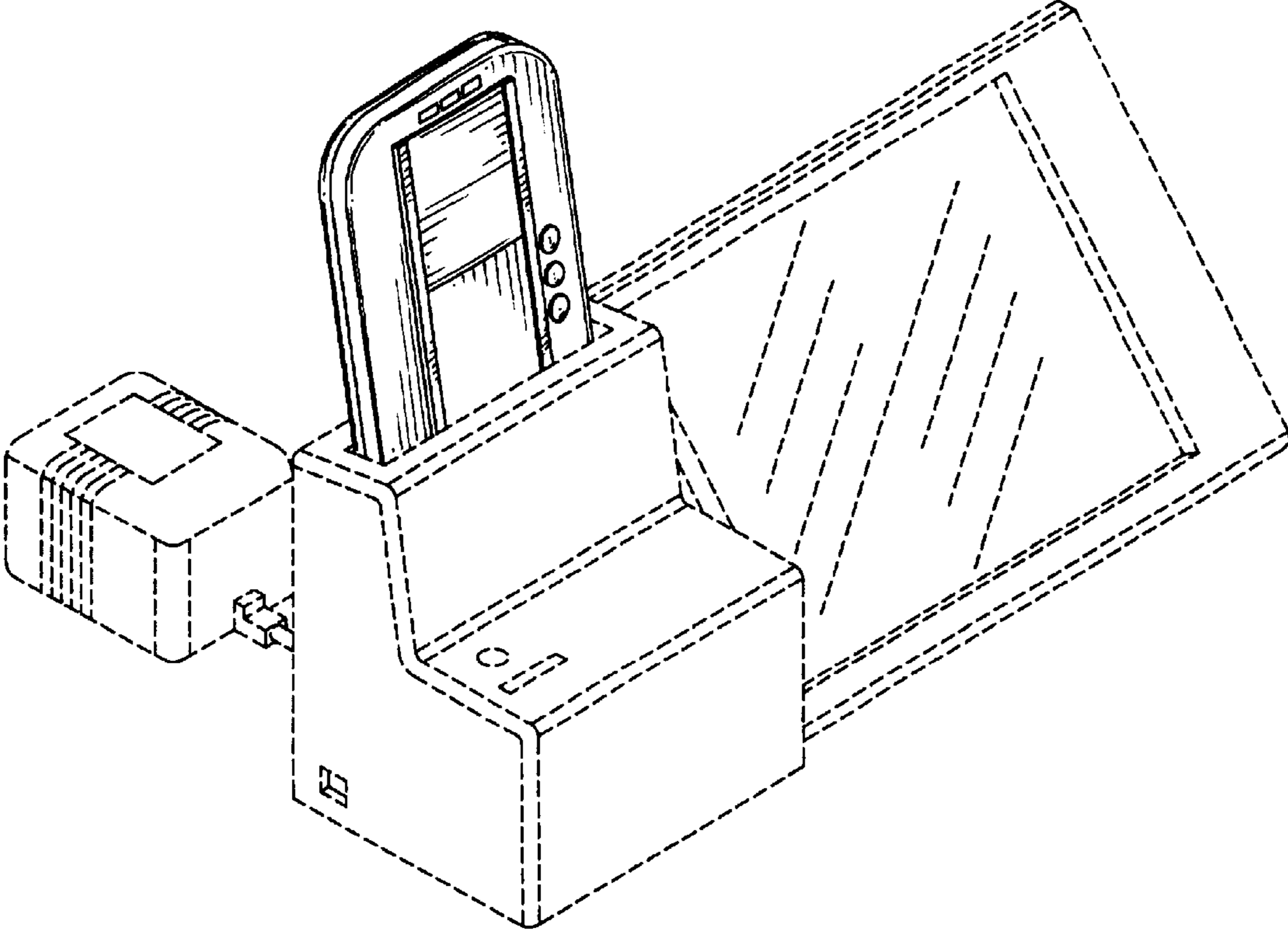
