DESCRIPTION

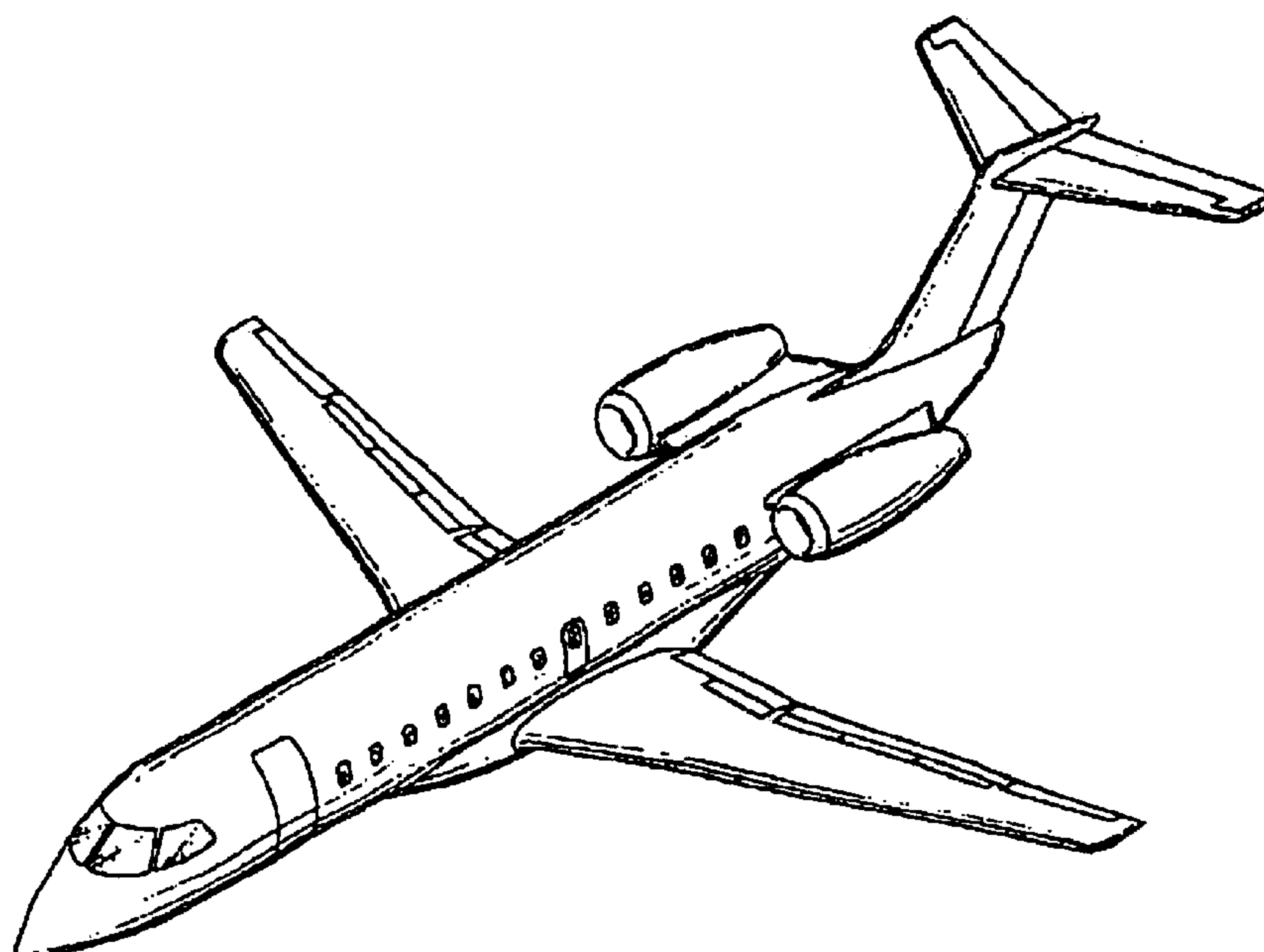

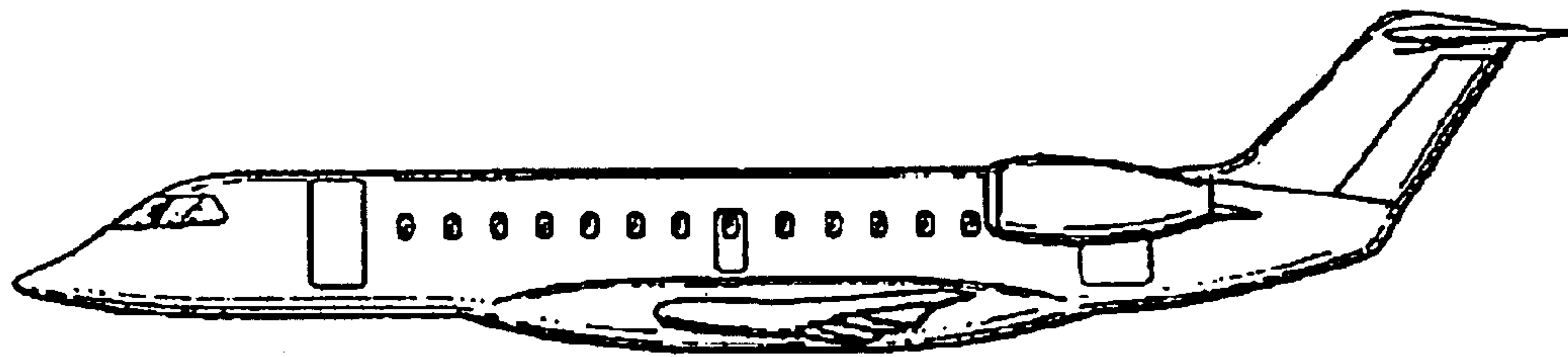

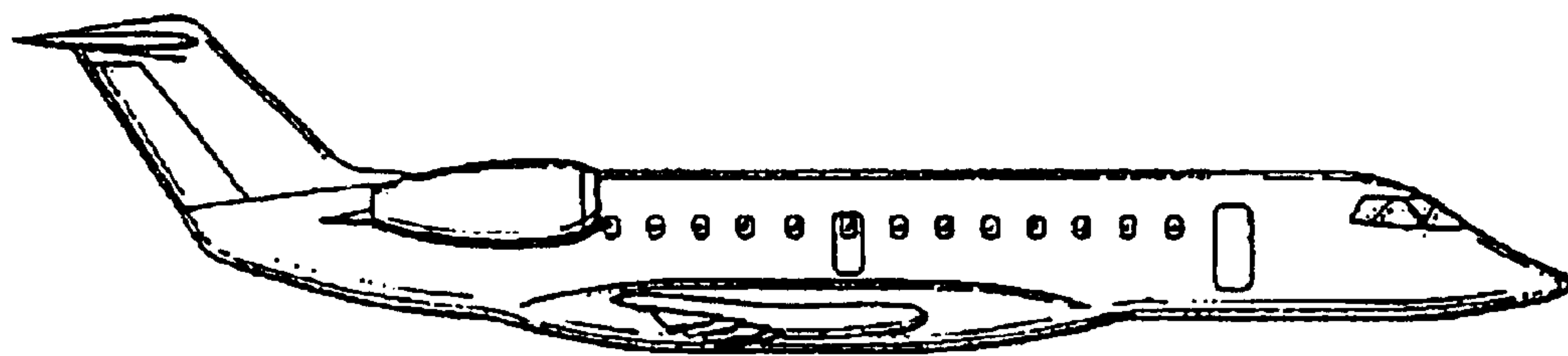

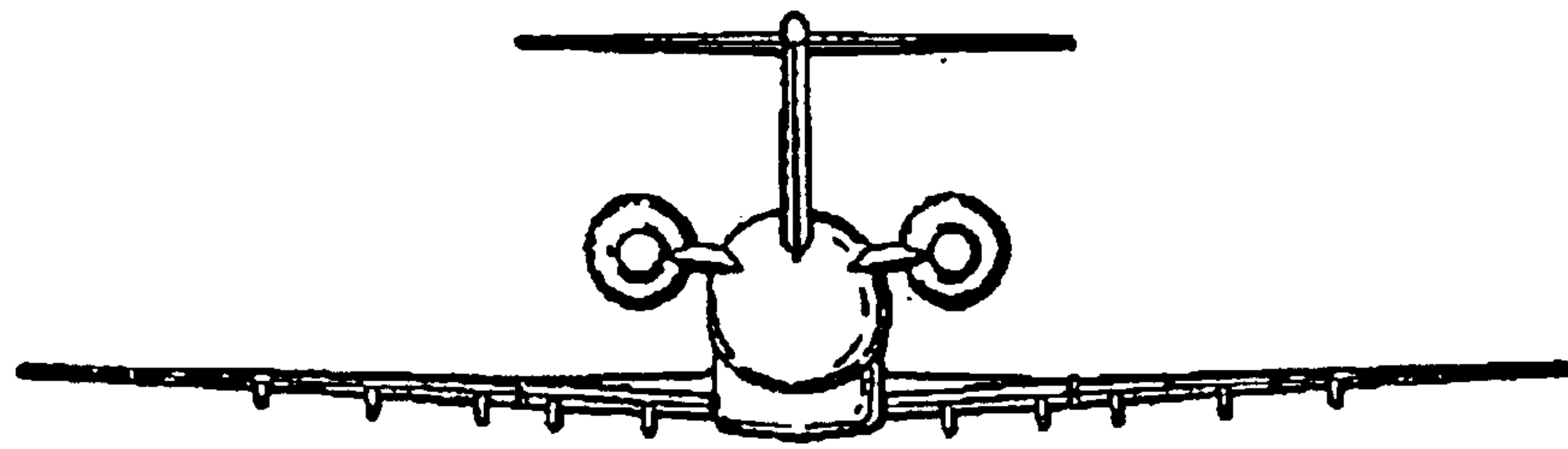

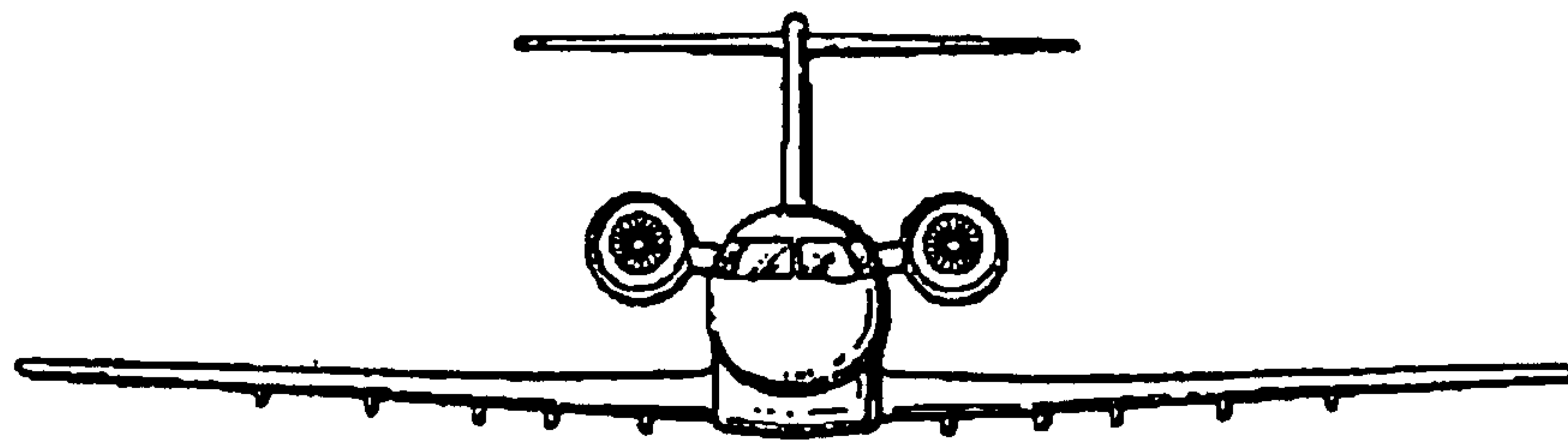

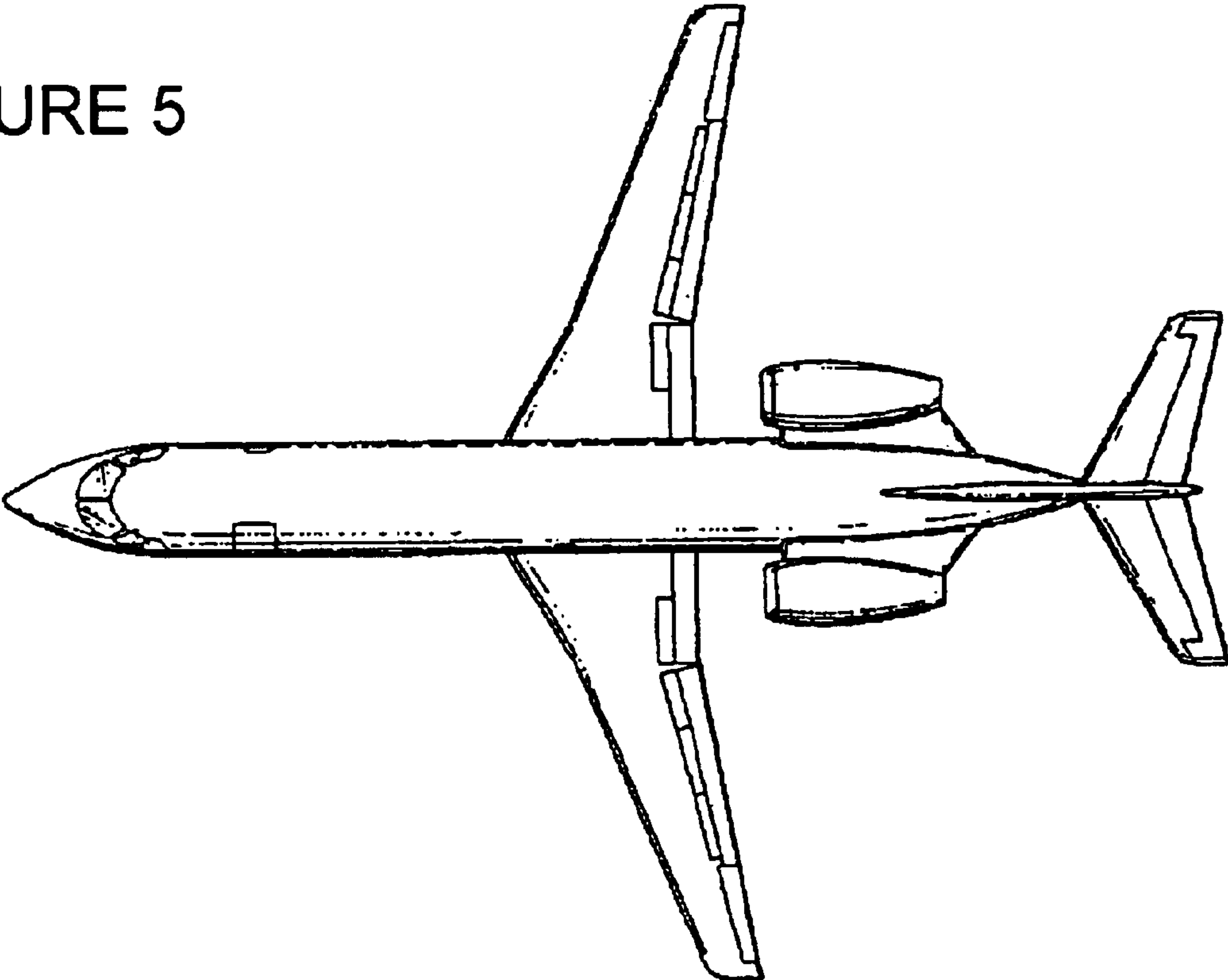

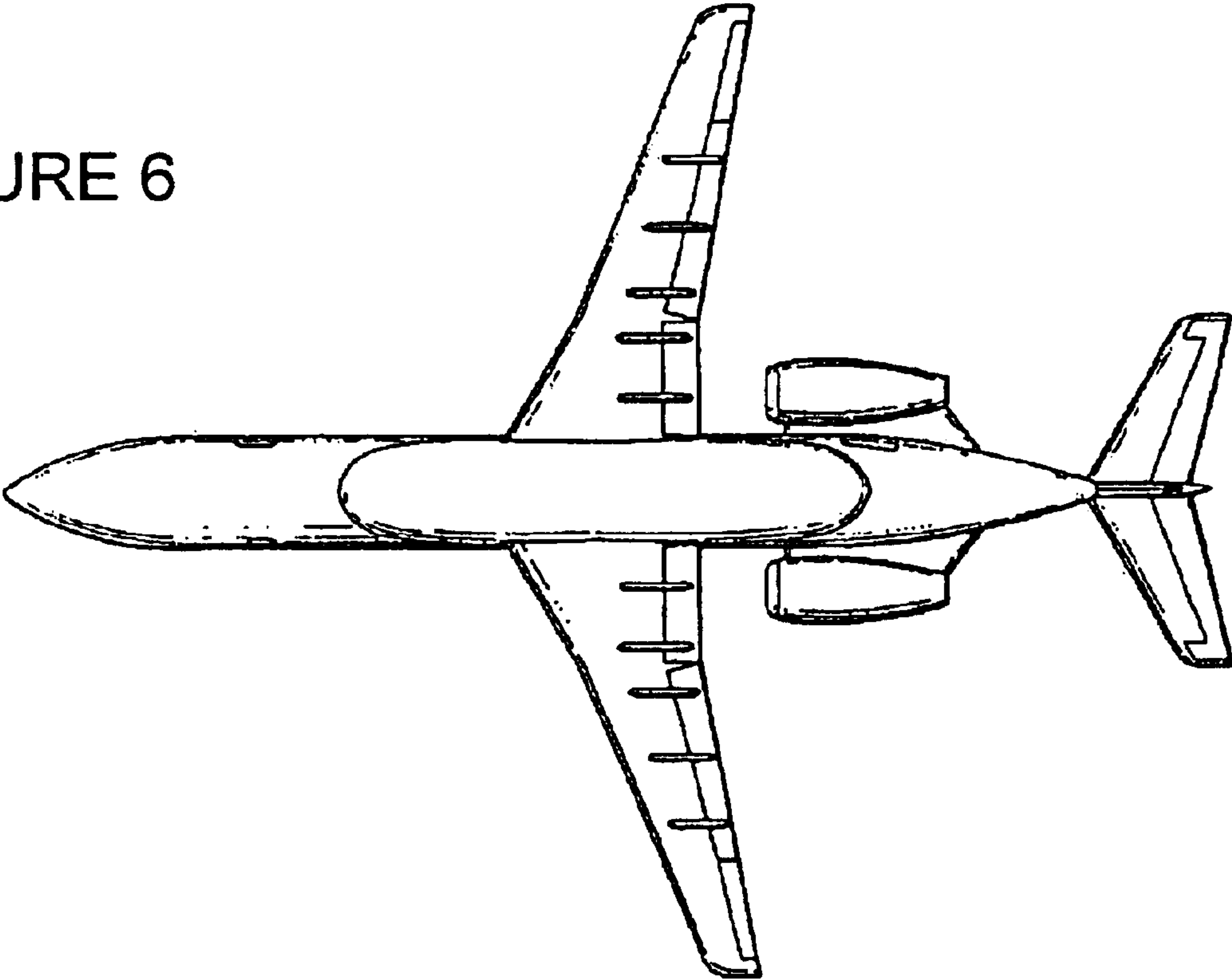

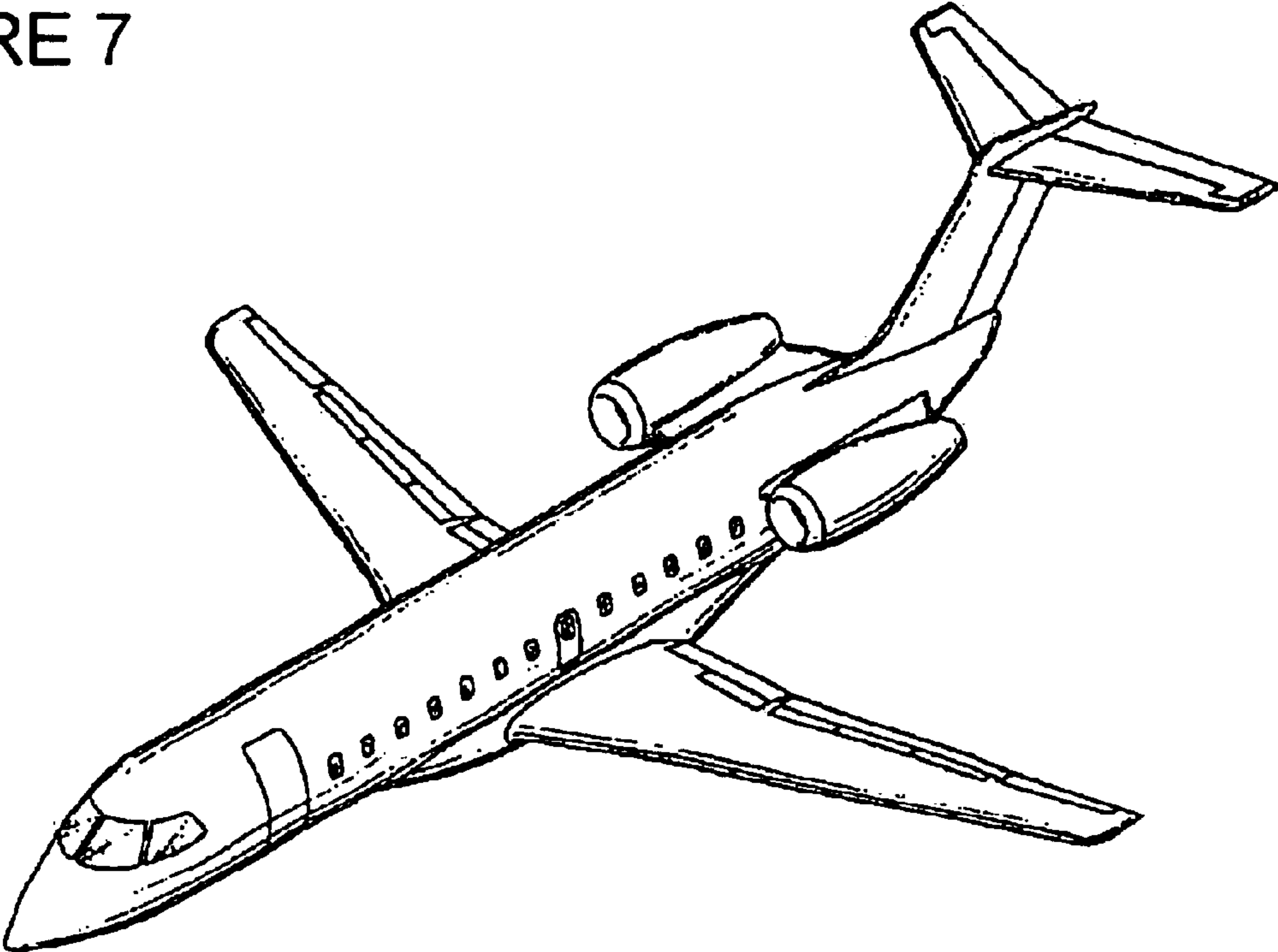

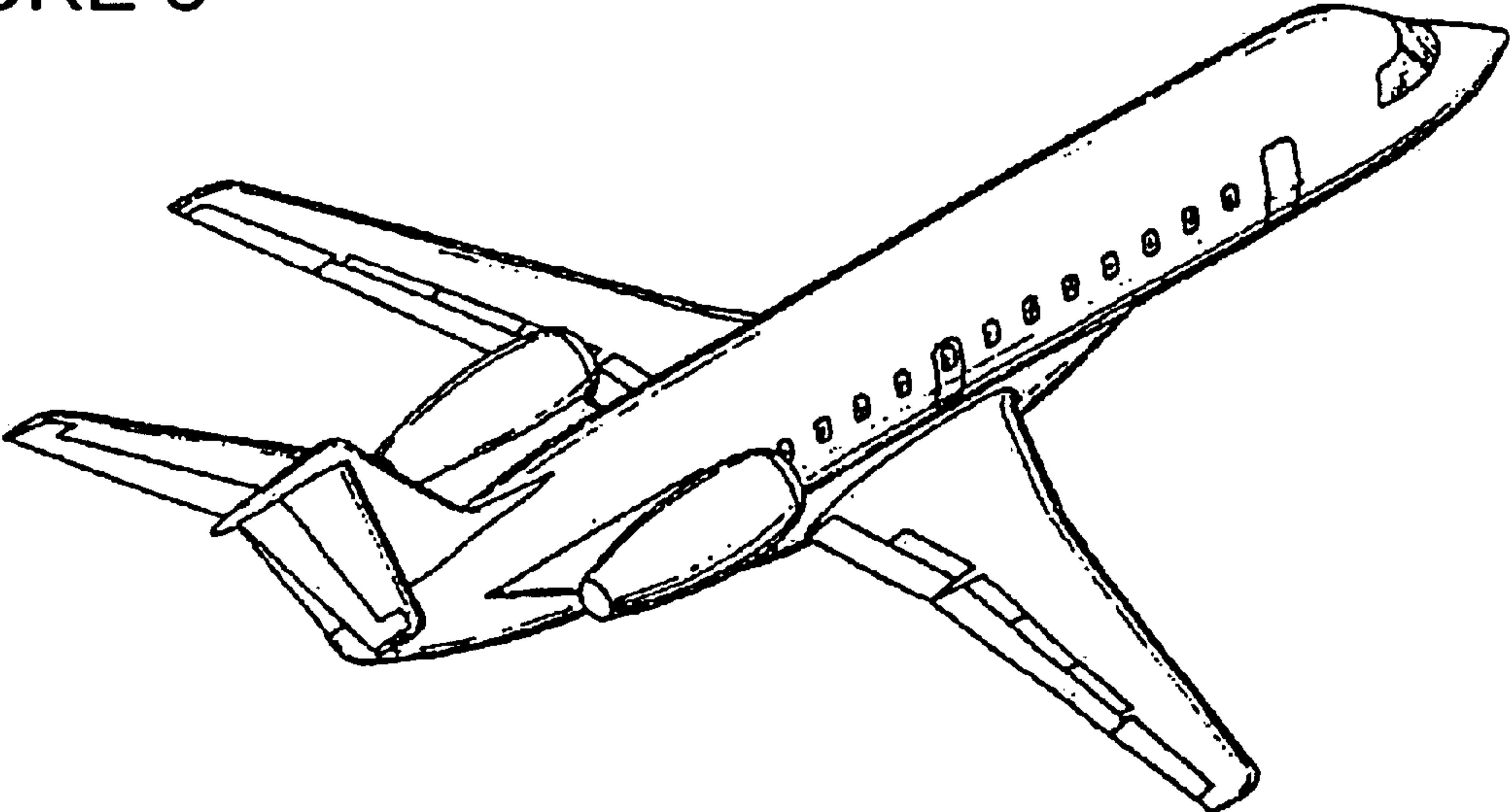

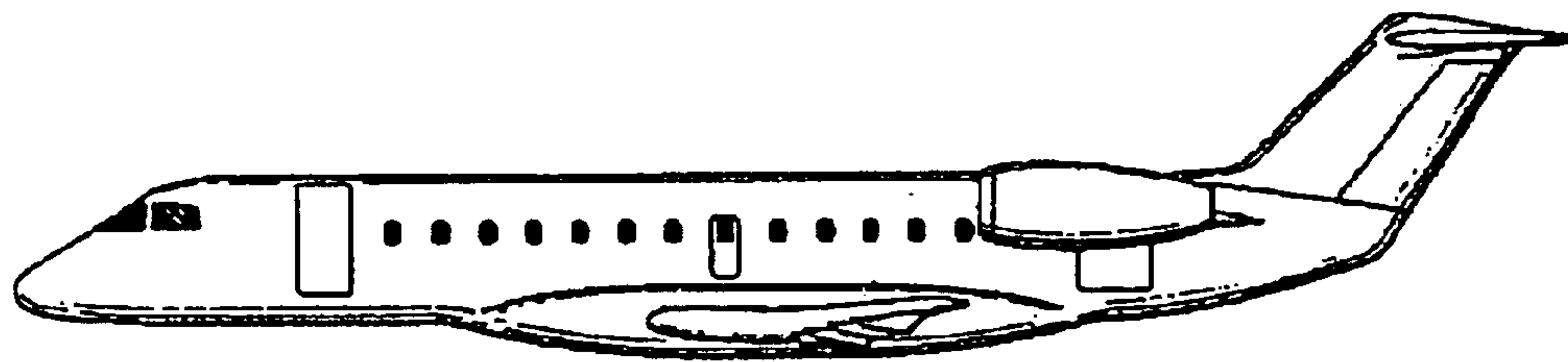

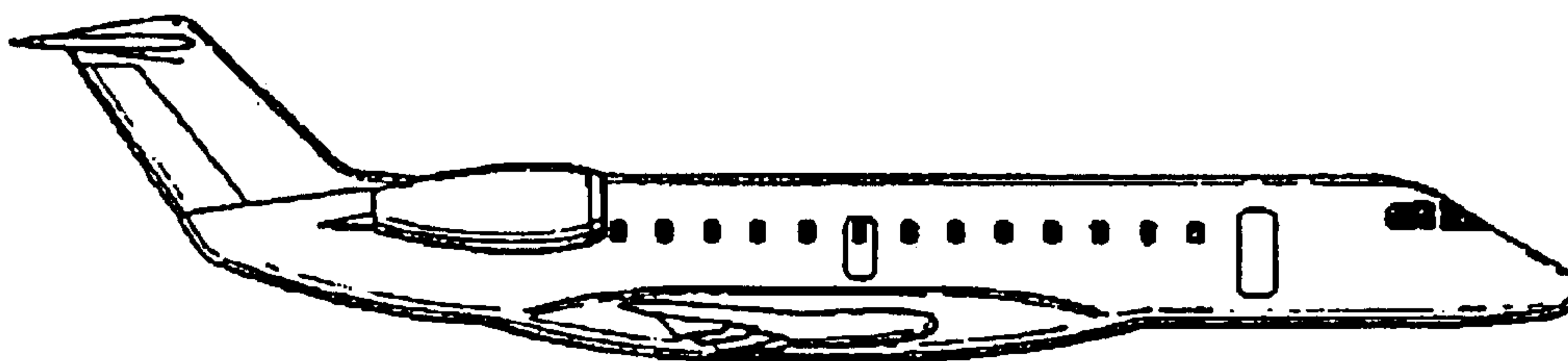

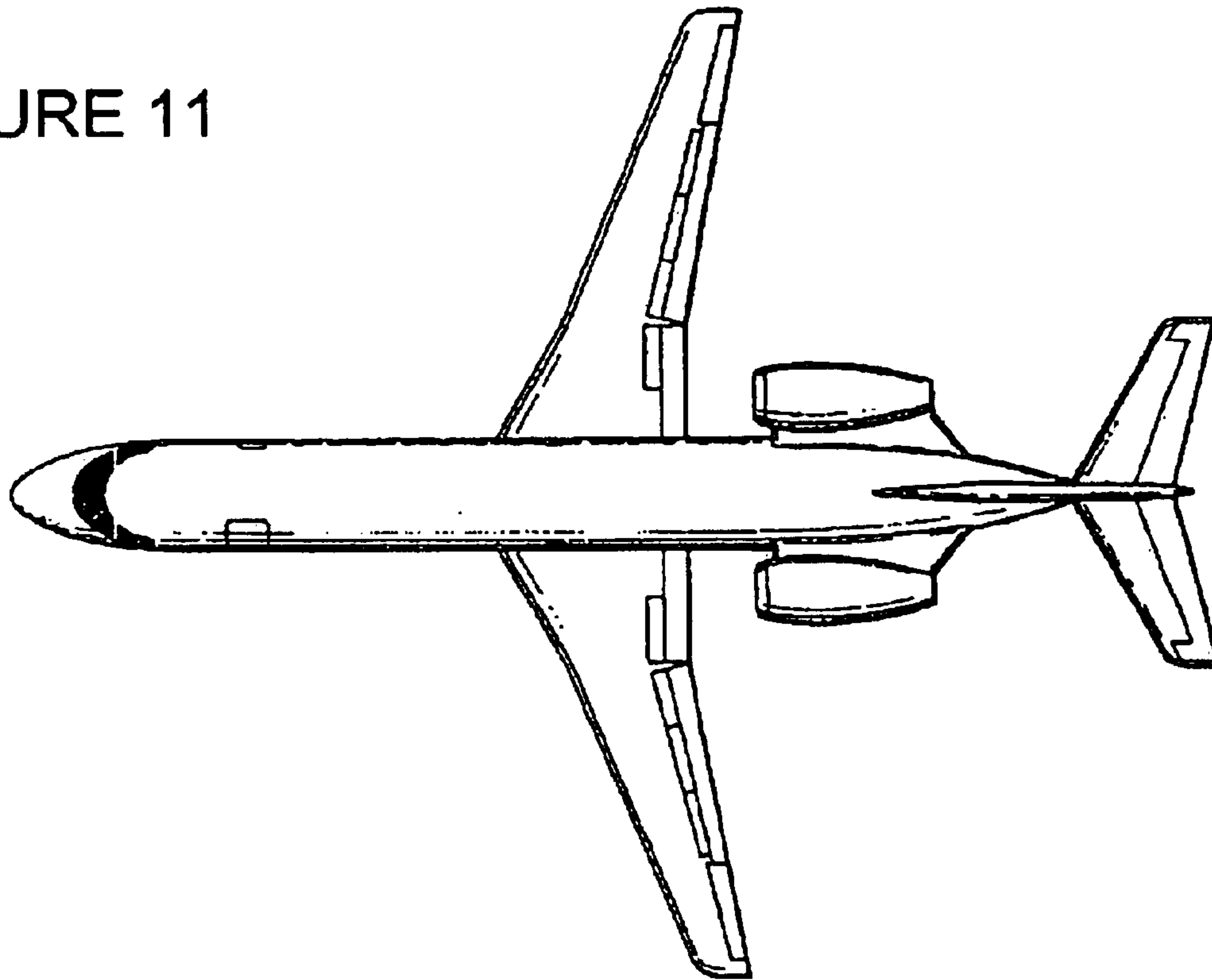

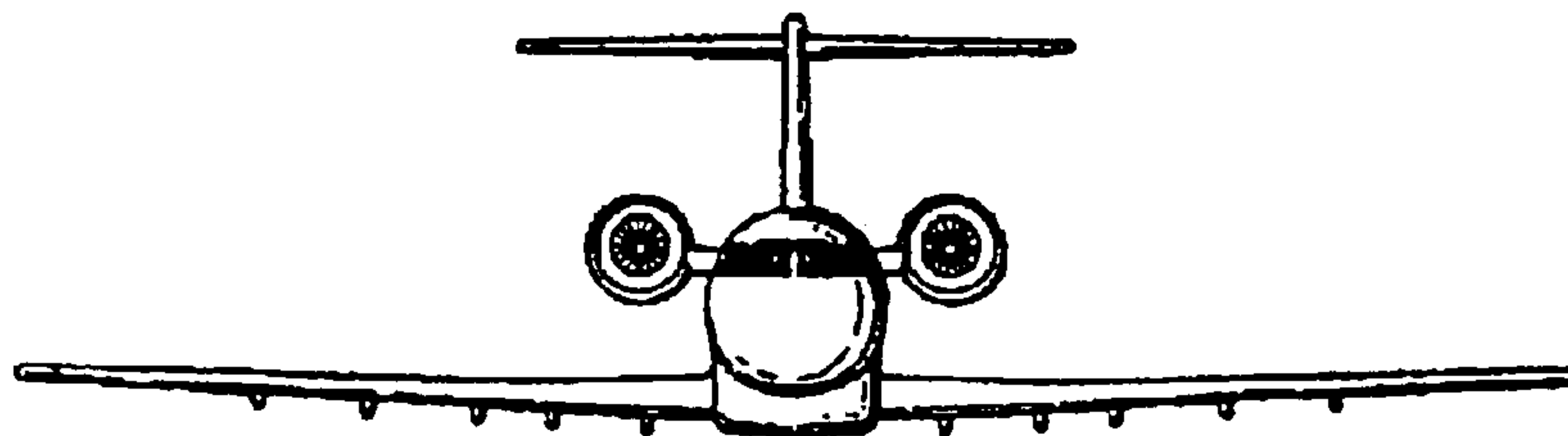

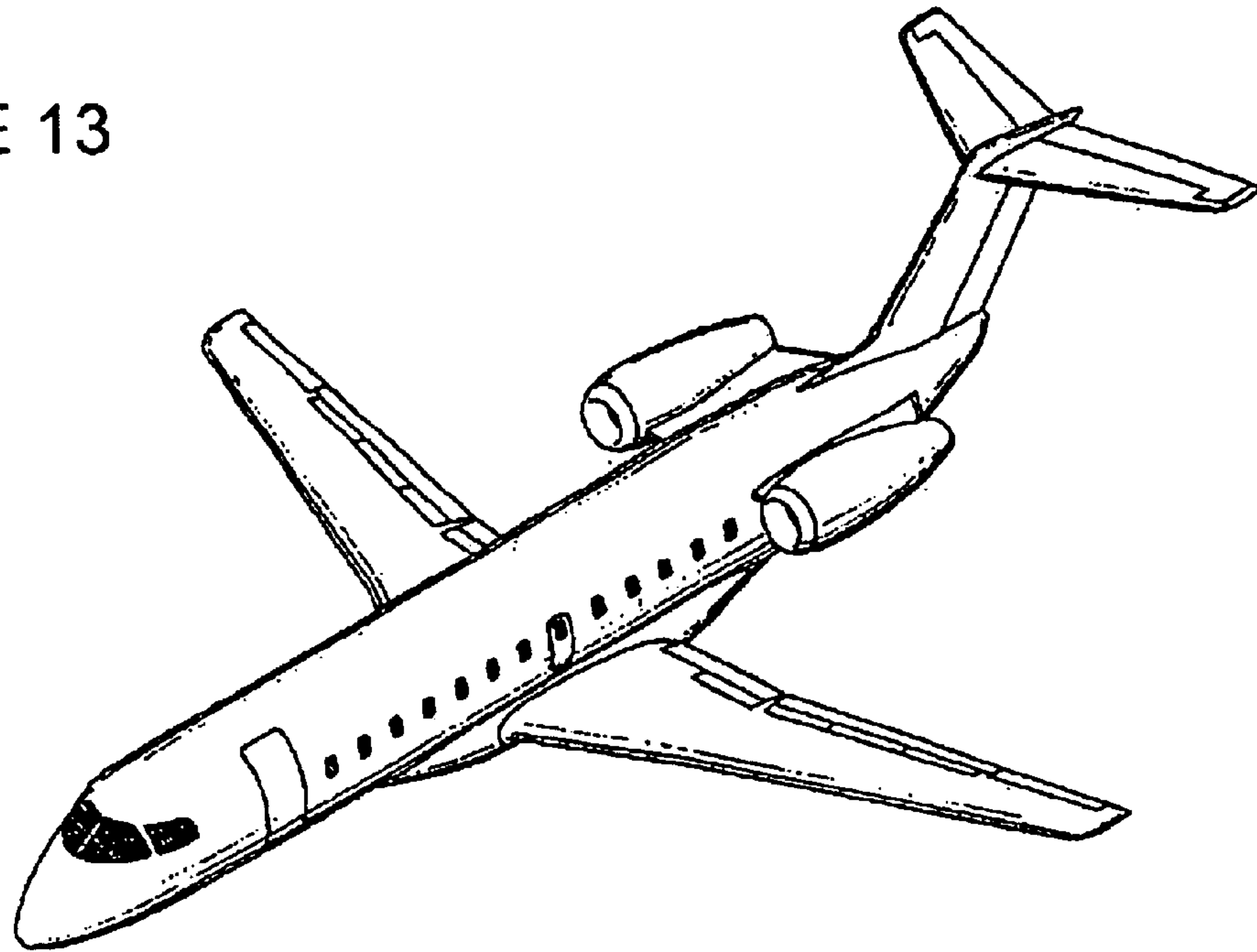
