DESCRIPTION

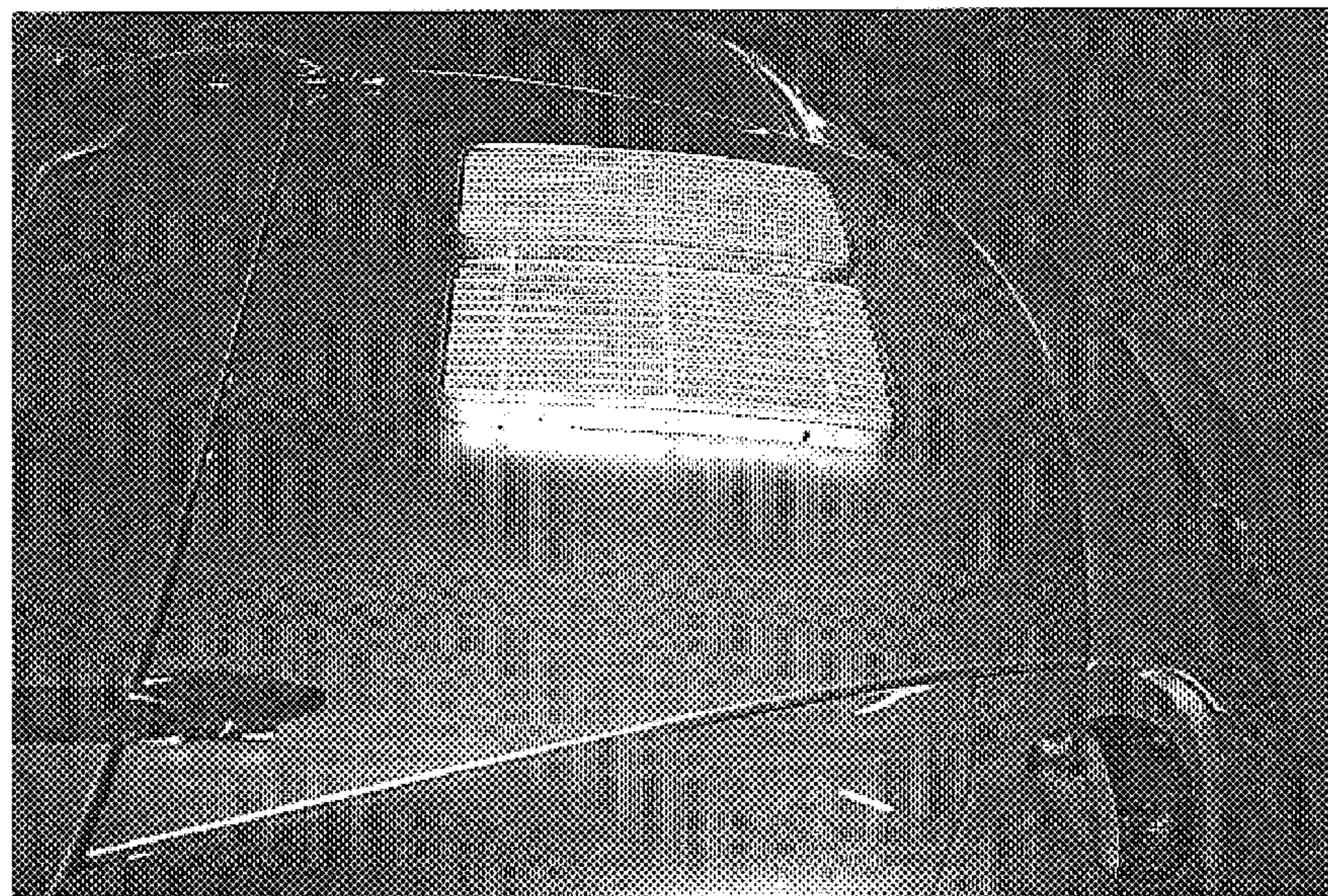
FIG. 1 is a perspective view of combined vehicle trunk straps and two piece luggage rack of a vehicle rear end configuration showing my new design.

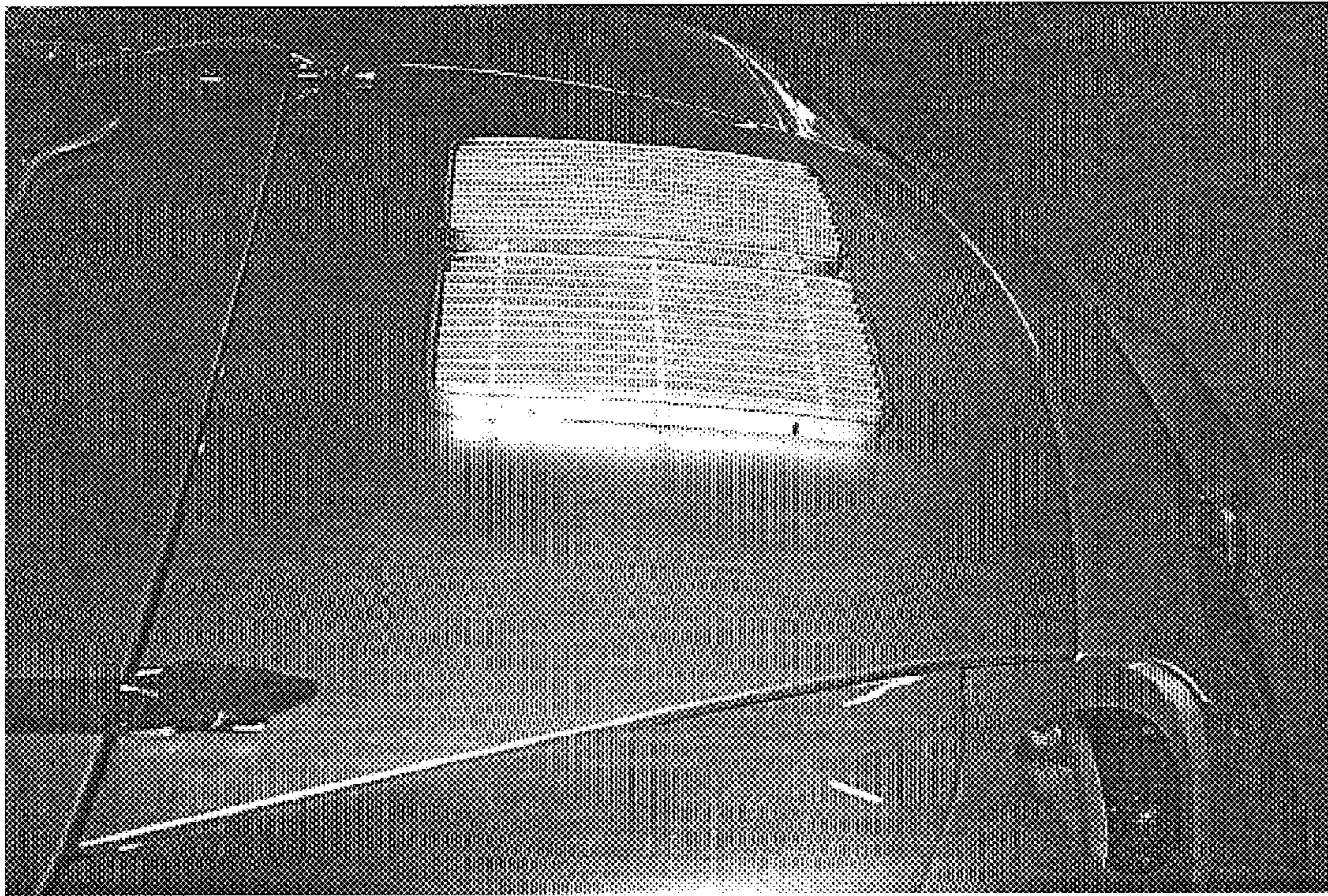

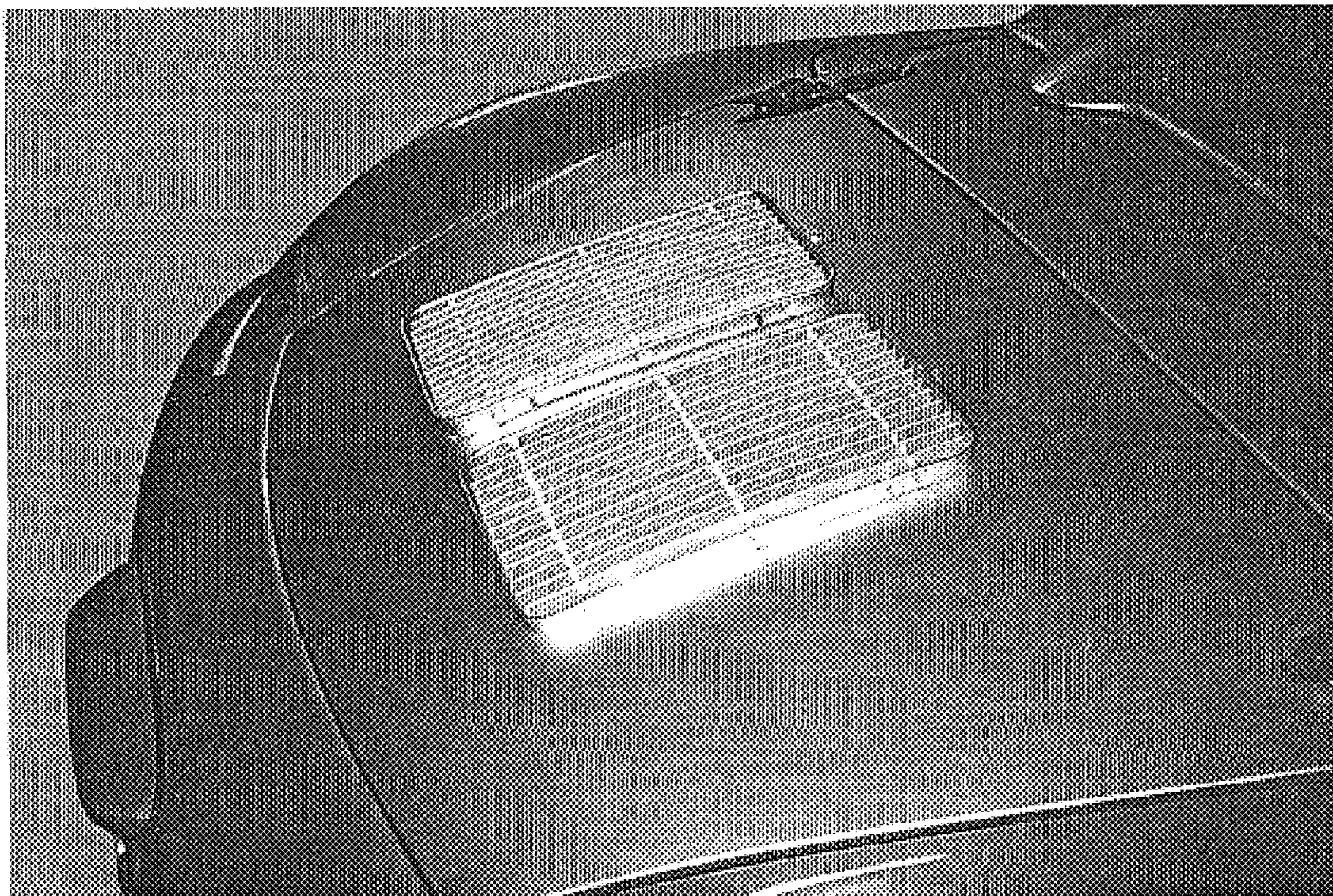

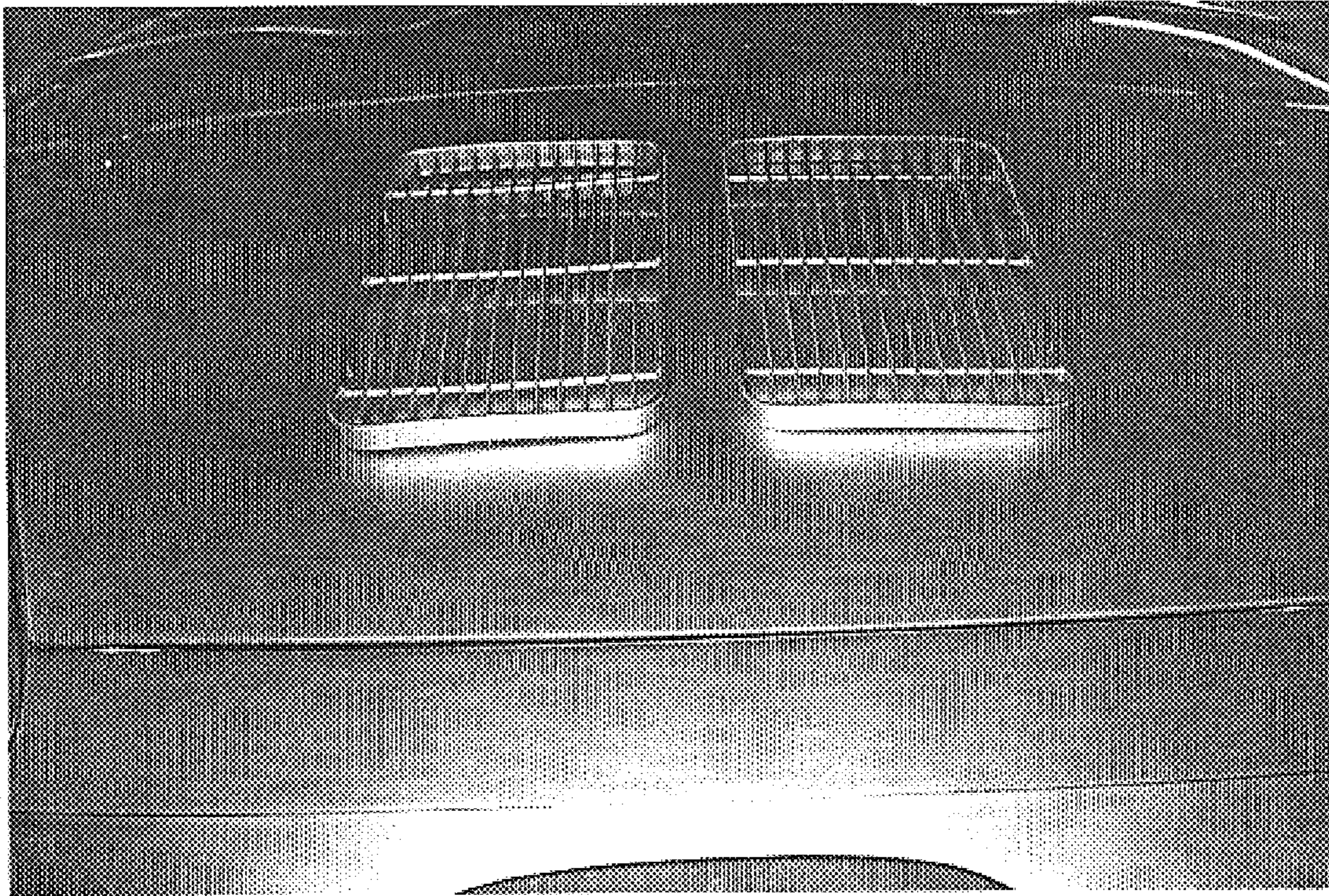

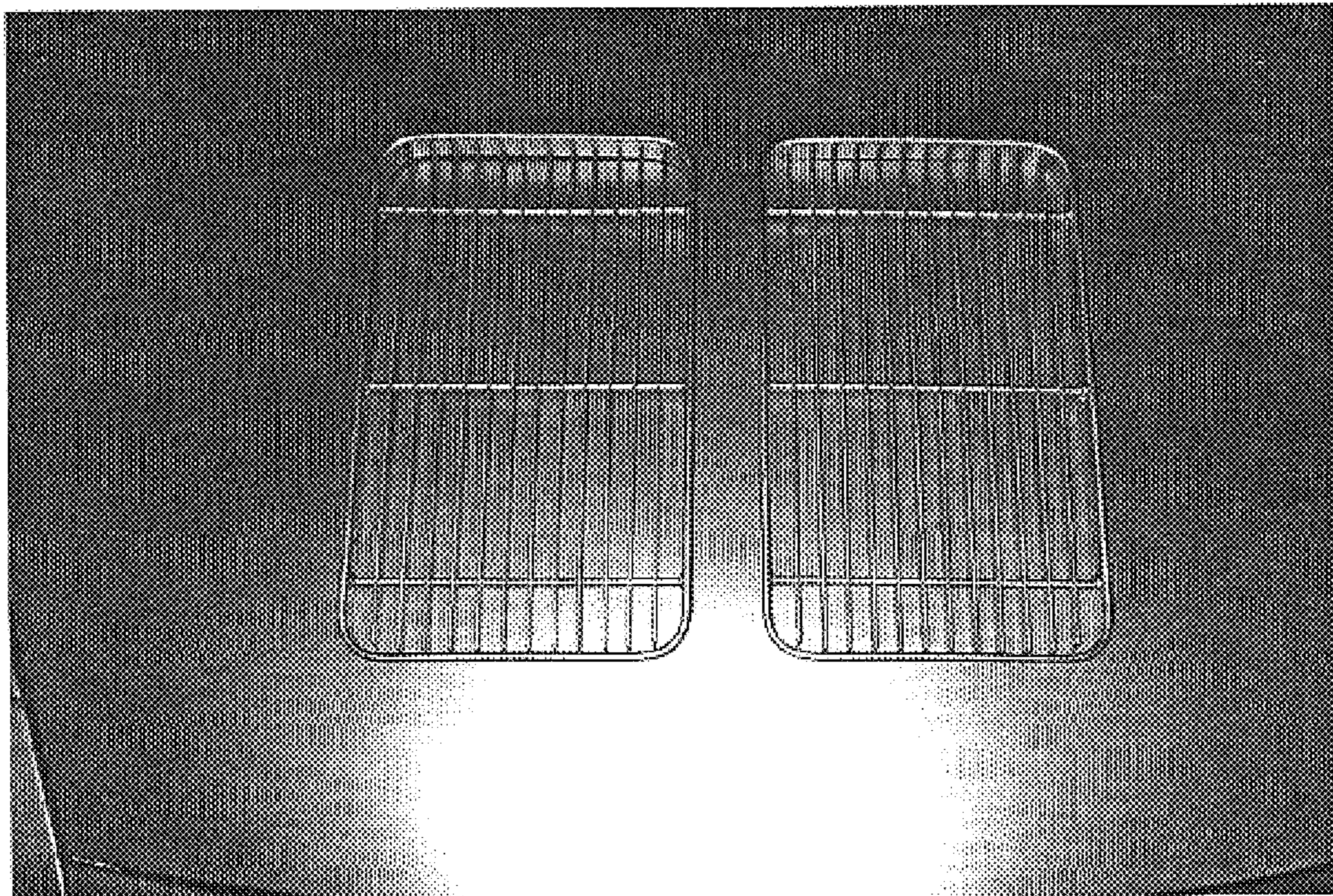
