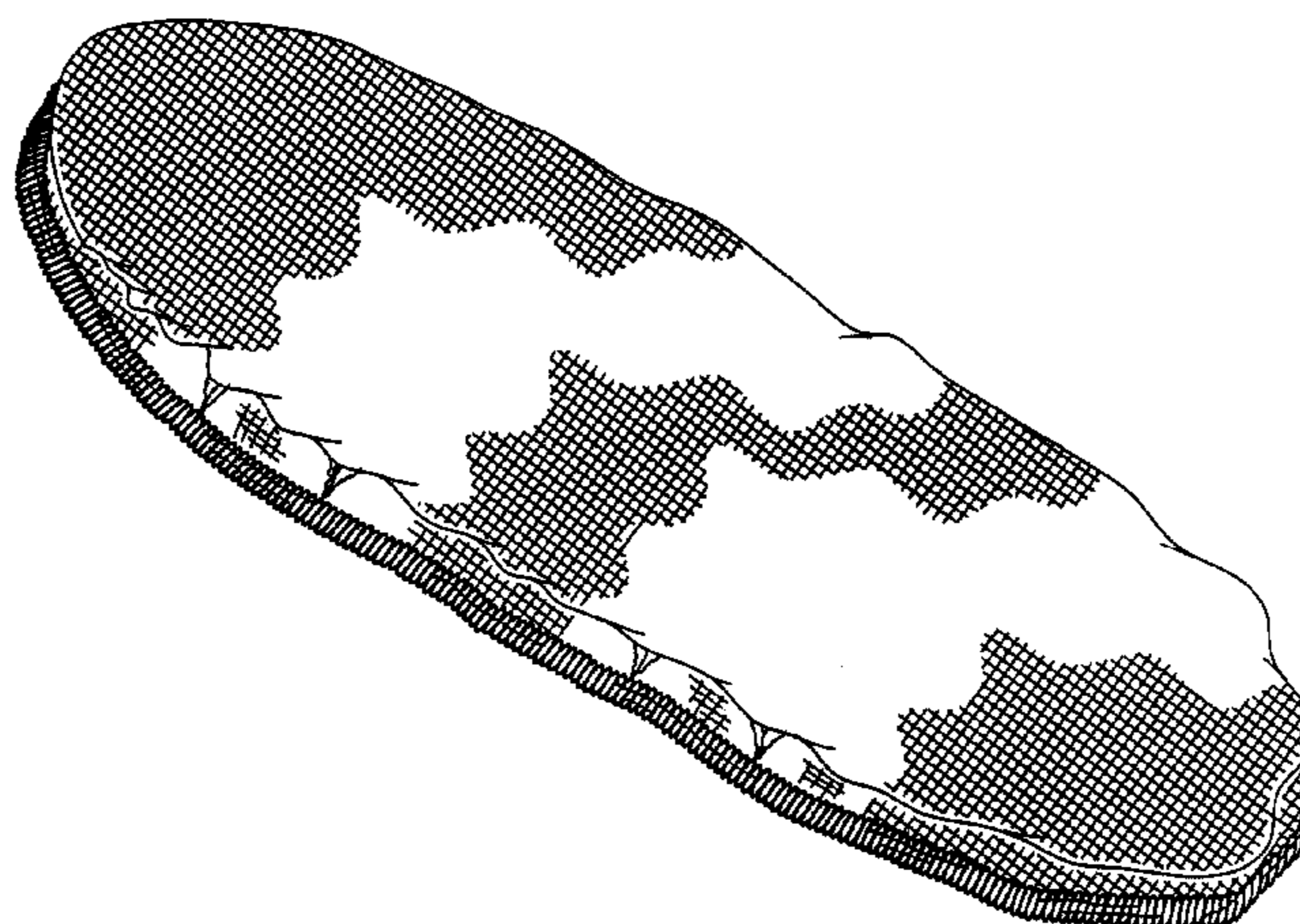

(57) **CLAIM**

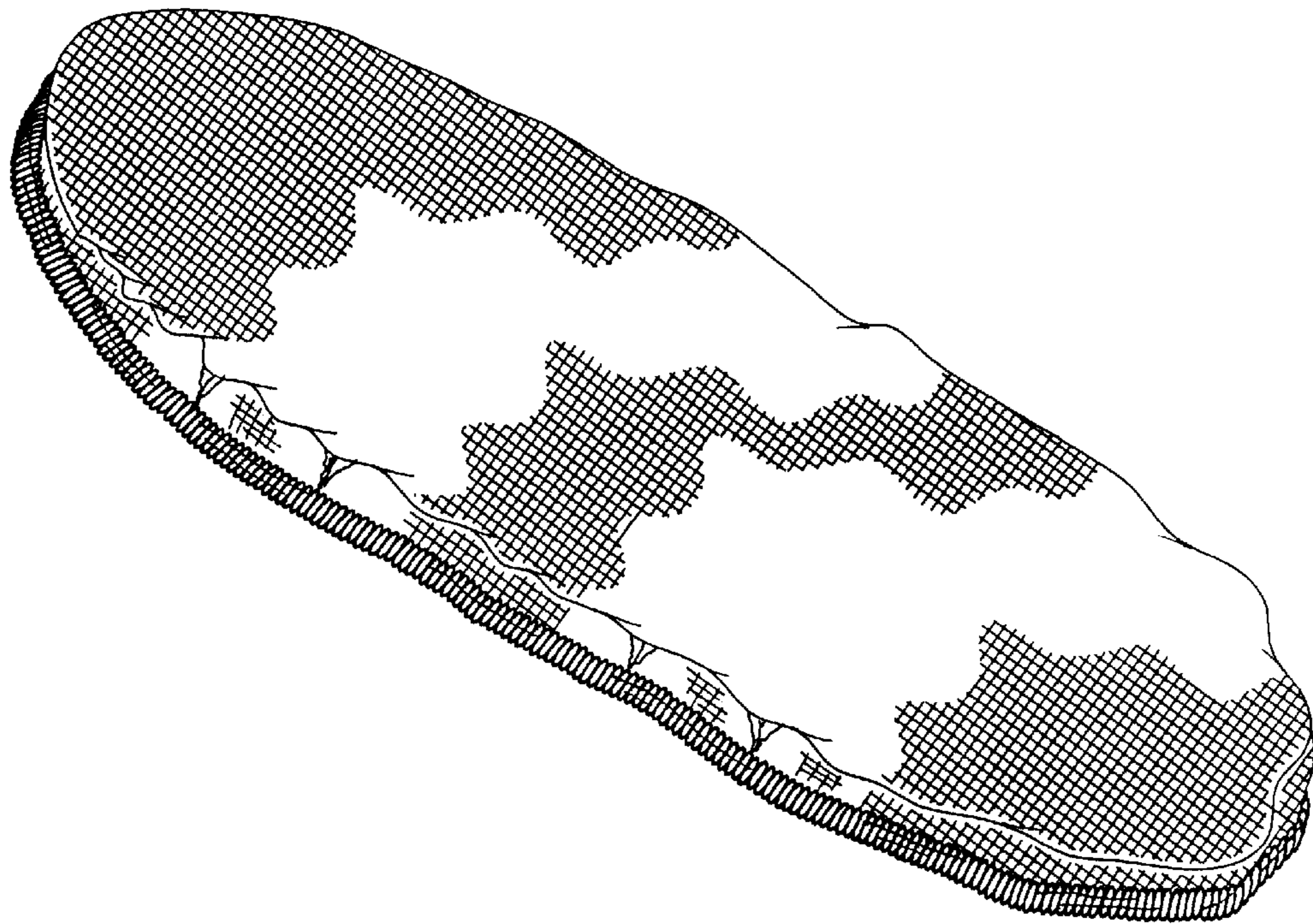
The ornamental design for a disposable sanitary phone cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective top, side and end view of a disposable sanitary phone cover showing my new design;  
FIG. 2 is a side view thereof, the unshown opposite side being of identical appearance;  
FIG. 3 is a bottom view thereof; and,  
FIG. 4 is a side view showing the disposable sanitary phone cover of FIGS. 1-3 in a position for use on a phone. The broken line showing of the phone is for illustrative purposes only and forms no part of the claimed design.

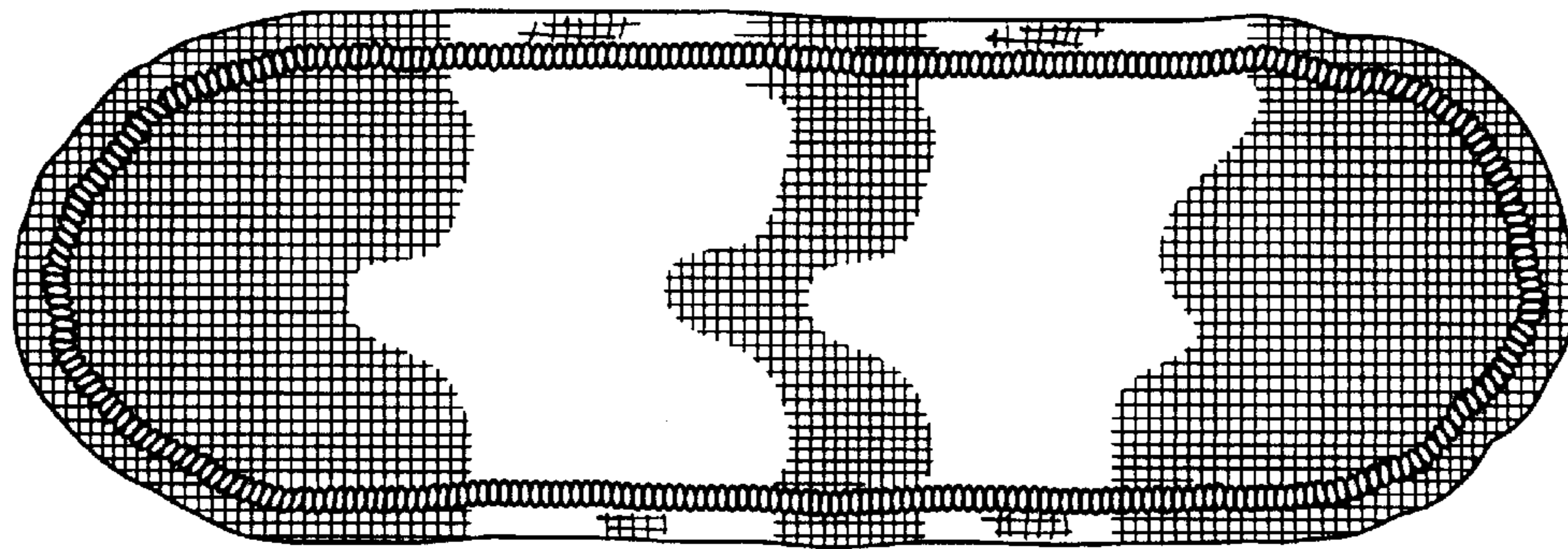

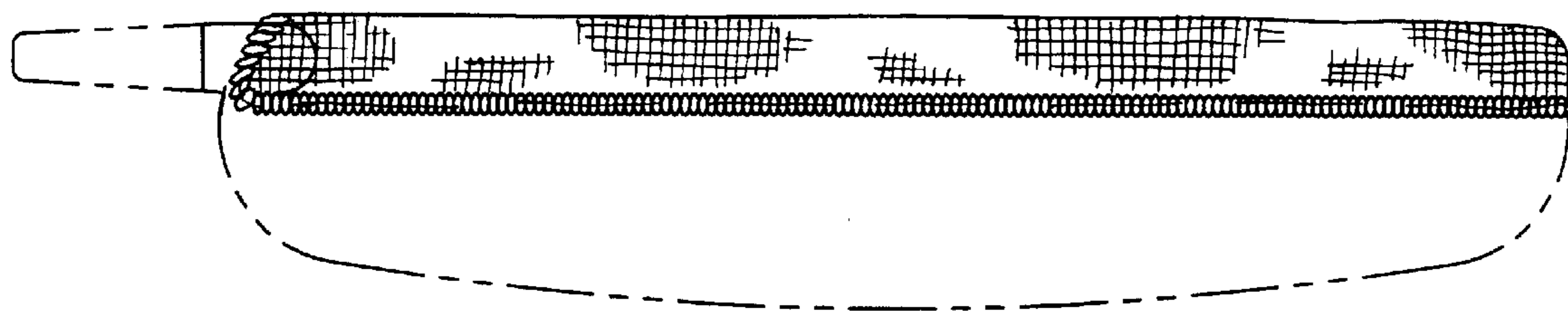
