(57) **CLAIM**

The ornamental design for a personal digital assistant with a keyboard, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a personal digital assistant with a keyboard showing a top lid in a closed position.

FIG. 2 is a front side view thereof showing a top lid in a closed position.

FIG. 3 is a left side view thereof.

FIG. 4 is a right side view thereof.

FIG. 5 is a top view thereof.

FIG. 6 is a bottom view thereof.

FIG. 7 is a rear side view thereof; and,

FIG. 8 is a perspective view of a personal digital assistant with a keyboard showing a top lid in an open position.

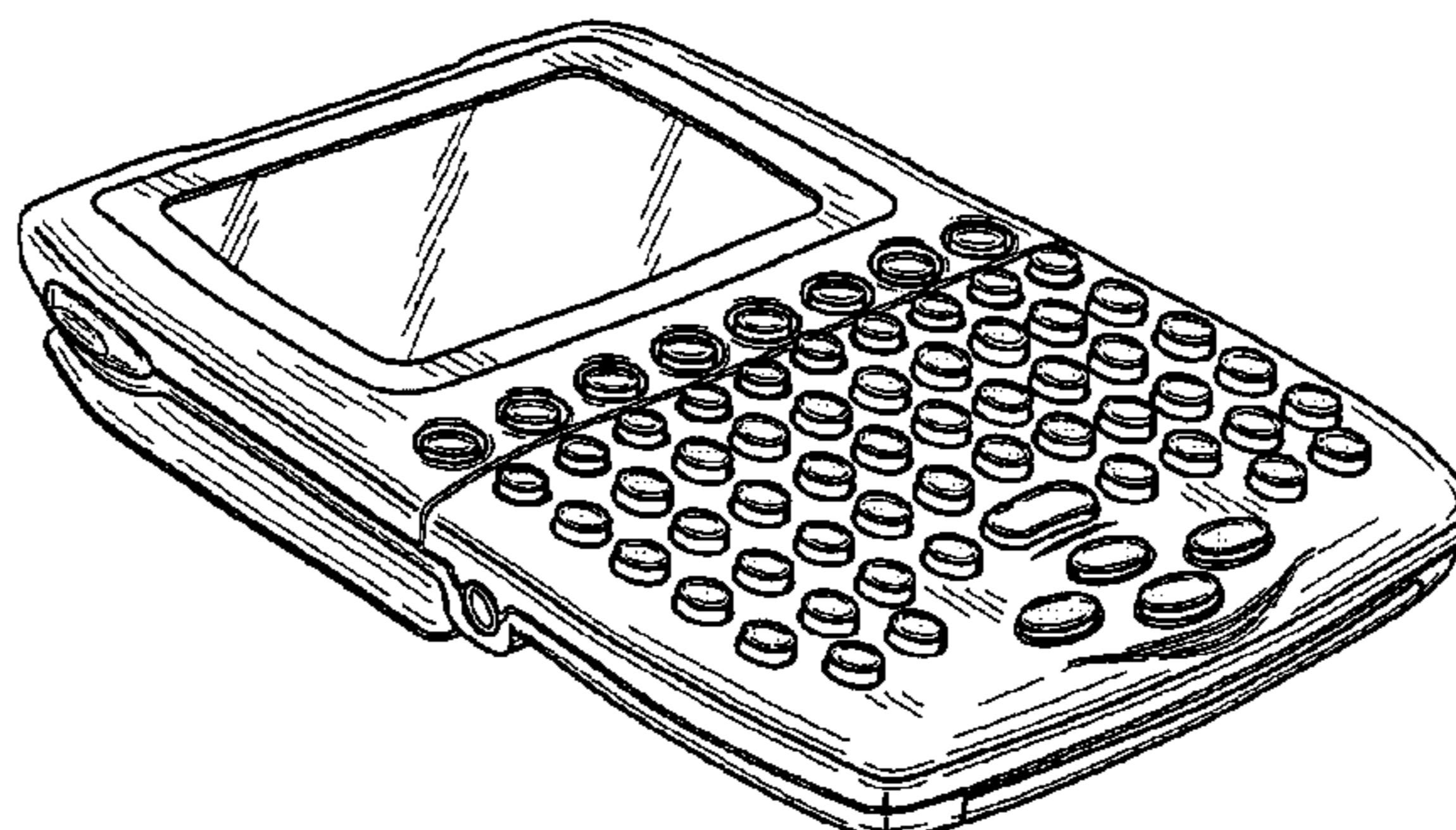

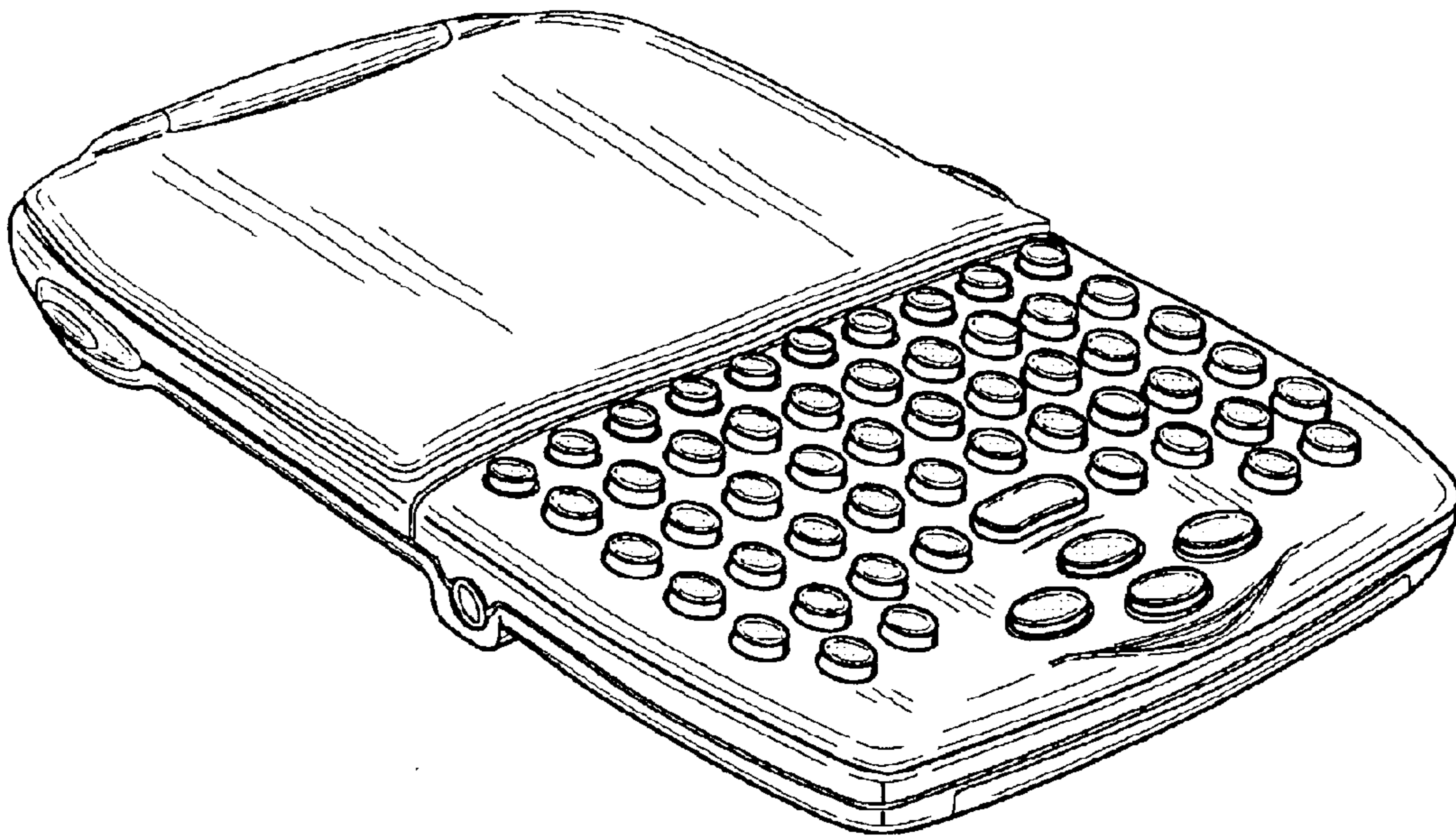

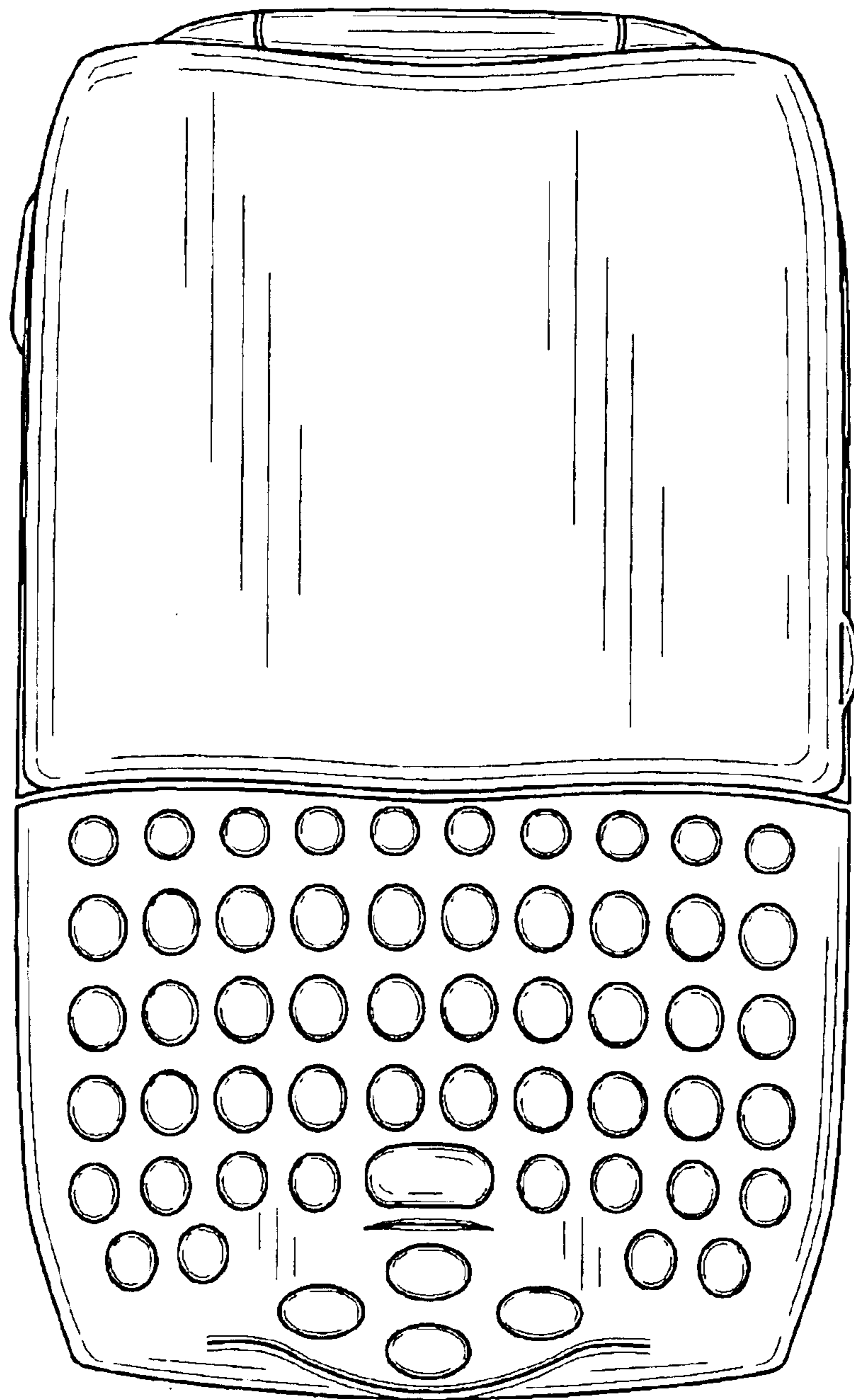

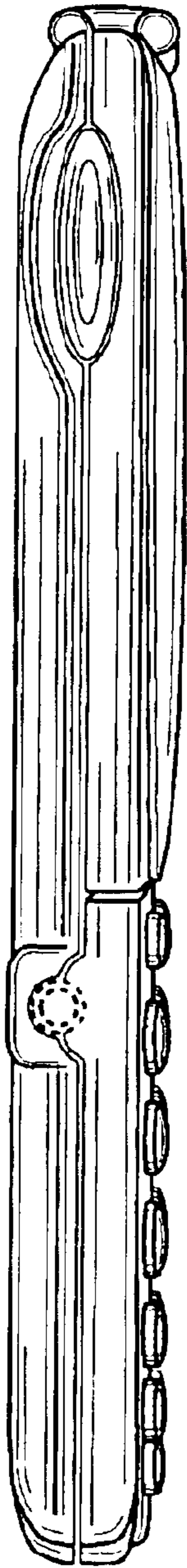

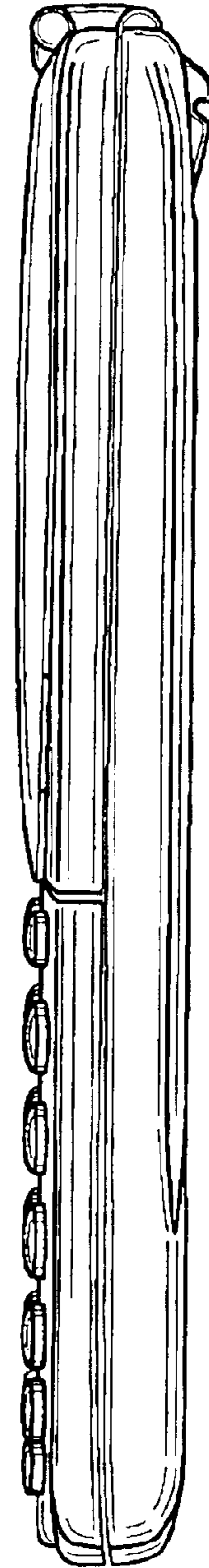

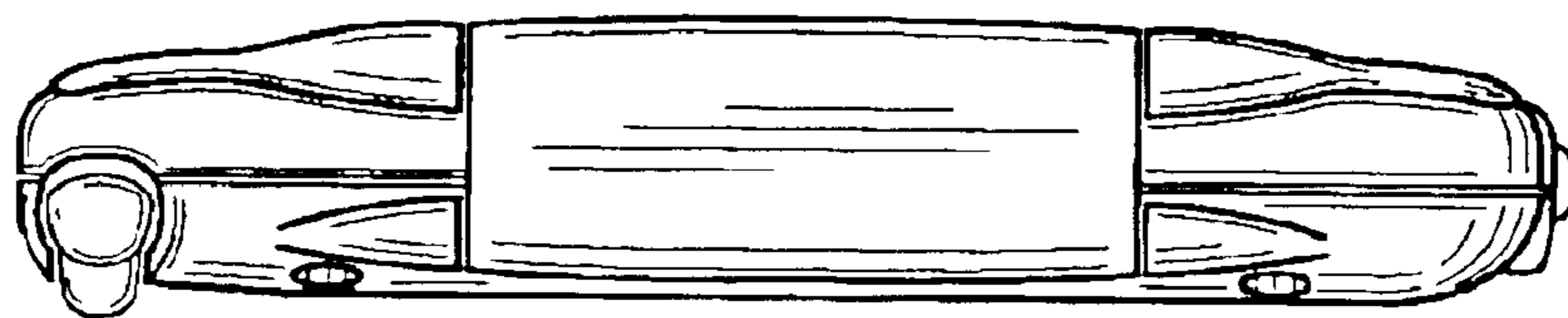

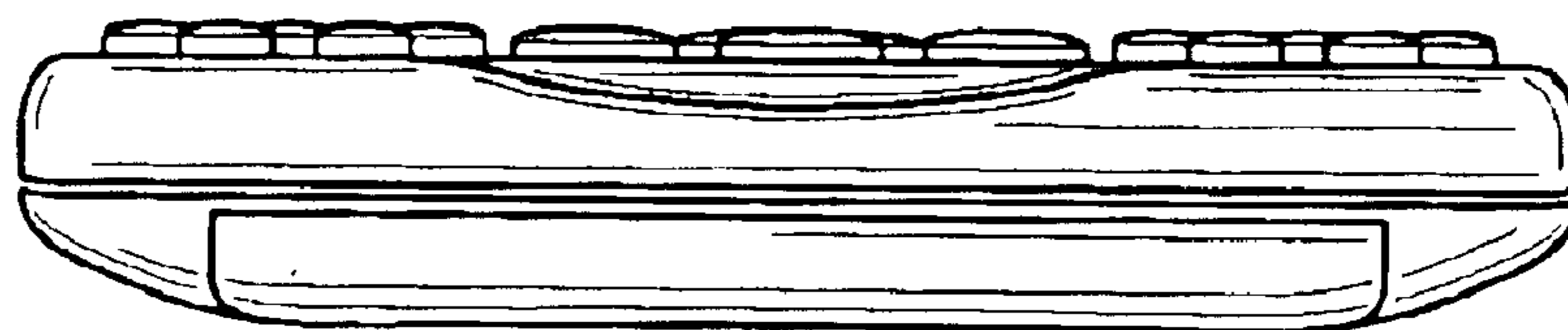

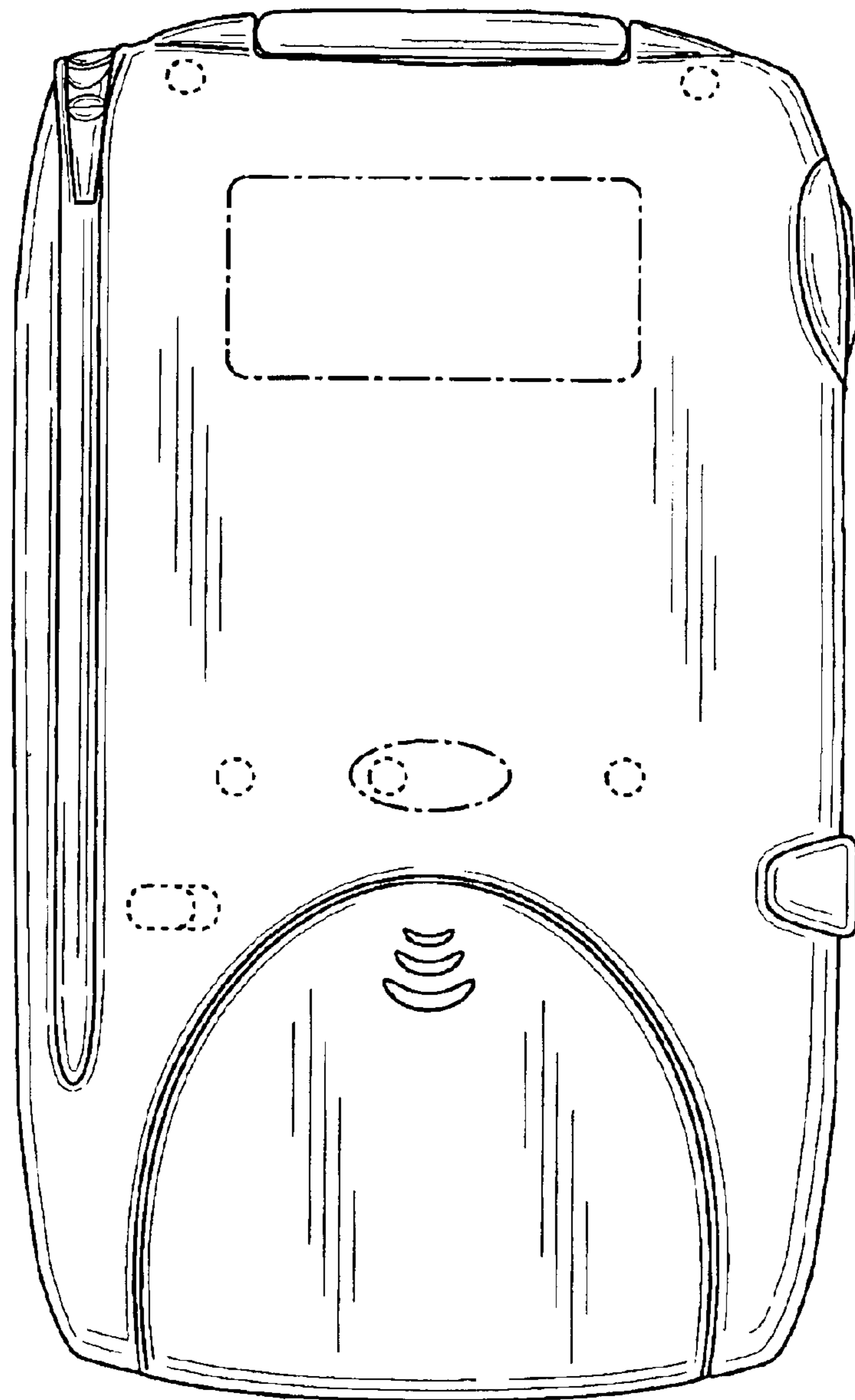
