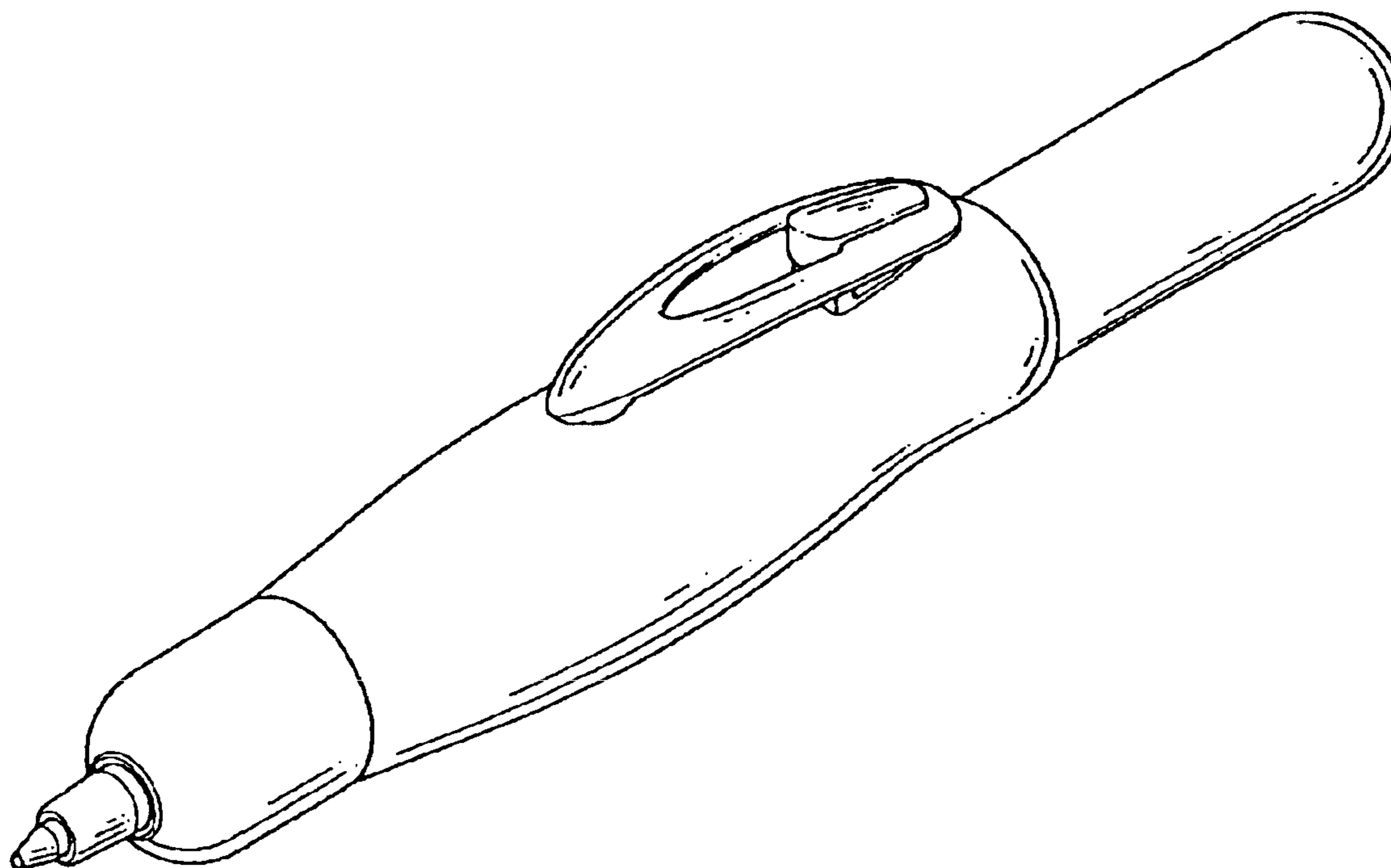
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of a pen, showing my new design;  
 FIG. 2 is a right side elevational view thereof;  
 FIG. 3 is a left side elevational view thereof;  
 FIG. 4 is a bottom plan view thereof;  
 FIG. 5 is a top plan view thereof;  
 FIG. 6 is a front elevational view thereof;  
 FIG. 7 is a rear elevational view thereof; and,  
 FIG. 8 is a right side elevational view thereof, with the writing tip in a retracted position.

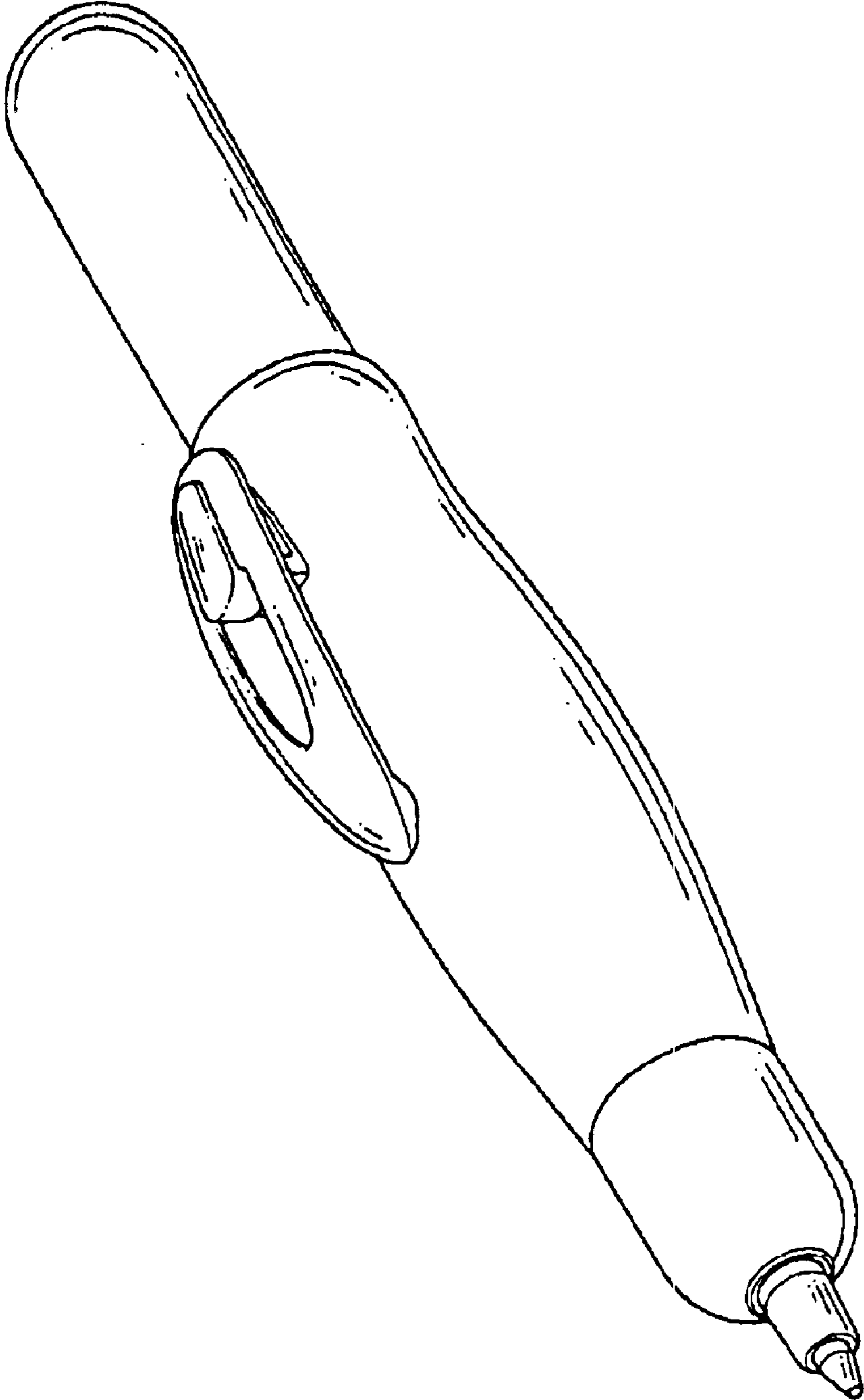

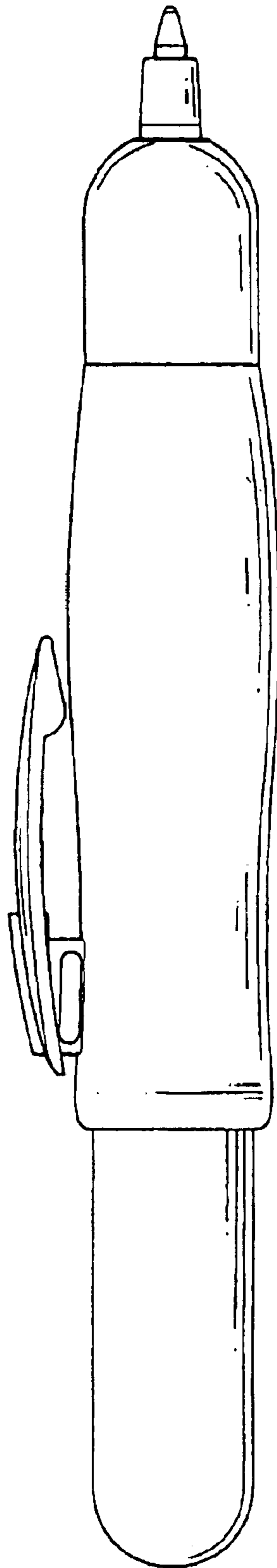

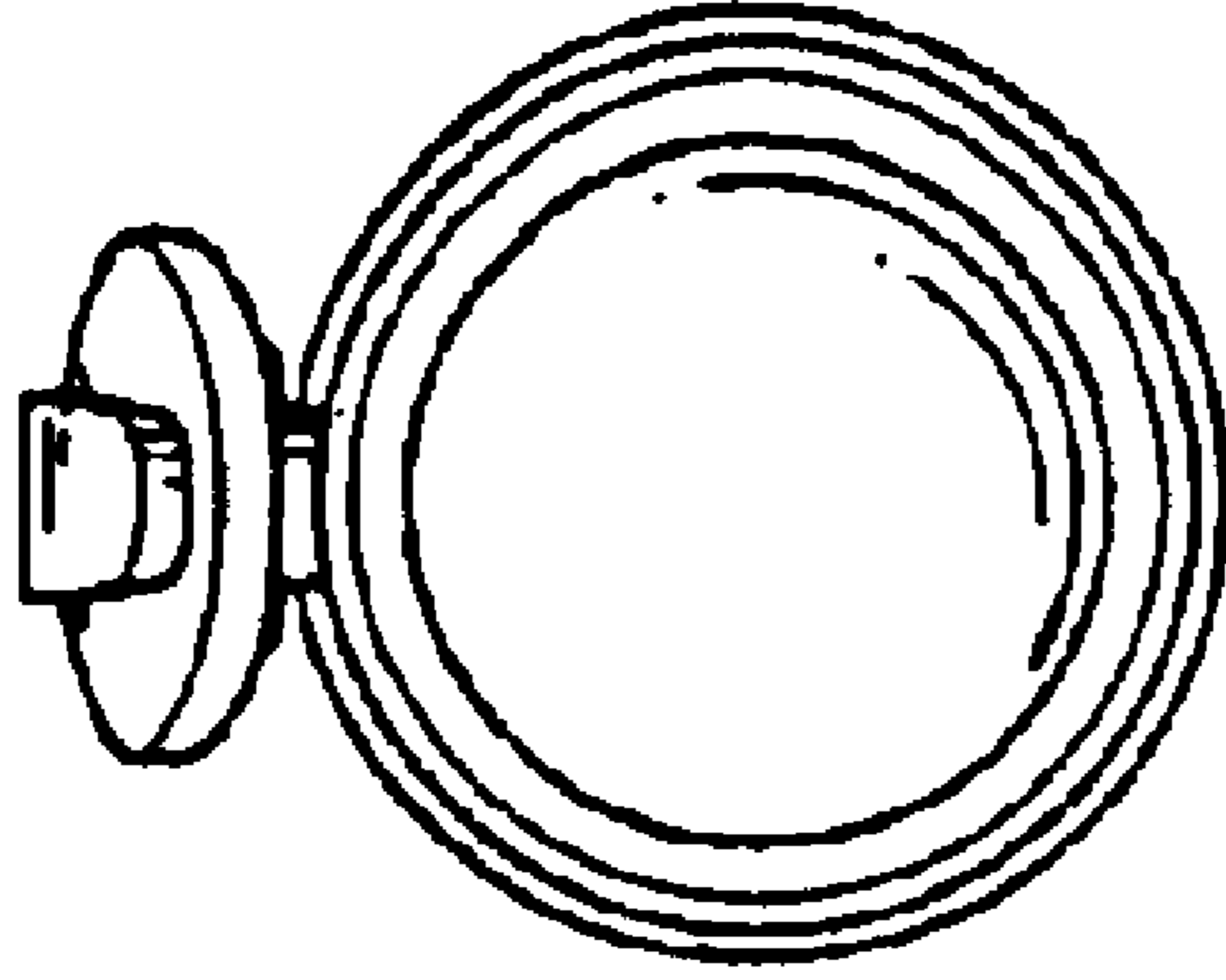

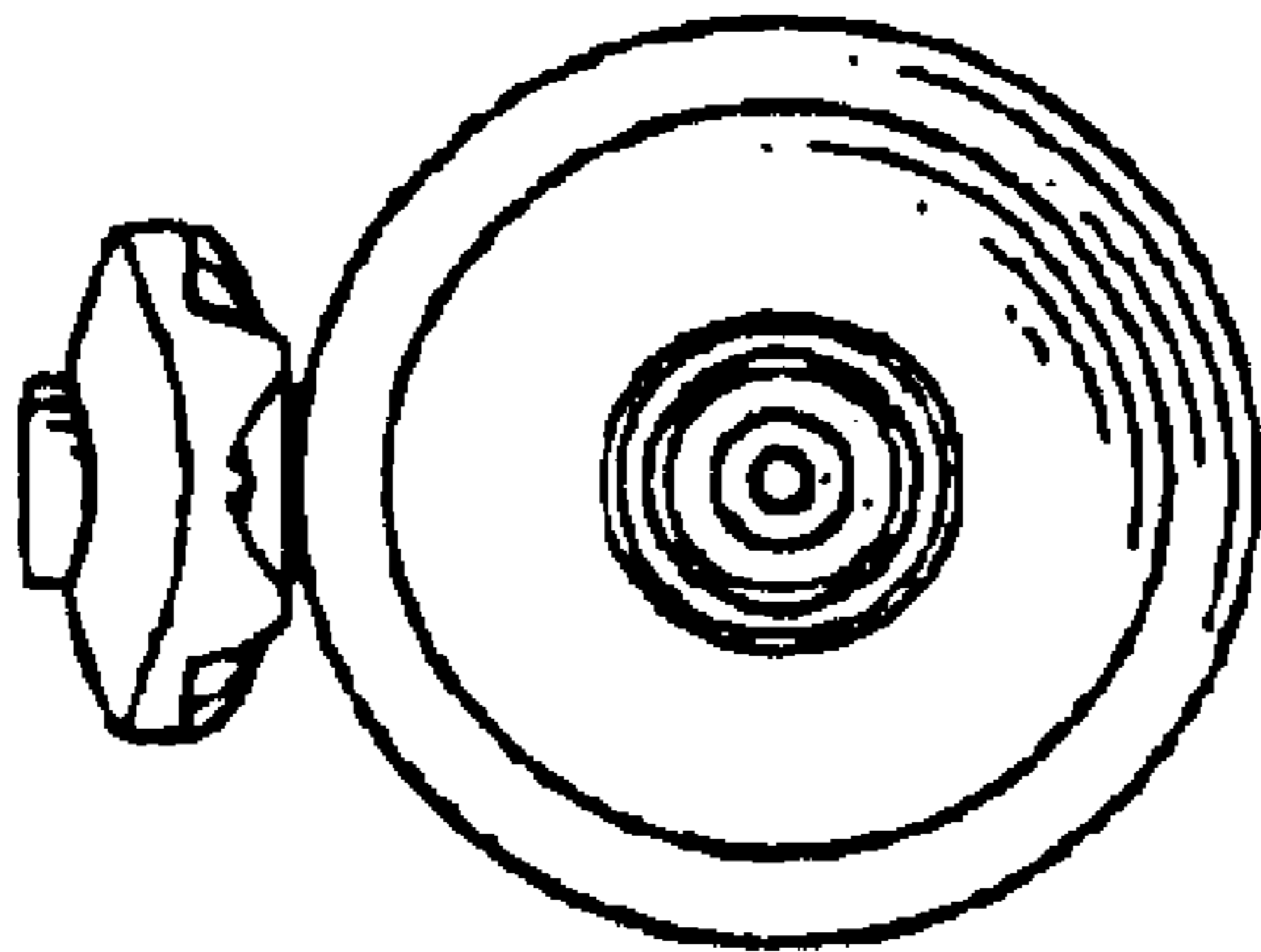

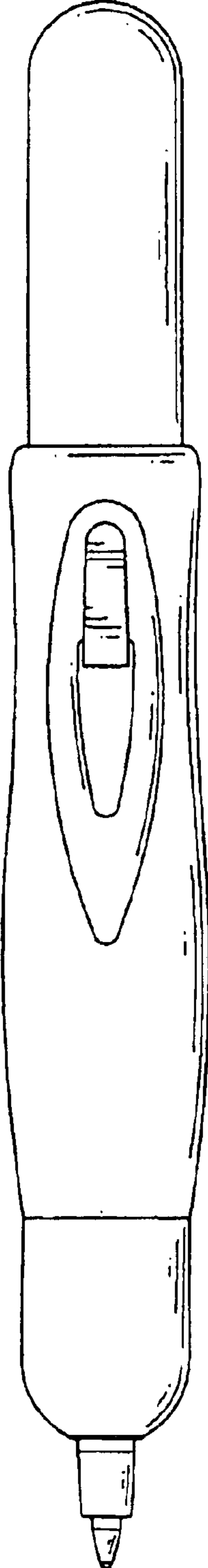

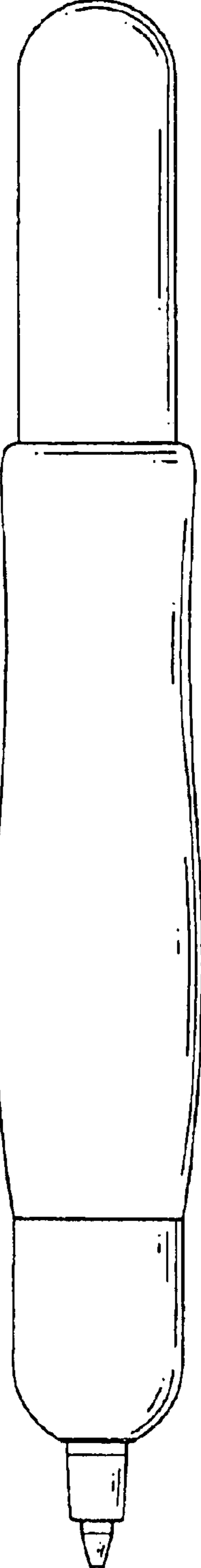

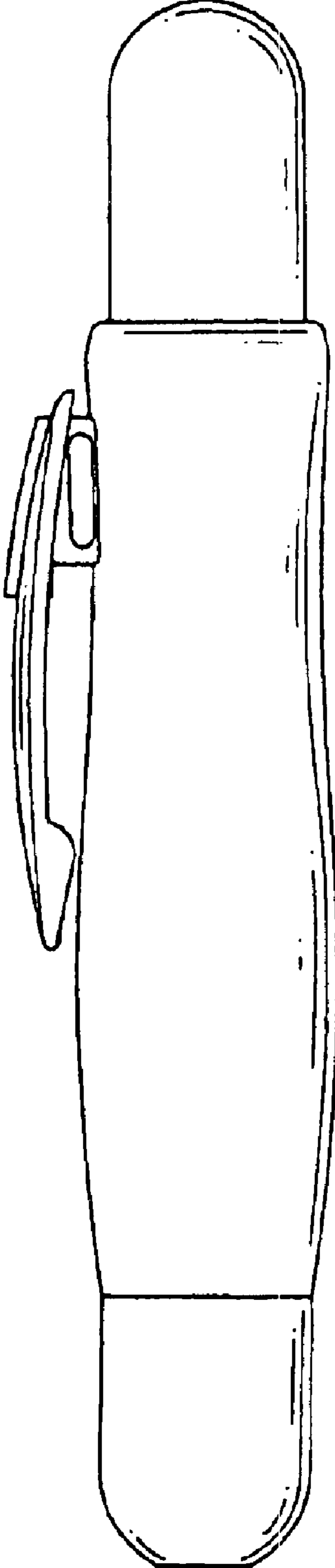
