(57) **CLAIM**

The ornamental design for a gift product display flower, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a gift product display flower, the broken lines showing a gift product tray are for illustrative purposes only and form no portion of the claimed design;

FIG. 2 is a rear elevational view of a gift product display flower, the broken lines showing a gift product tray are for illustrative purposes only and form no portion of the claimed design;

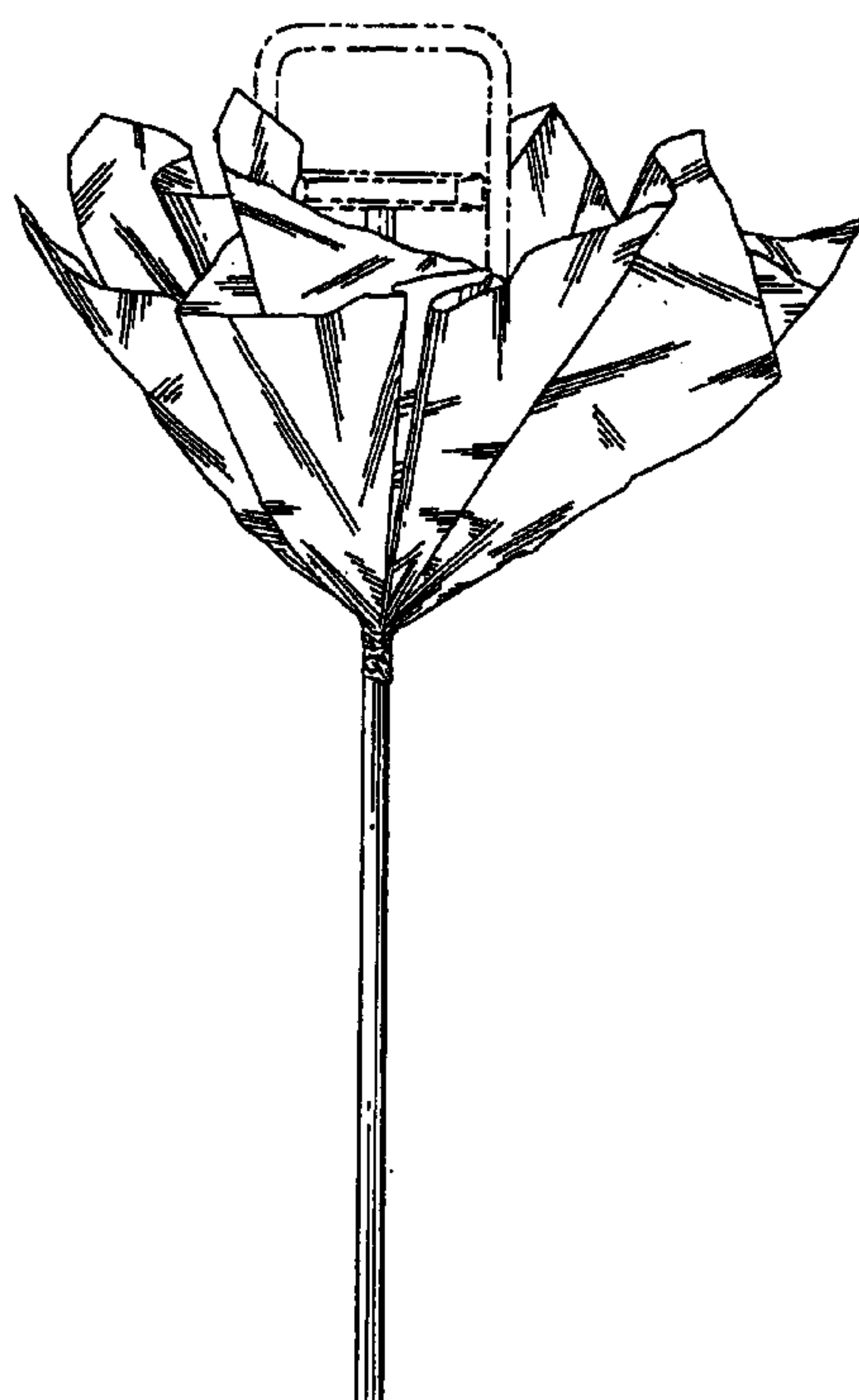
FIG. 3 is a right side elevational view of a gift product display flower, the broken lines showing a gift product tray are for illustrative purposes only and form no portion of the claimed design;

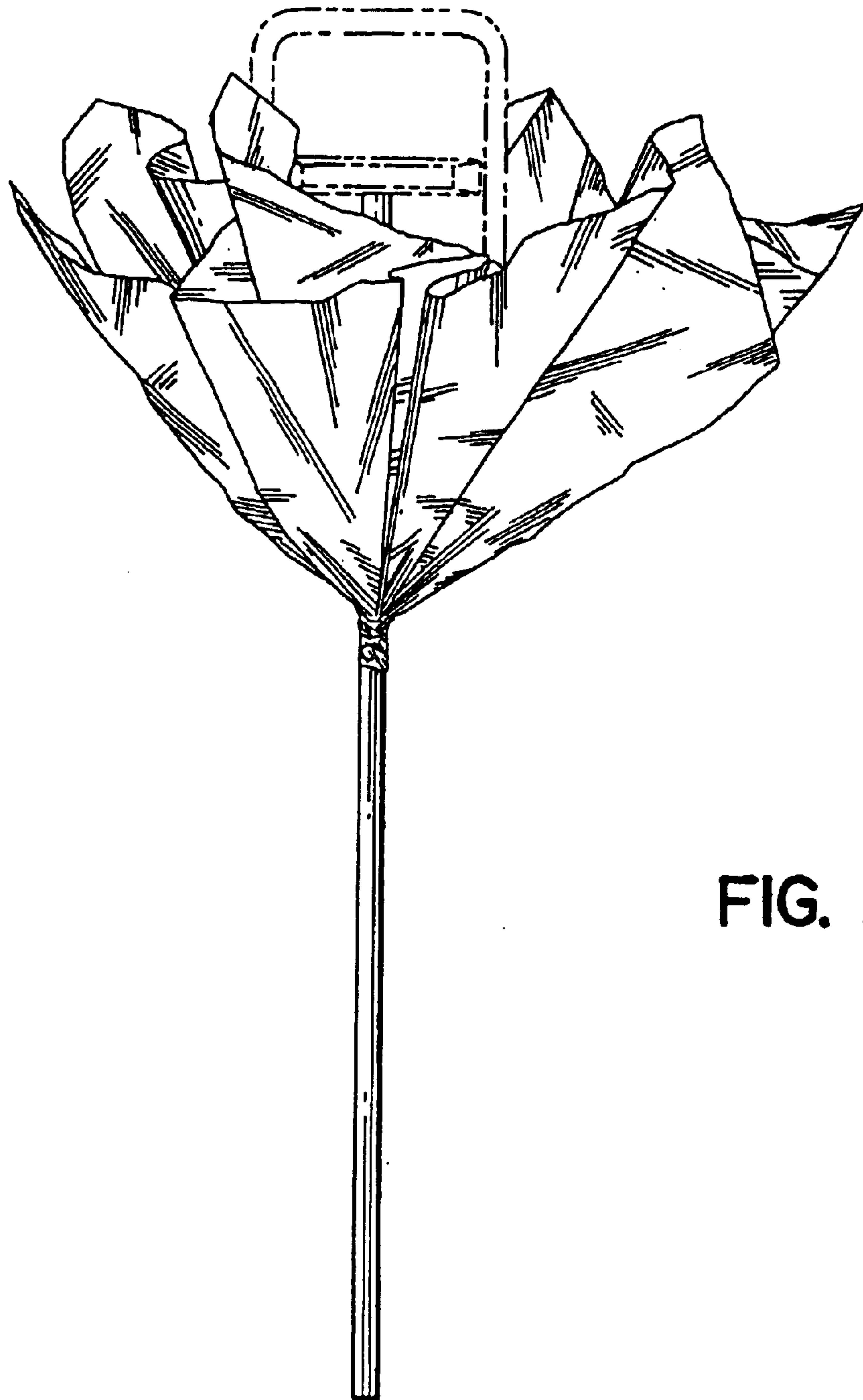

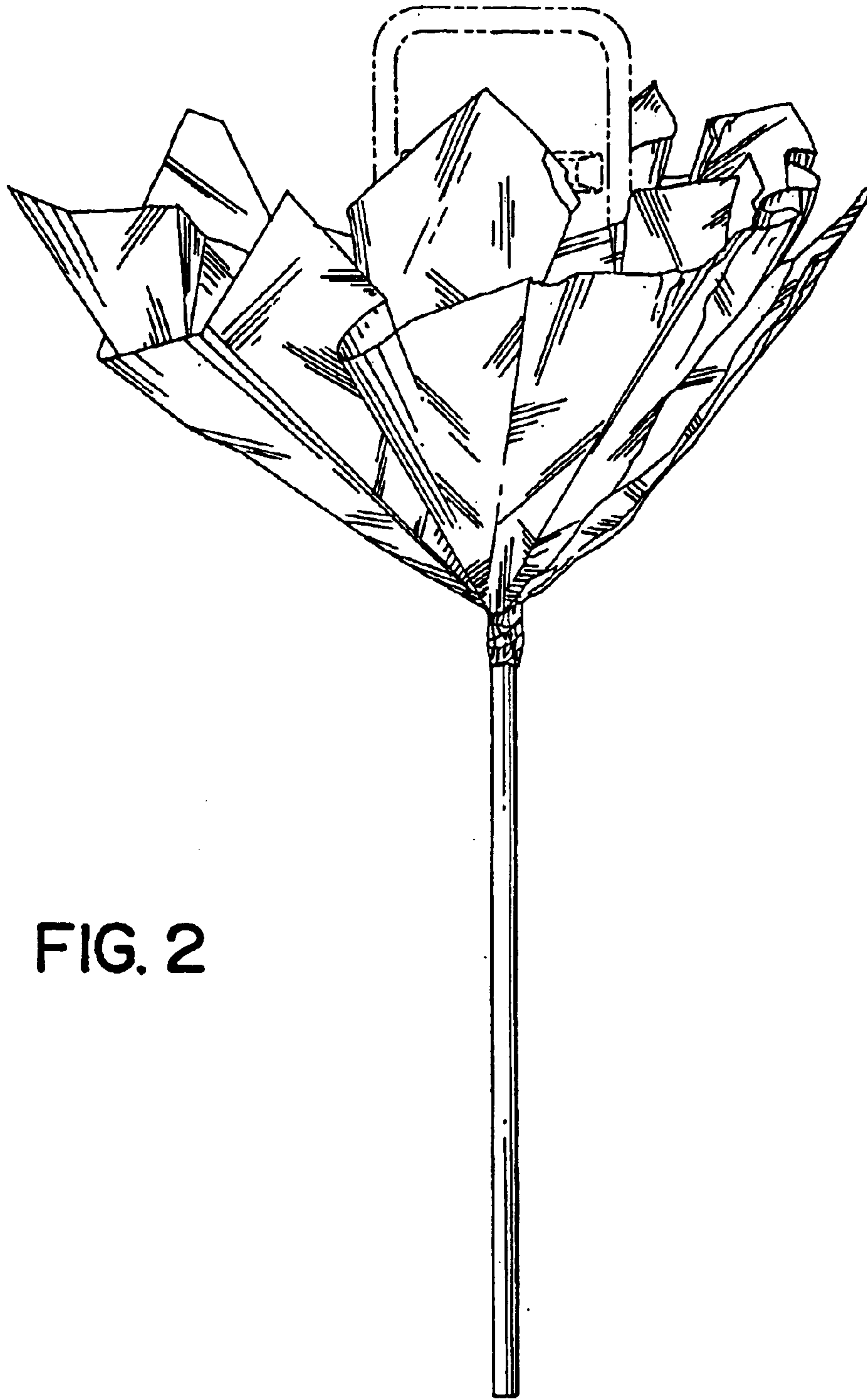

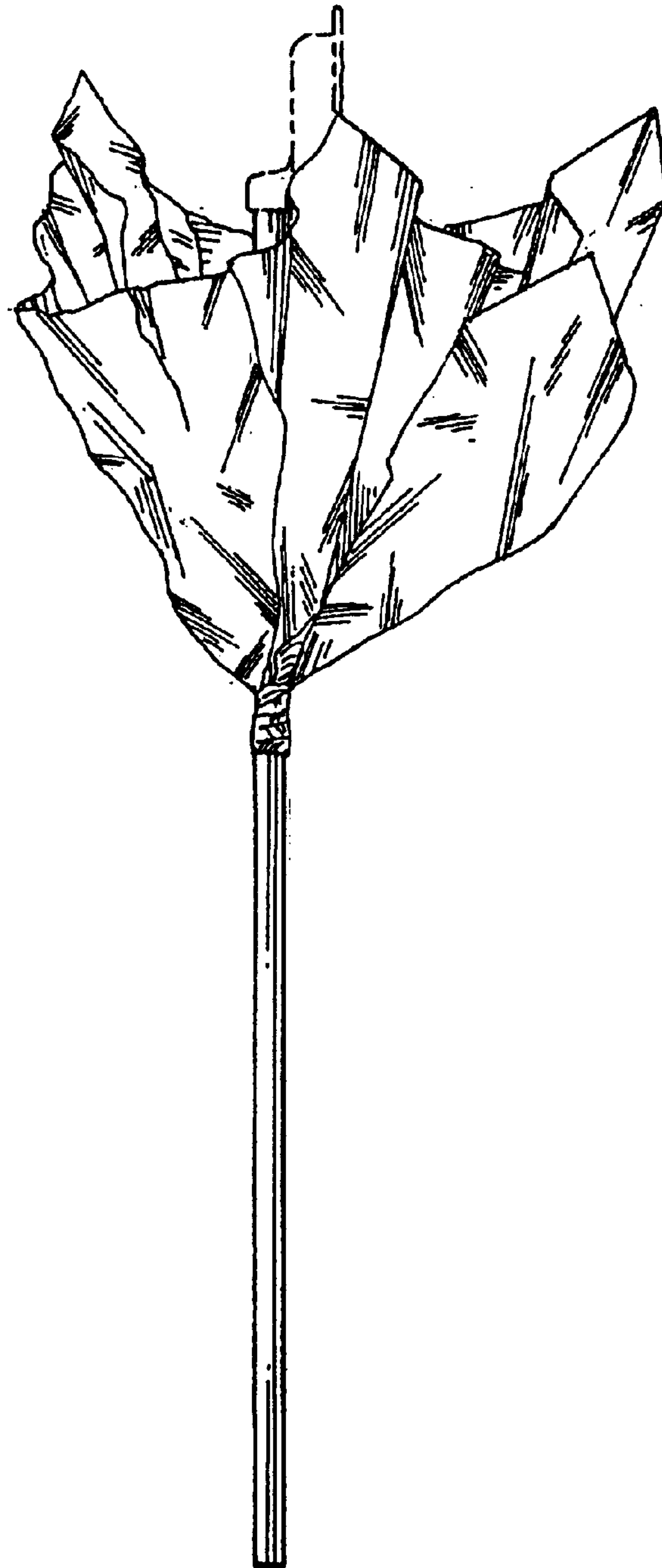
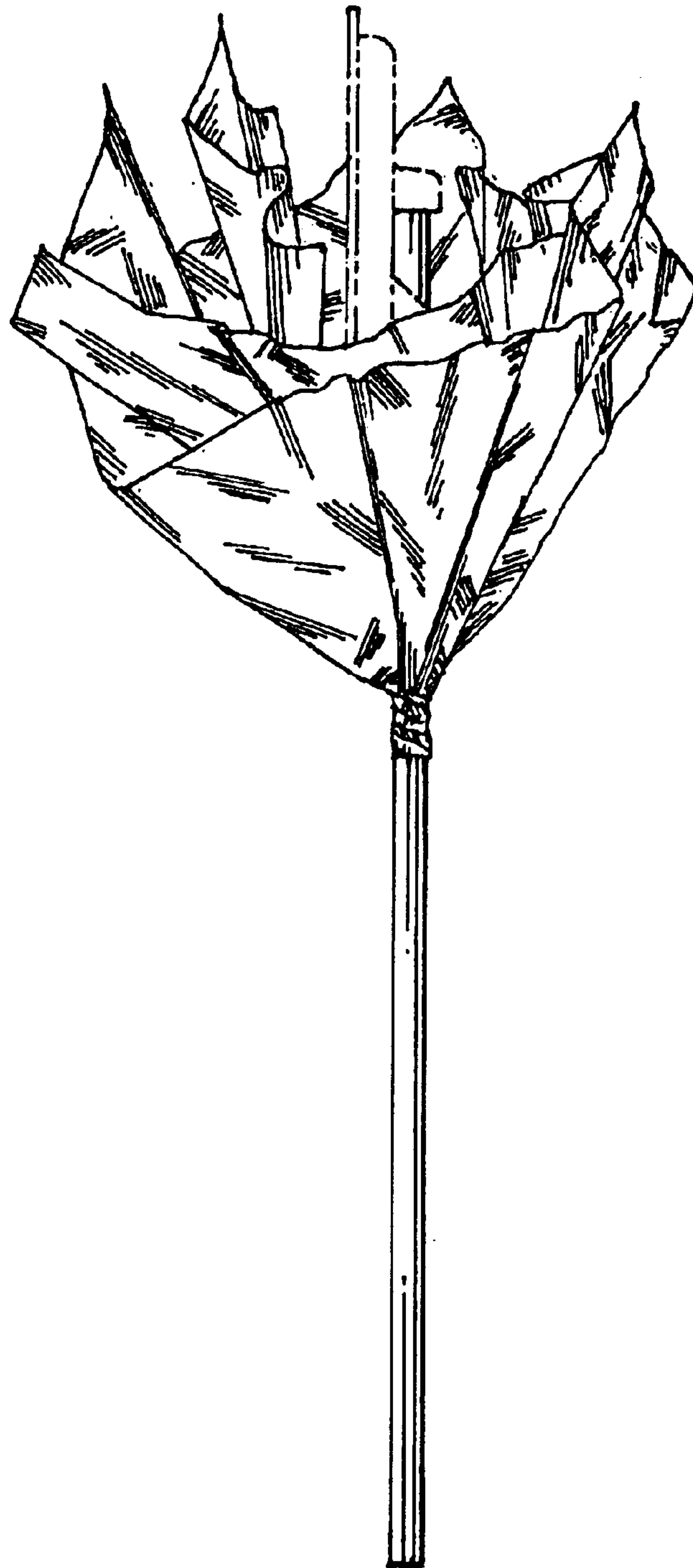

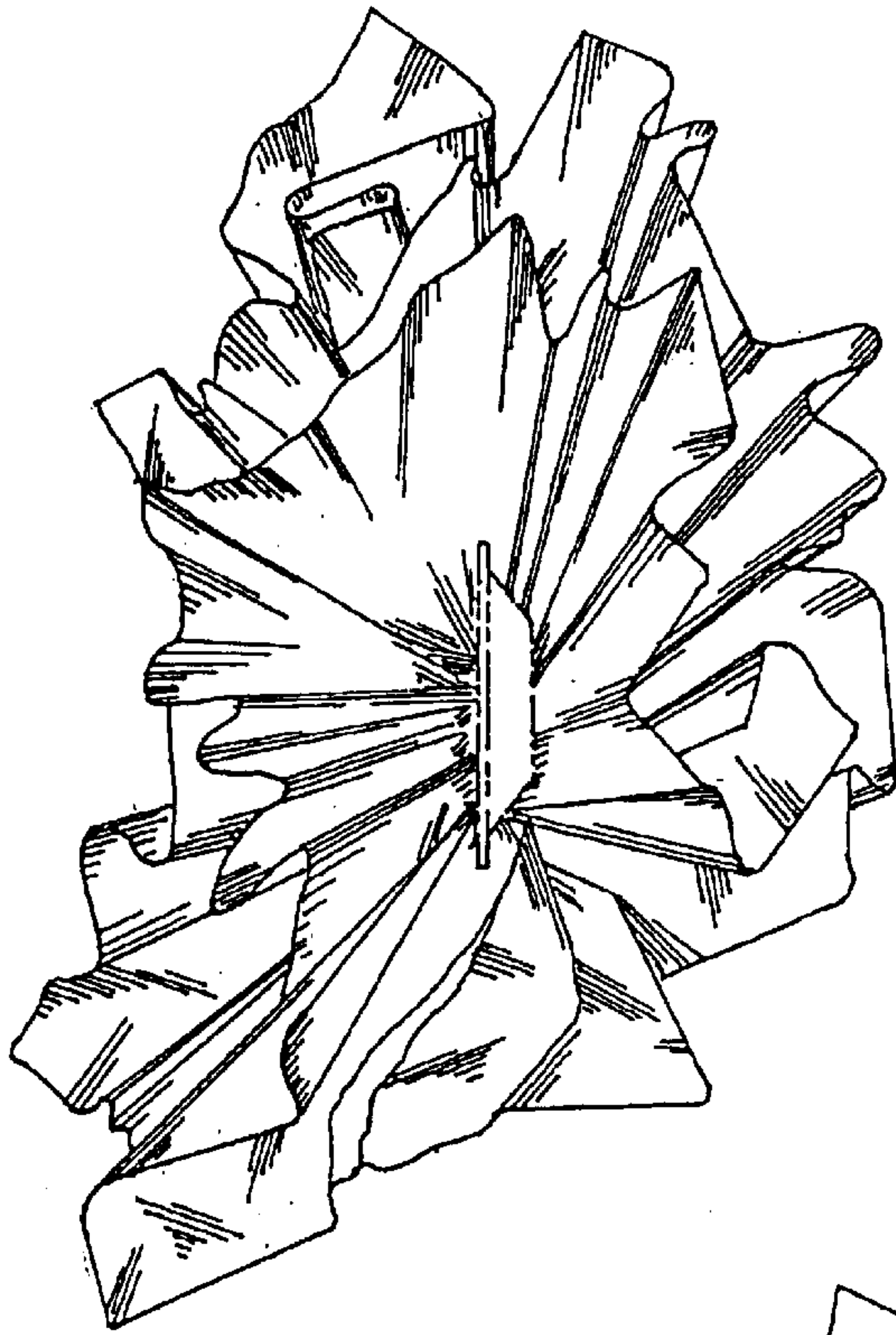

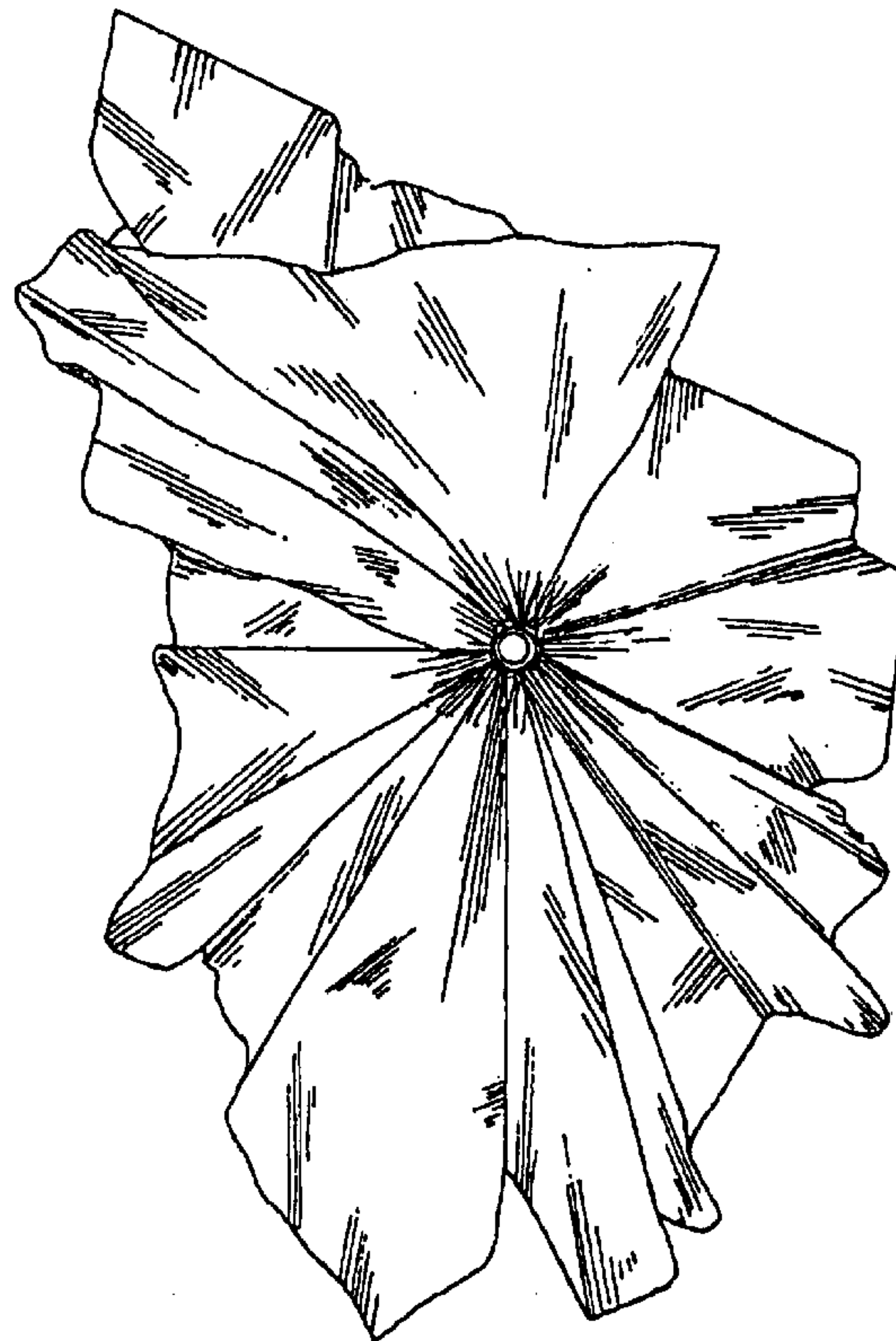
