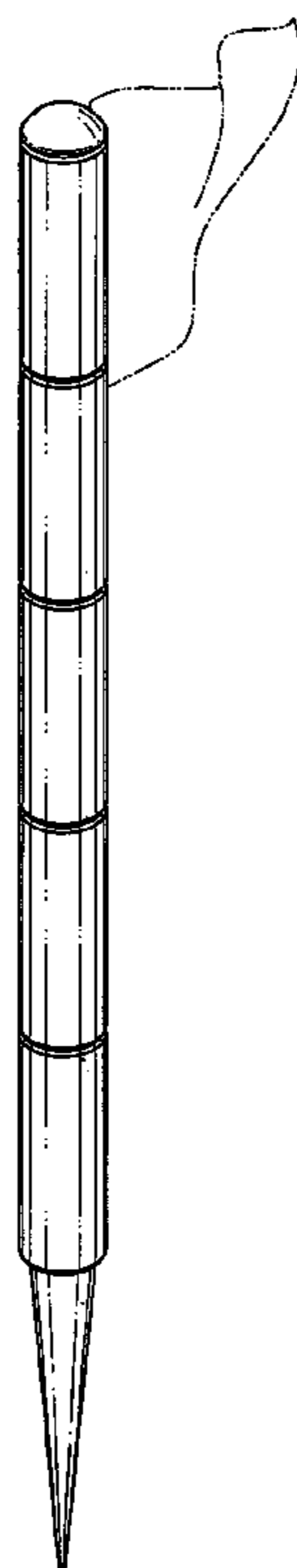

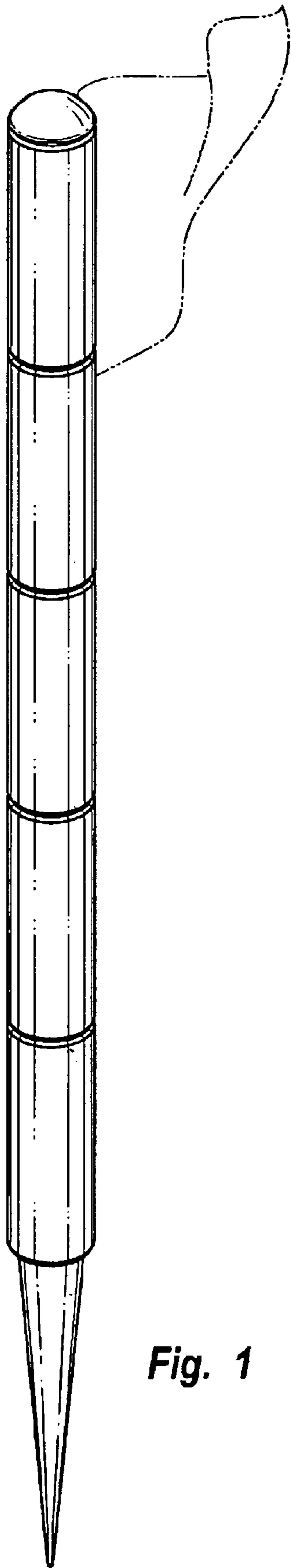
The ornamental design for the croquet stake, as shown and described.

**DESCRIPTION**

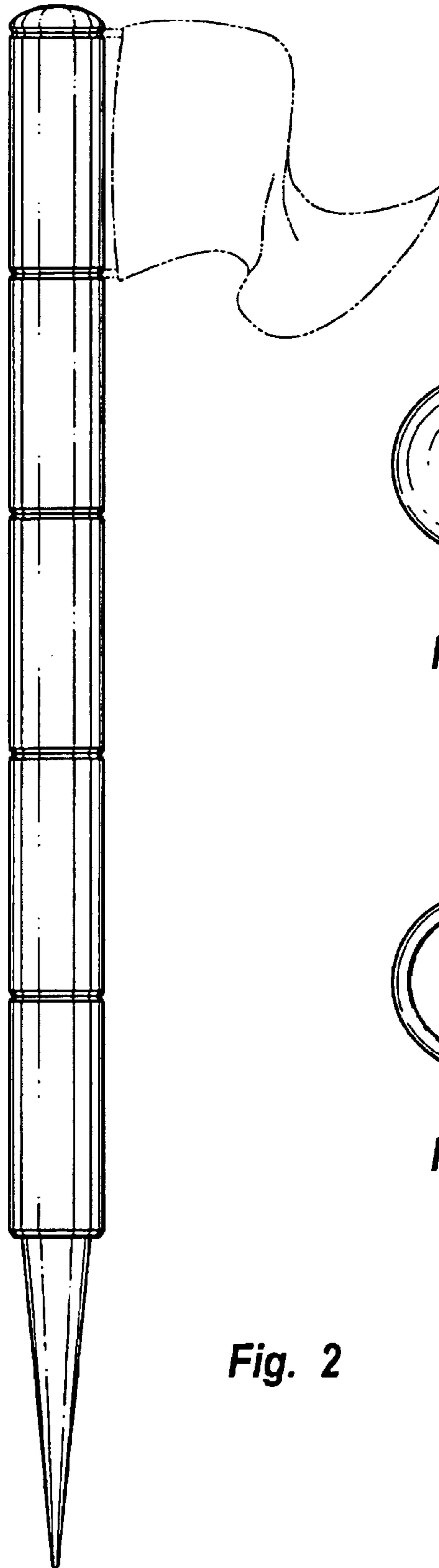
FIG. 1 is a perspective view of the front of the croquet stake;

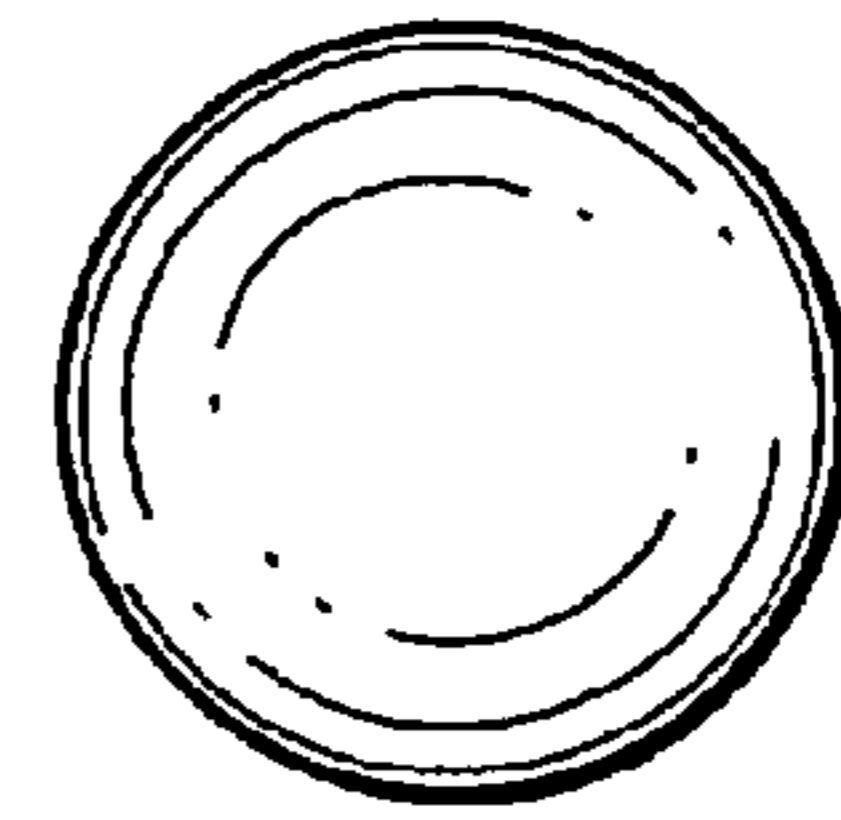




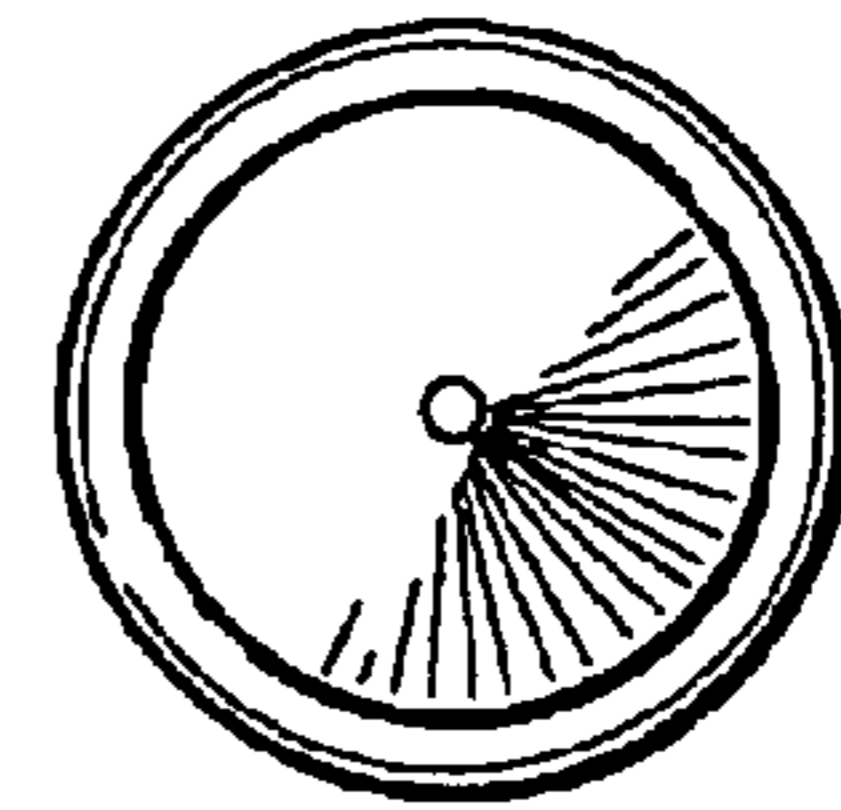
