The ornamental design for a clipper lid with insert, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a first embodiment of the present clipper lid;

FIG. 2 is a top view of same;

FIG. 3 is a right side view of same;

FIG. 4 is a left side view of the clipper lid of FIG. 1;

FIG. 5 is a front view of same;

FIG. 6 is a rear view of the clipper lid of FIG. 1;

FIG. 7 is a top perspective view of a second embodiment of the present clipper lid;

FIG. 8 is a top view of same;

FIG. 9 is a left side of the clipper lid of FIG. 7;

FIG. 10 is a right side view of same;

FIG. 11 is a rear view of same; and,

FIG. 12 is a front view of the clipper lid of FIG. 7.

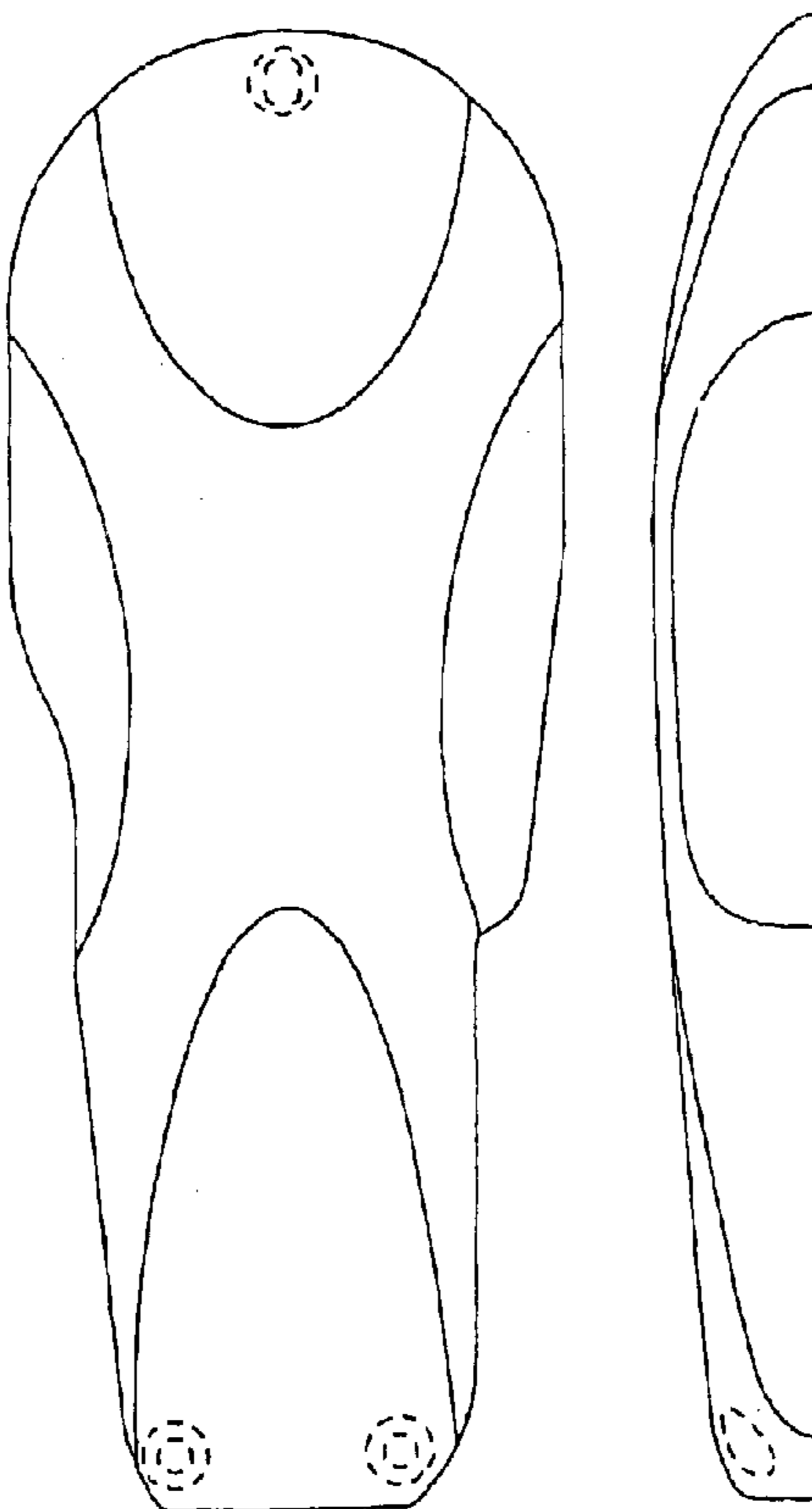
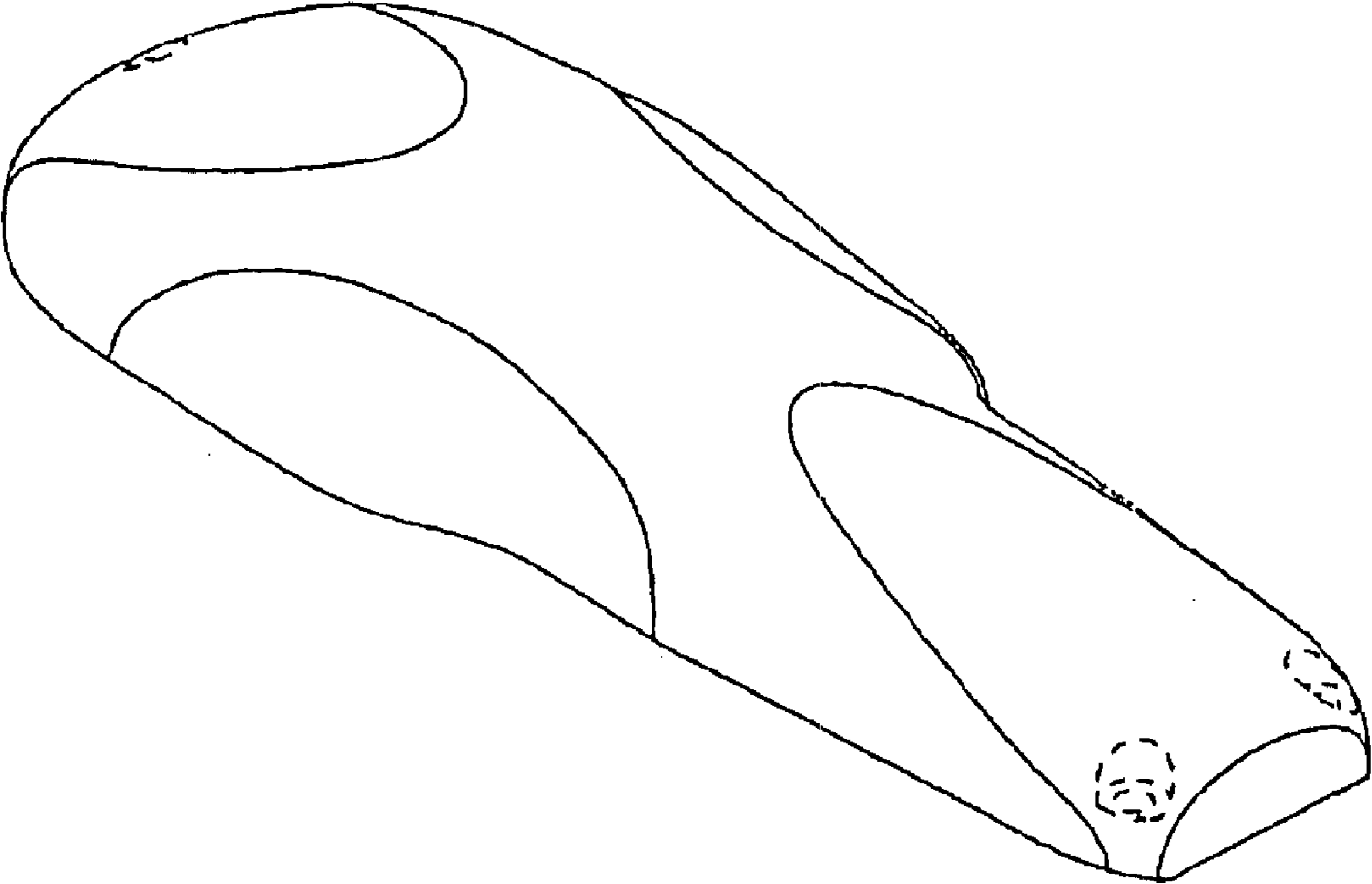

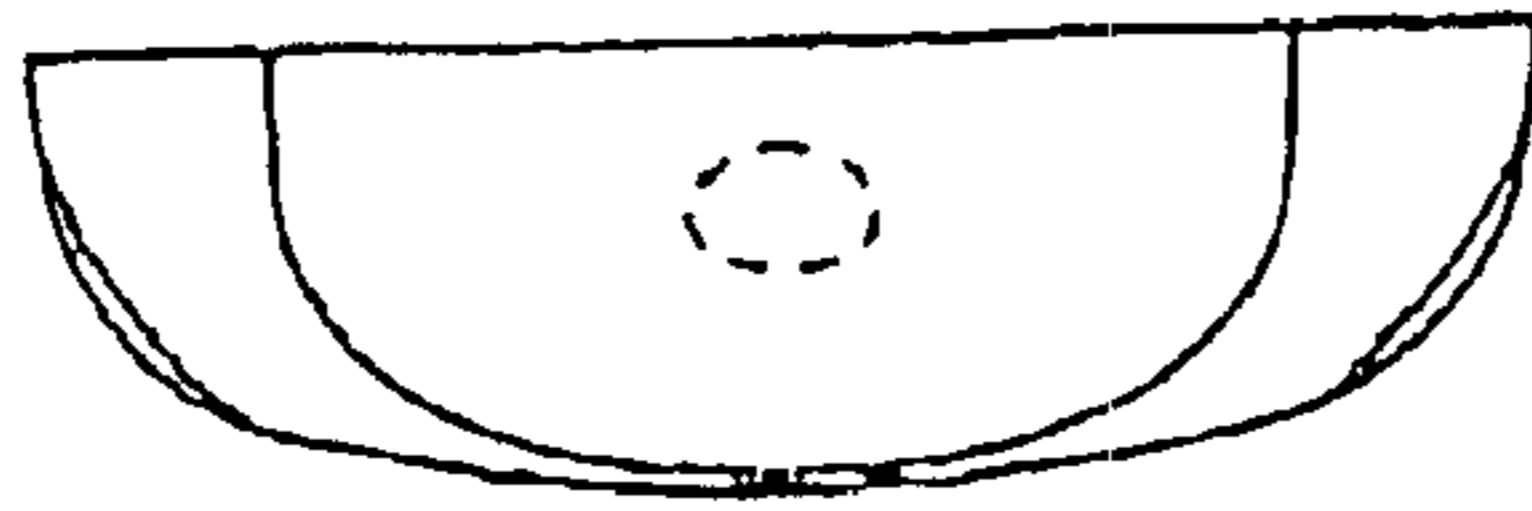

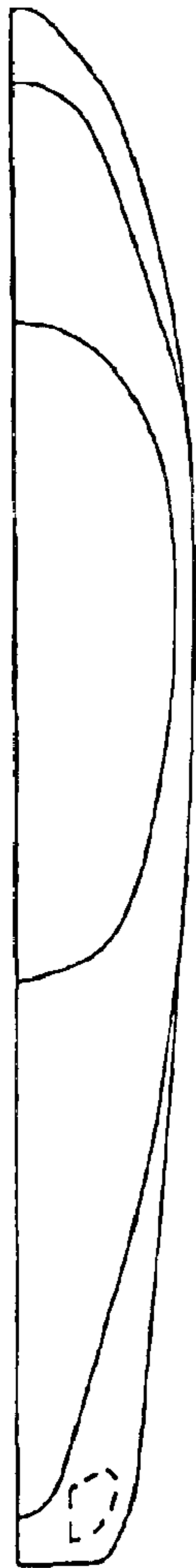

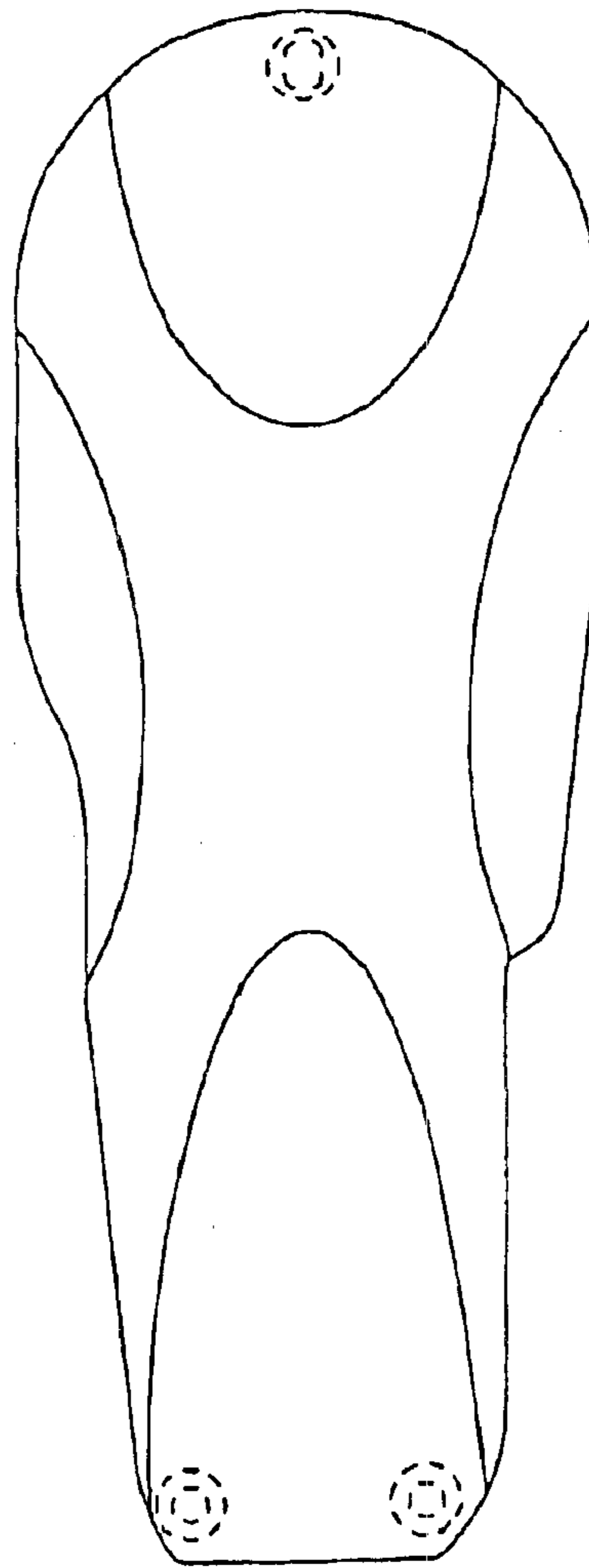

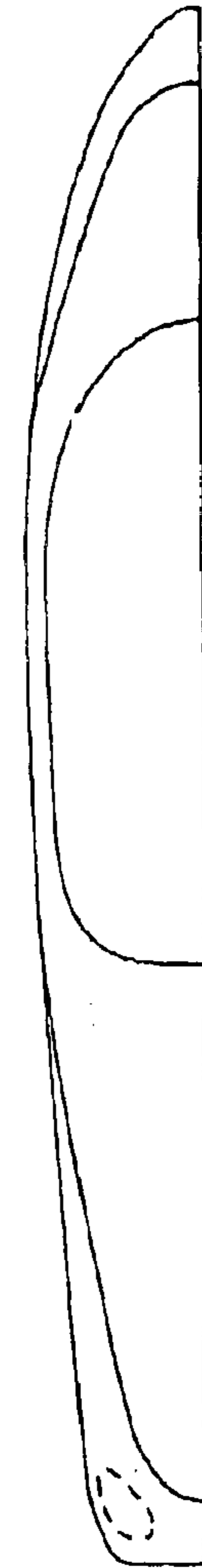

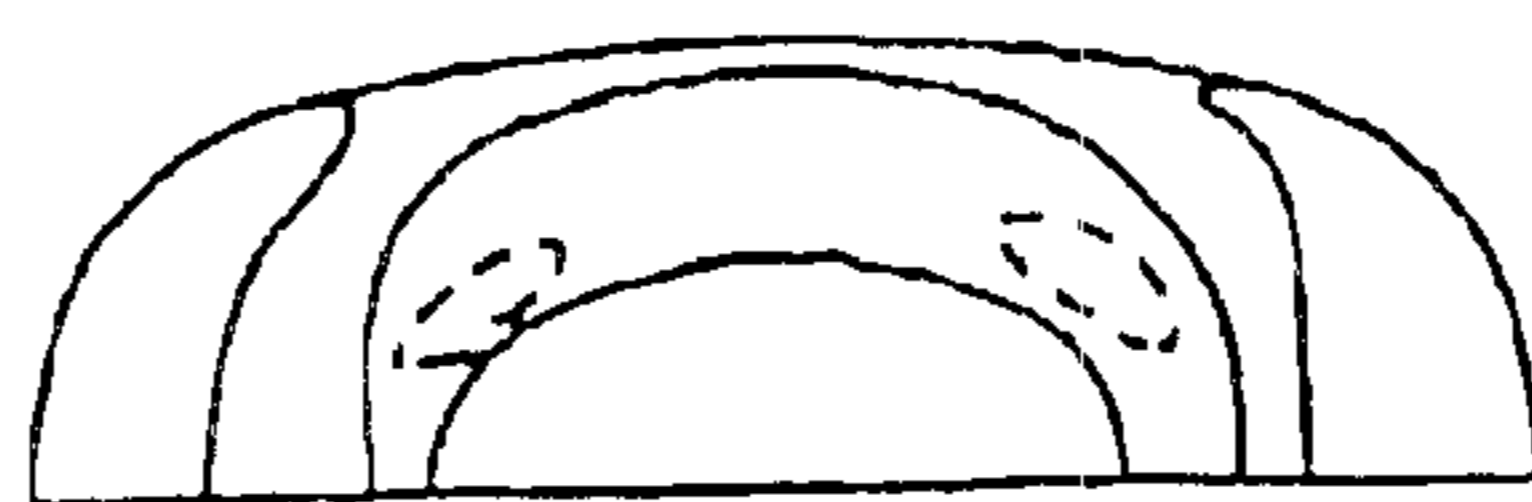

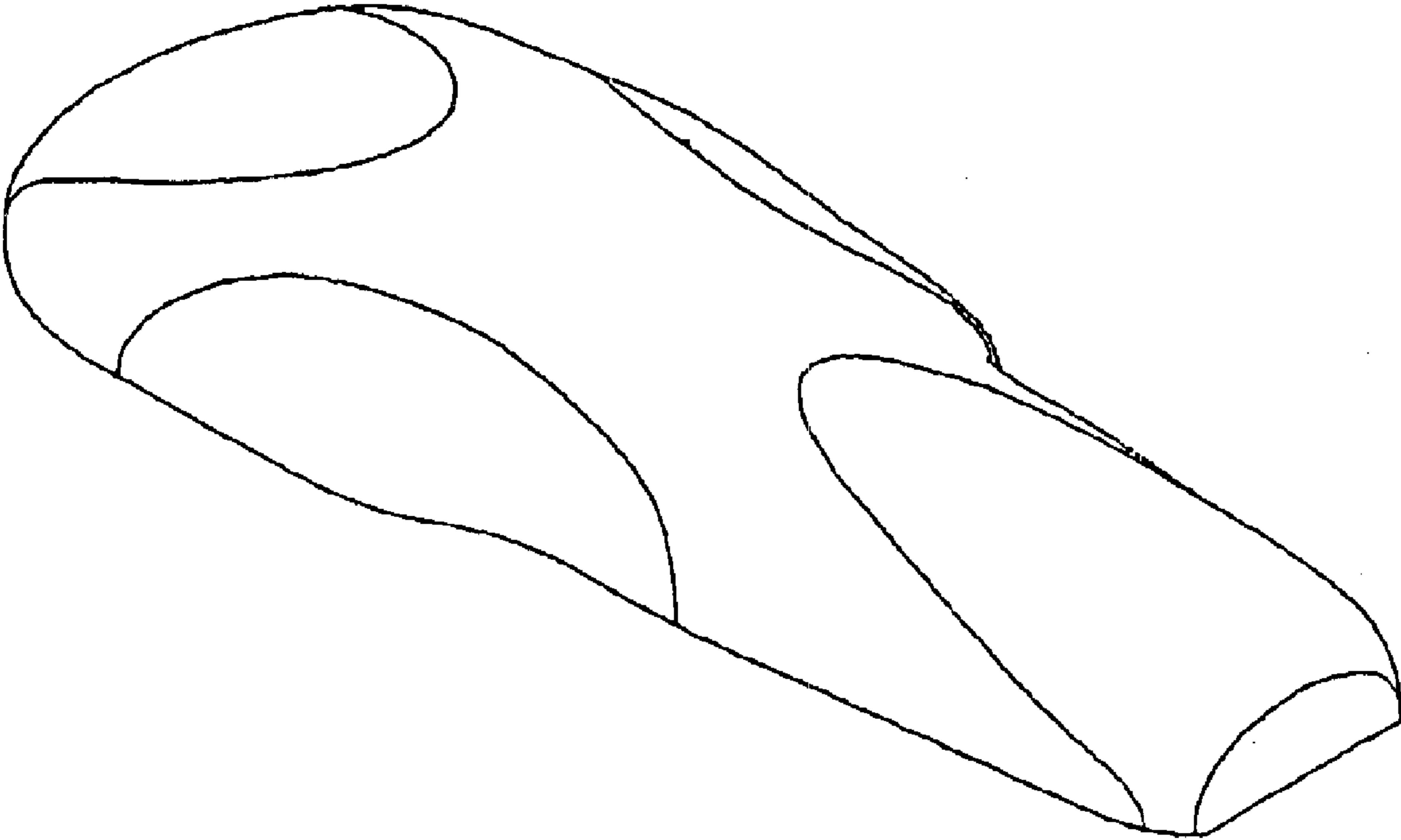

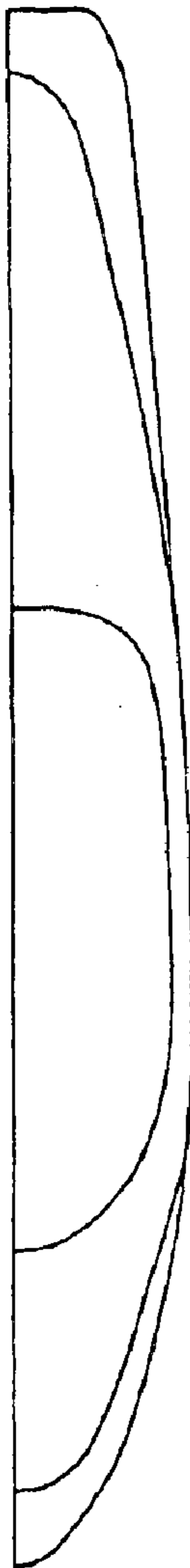

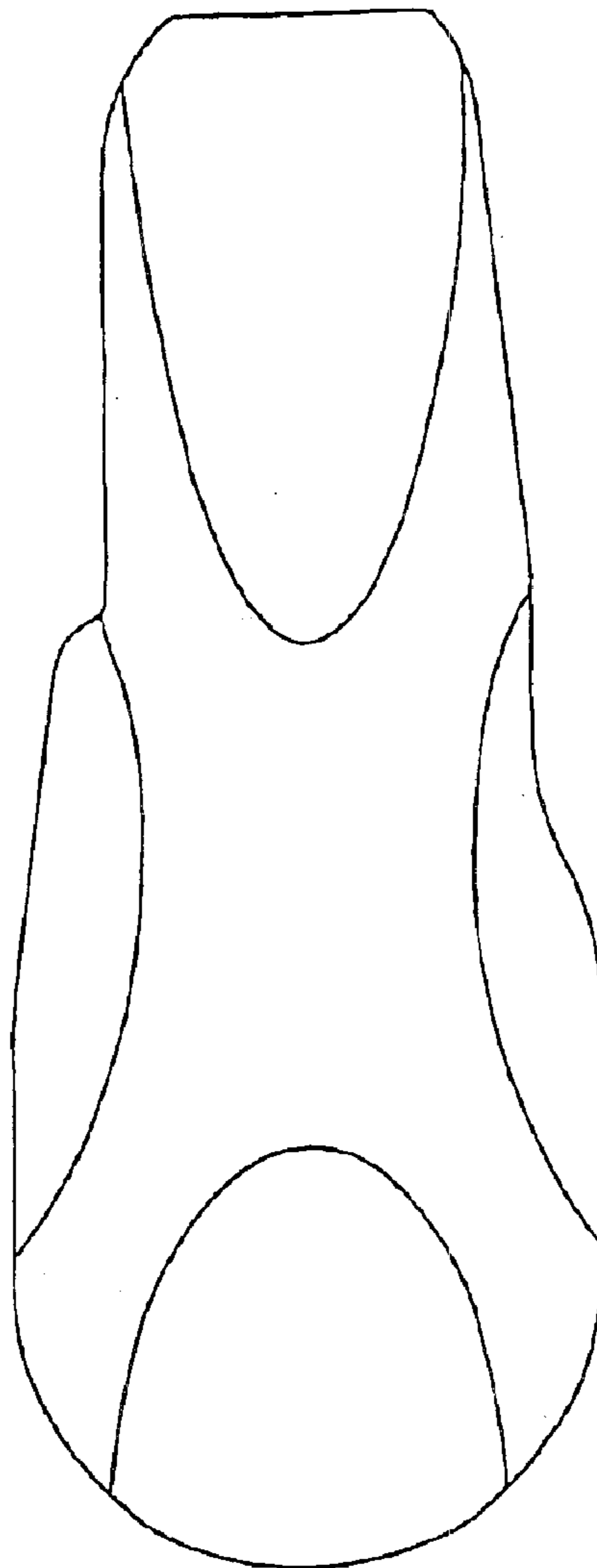

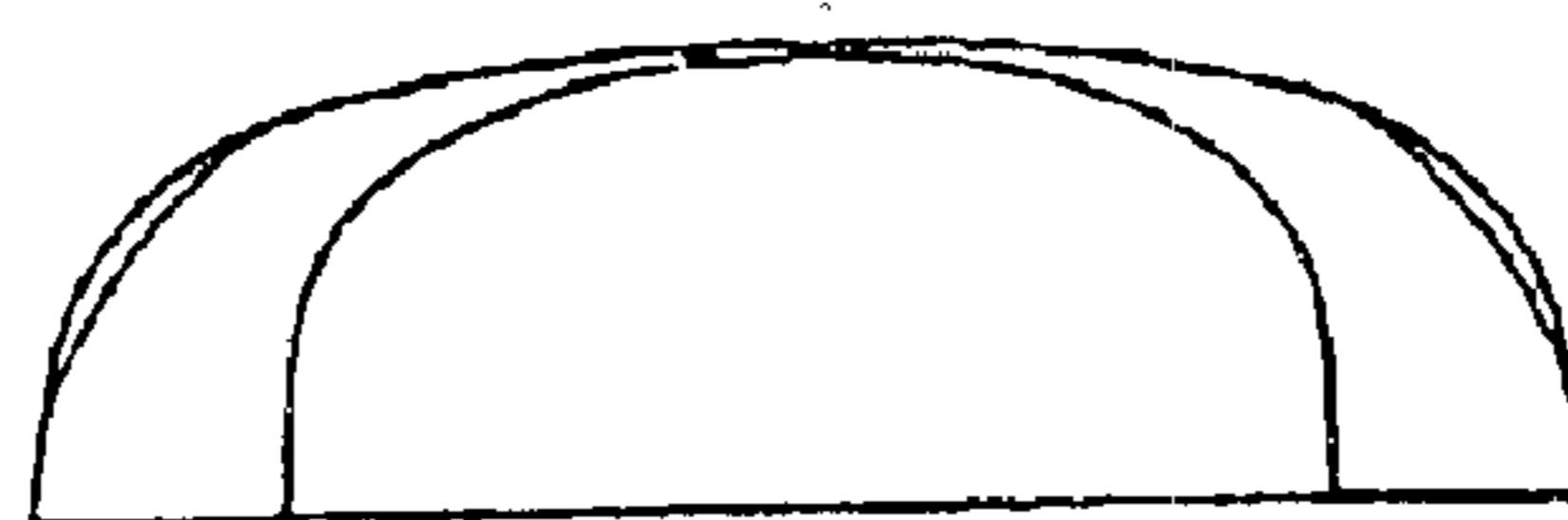
