The ornamental design for a garment hanger, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a garment hanger showing my new design;

FIG. 12 is a bottom plan view thereof;

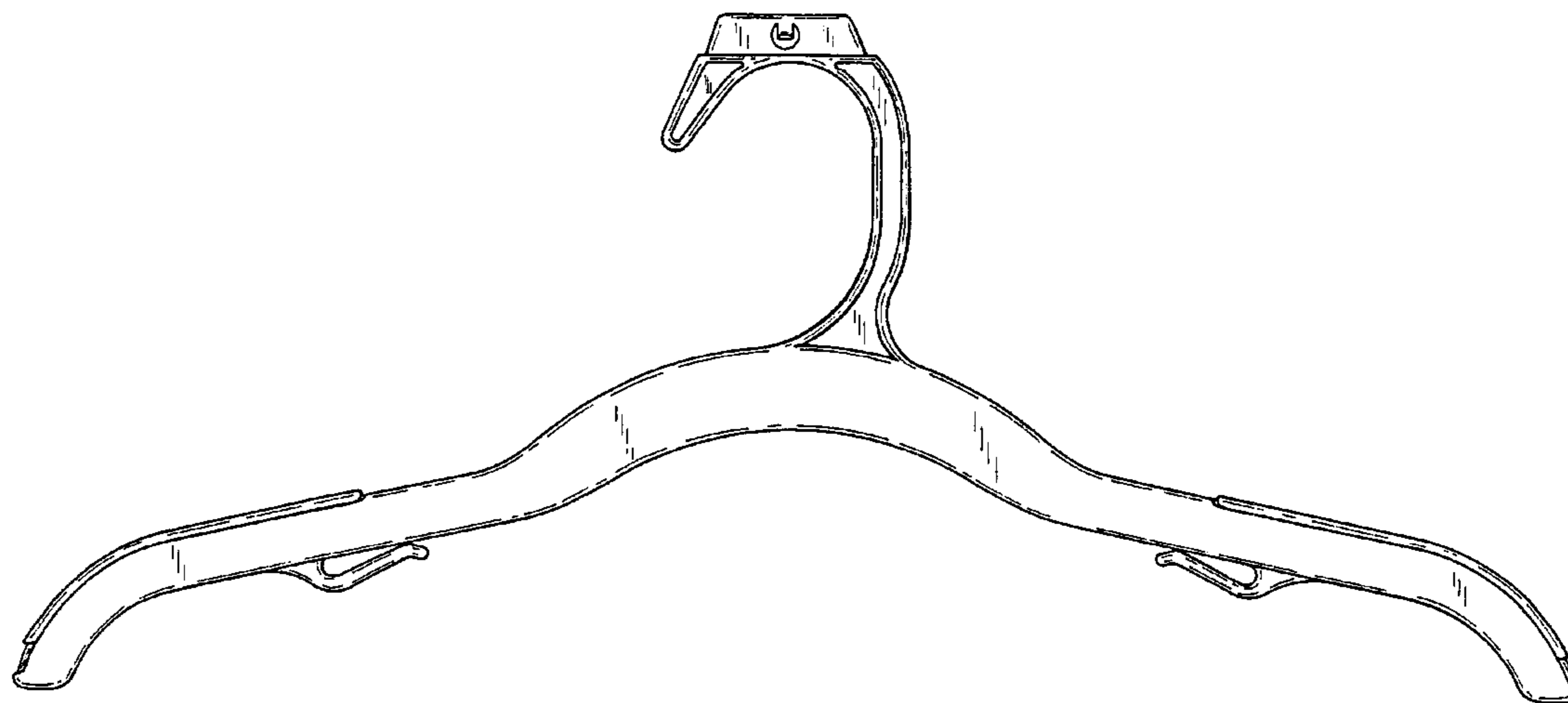
FIG. 13 is a left end elevation view thereof; and,

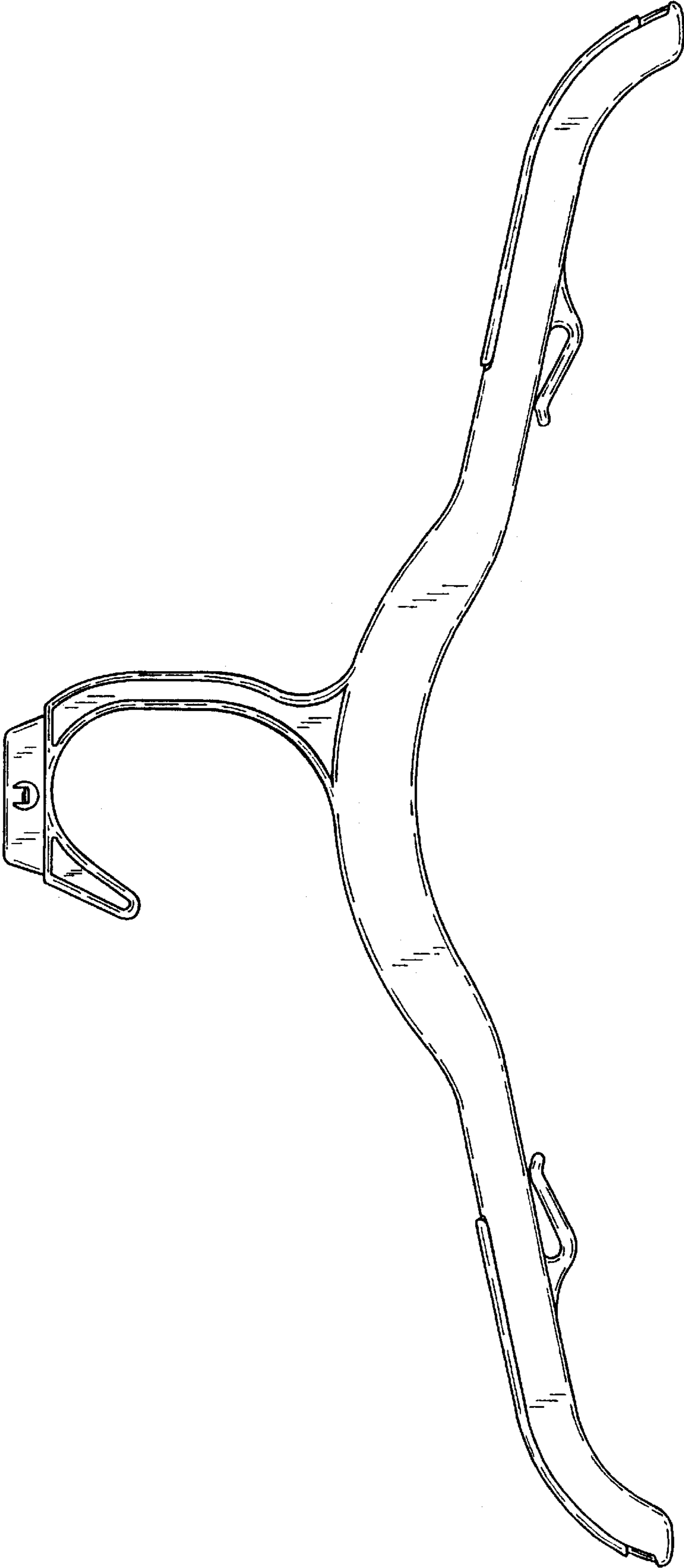

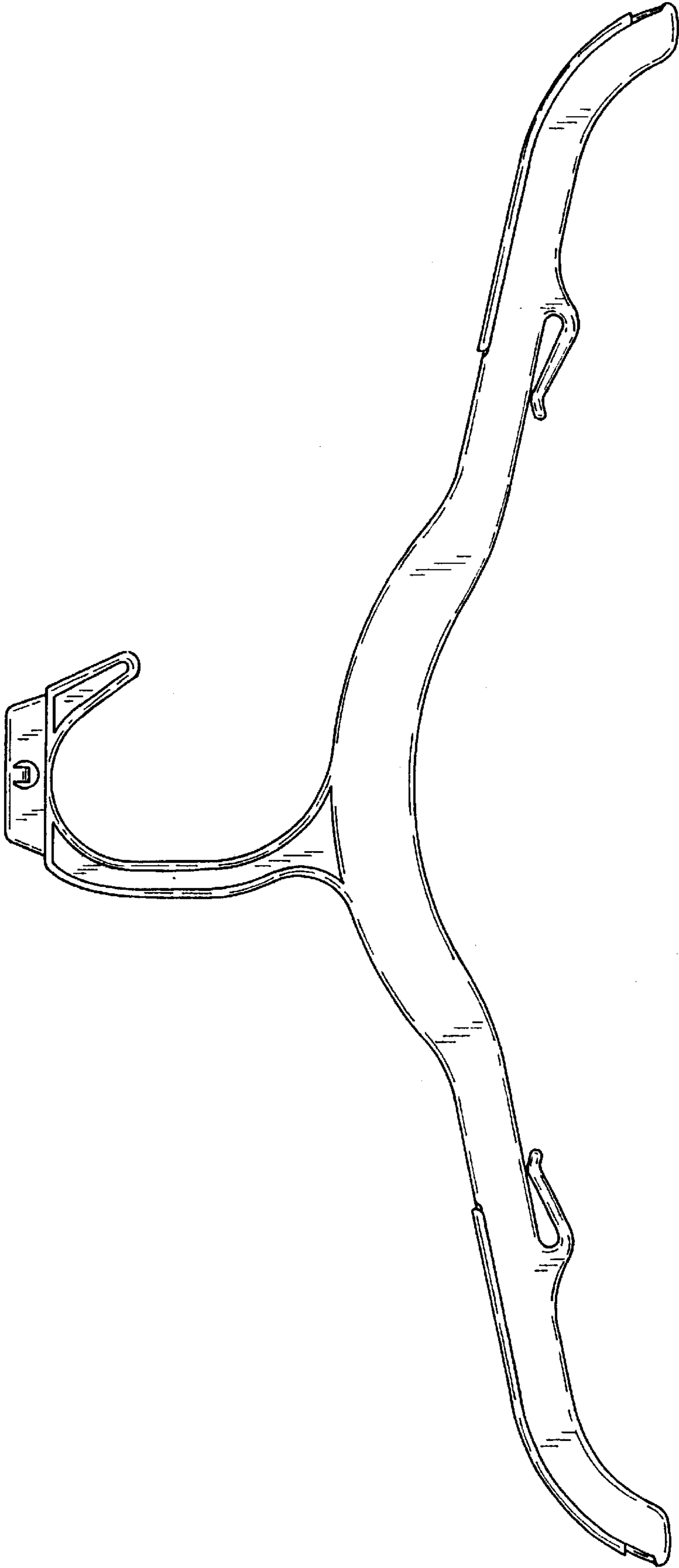

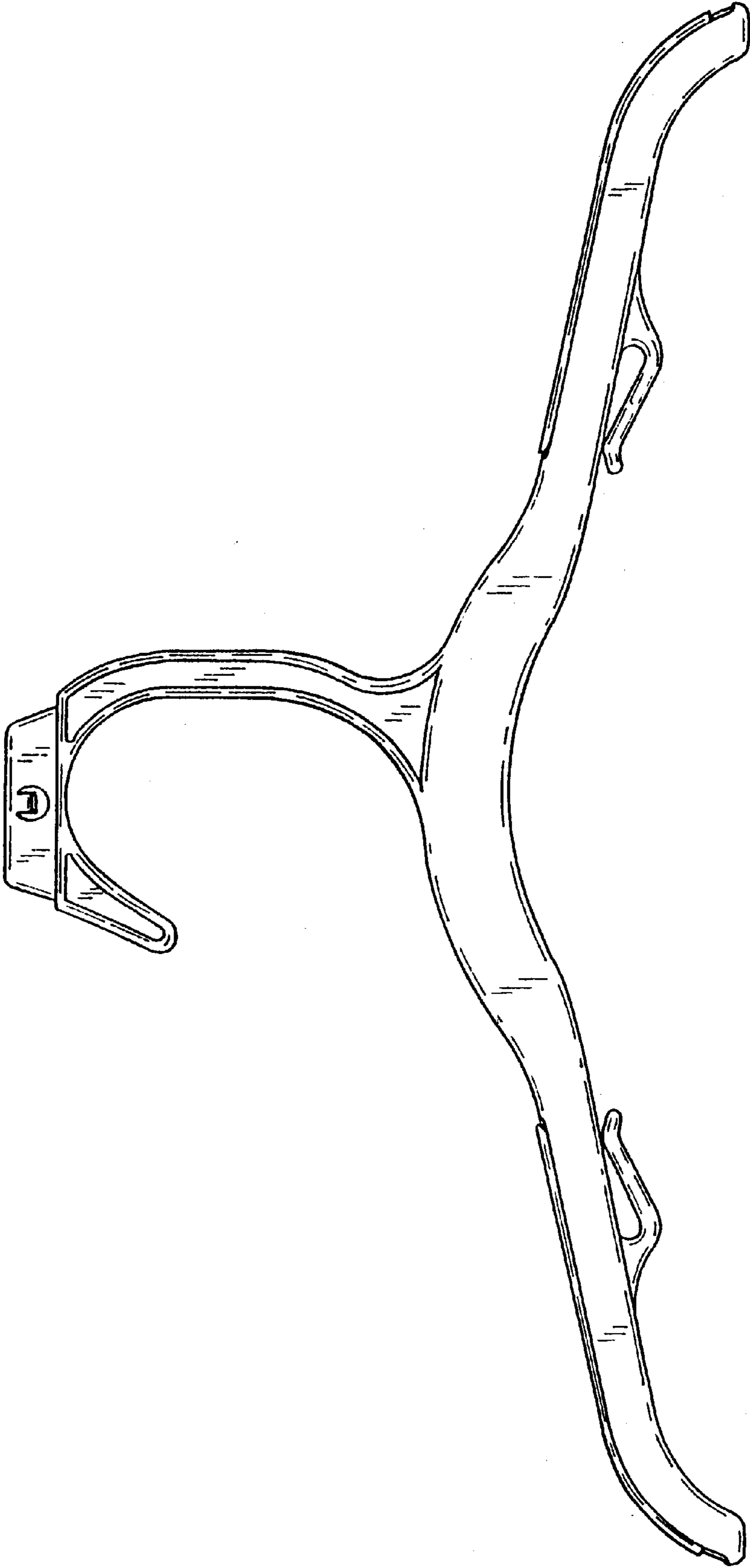

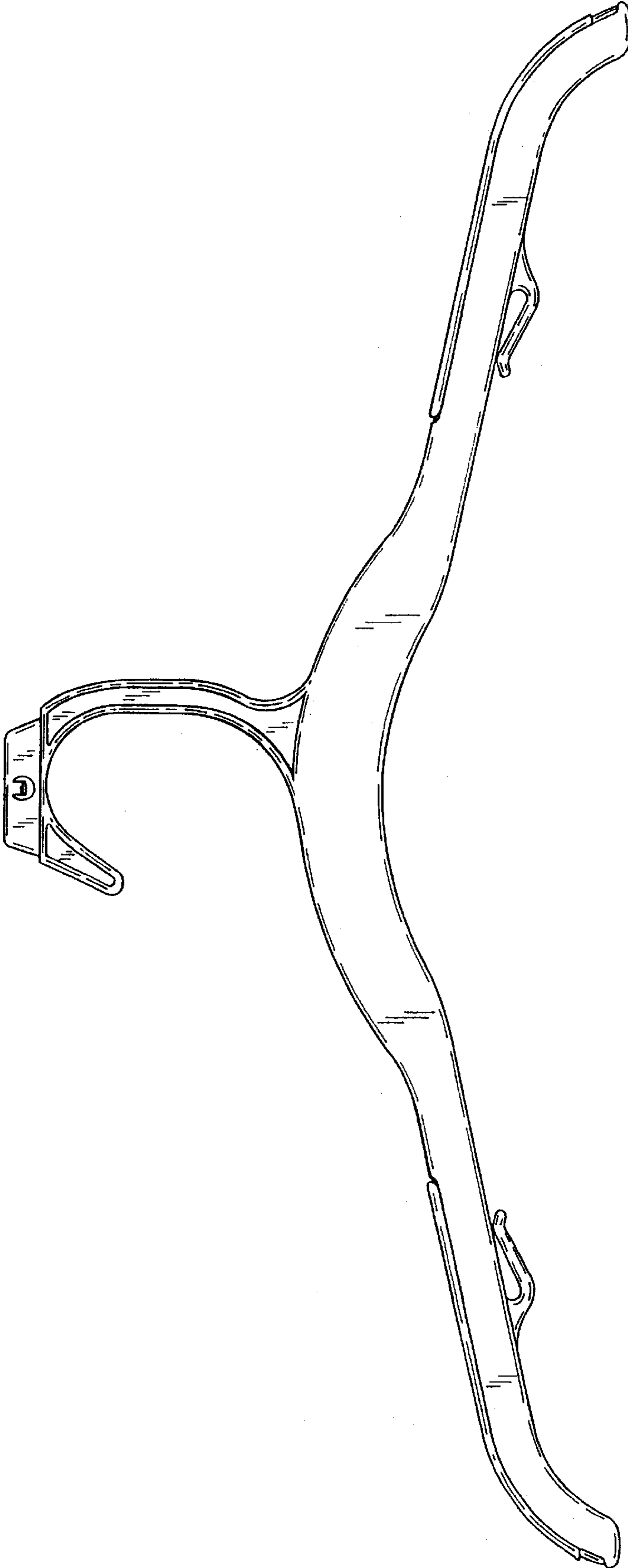

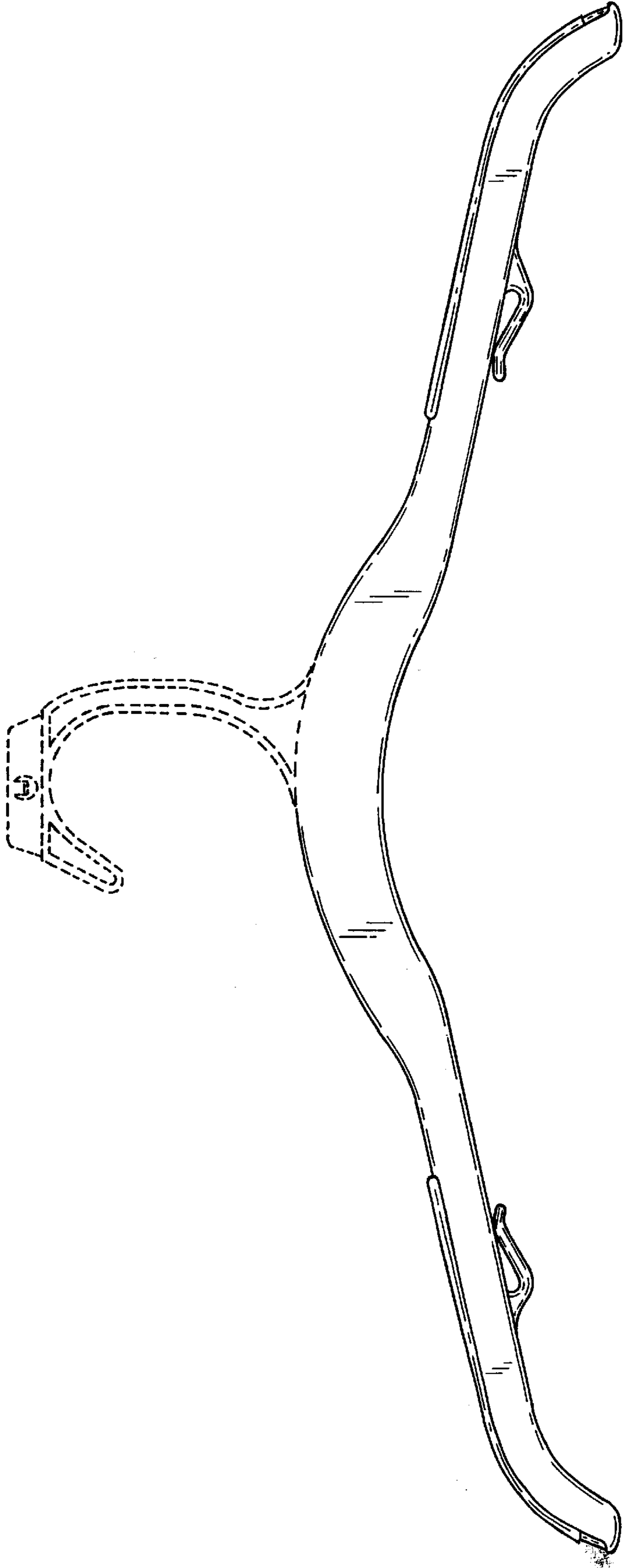

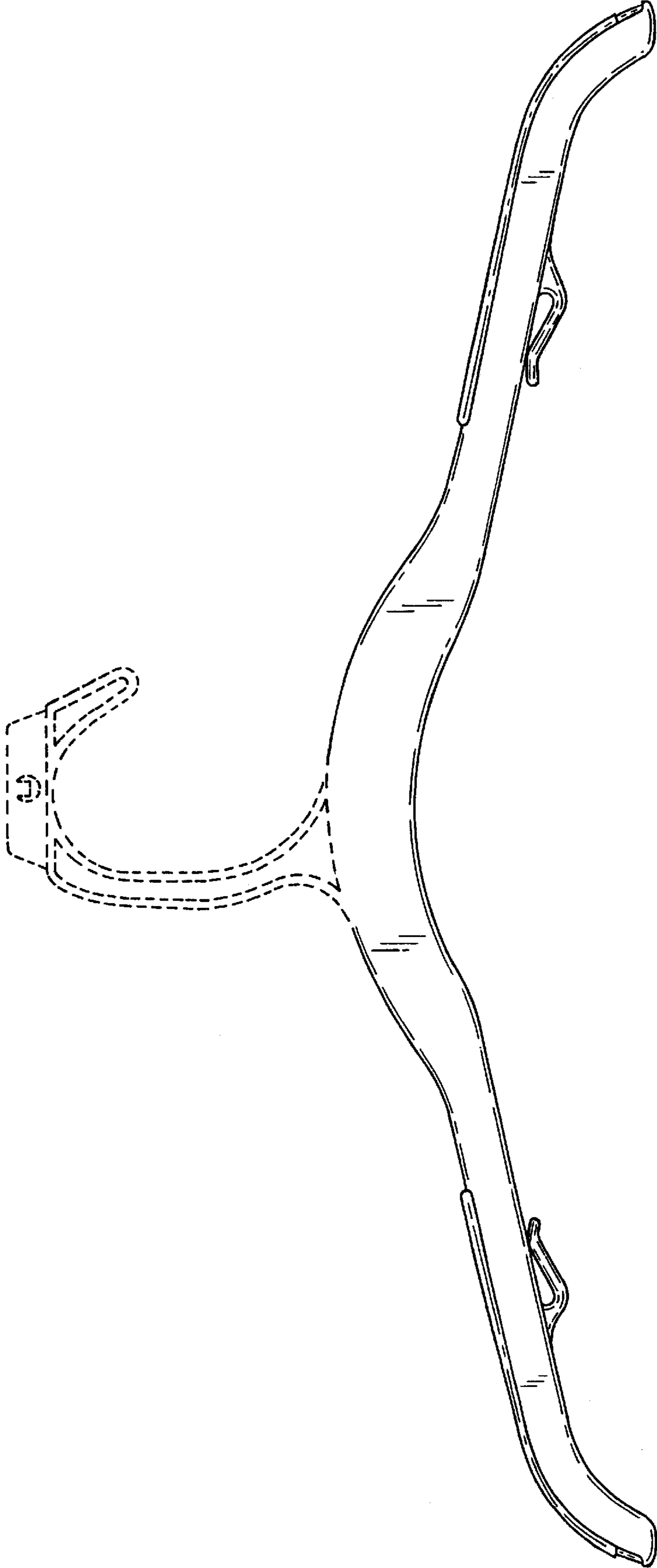

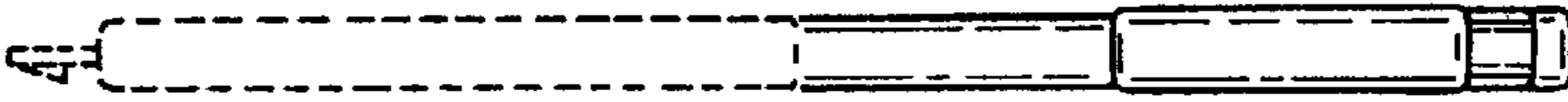

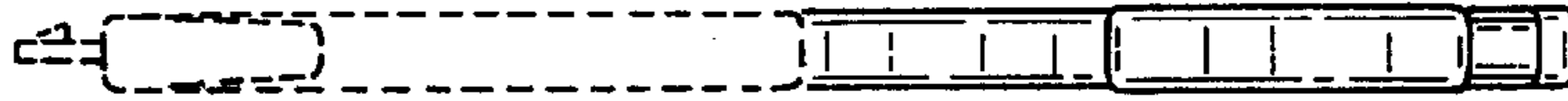
