DESCRIPTION

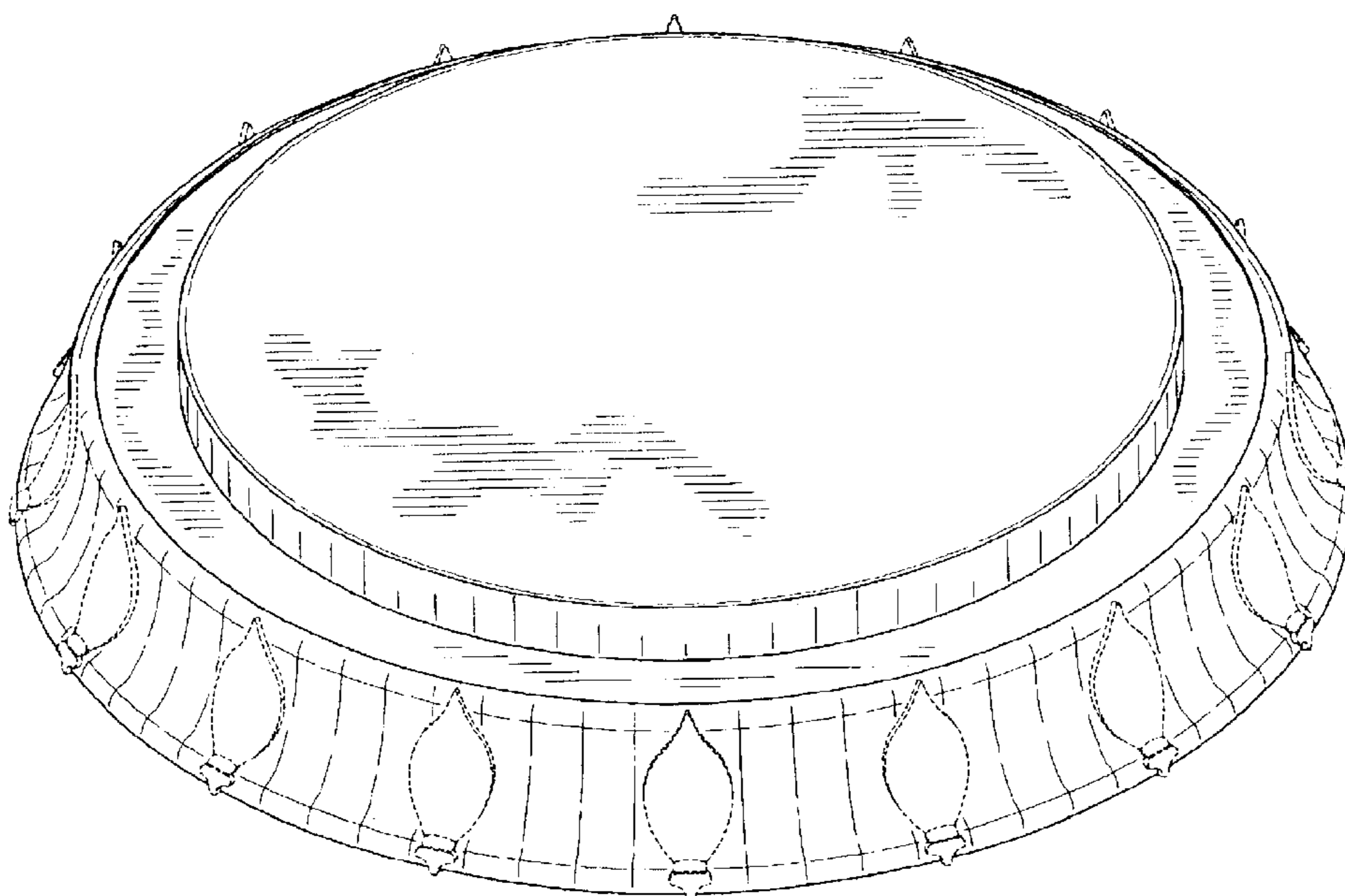
FIG. 1 is a perspective view of a cake plate showing our new design;

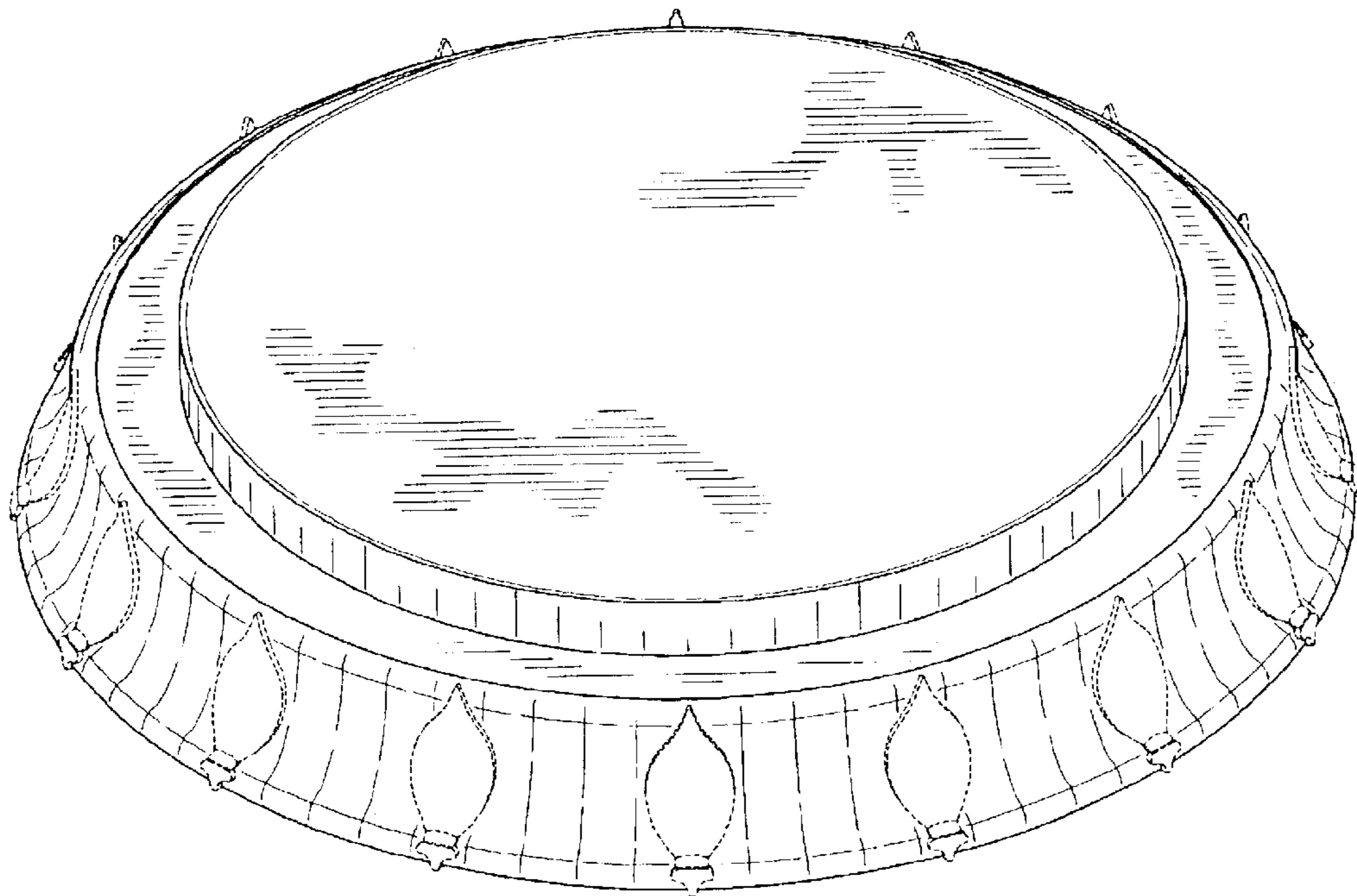

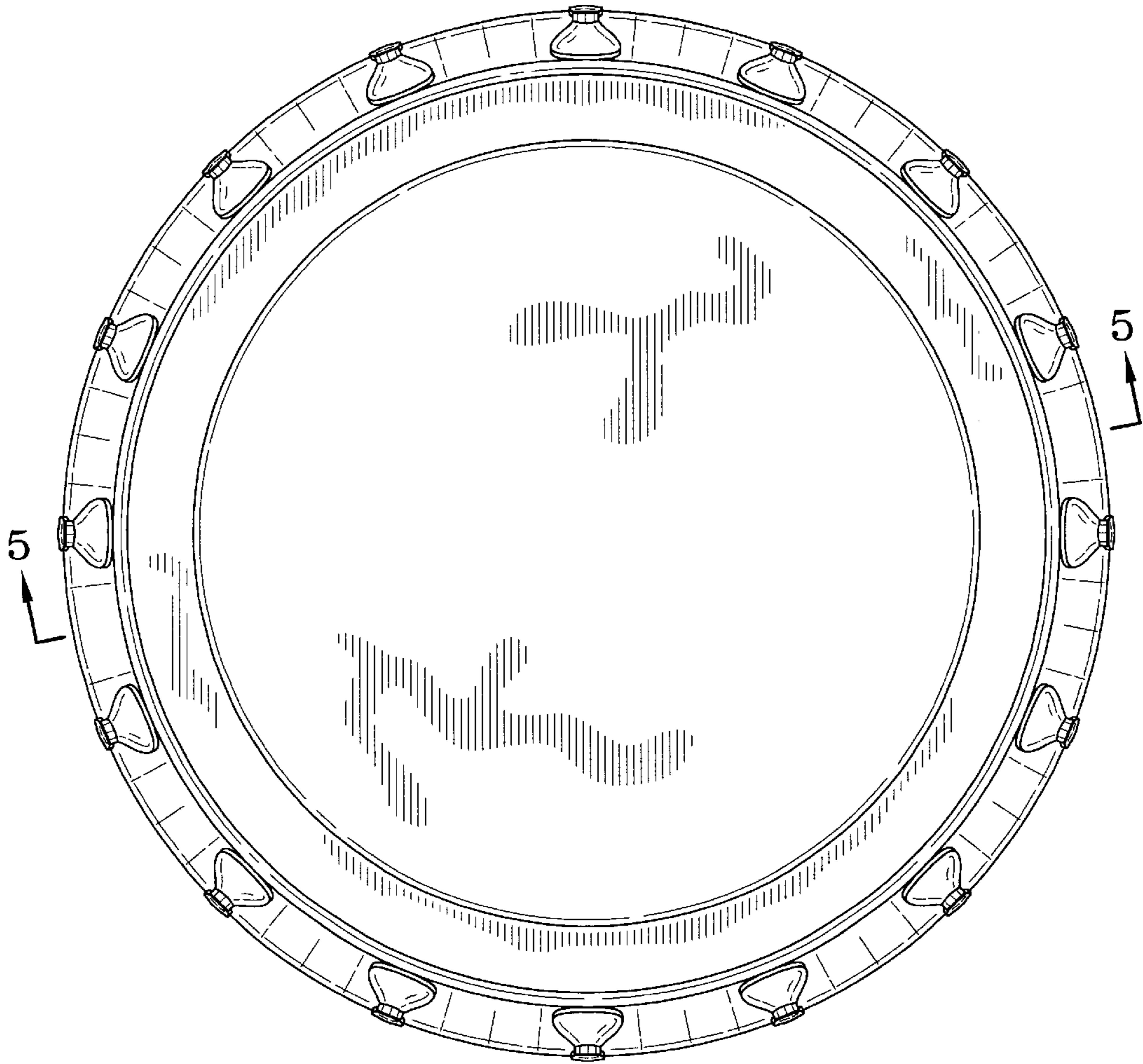

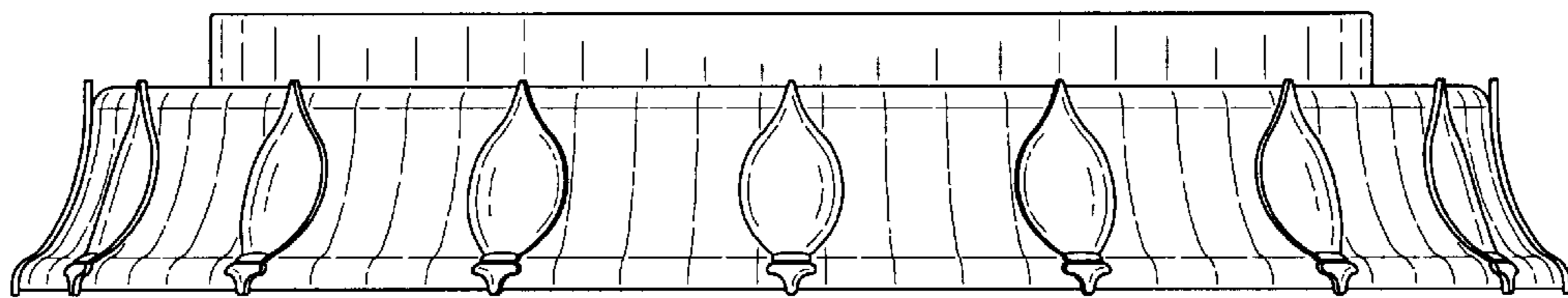

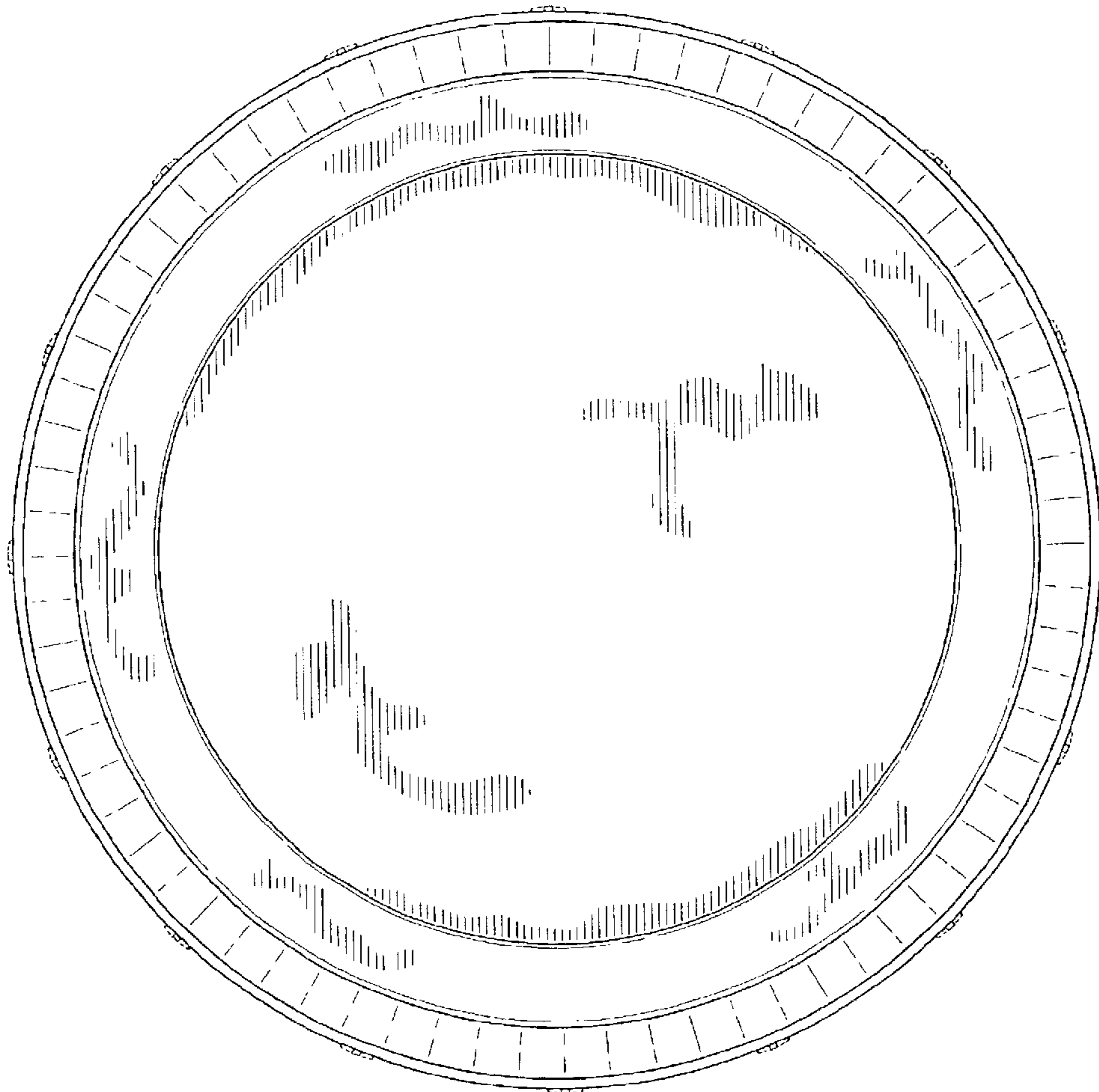

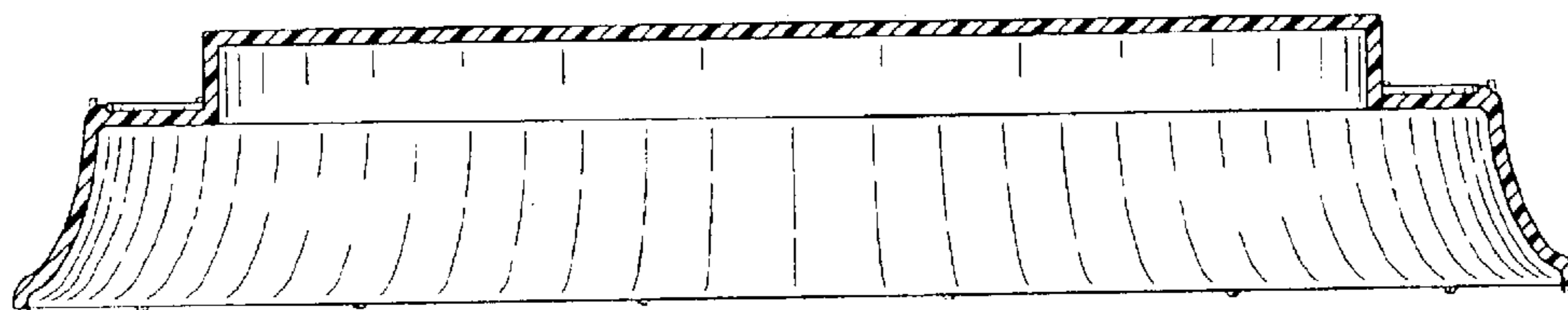
