The ornamental design for a perfume bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, and left side perspective view of the perfume bottle showing my new design;

FIG. 2 is a top plan view thereof;

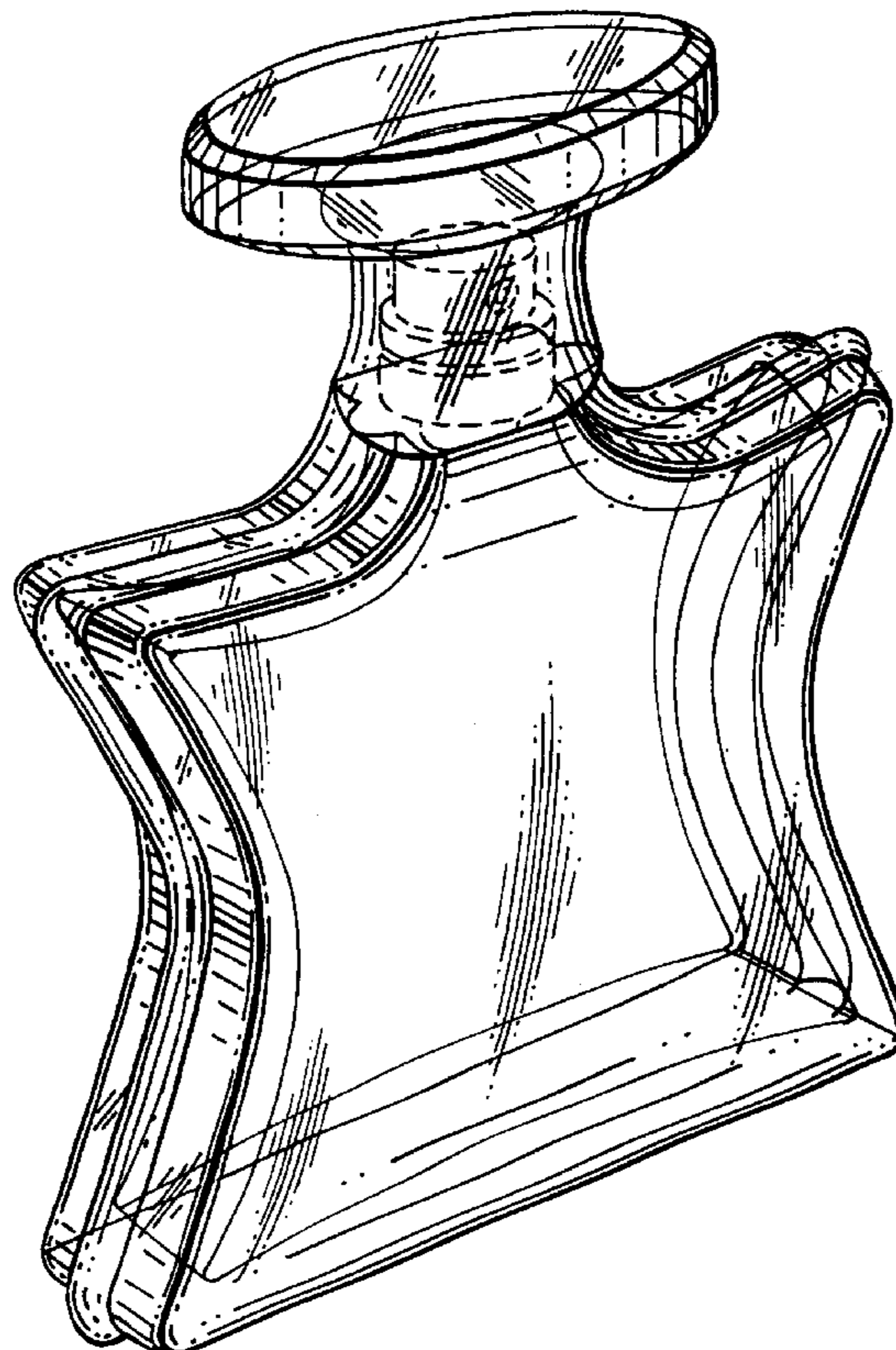
FIG. 3 is a right side elevational view thereof, the left side elevational view being a mirror image;

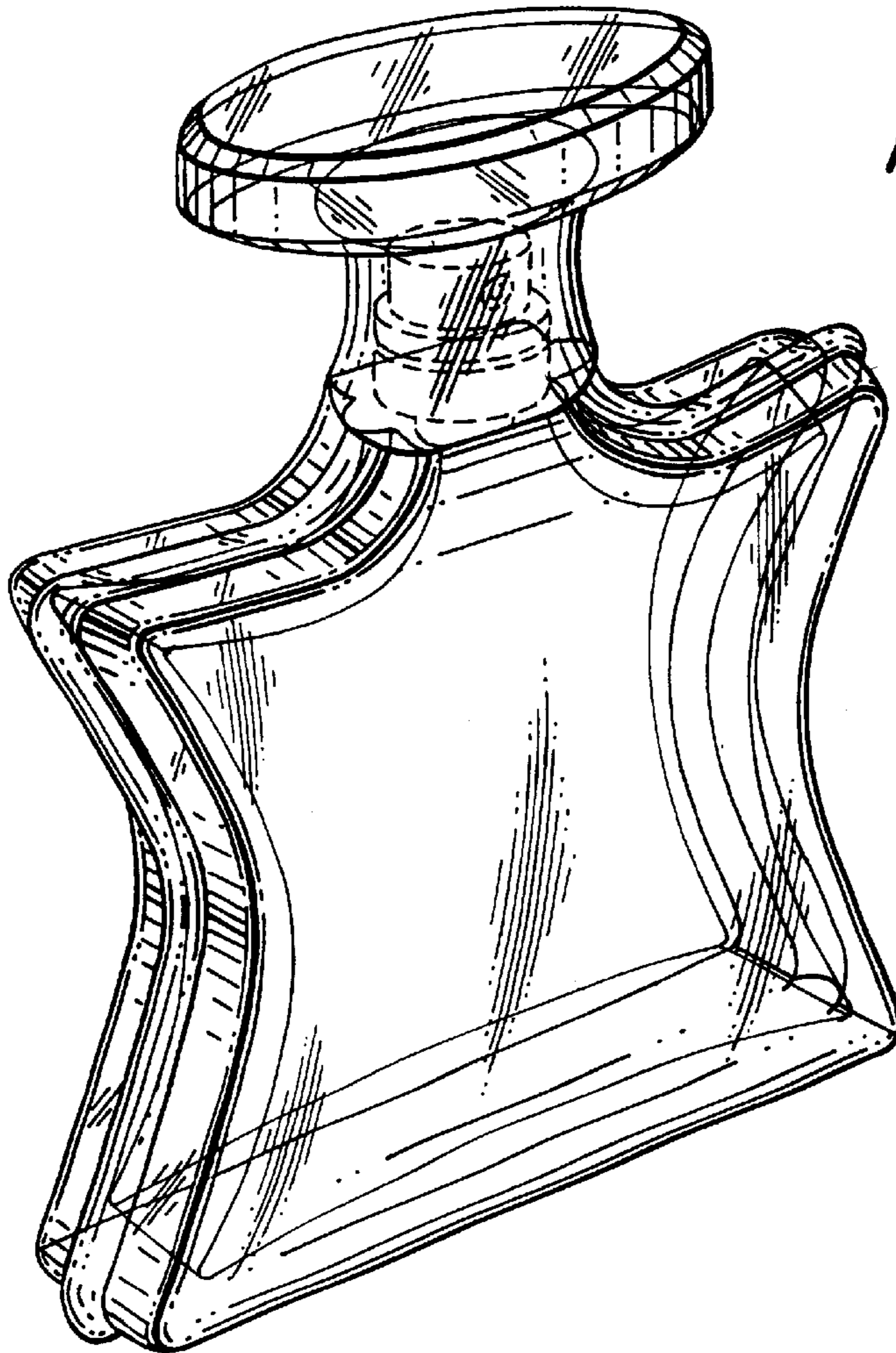
FIG. 4 is a front elevational view thereof, the rear elevational view being a mirror image except for the unclaimed sprayer tip; and,

FIG. 5 is a bottom plan view thereof.

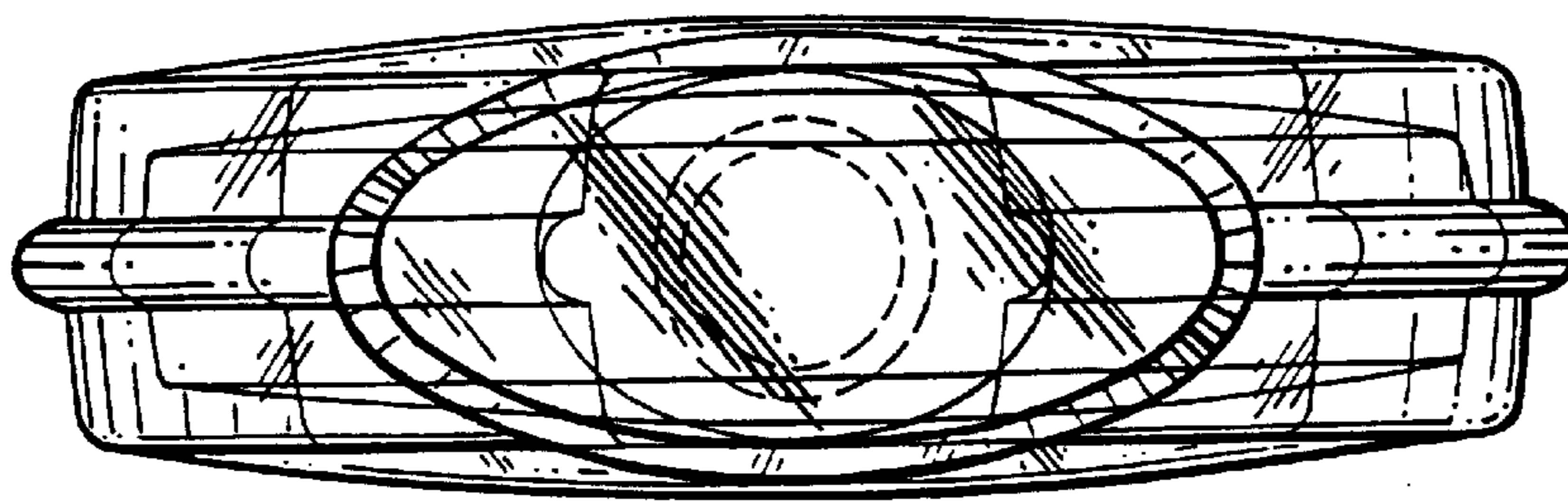
The broken line showing in the drawing figures is for illustrative purposes only and forms no part of the claimed design.

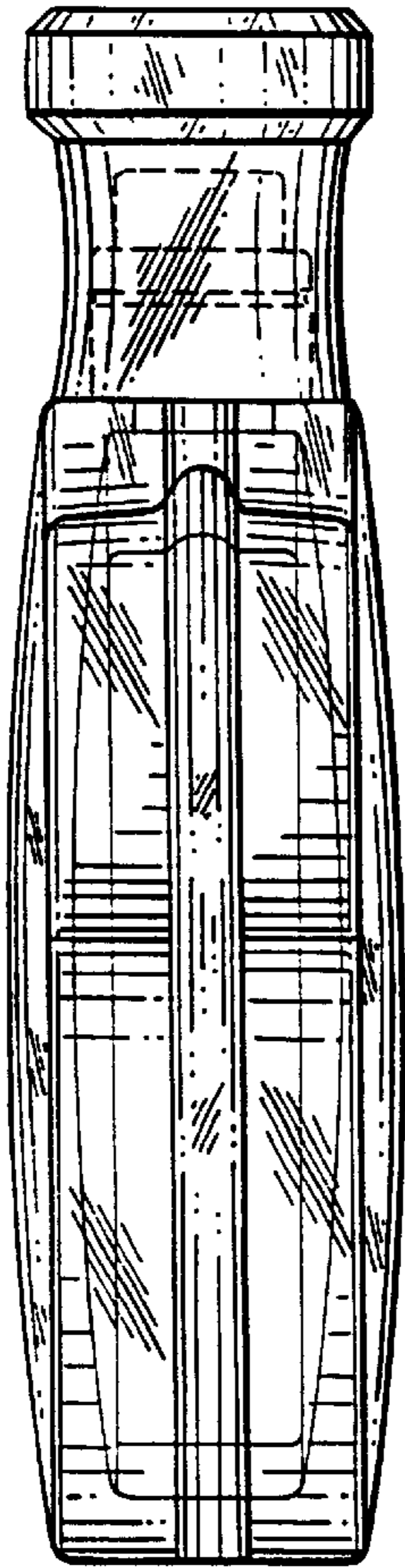

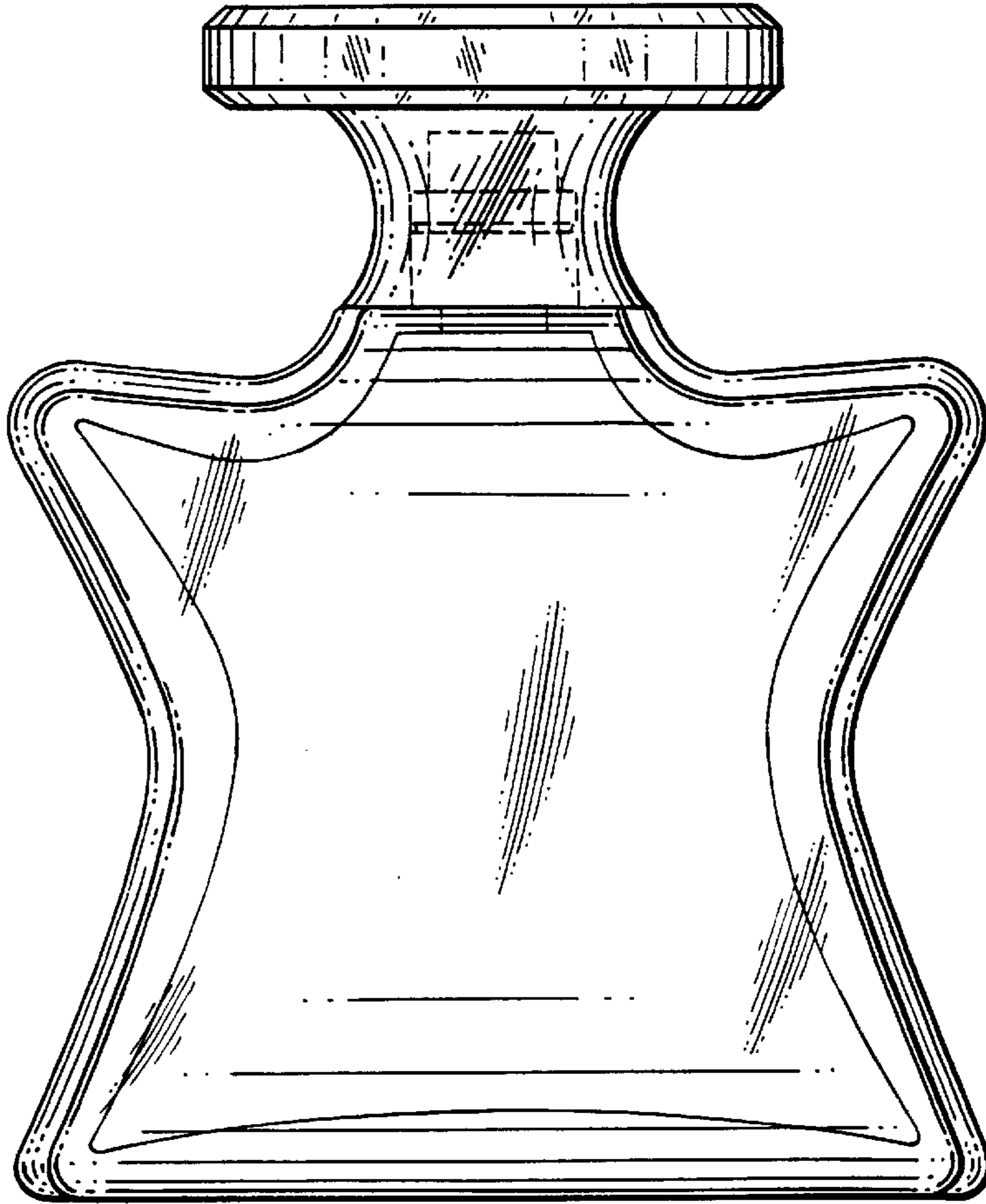
