FIG. 3 is a rear view thereof;

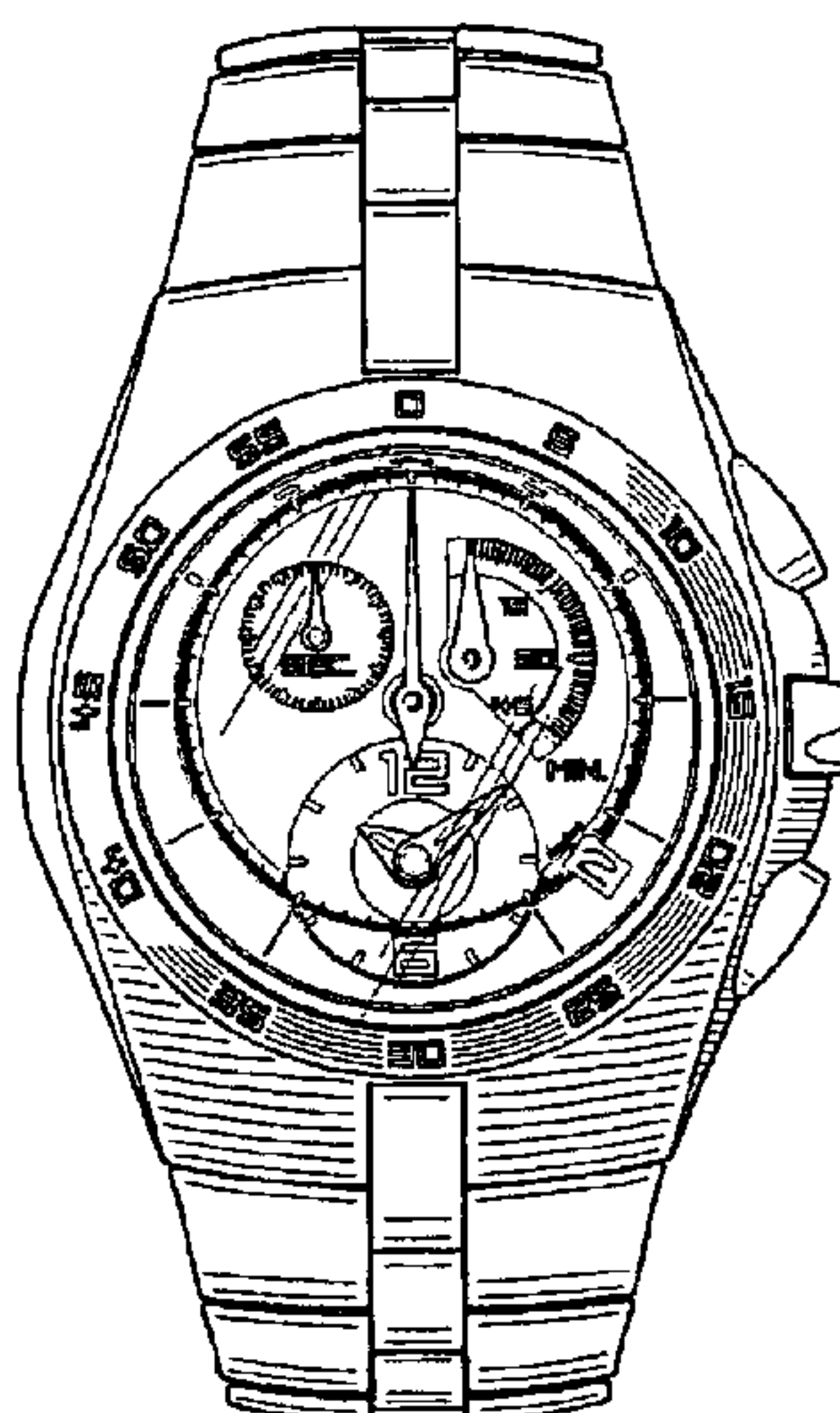
FIG. 4 is a right-side view thereof;

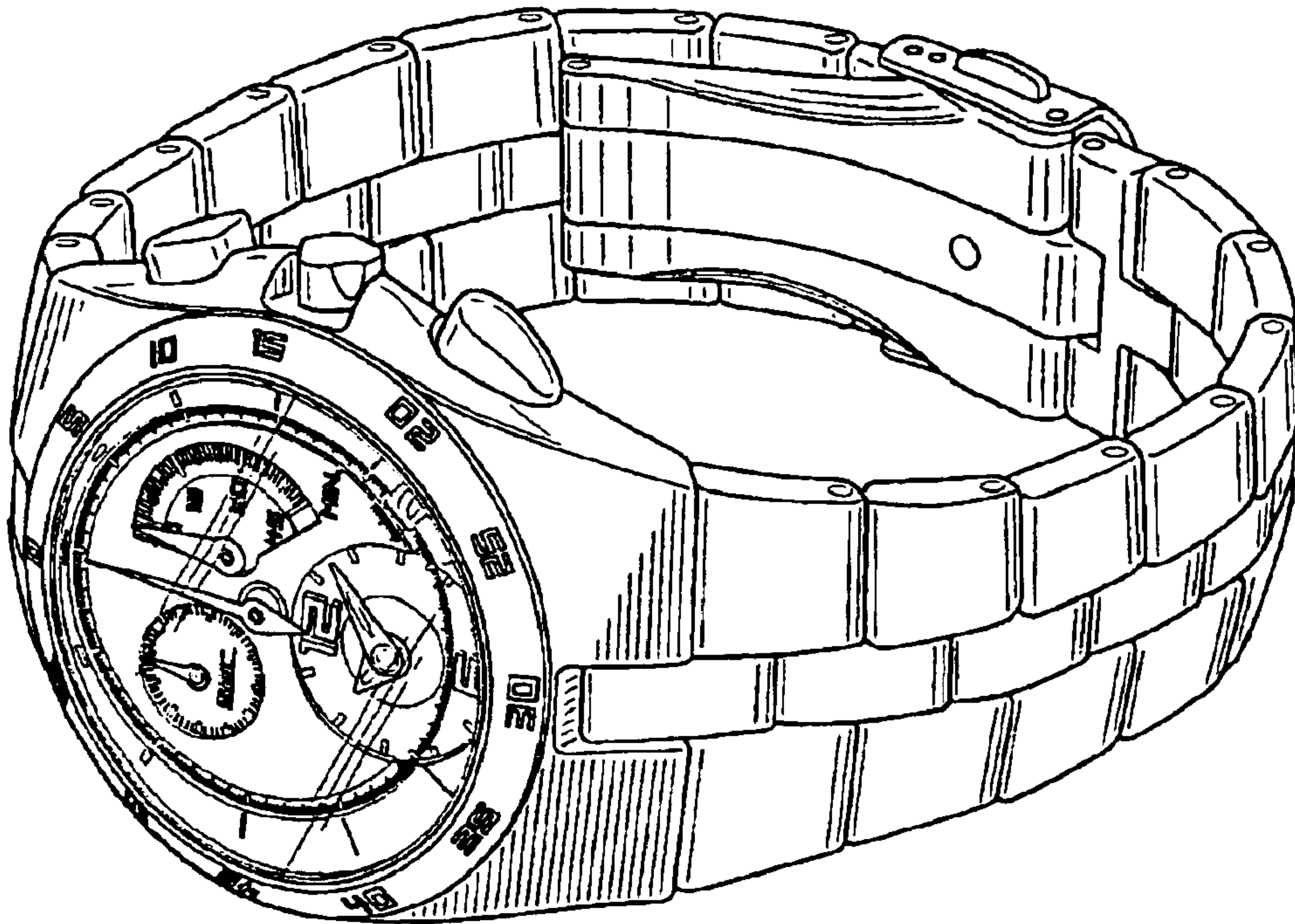

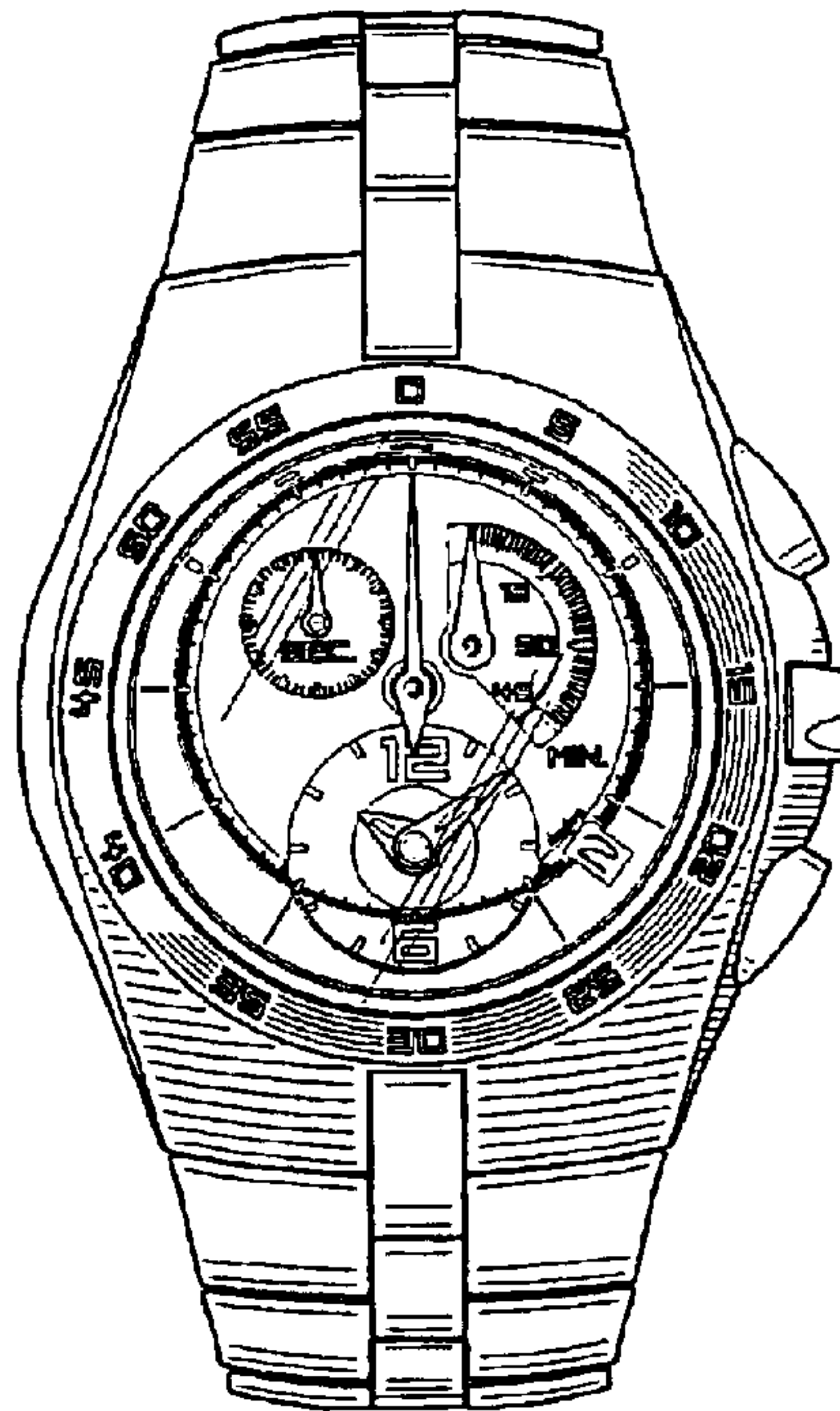

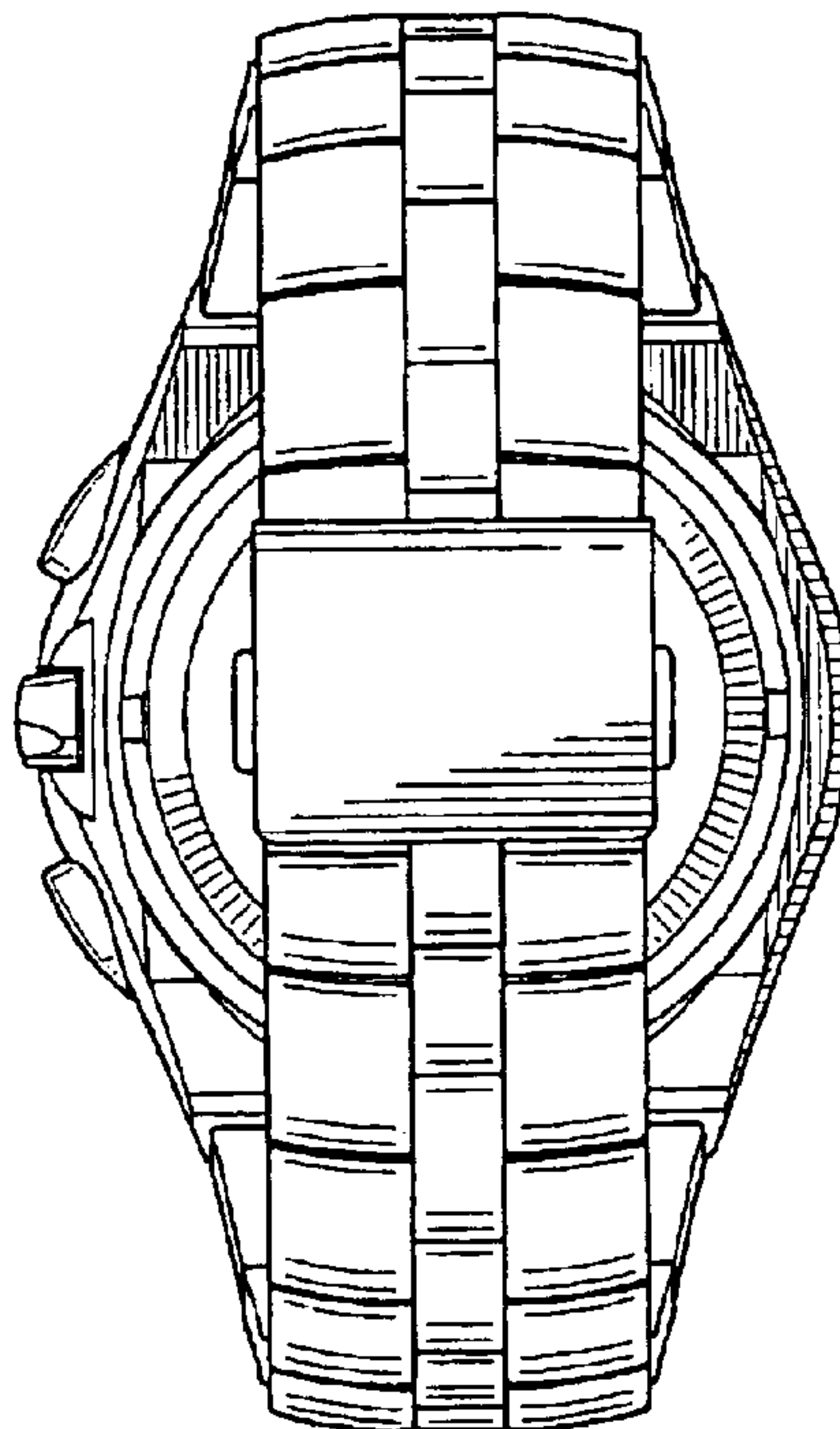

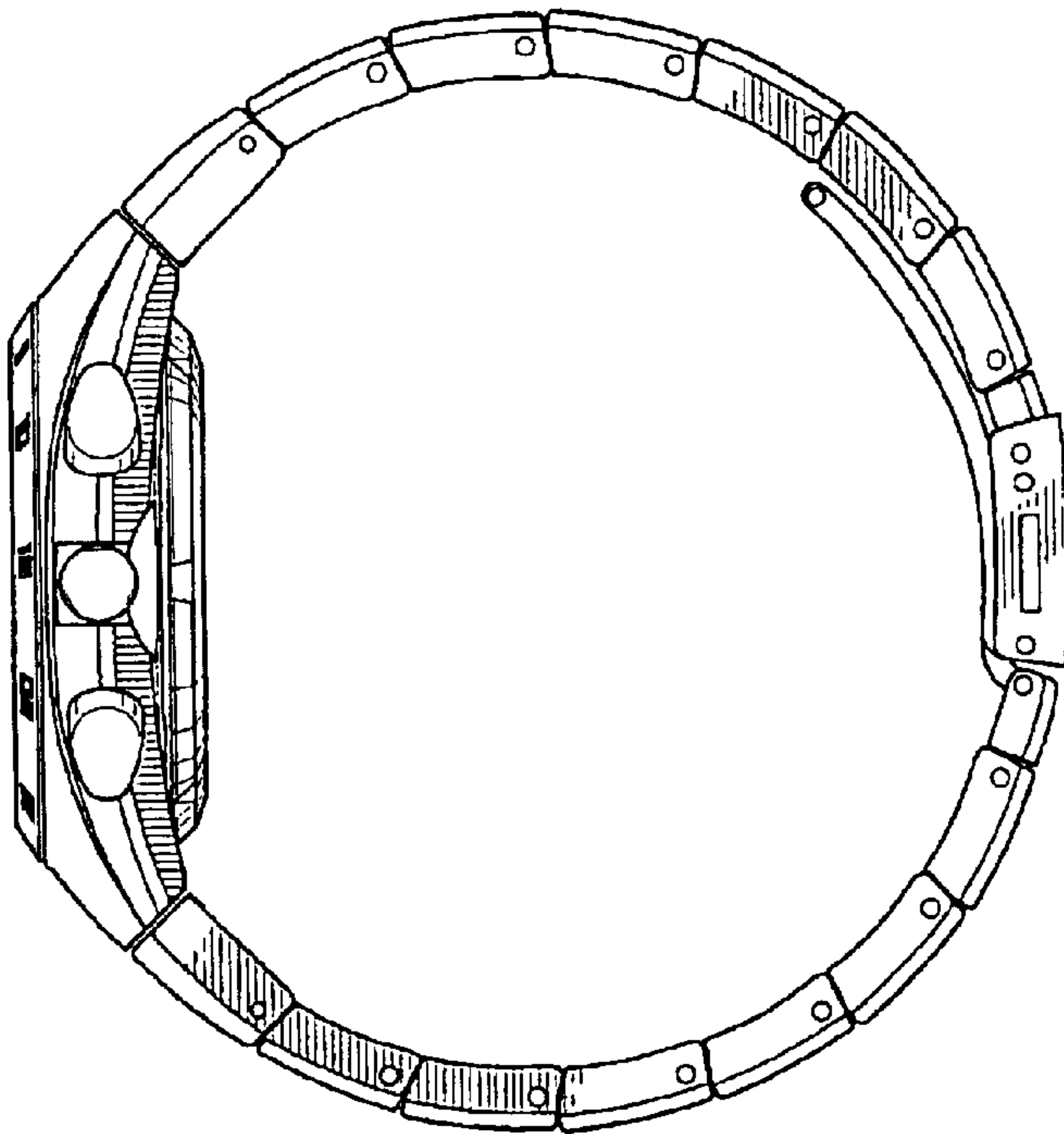

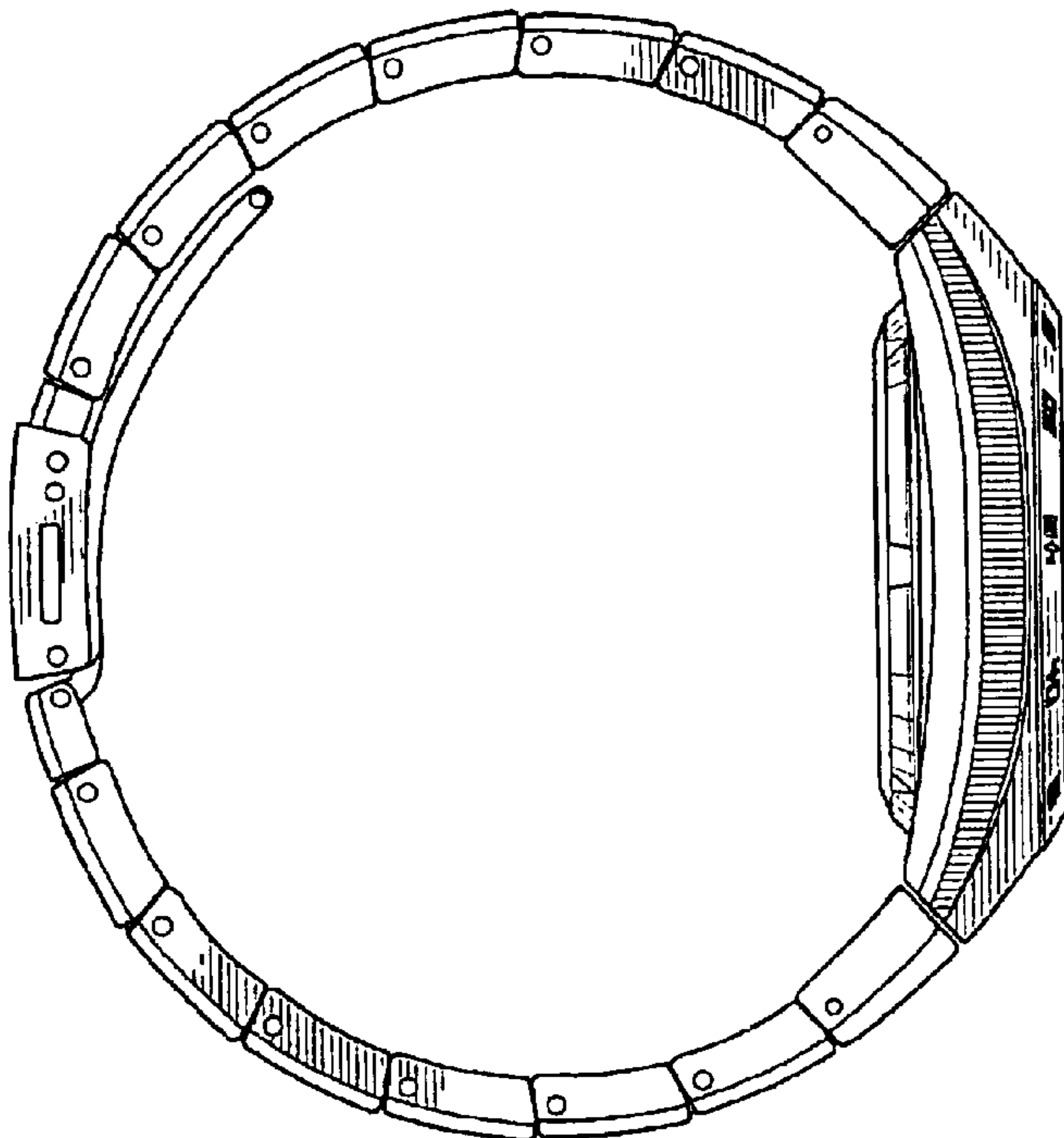

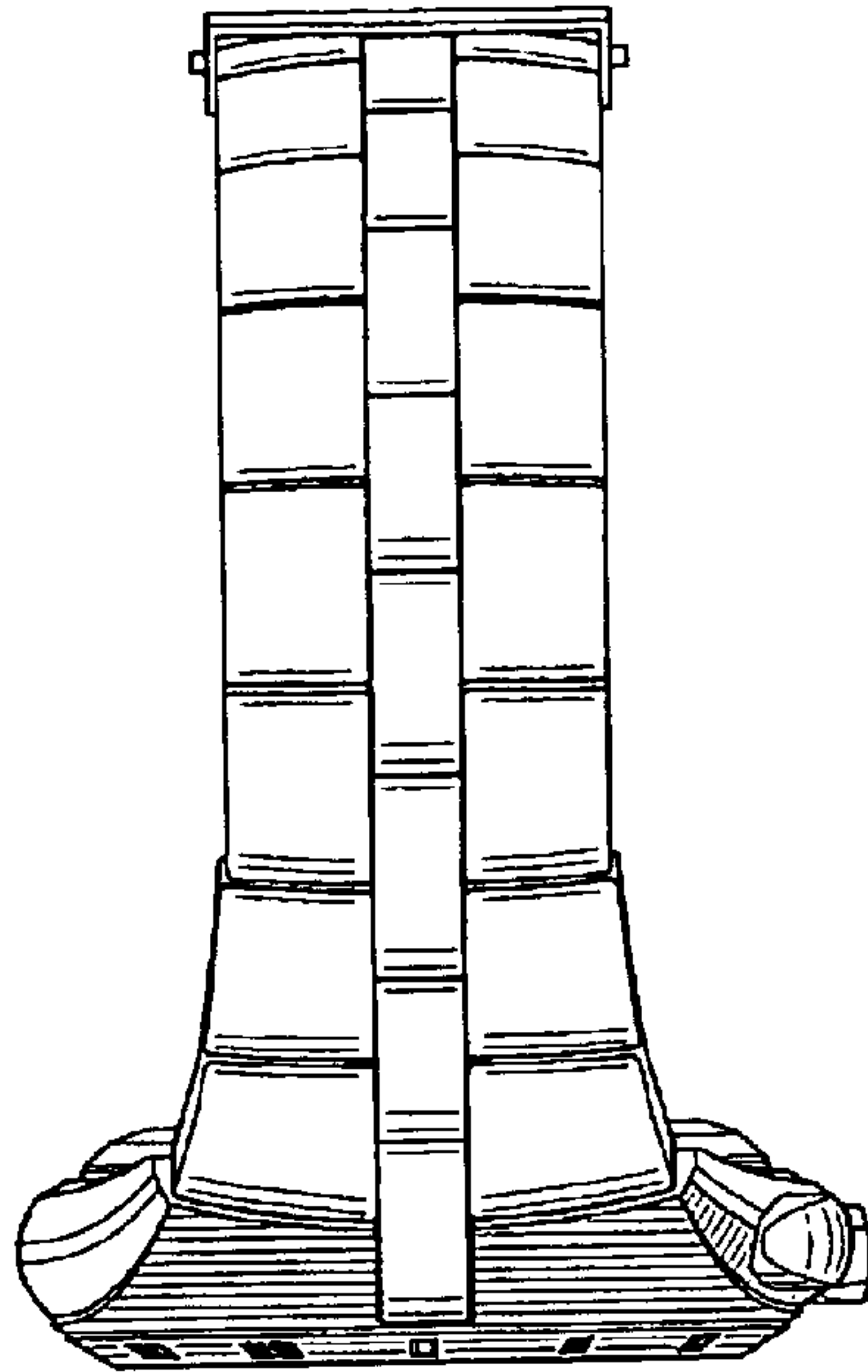
