(57) **CLAIM**

The ornamental design for a photo album with a flower display, as shown and described.

**DESCRIPTION**

FIG. 1 shows a perspective view of my design for a photo album with a flower display;

FIG. 2 shows a front view thereof;

FIG. 3 shows a back view thereof;

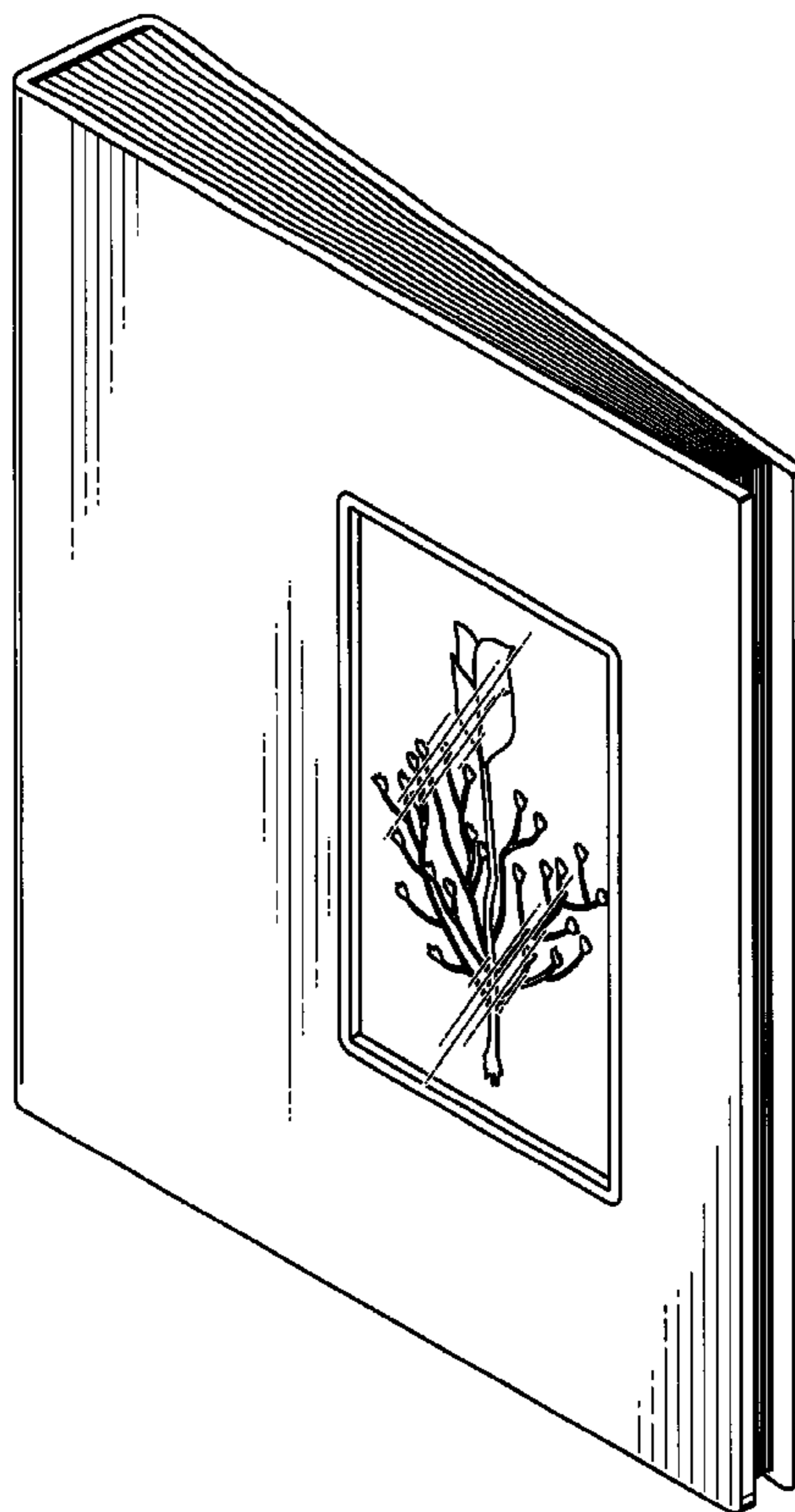
FIG. 4 shows a right side view thereof based on the view in FIG. 2;

FIG. 5 shows a left side view thereof based upon the view in FIG. 2;

FIG. 6 shows a top view thereof with the opposite bottom side being identical; and,

FIG. 7 shows a front view of a second embodiment of the photo album with a flower display wherein the back side, top side, left side, right side and bottom side of this embodiment are all identical to those respective sides shown in the first embodiment except that the rectangle enclosing the flower display in FIG. 4 is reduced in size consistent with FIG. 7.

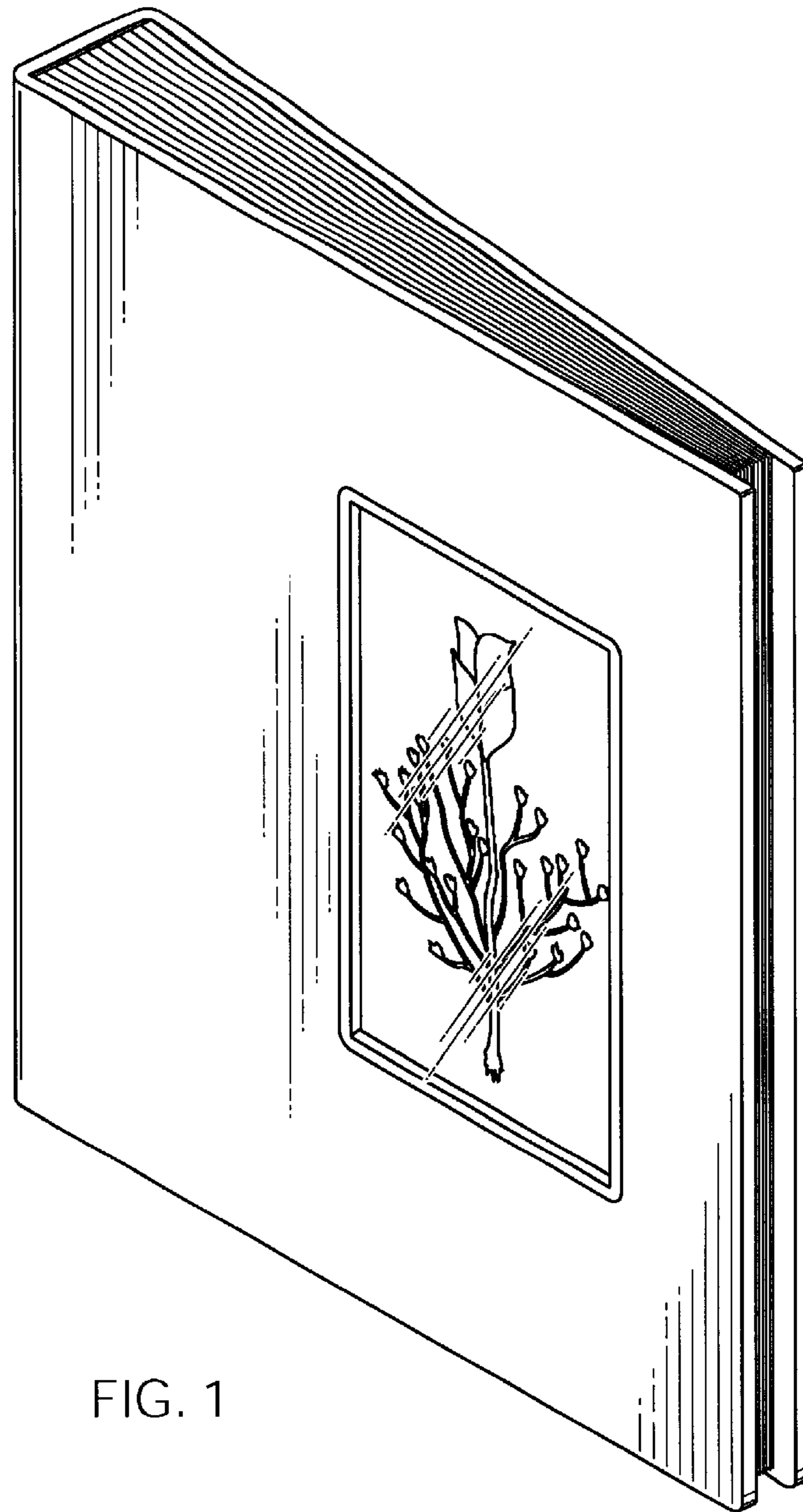

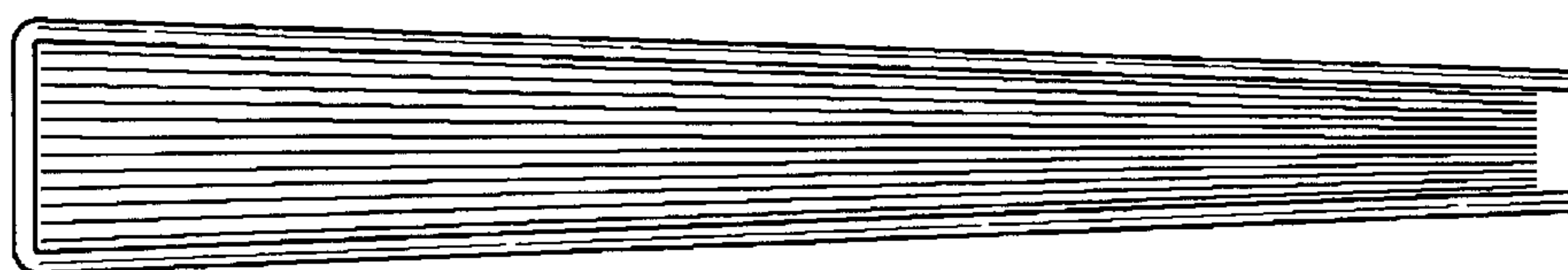

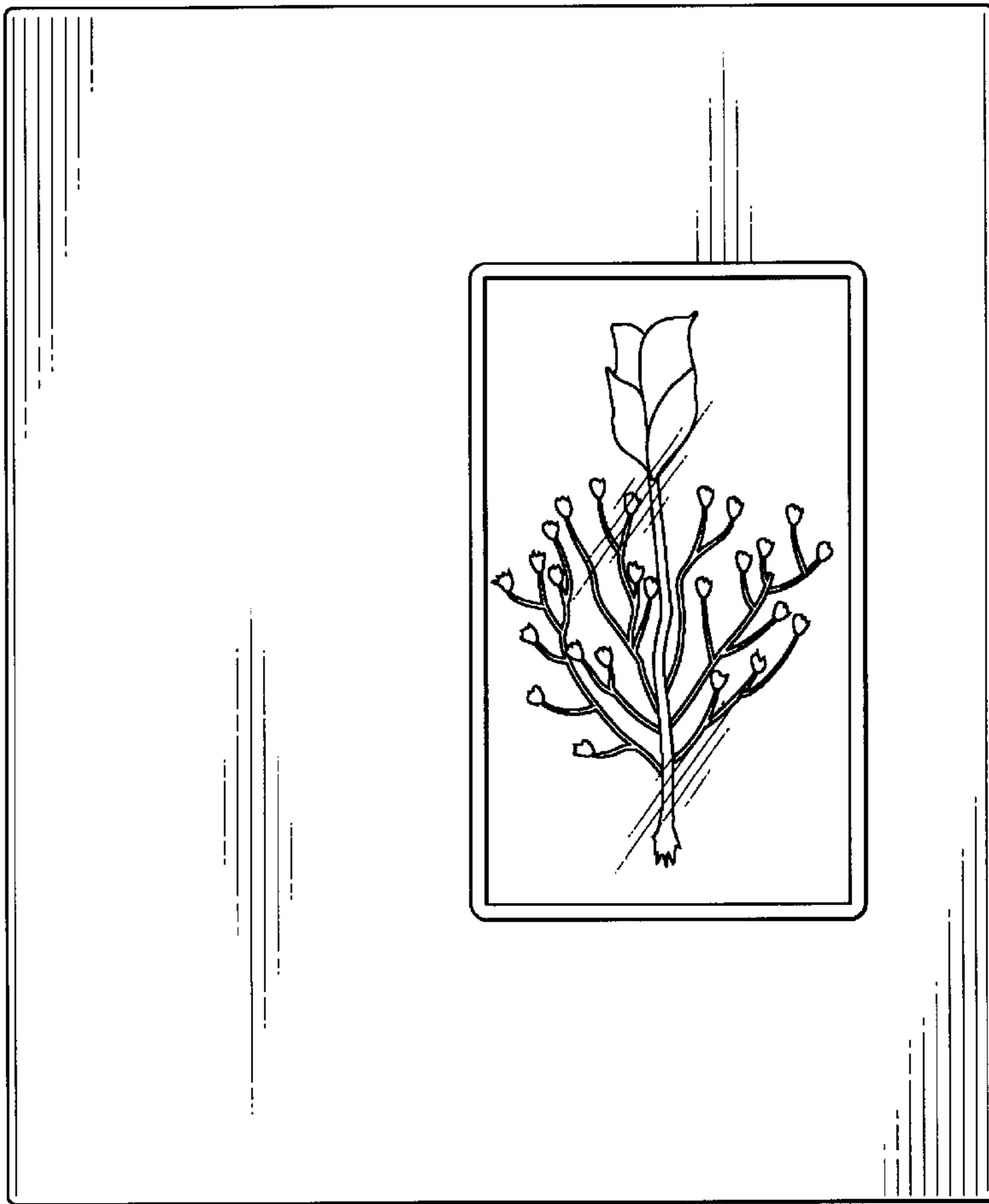

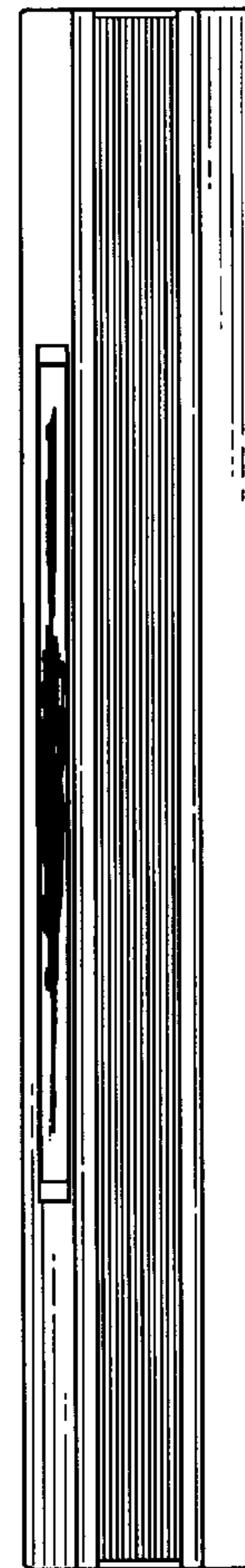

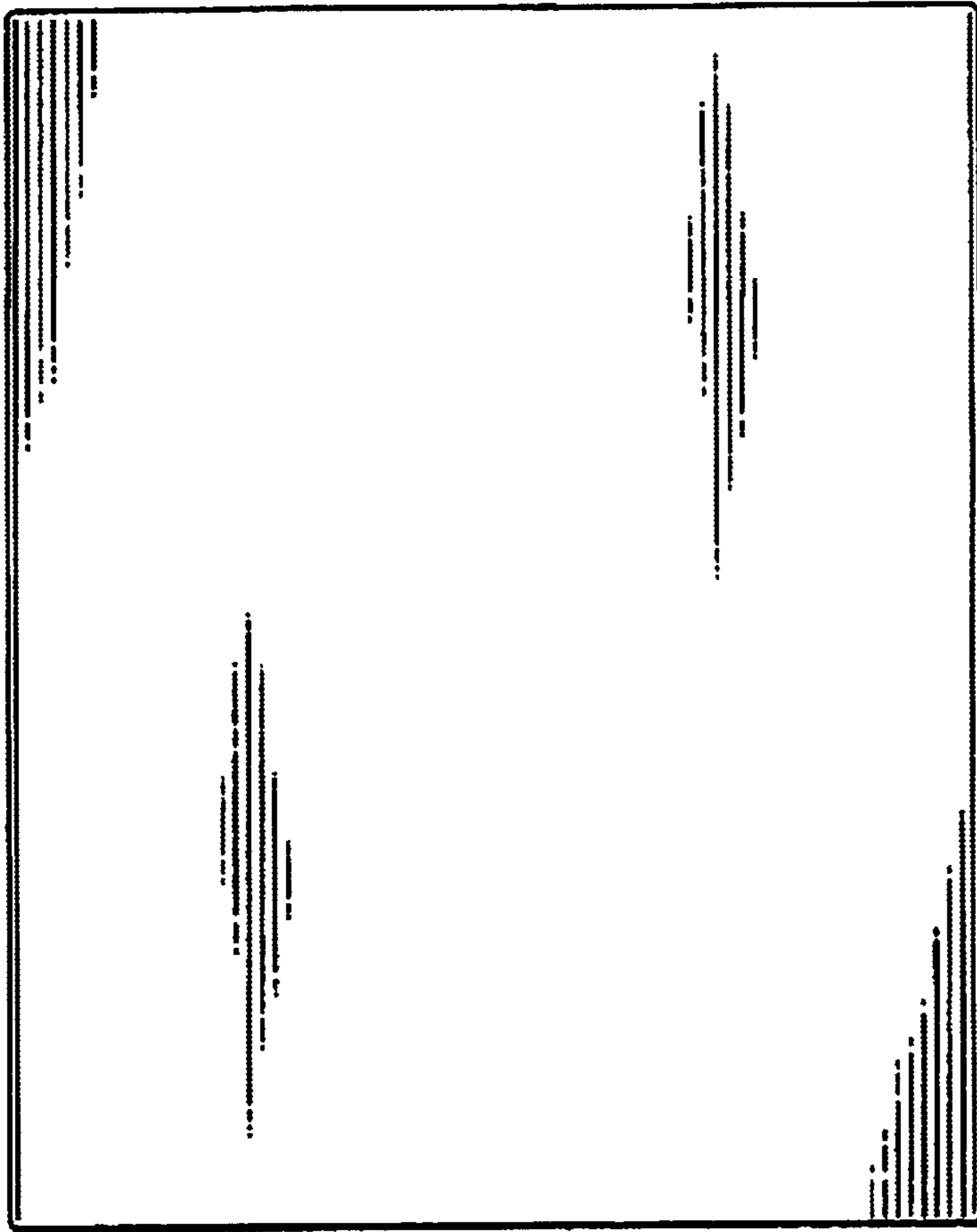

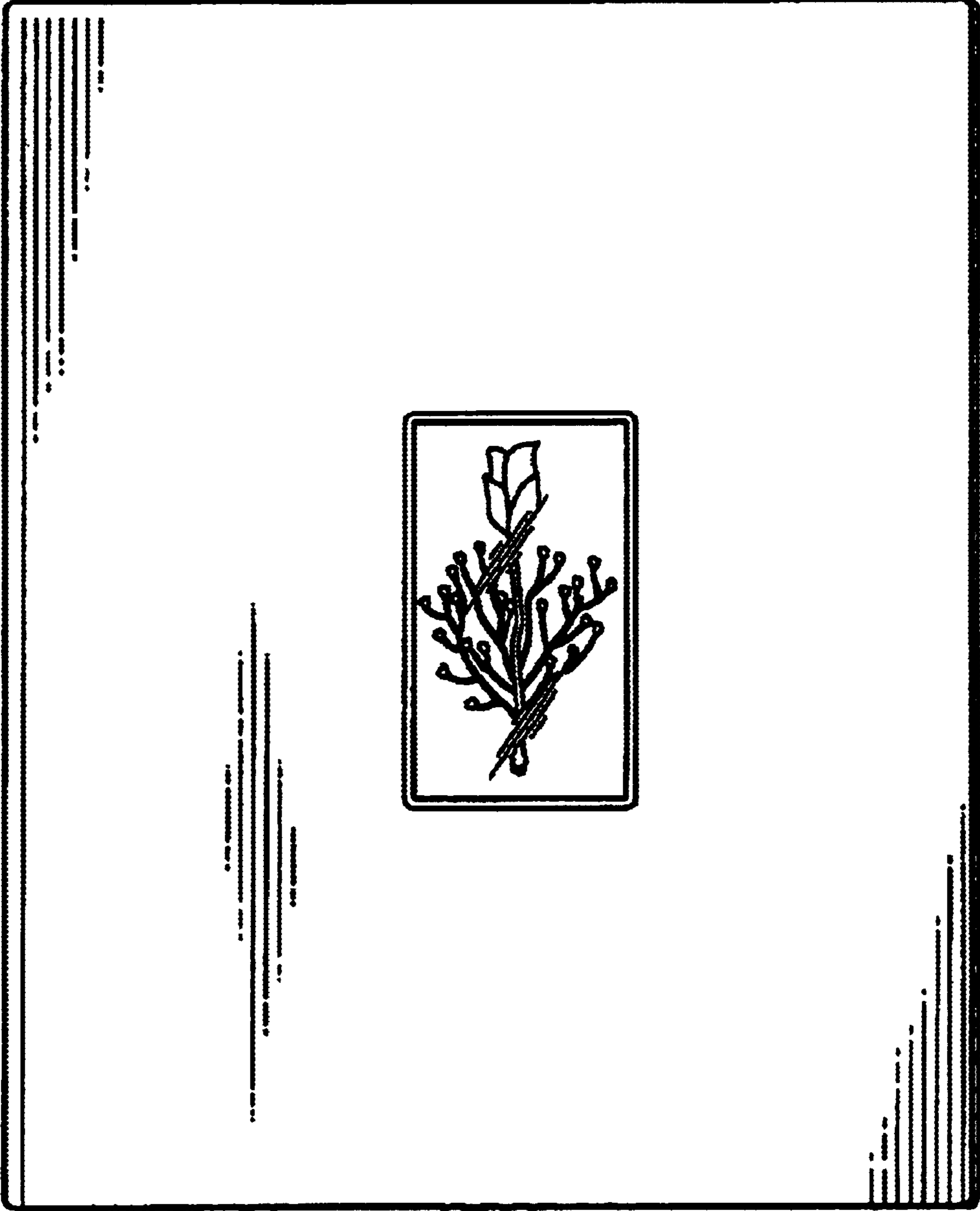
